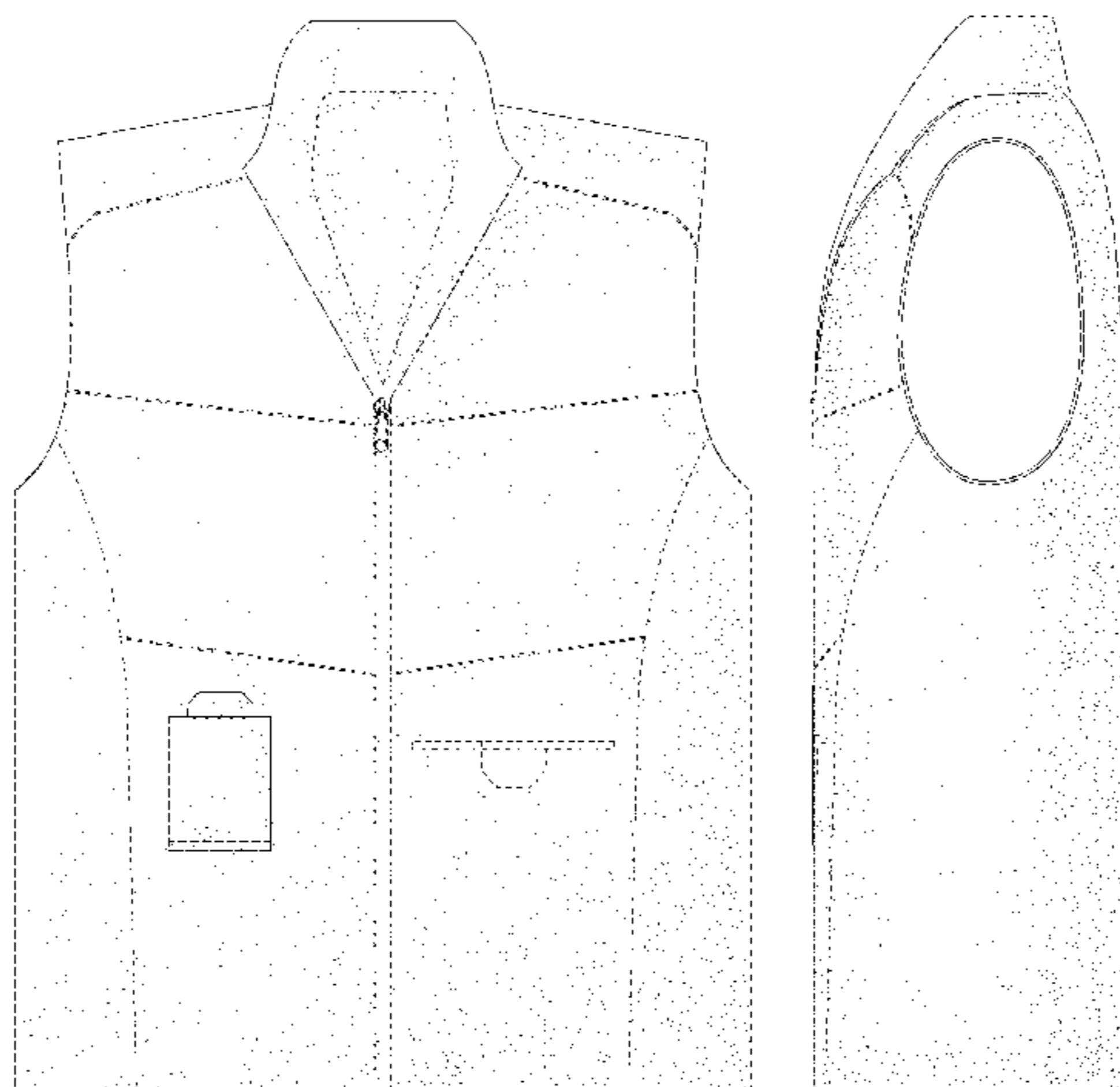

(57) CLAIM

The ornamental design for a garment with carrying case for medical delivery device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of our design for a garment with carrying case for medical delivery device. FIG. 2 is a front view of the garment with carrying case for medical delivery device of FIG. 1. FIG. 3 is a rear view of the garment with carrying case for medical delivery device of FIG. 1. FIG. 4 is a left side view of the garment with carrying case for medical delivery device of FIG. 1. FIG. 5 is a right side view of the garment with carrying case for medical delivery device of FIG. 1. FIG. 6 is a top view of the garment with carrying case for medical delivery device of FIG. 1.

FIG. 7 is a bottom view of the garment with carrying case for medical delivery device of FIG. 1.

FIG. 8 is a front view of the garment with carrying case for medical delivery device of FIG. 1, illustrated inside-out with respect to FIG. 2; and,

FIG. 9 is a perspective view of the garment with carrying case for medical delivery device of FIG. 1, illustrated inside-out with respect to FIG. 1.

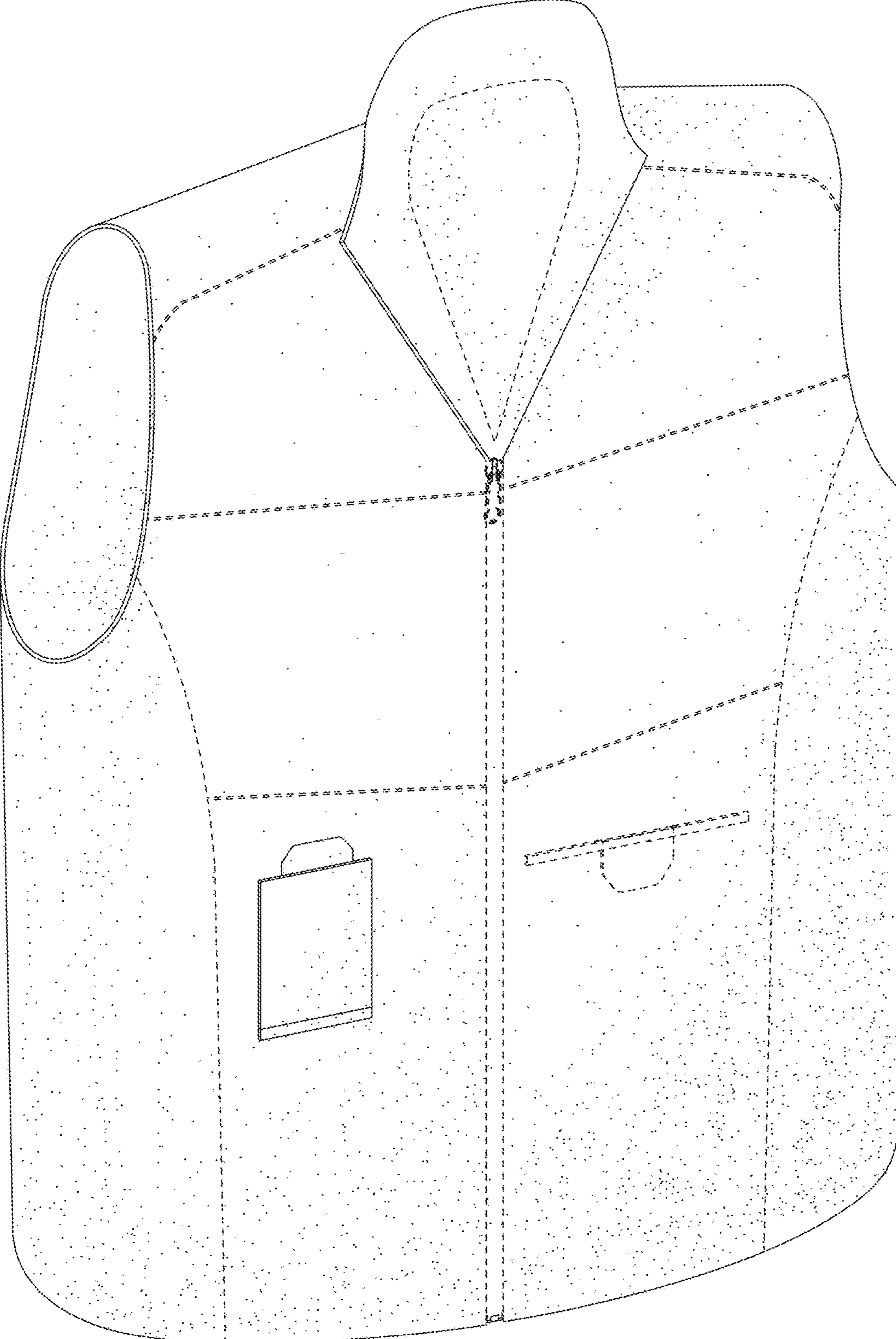

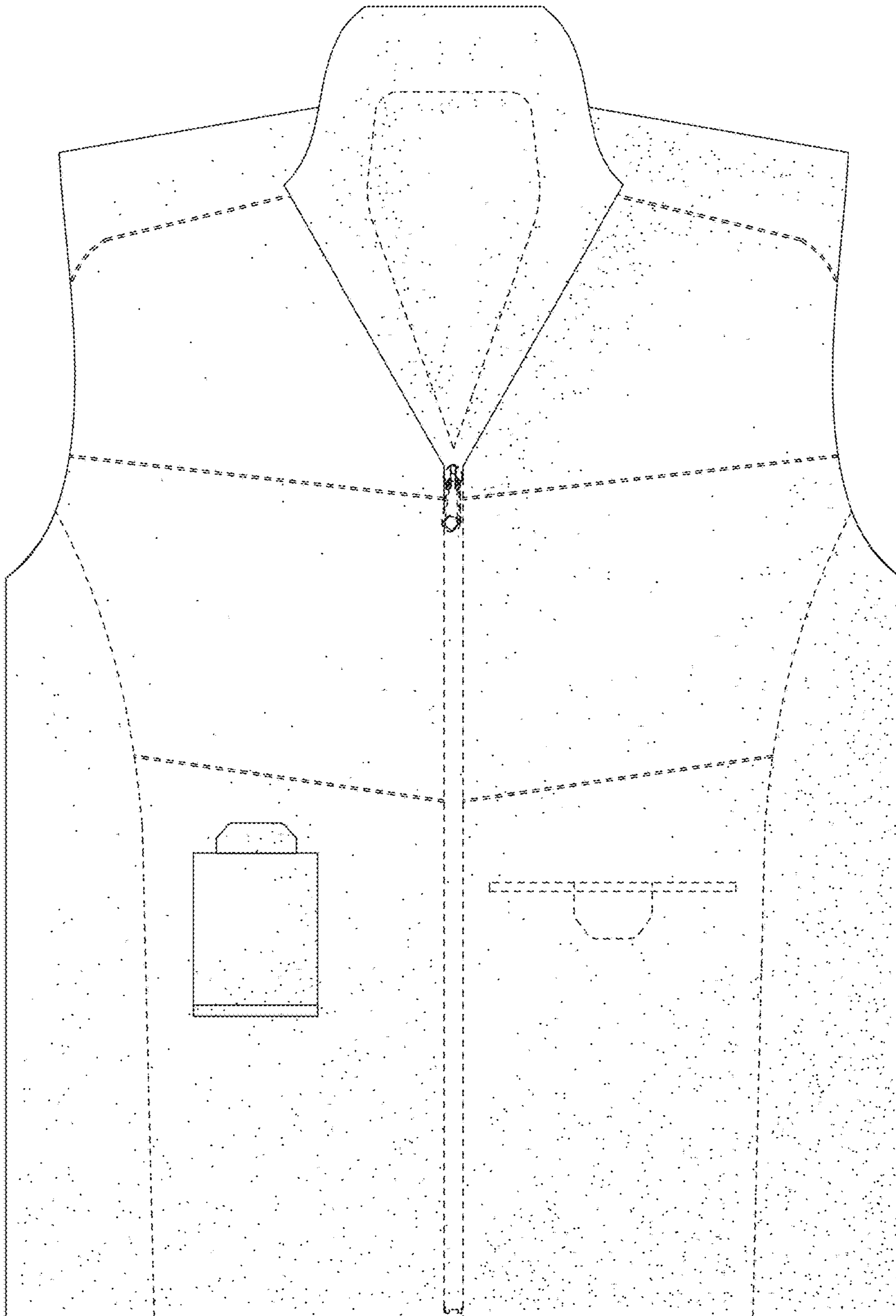

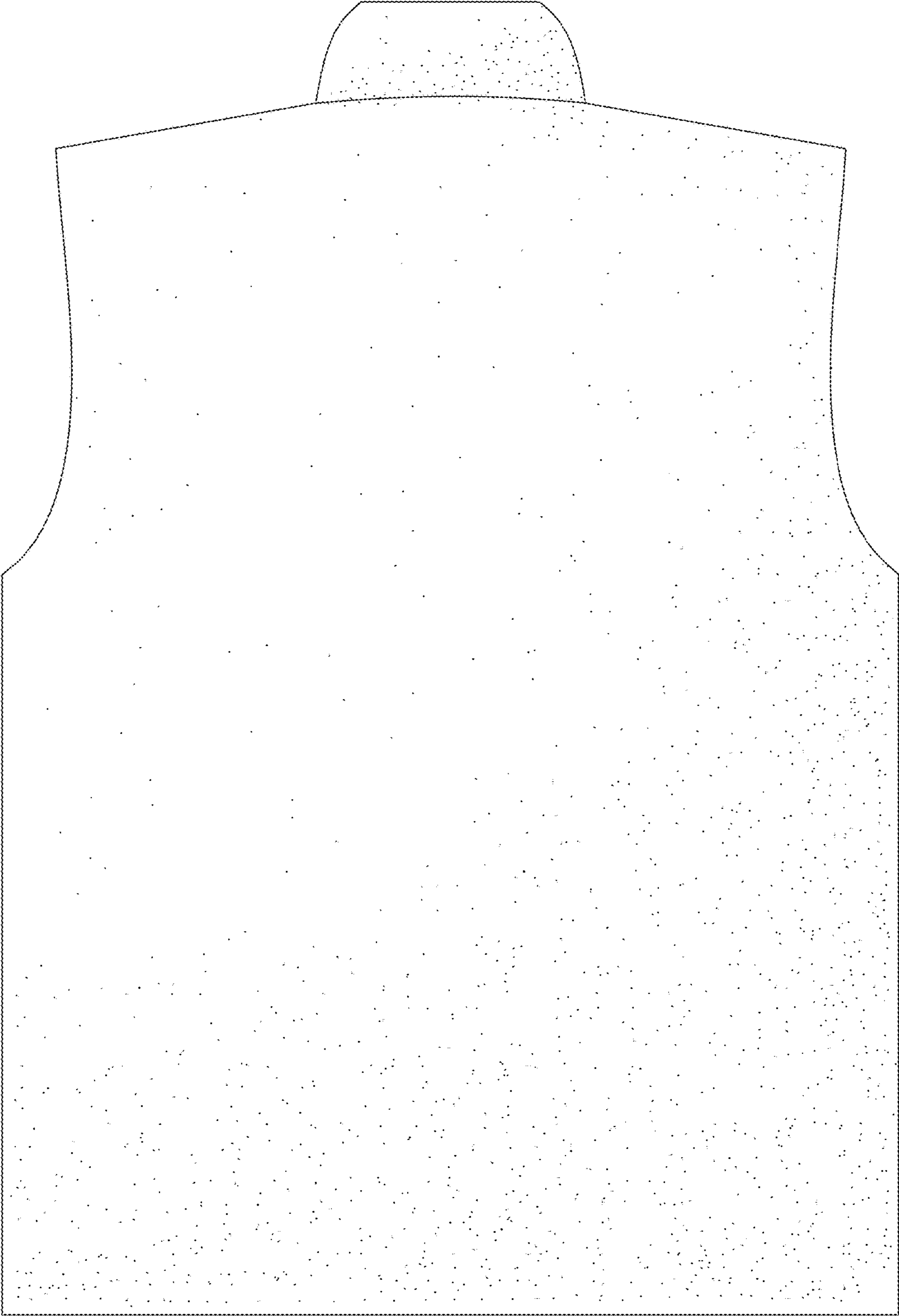

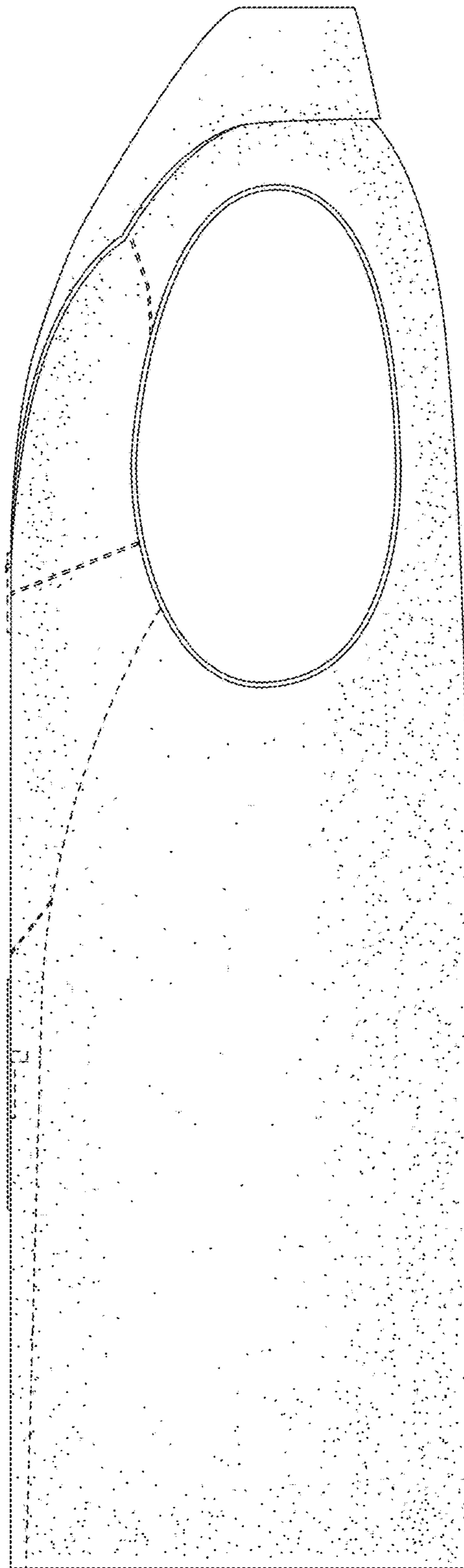

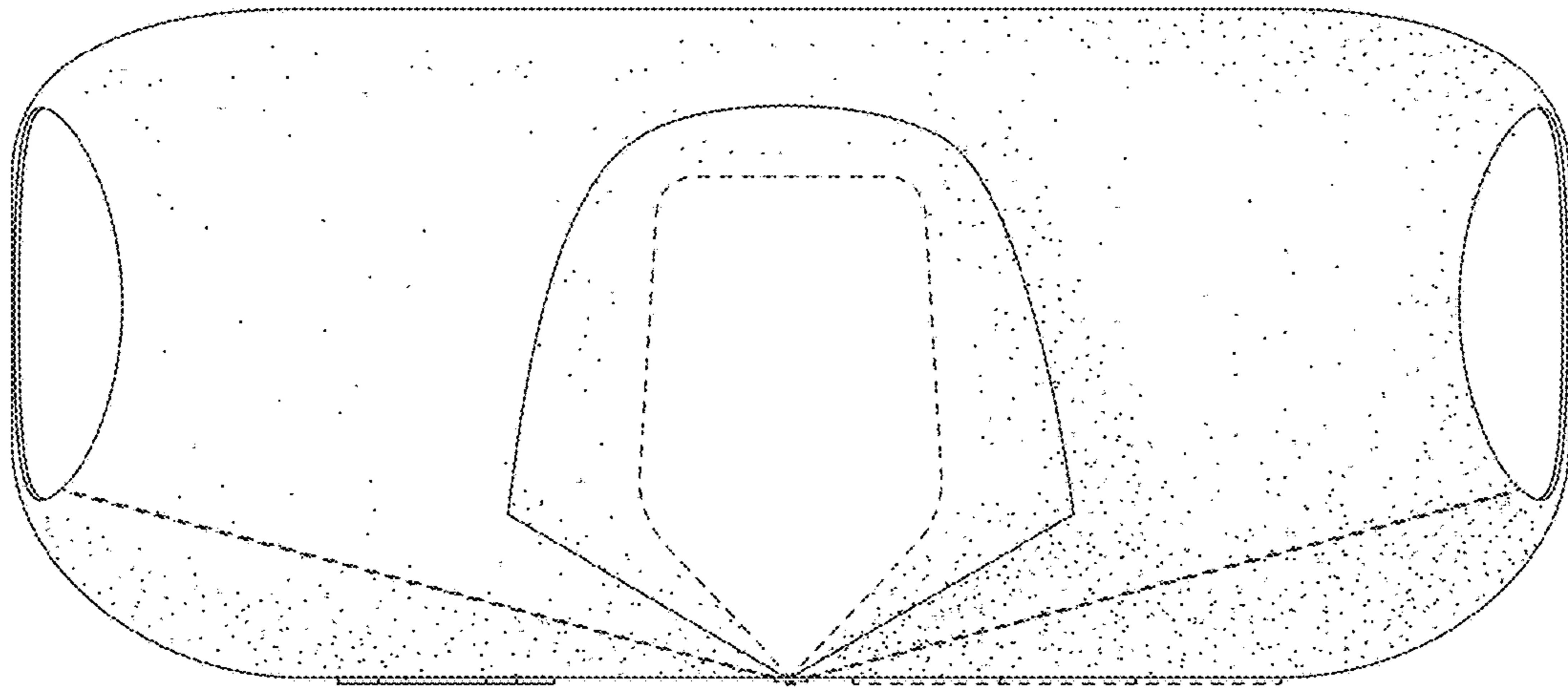

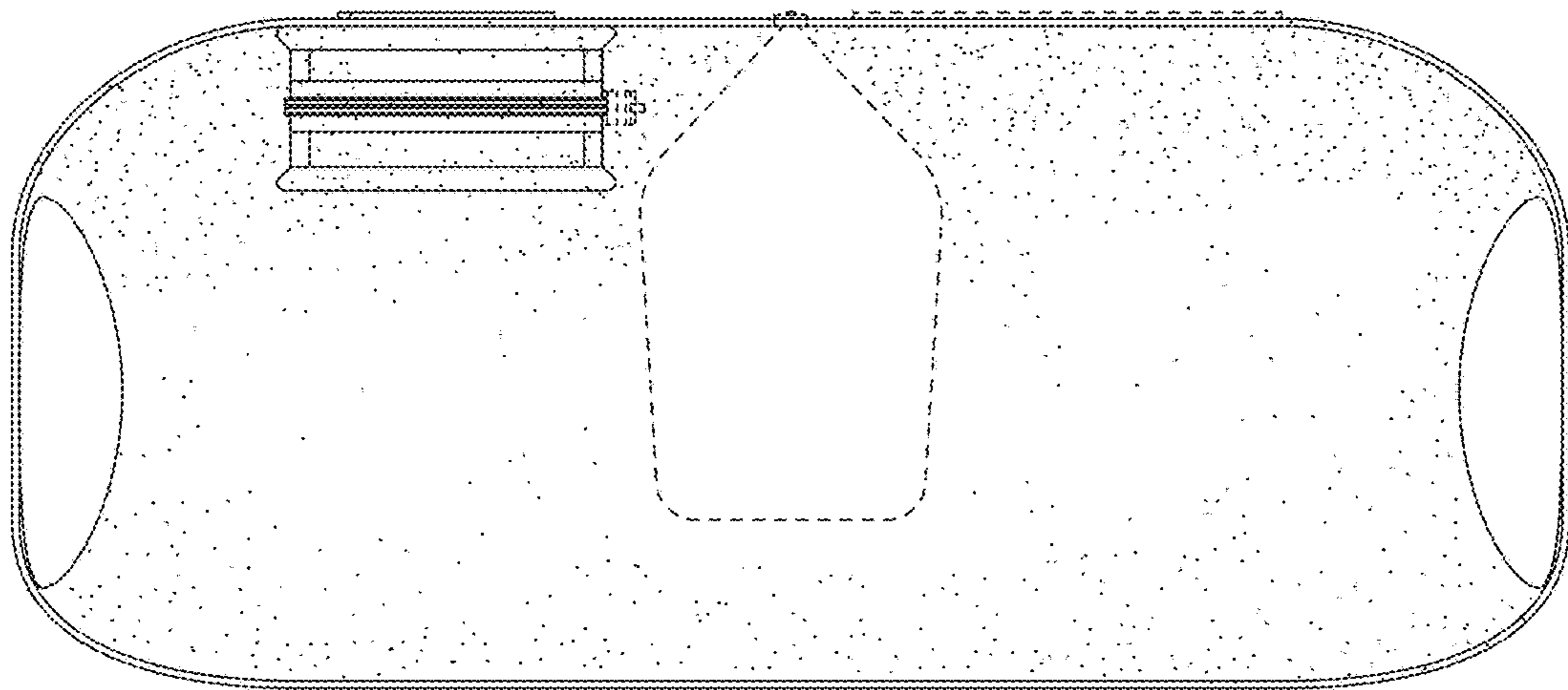

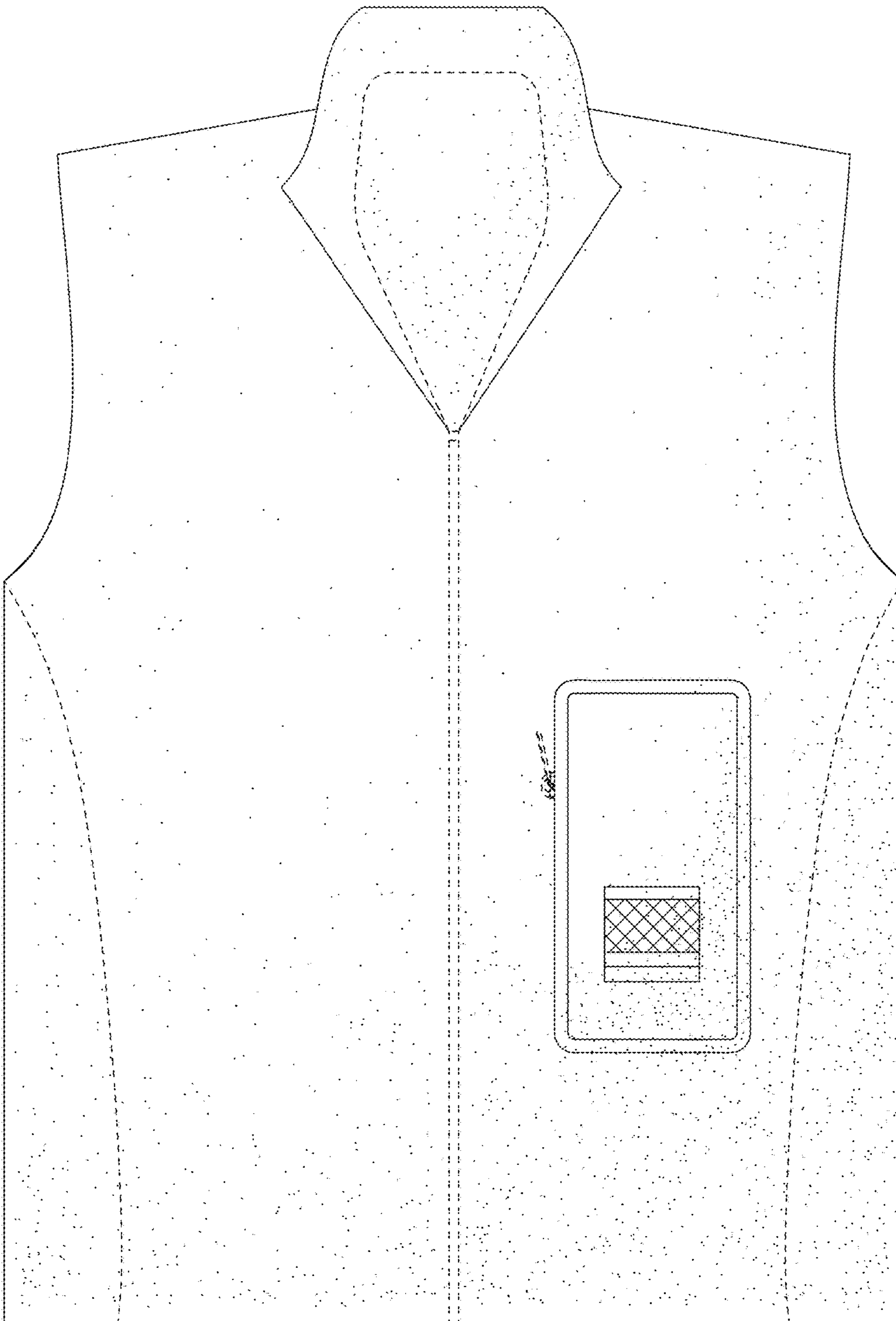

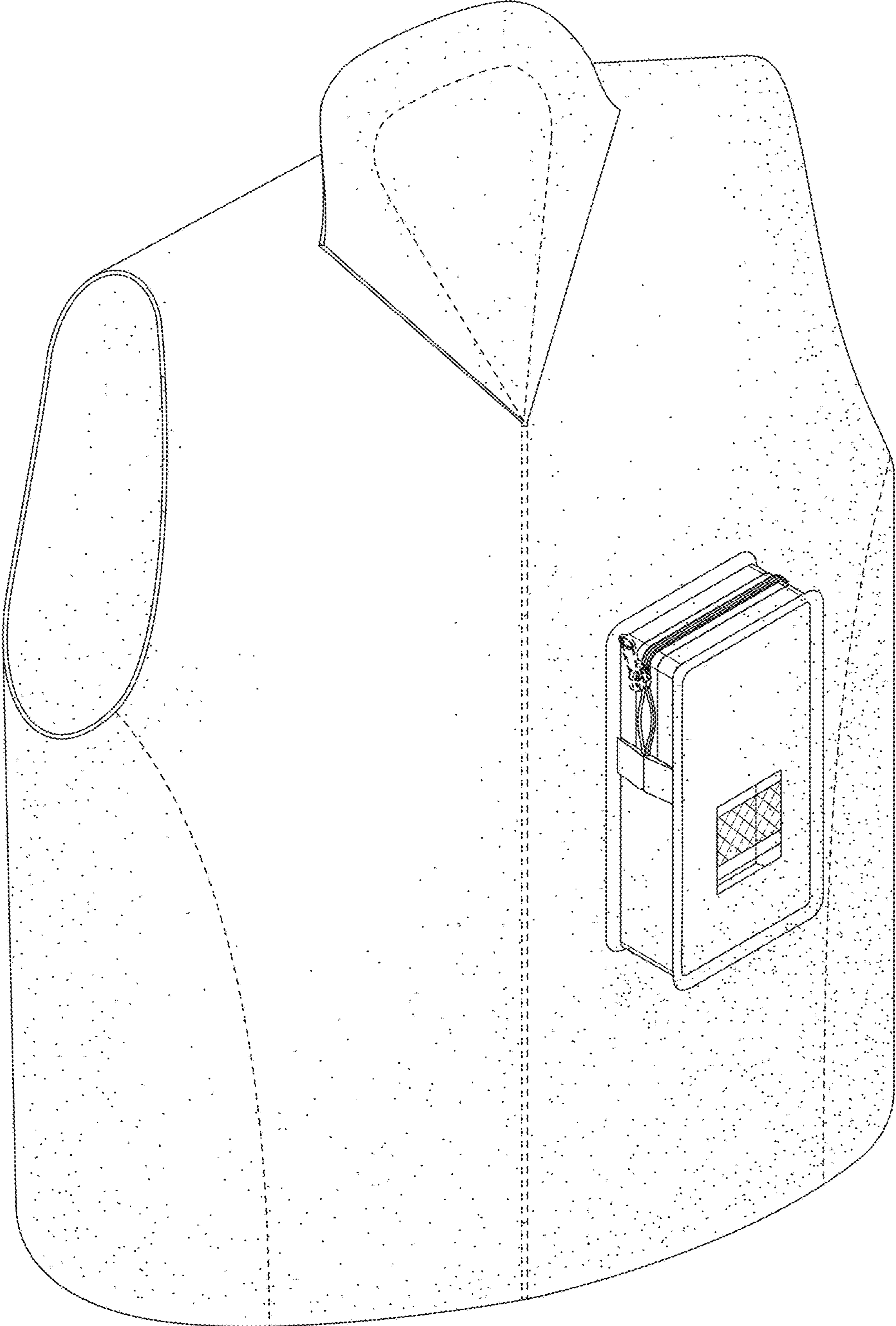
