The ornamental design for a sandal, as shown.

**DESCRIPTION**

FIG. 1 is a top right perspective view of a sandal showing my new design;

 FIG. 10 is a rear view thereof.  
 The portions of the sandal shown in broken lines represent thread stitching.

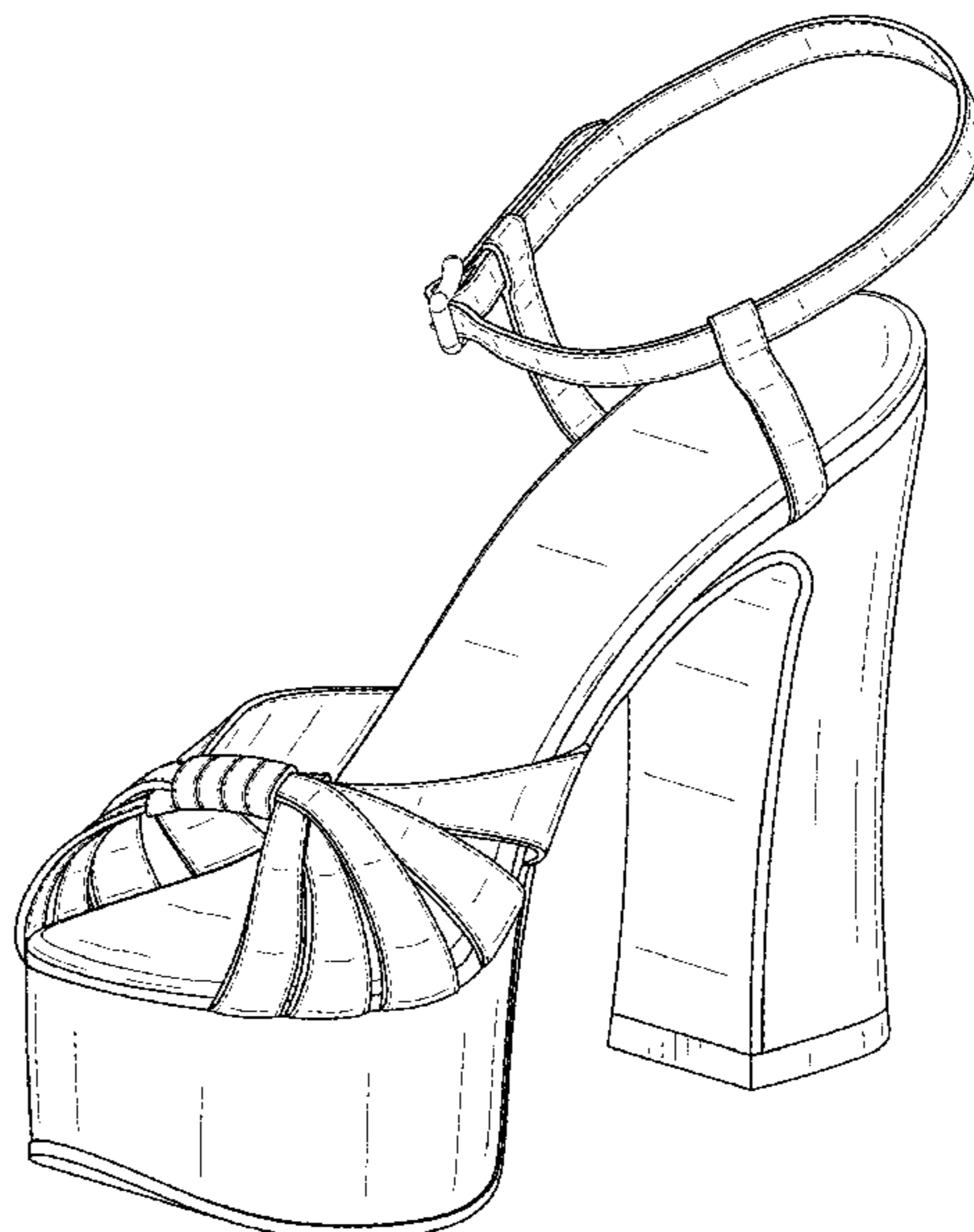

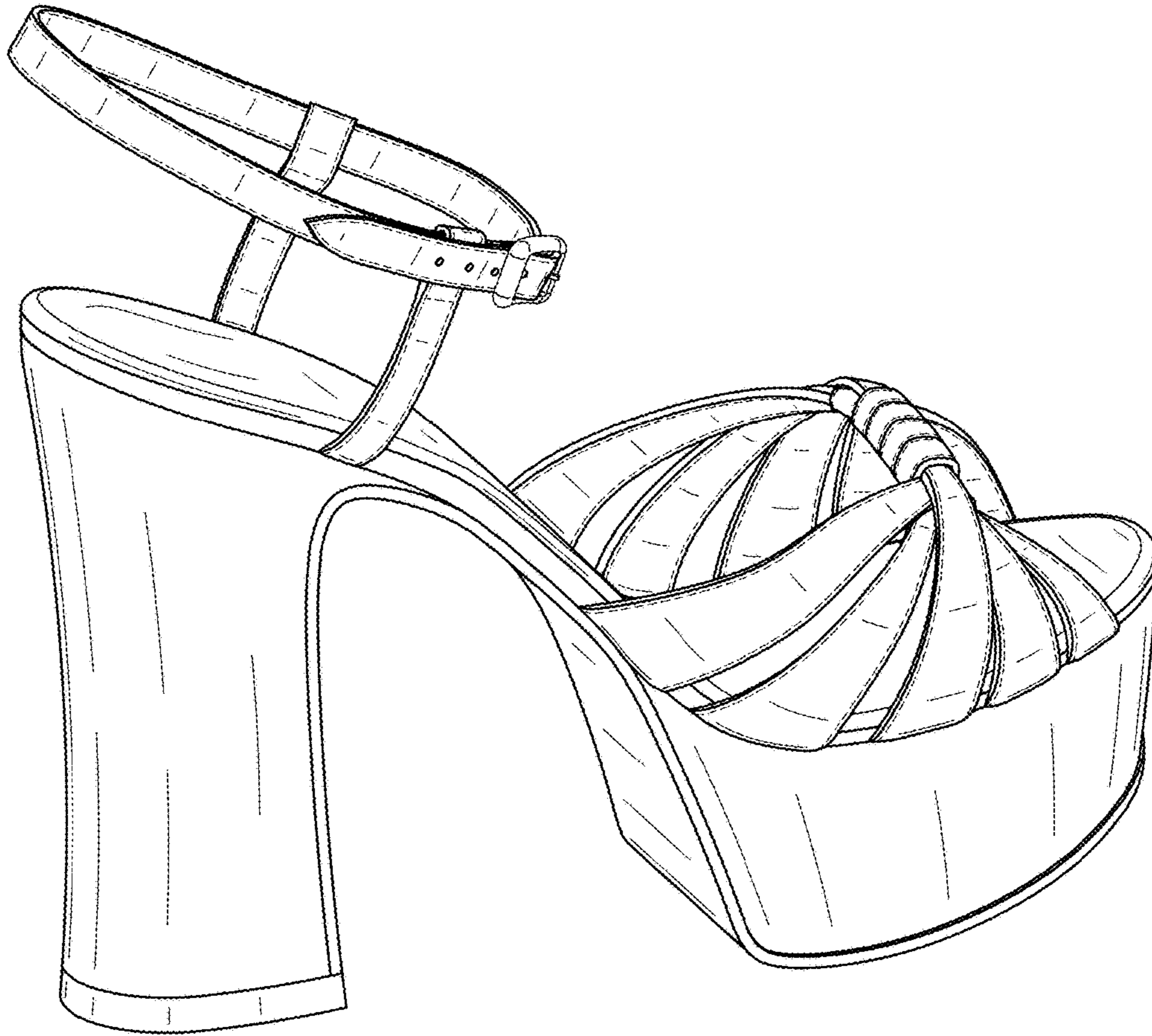

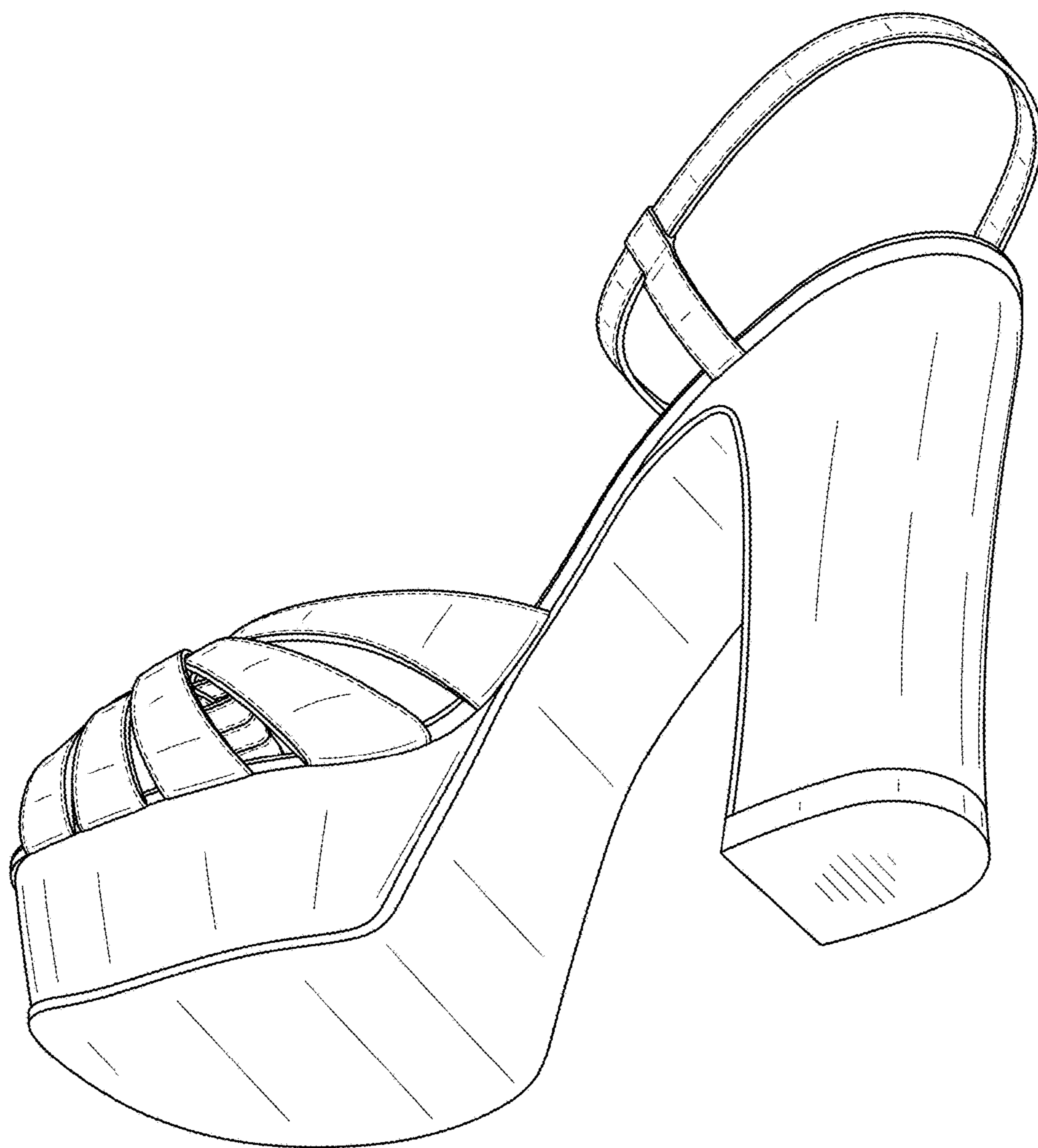

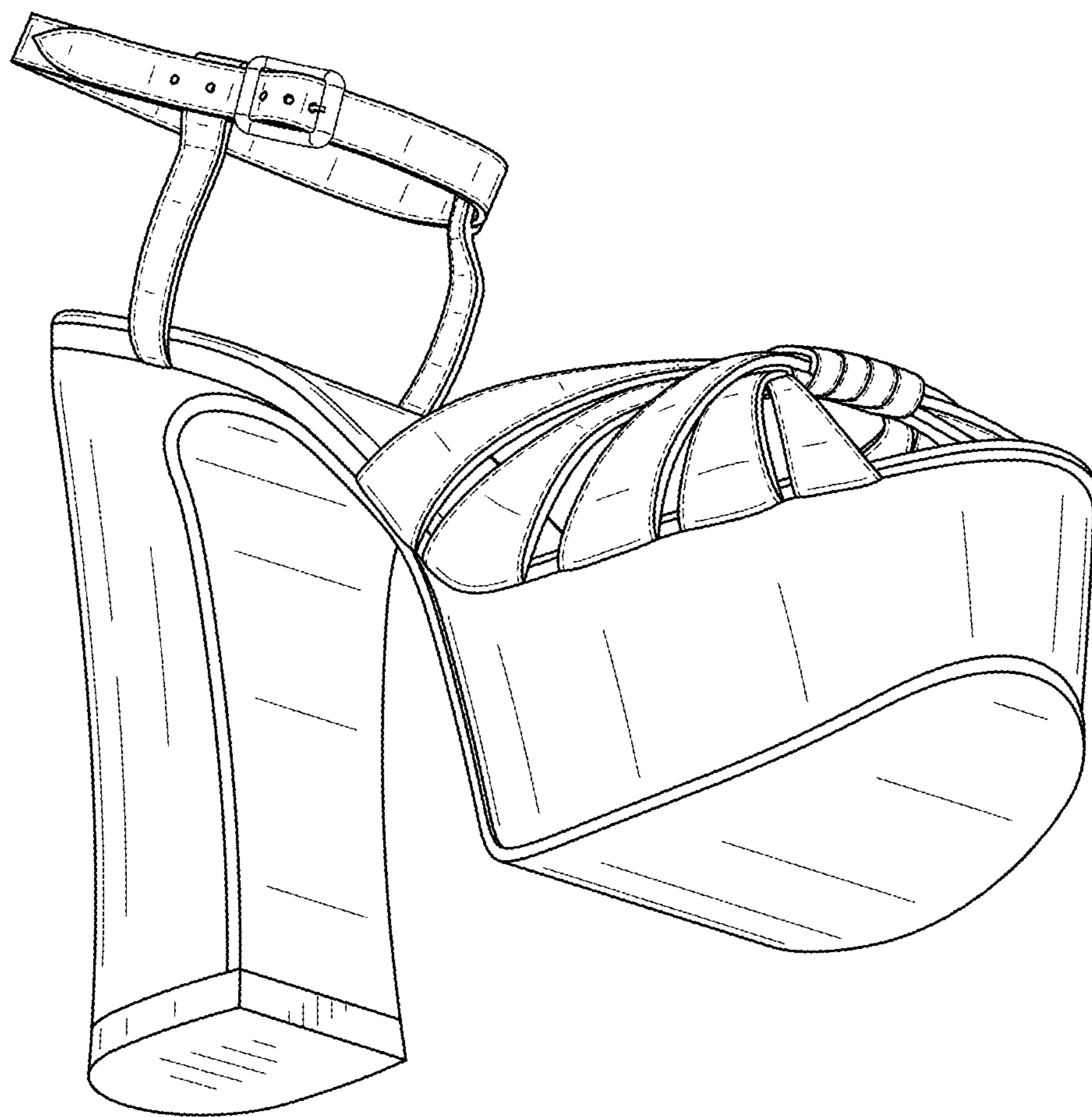

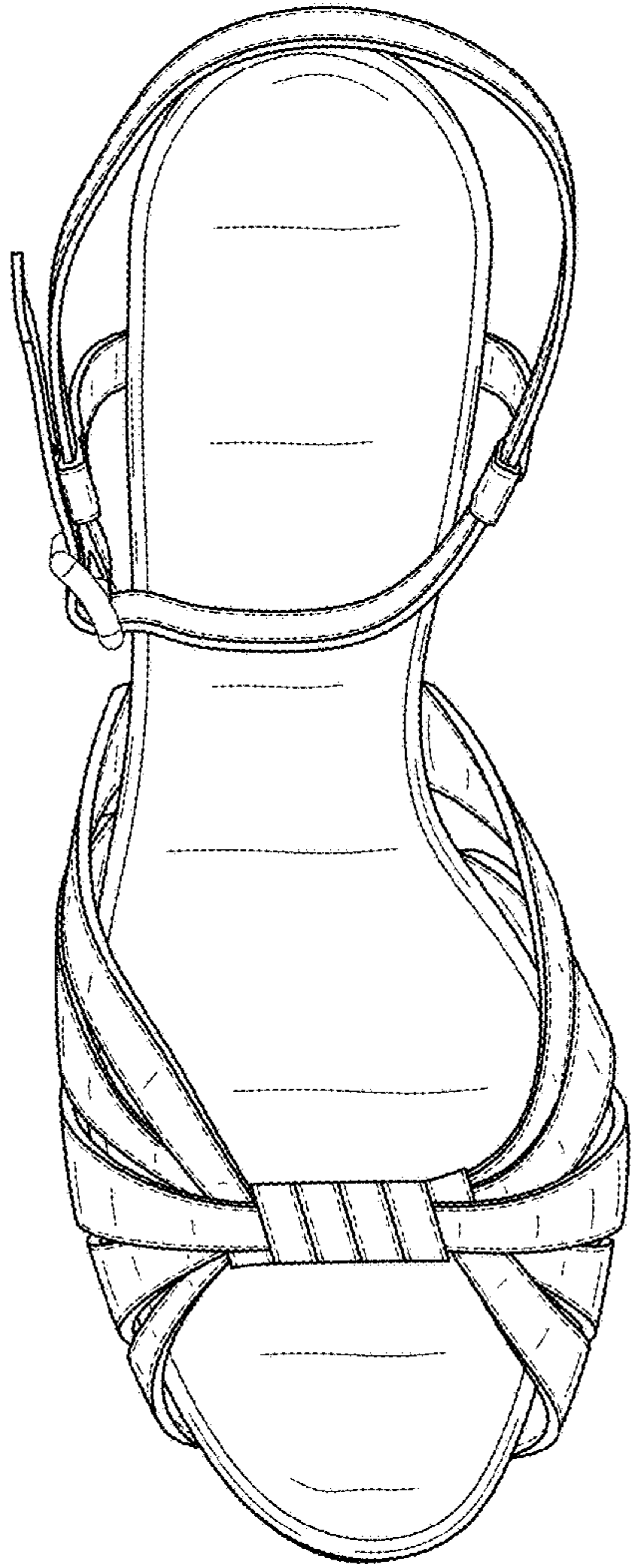

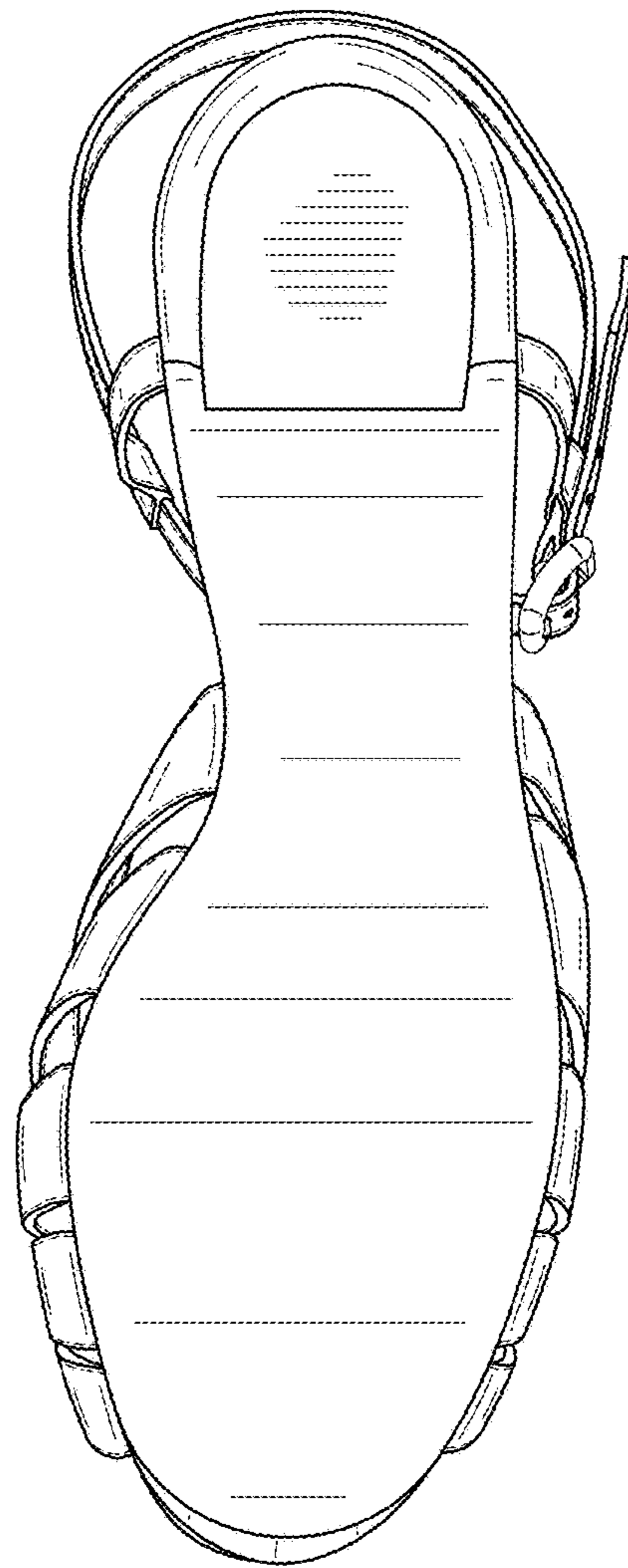

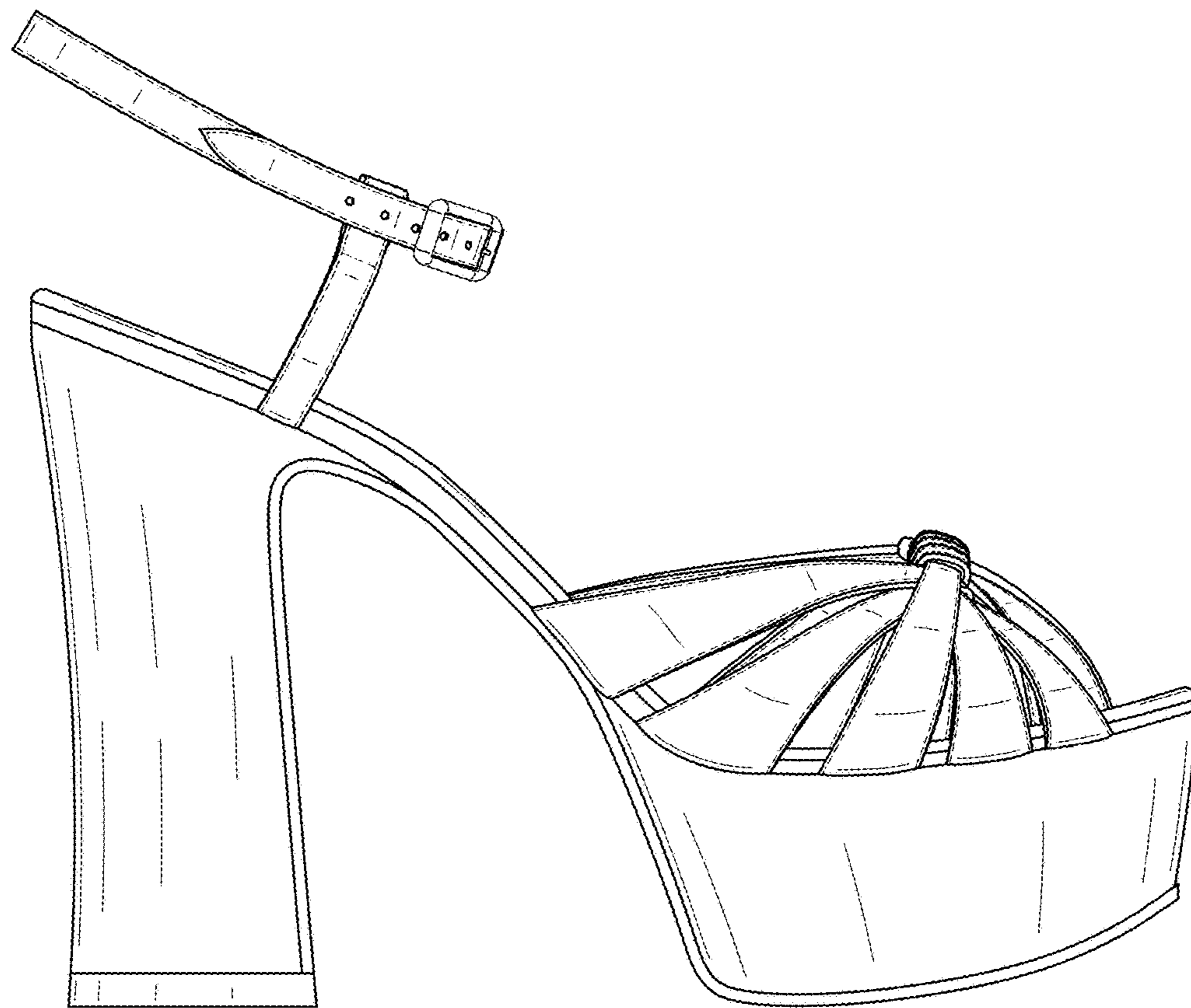

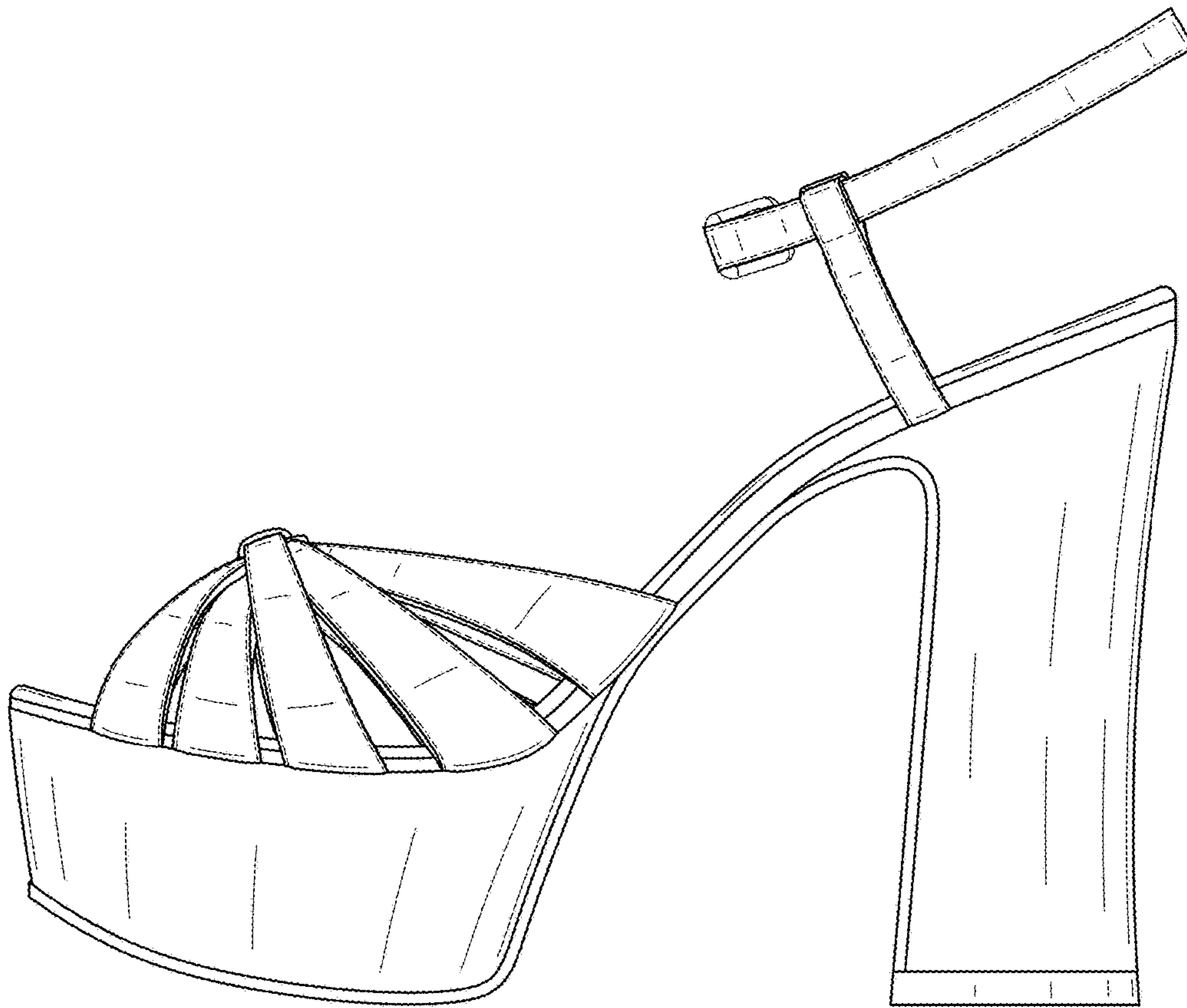

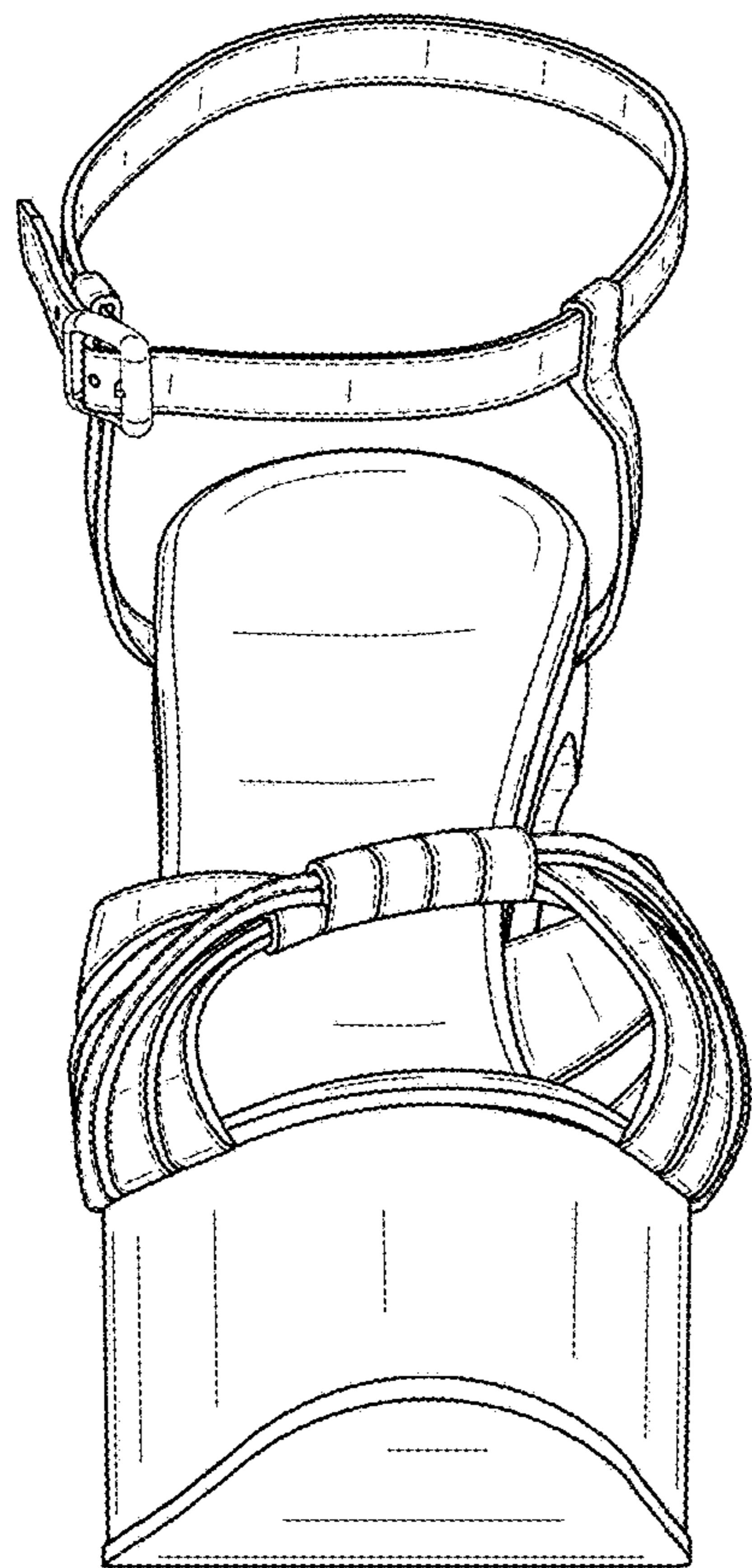

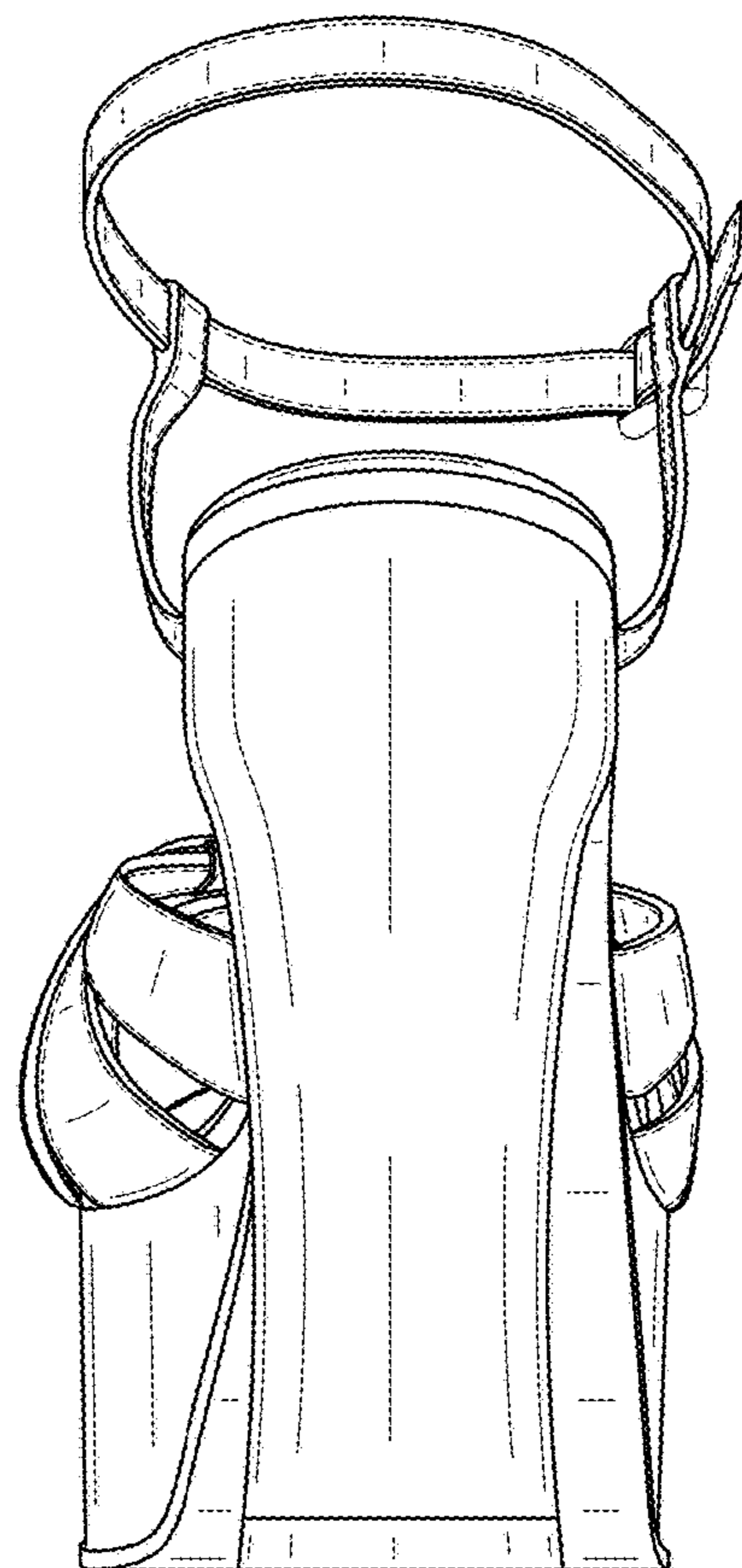
