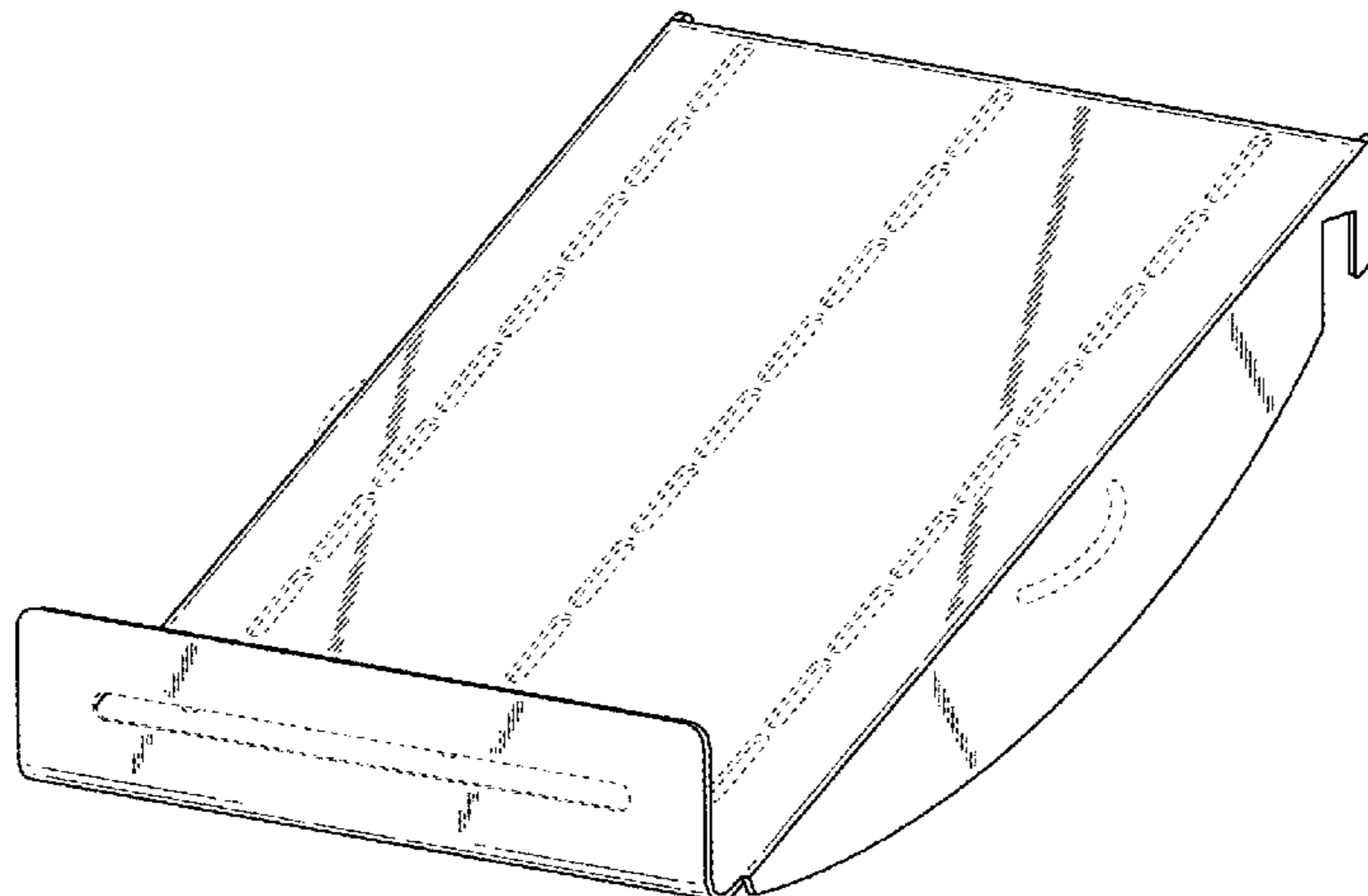
(57) **CLAIM**

The ornamental design for a display shelf, as shown and
described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a display shelf
showing a first embodiment of our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, the left side view being
a mirror image of the right side view;
FIG. 5 is a top view thereof; and
FIG. 6 is a bottom view thereof.
FIG. 7 is a top and front perspective view of the display shelf
of FIG. 1 with additional unclaimed environmental subject
matter illustrating one example use of the display shelf;
FIG. 8 is a front view thereof;
FIG. 9 is a rear view thereof;
FIG. 10 is a right side view thereof, the left side view being
a mirror image of the right side view;
FIG. 11 is a top view thereof; and,
FIG. 12 is a bottom view thereof.

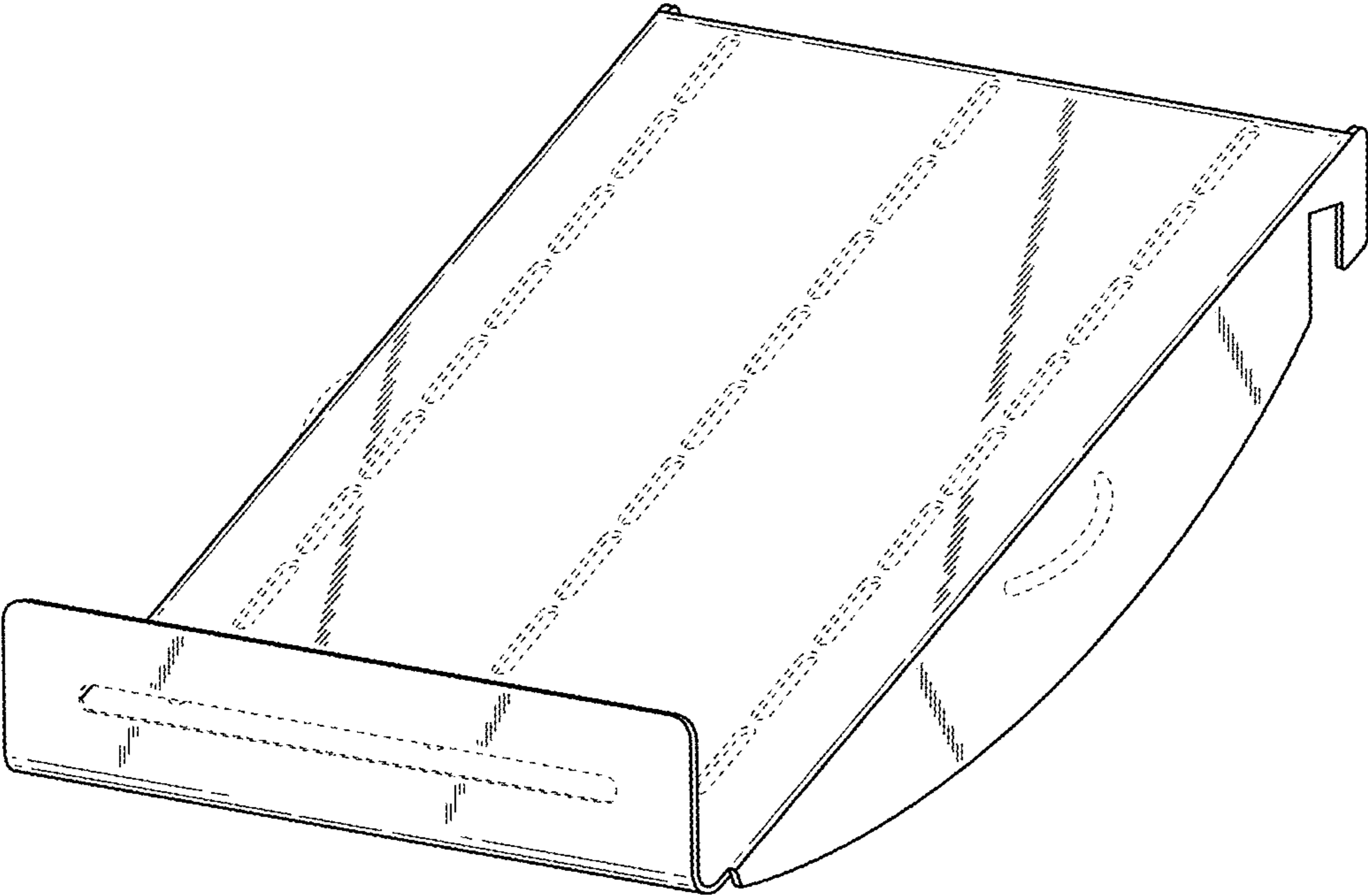

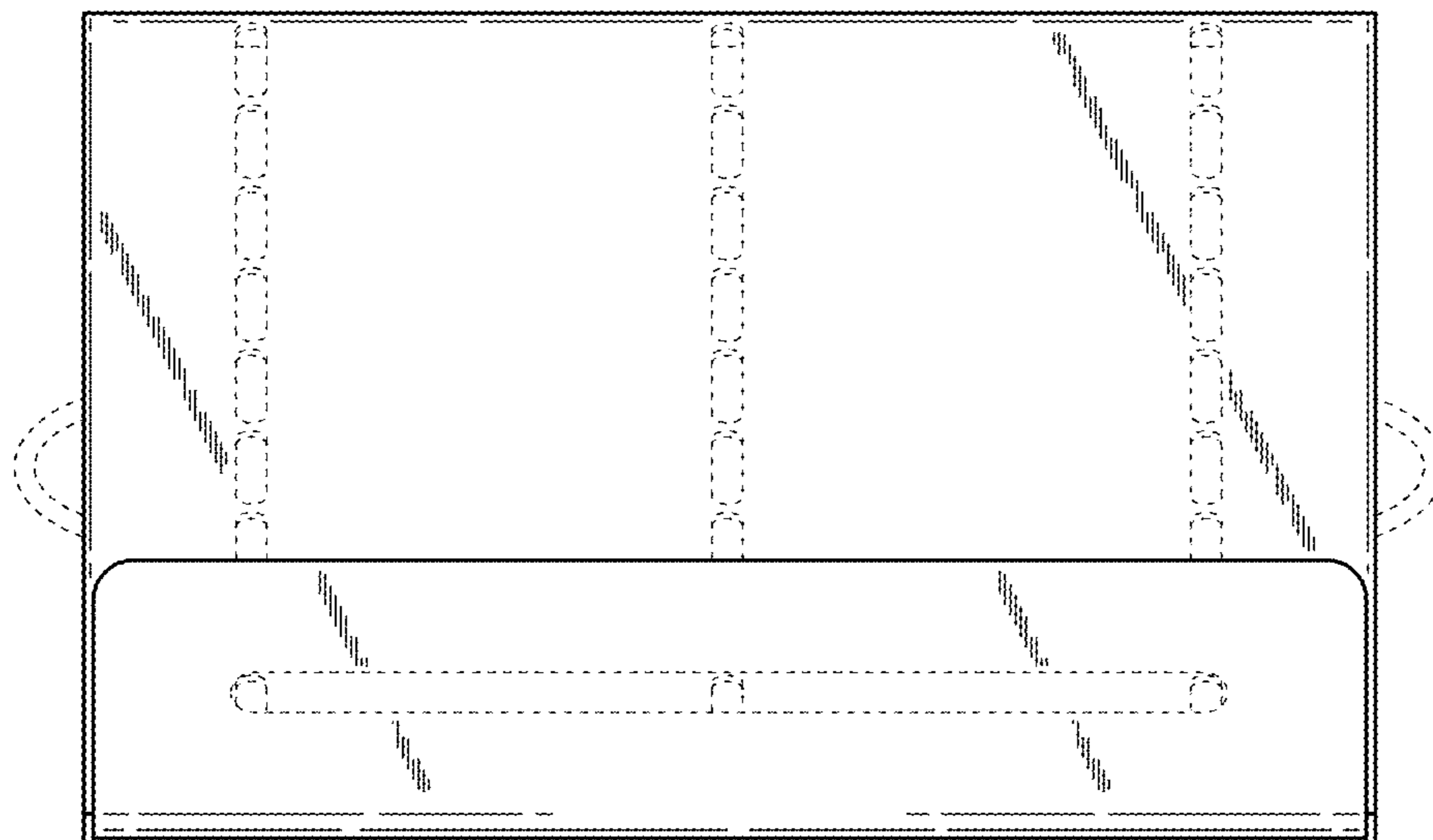

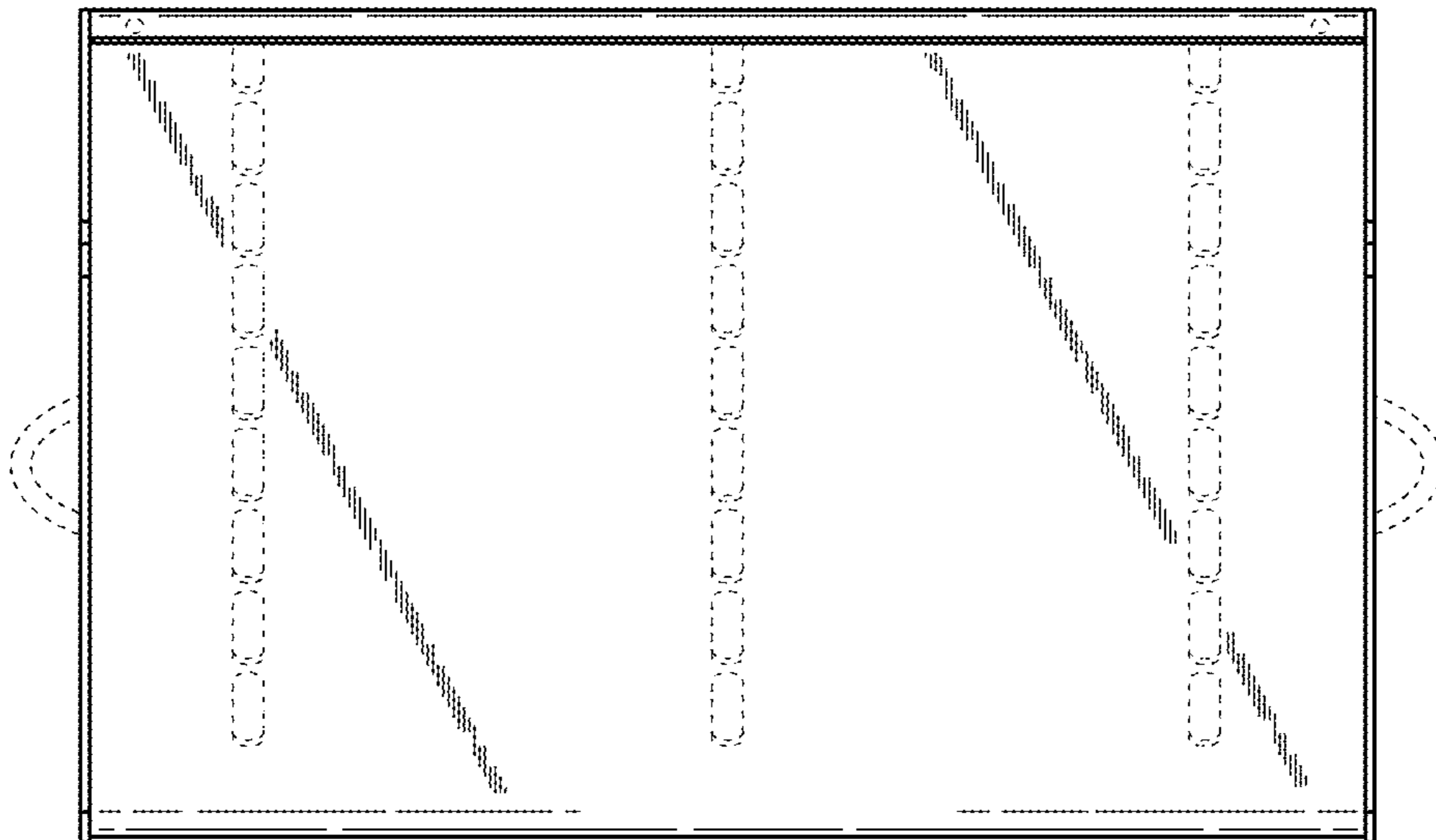

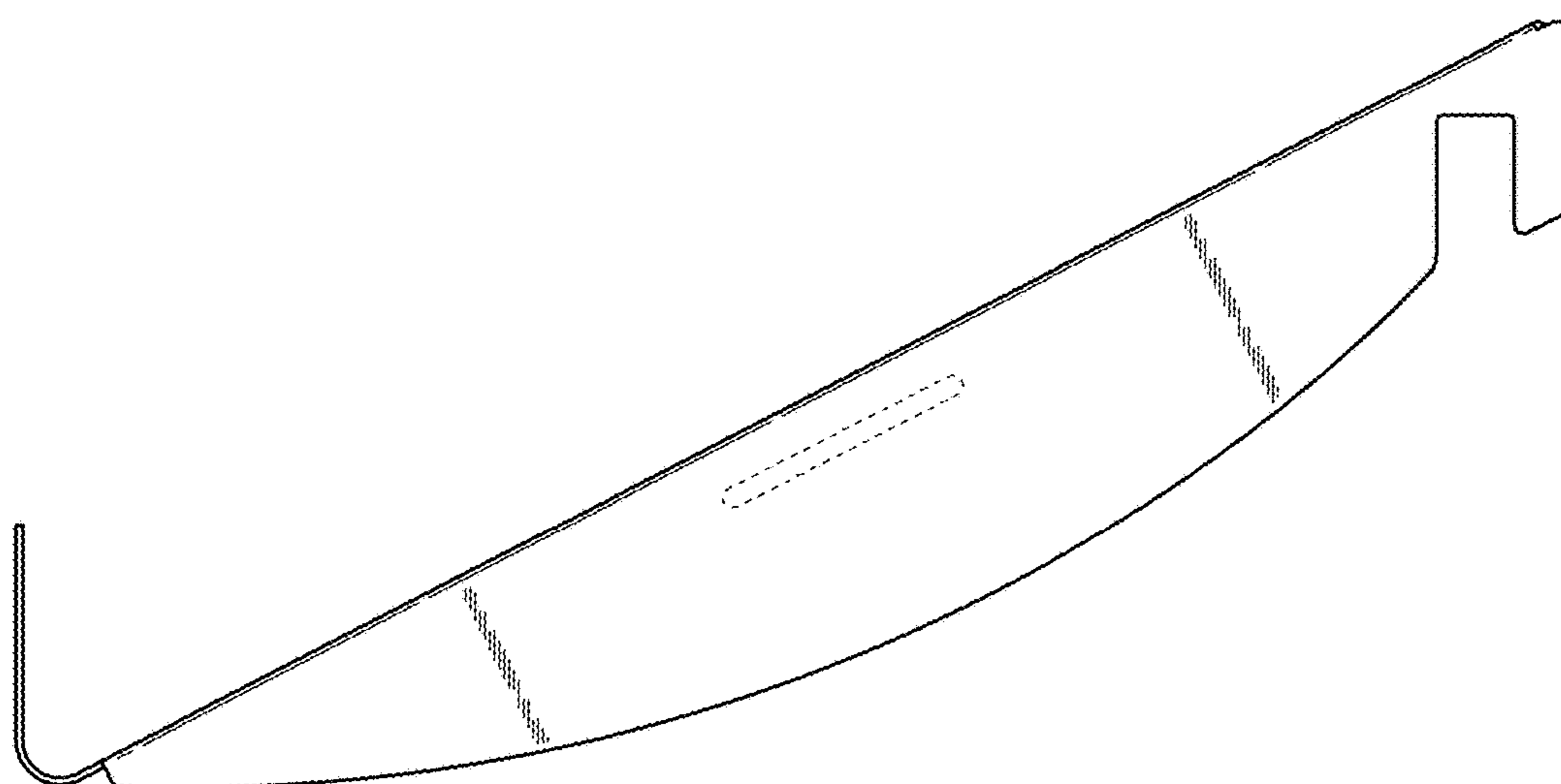

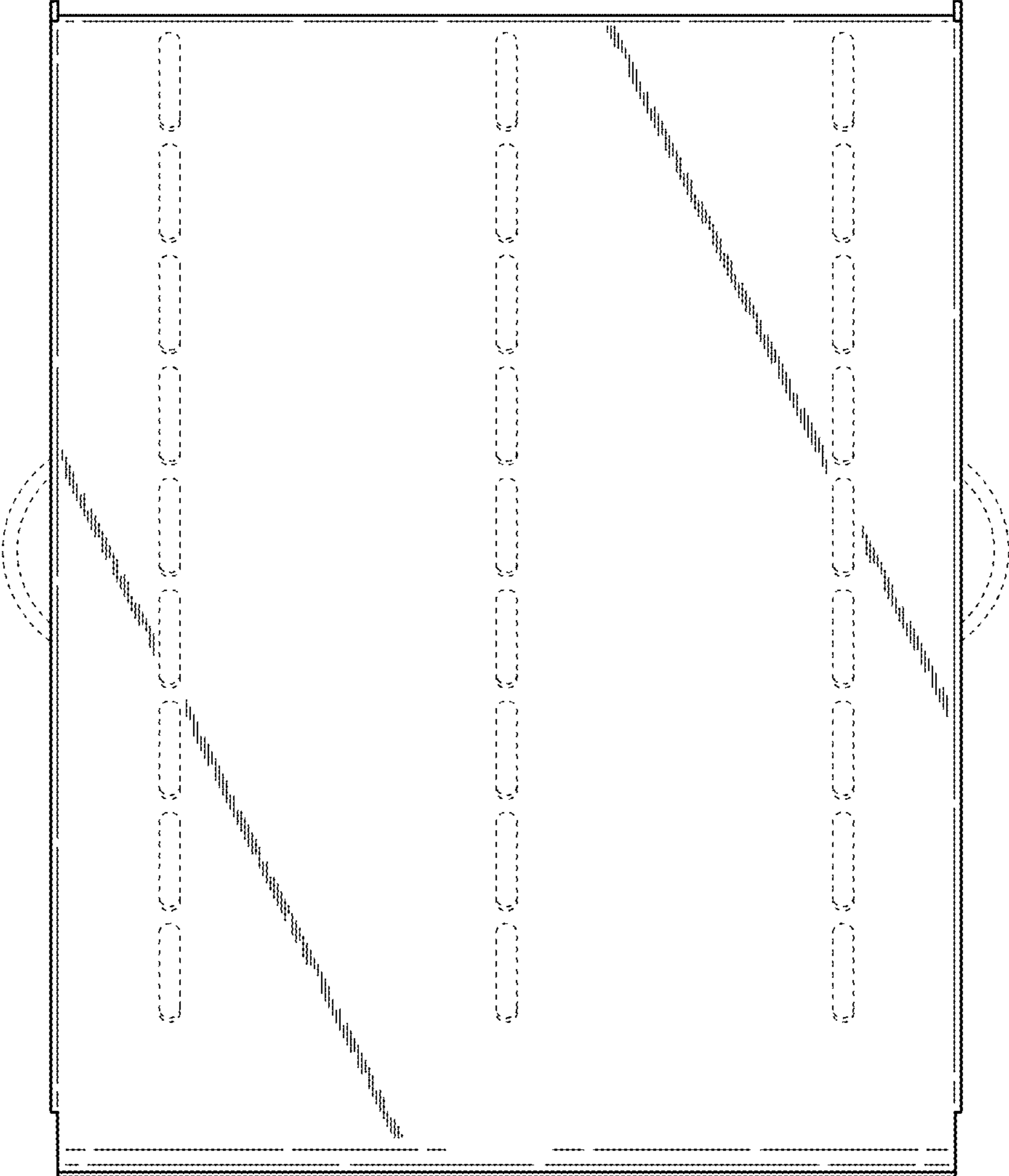

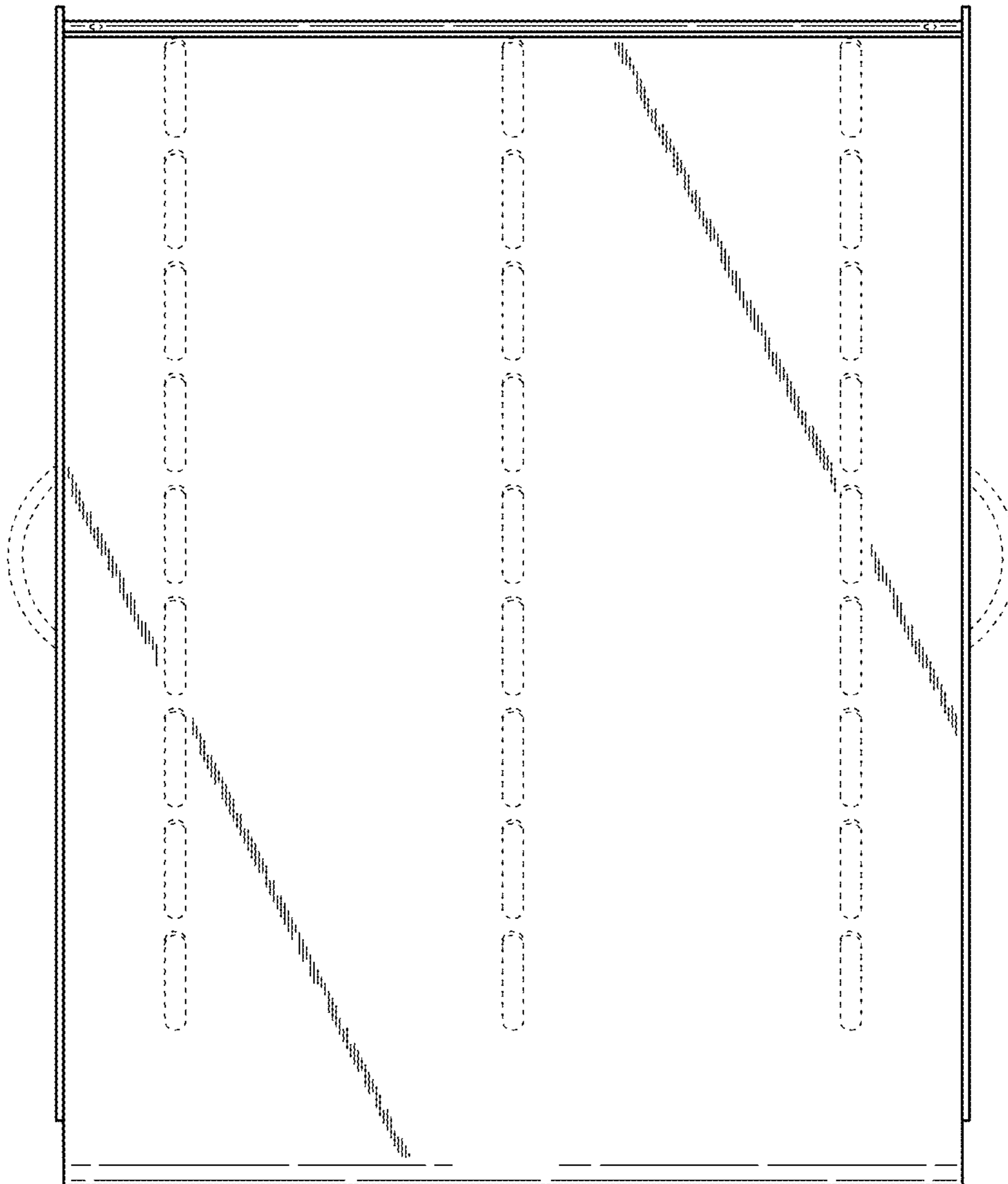

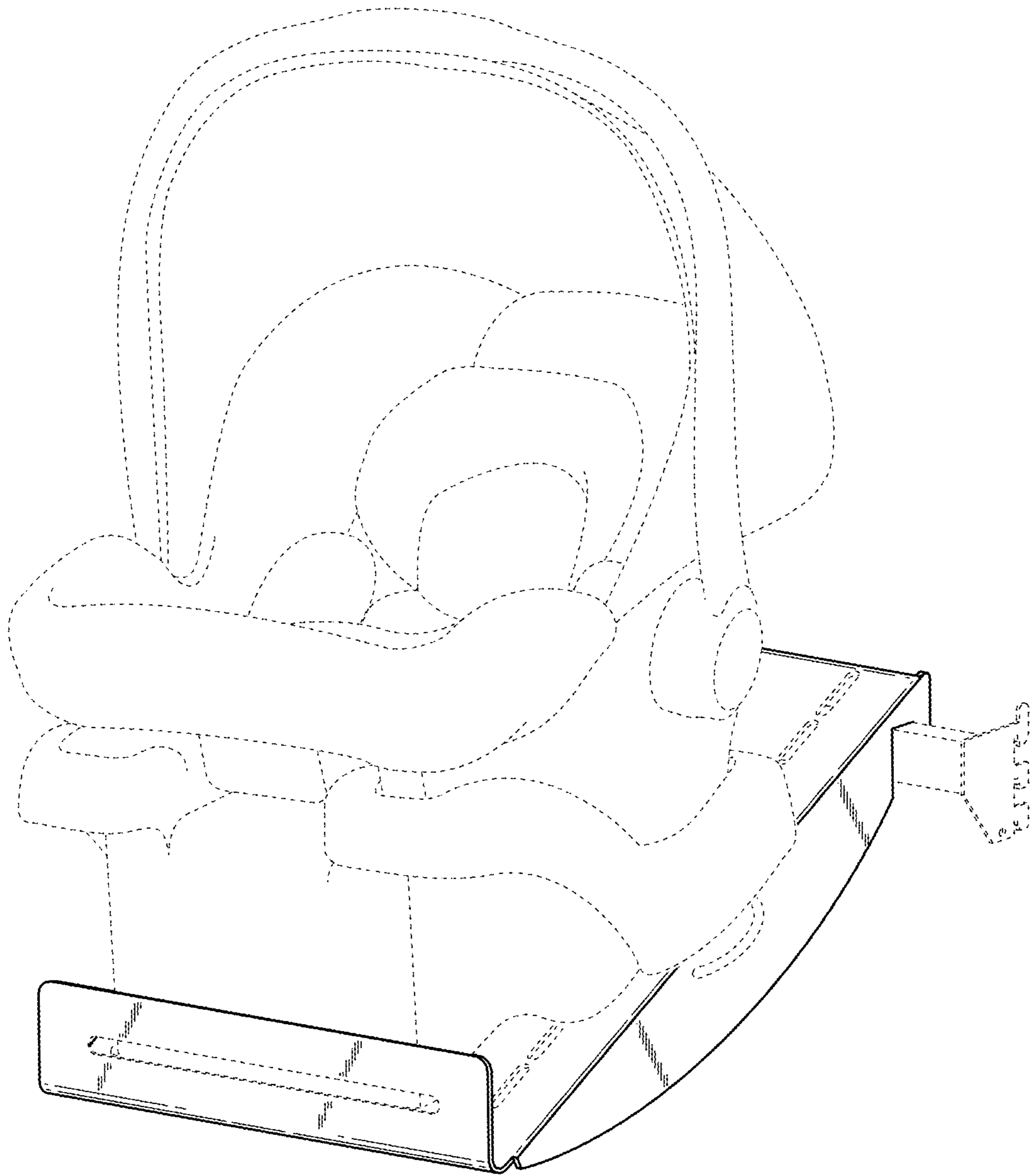

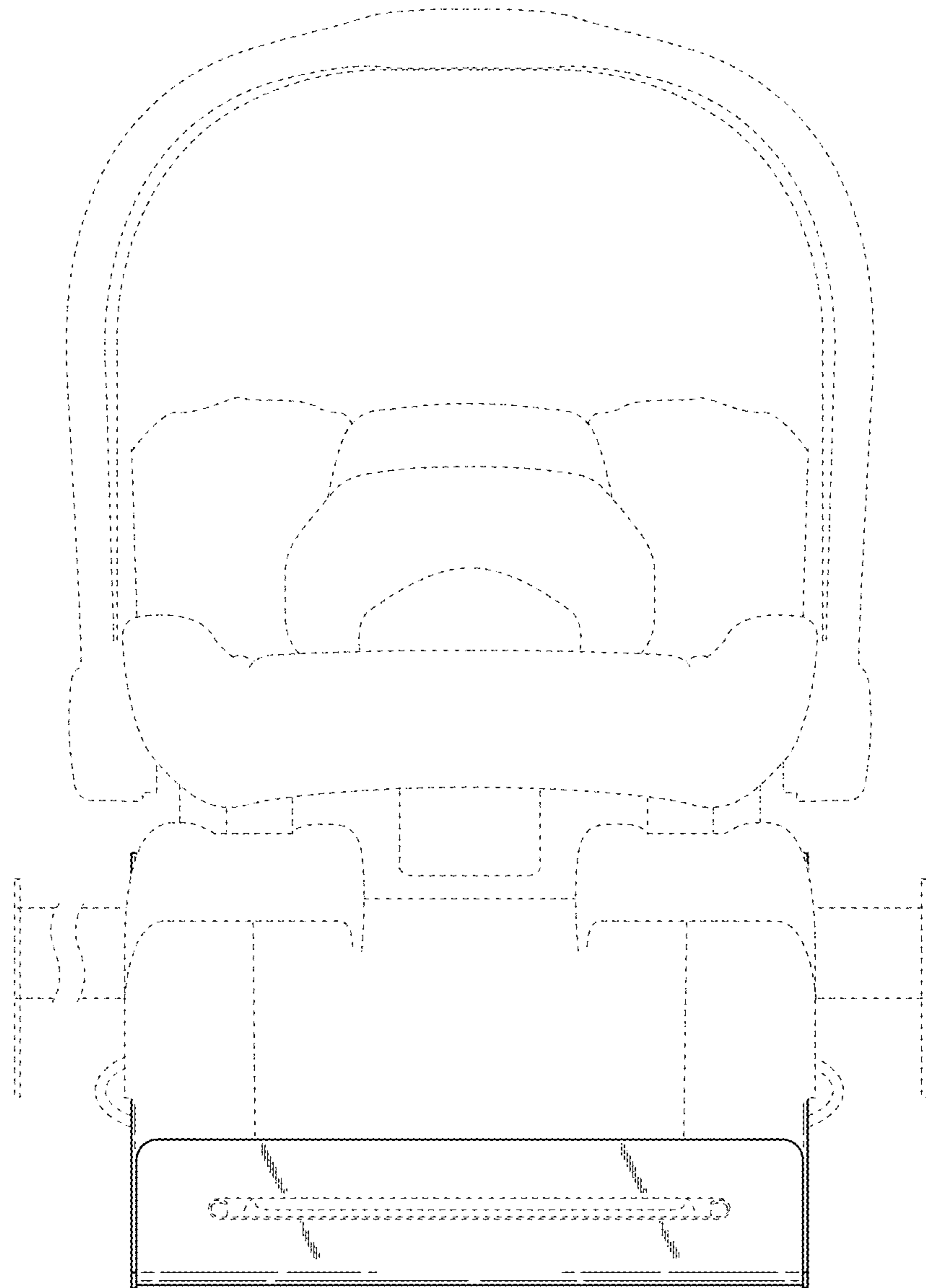

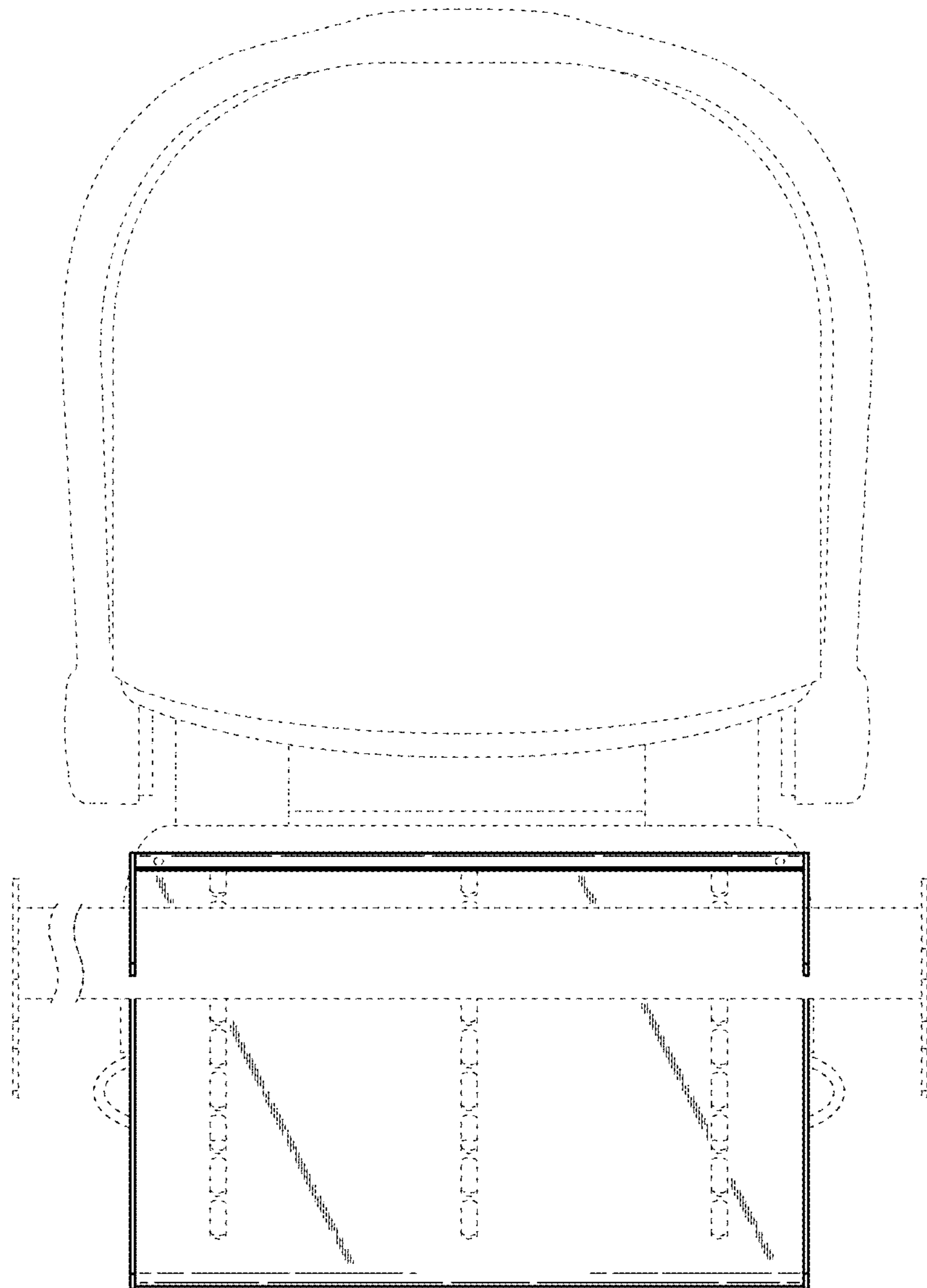

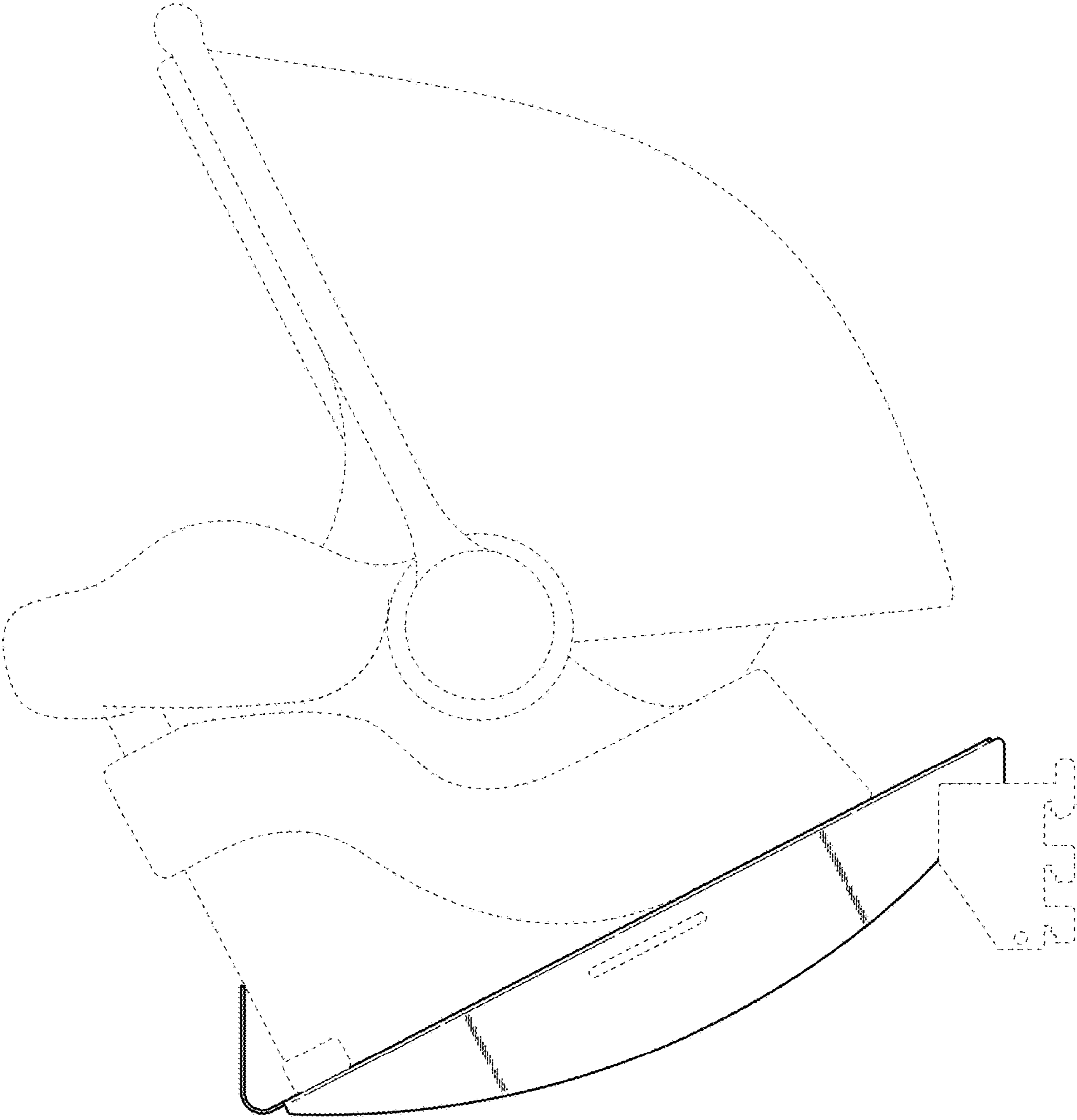

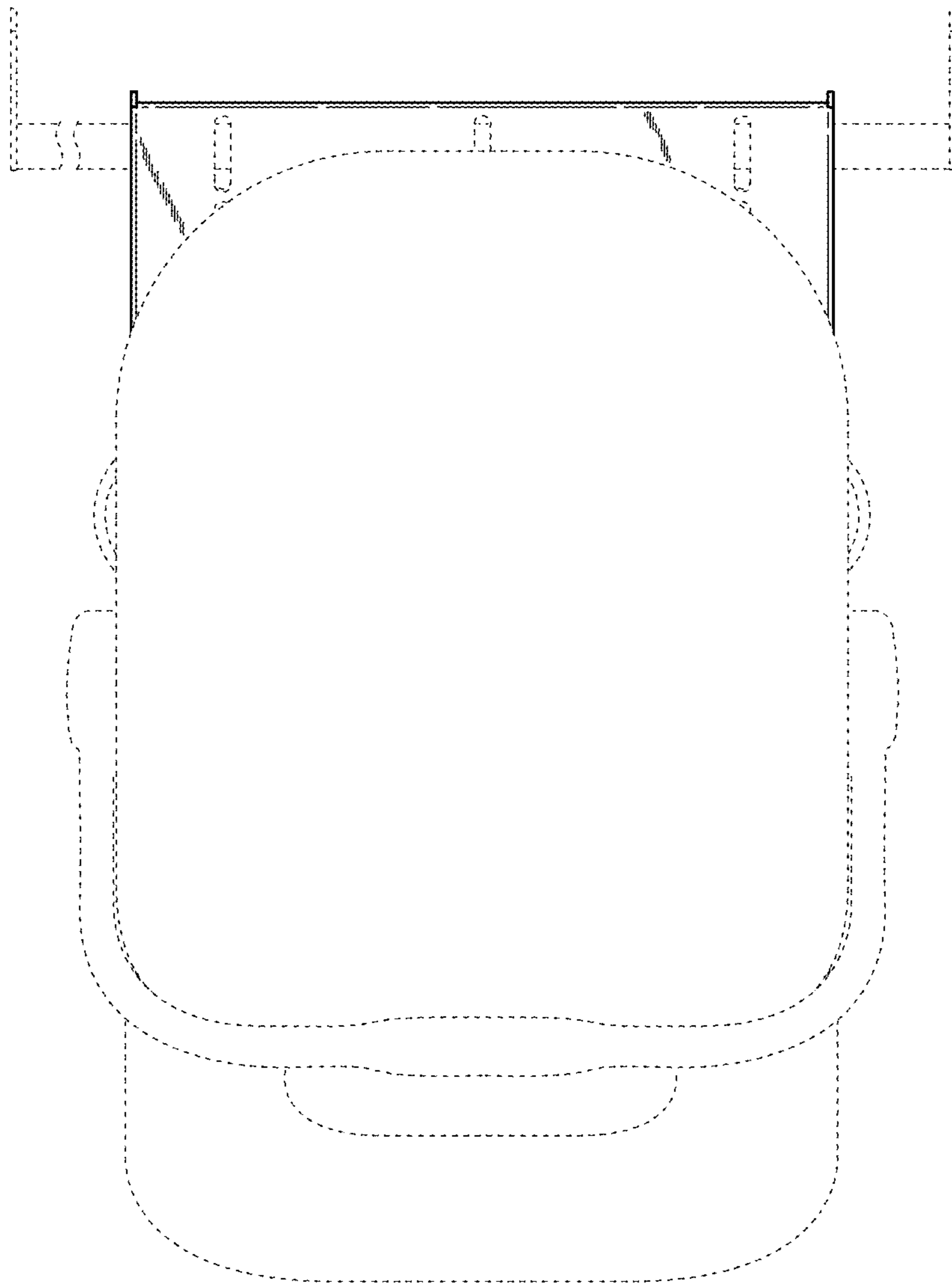

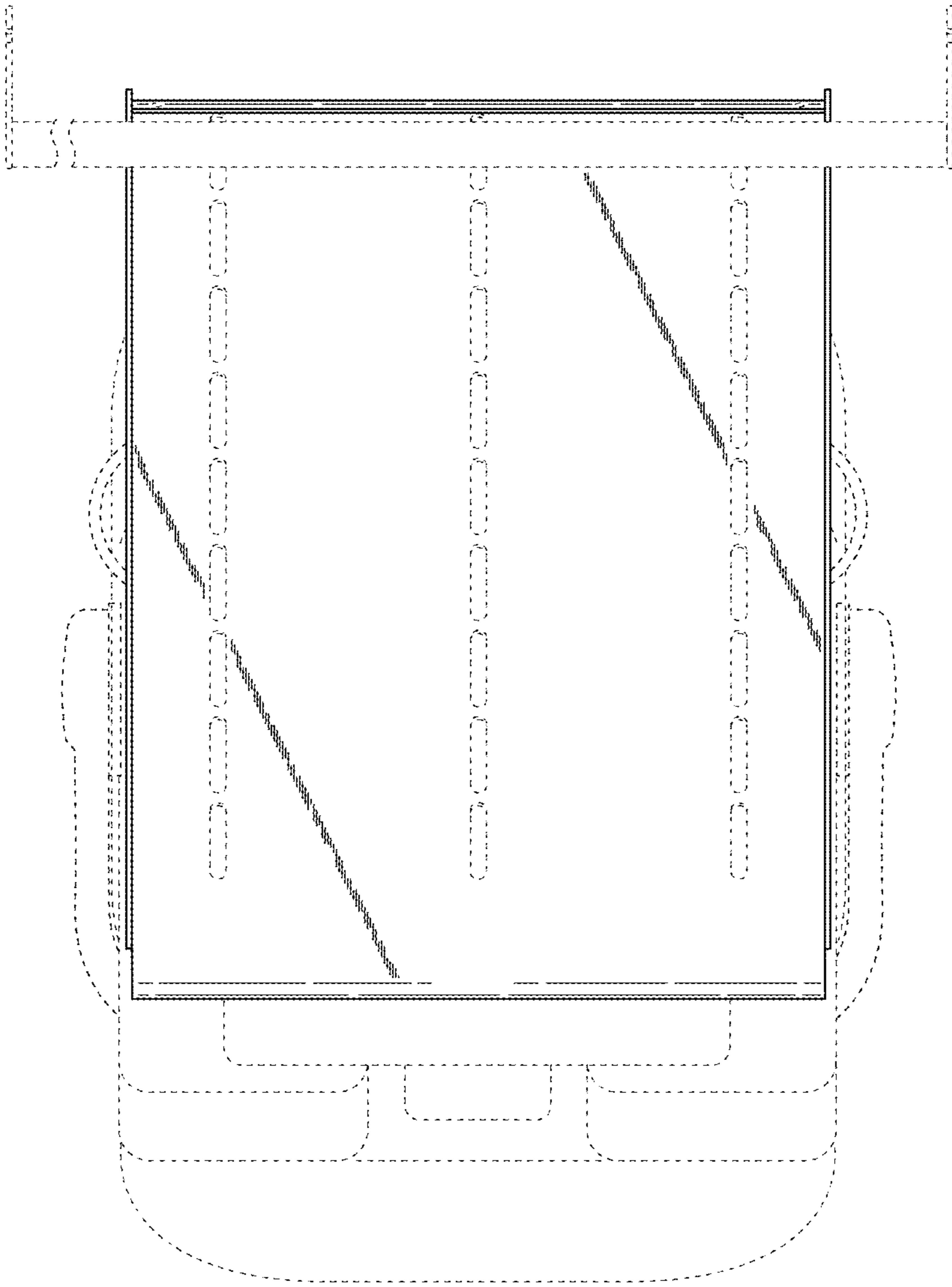
