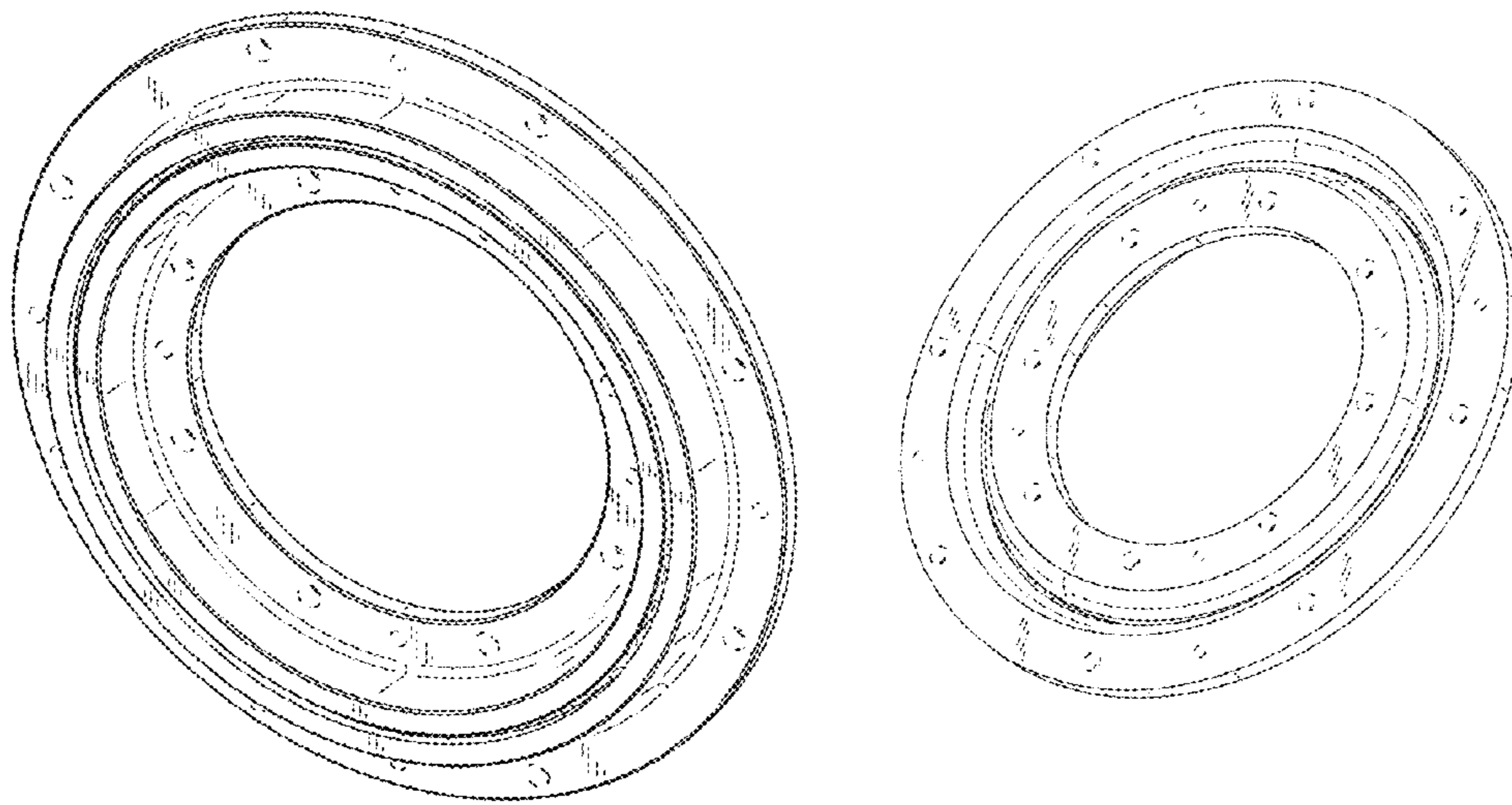
(57) **CLAIM**

The ornamental design for a roller bearing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a roller bearing showing our new design.
FIG. 2 is a rear elevational view thereof.
FIG. 3 is a right side elevational view thereof.
FIG. 4 is a left side elevational view thereof.
FIG. 5 is a top plan view thereof.
FIG. 6 is a bottom plan view thereof.
FIG. 7 is a cross-sectional view, taken along line 7-7 of FIG. 1.
FIG. 8 is a front perspective view thereof; and,
FIG. 9 is a rear perspective view thereof.

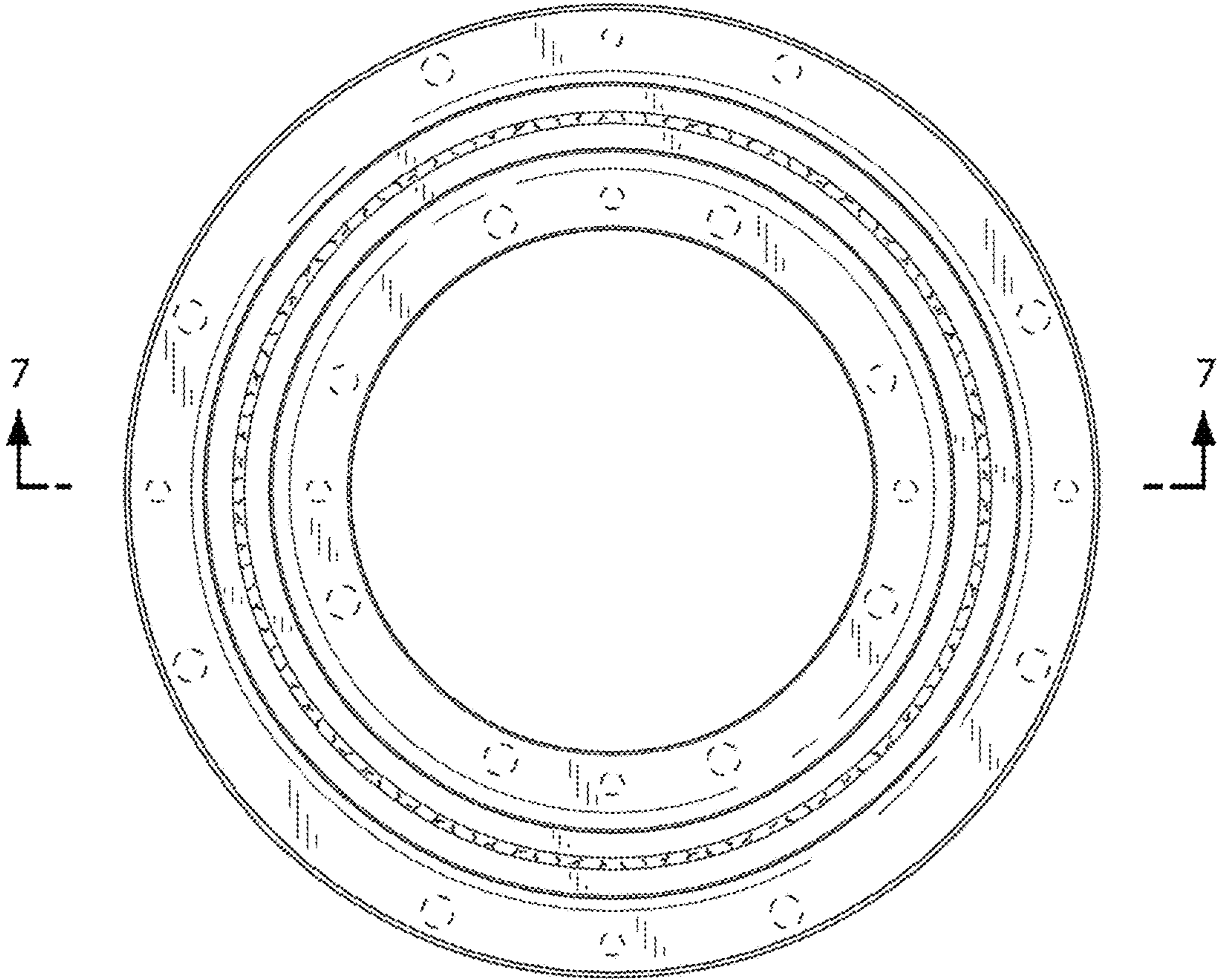

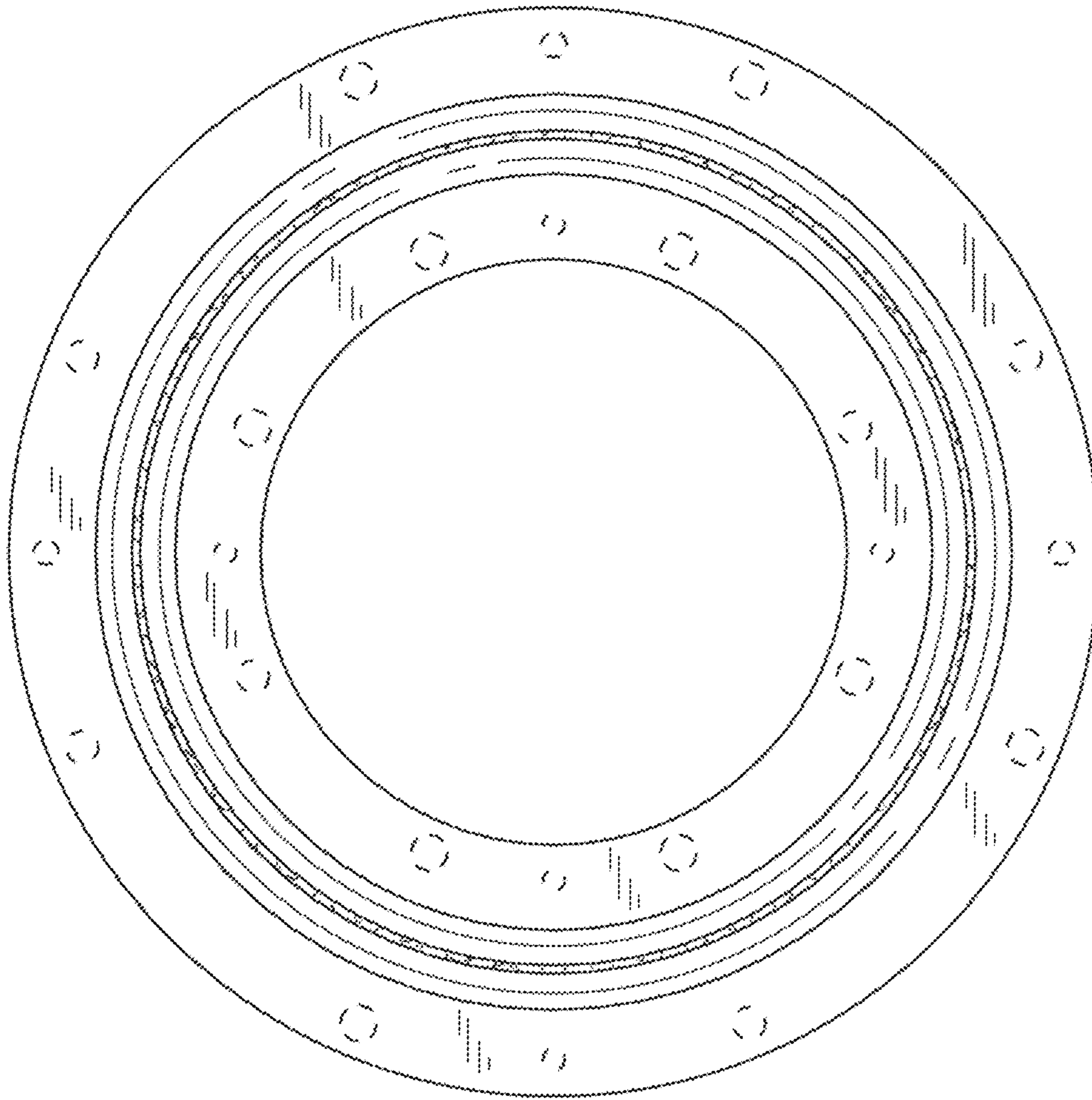

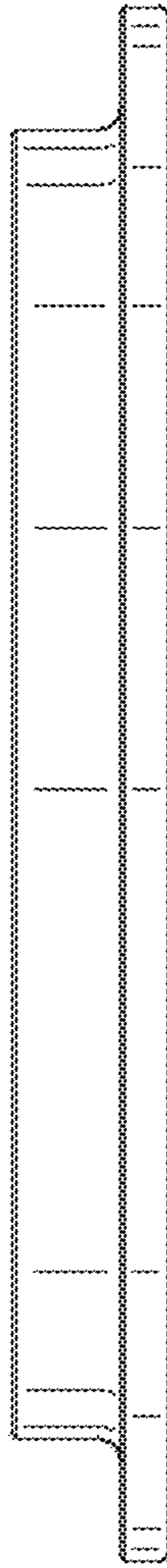

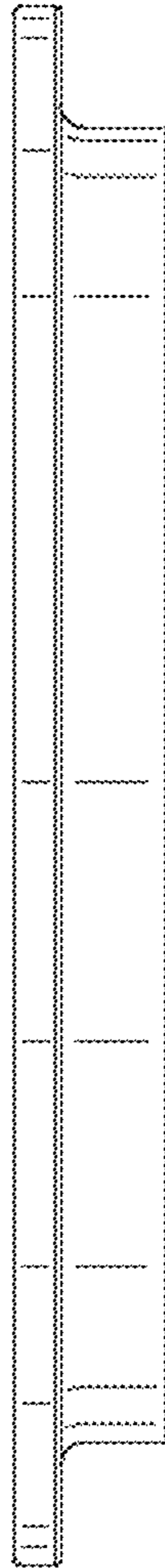

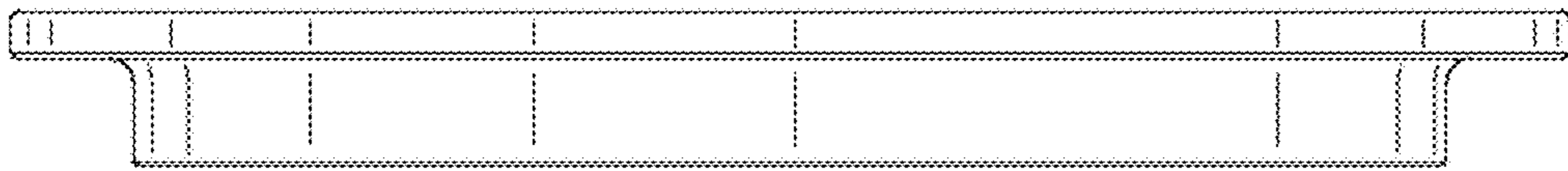

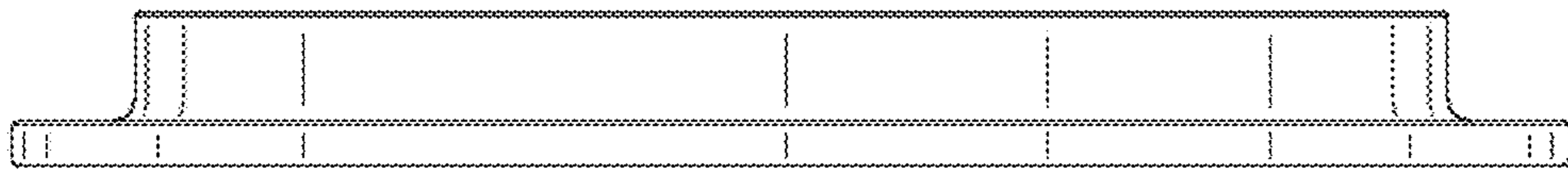

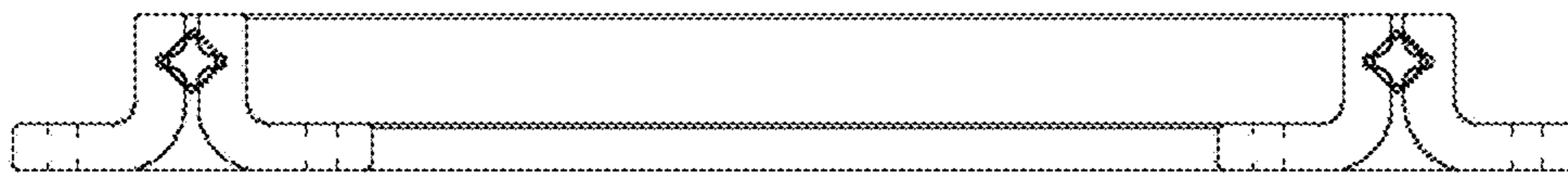

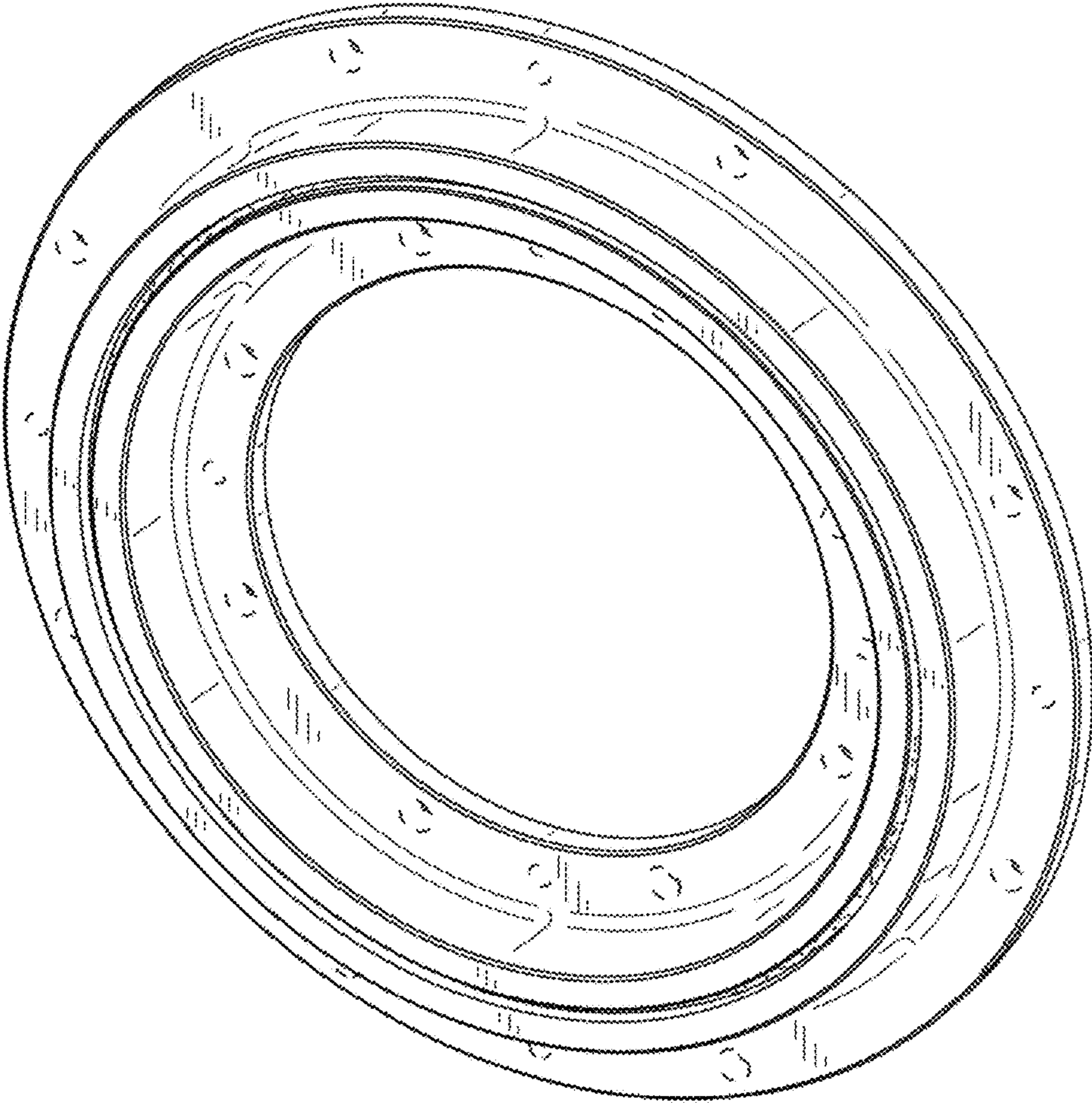

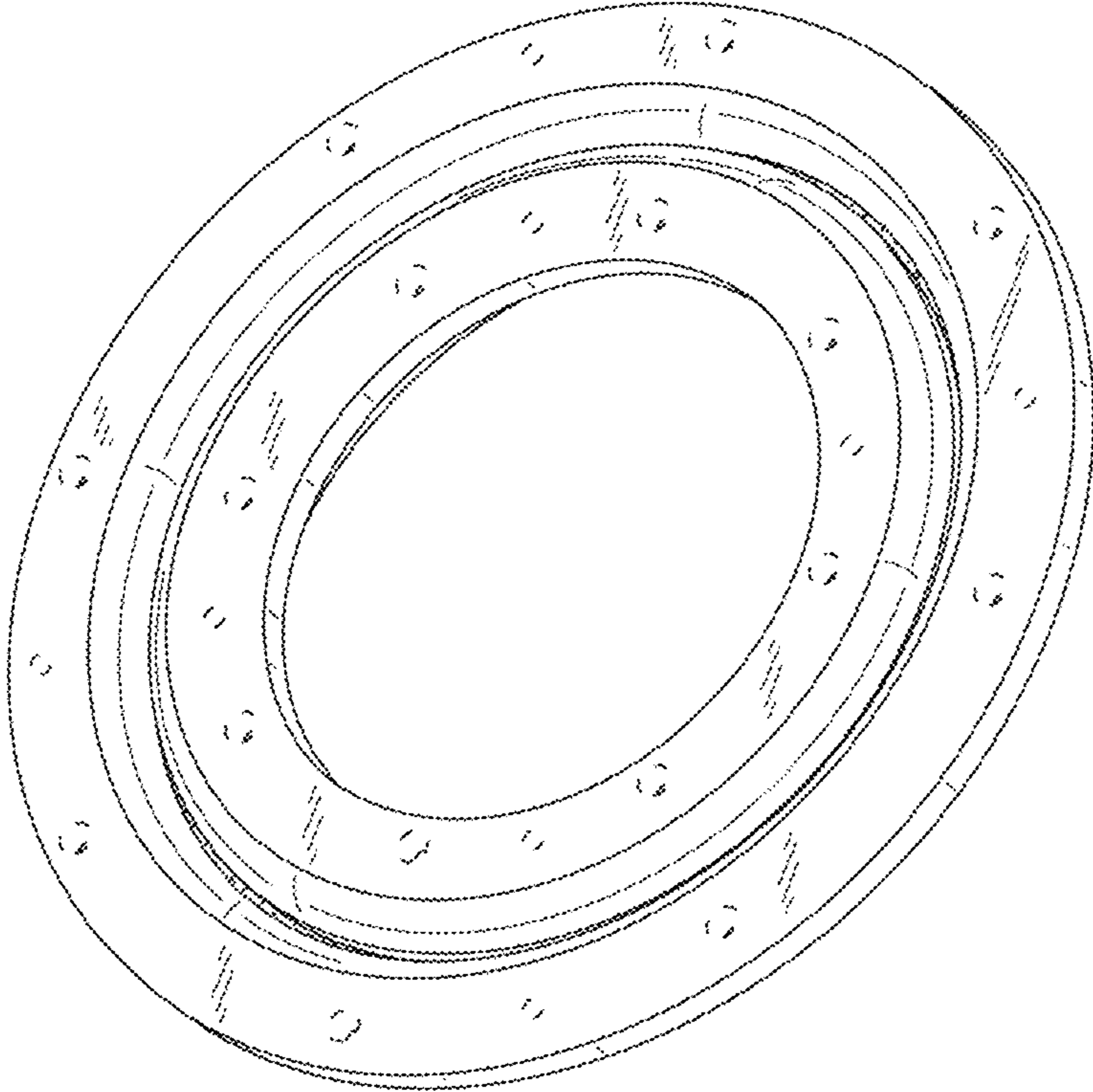
