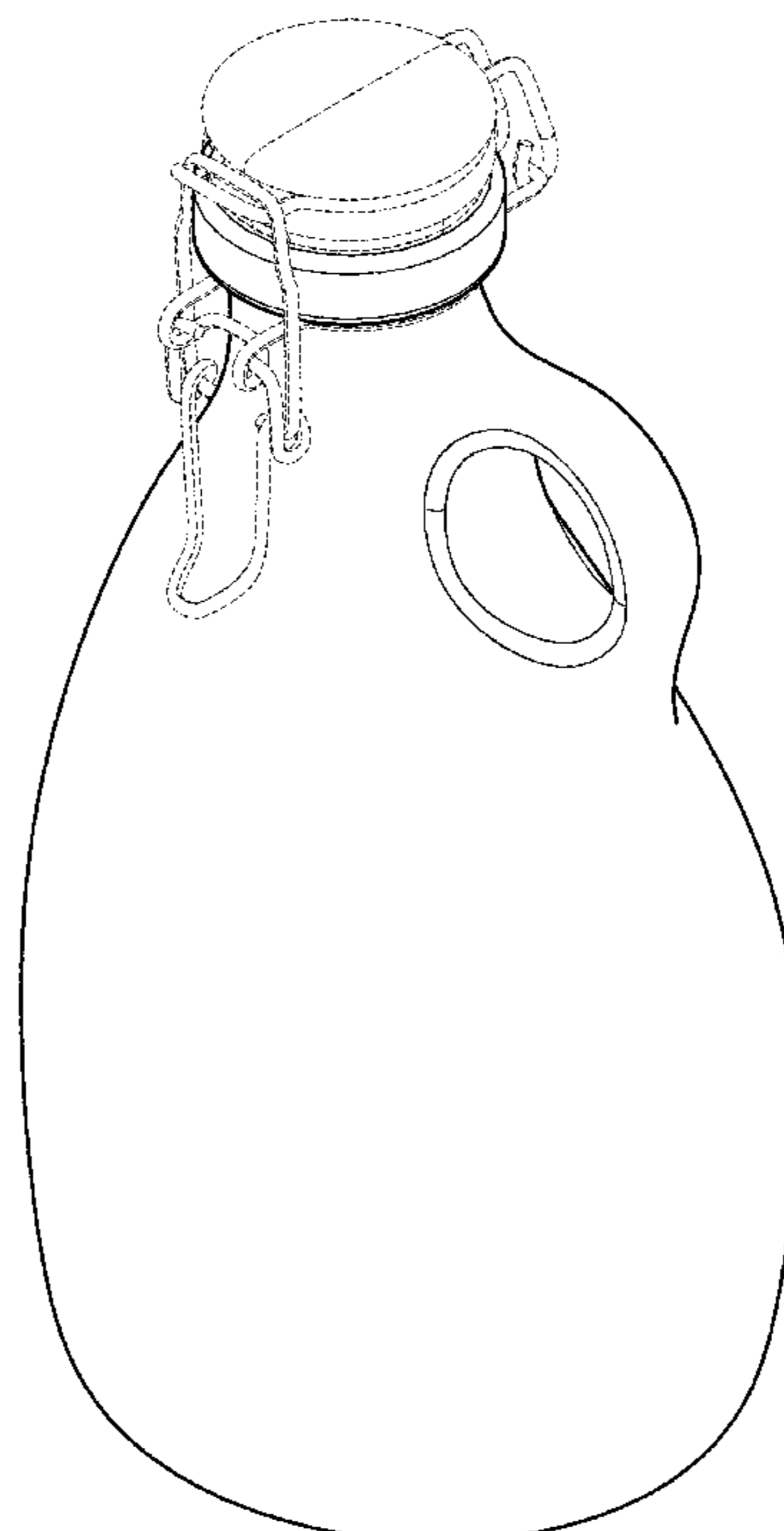
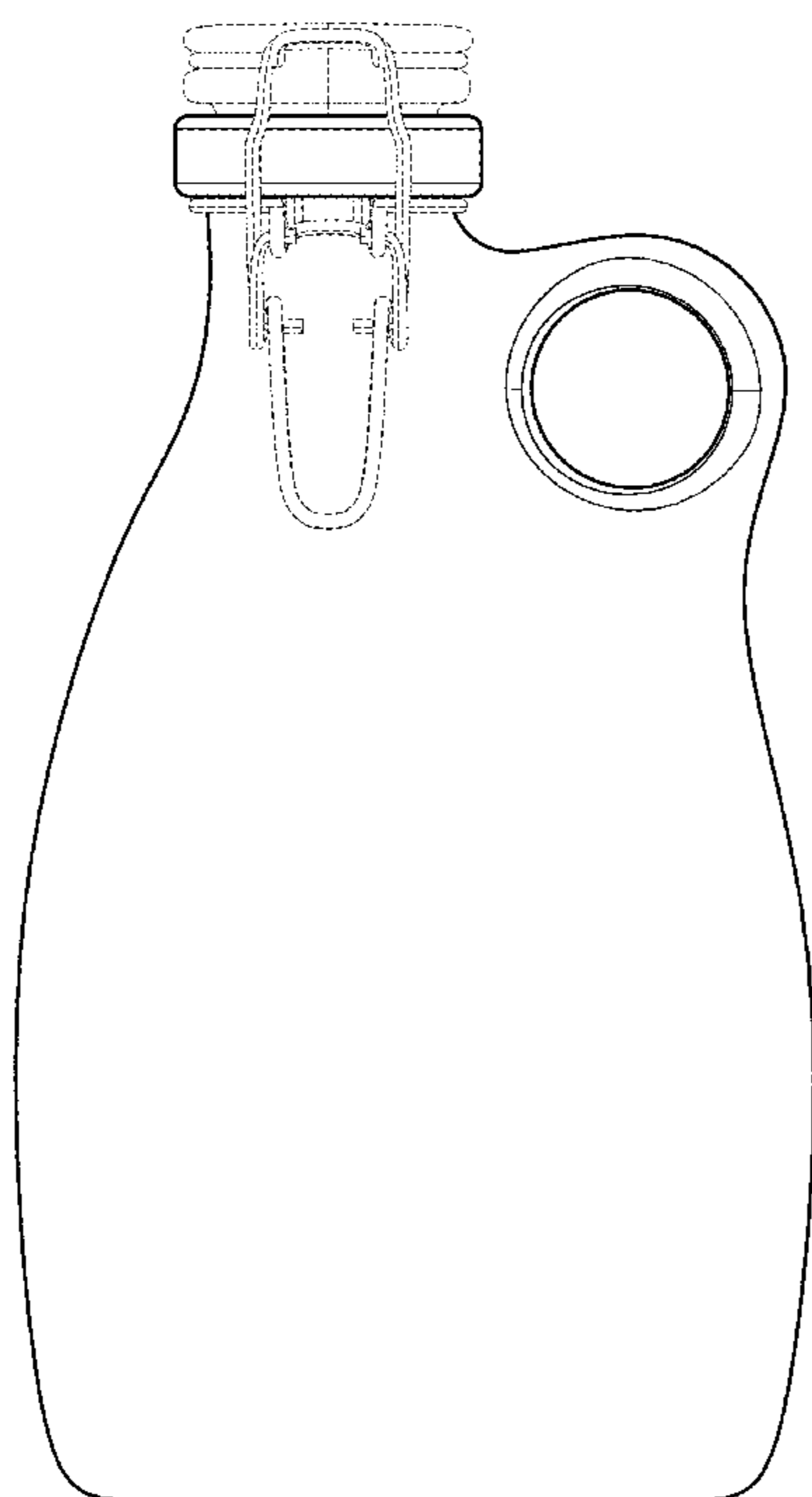
(57) **CLAIM**

The ornamental design for a beer growler, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side view of a beer growler, and the right side view being a mirror image thereof, showing our new design; FIG. 2 is a back view thereof; FIG. 3 is a front view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a left side perspective view thereof.

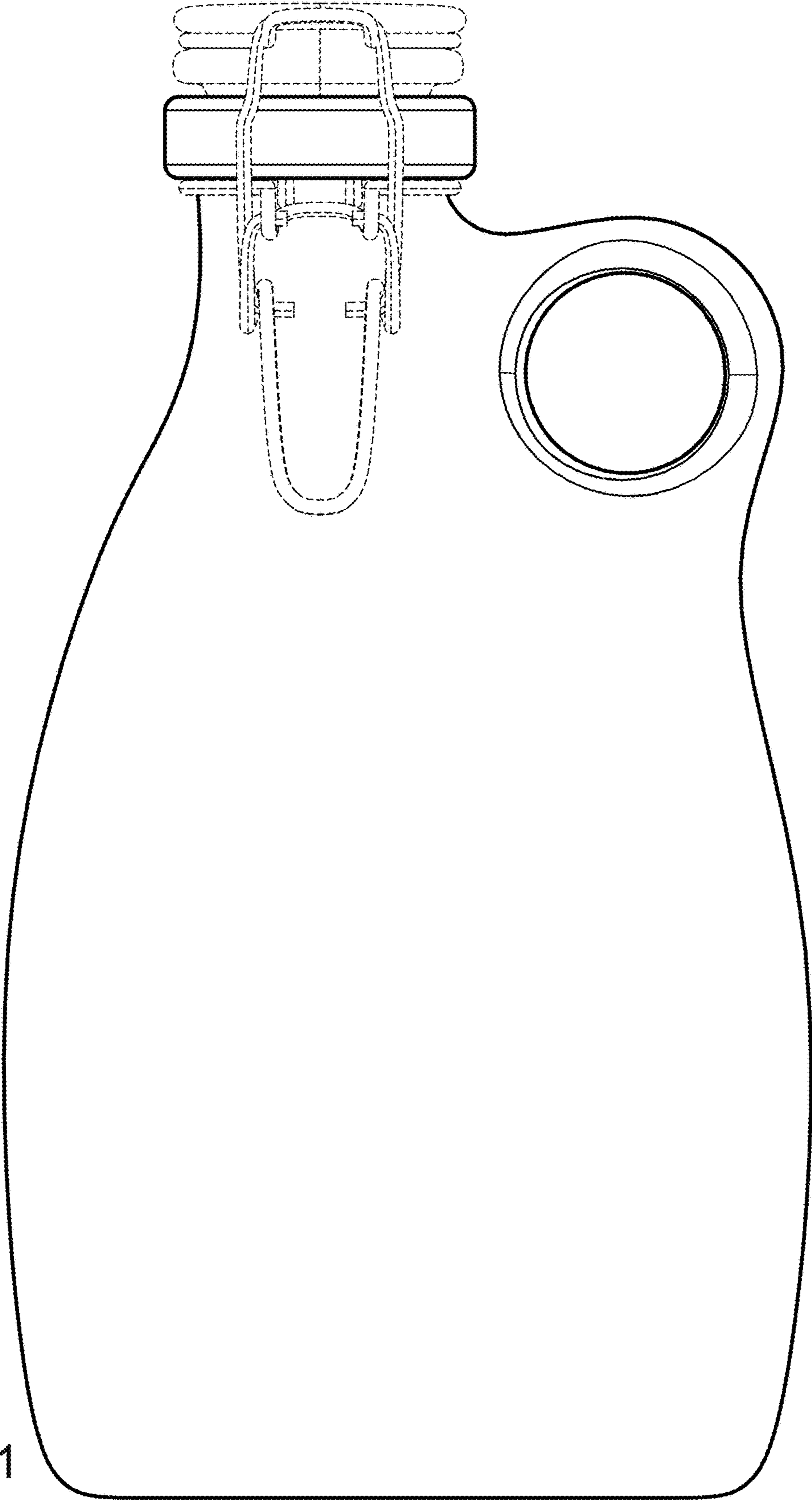

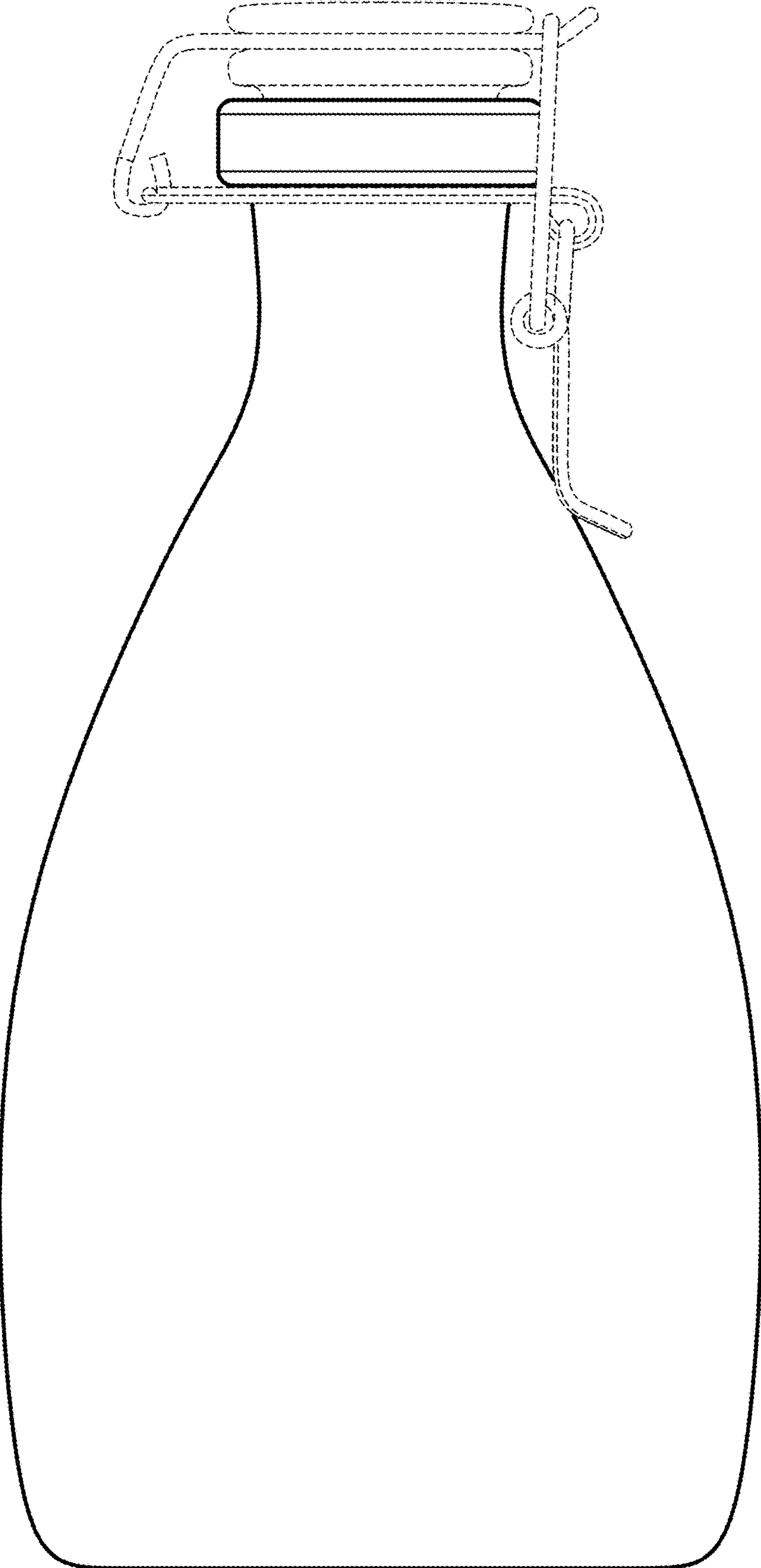

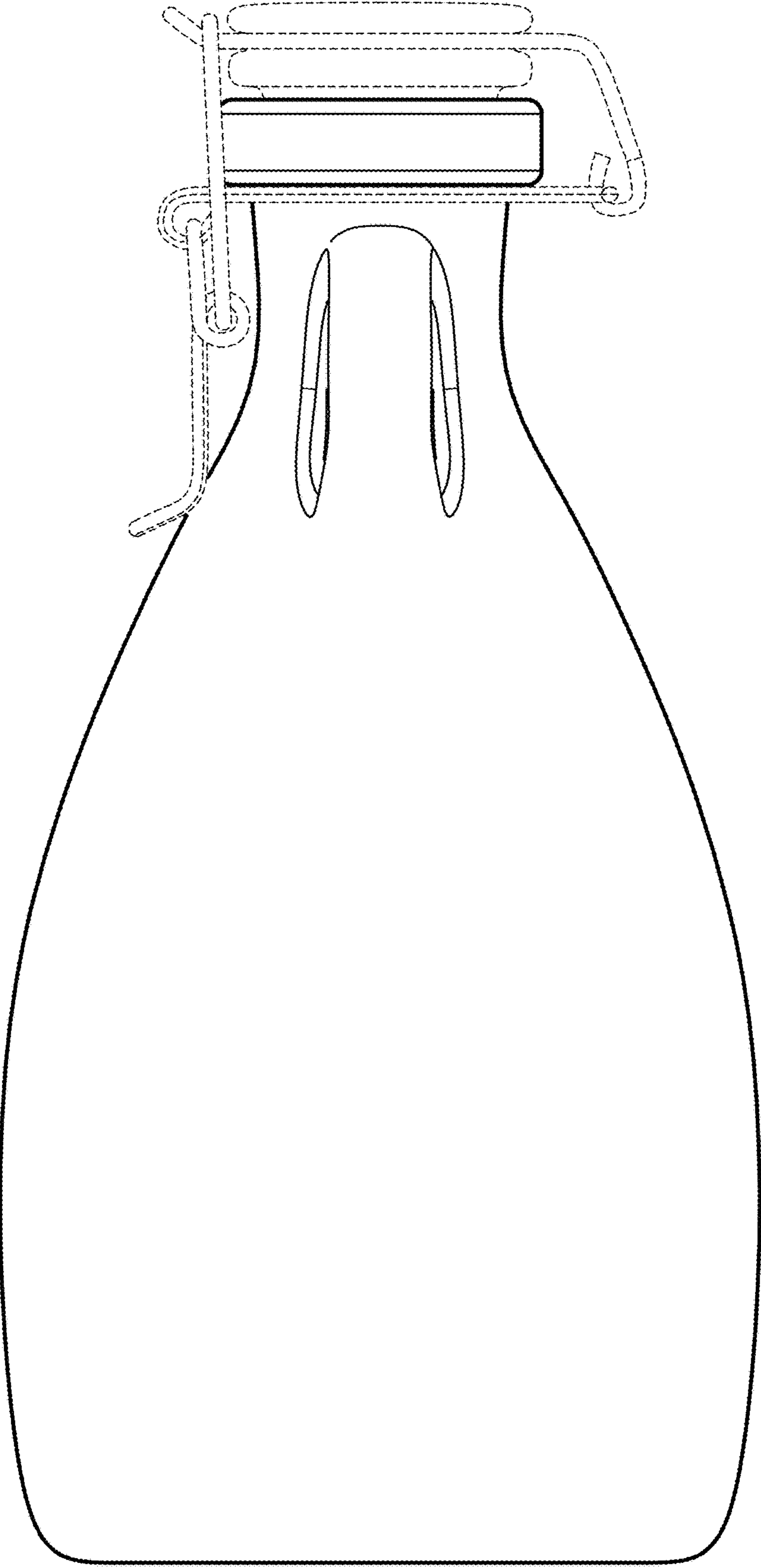

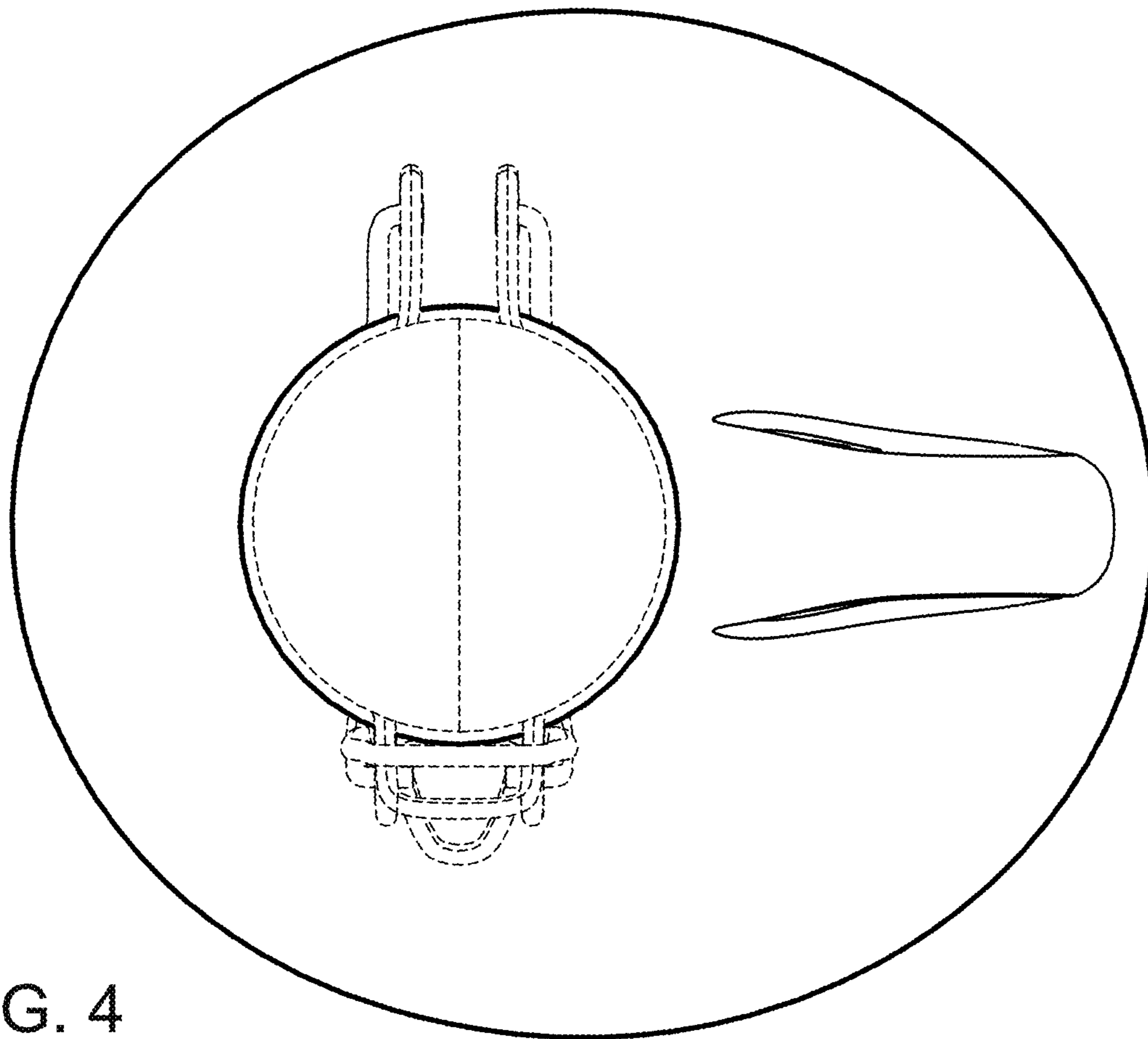

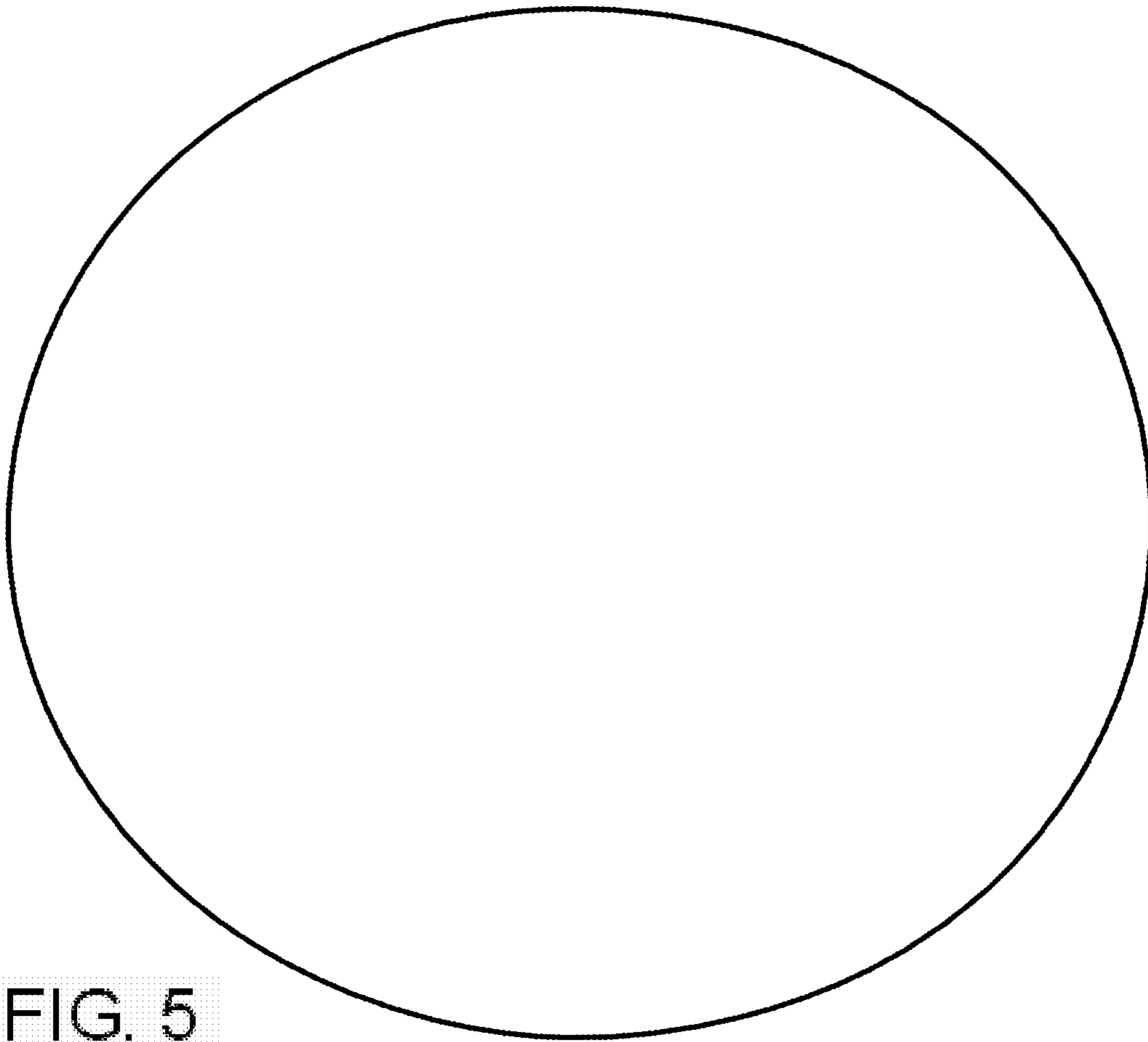

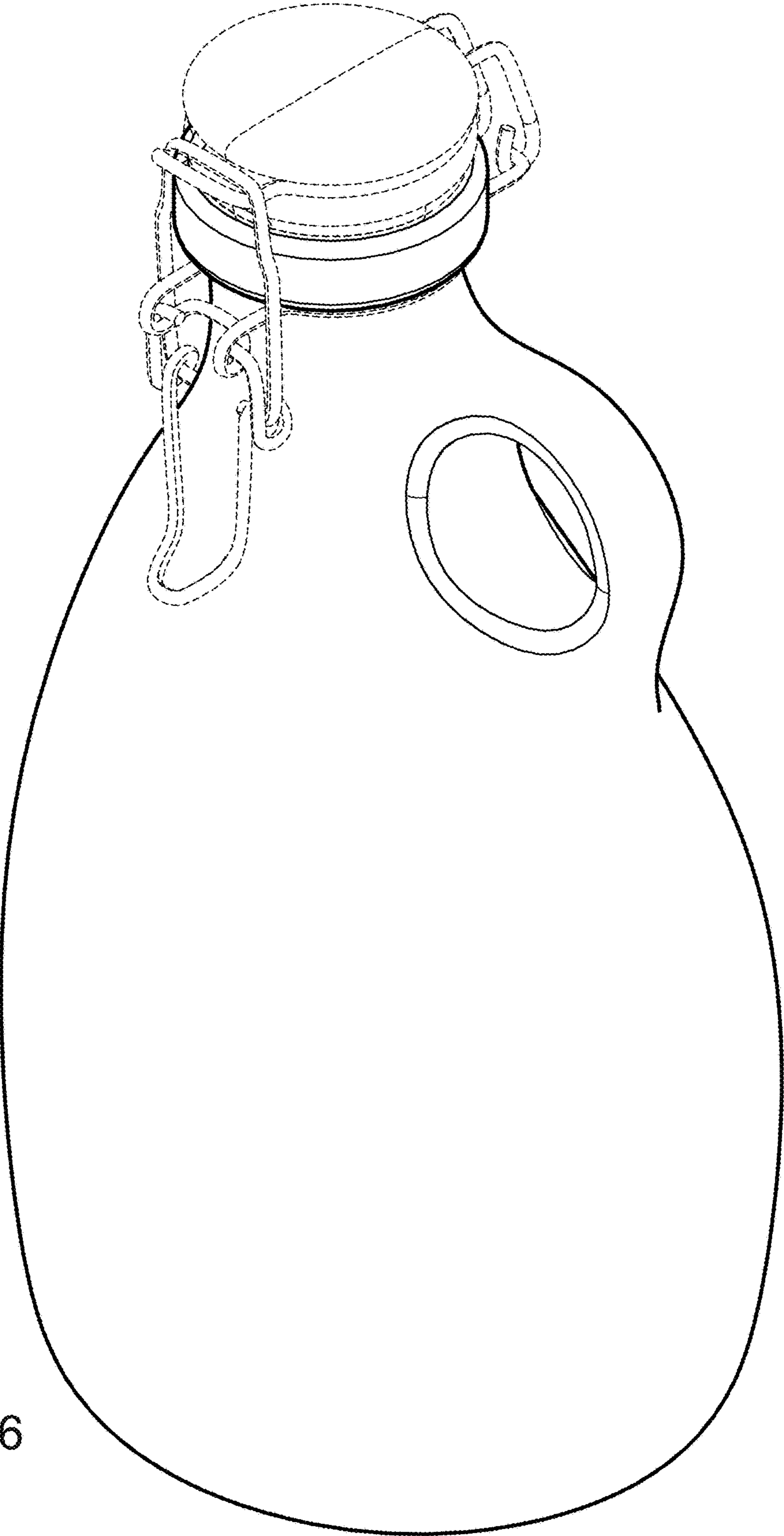
