DESCRIPTION

FIG. 1 is a top, front, left side isometric view of a bottle with cap embodying the new design, shown with an unclaimed valve;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side front elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a back elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

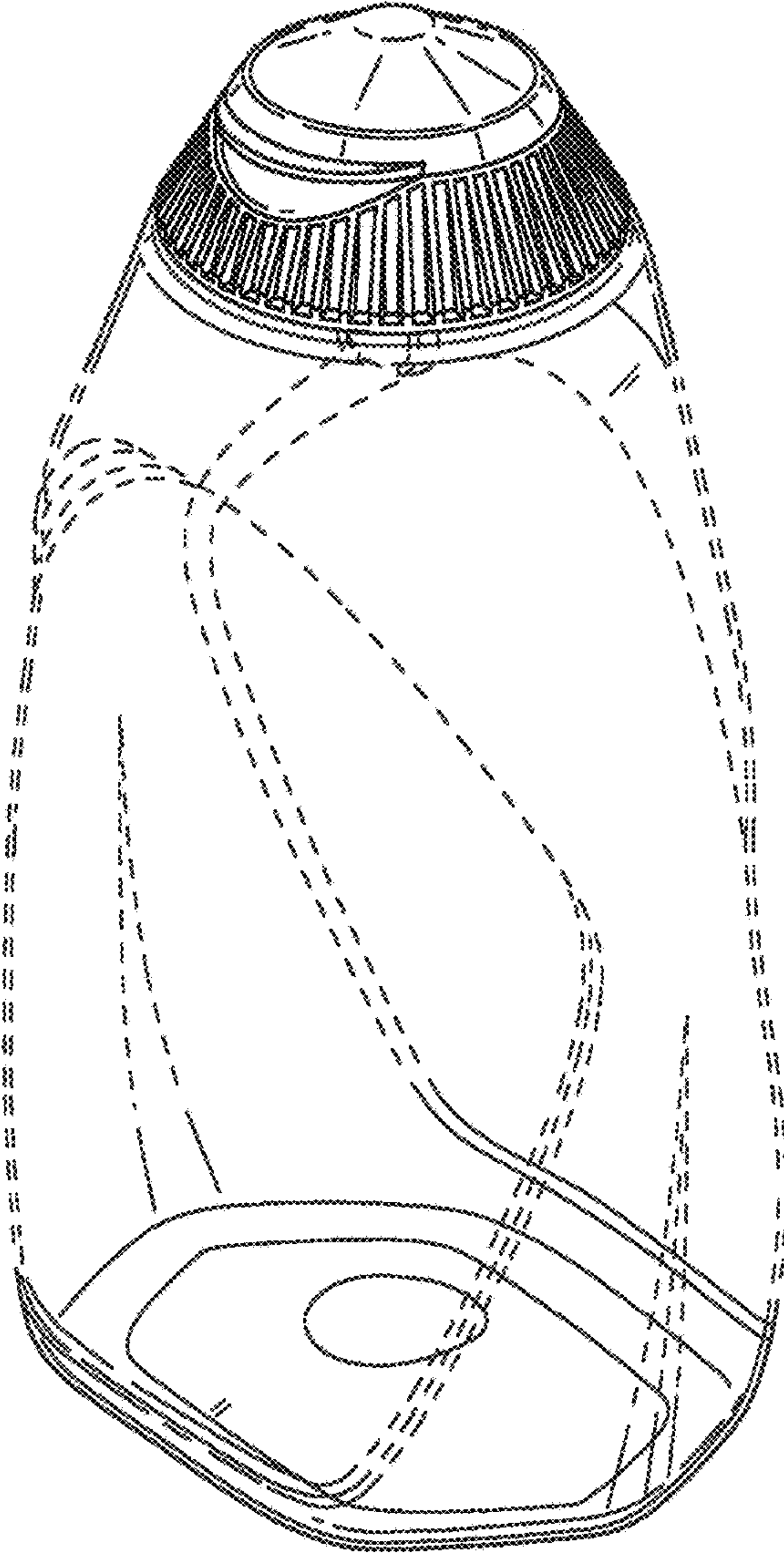

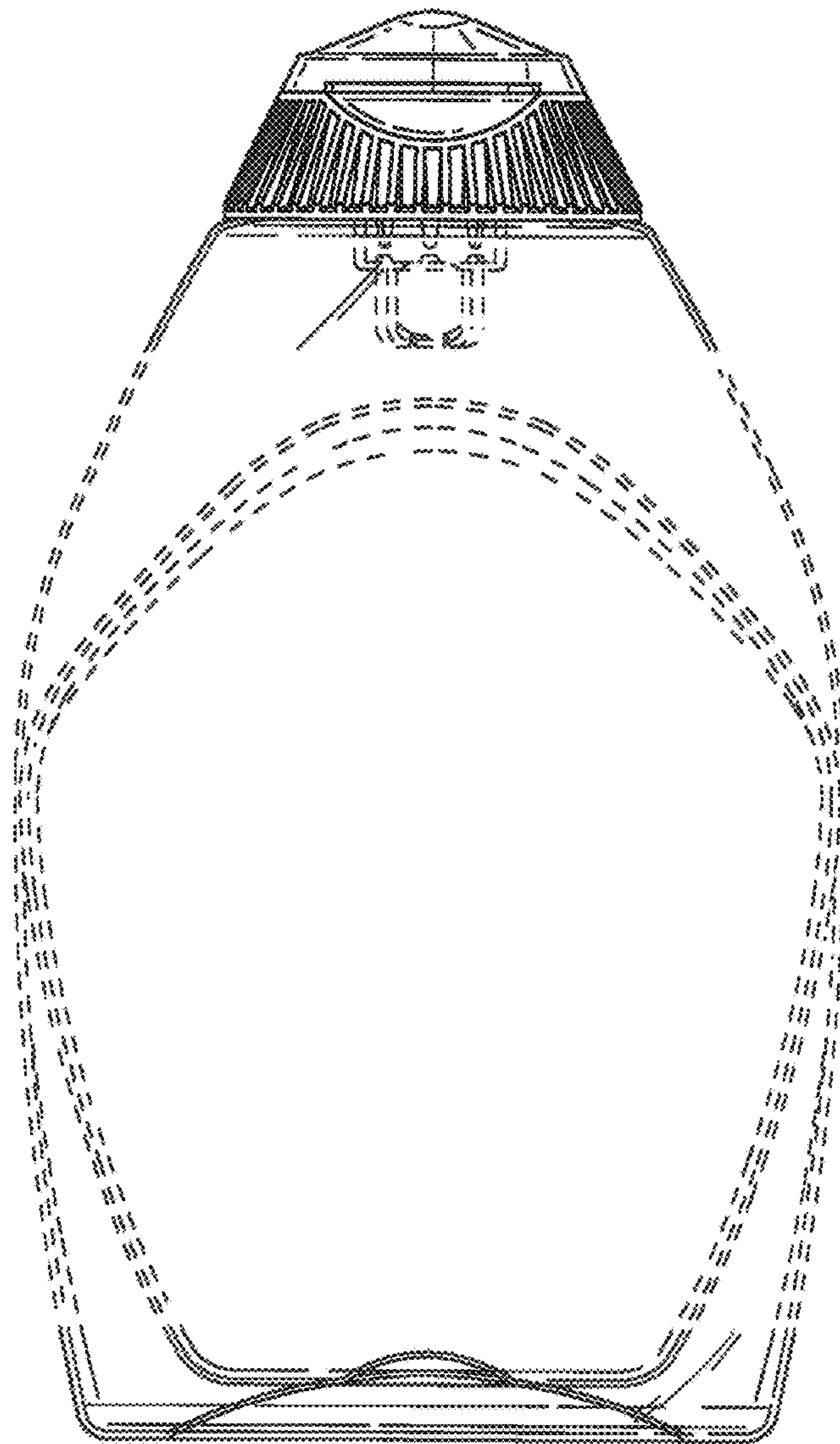

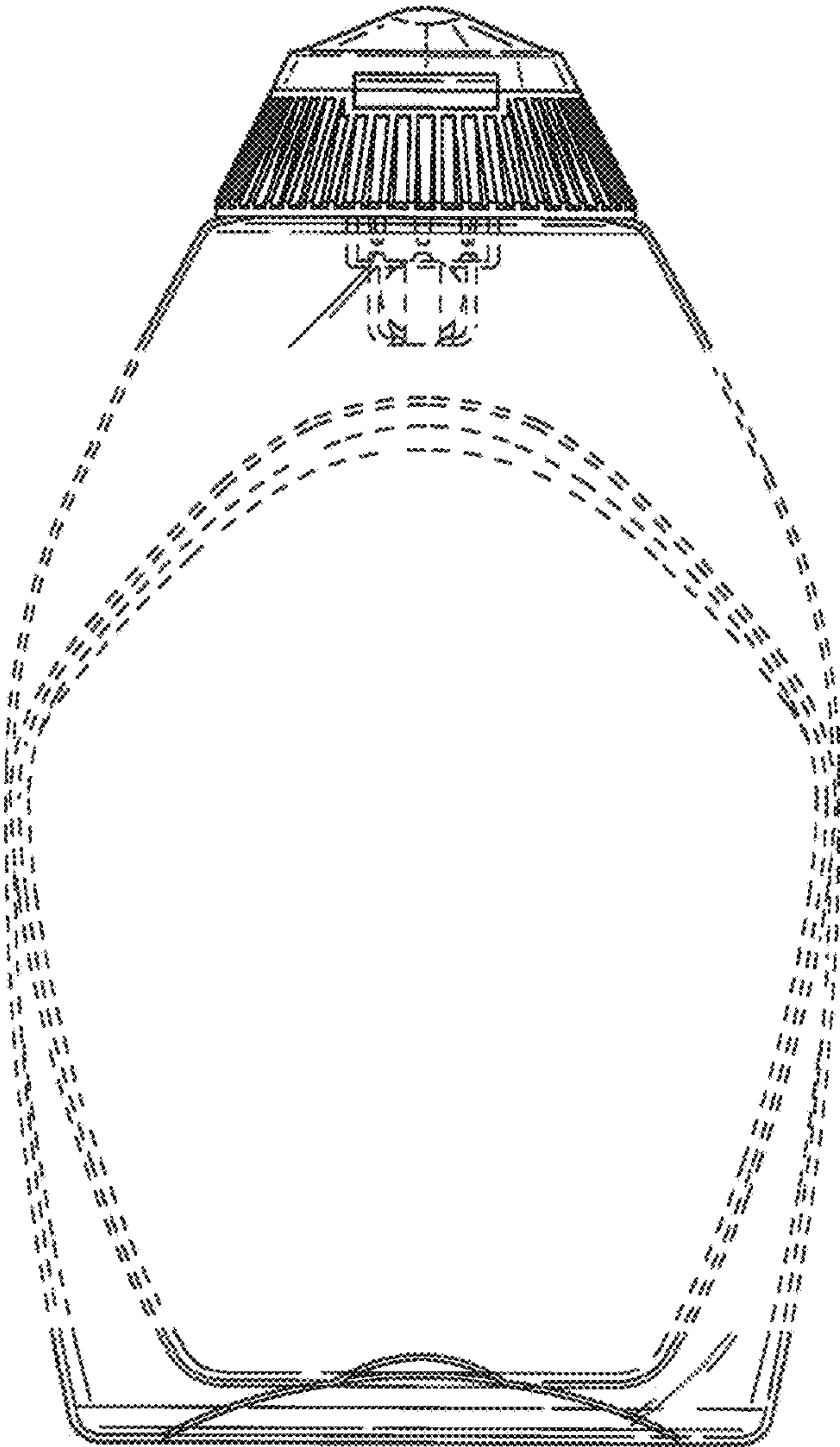

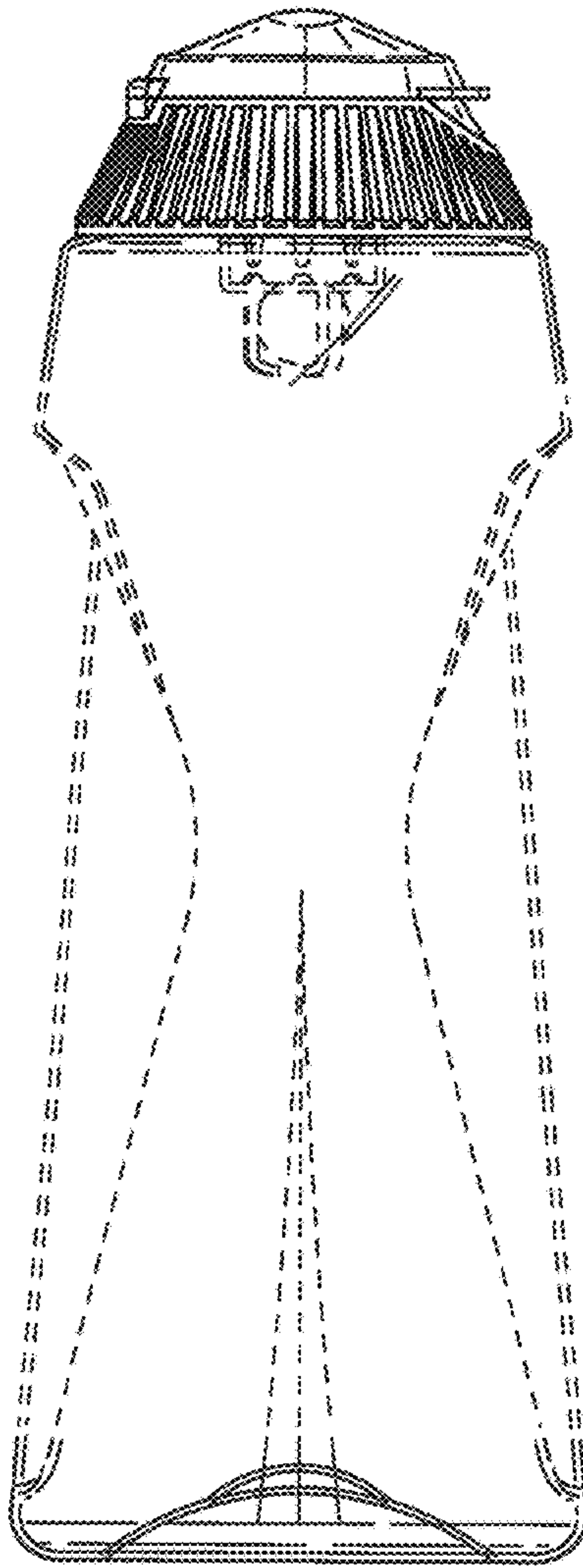

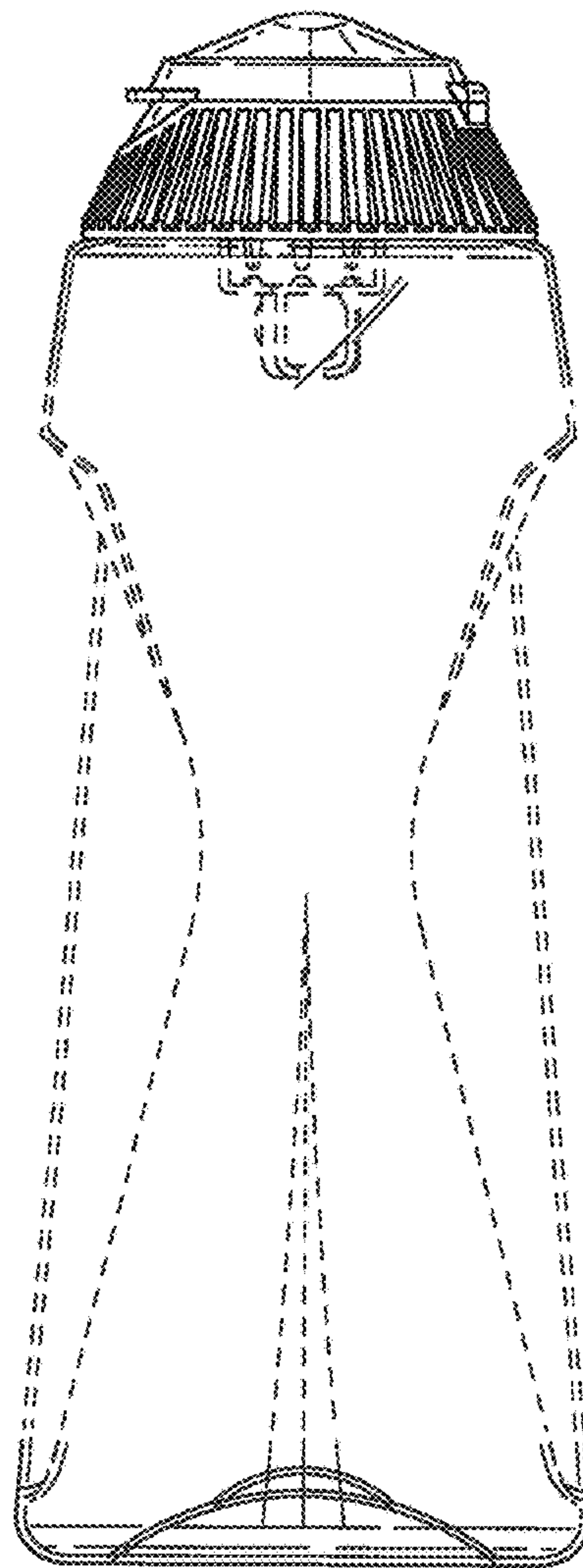

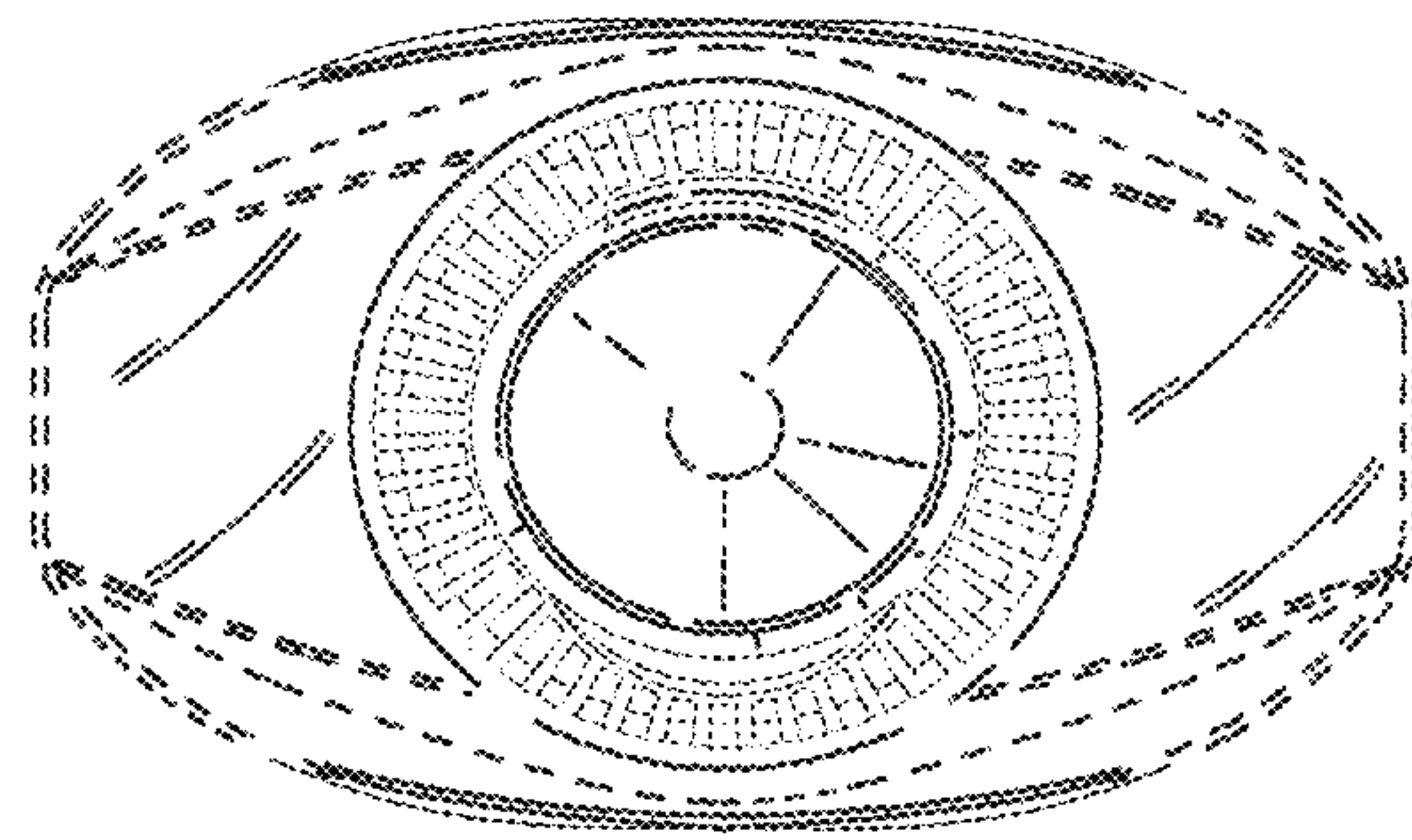

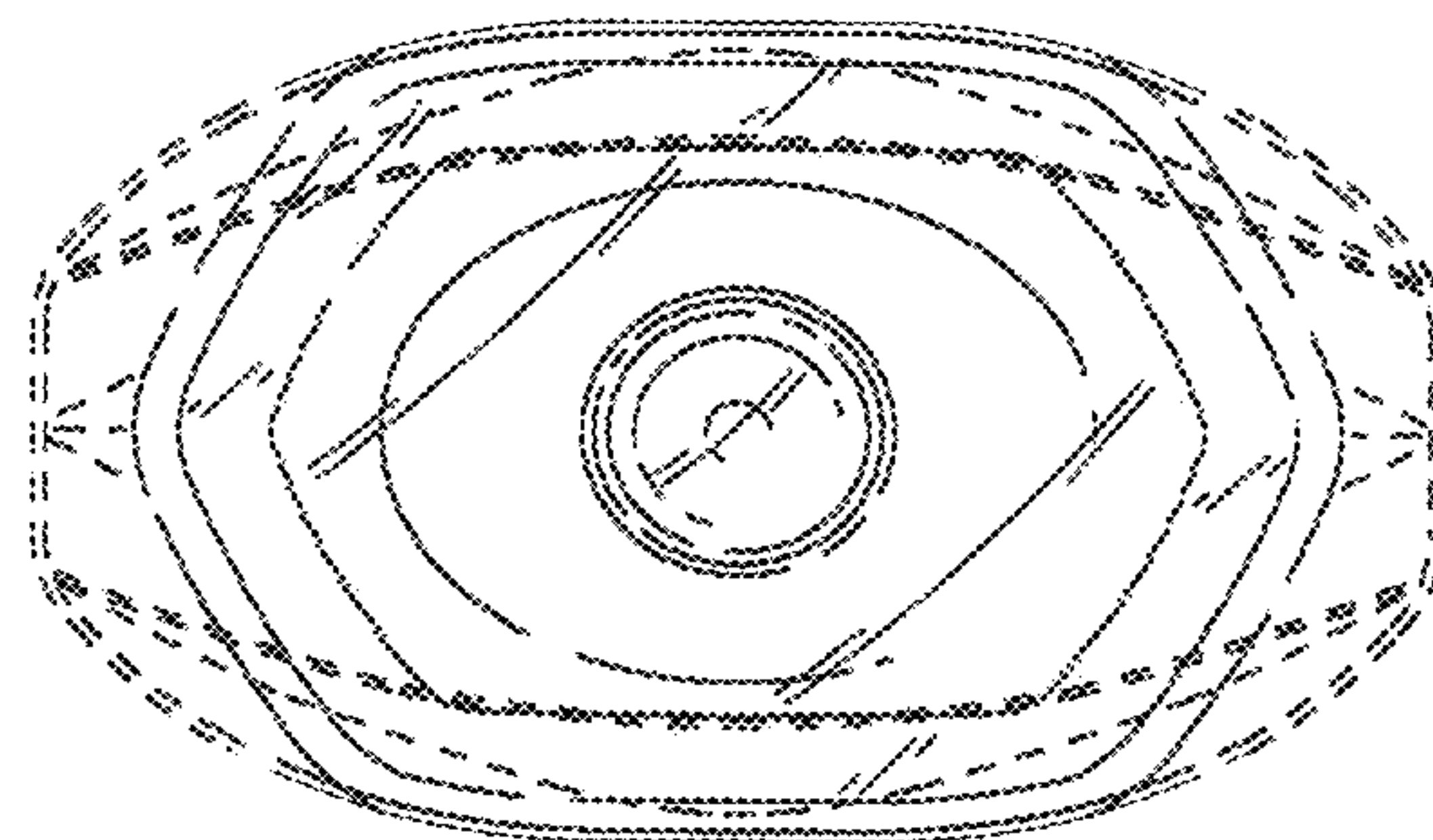
