(57) **CLAIM**

The ornamental design for an ornamental tag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ornamental tag showing my new design;
FIG. 2 is a front side view thereof;
FIG. 3 is a back side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines showing a chain and jump ring represent environment and the remaining broken lines in the drawings represent portions of the ornamental tag which form no part of the claimed design.

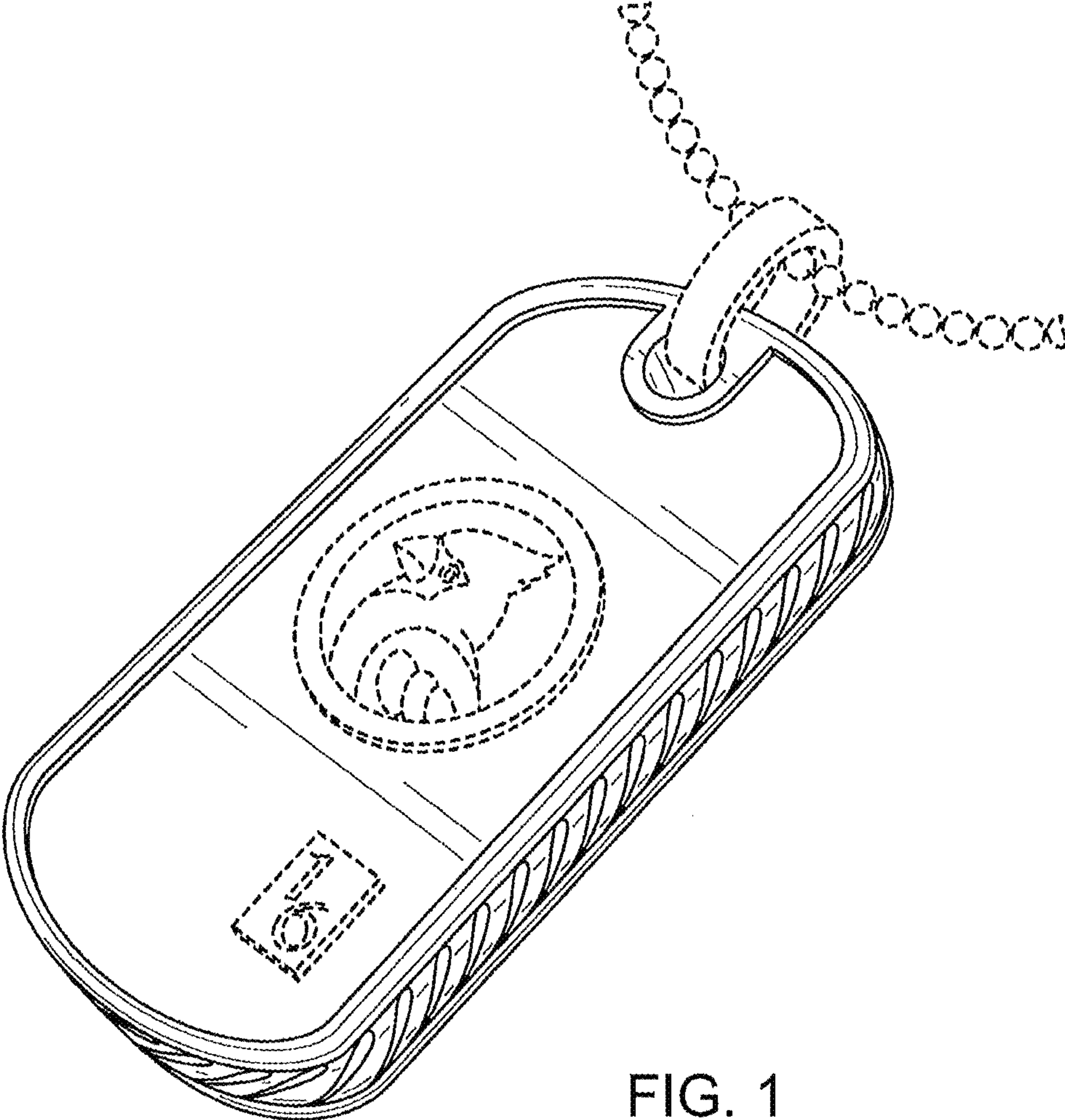

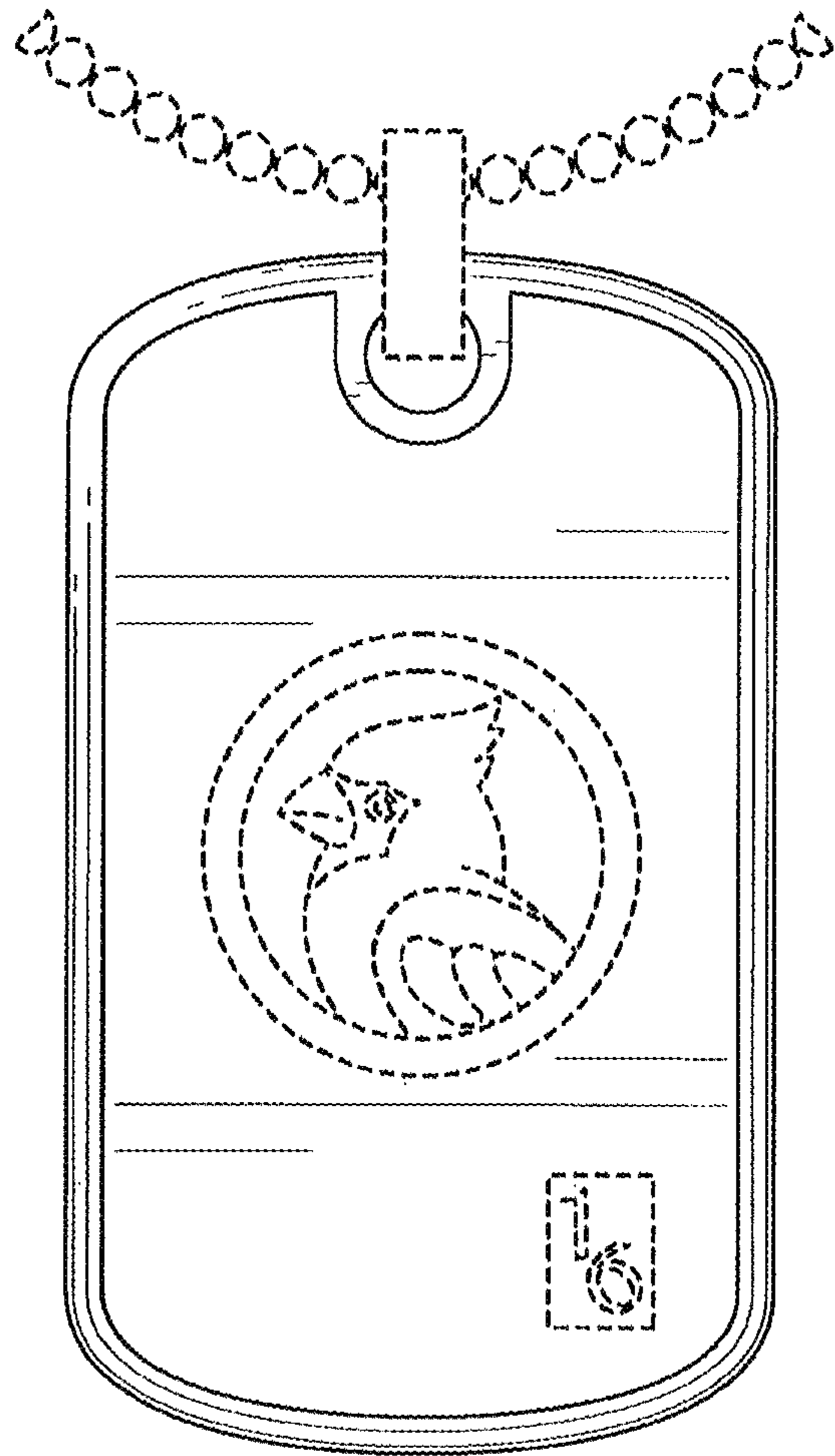

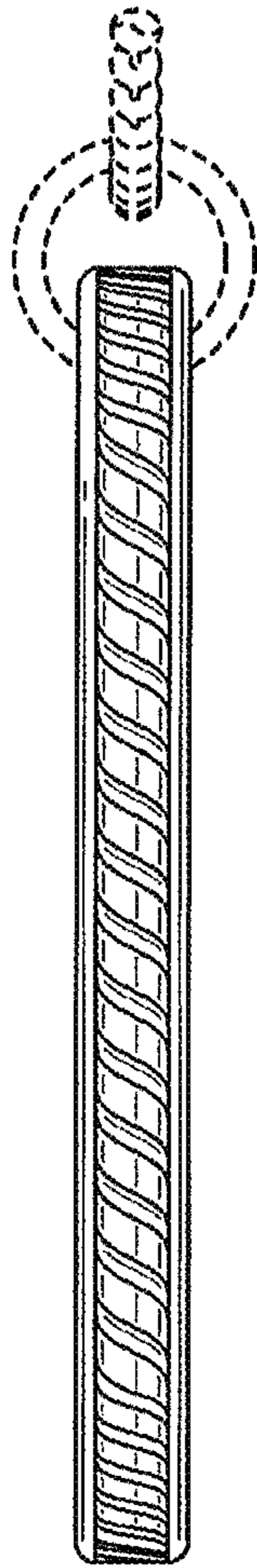

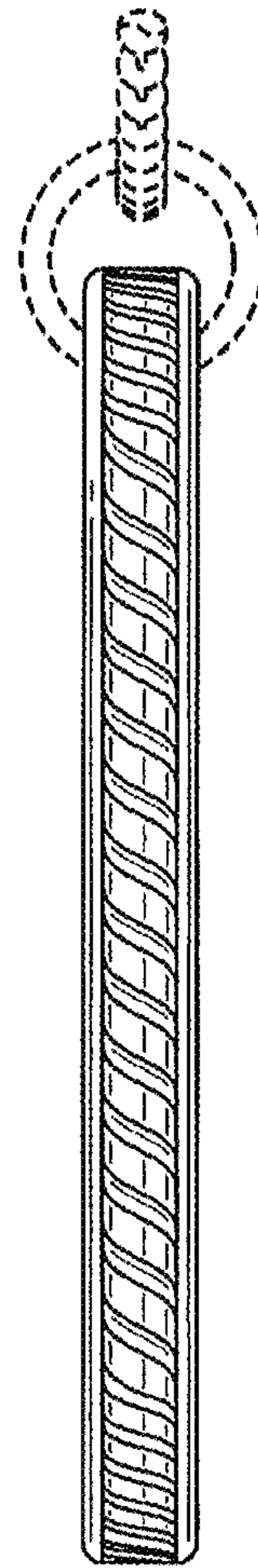

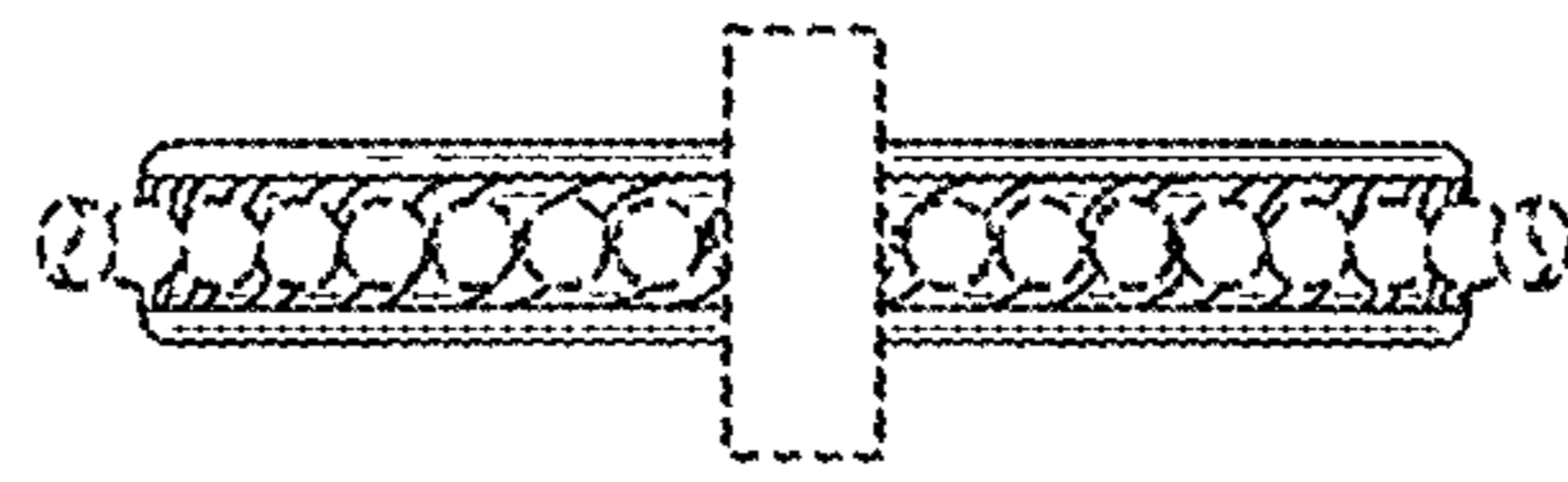

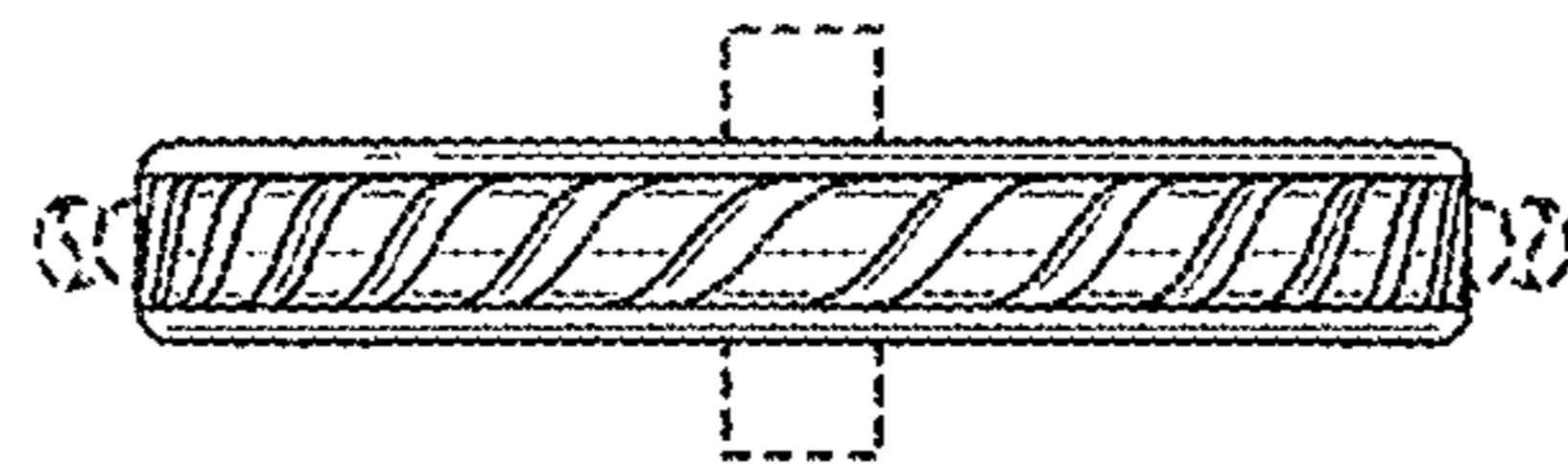
