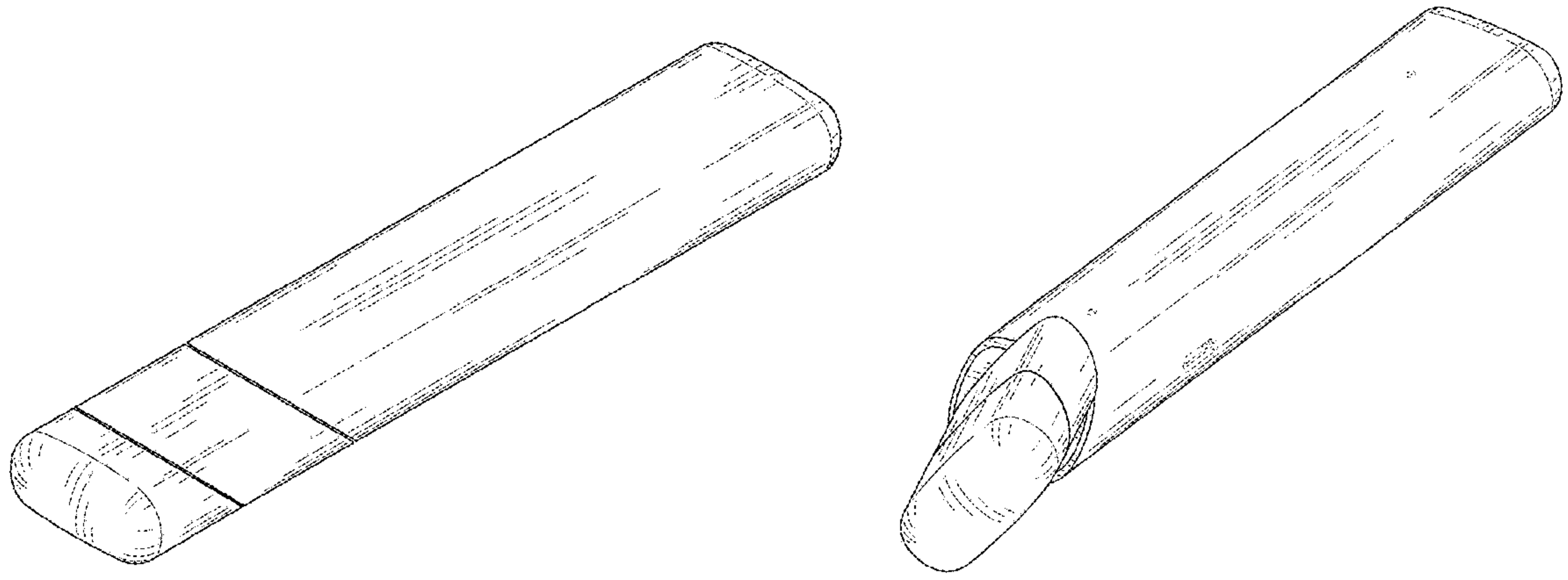

(57) **CLAIM**
The ornamental design for an electrical dongle, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of an electrical dongle according to a first configuration, showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front perspective view thereof, according to a second configuration; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a top plan view thereof; FIG. 14 is a bottom plan view thereof; FIG. 15 is a front perspective view thereof, according to a third configuration; FIG. 16 is a front elevation view thereof; FIG. 17 is a rear elevation view thereof; FIG. 18 is a right side elevation view thereof; FIG. 19 is a left side elevation view thereof; FIG. 20 is a top plan view thereof; and, FIG. 21 is a bottom plan view thereof.

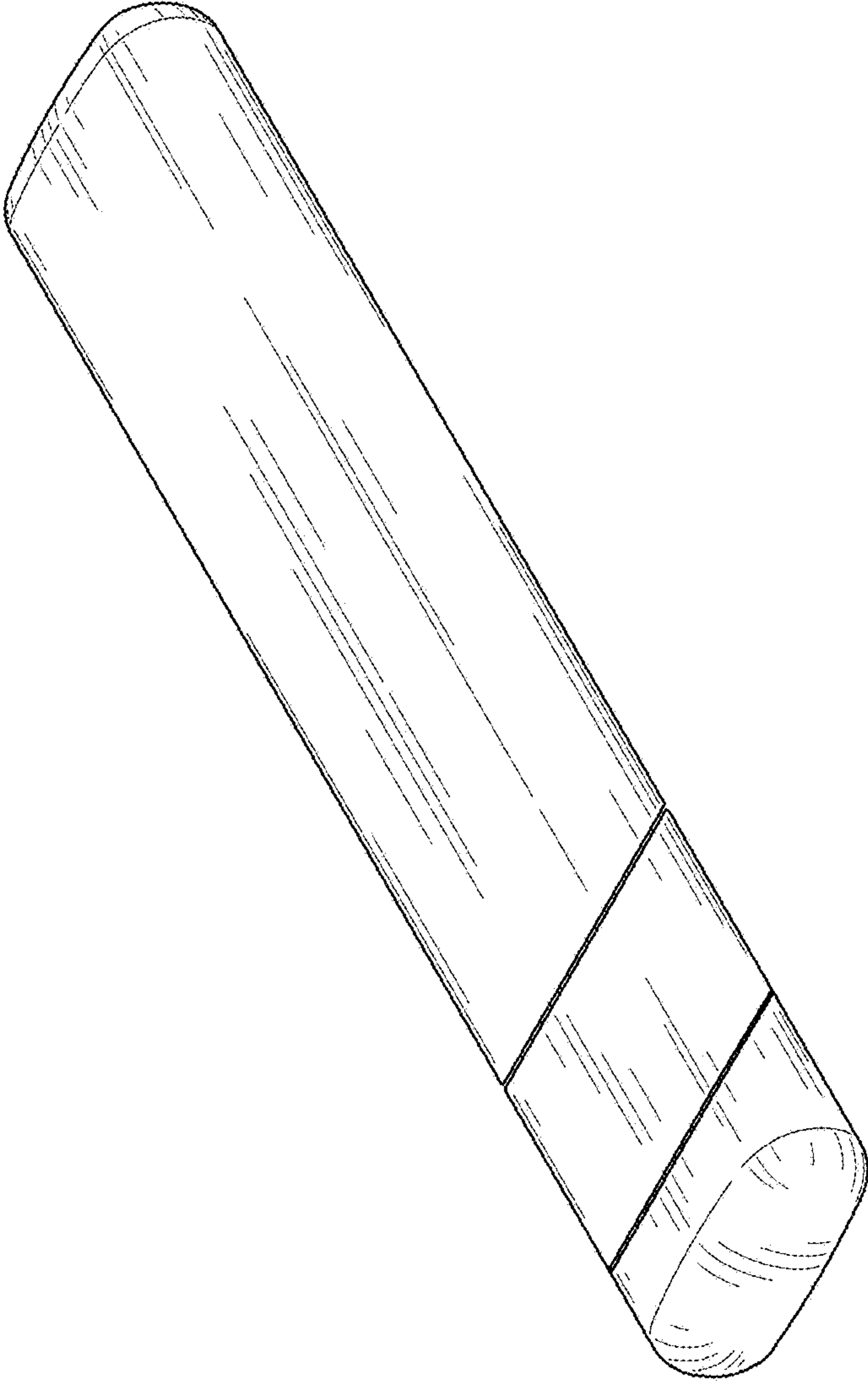

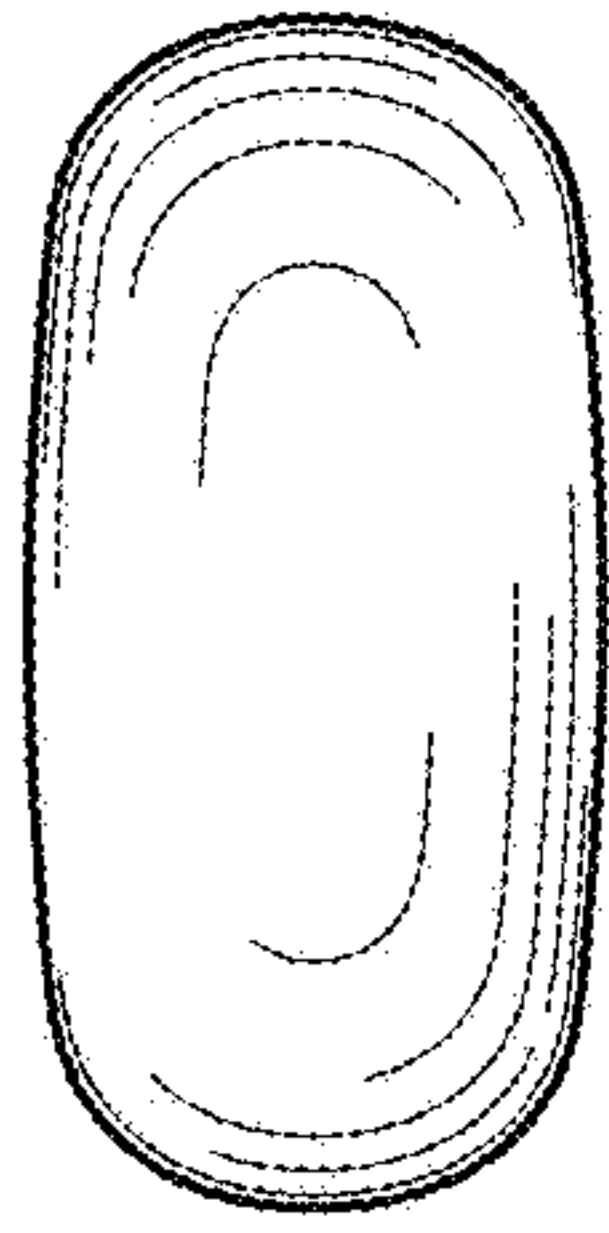

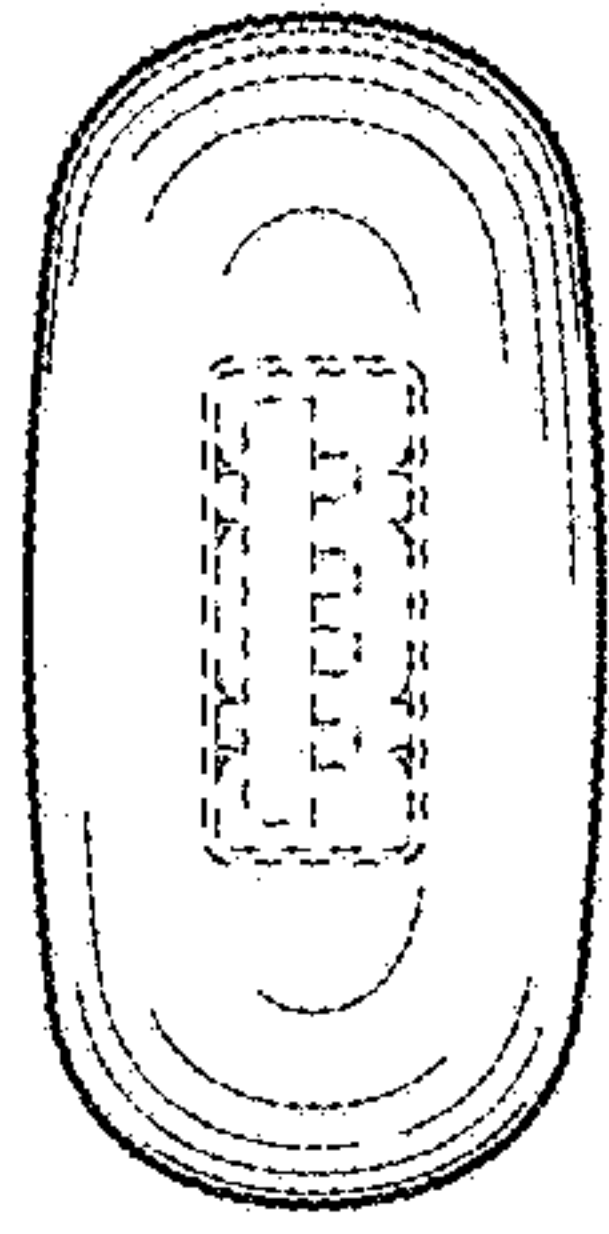

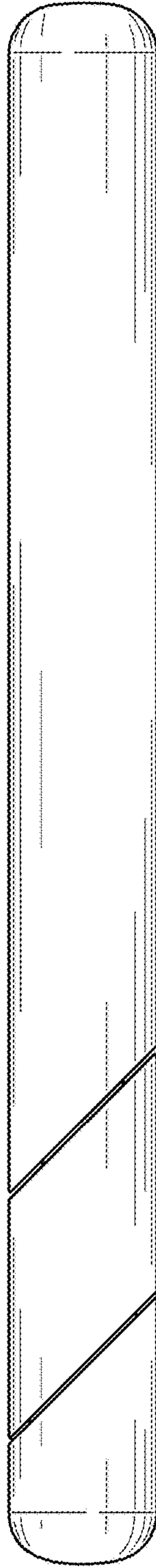

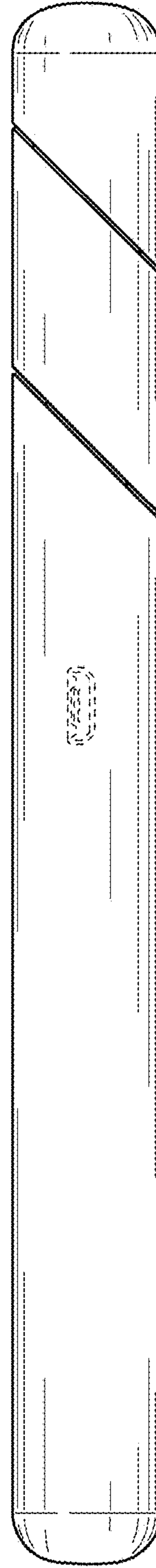

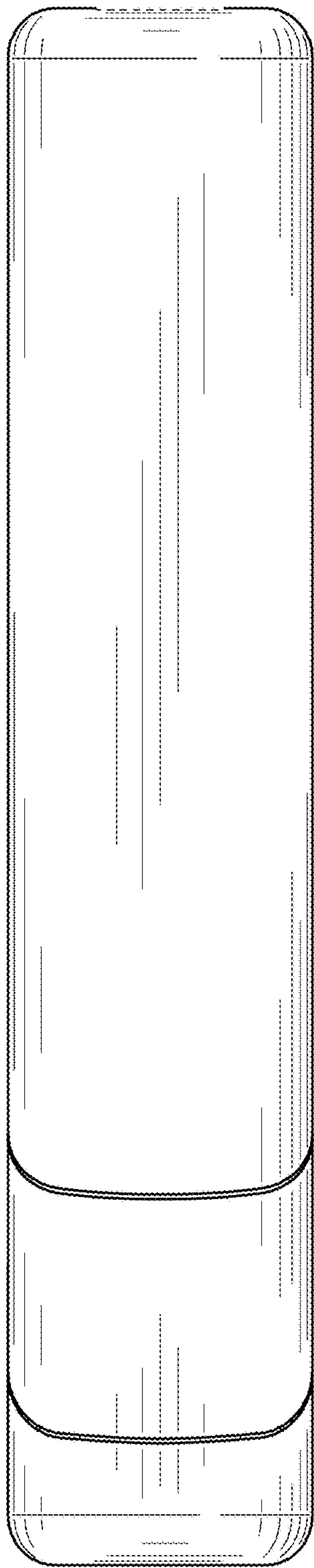

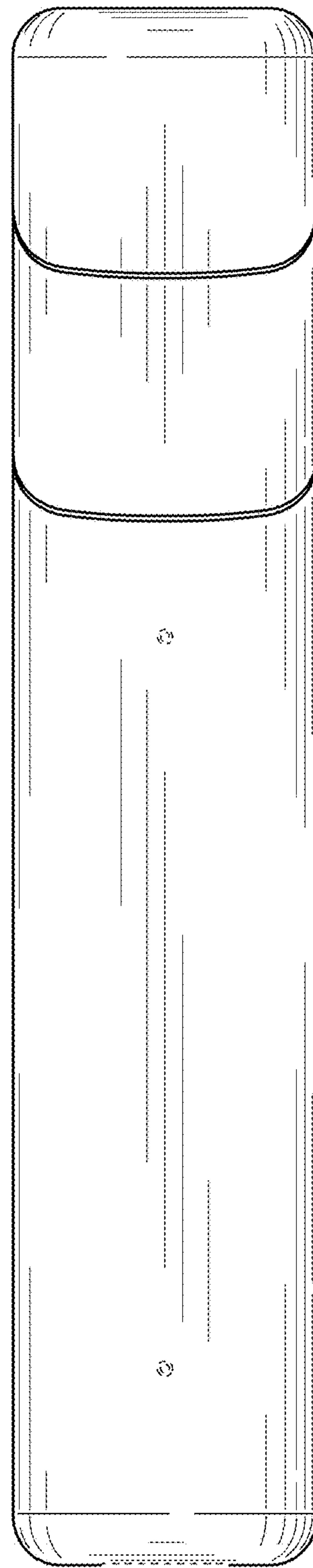

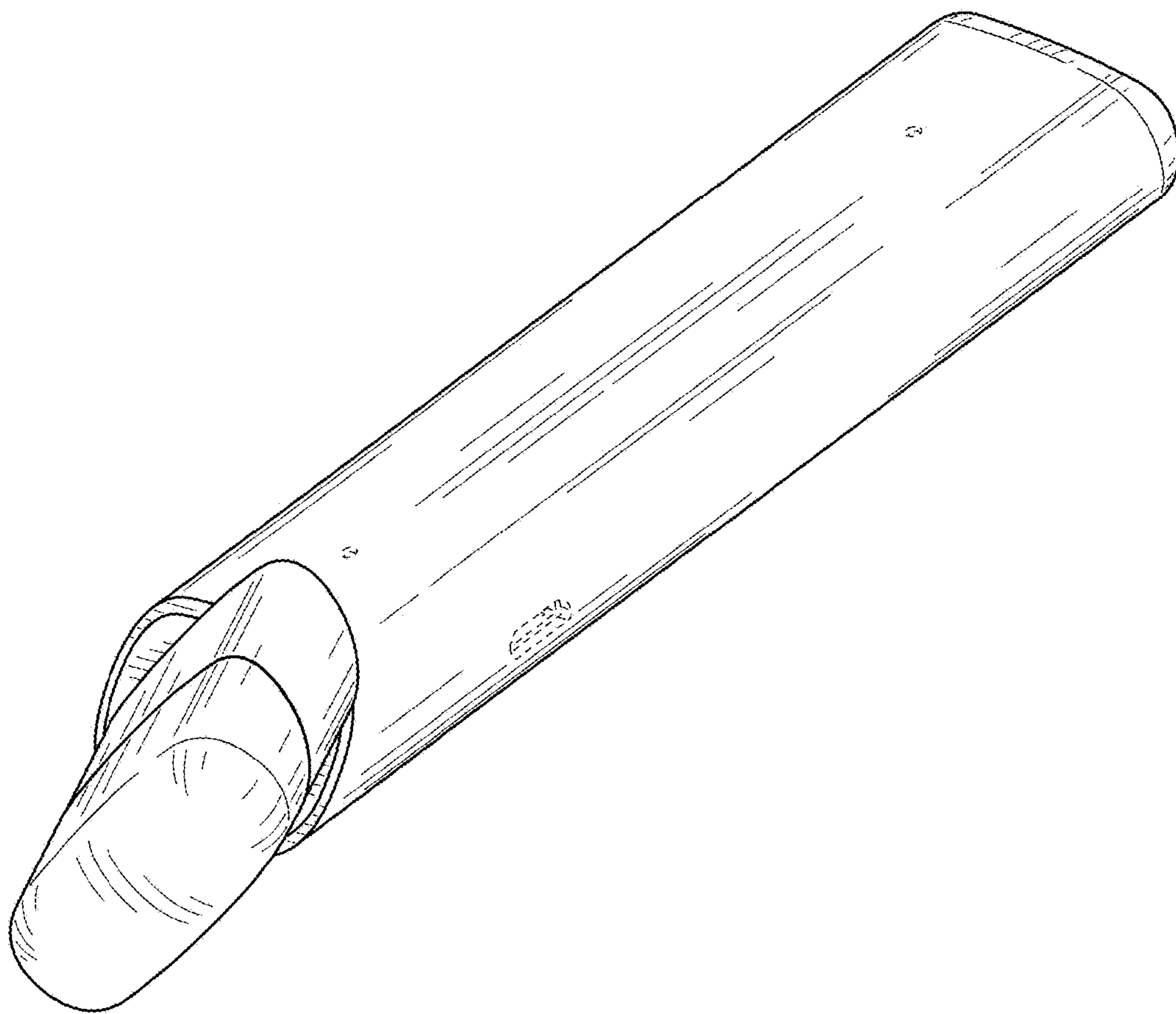

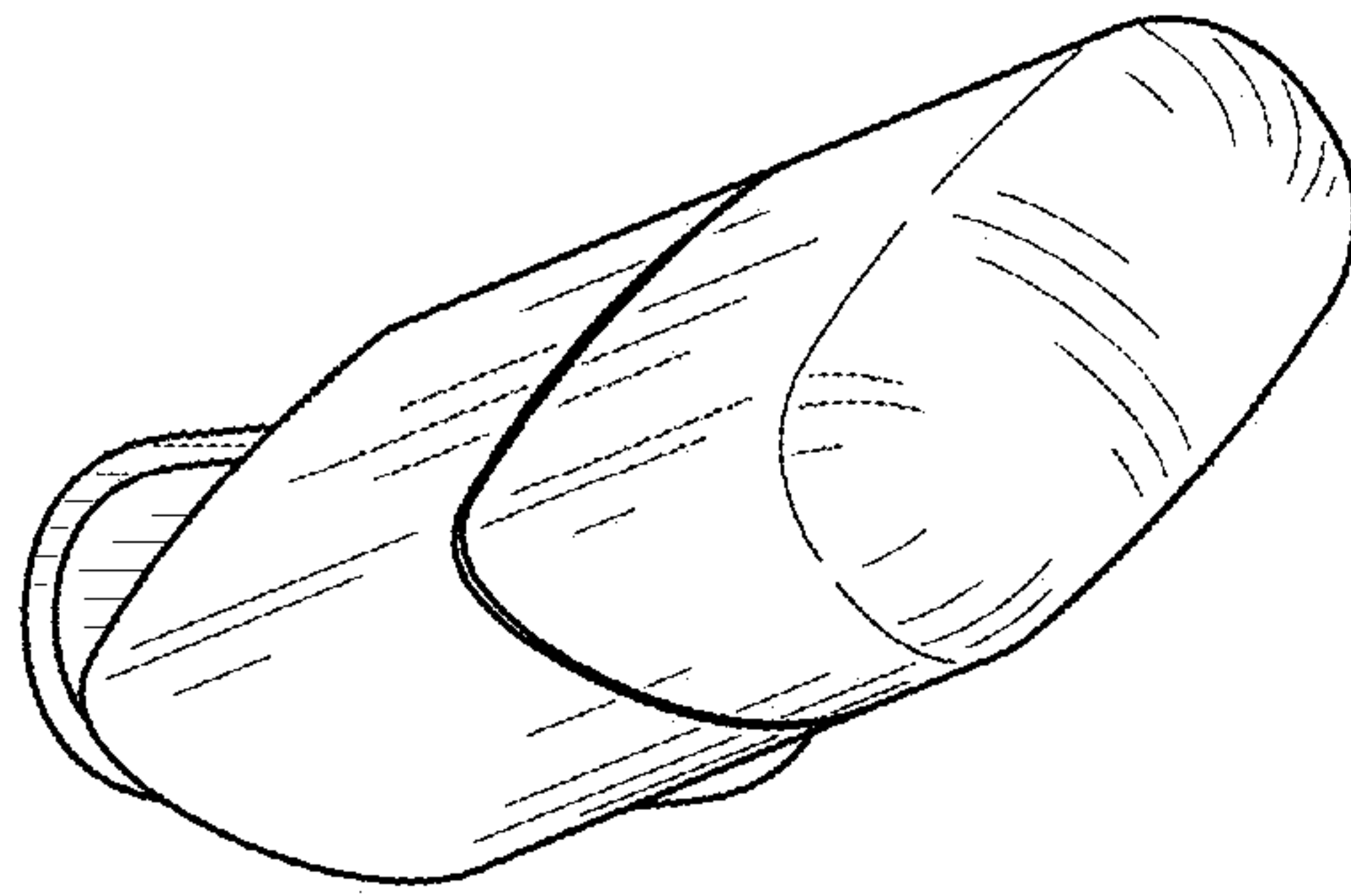

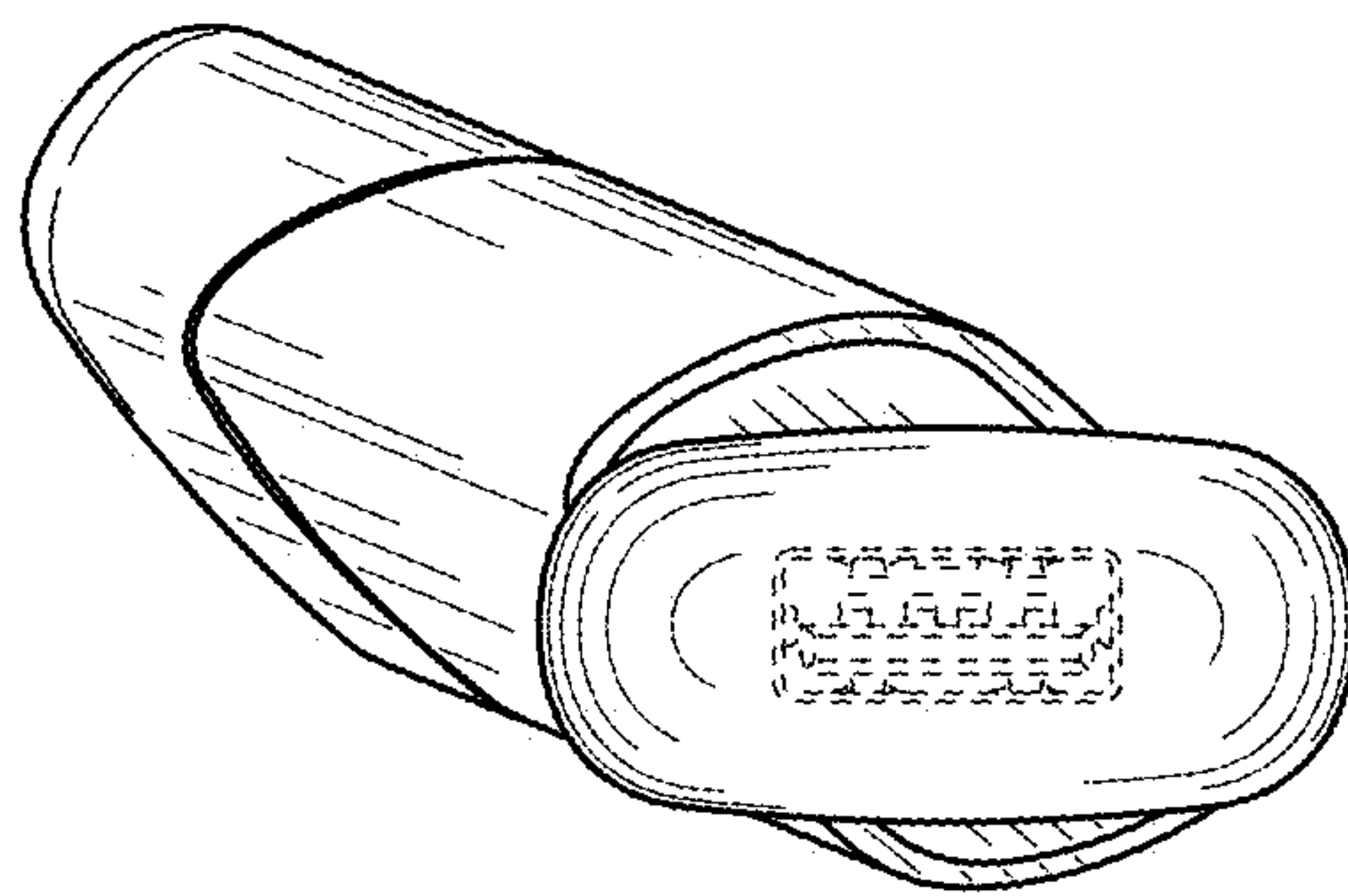

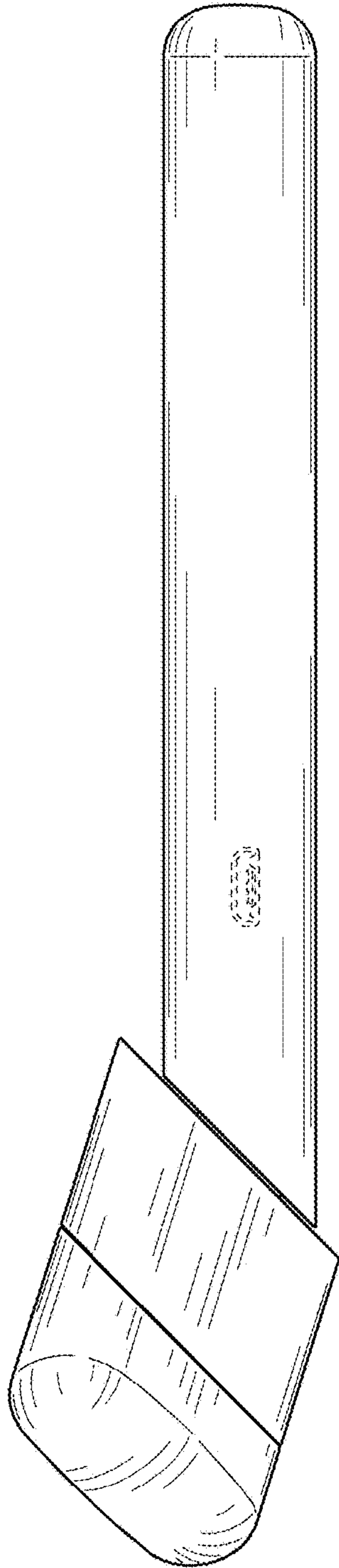

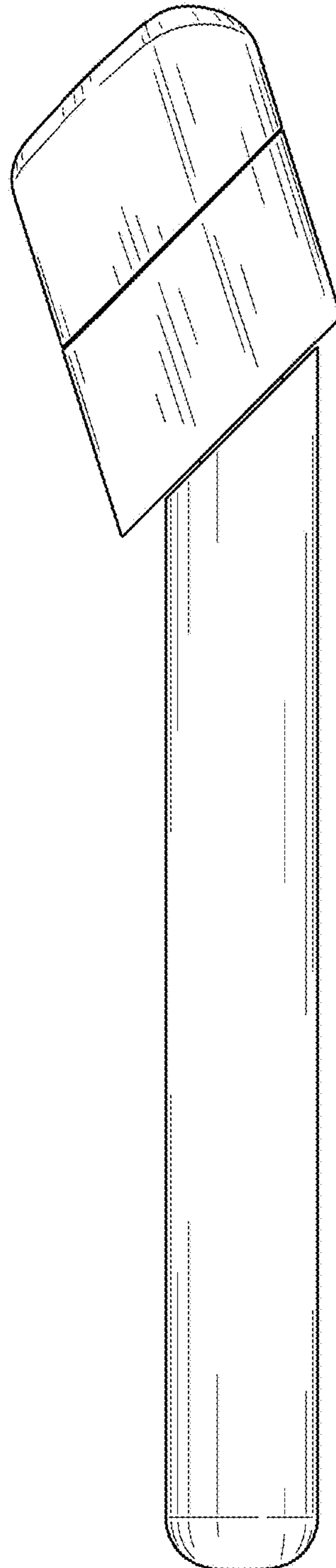

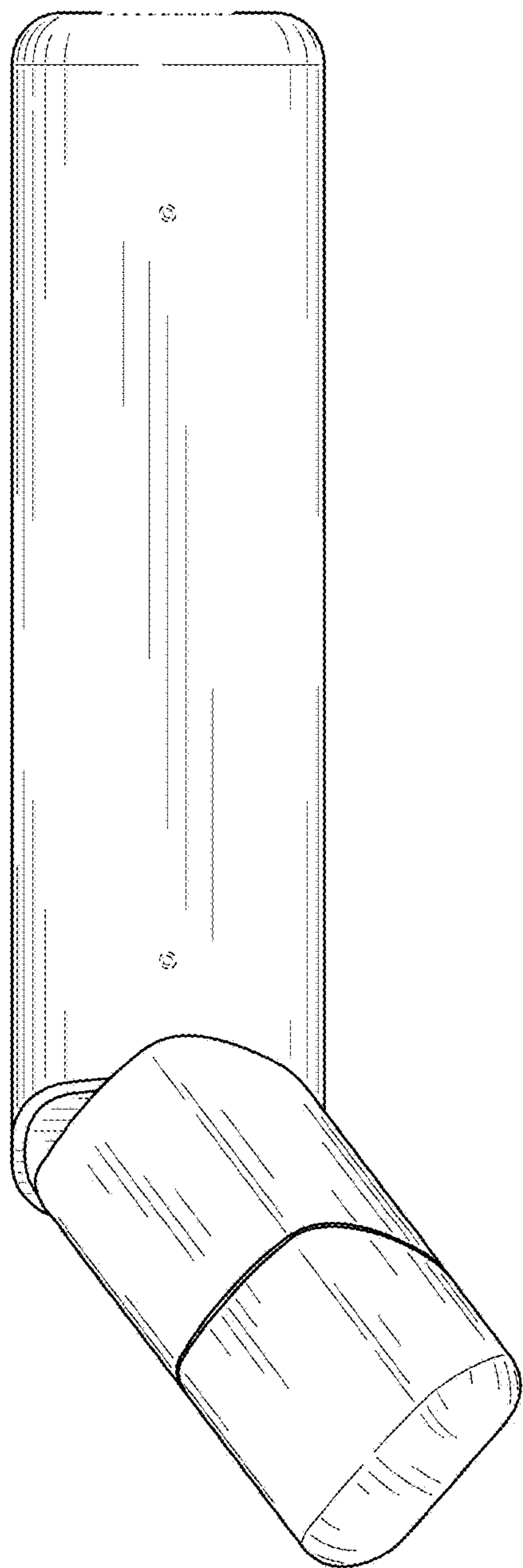

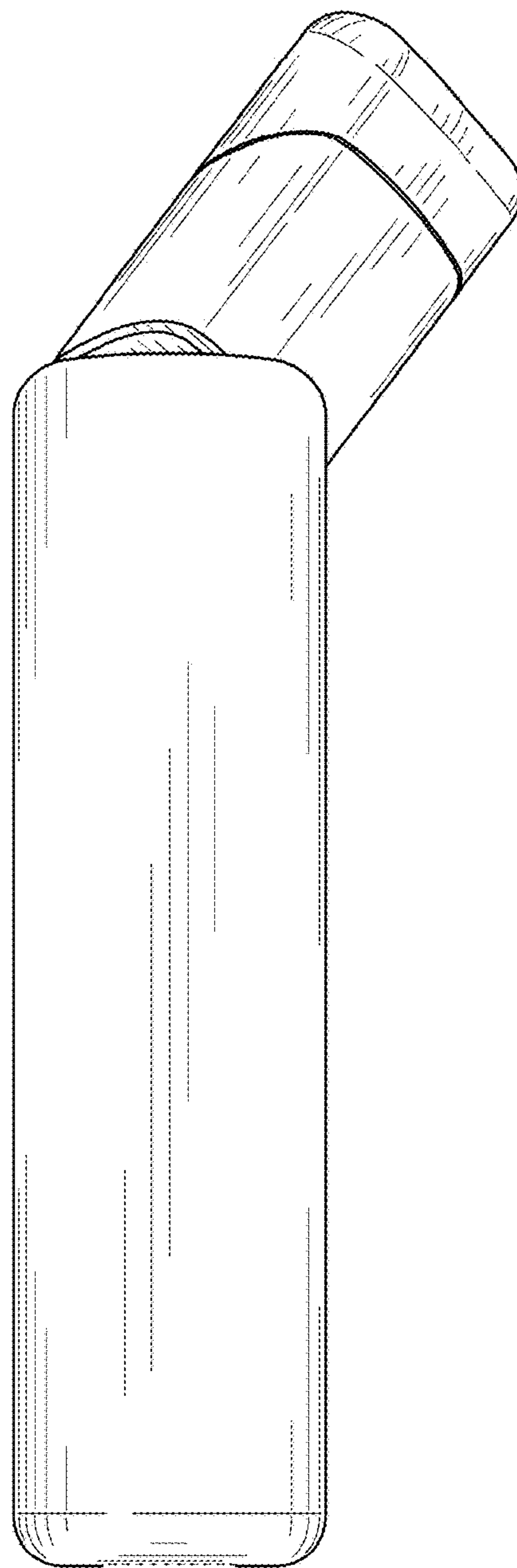

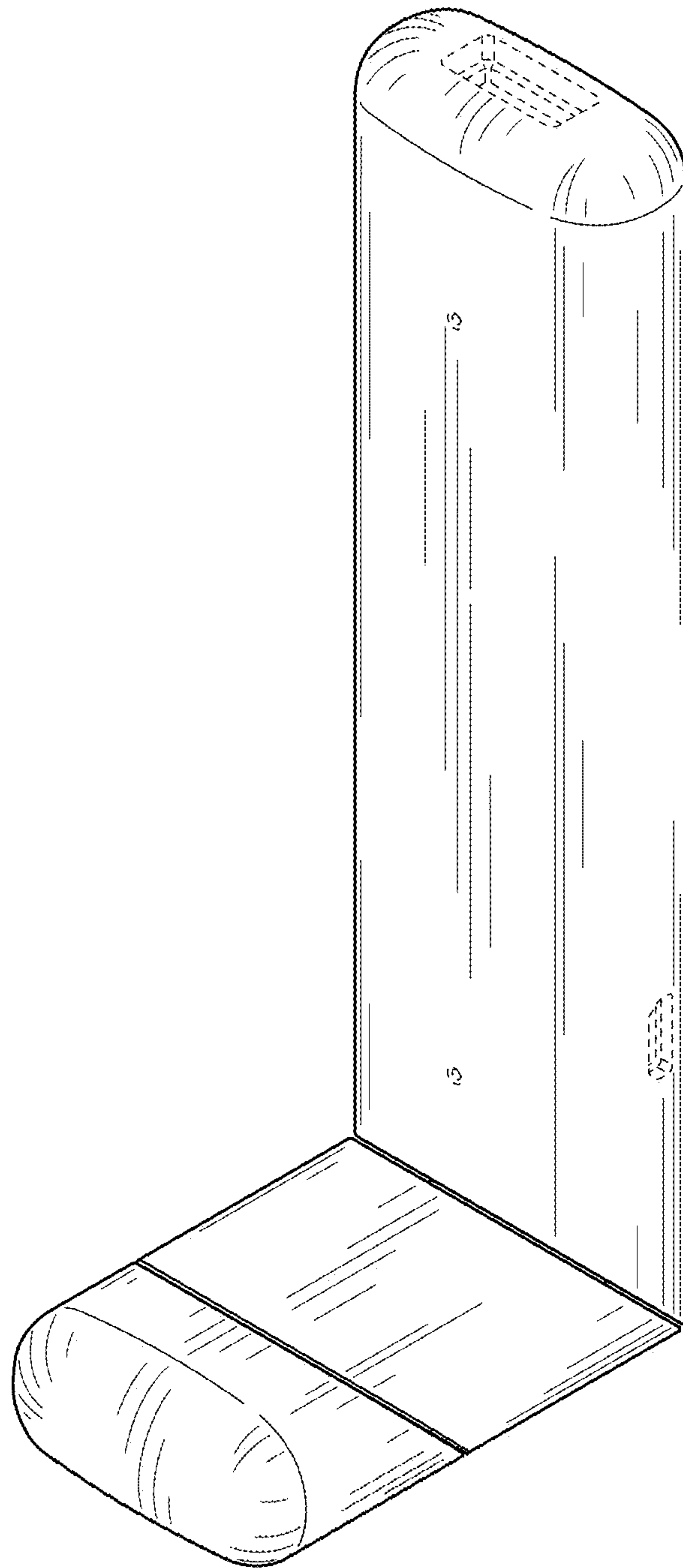

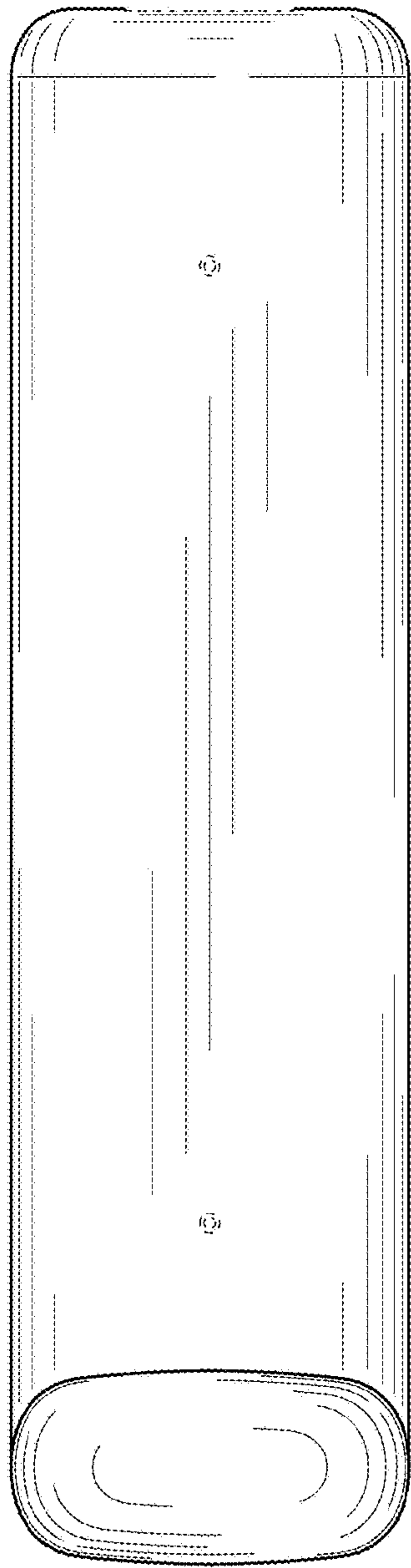

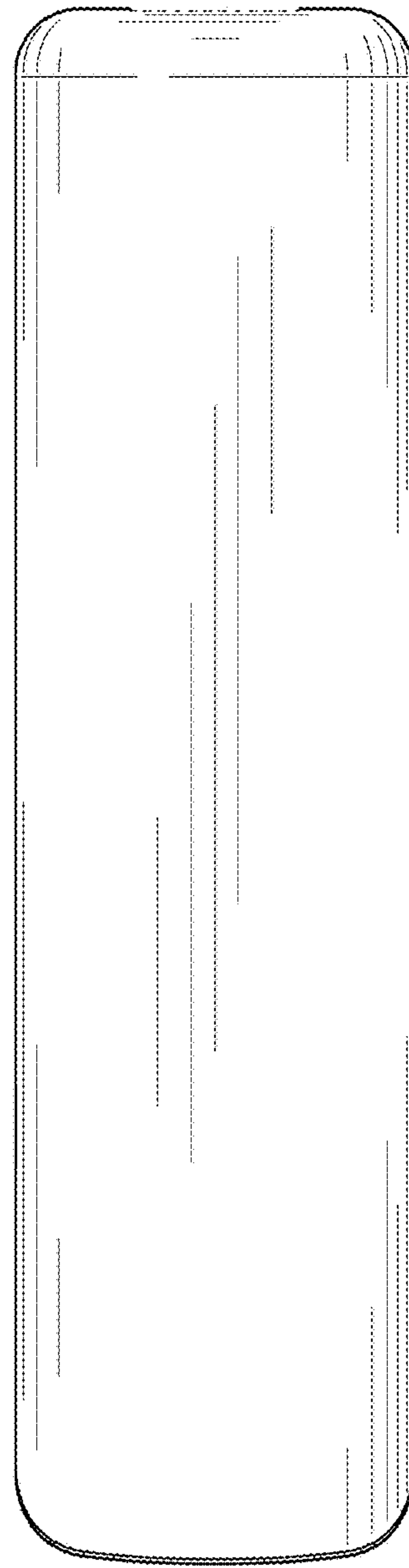

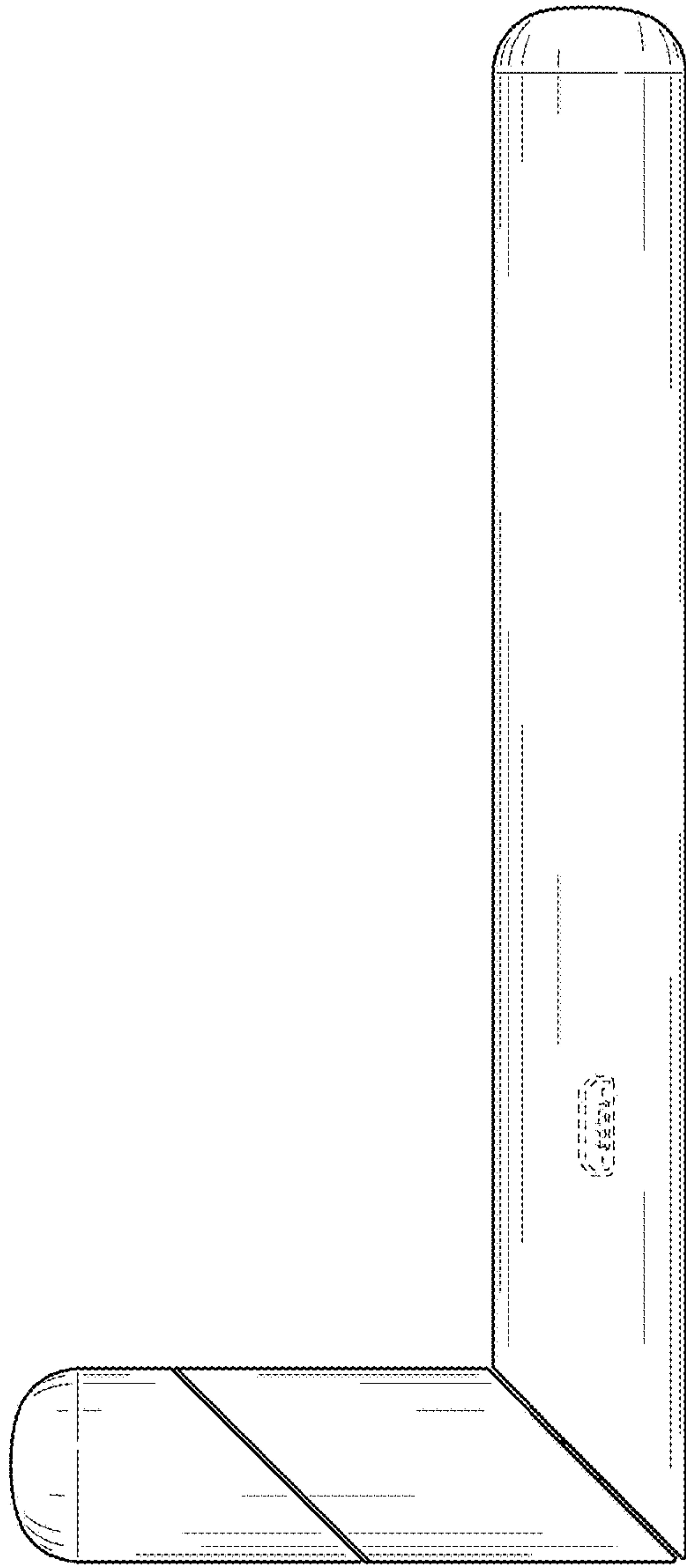

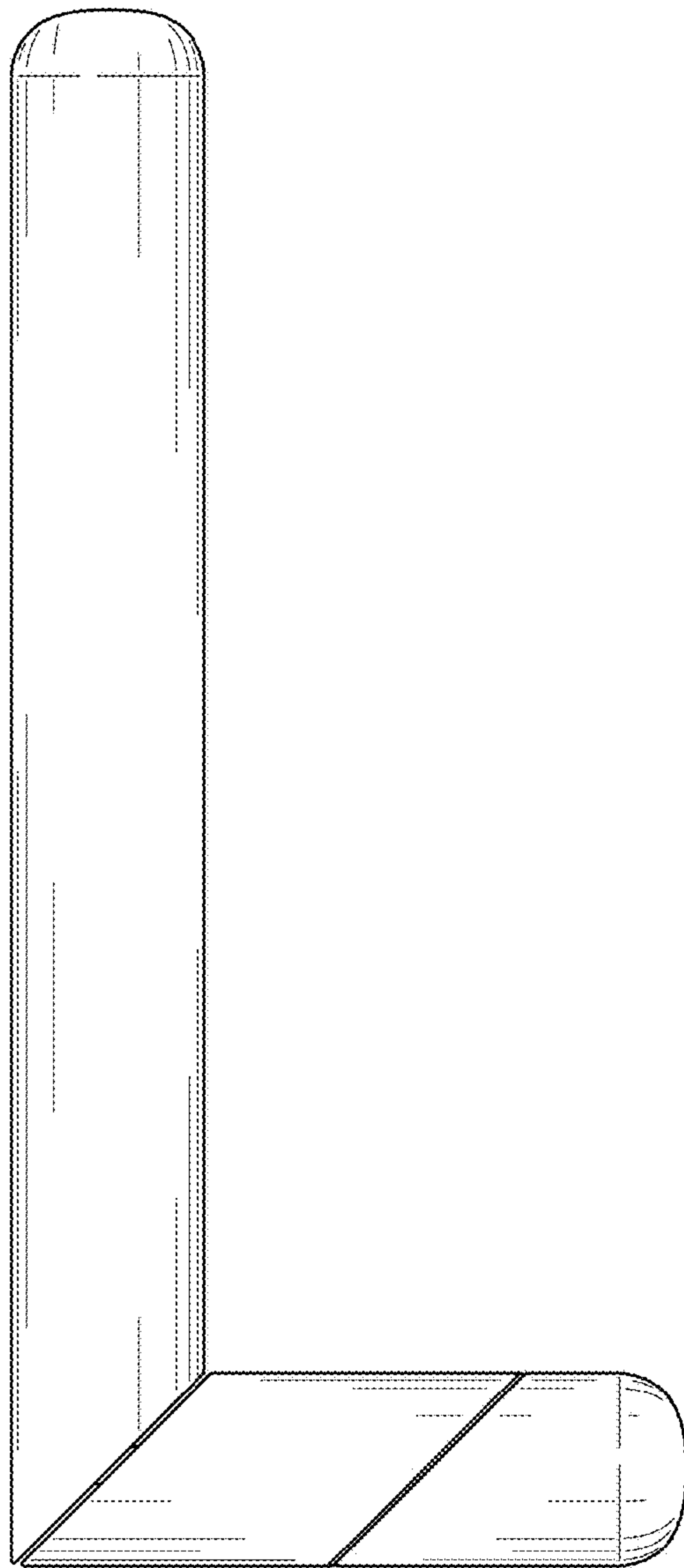

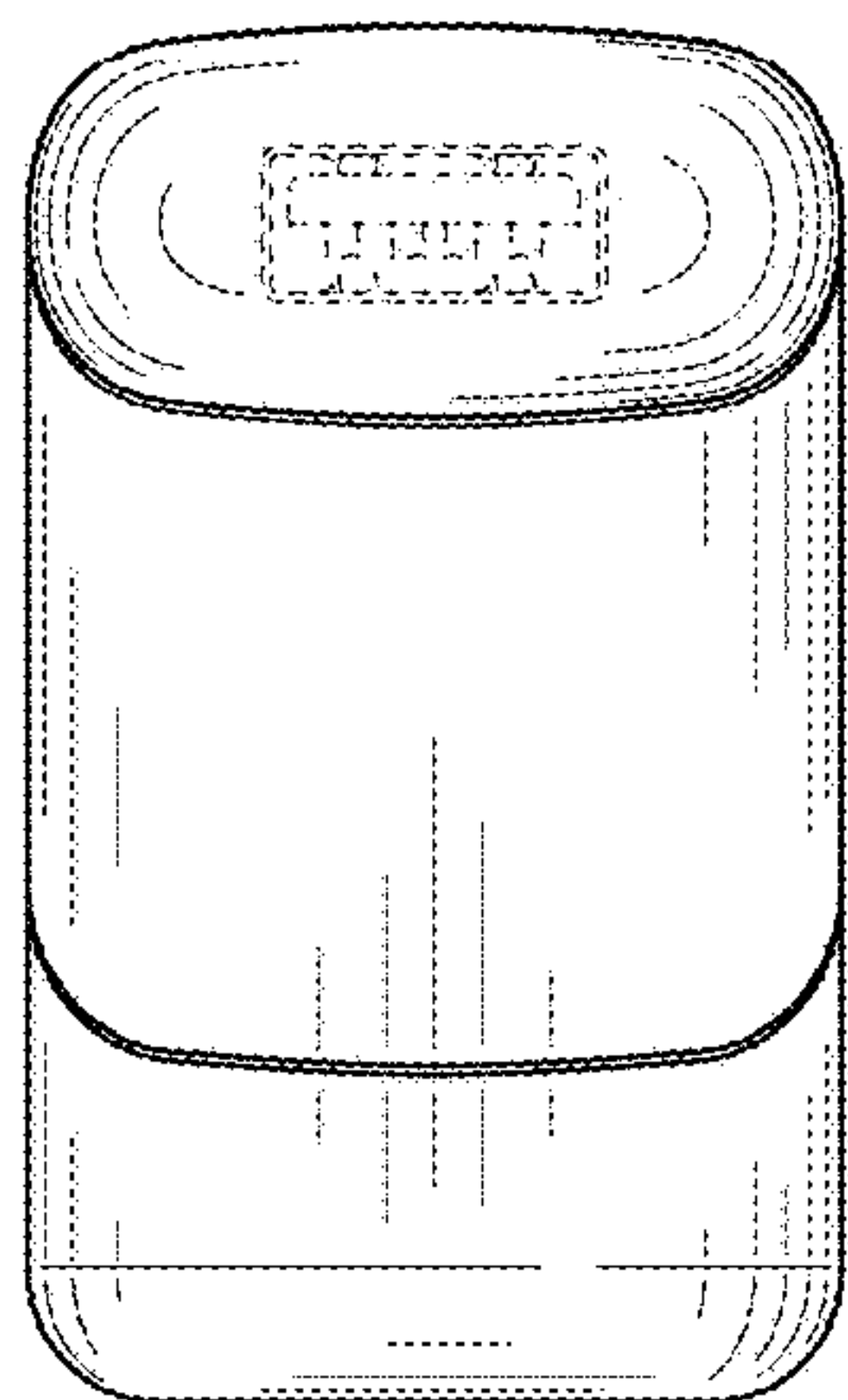

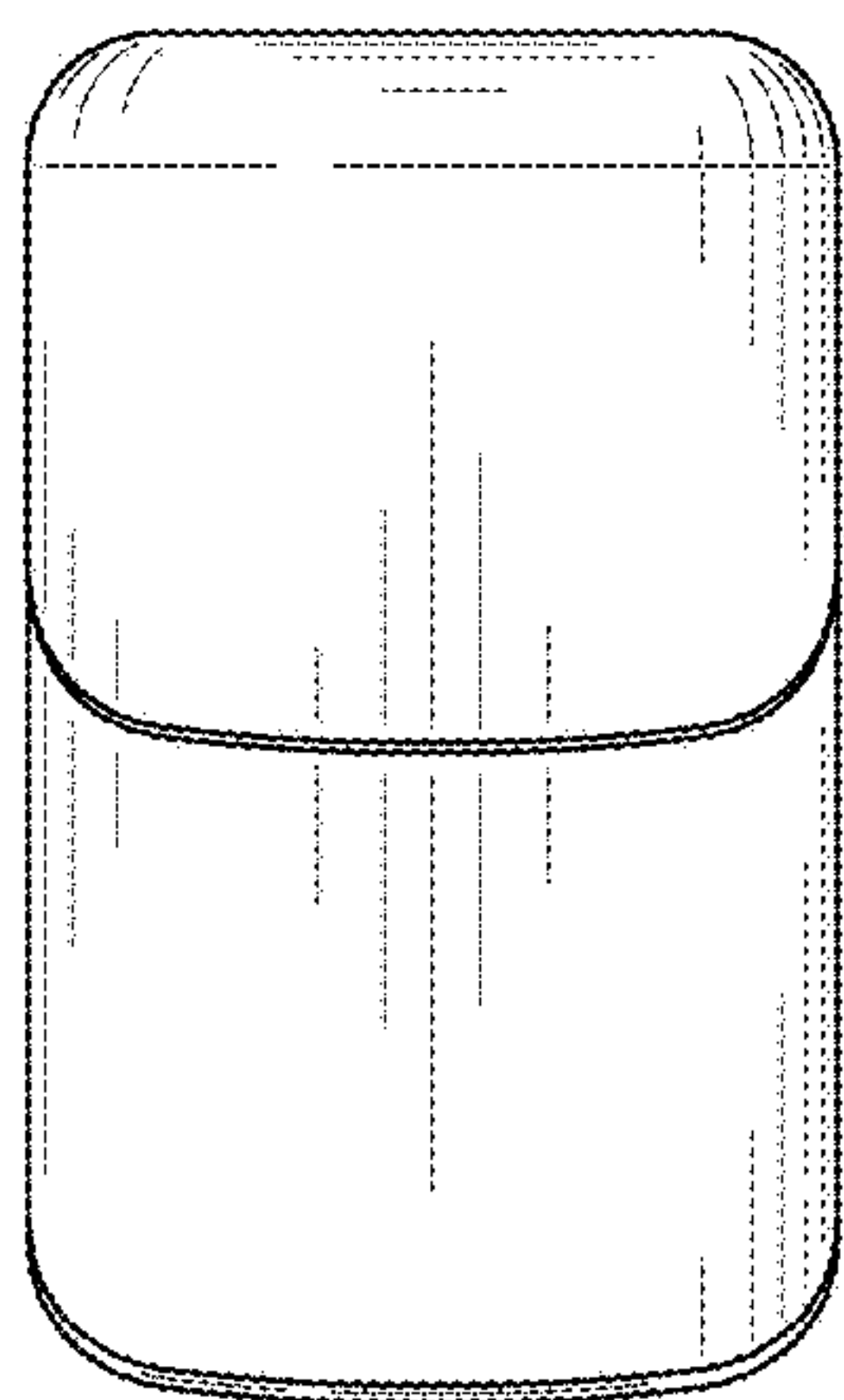
