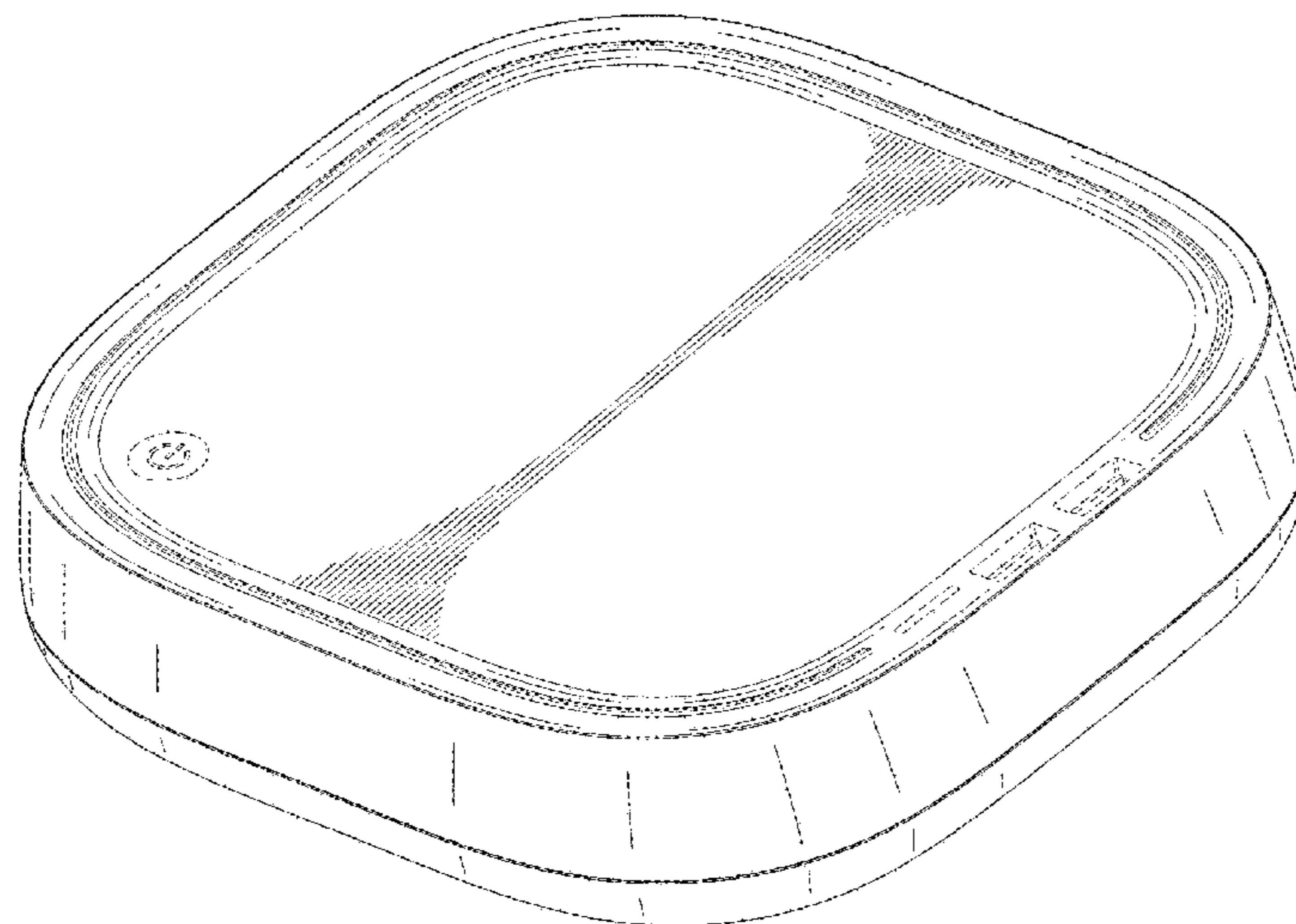
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an electronic device according to my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a bottom view illustrating an electronic device with a small form factor design according to one embodiment;
FIG. 5 is a top view thereof;
FIG. 6 is a side view thereof;

FIG. 8 is a bottom view thereof wherein a removable portion has been removed.

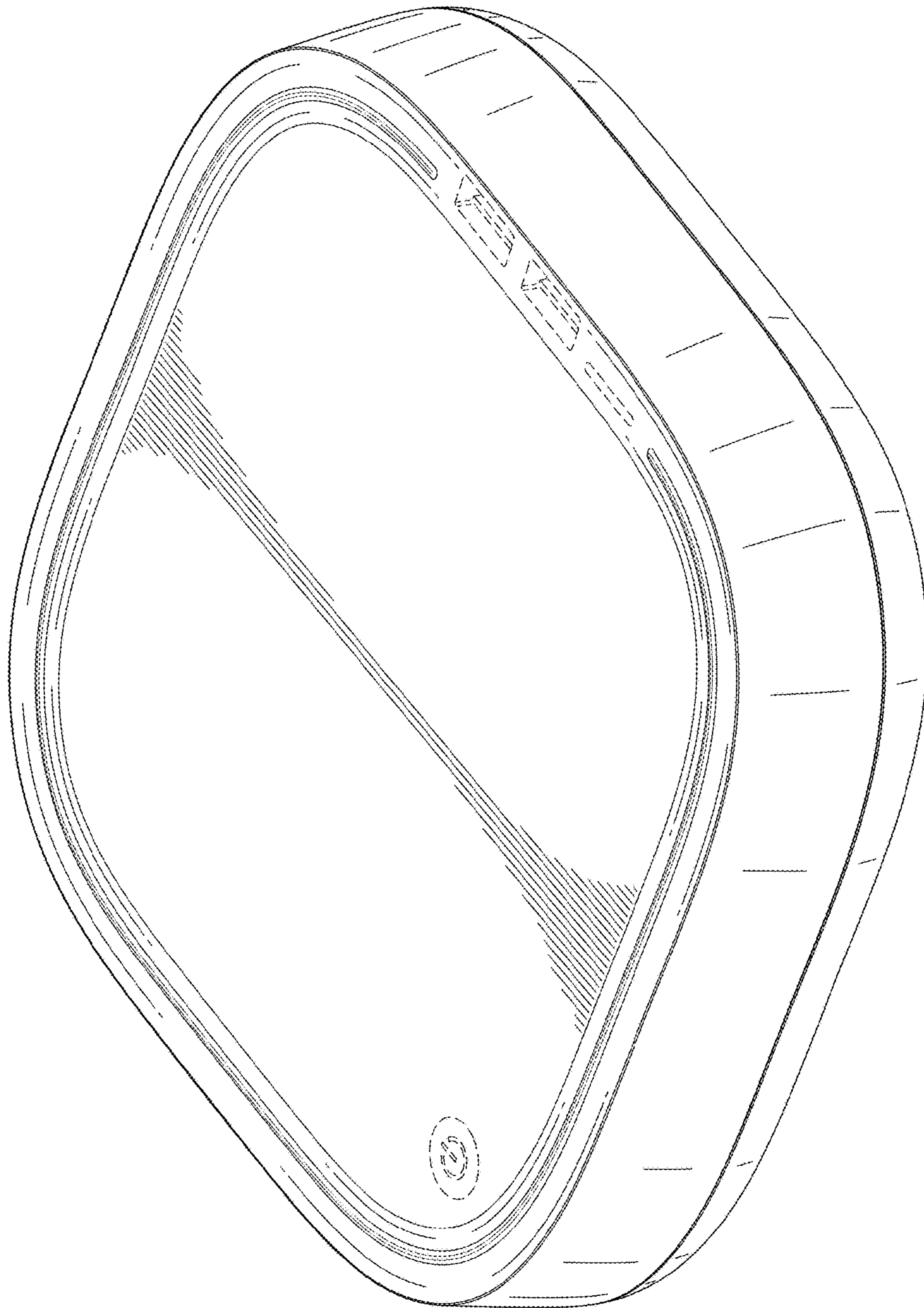

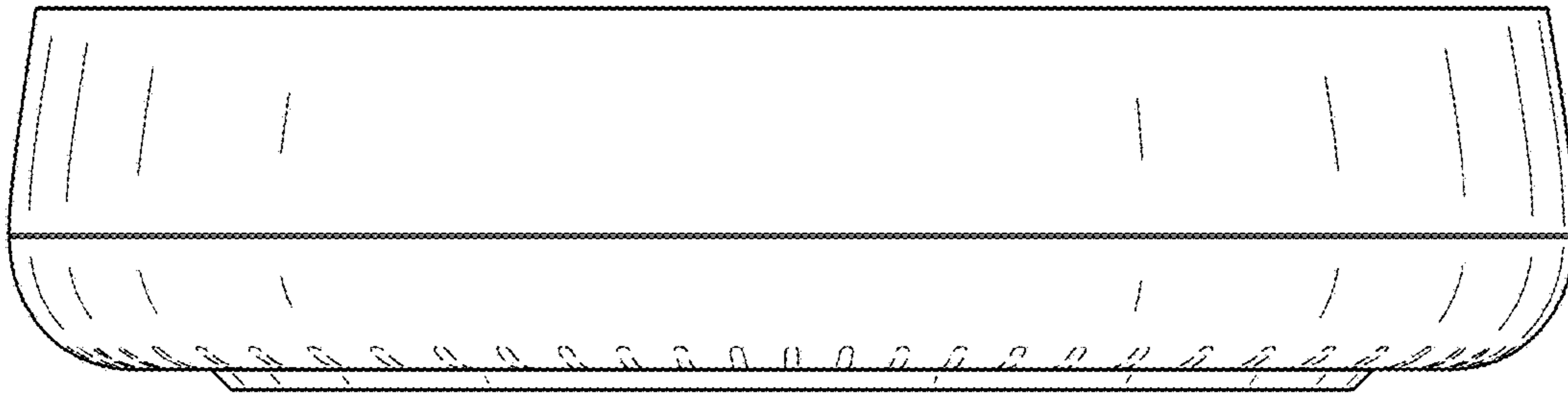

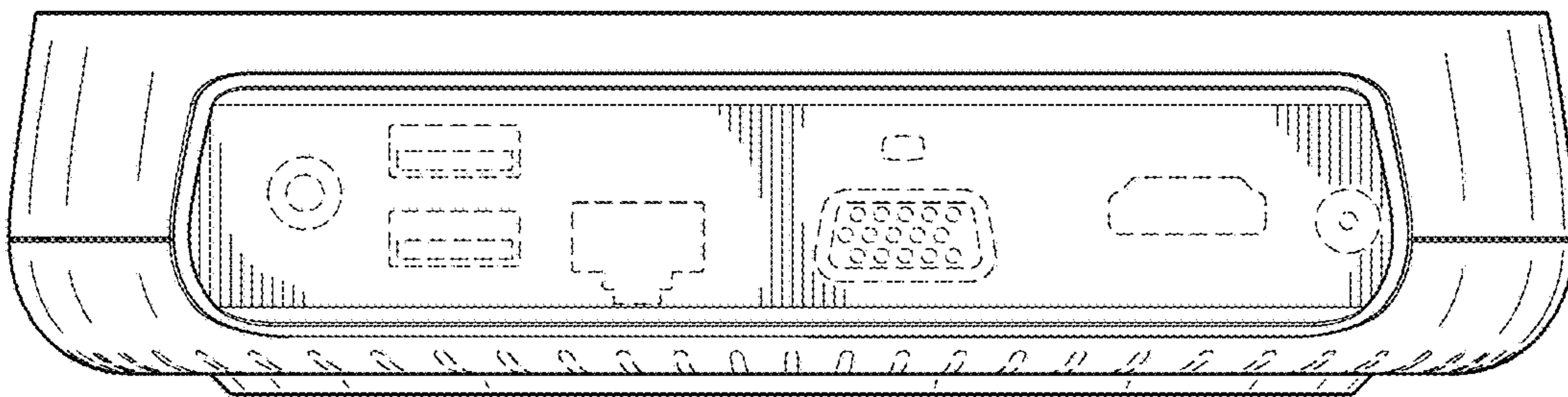

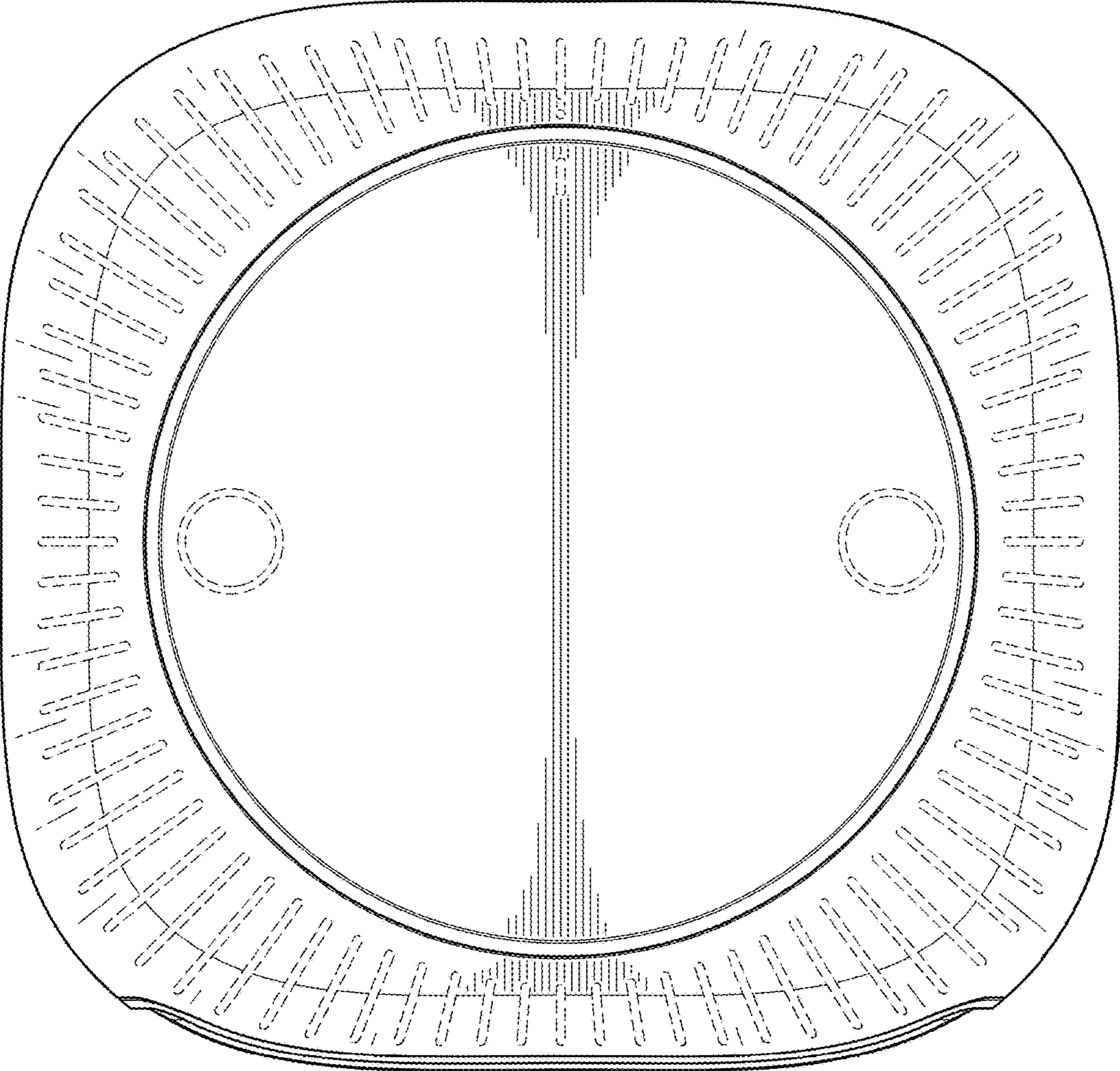

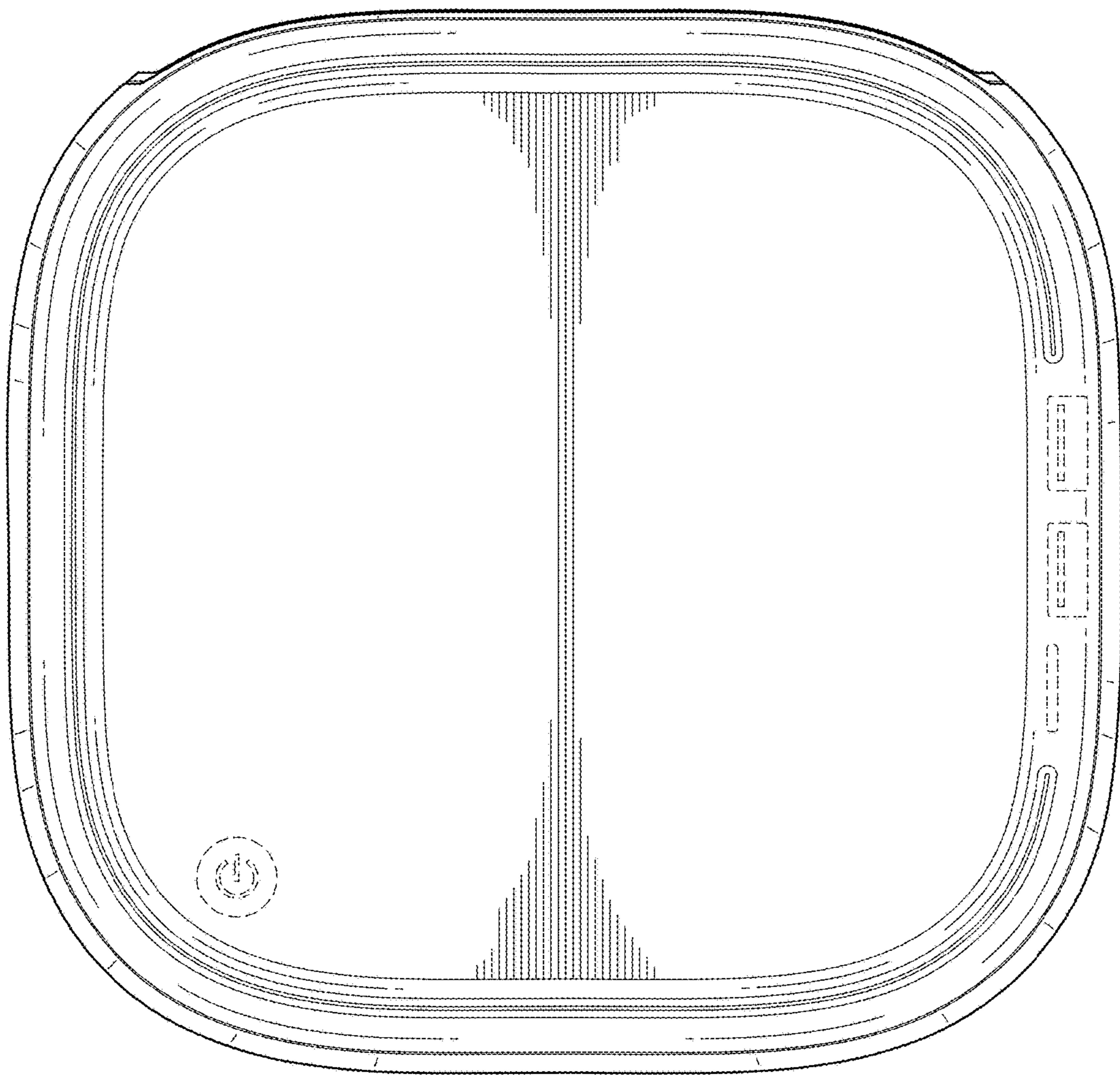

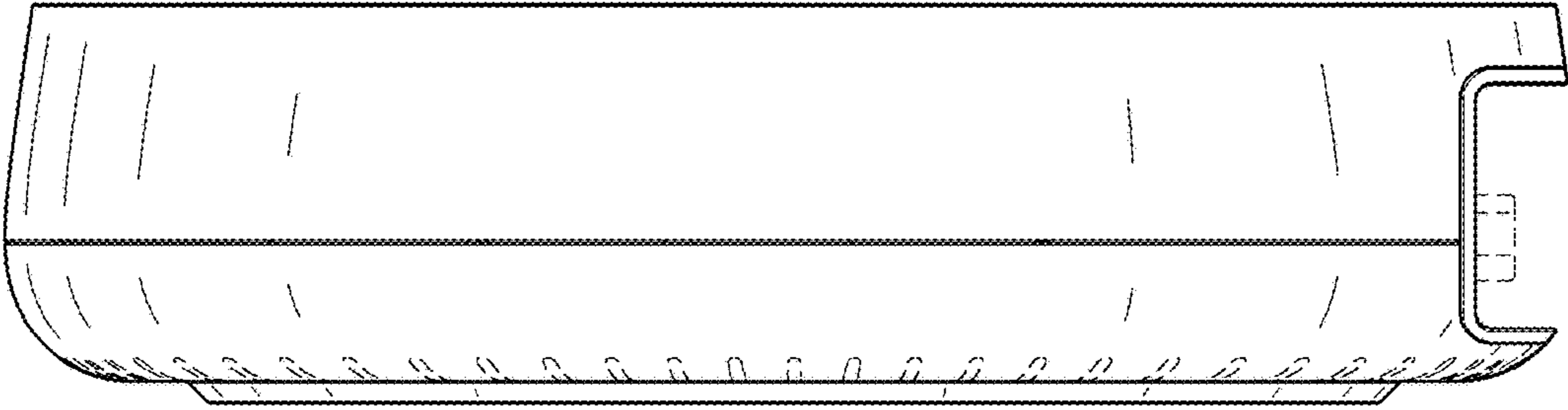

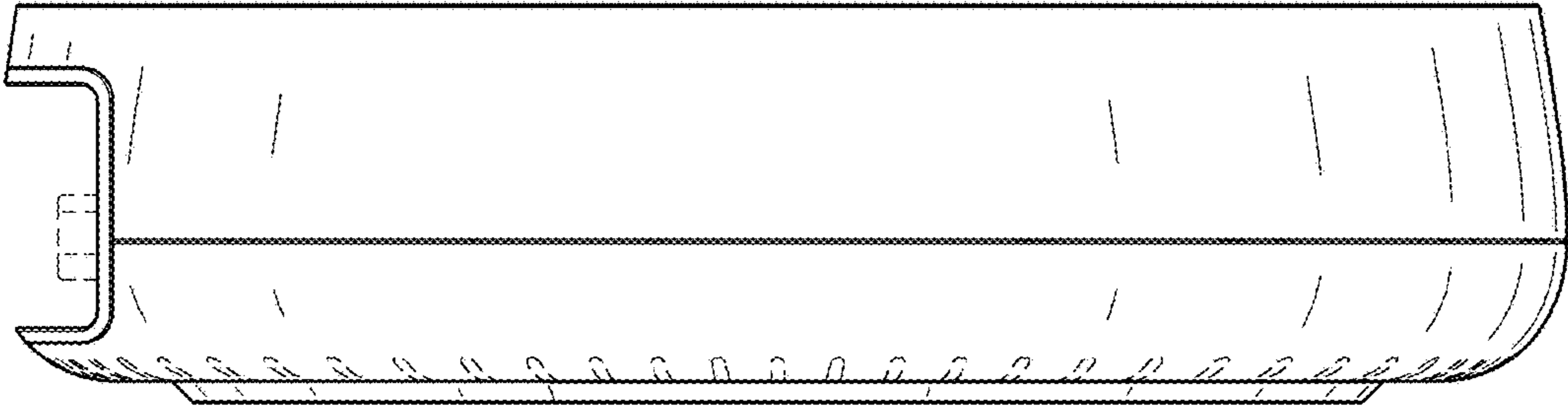

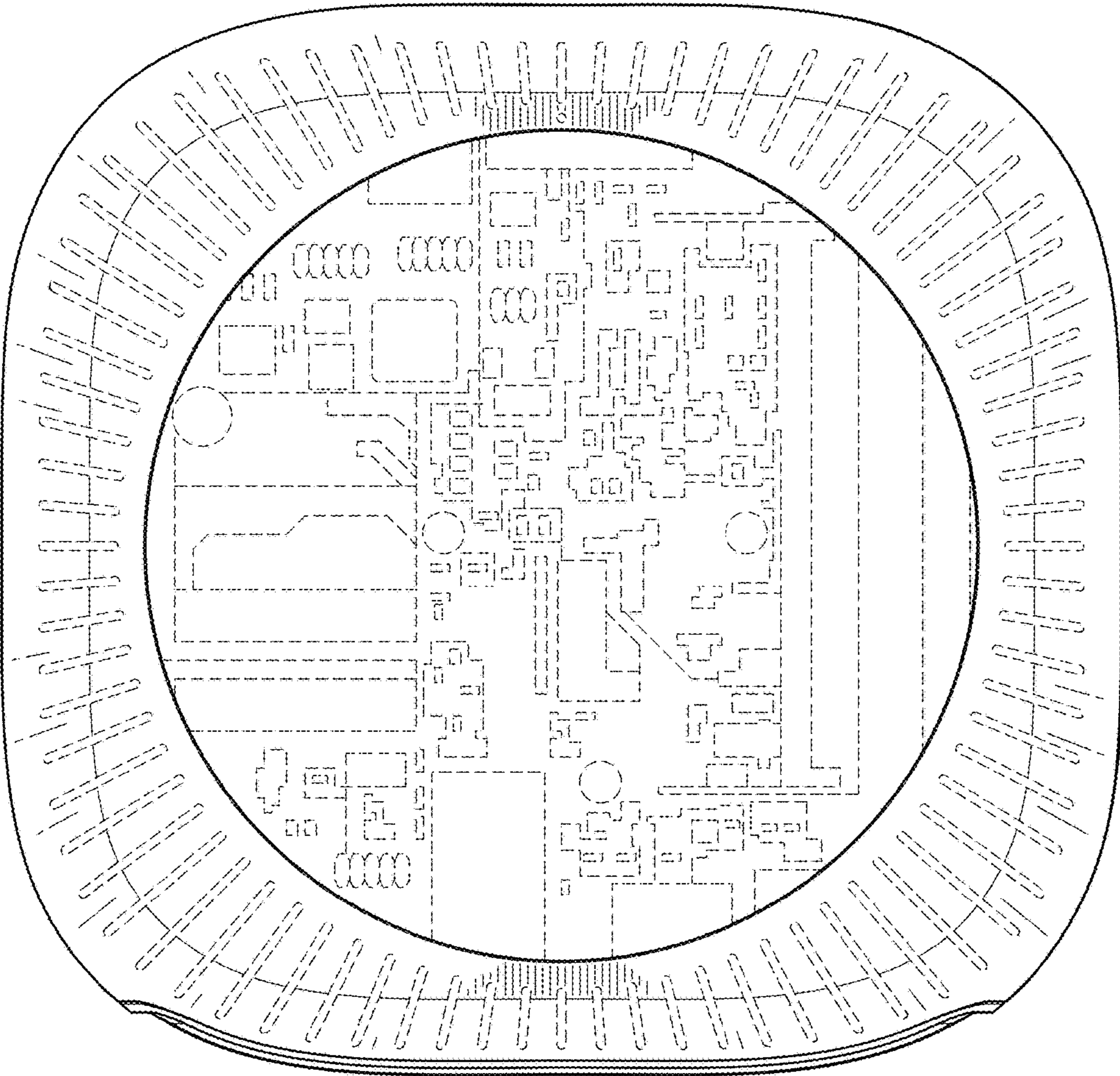
