DESCRIPTION

FIG. 1 is a front perspective view of a port replicator of the present invention;
FIG. 2 is a front view;
FIG. 3 is a rear view;
FIG. 4 is a left side;
FIG. 5 is a right side view;
FIG. 6 is a top view;
FIG. 7 is a bottom view; and,
FIG. 8 is an enlarged view of a portion of between 8-8 in FIG. 1.

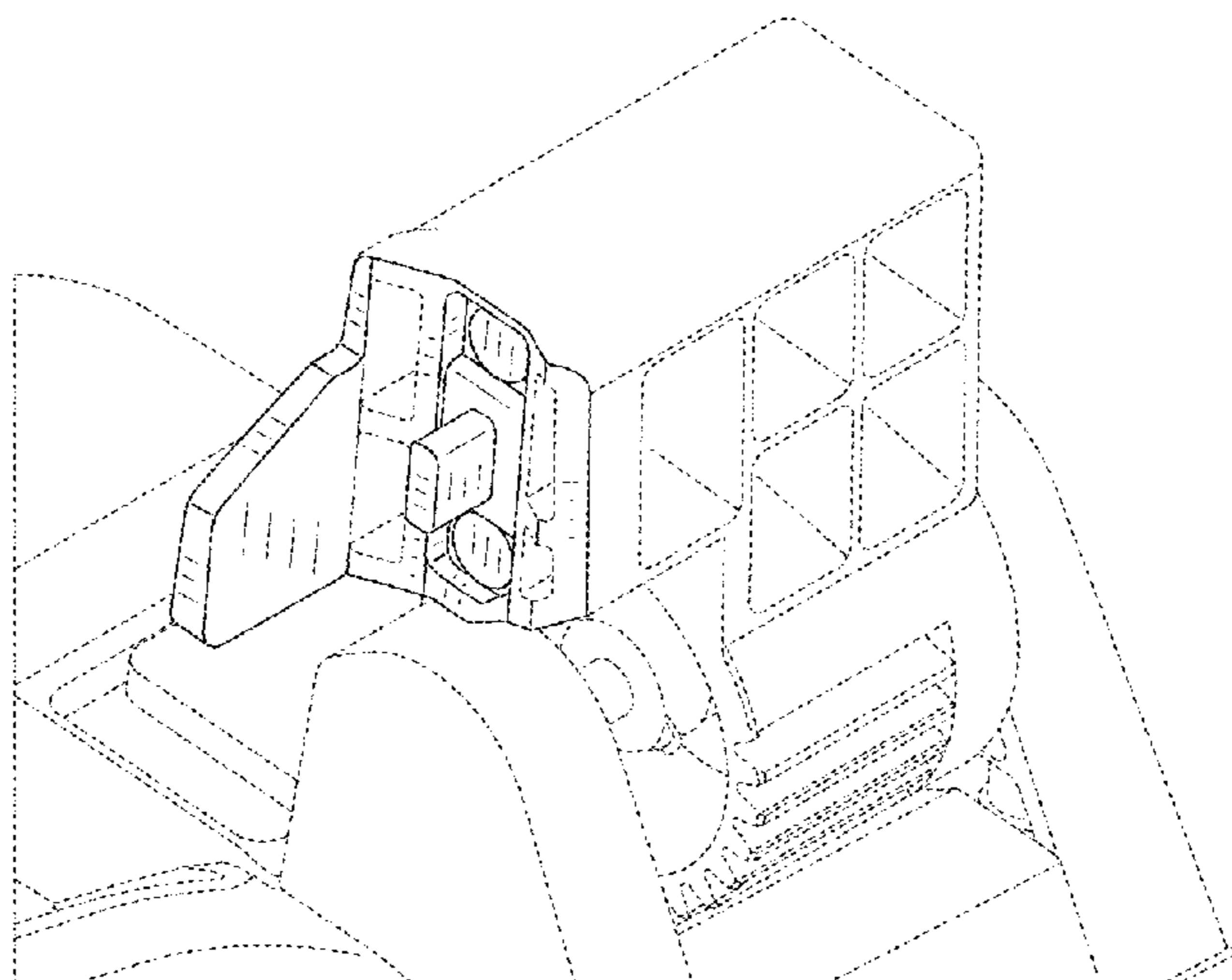

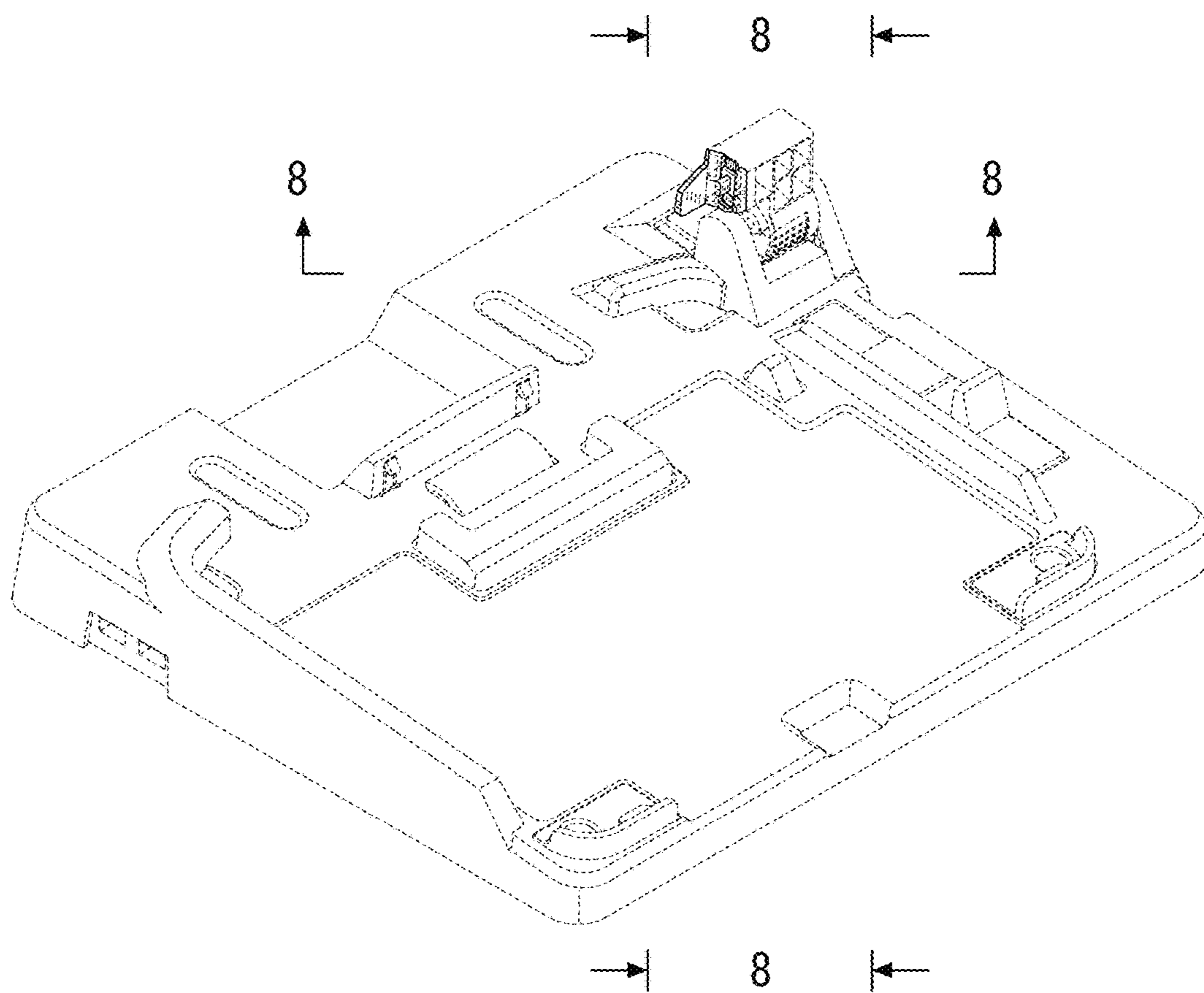

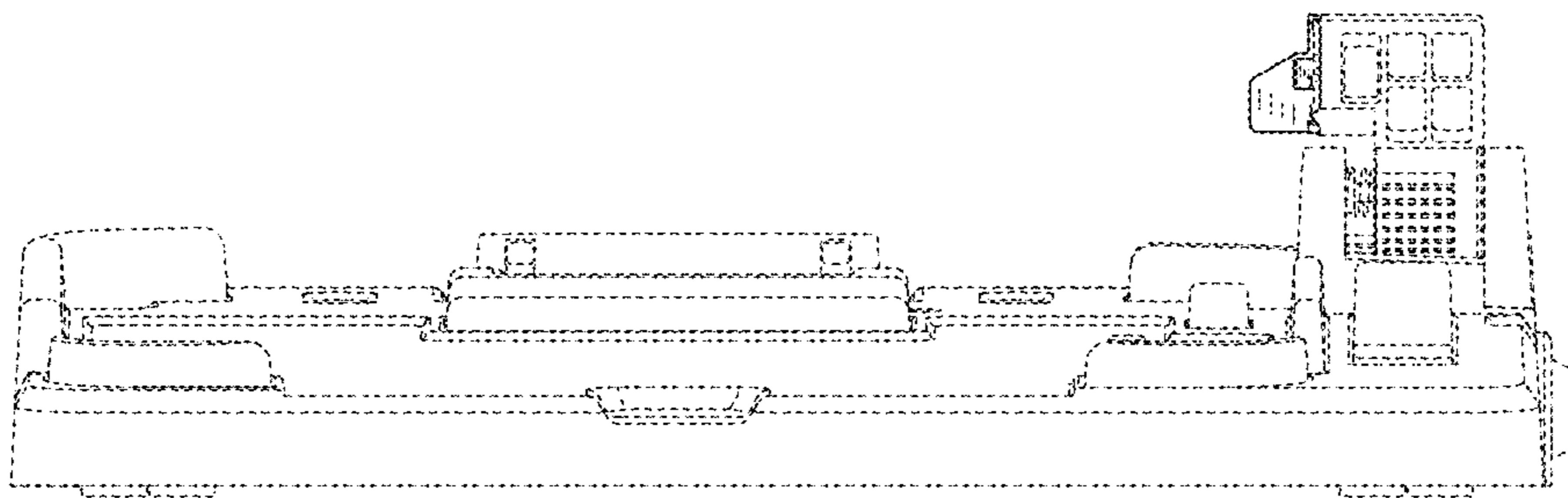

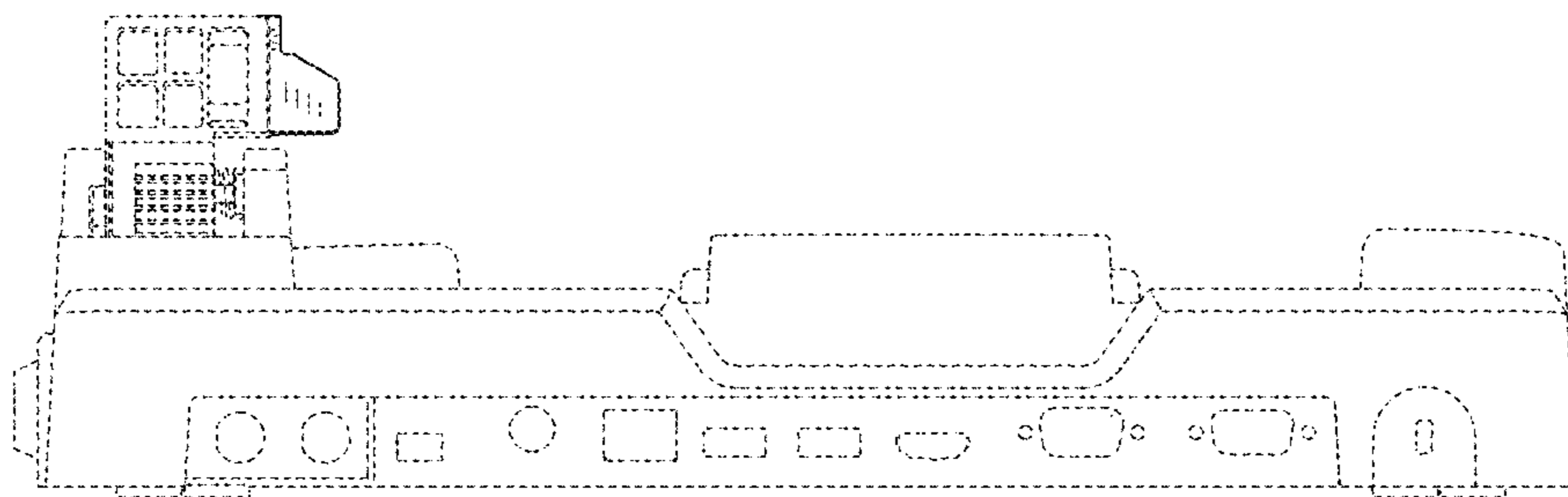

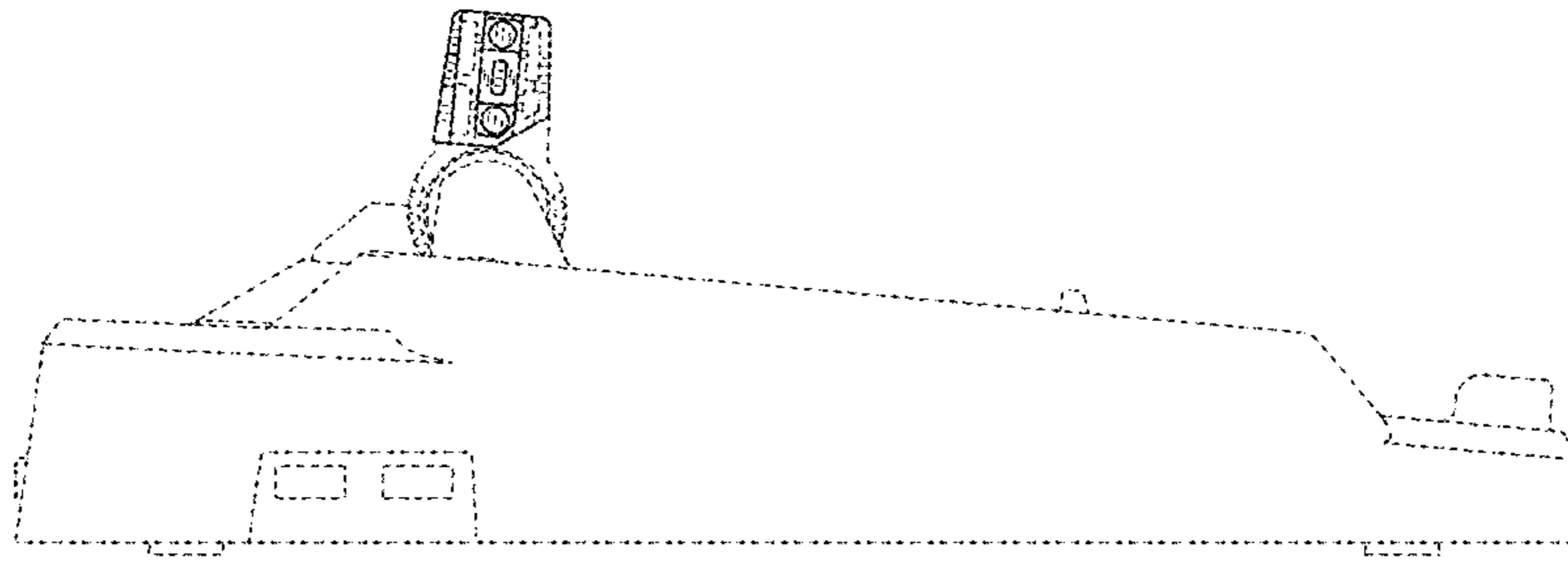

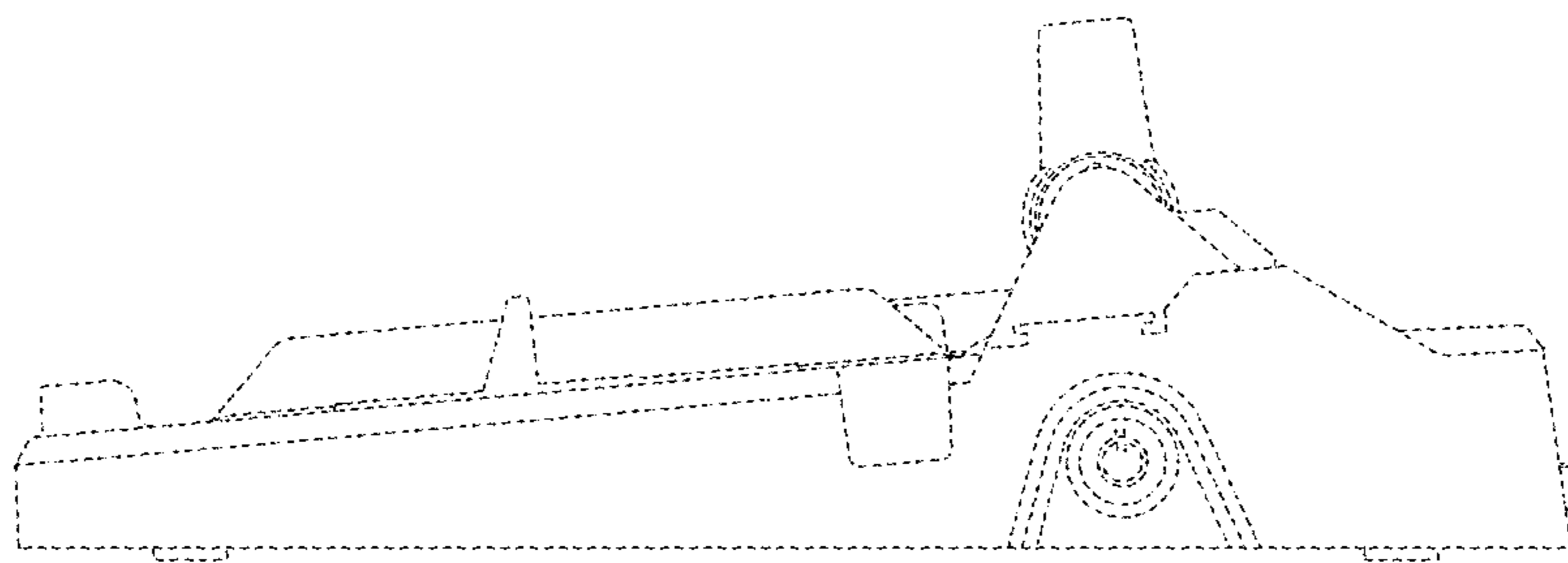

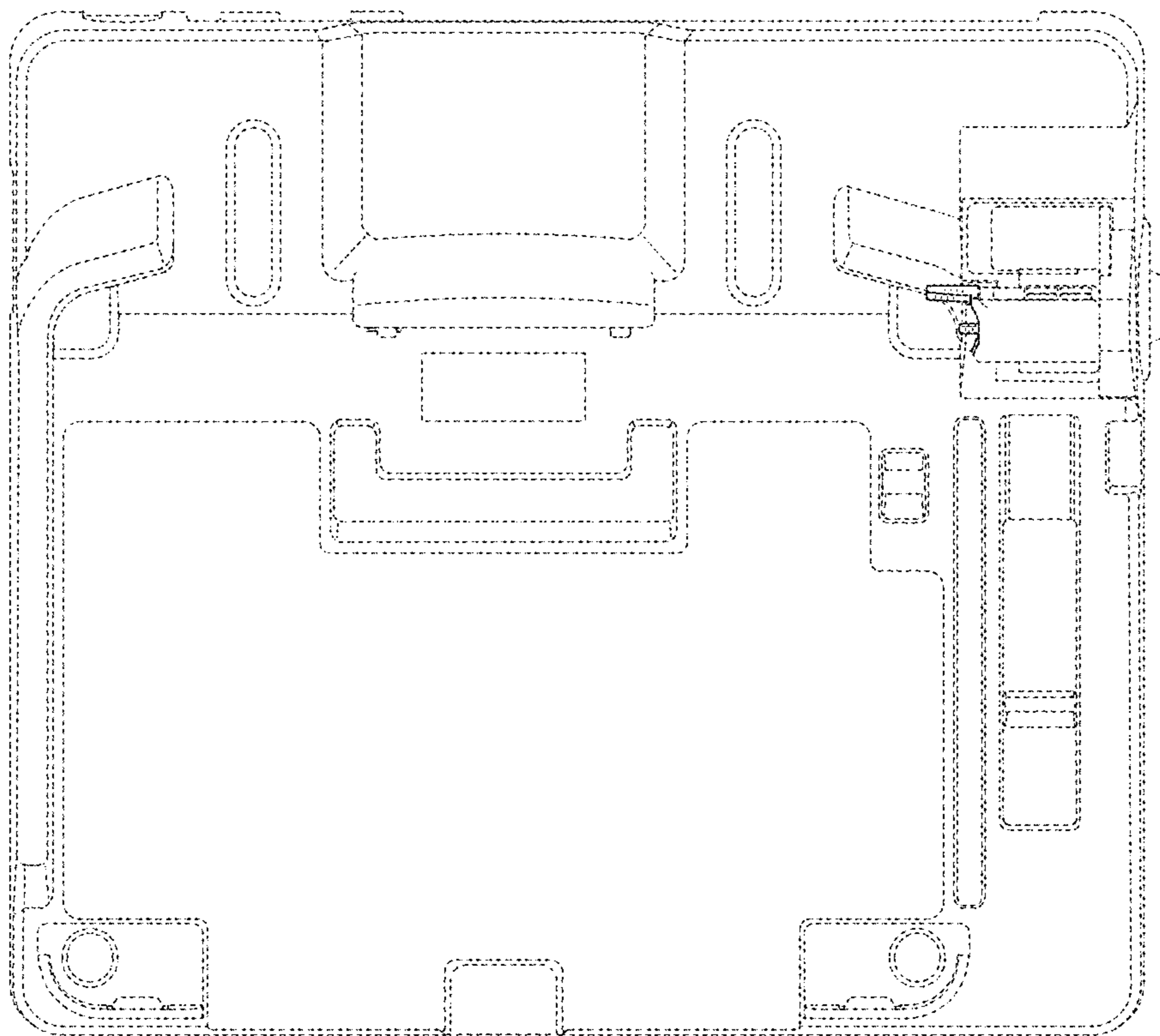

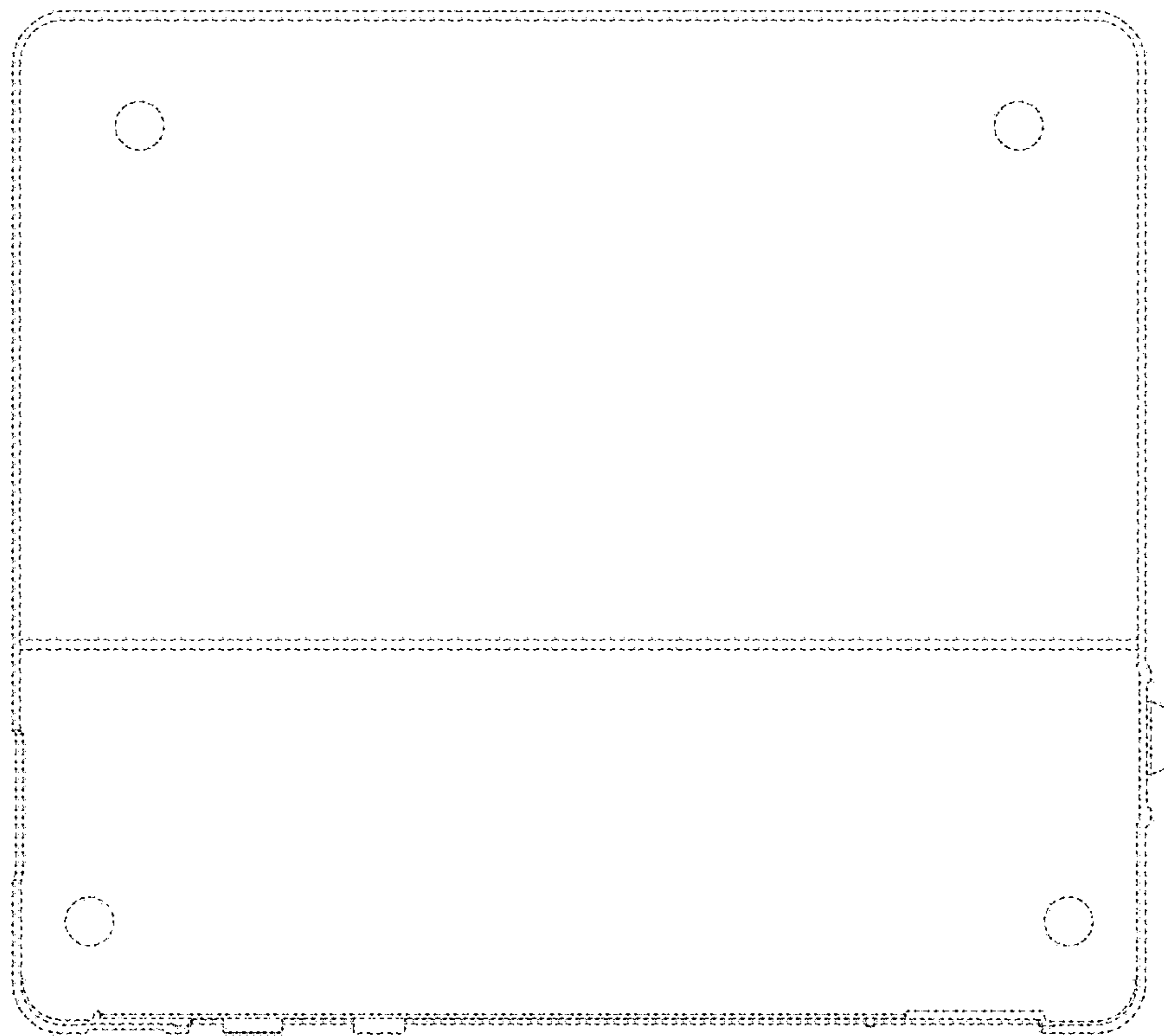
