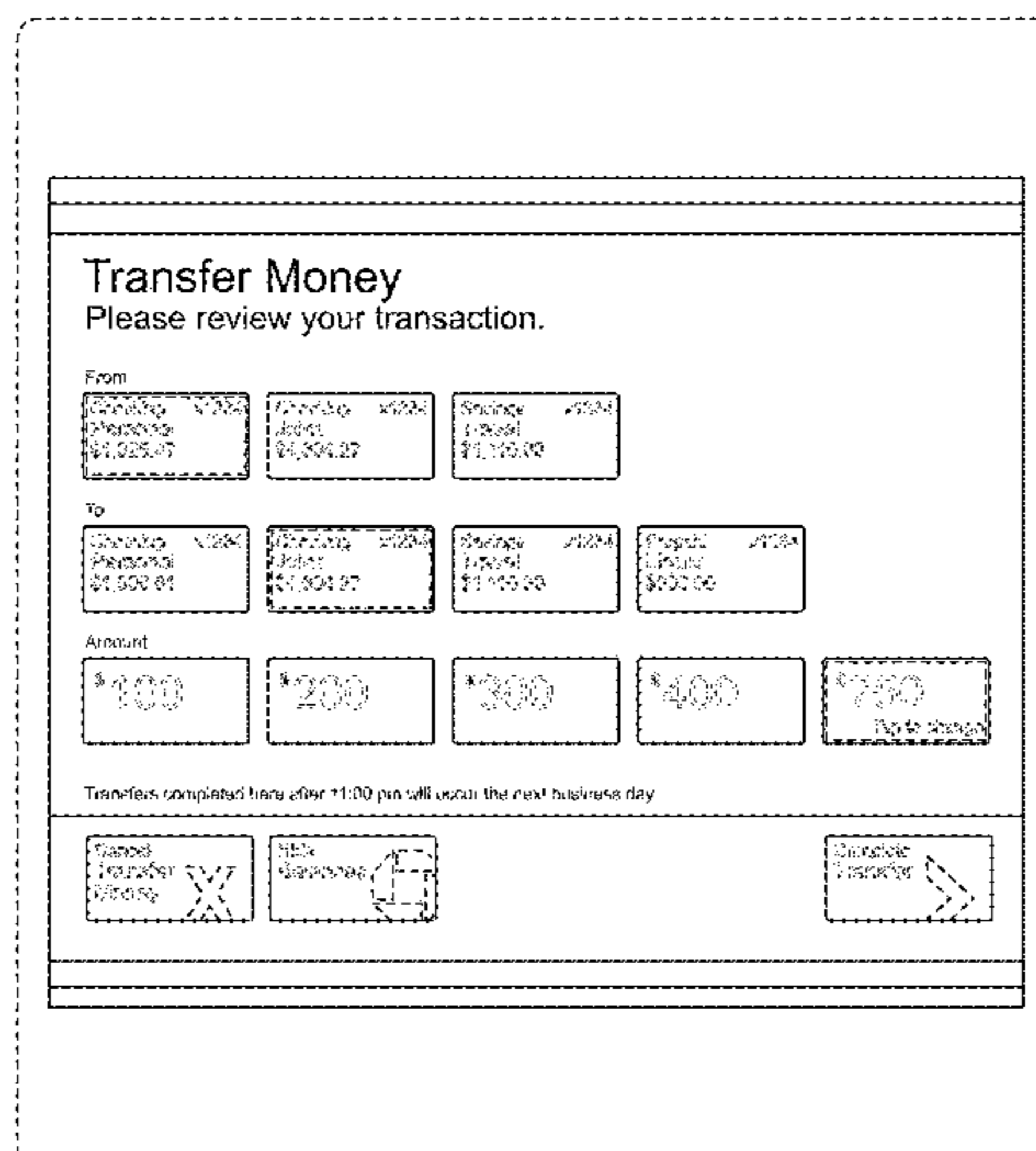
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with a graphical user interface showing our new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; and, FIG. 4 is a front view of a fourth embodiment thereof. The outermost broken line rectangle illustrates a display screen or portion thereof and forms no part of the claimed design. 



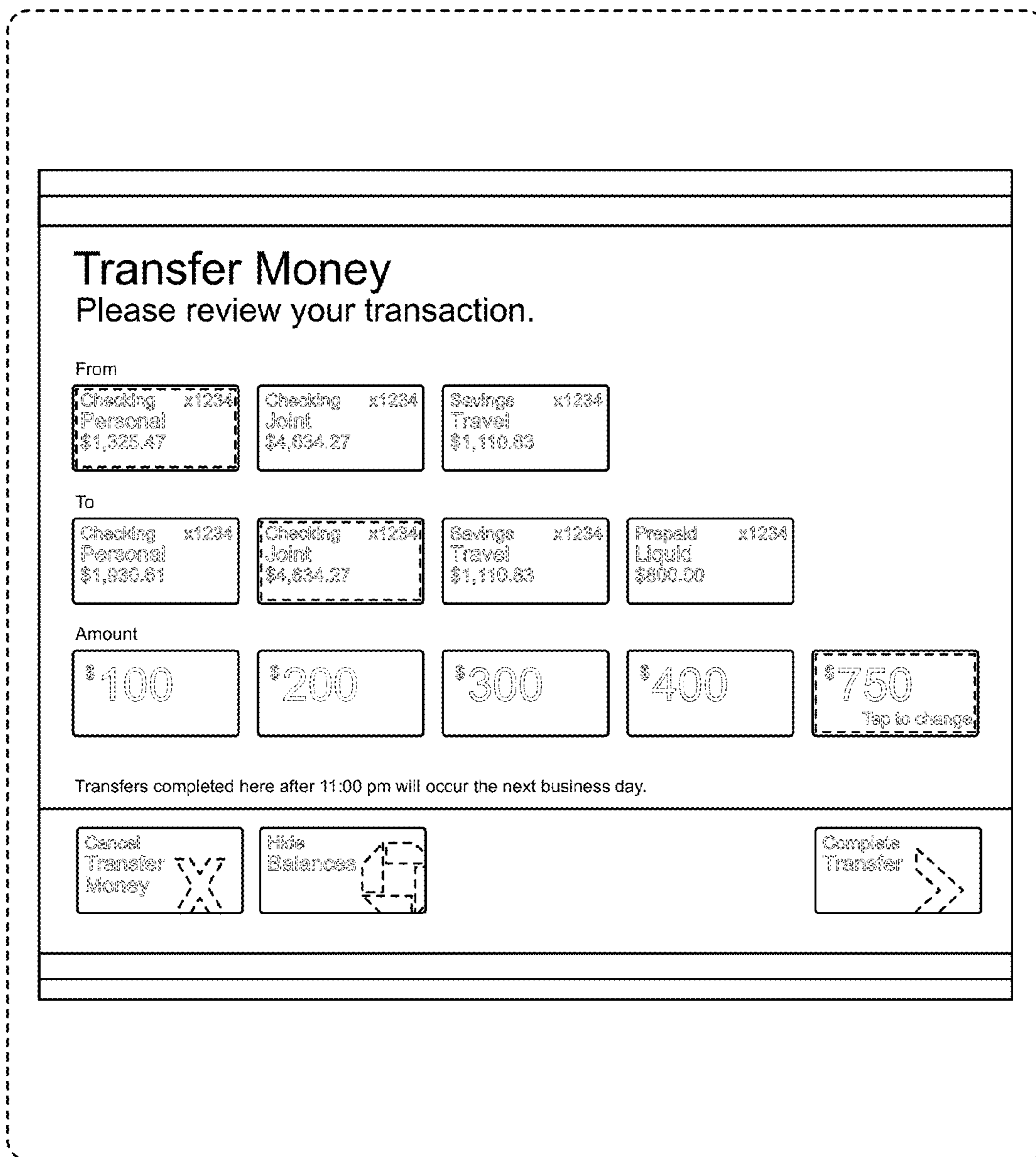
