FIG. 2 is a front elevational view of a second embodiment of display screen or portion thereof with graphical user interface and icons.

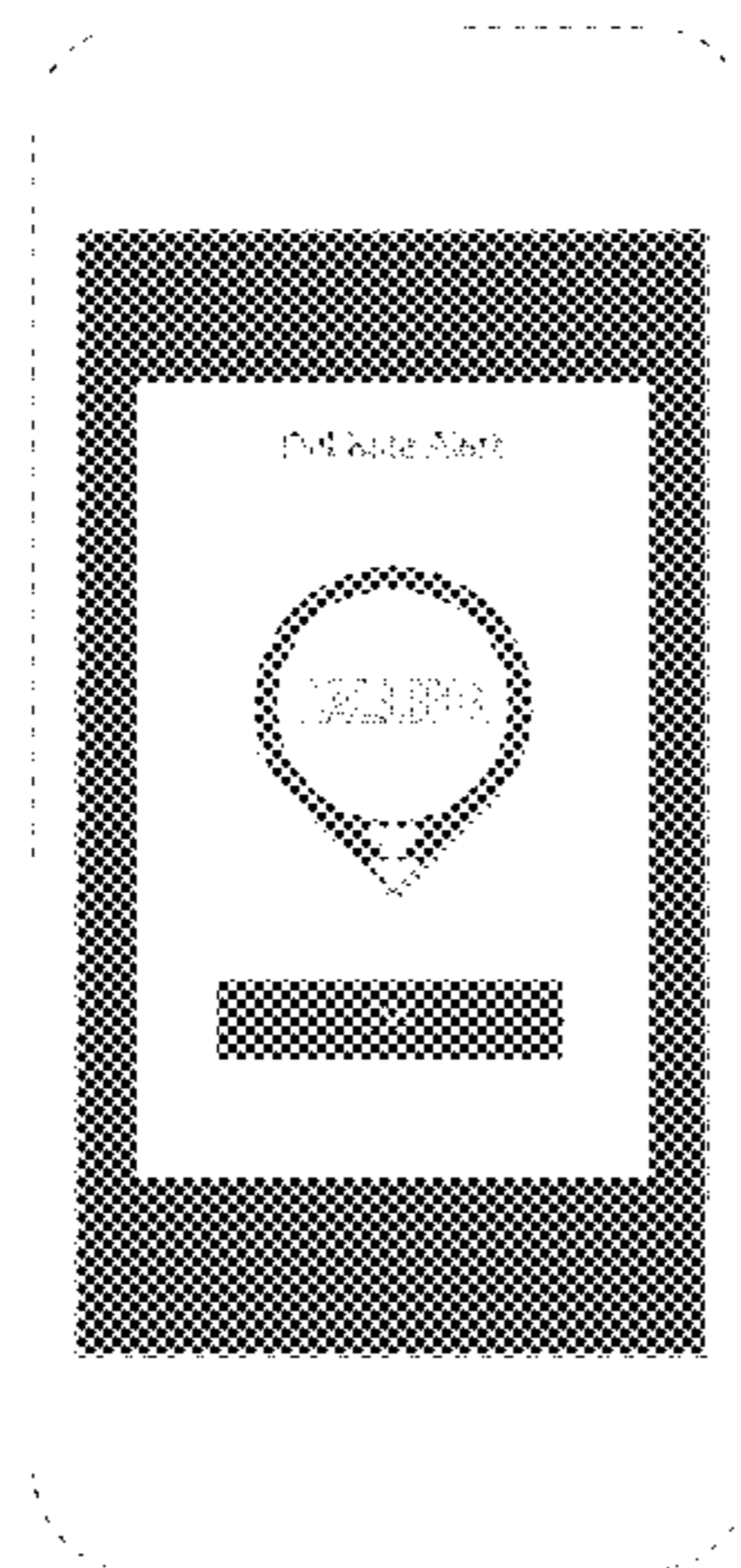
FIG. 3 is a front elevational view of a third embodiment of display screen or portion thereof with graphical user interface and icons.

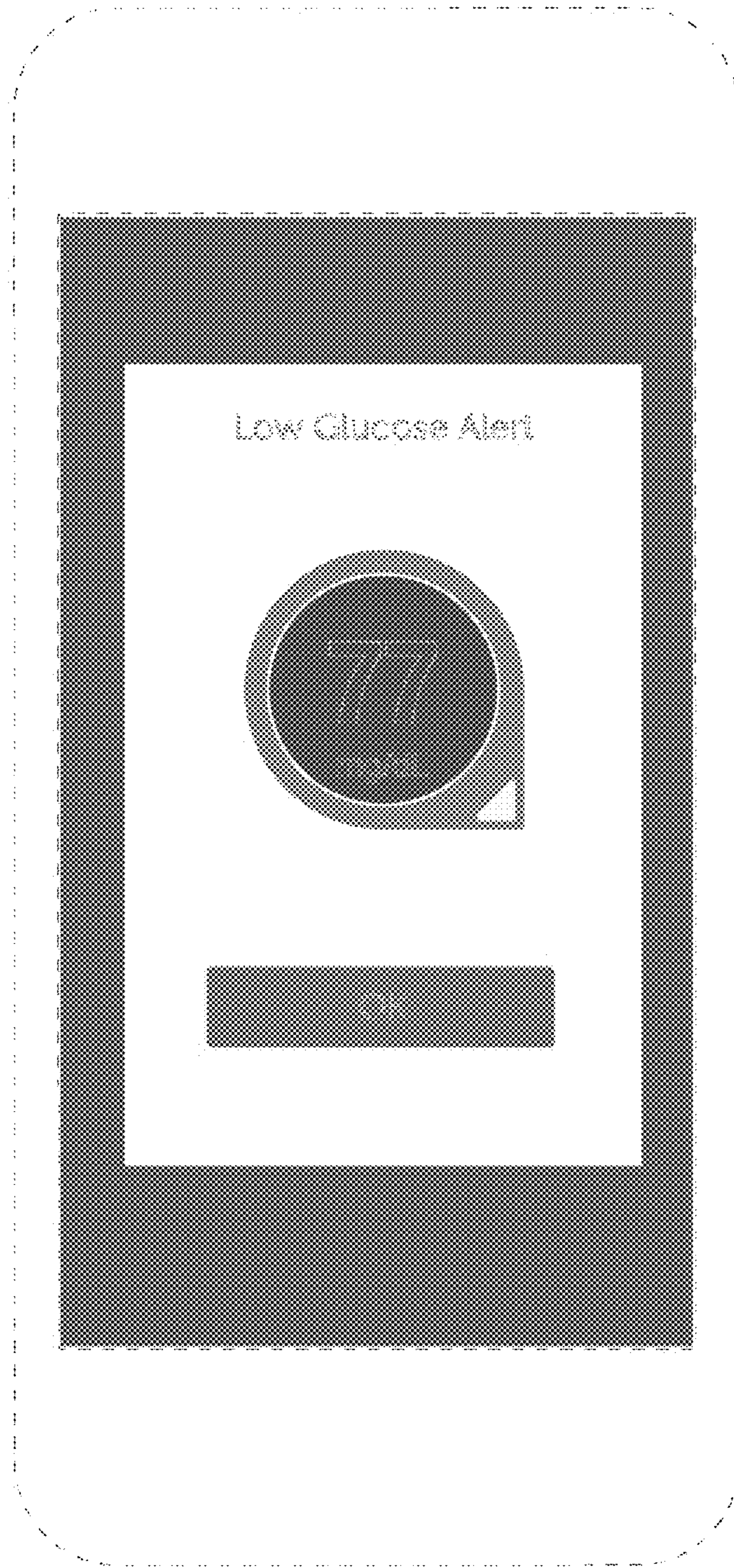

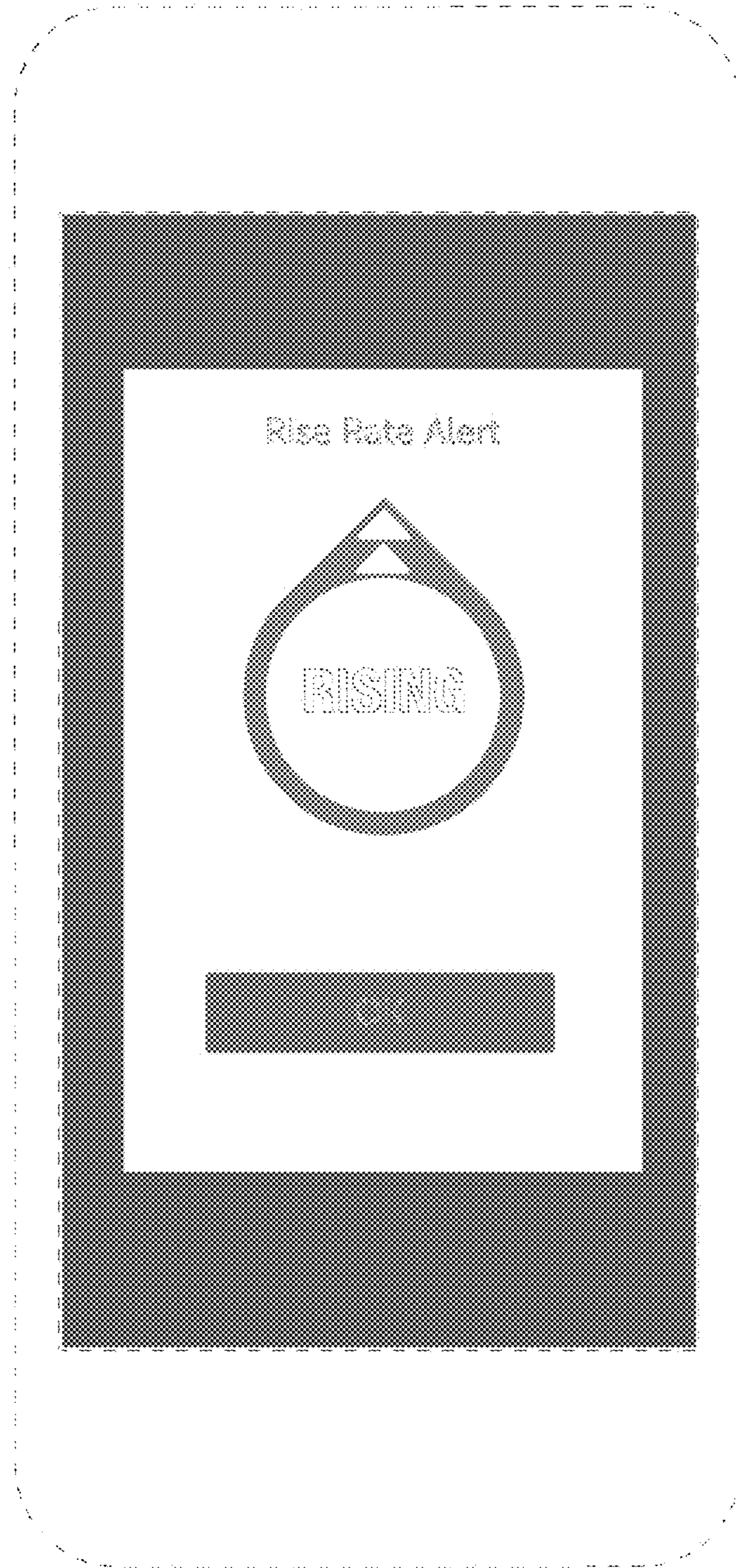
