(57) **CLAIM**

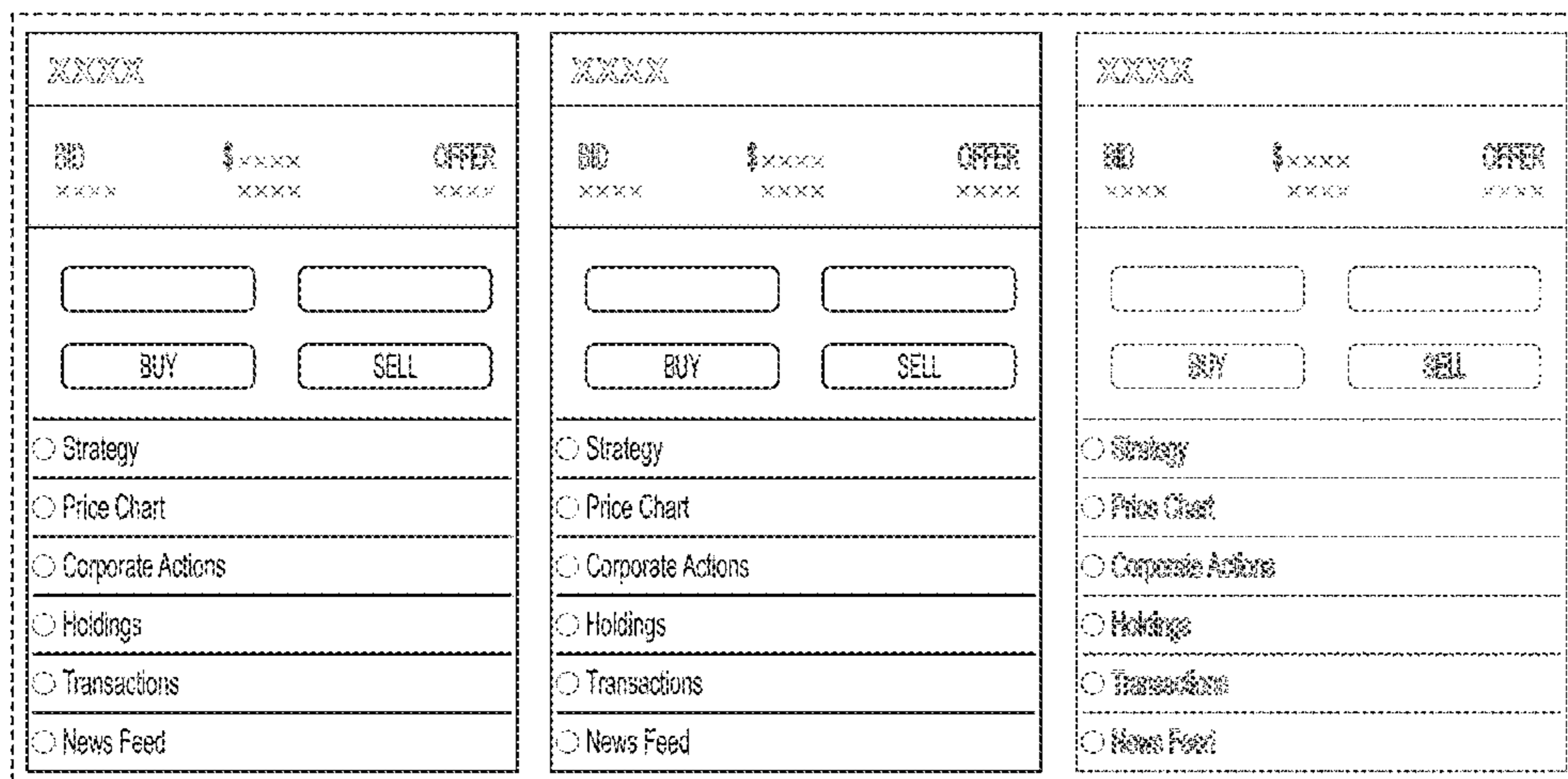
I claim the ornamental design for a display screen or portion thereof with stock trading graphical user interface, as shown and described.
