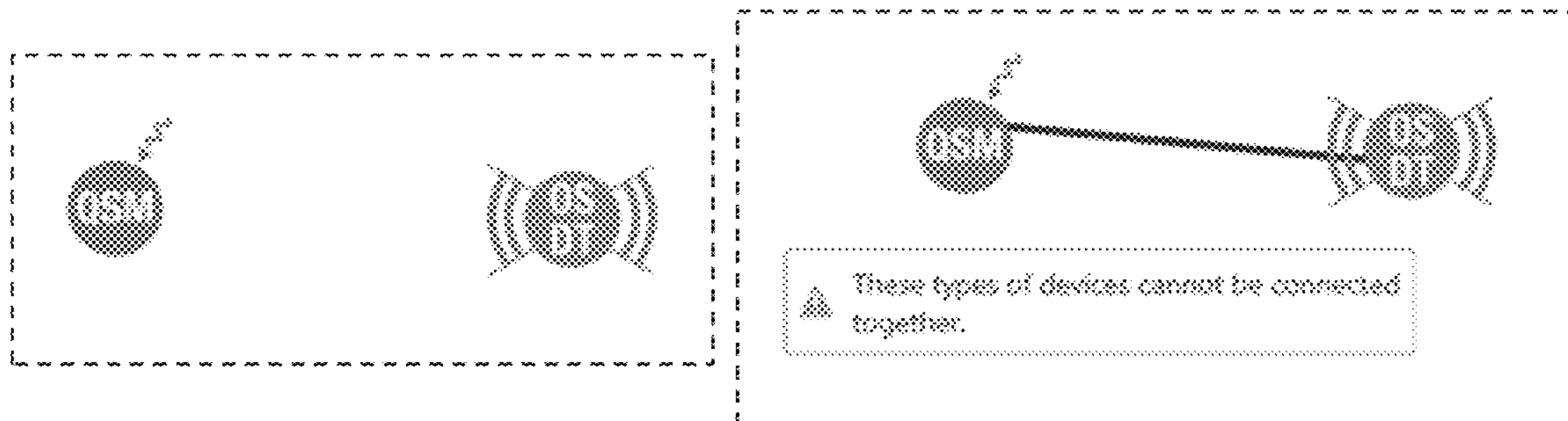
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 shows a display screen or portion thereof with animated graphical user interface showing our new design; FIG. 2 shows a second image thereof; and, FIG. 3 shows a third image thereof. The peripheral dashed broken lines represent a display screen or portion thereof and form no part of the claimed design. The appearance of the graphical user interface sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another forms no part of the claimed design.

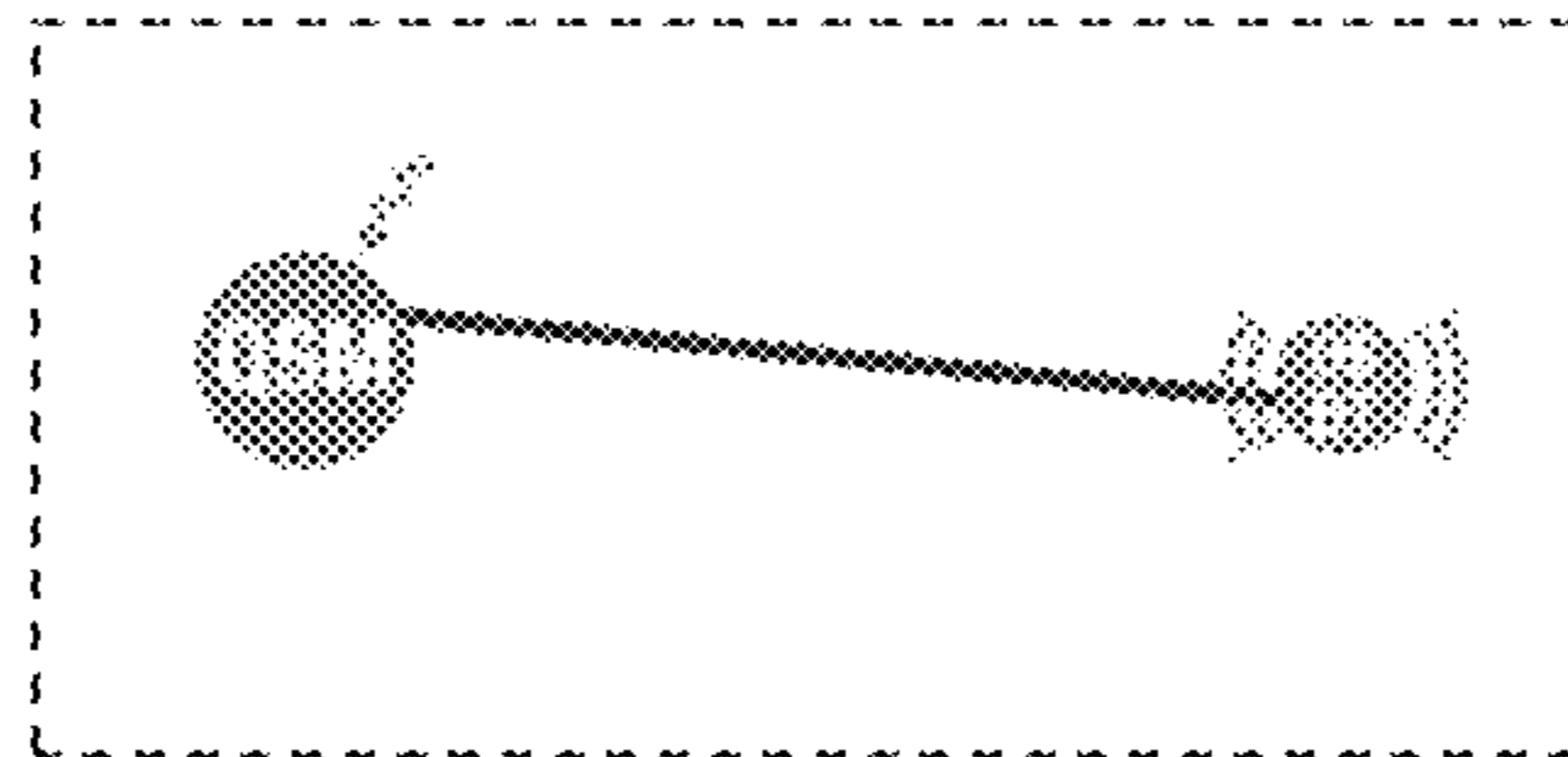

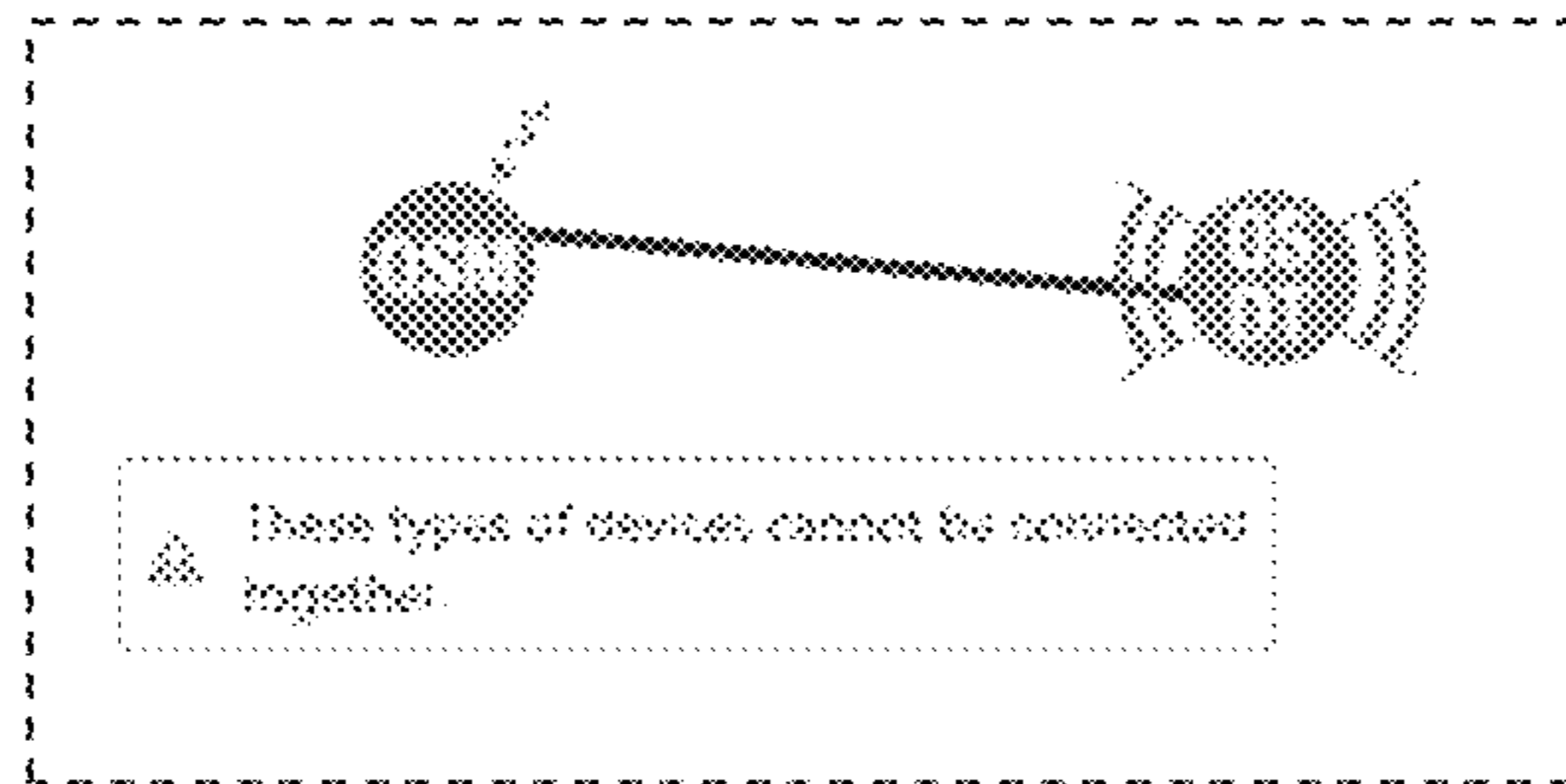
