(57) **CLAIM**

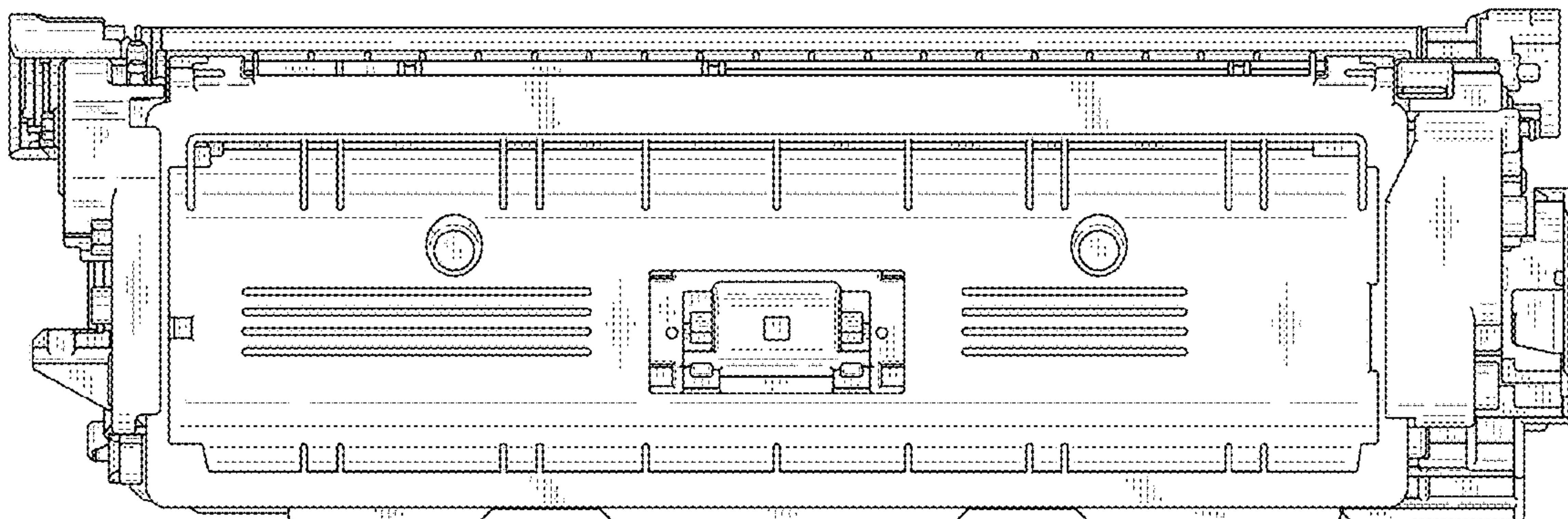
The ornamental design for a process cartridge for image forming apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a process cartridge for image forming apparatus showing our new design; FIG. 2 is a rear view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a front perspective view thereof; FIG. 8 is a rear perspective view thereof; and, FIG. 9 is a front, bottom and left side perspective view thereof.

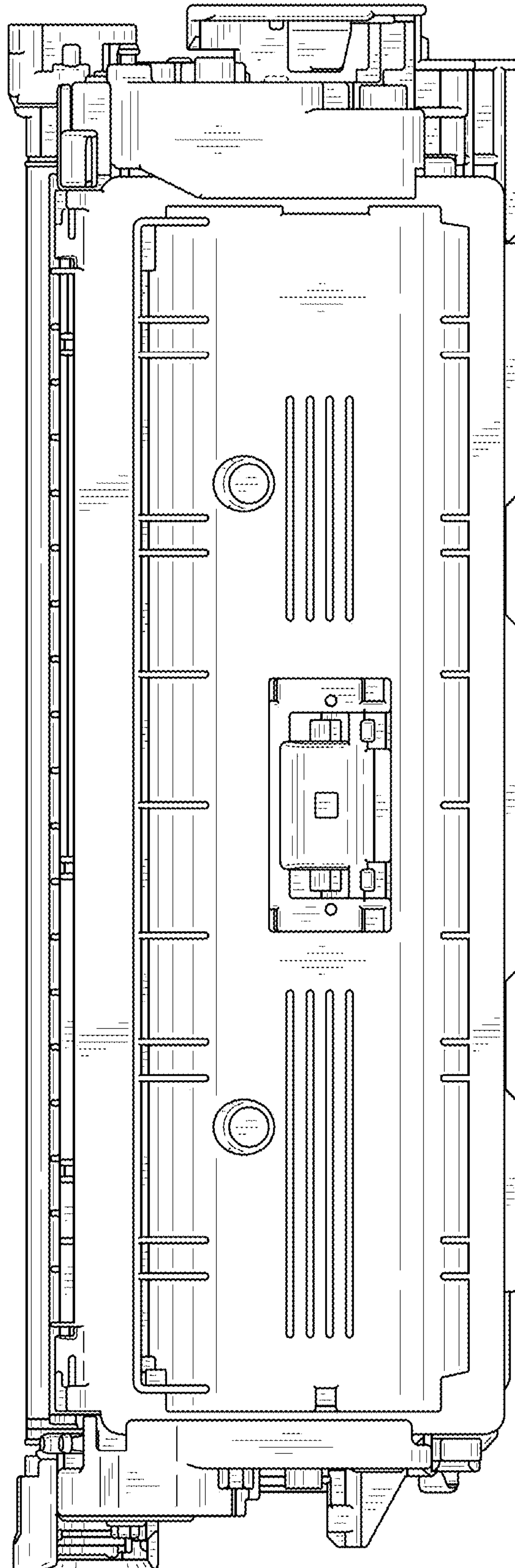

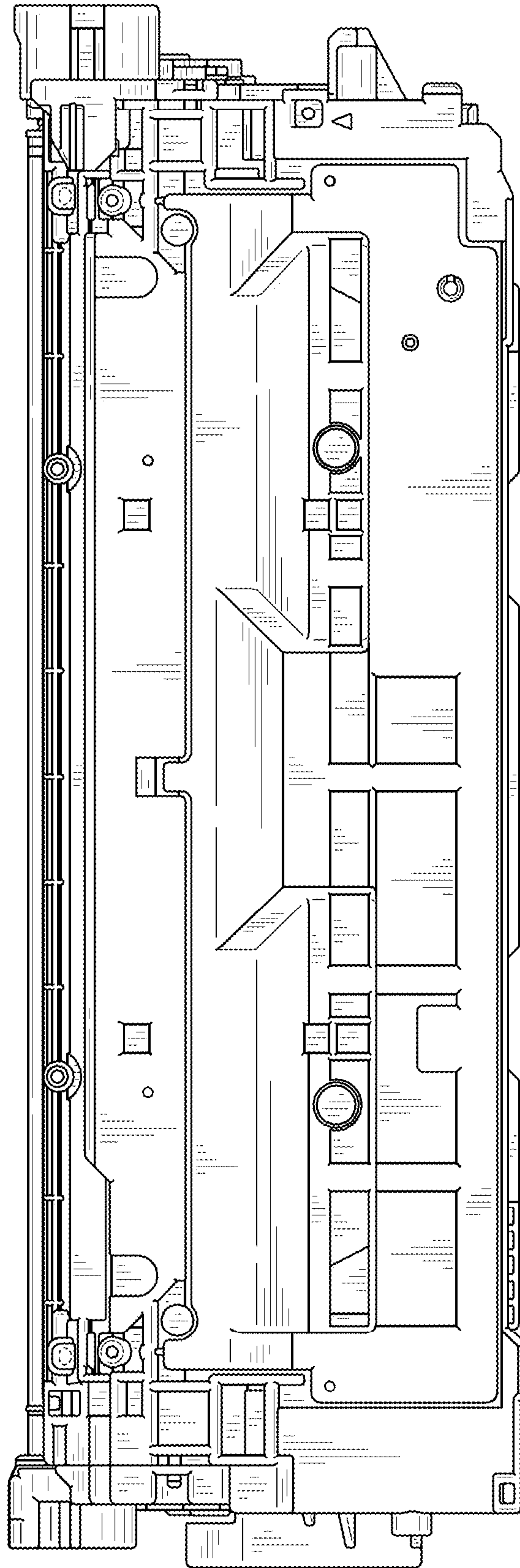

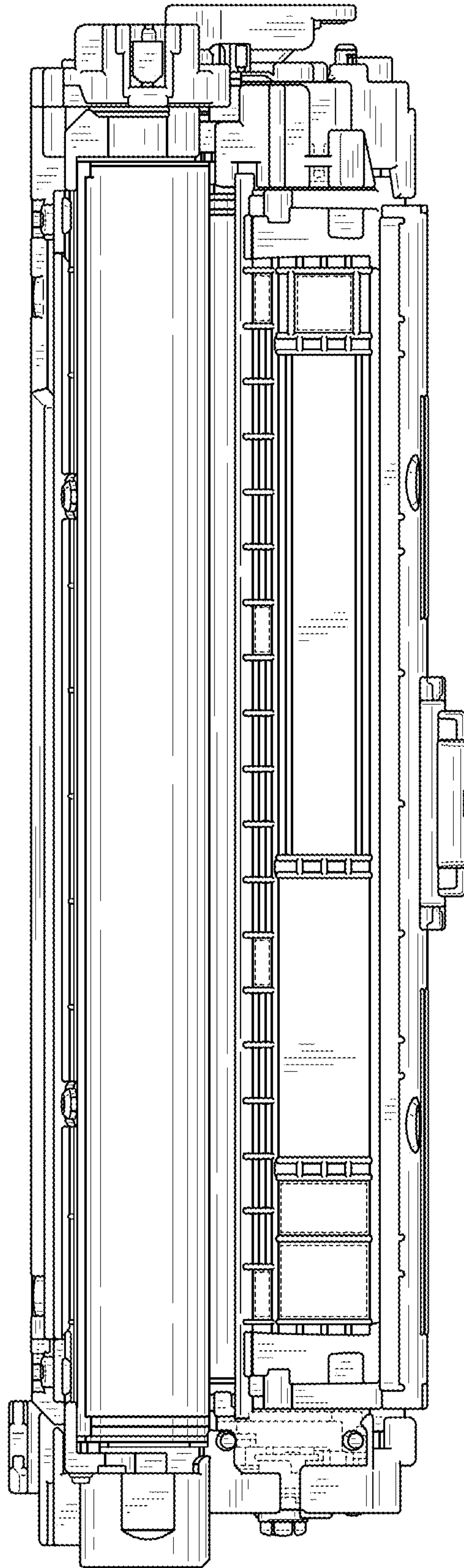

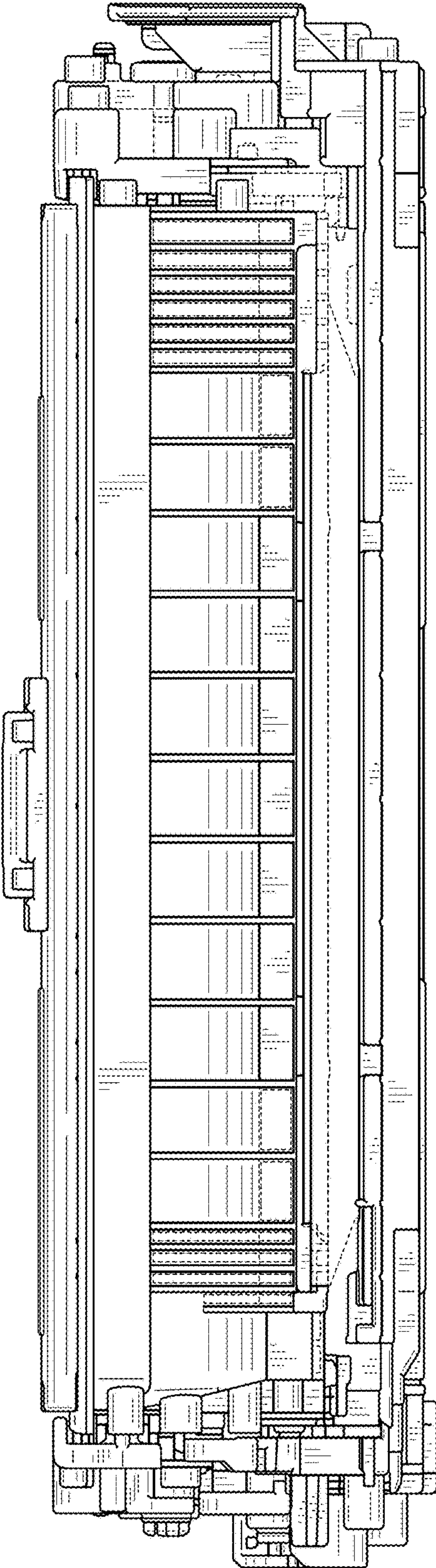

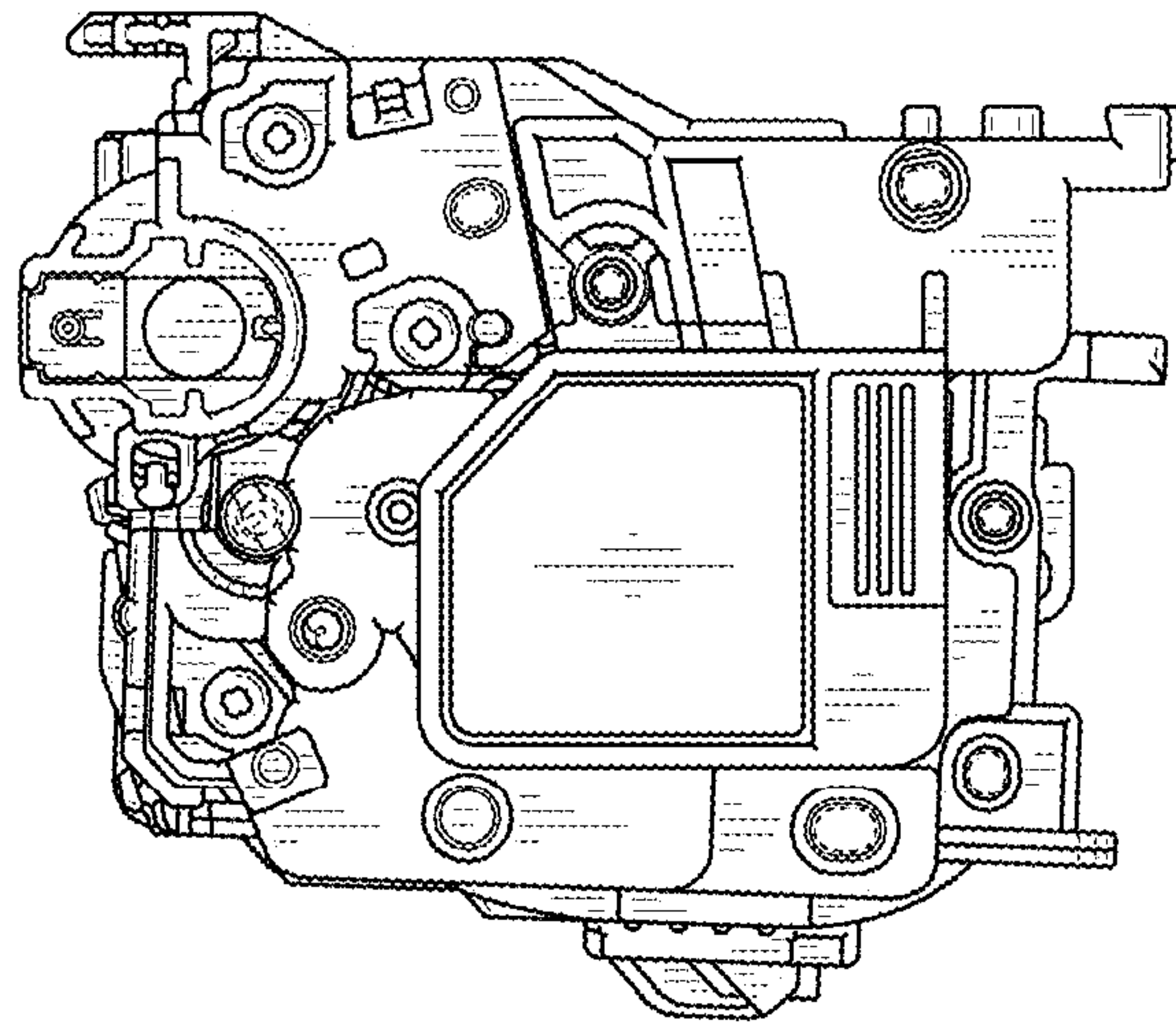

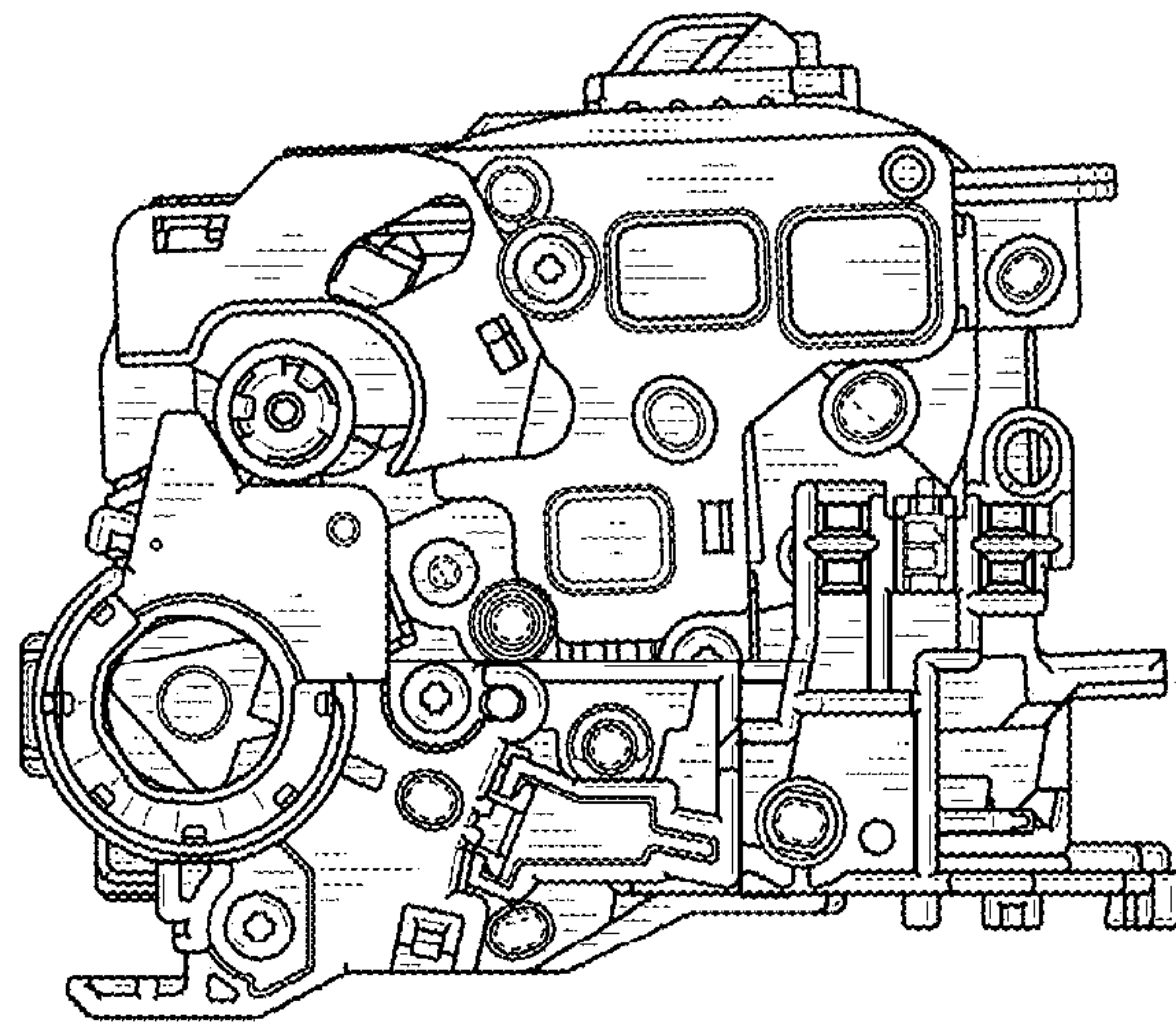

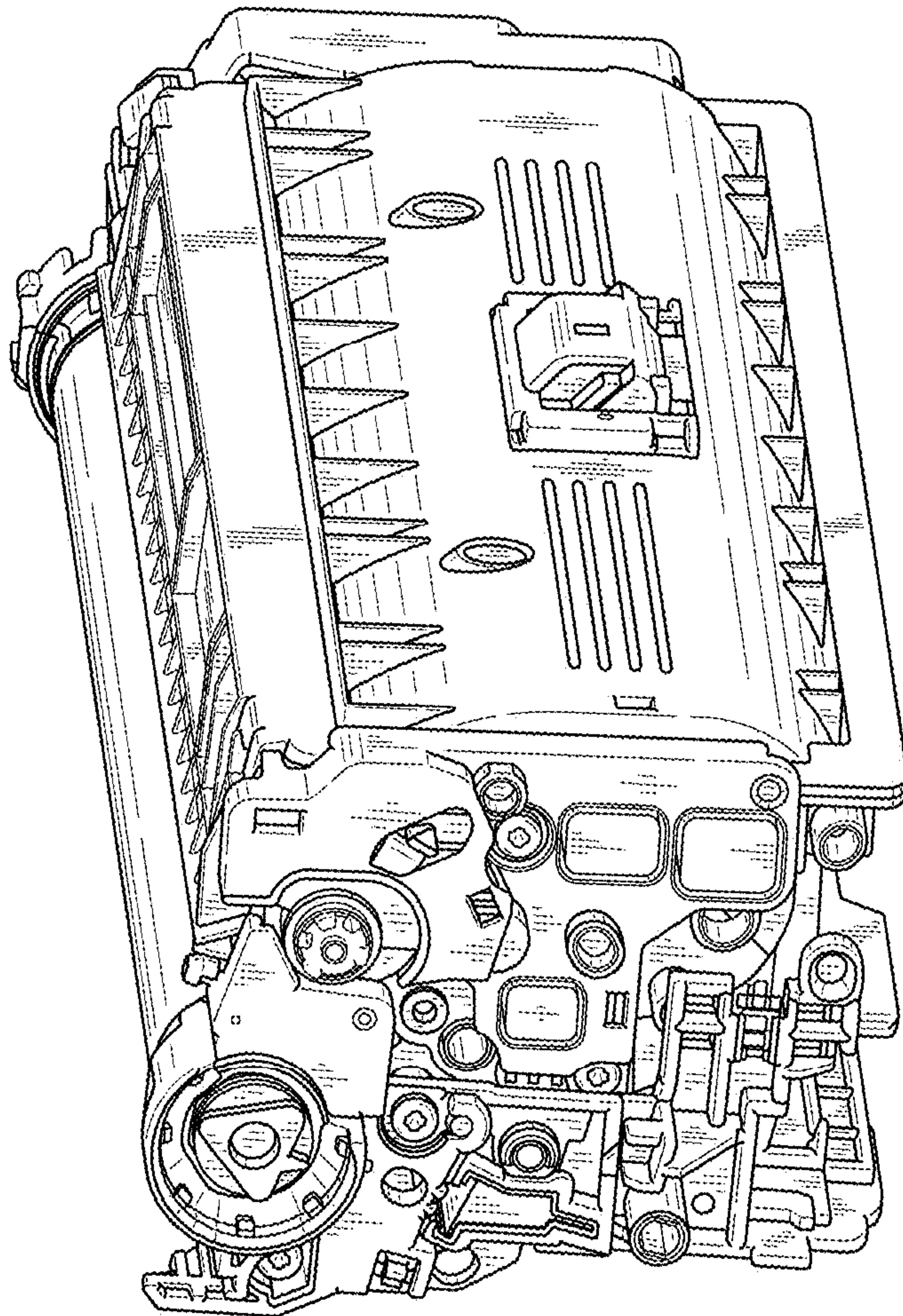

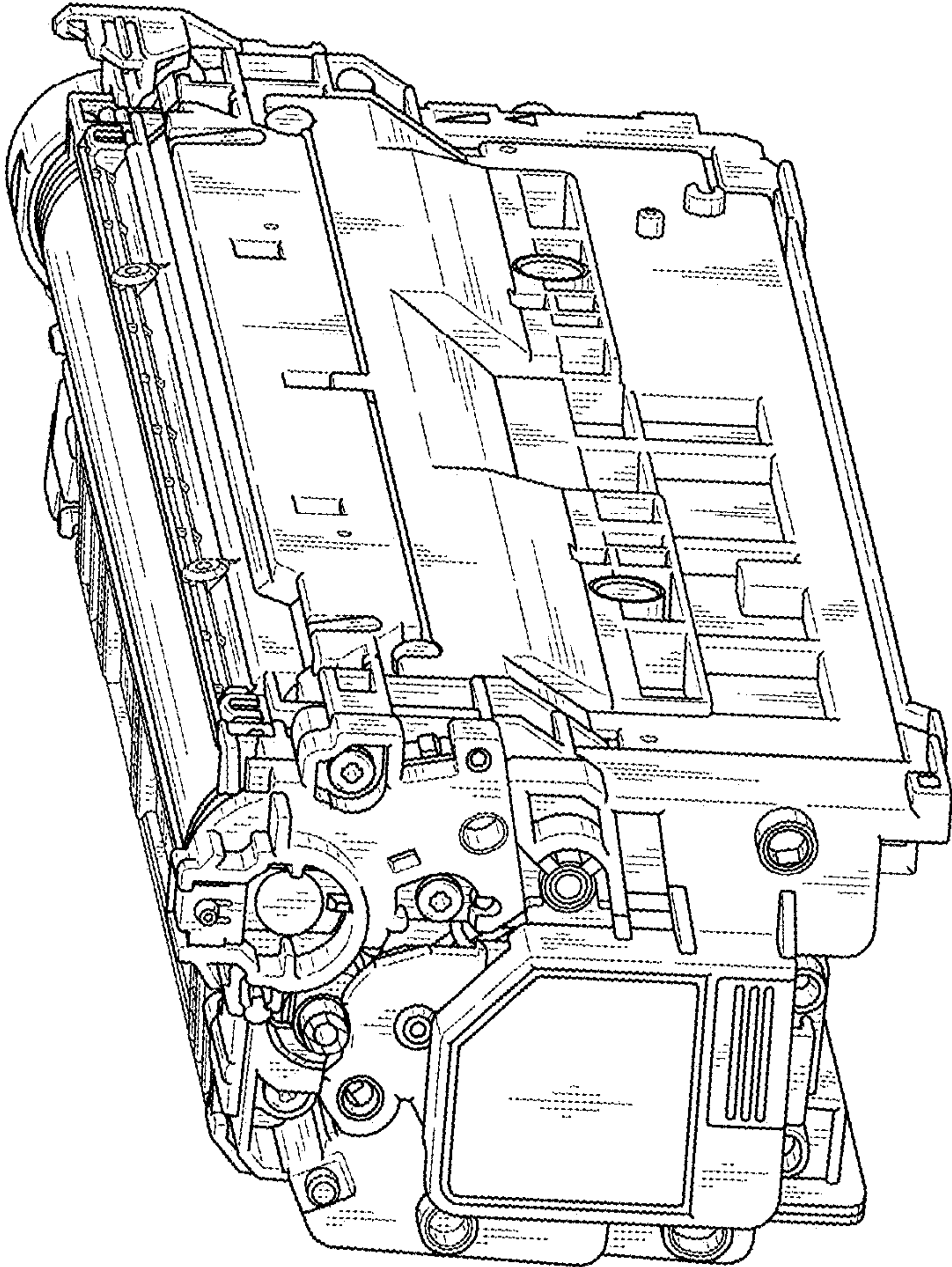

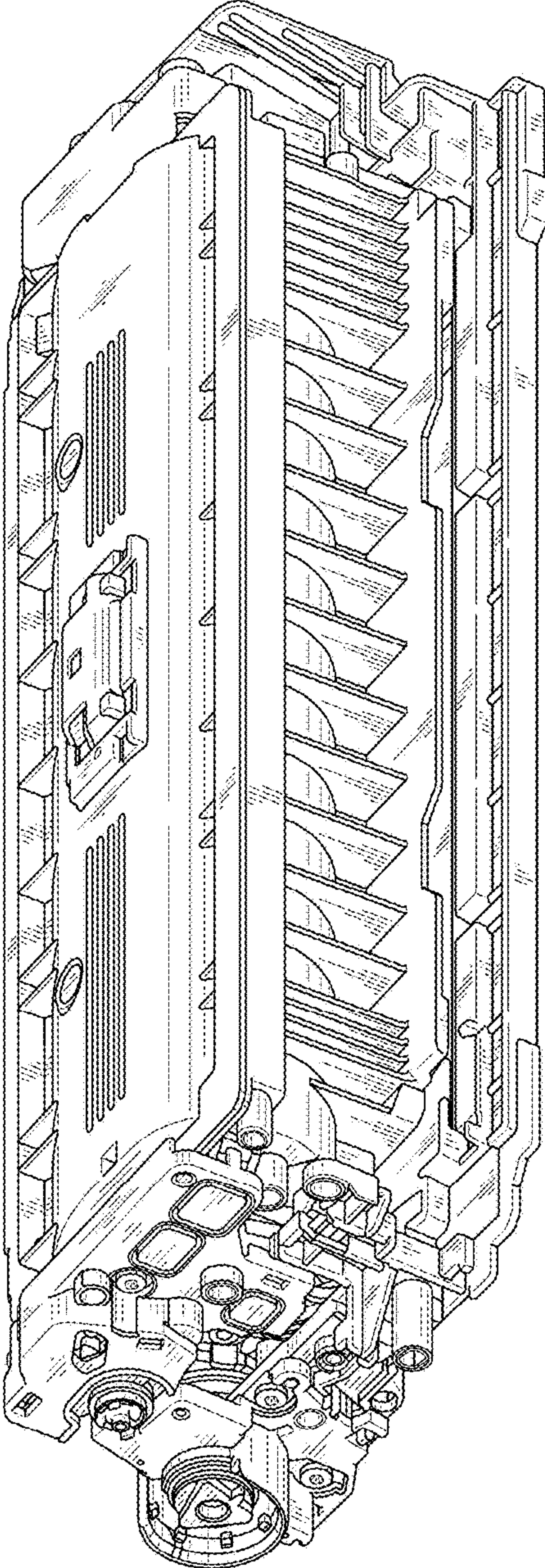
