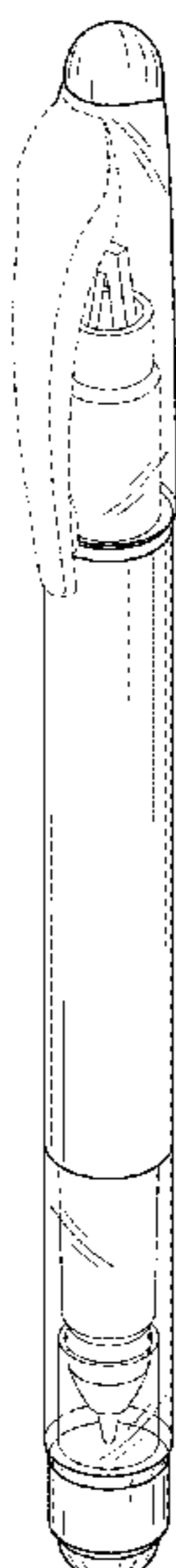
The ornamental design for a pen with highlighter tip, as shown and described.

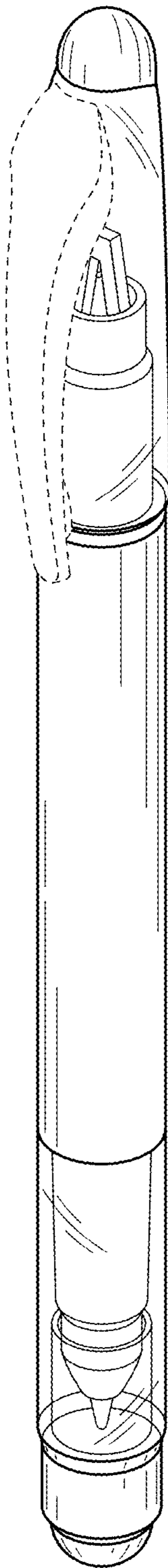

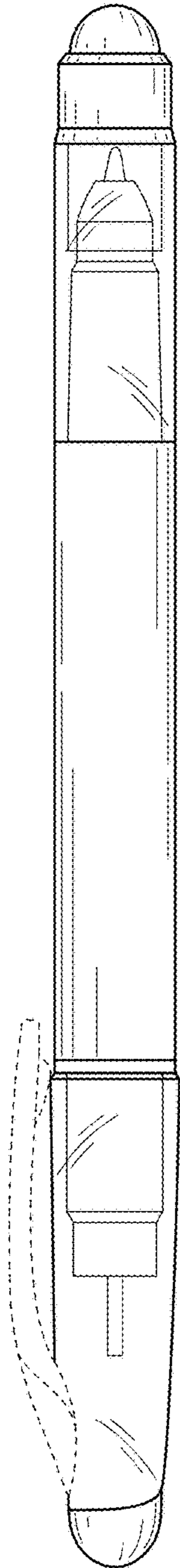

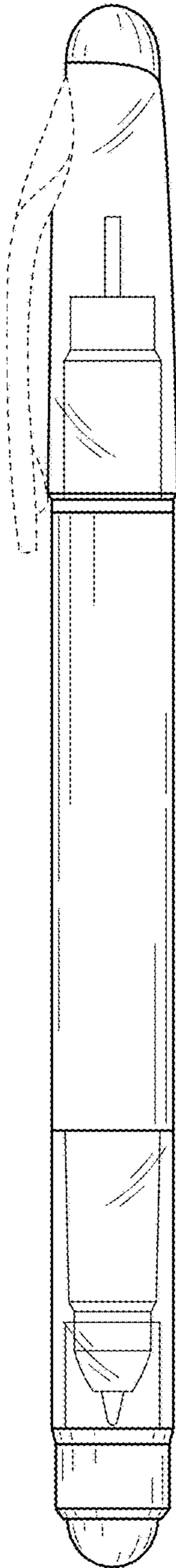

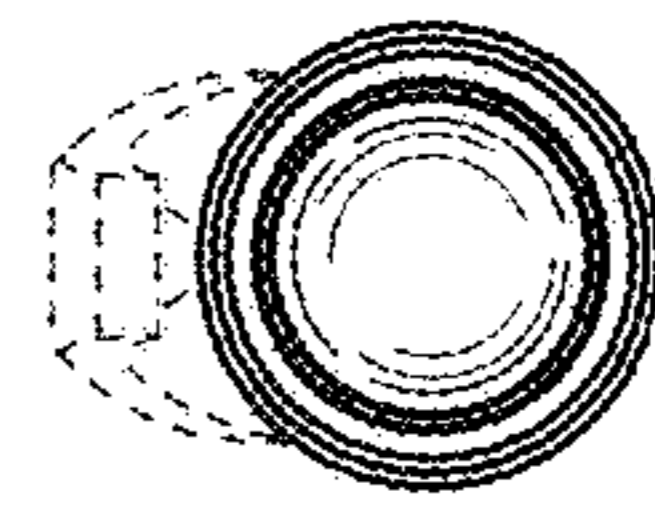

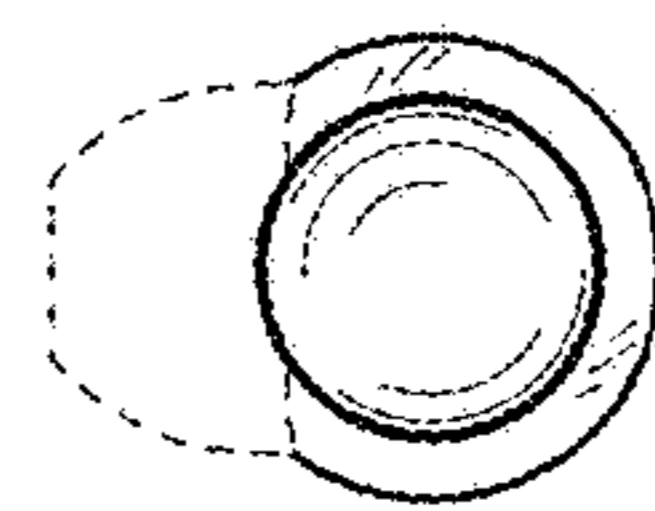

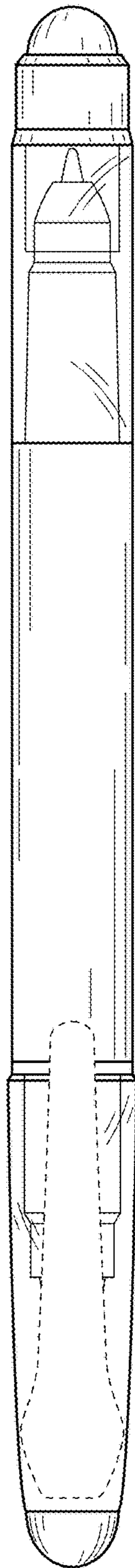

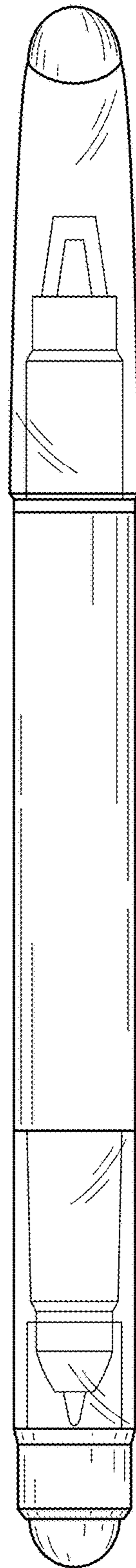
