FIG. 5 is a toe side elevational view thereof;

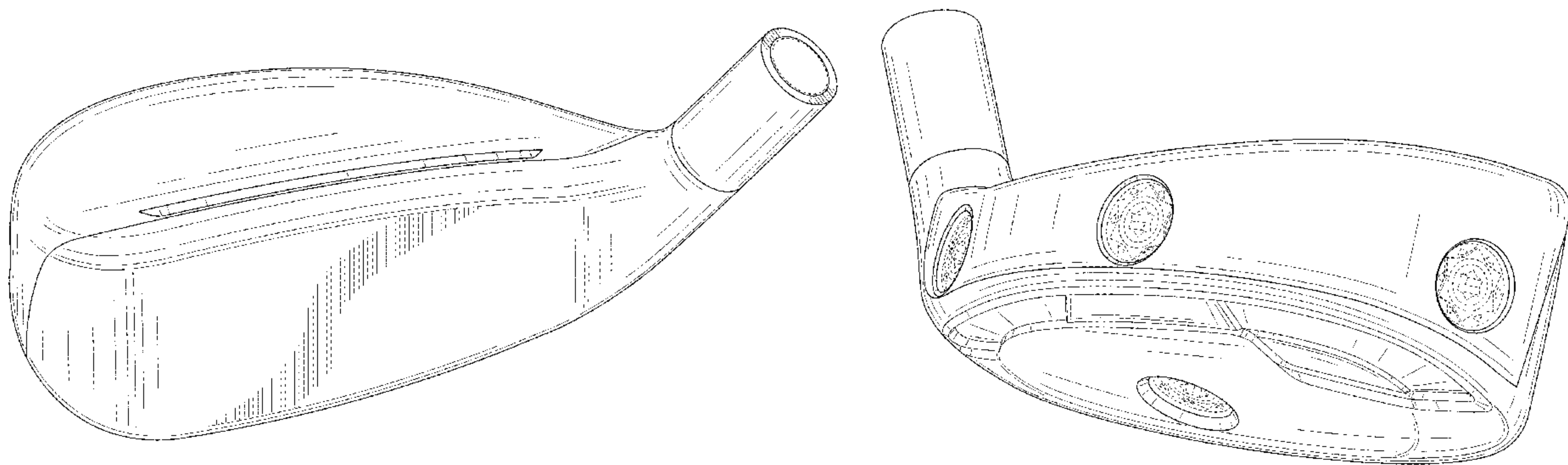
FIG. 6 is a heel side elevational view thereof;

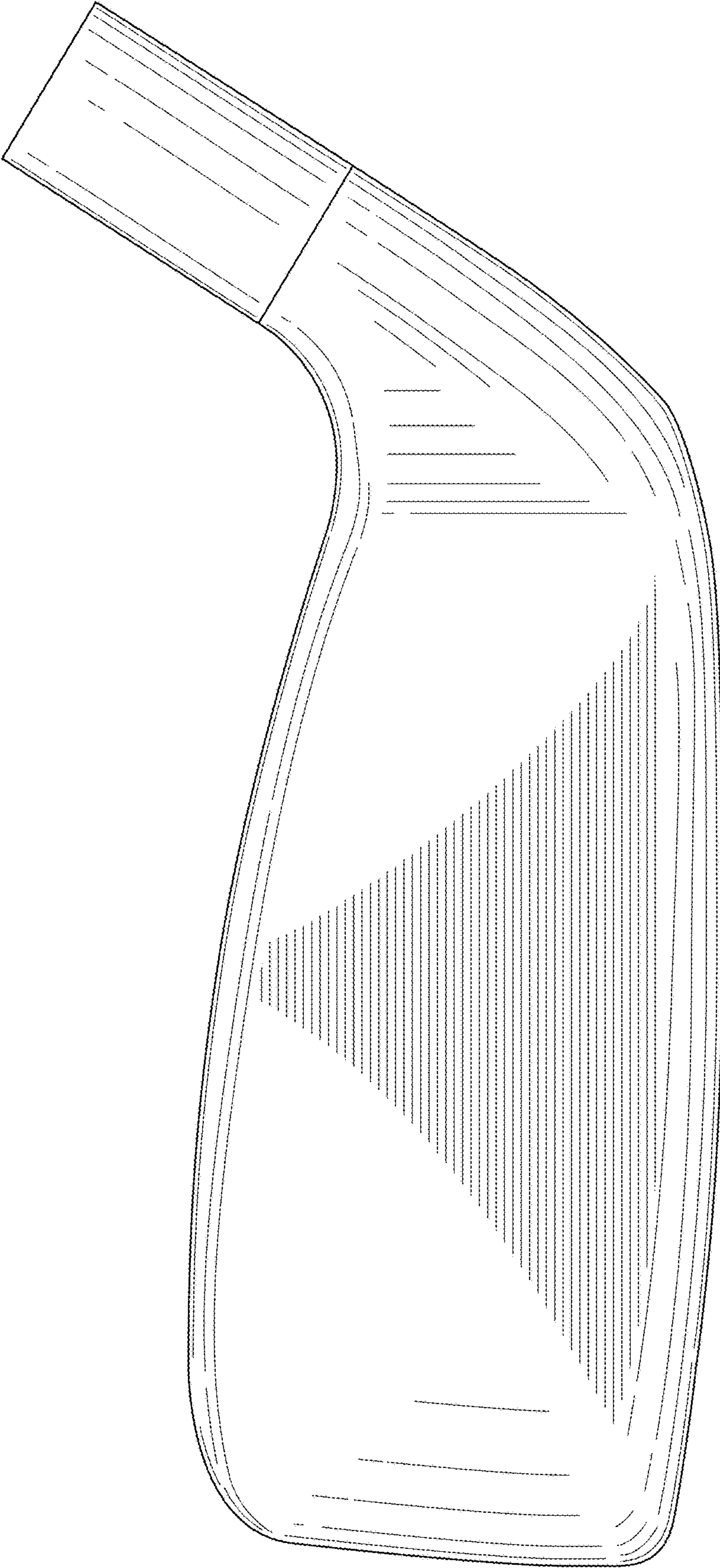

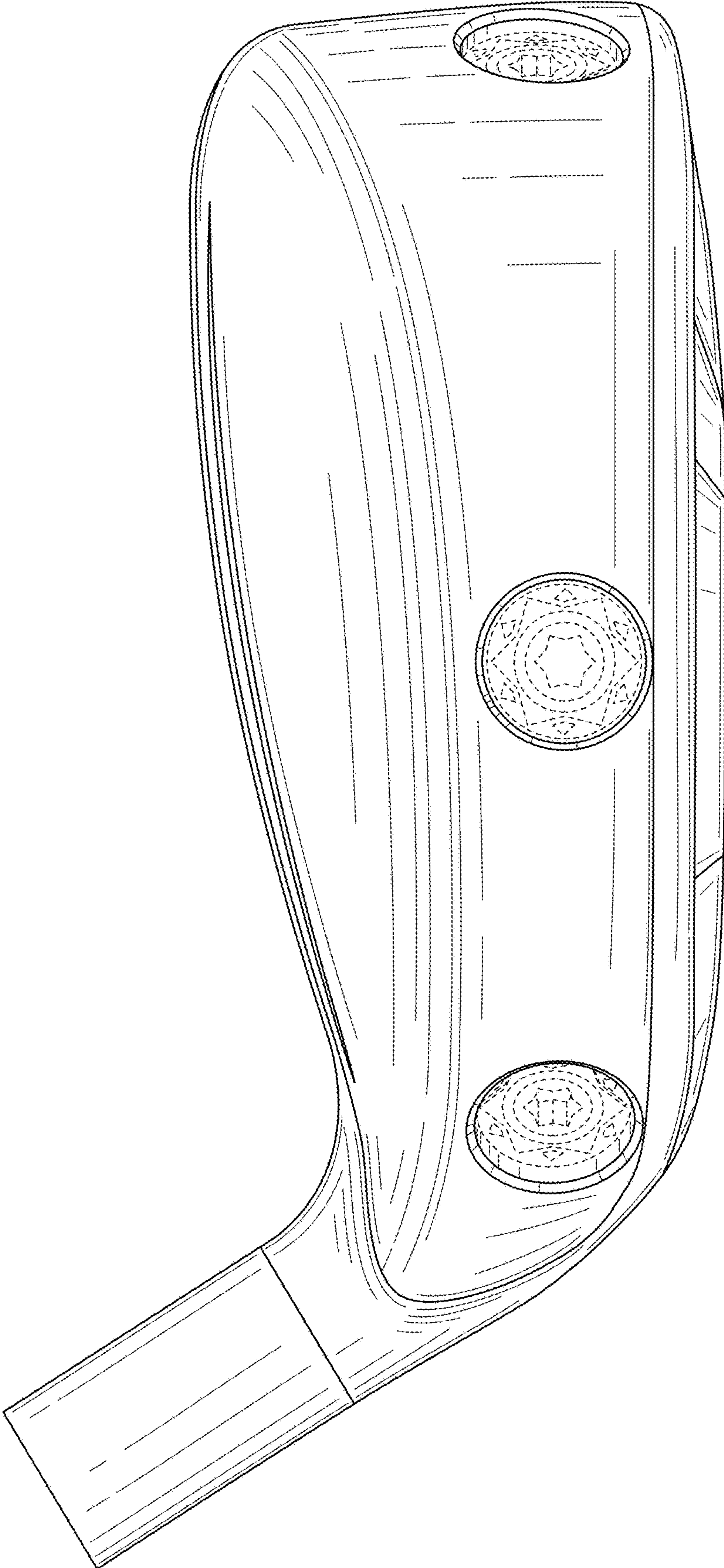

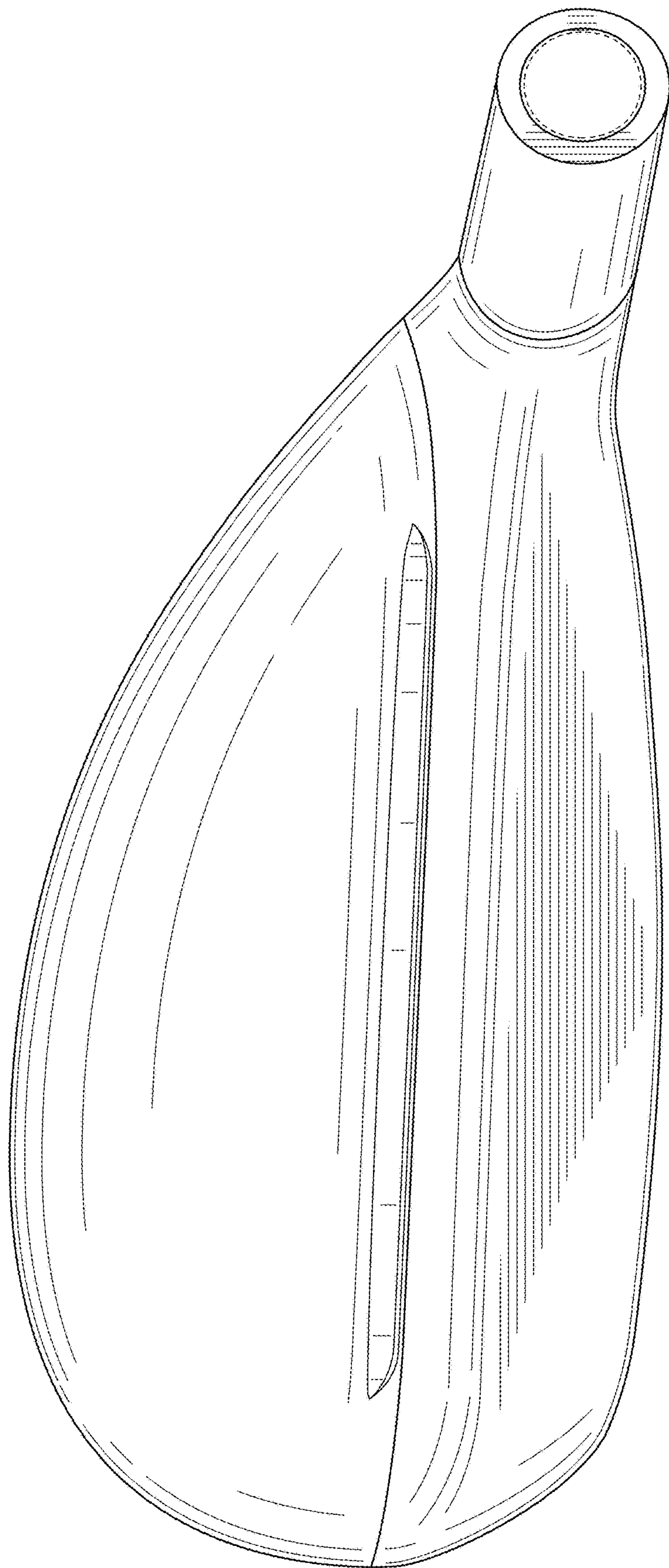

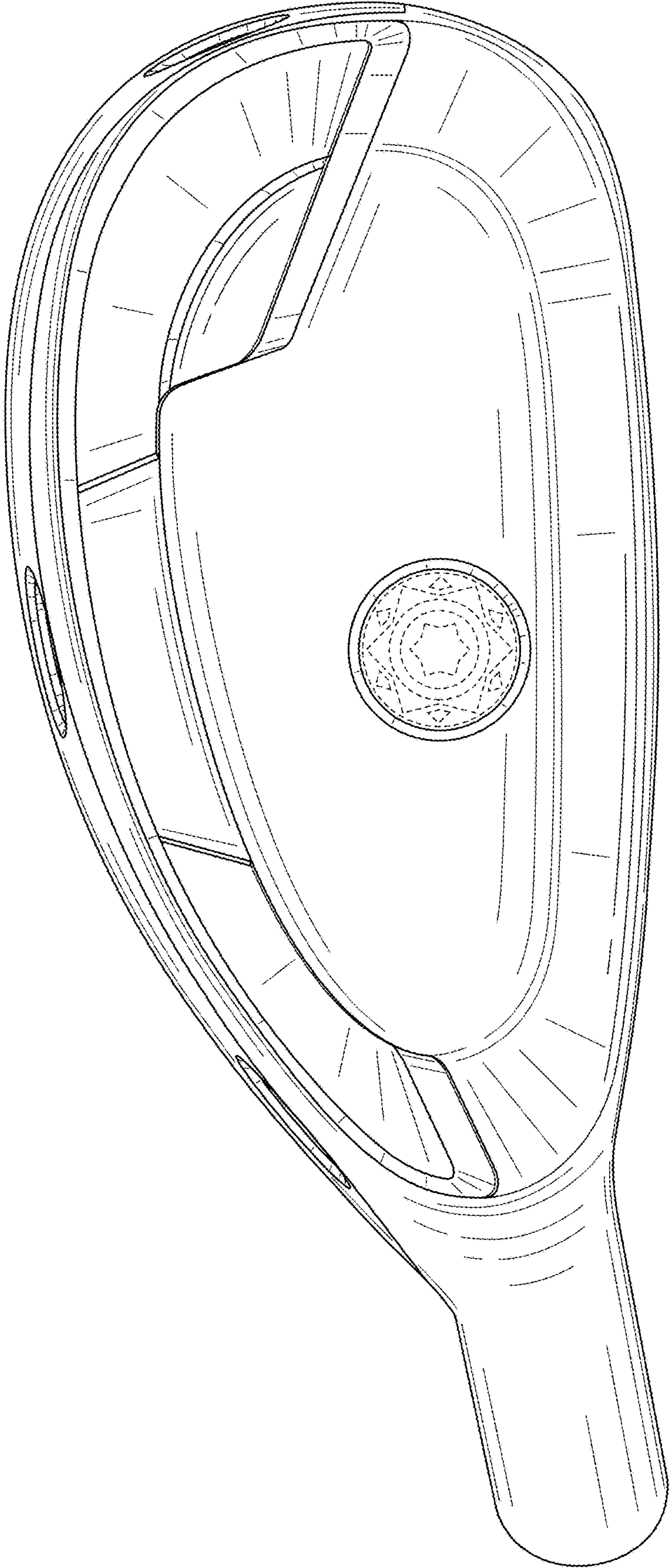

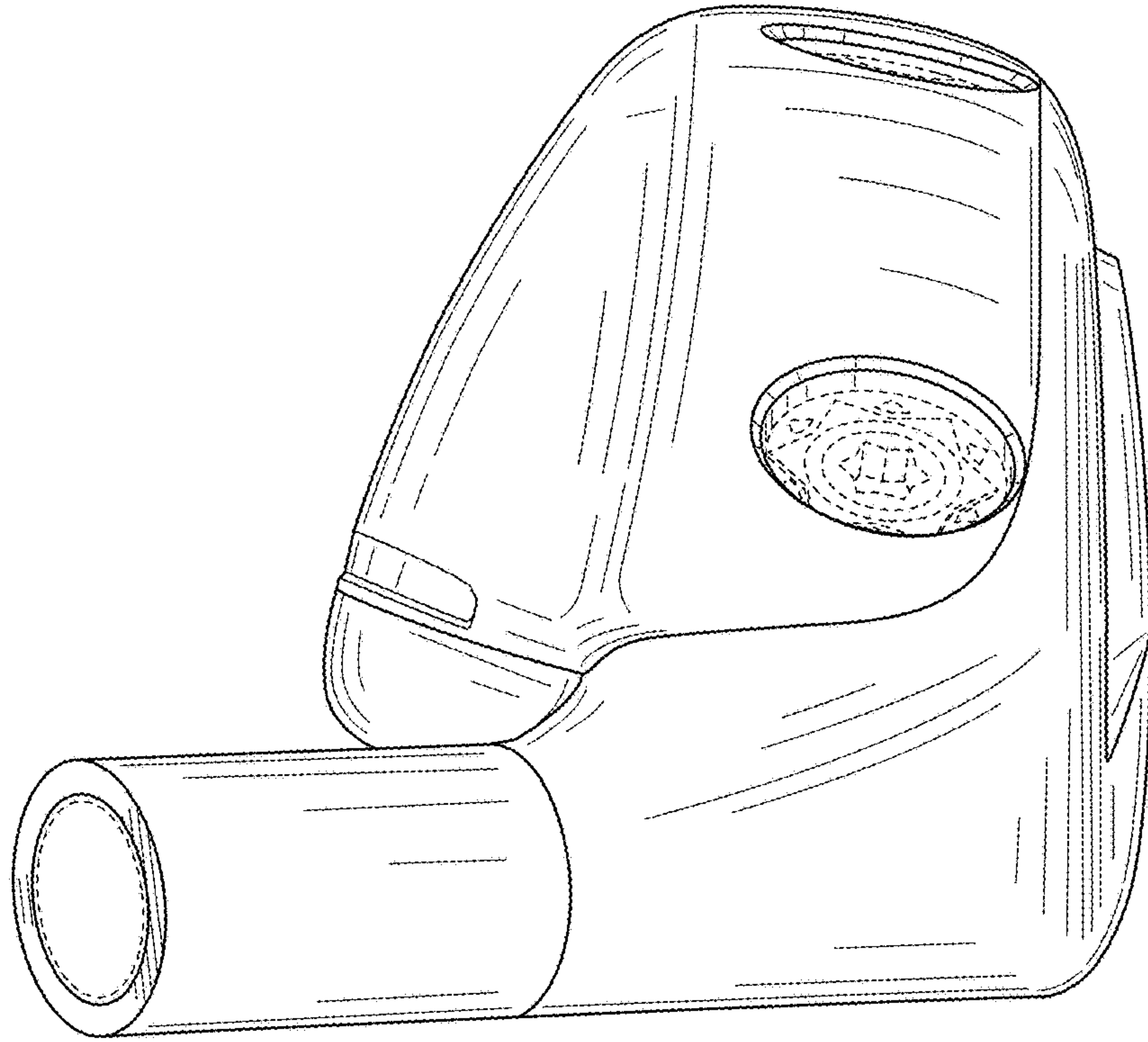

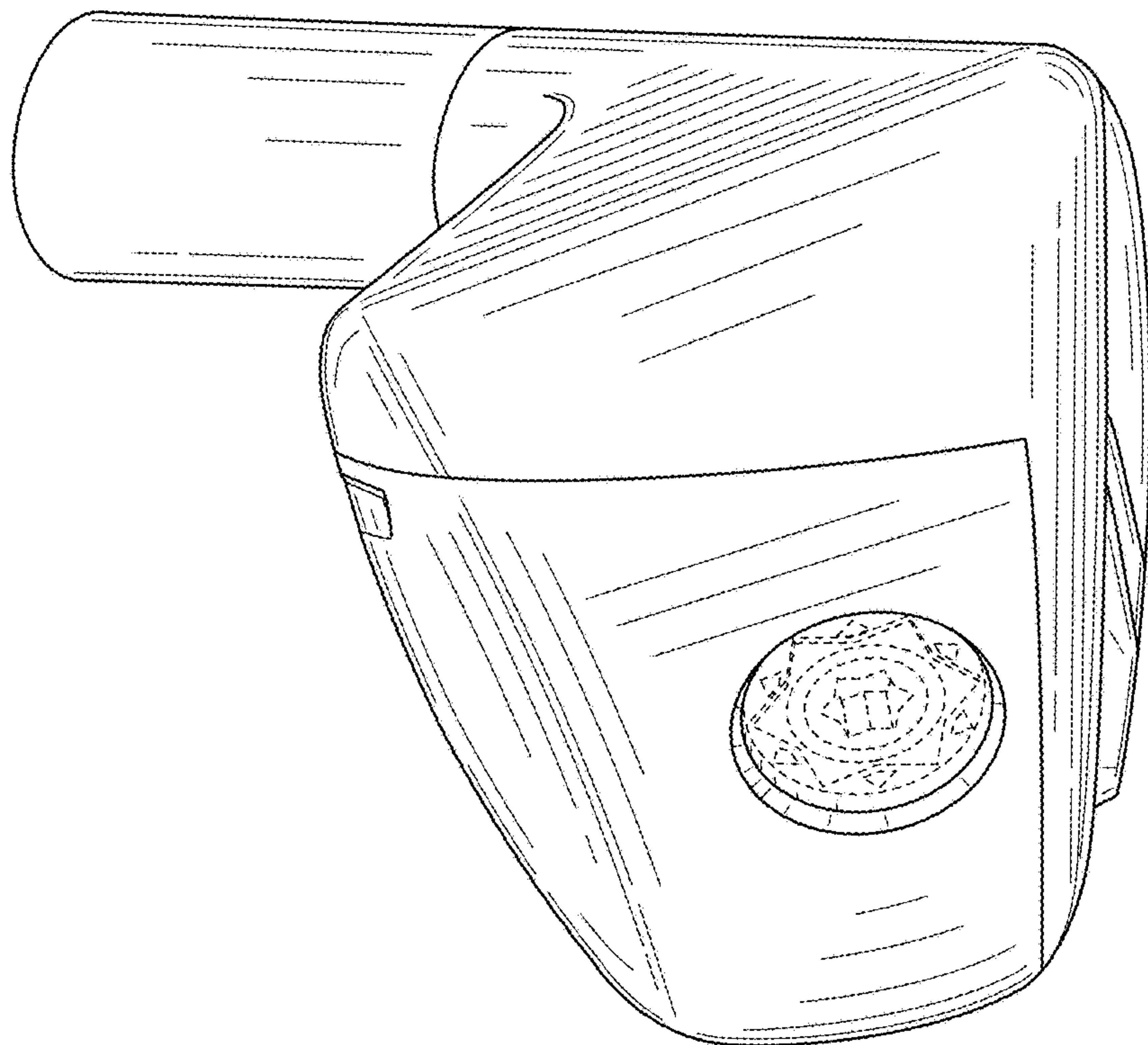

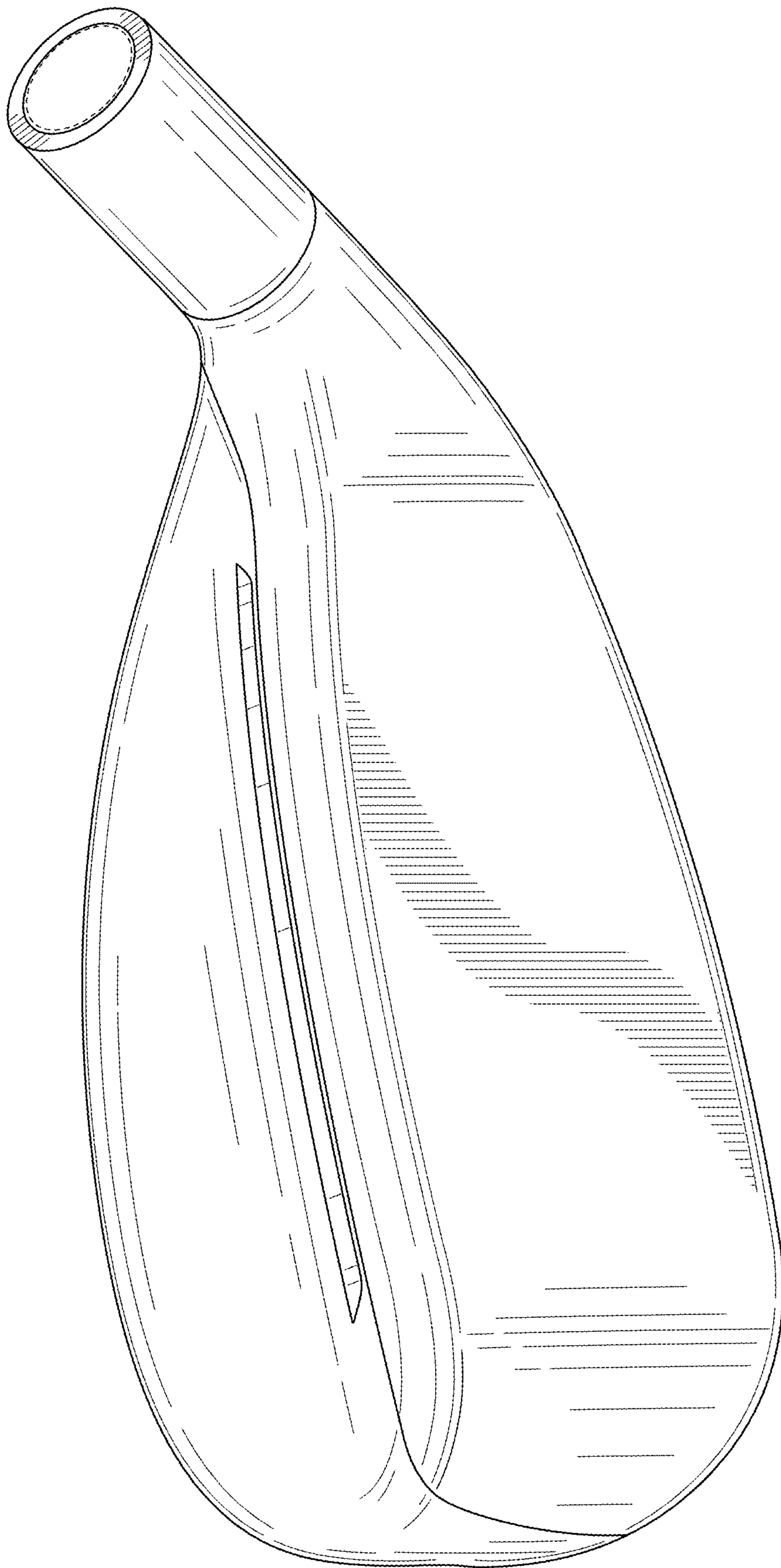

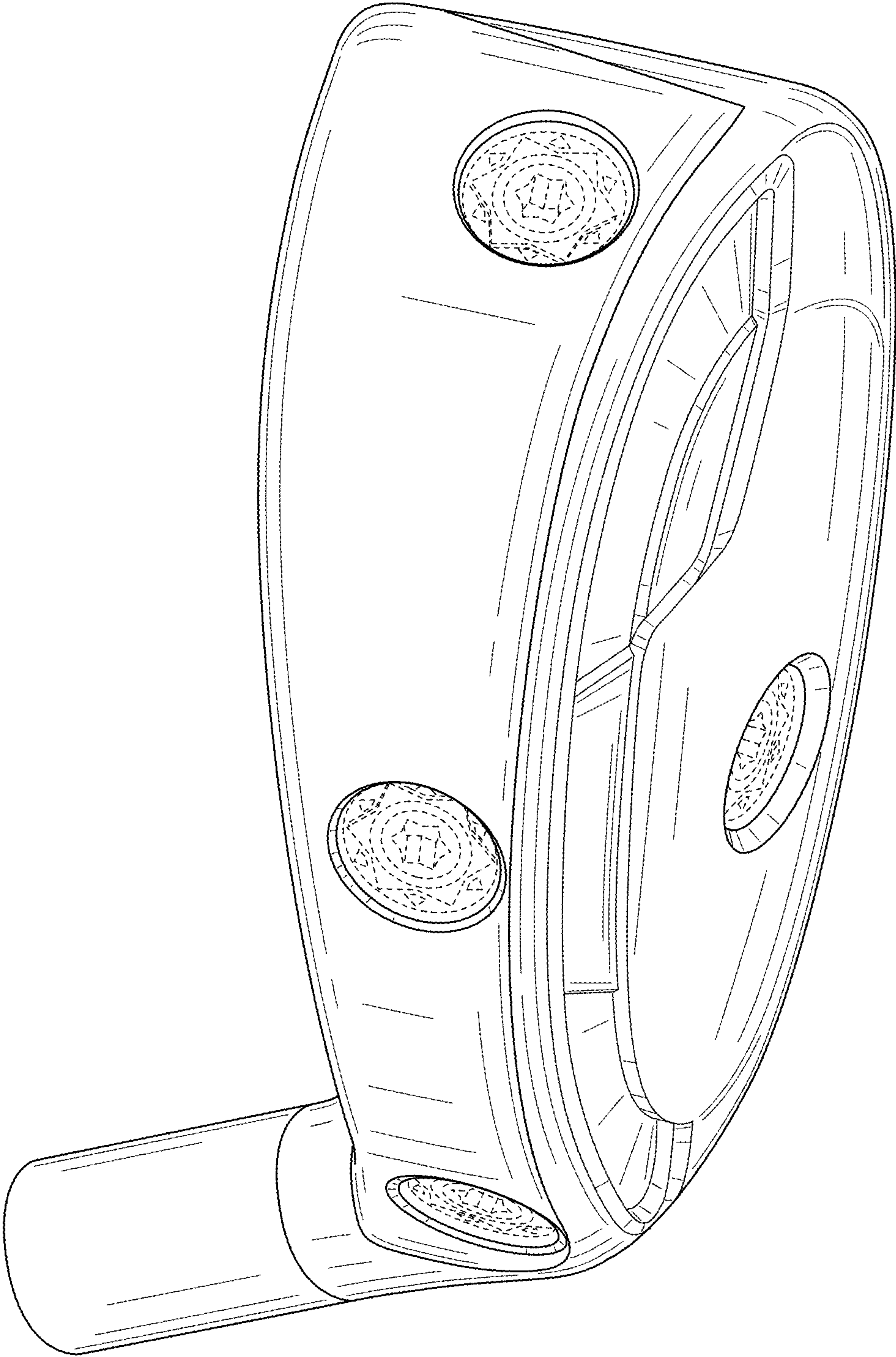
