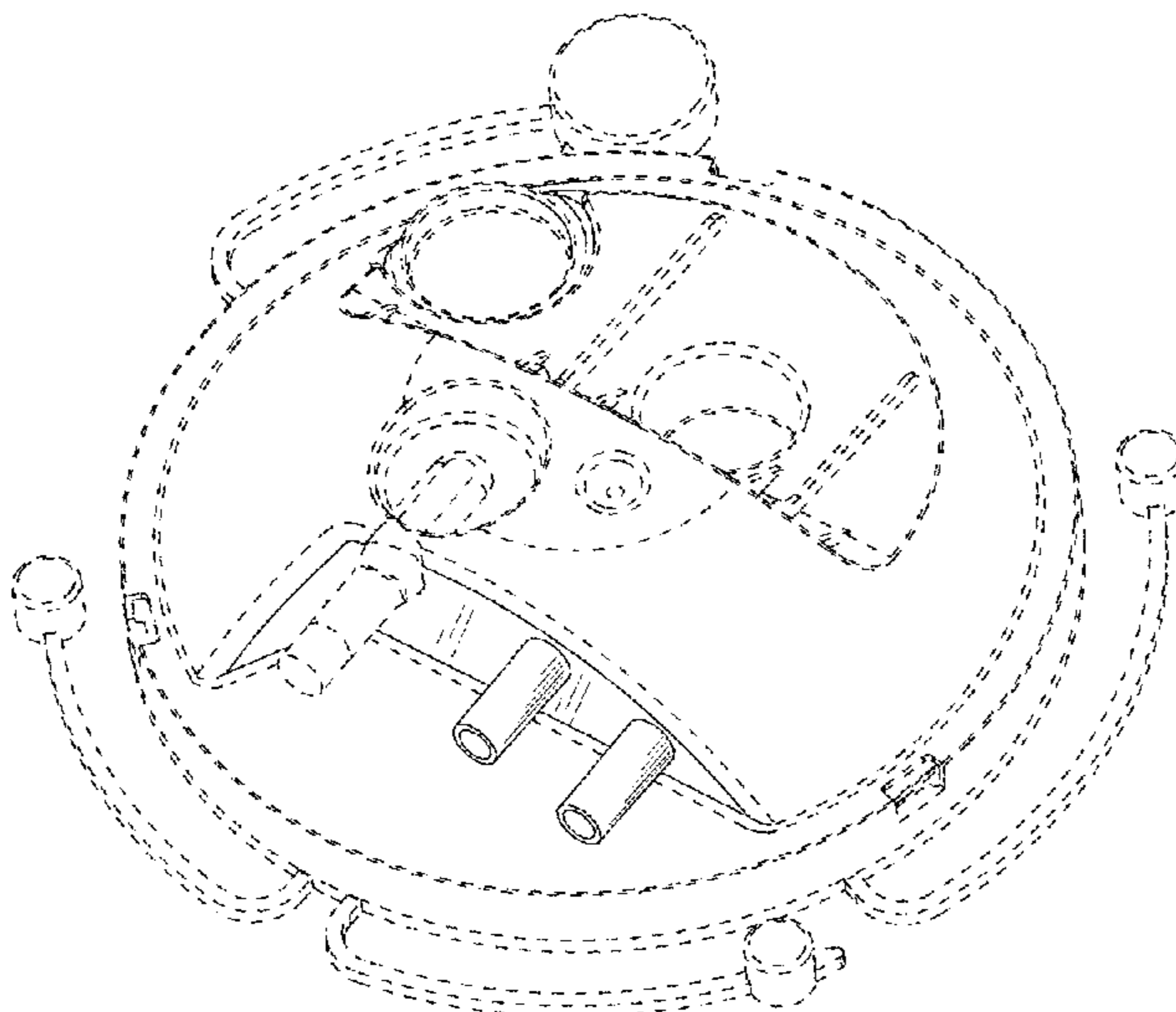
(57) **CLAIM**

The ornamental design for a fluid collection container lid, as shown and described.

DESCRIPTION

FIG. 1 is top perspective view of a fluid collection container lid, illustrating our new design;
FIG. 2 is a bottom perspective view thereof;

FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;

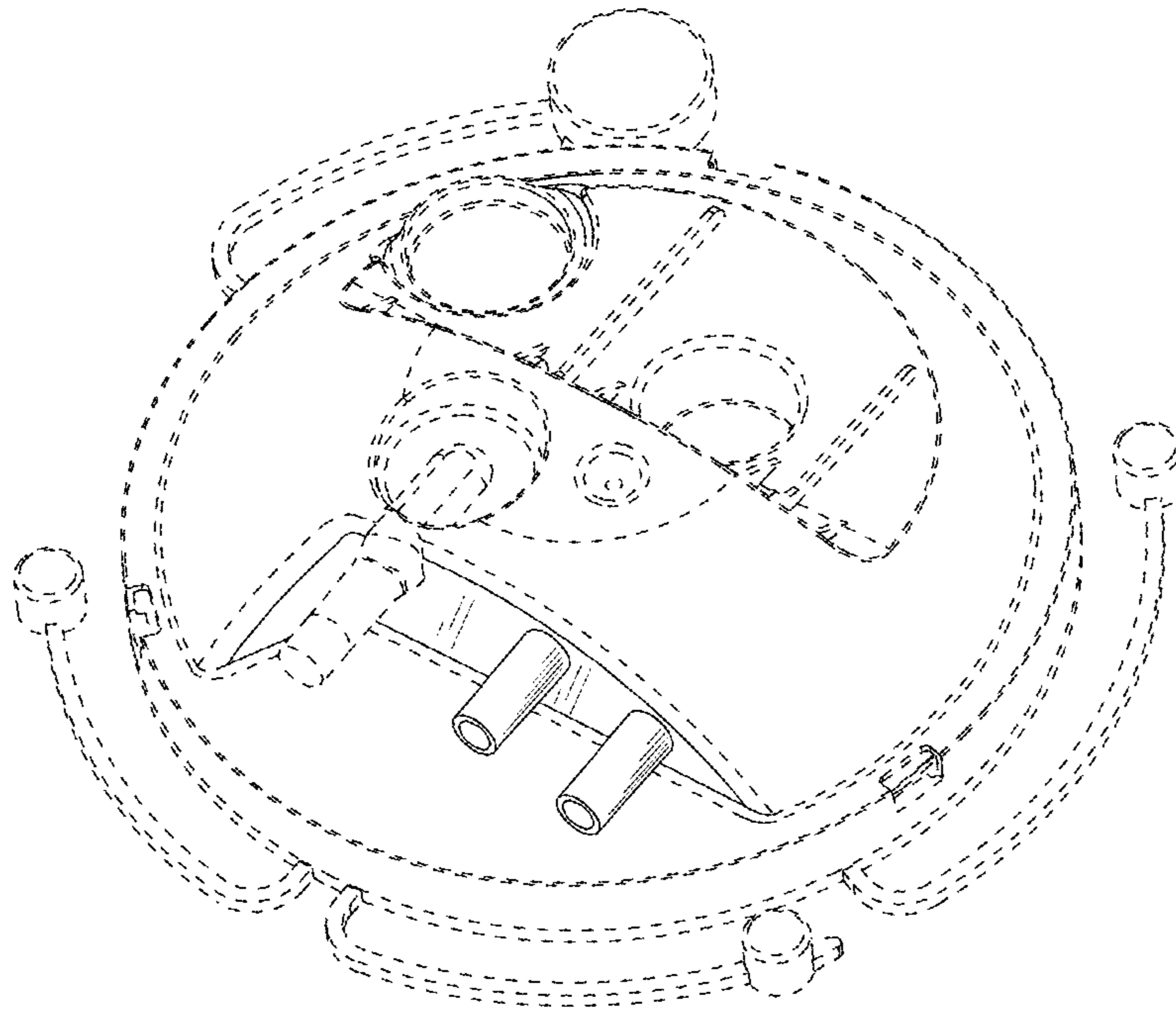

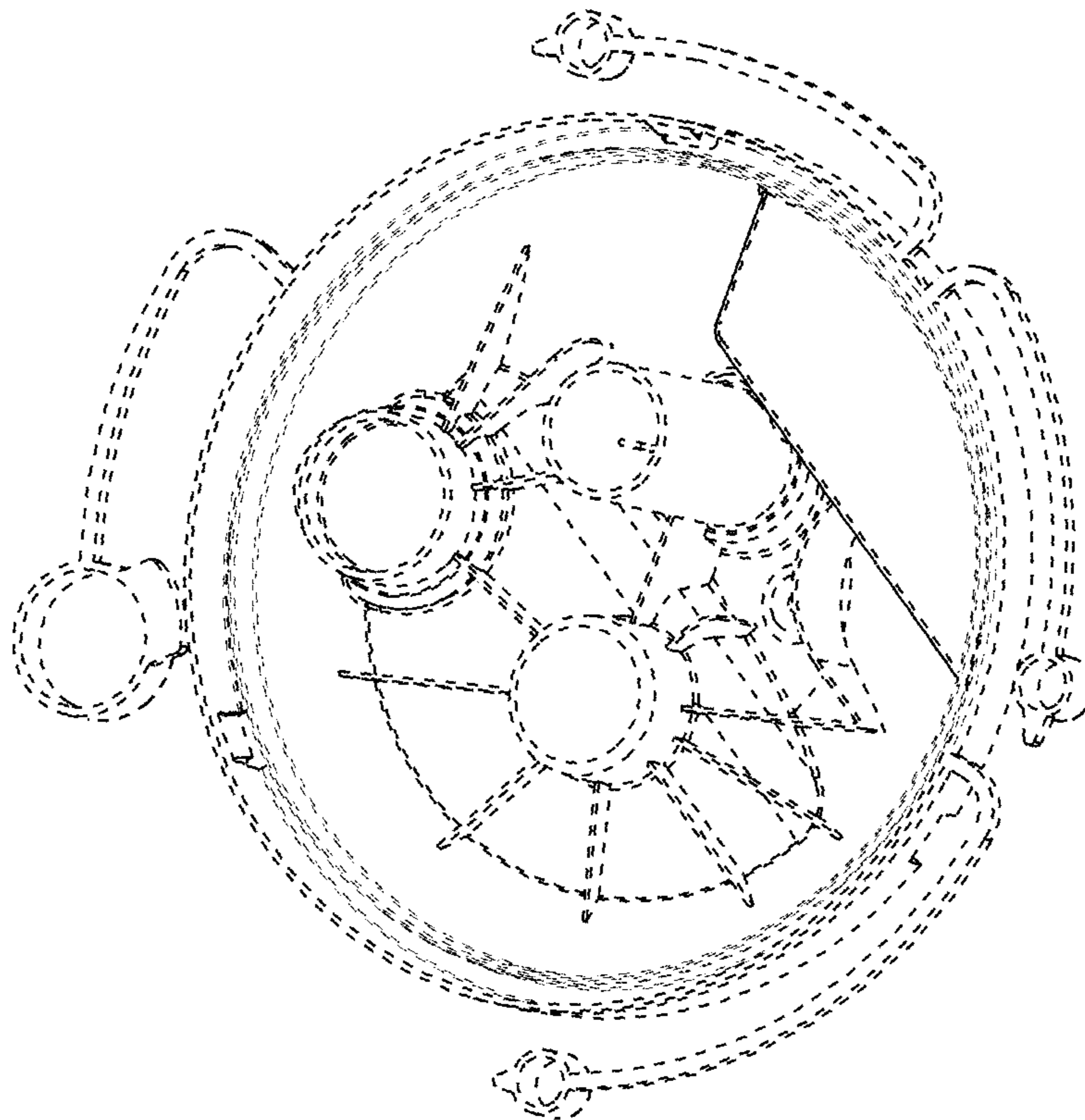

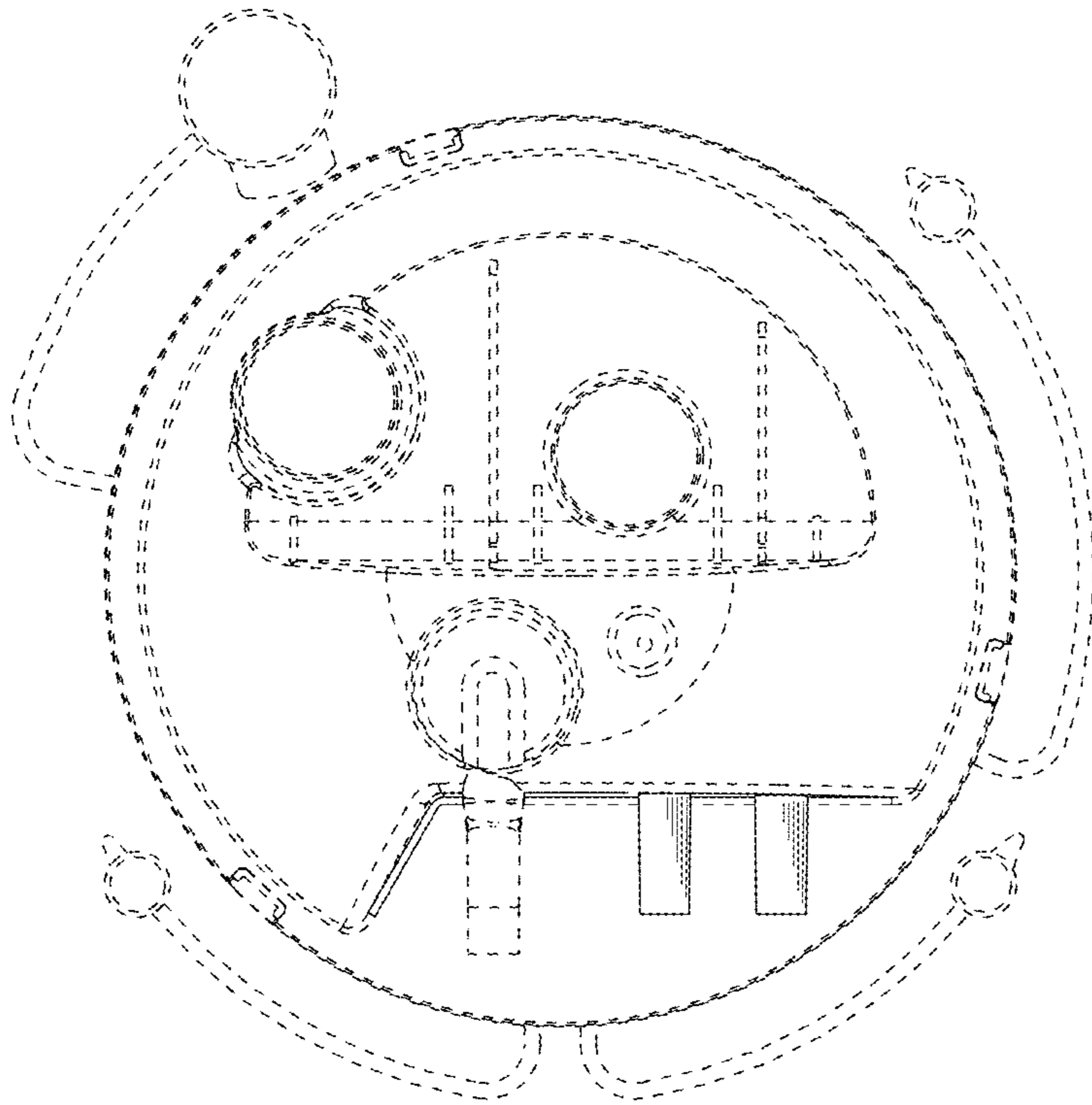

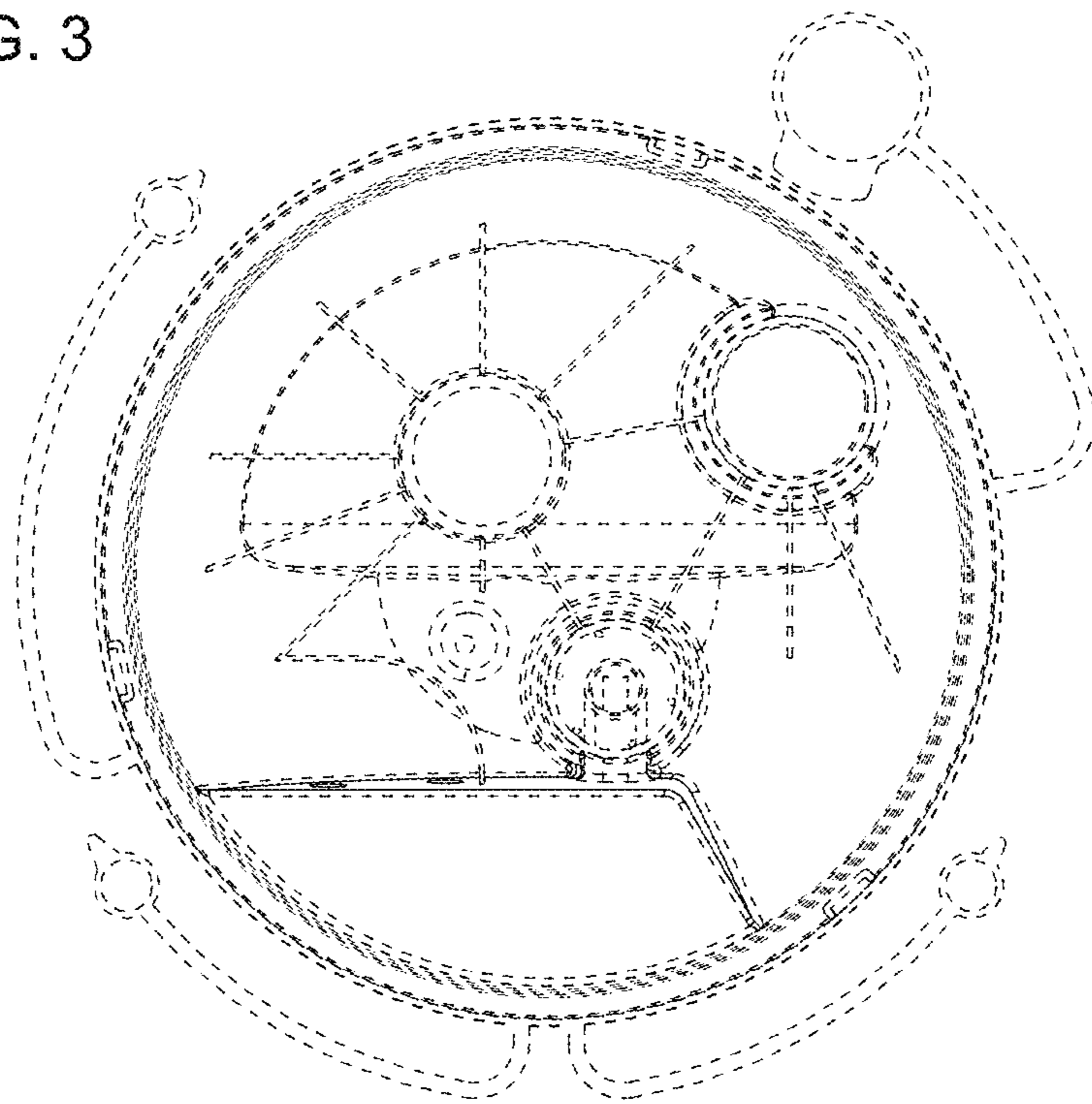

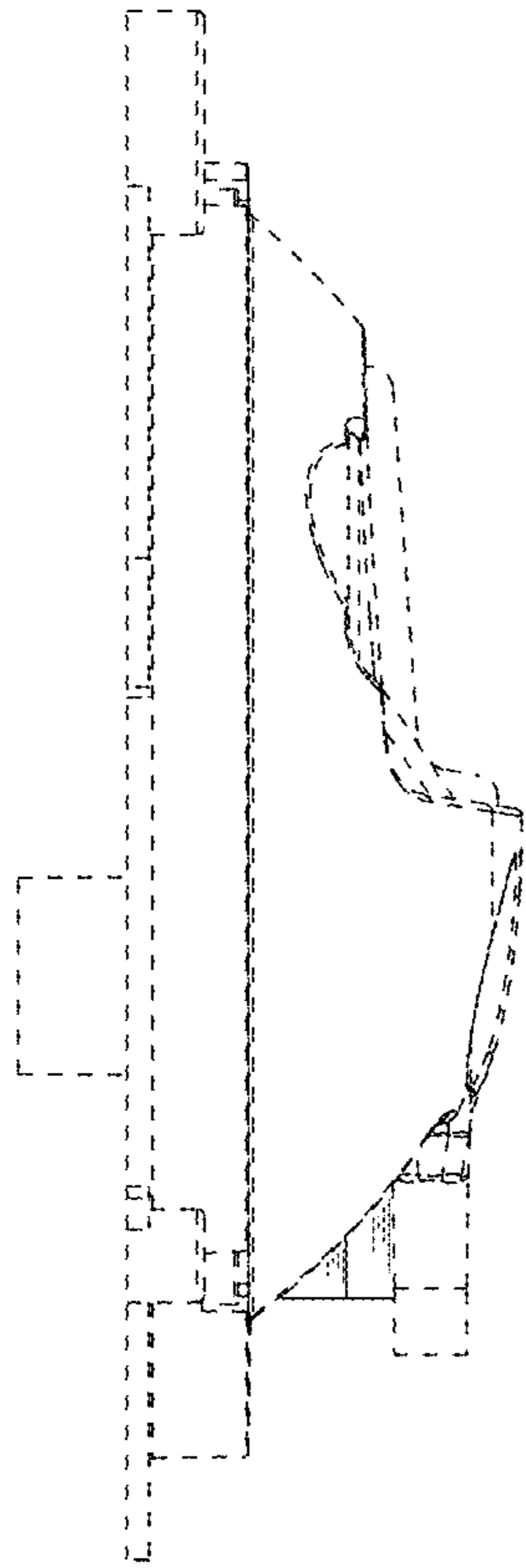

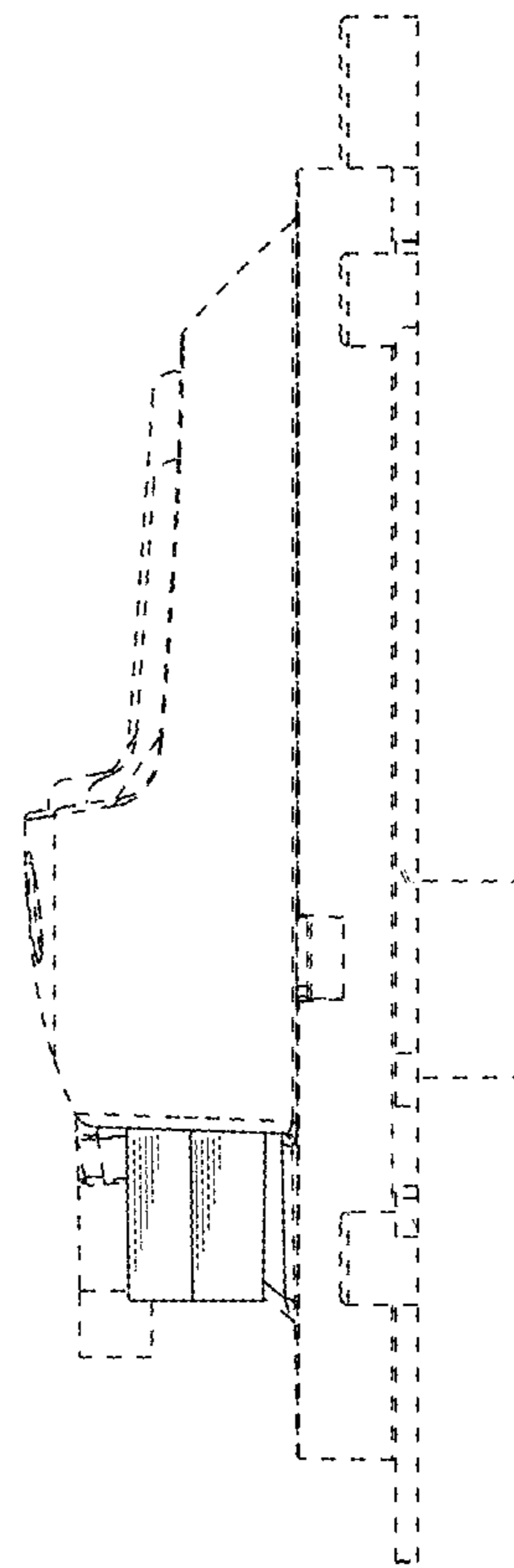

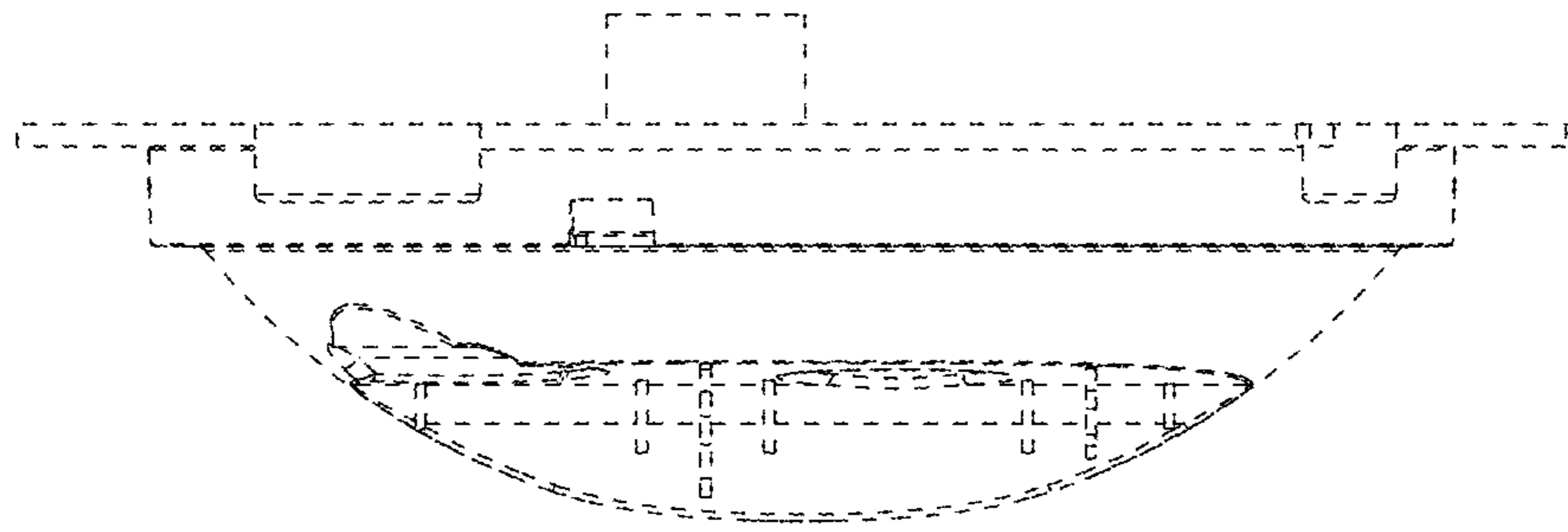

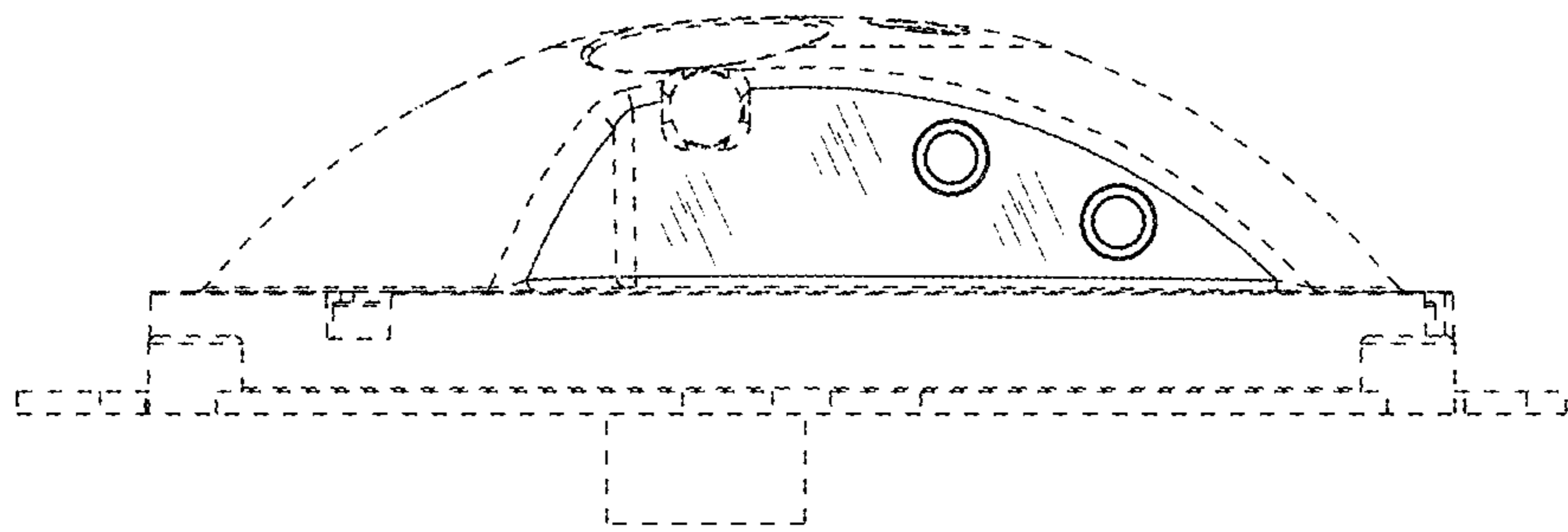
