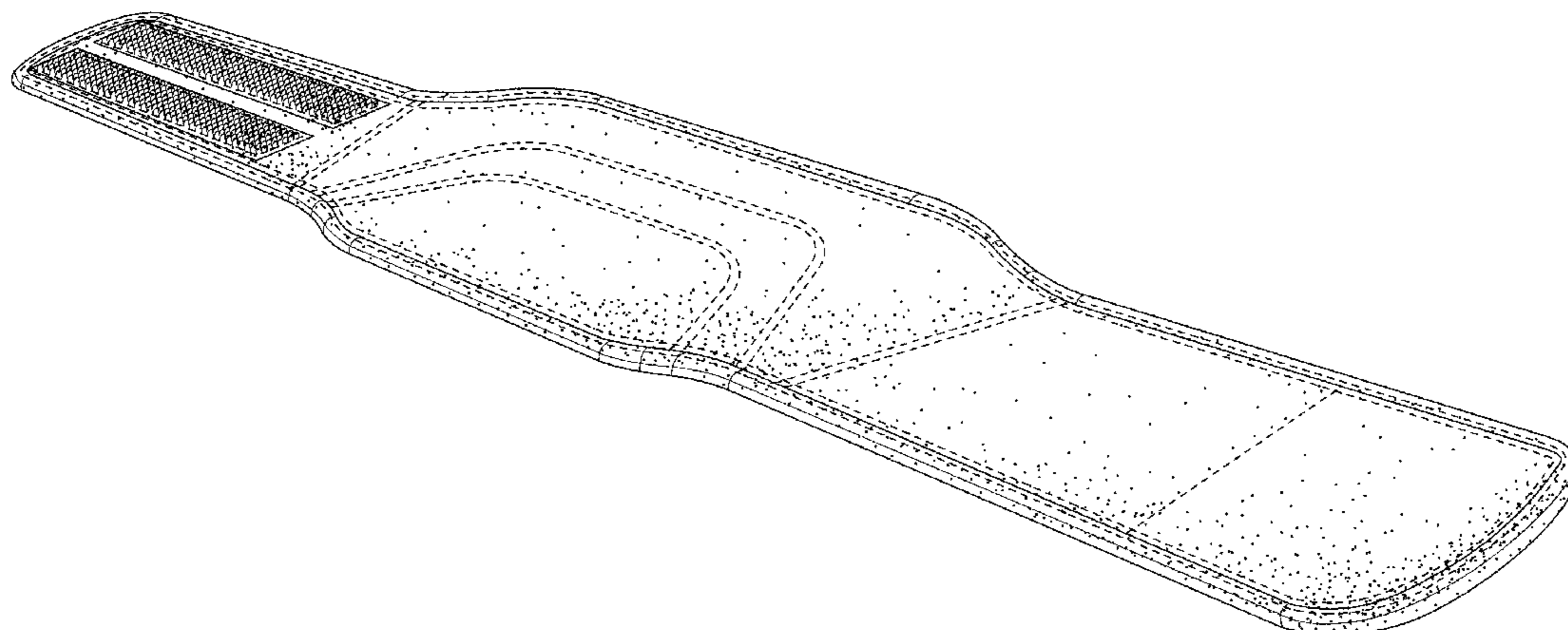
(57) **CLAIM**

The ornamental design for an athletic belt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the athletic belt of the present invention showing our new design.  
FIG. 2 is a front side elevation view thereof;  
FIG. 3 is back side elevation view thereof;  
FIG. 4 is a side elevation view thereof;  
FIG. 5 is another side elevation view thereof  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a perspective view of FIG. 1 shown in use.  
In the drawings, the evenly-spaced broken lines depict stitching and form part of the claim.

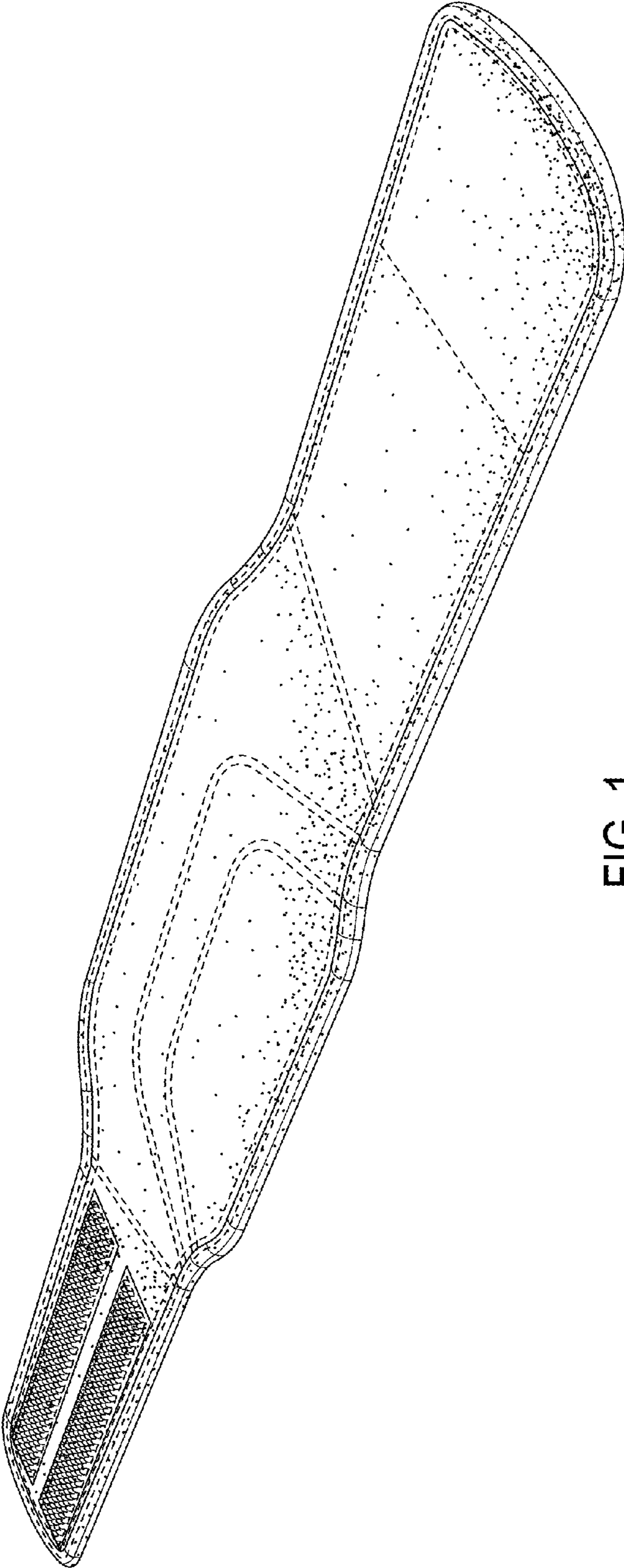

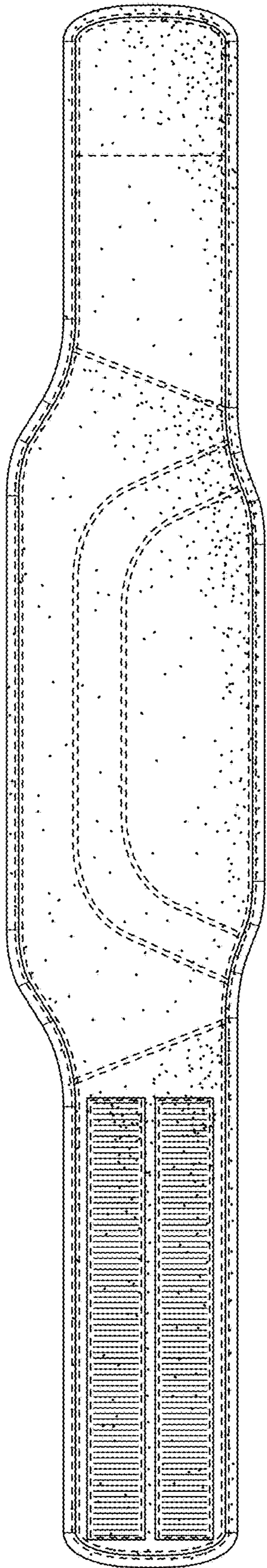

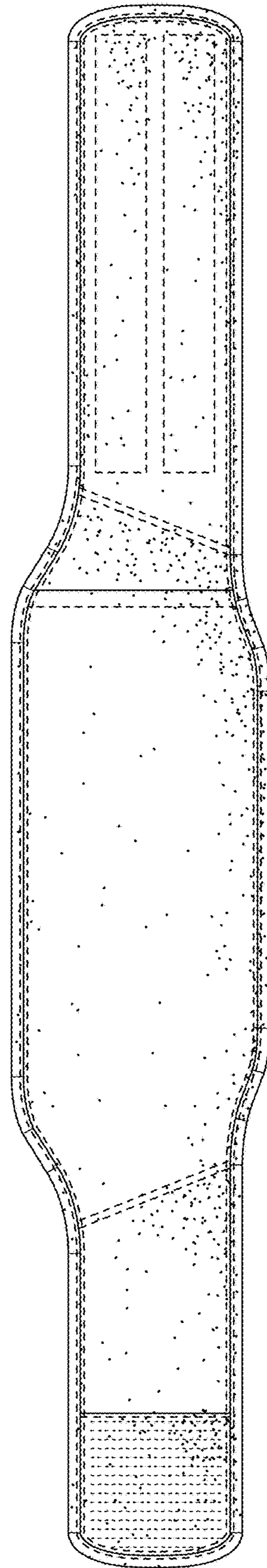

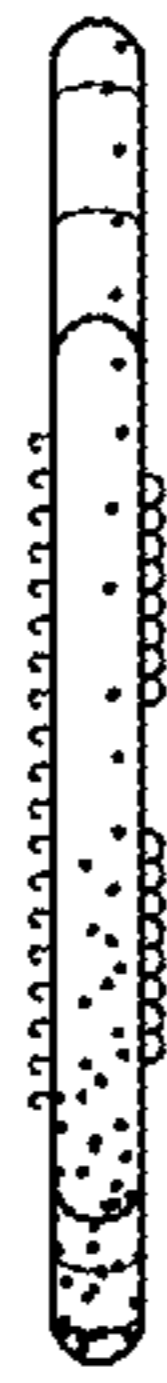

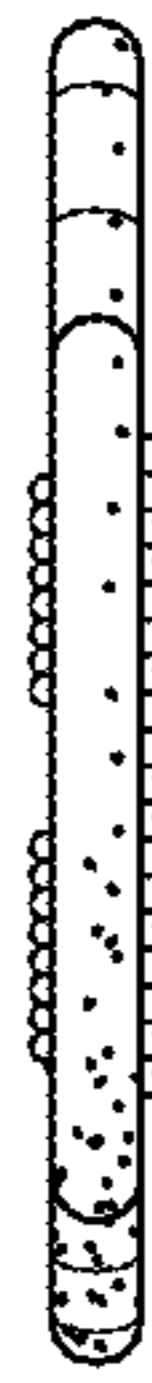

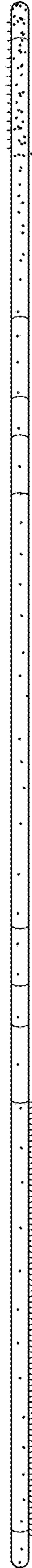

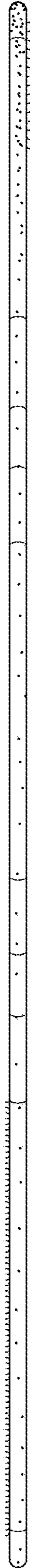

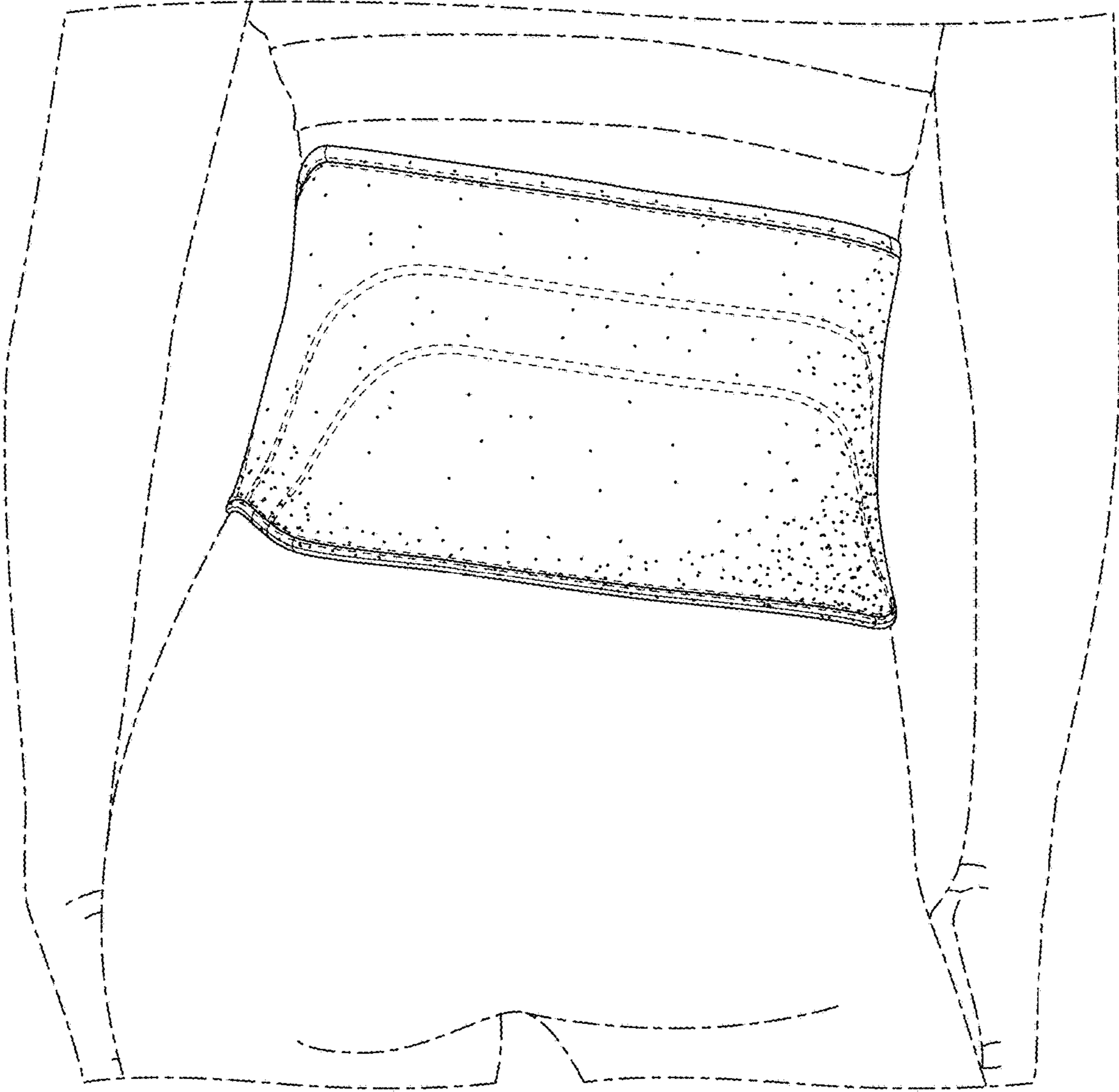
