We claim the ornamental design for a razor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the razor of the present invention.

FIG. 2 is a front elevation of the razor of FIG. 1.

FIG. 3 is a rear elevation of the razor of FIG. 1.

FIG. 4 is a left side elevation of the razor of FIG. 1.

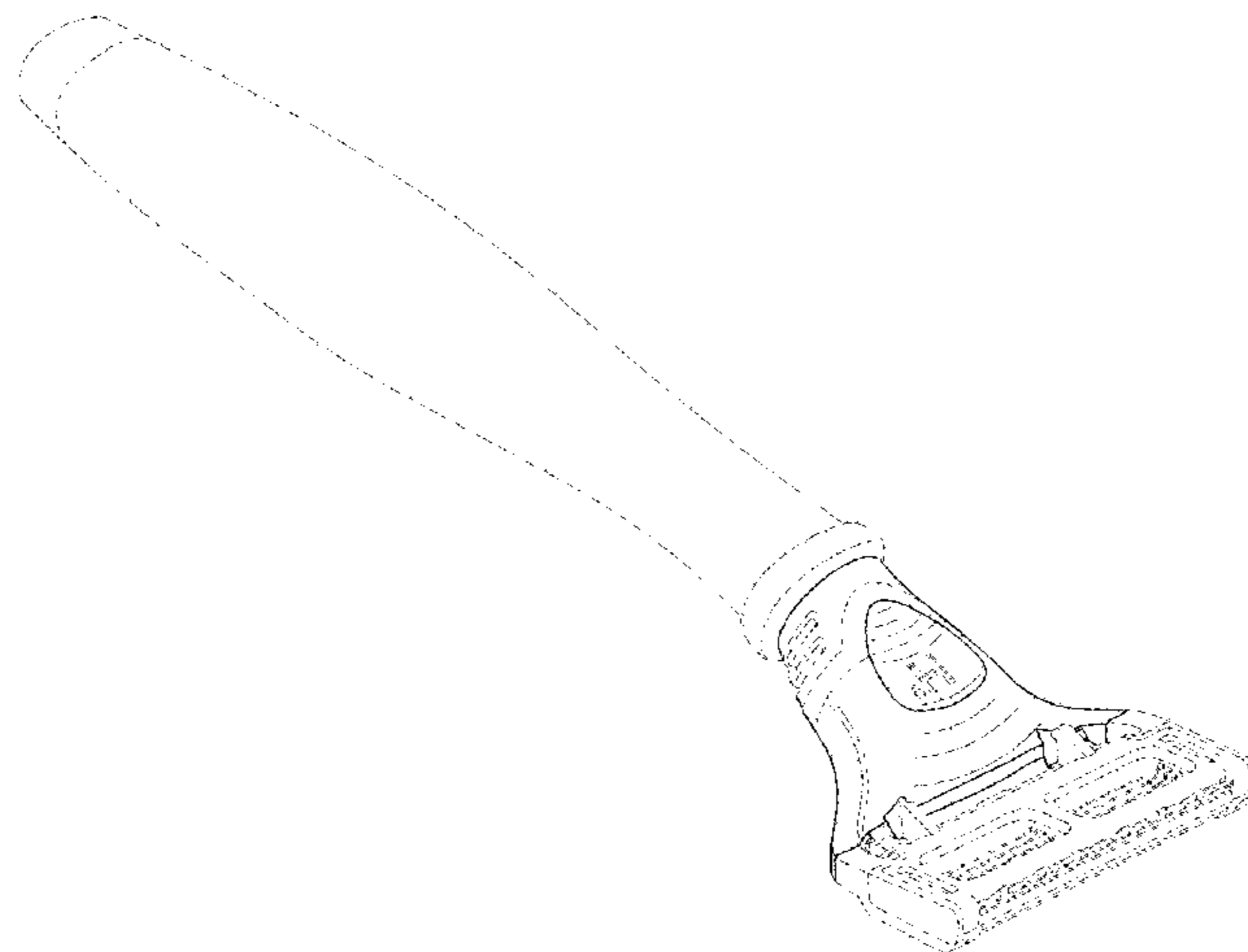
FIG. 5 is a right side elevation of the razor of FIG. 1.

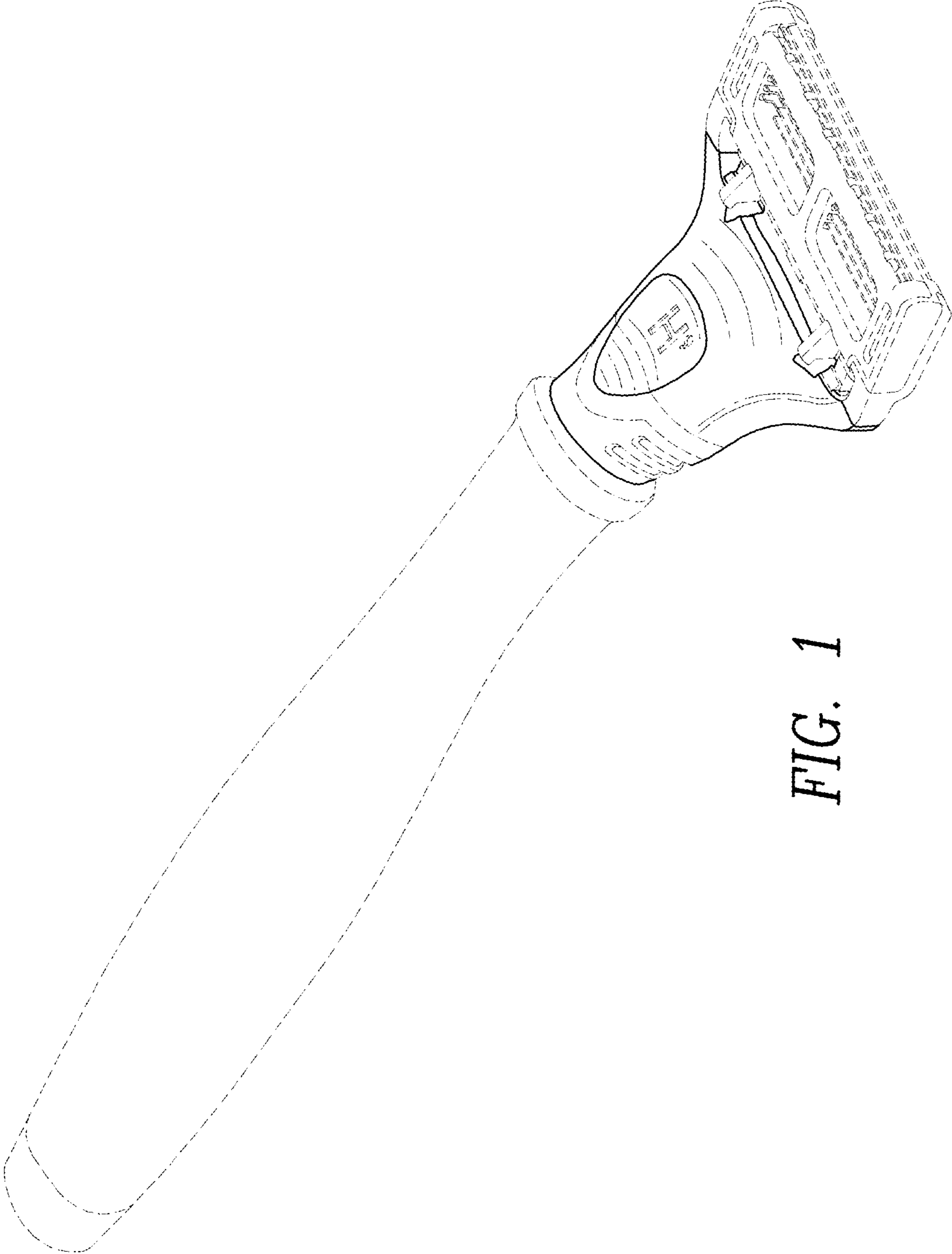

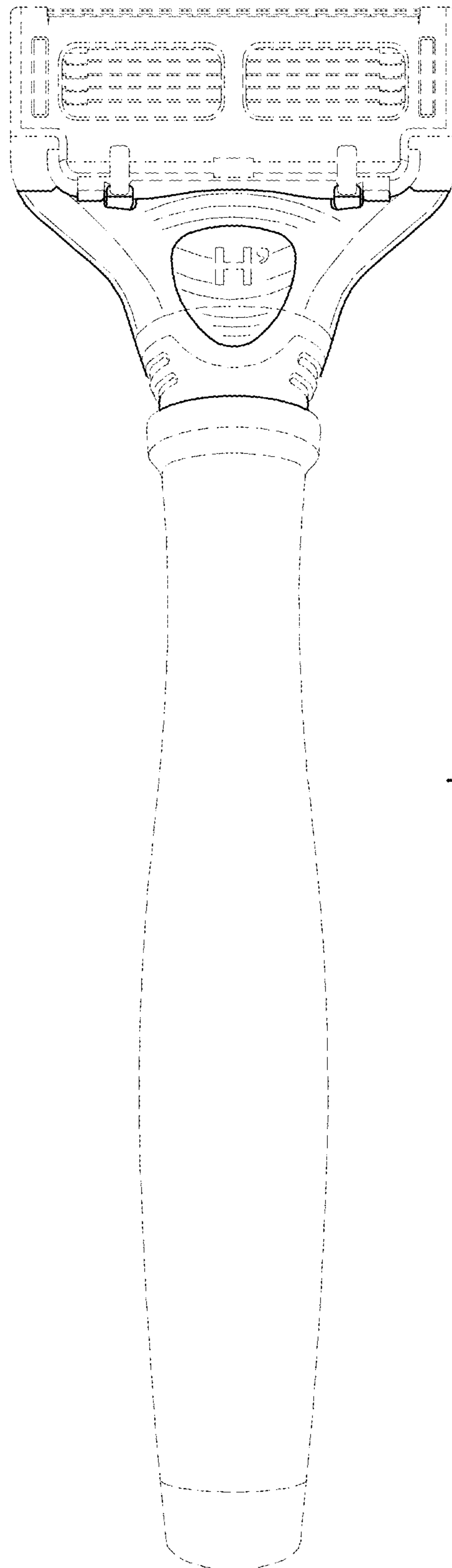

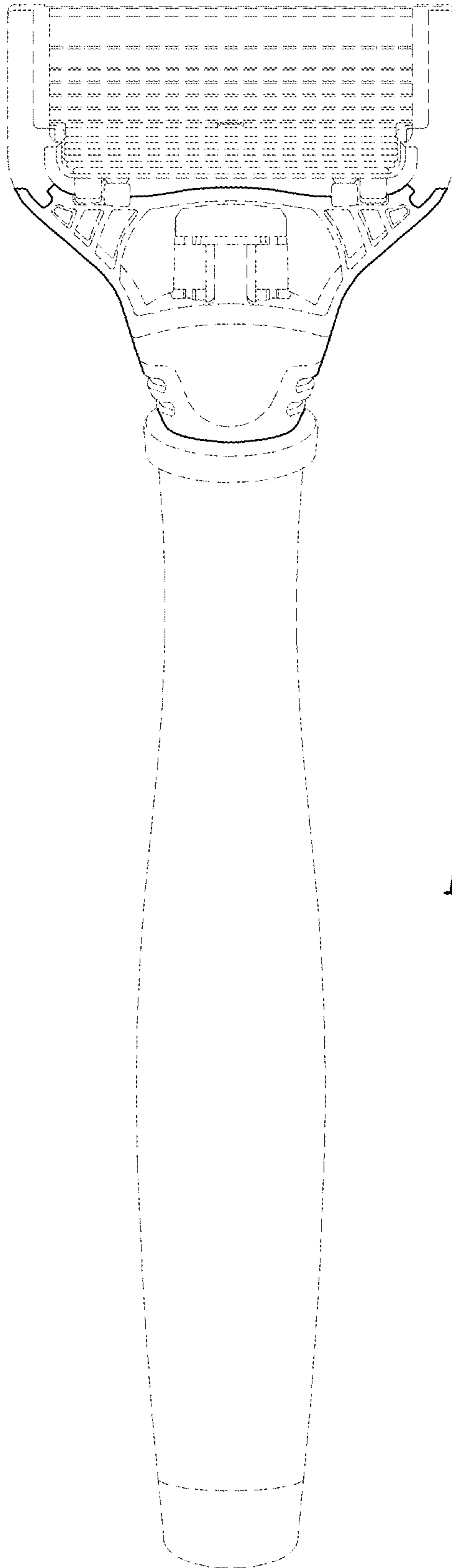

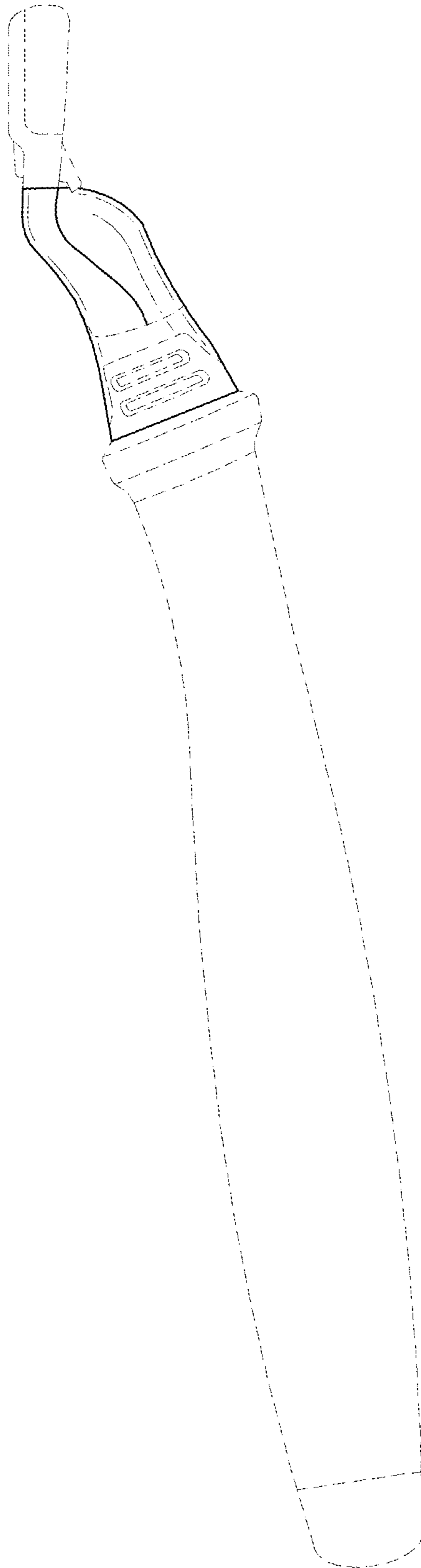

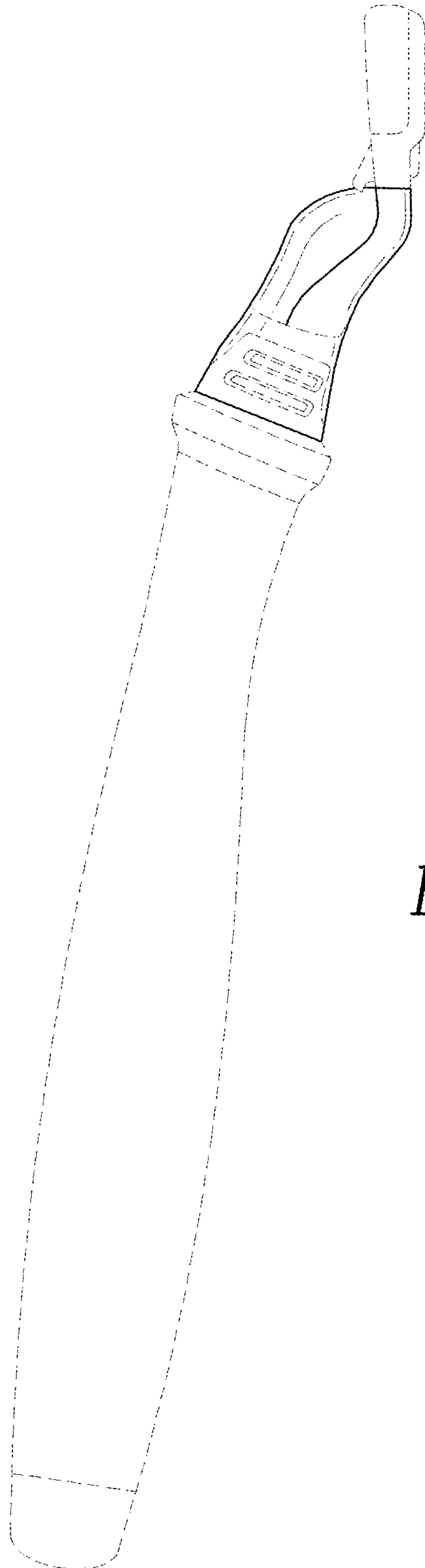

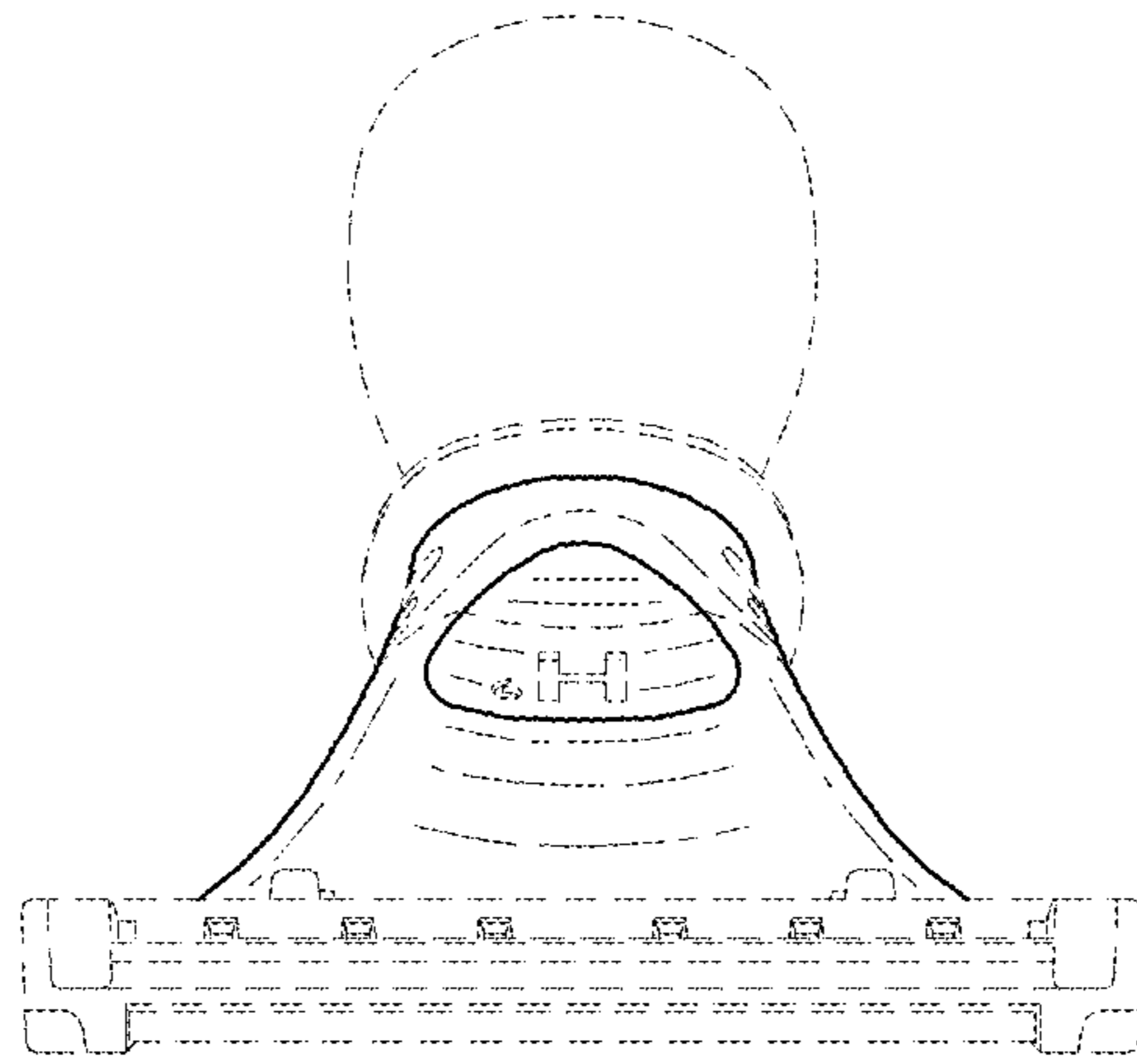

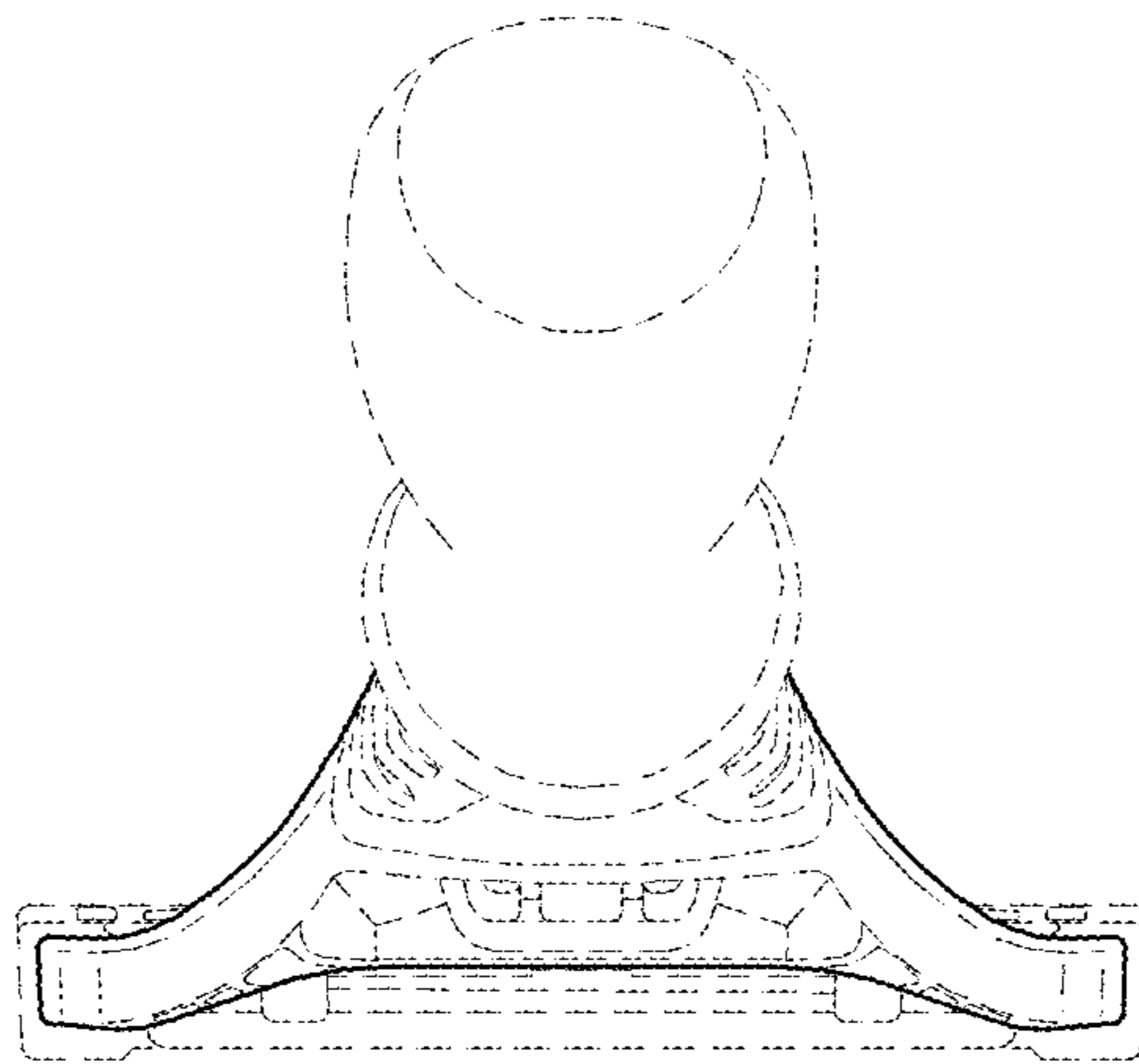
