(57) **CLAIM**

The ornamental design for a mobile ballistic shield, as shown and described herein.

FIG. 1 is a top, front, right side perspective view of a mobile ballistic shield according to an embodiment of the present invention.

FIG. 2 is a front elevation view of the mobile ballistic shield shown in FIG. 1.

FIG. 3 is a rear elevation view of the mobile ballistic shield shown in FIG. 1.

FIG. 13 is a right side elevation view of the mobile ballistic shield shown in FIG. 9.

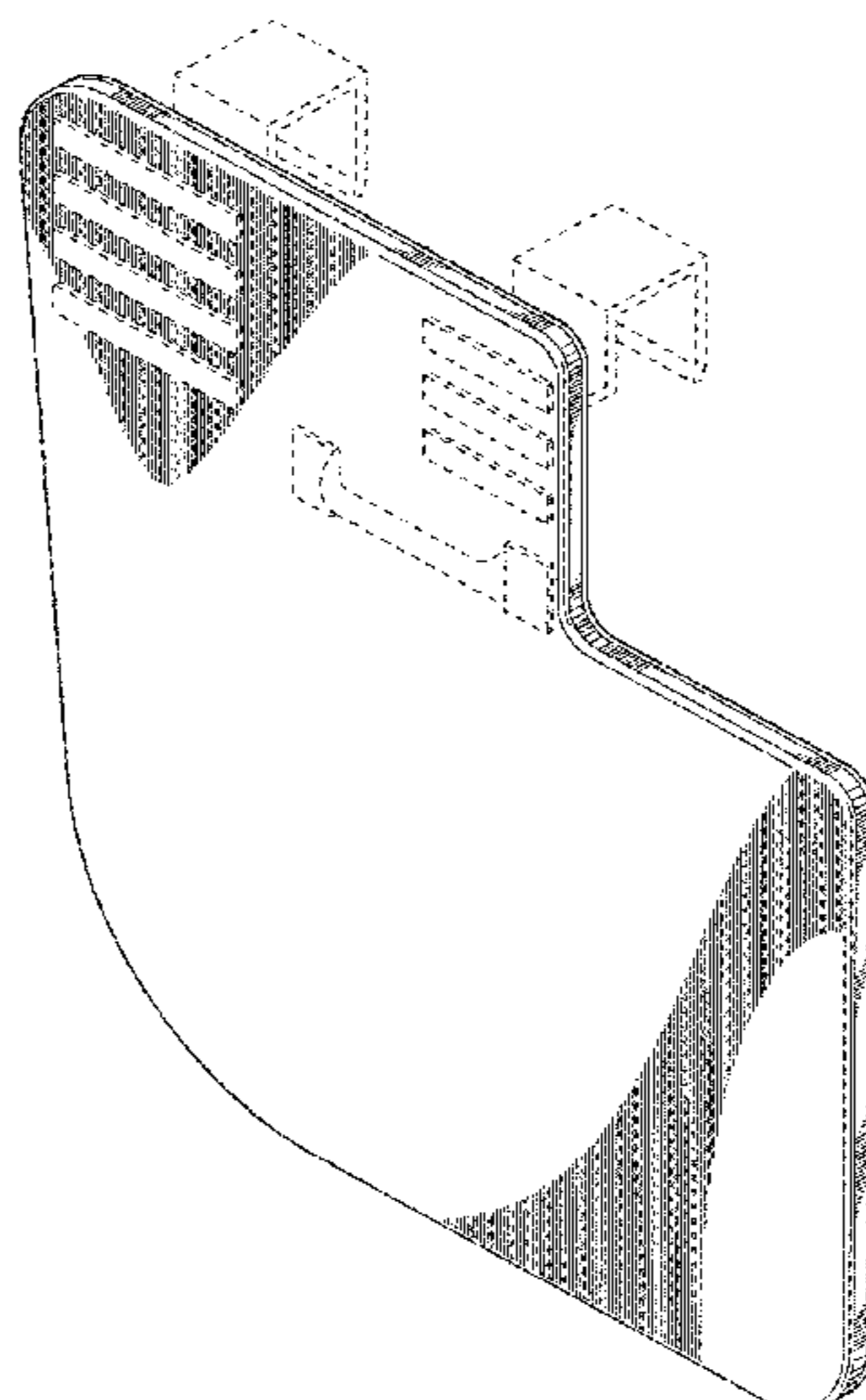
FIG. 14 is a top plan view of the mobile ballistic shield shown in FIG. 9.

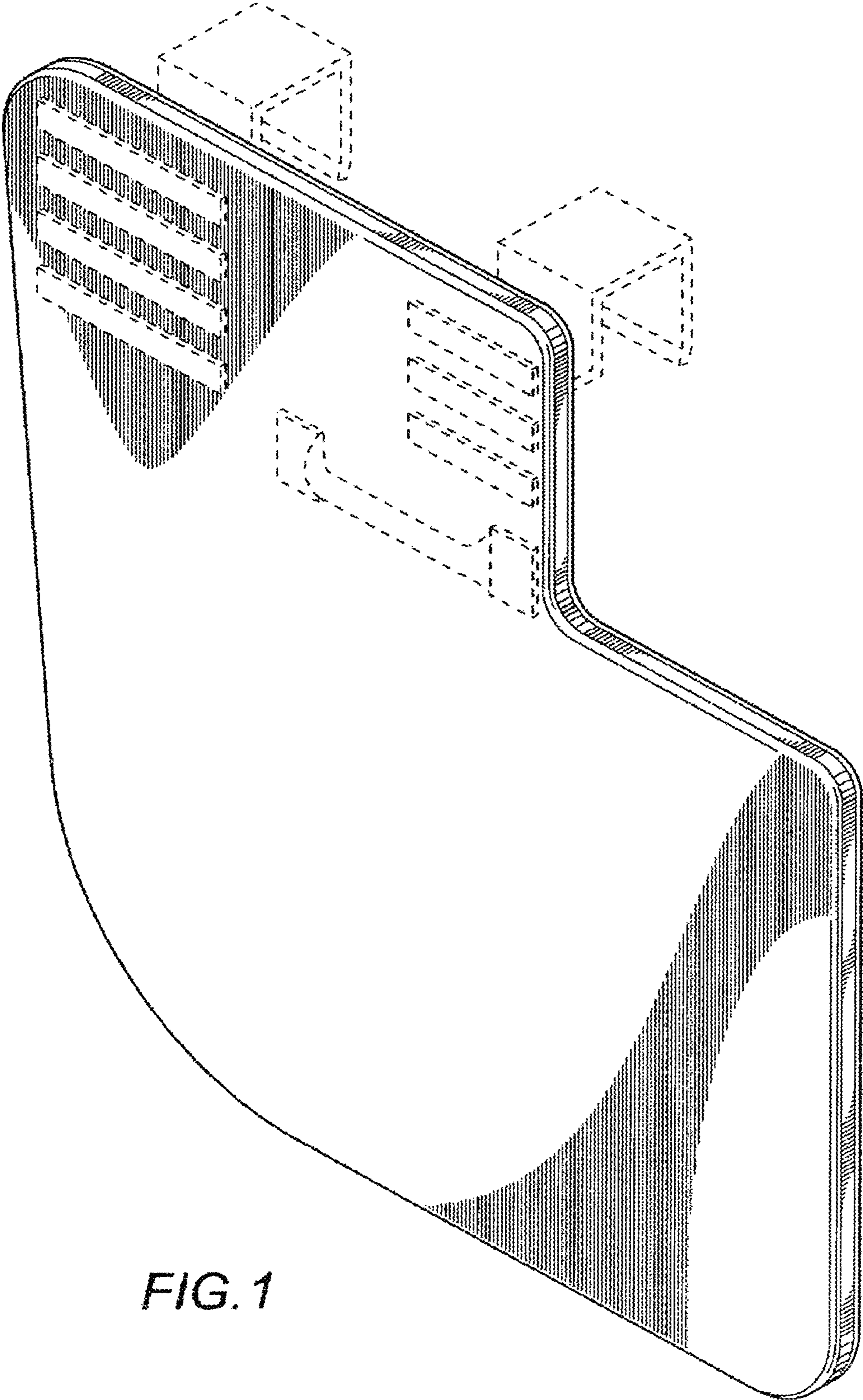

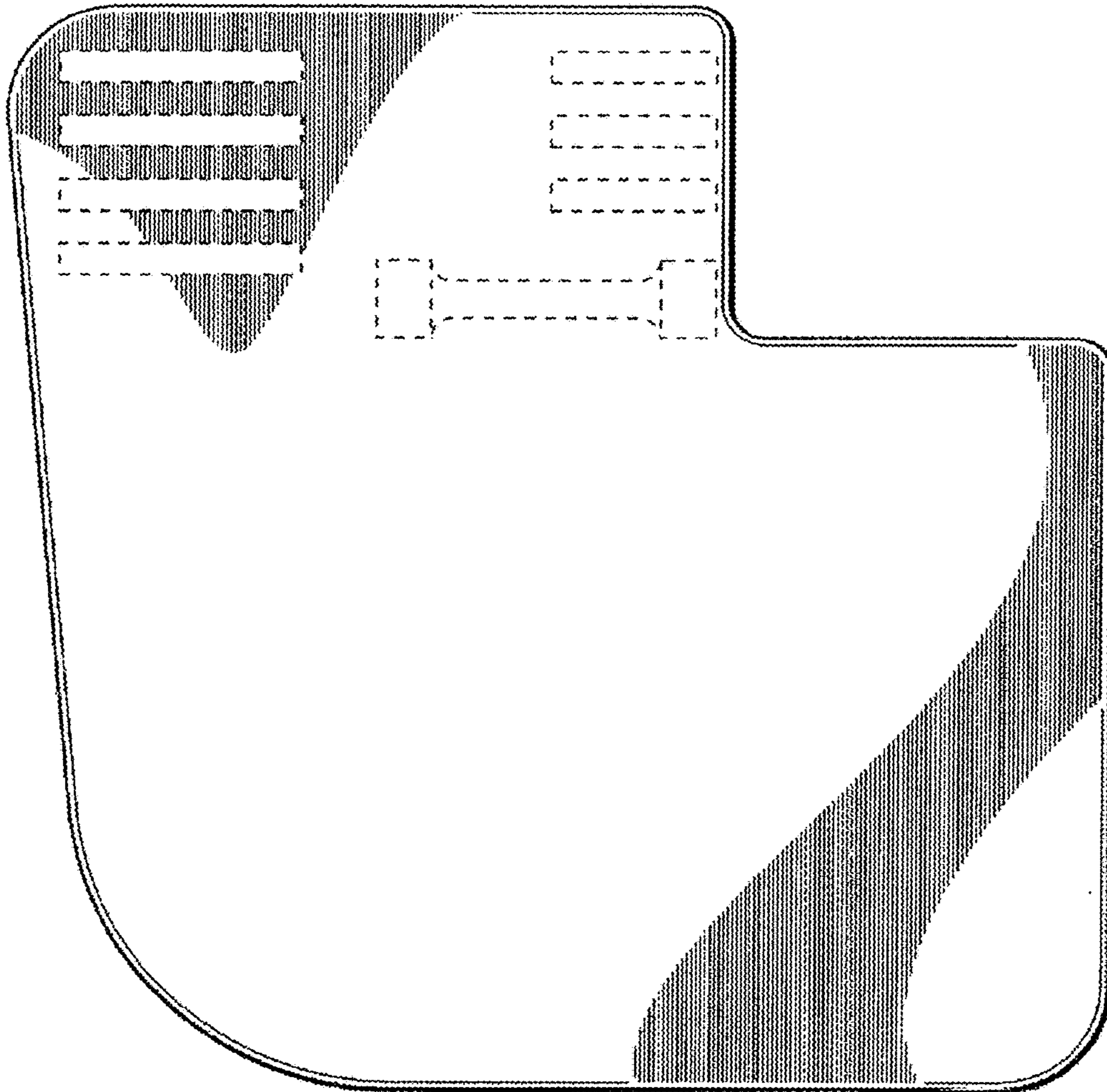
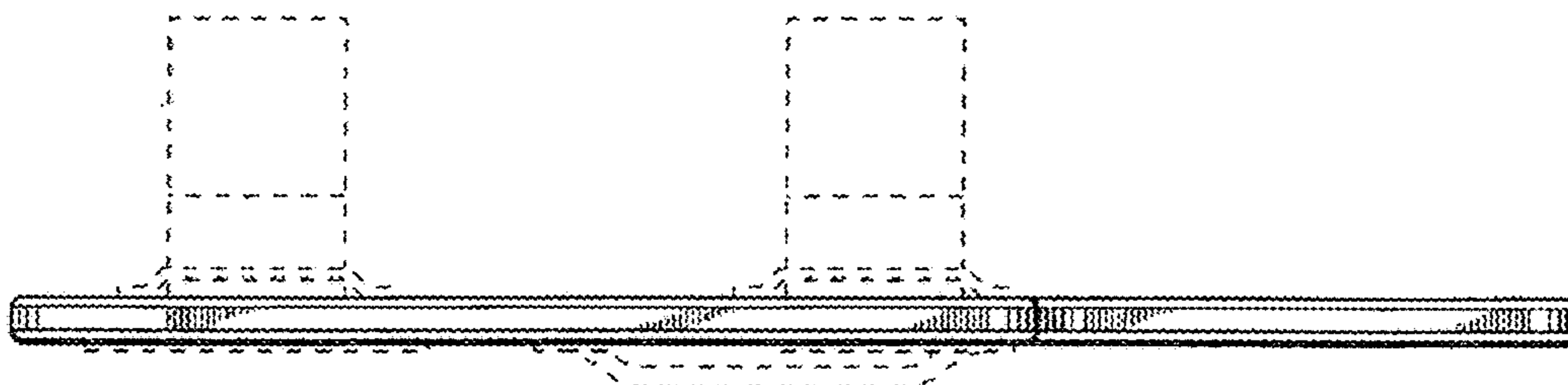

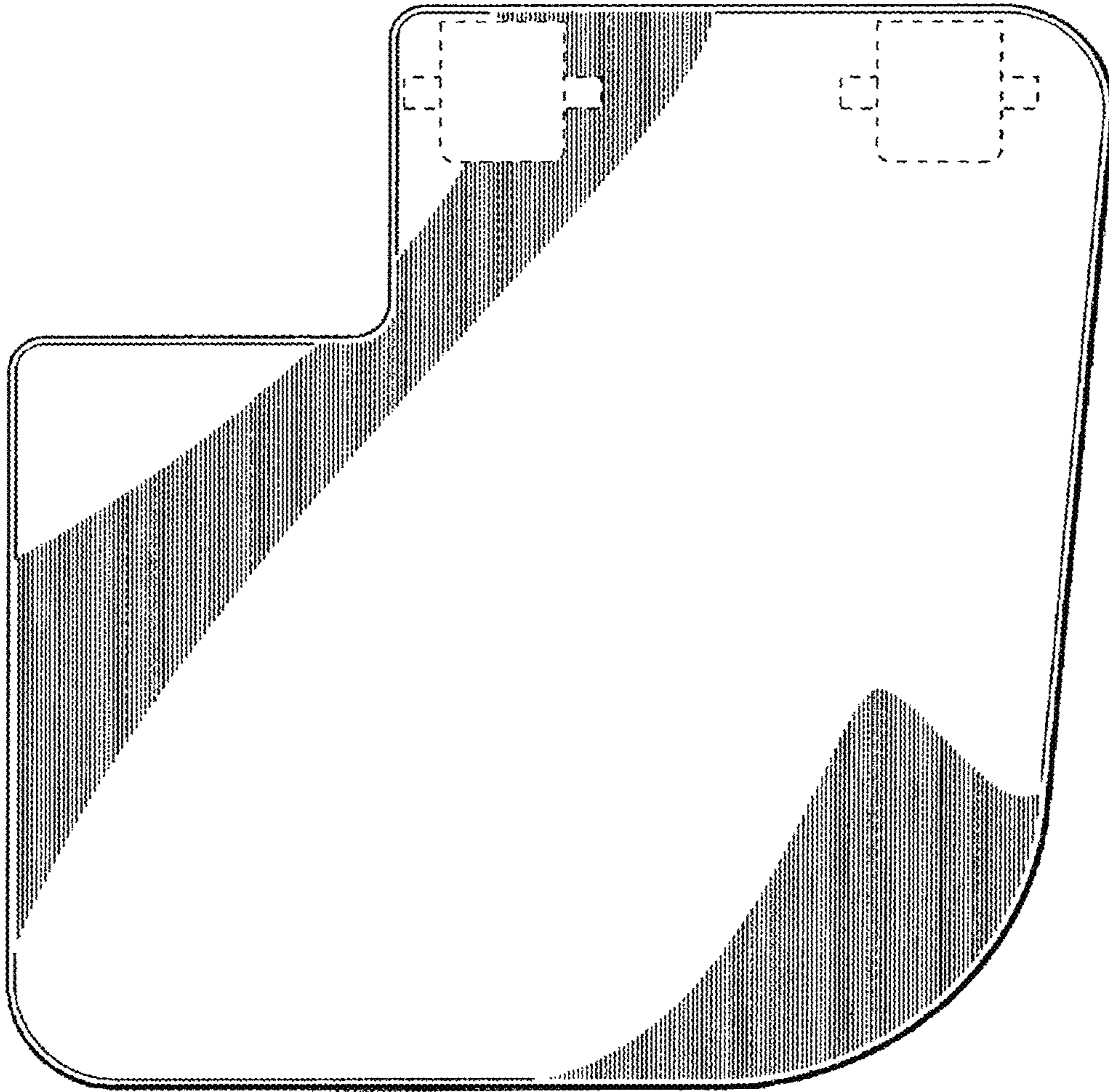
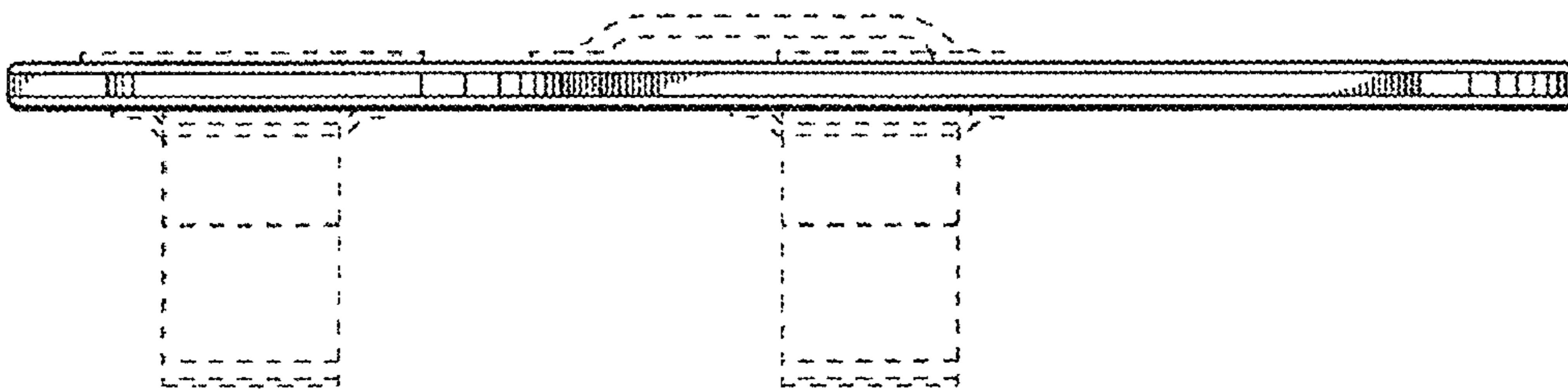

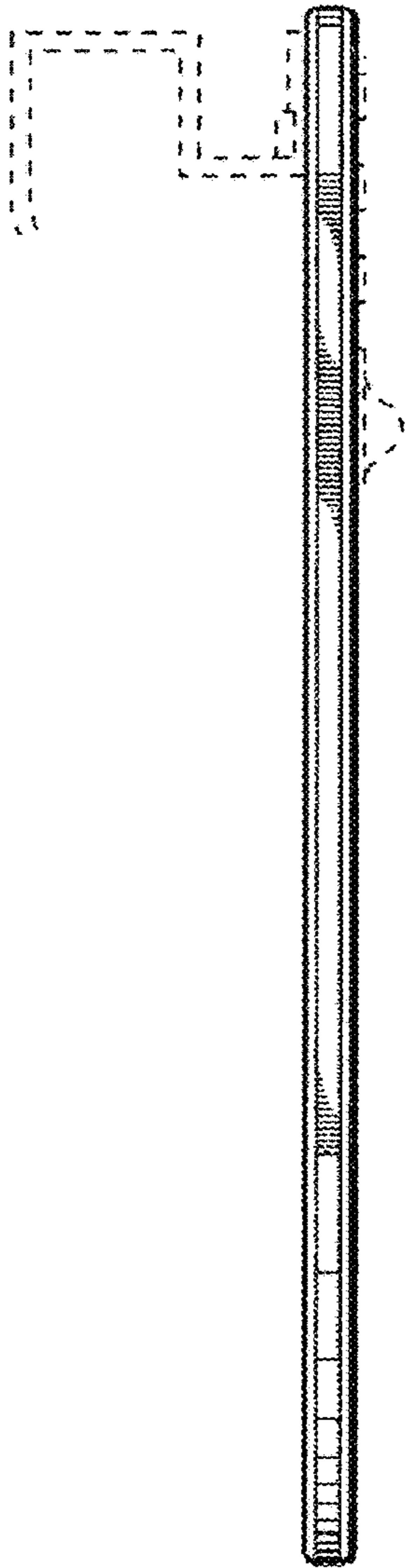

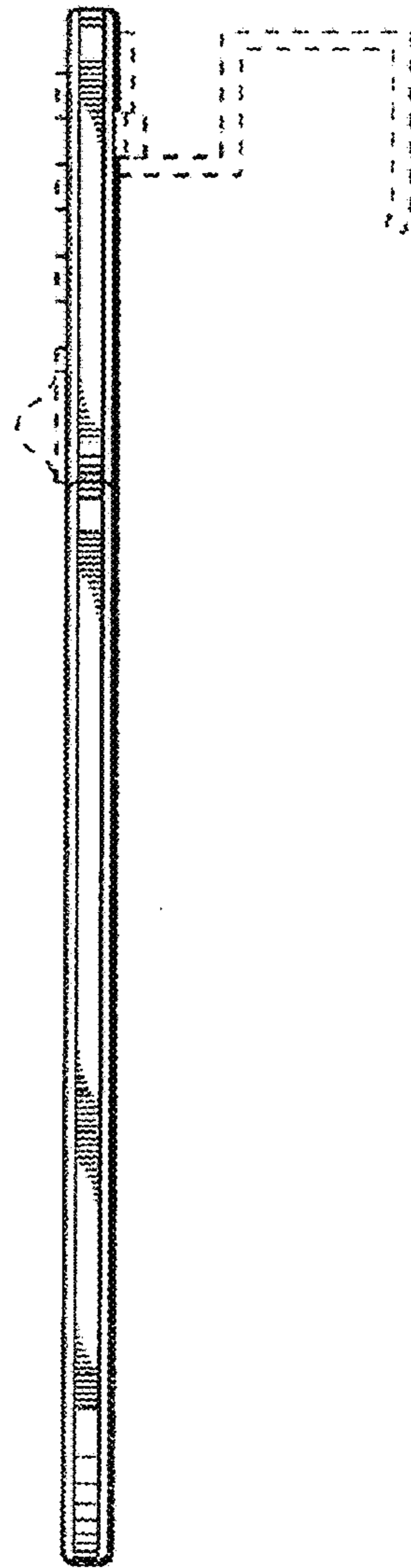

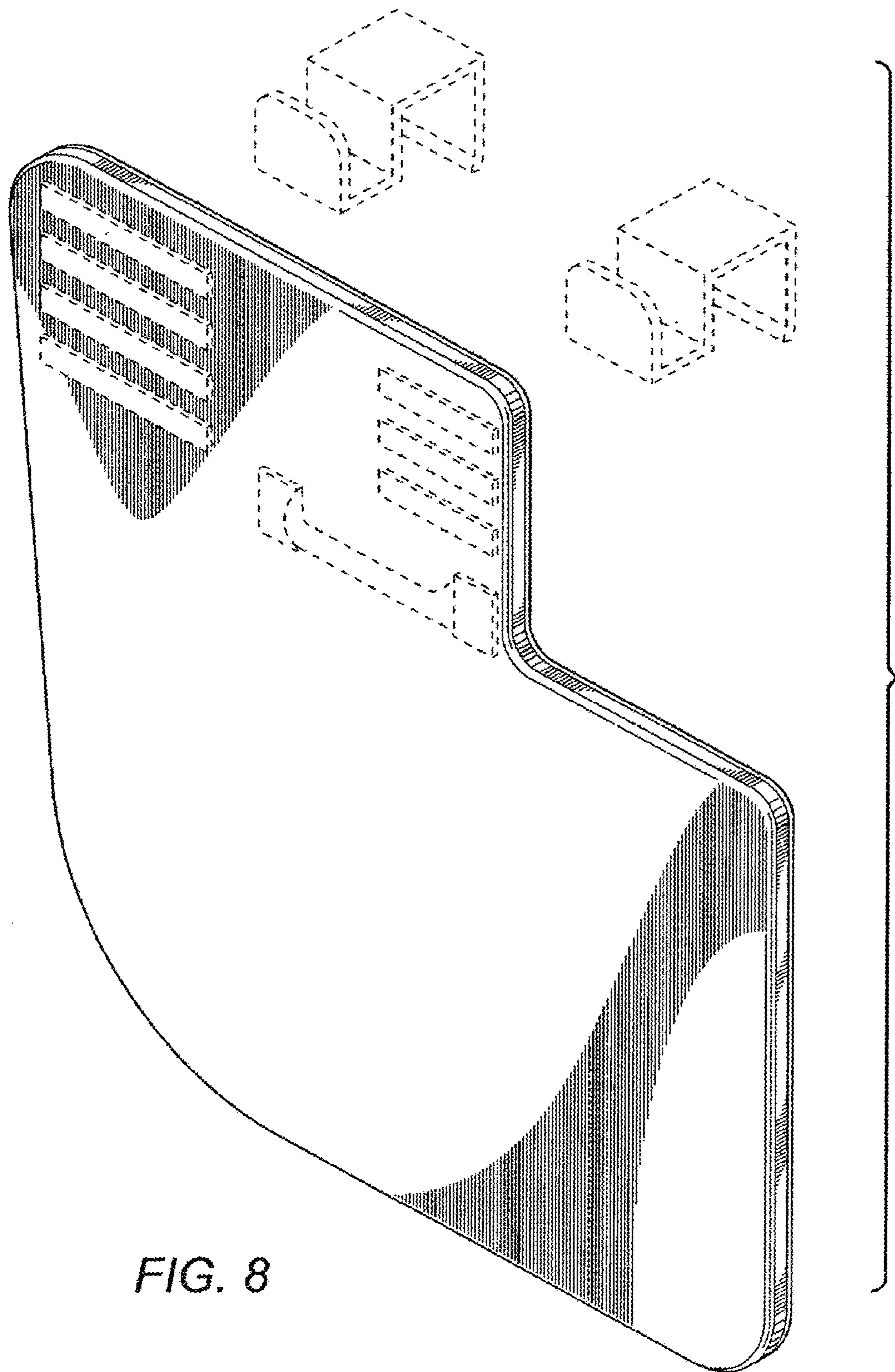

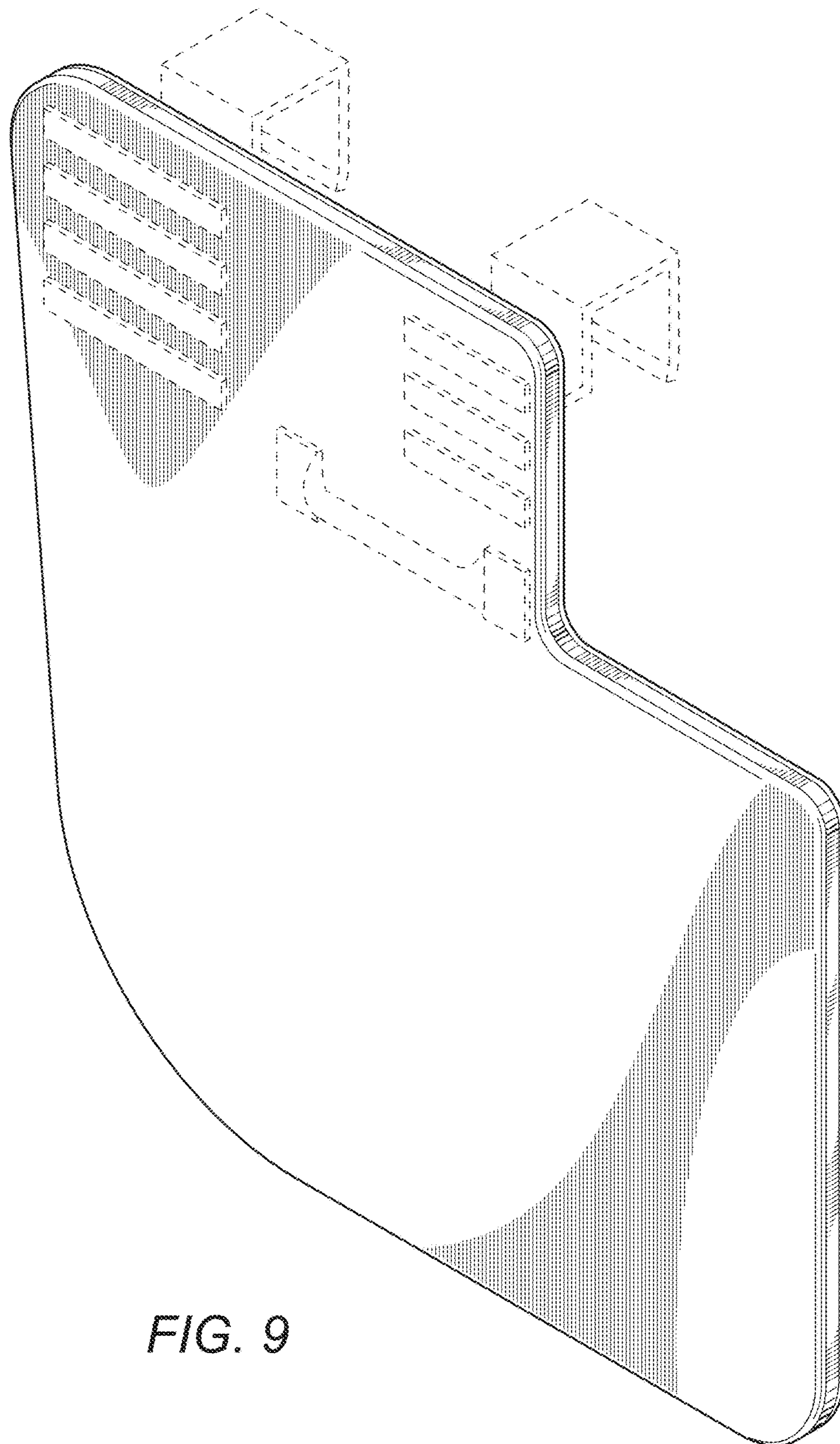

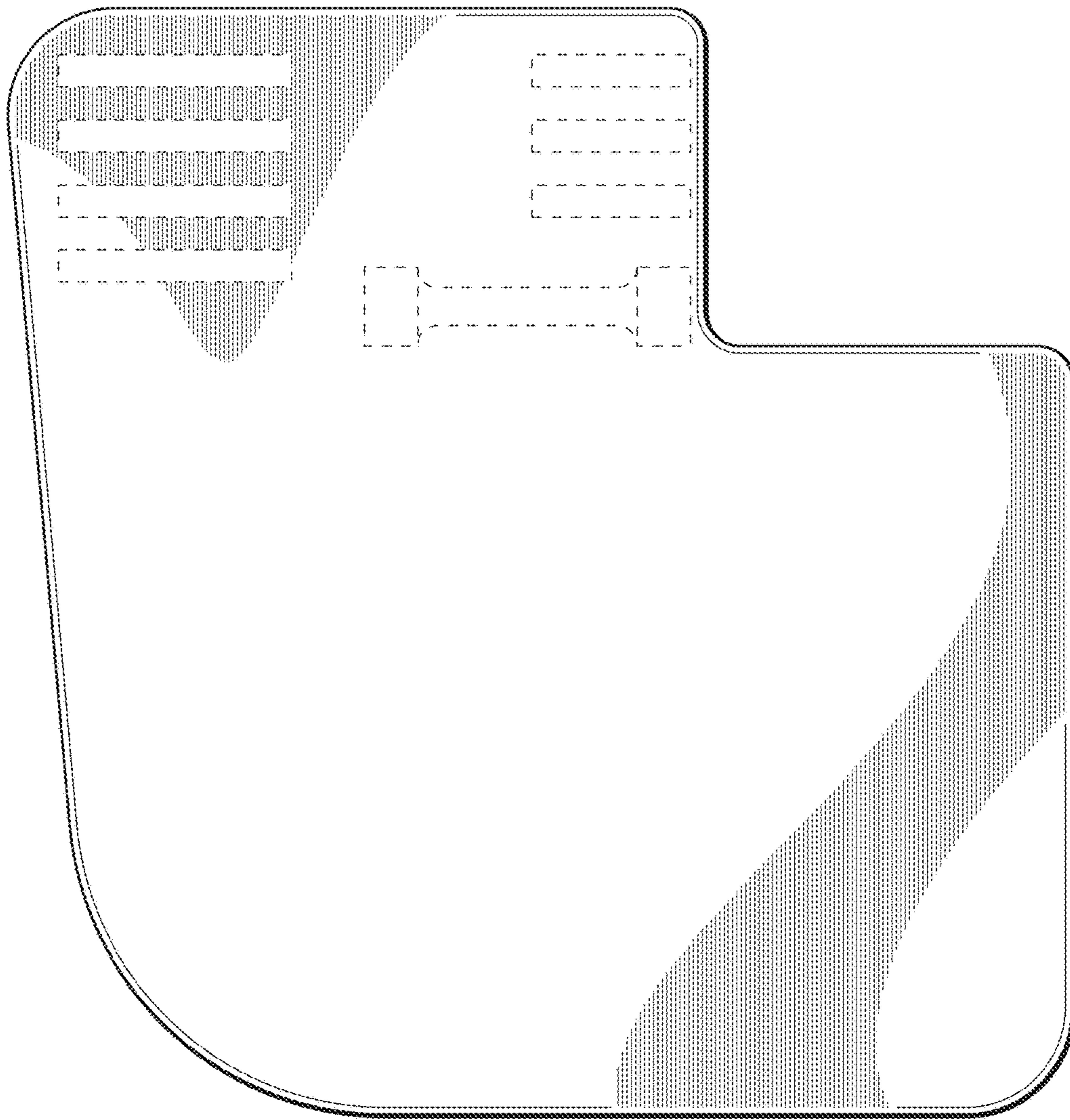
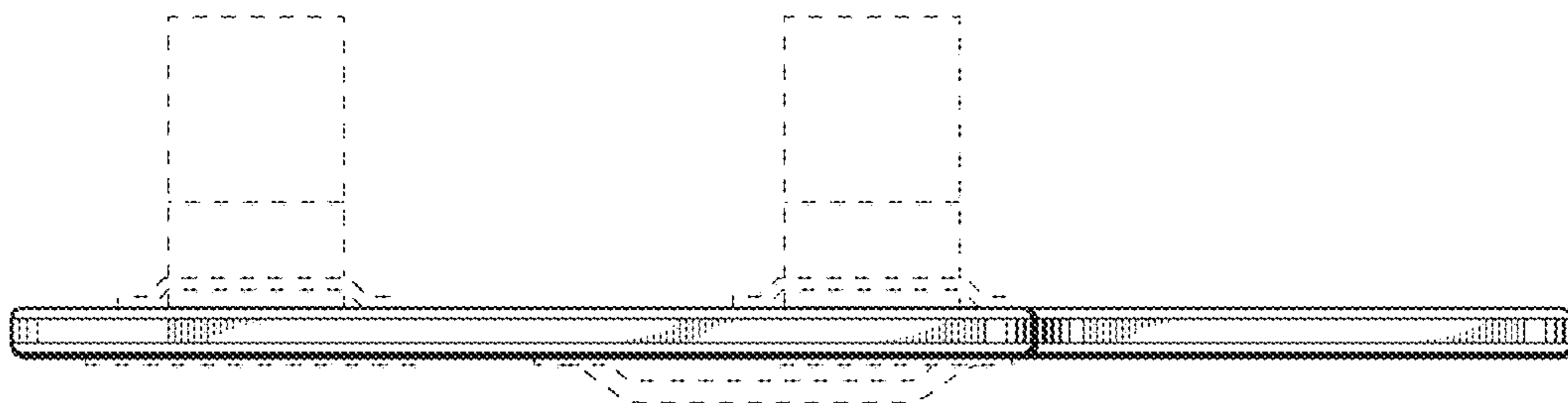

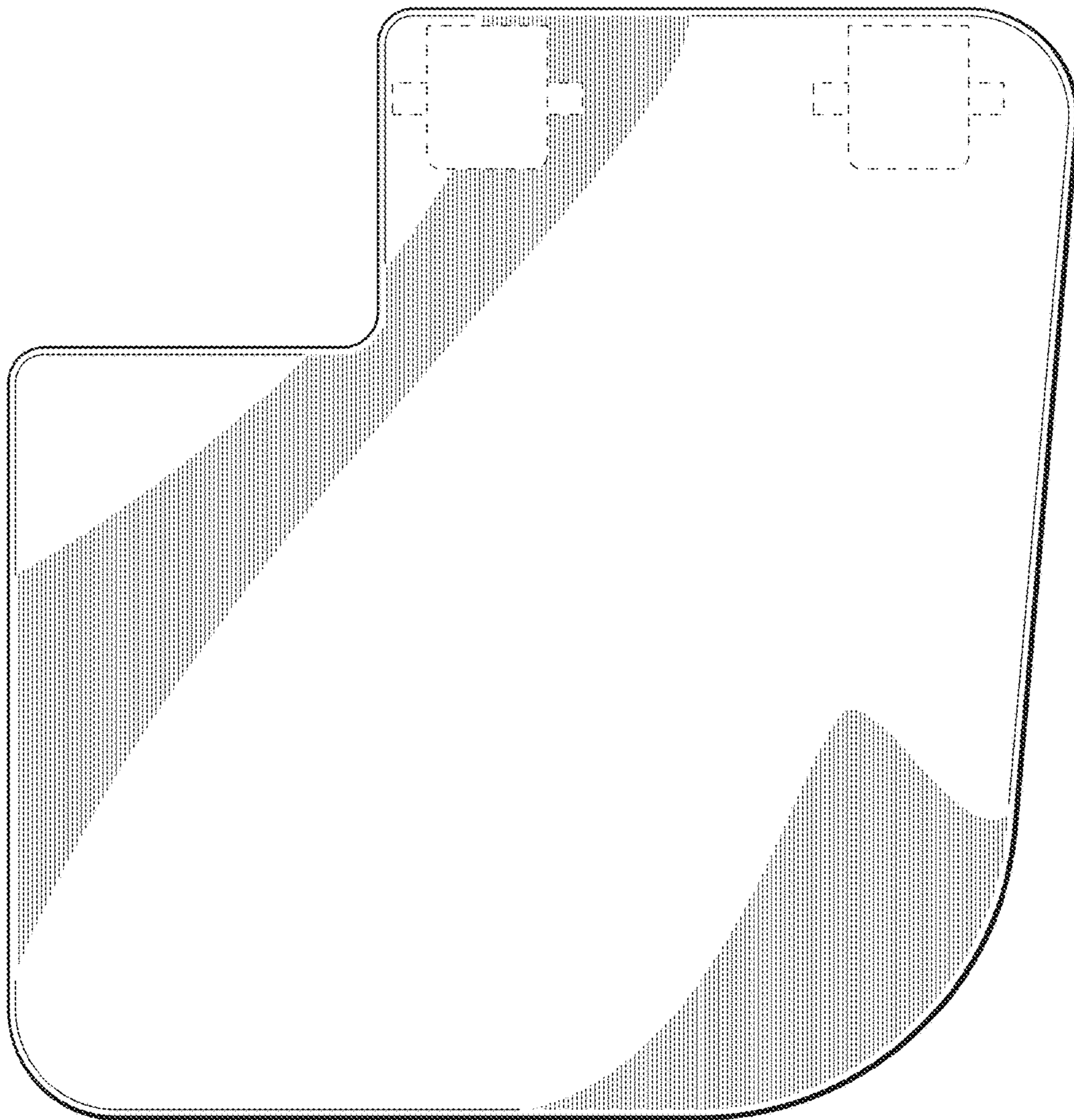
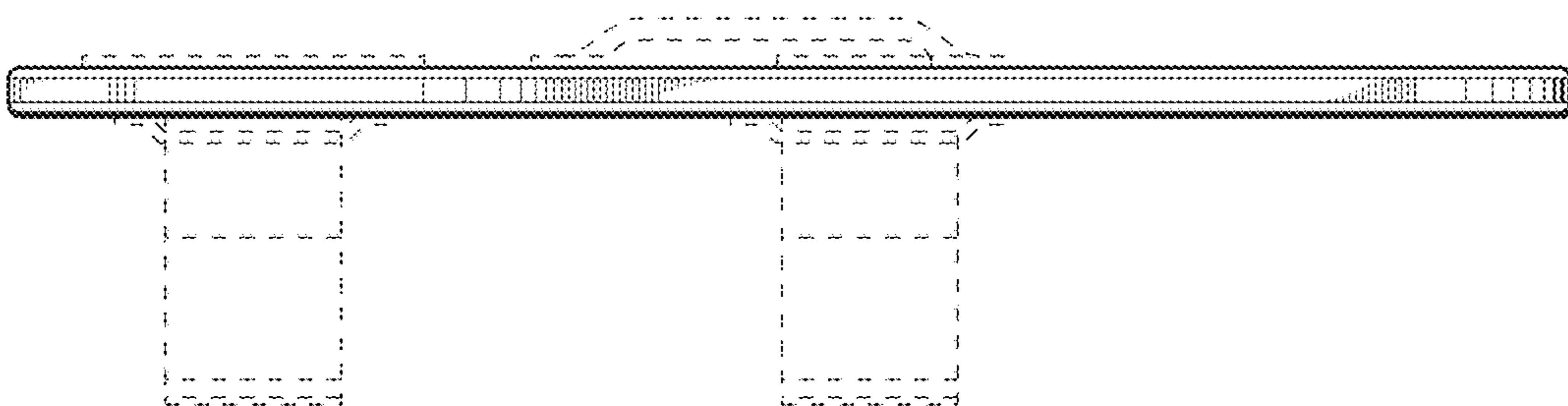

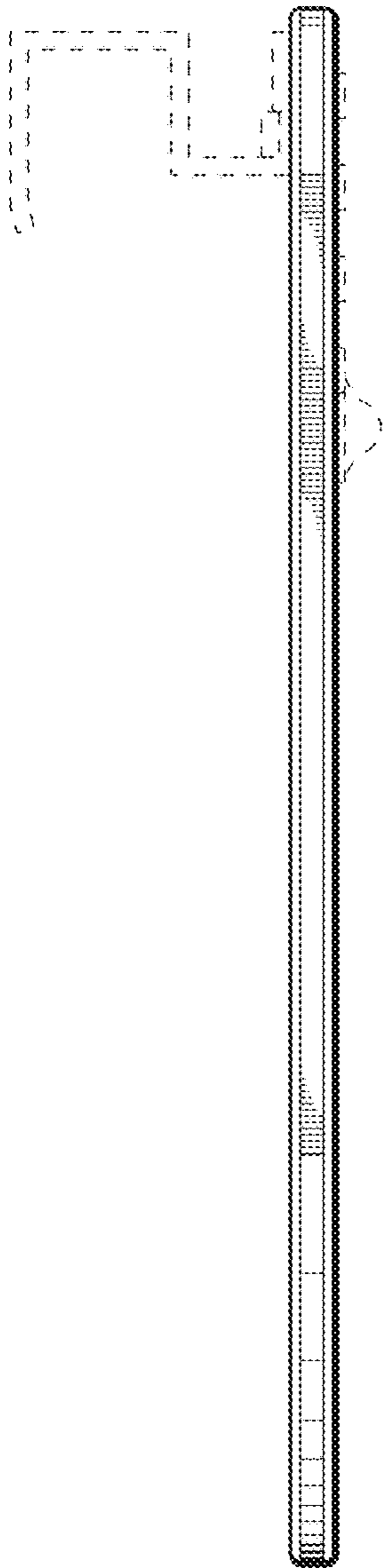

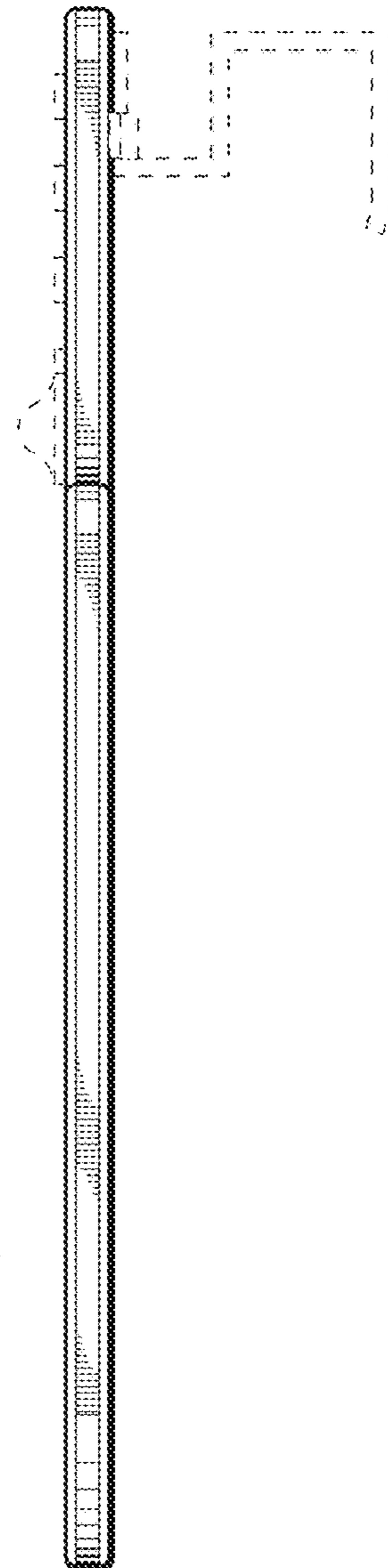

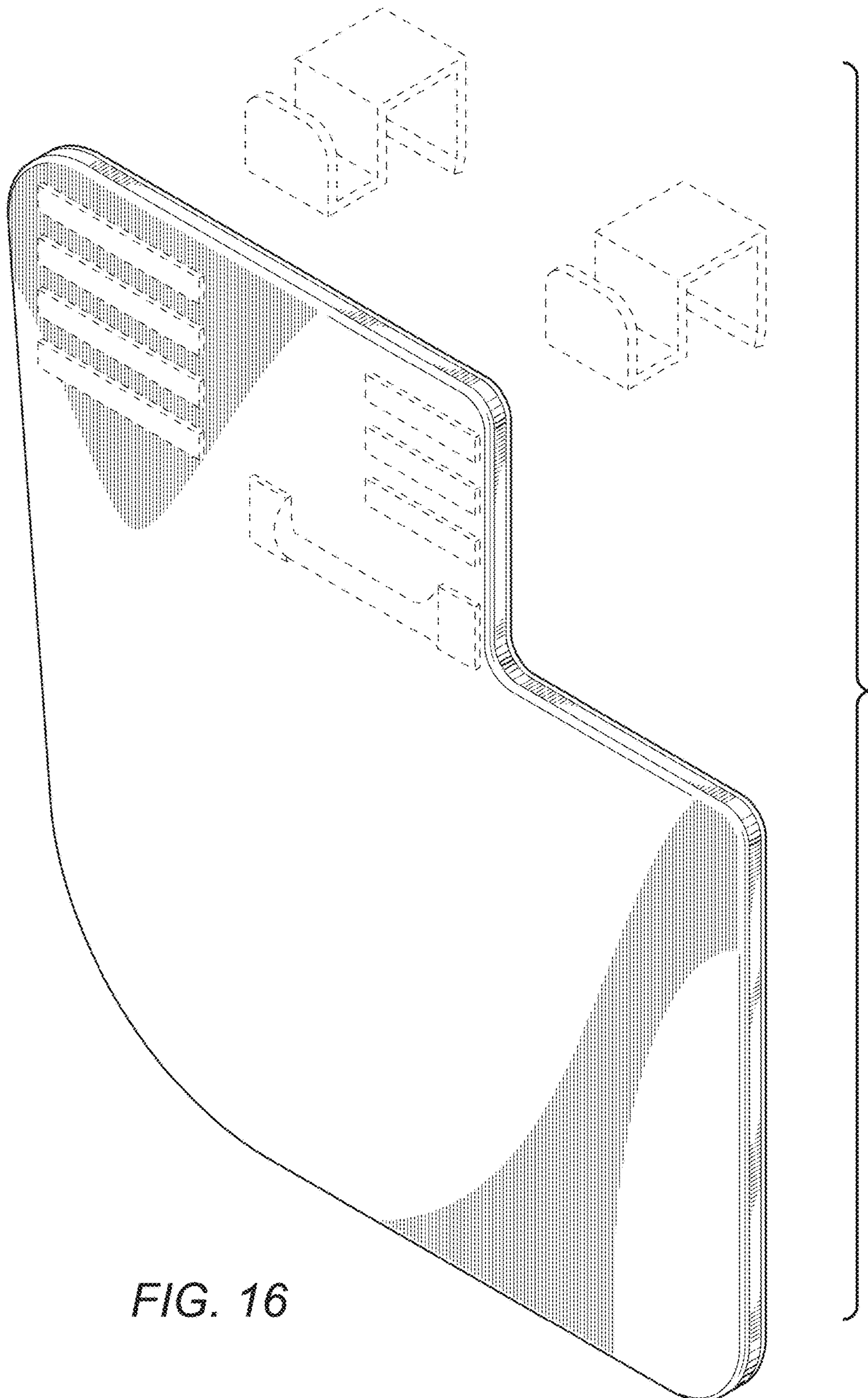
