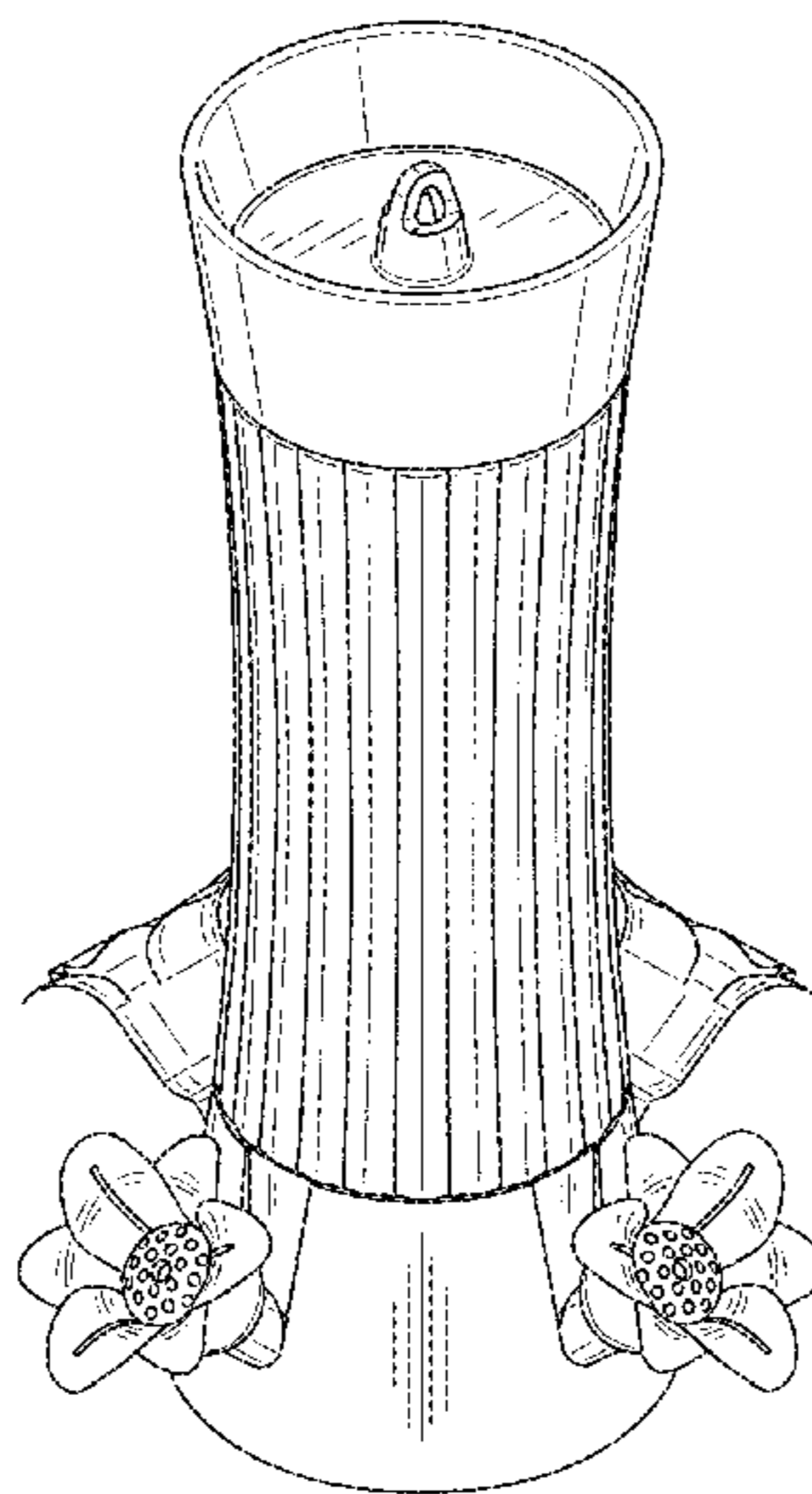
The ornamental design for a hummingbird feeder, as shown and described.

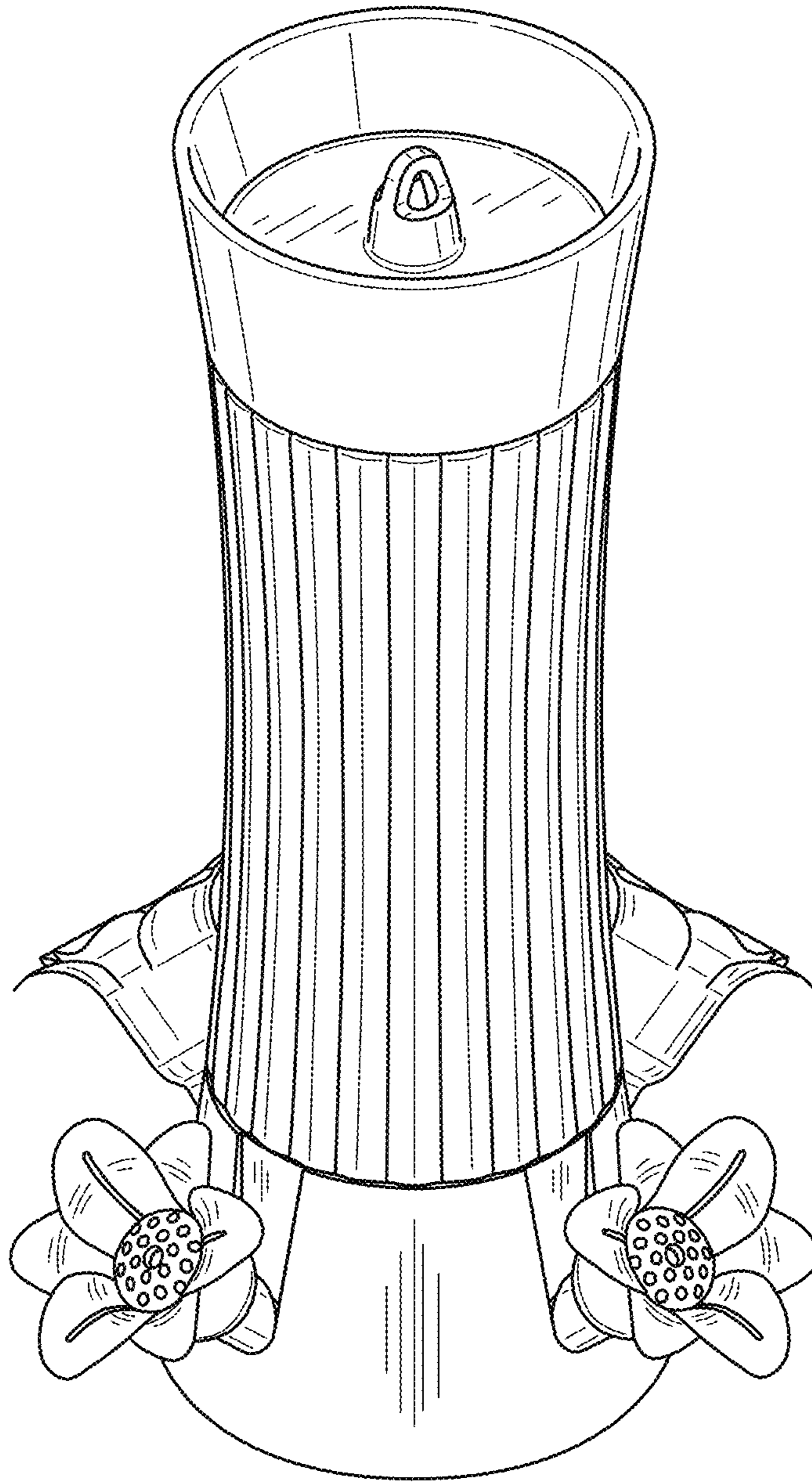

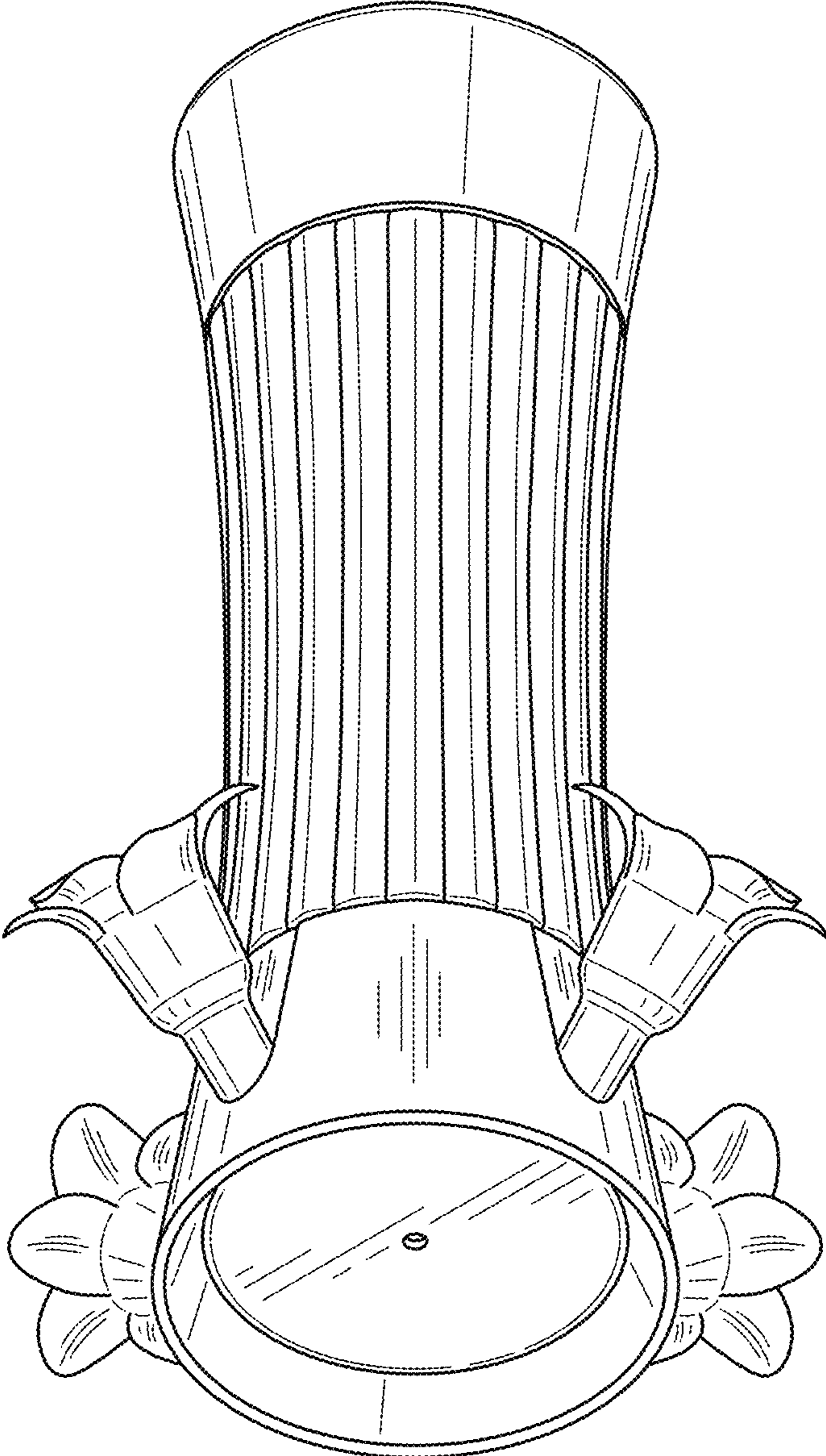

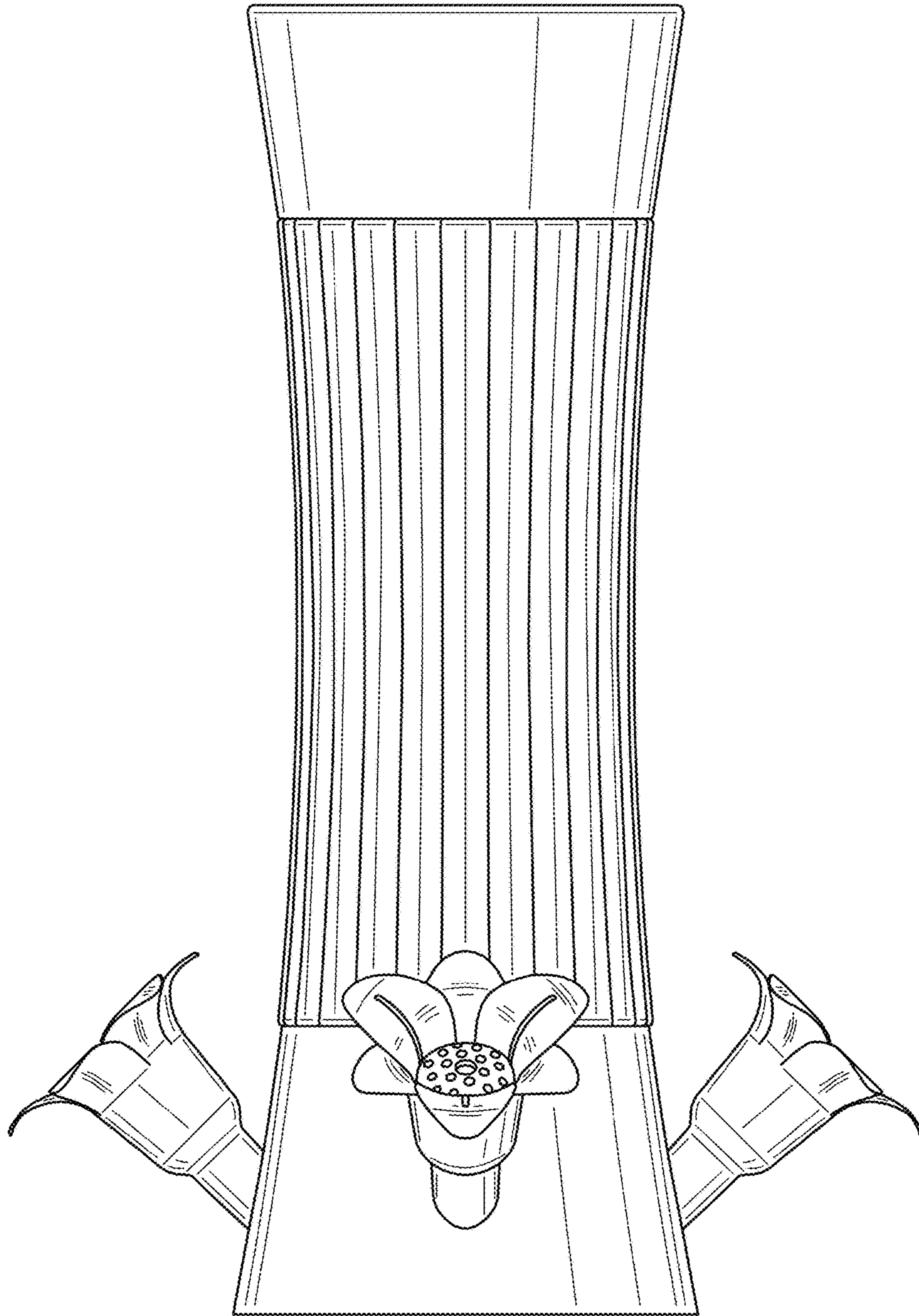

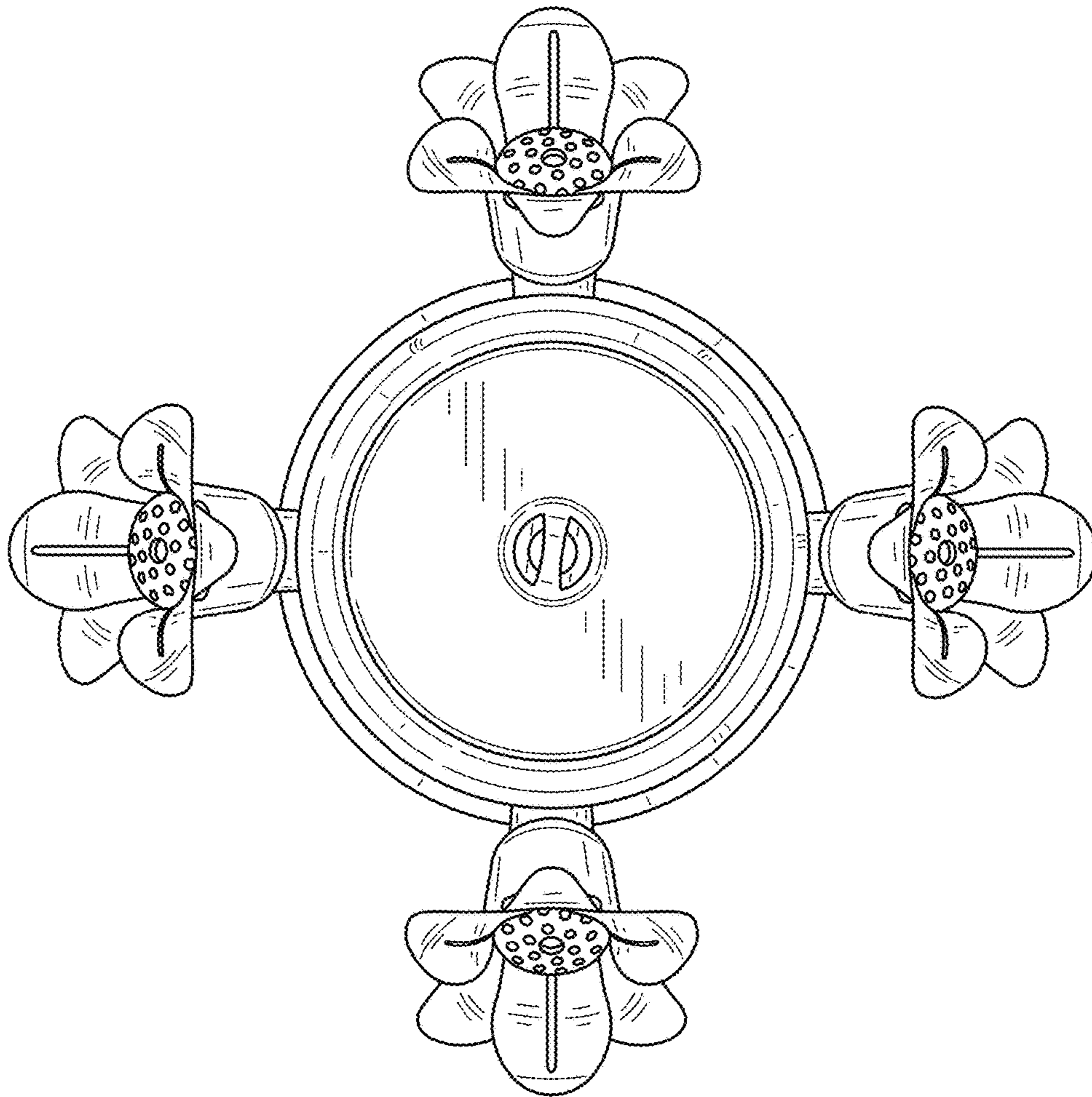

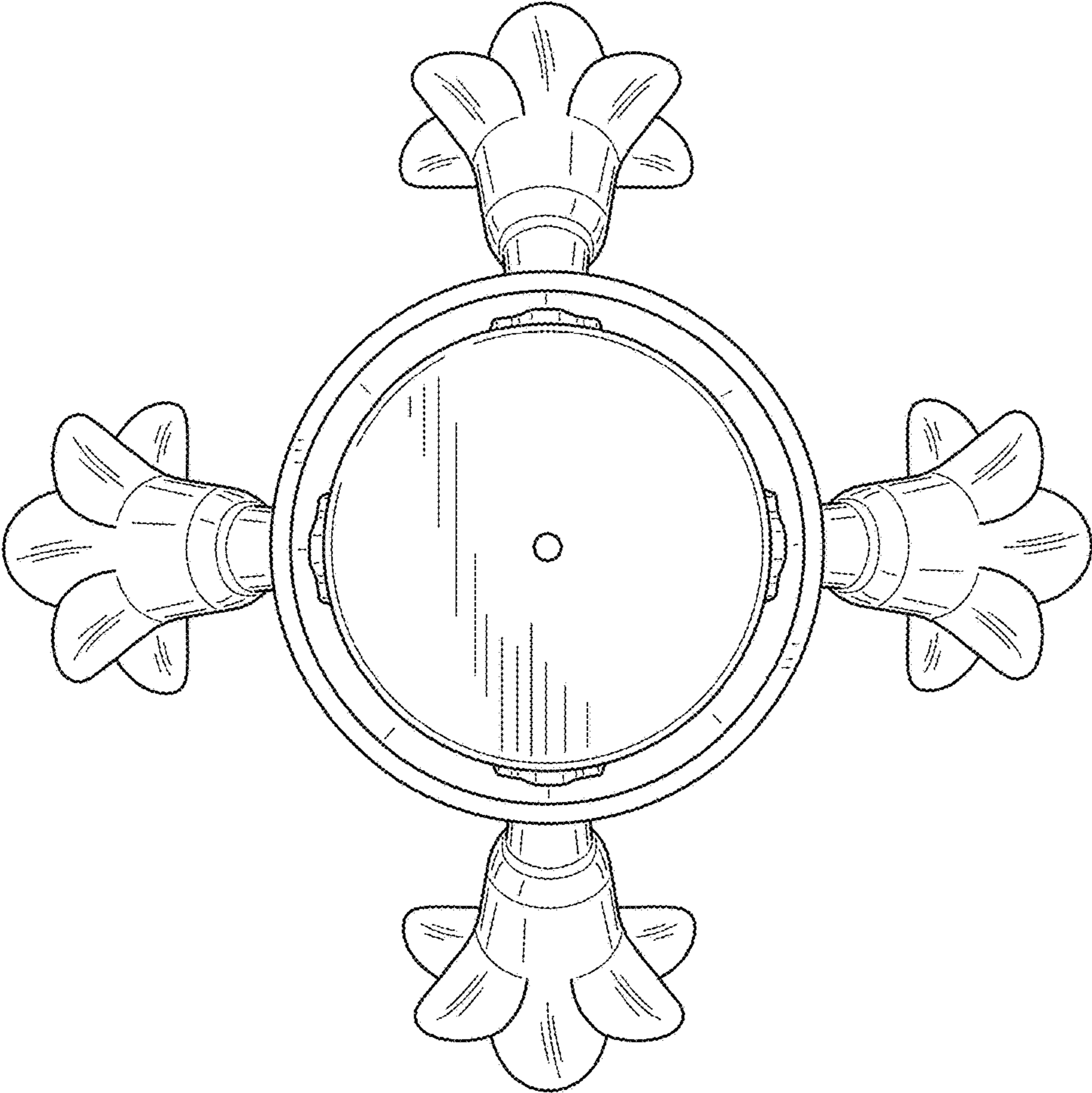
