swimsuit with the leg closed.

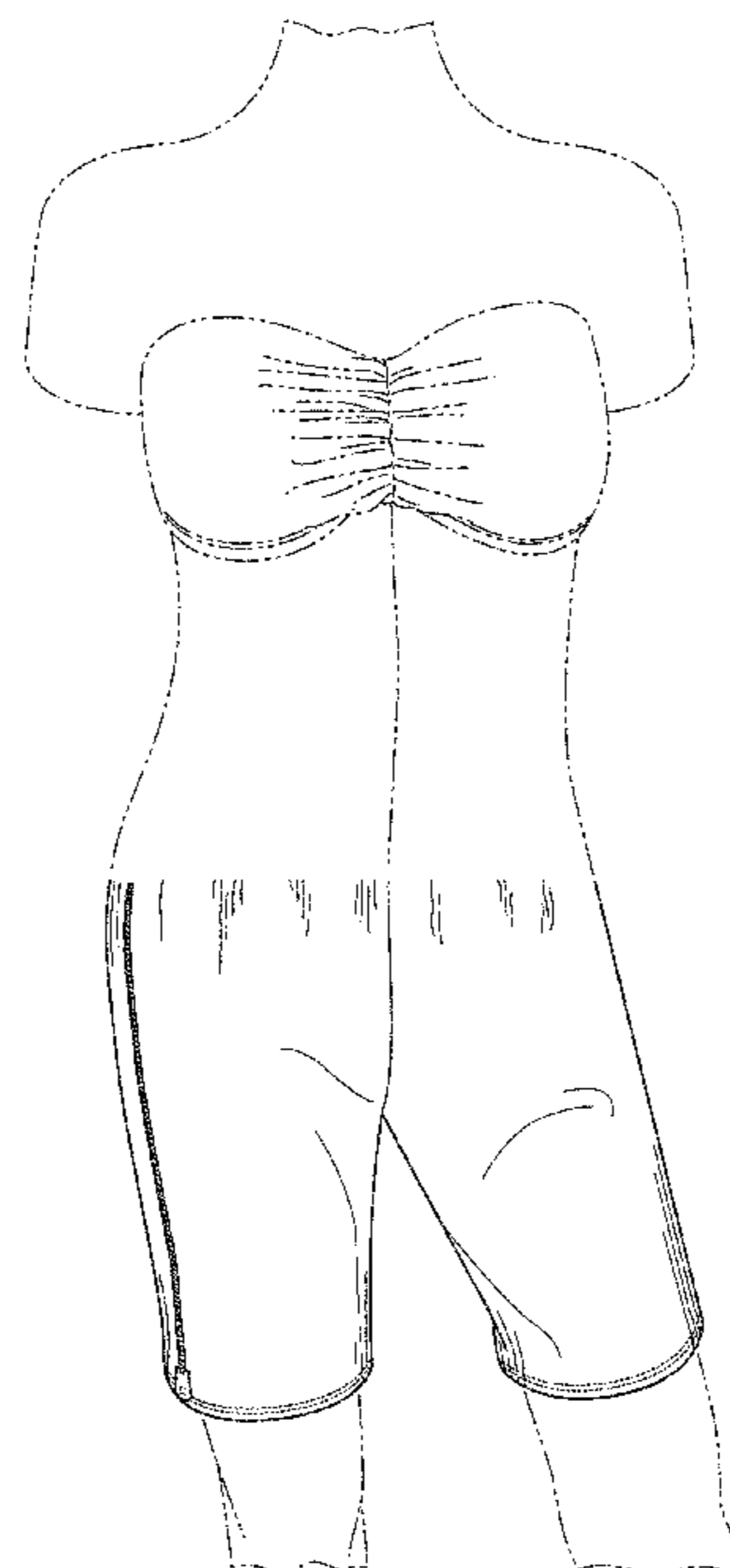
FIG. 4 is a standing side view of my newly designed

with the legs closed; and,

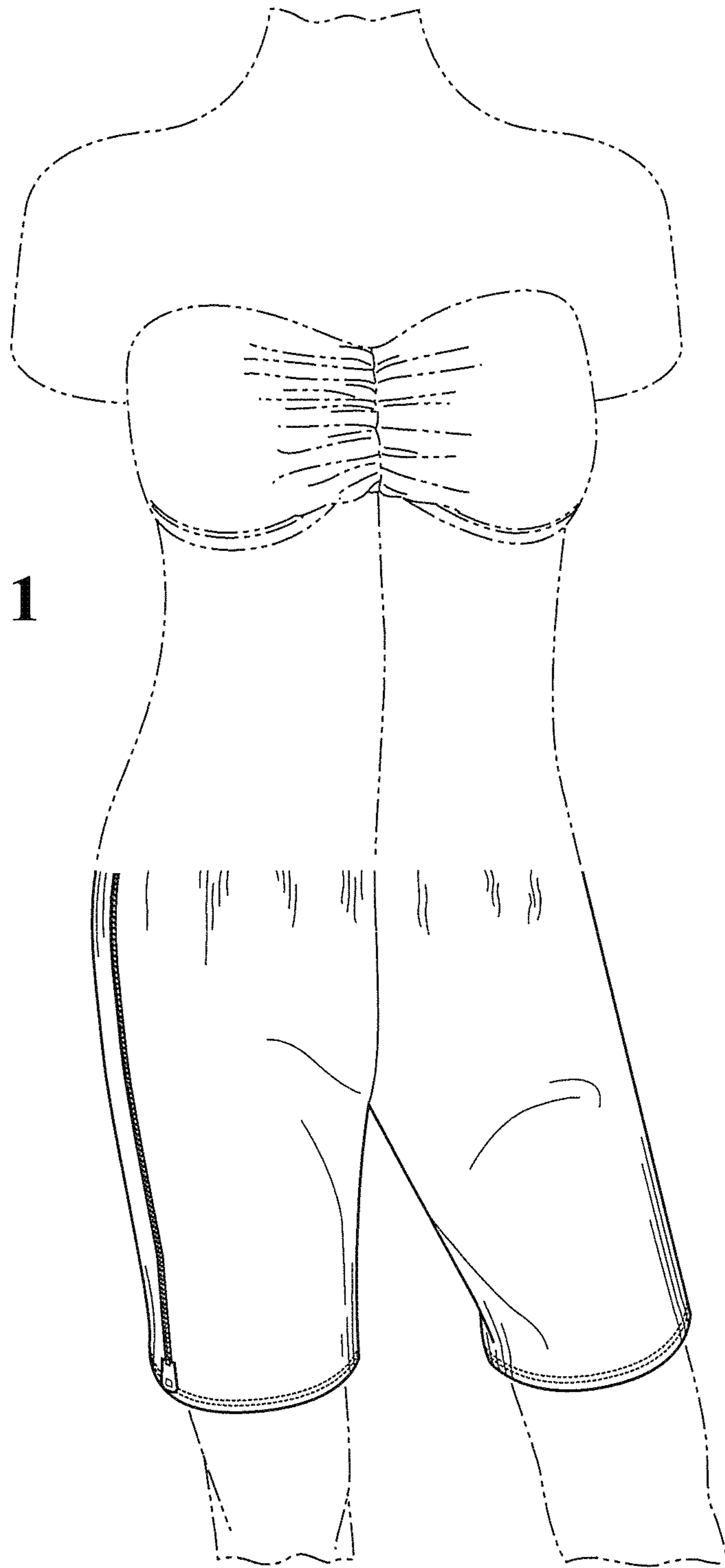
FIG. 6 is a sitting side view of my newly designed swimsuit  
with the legs open.

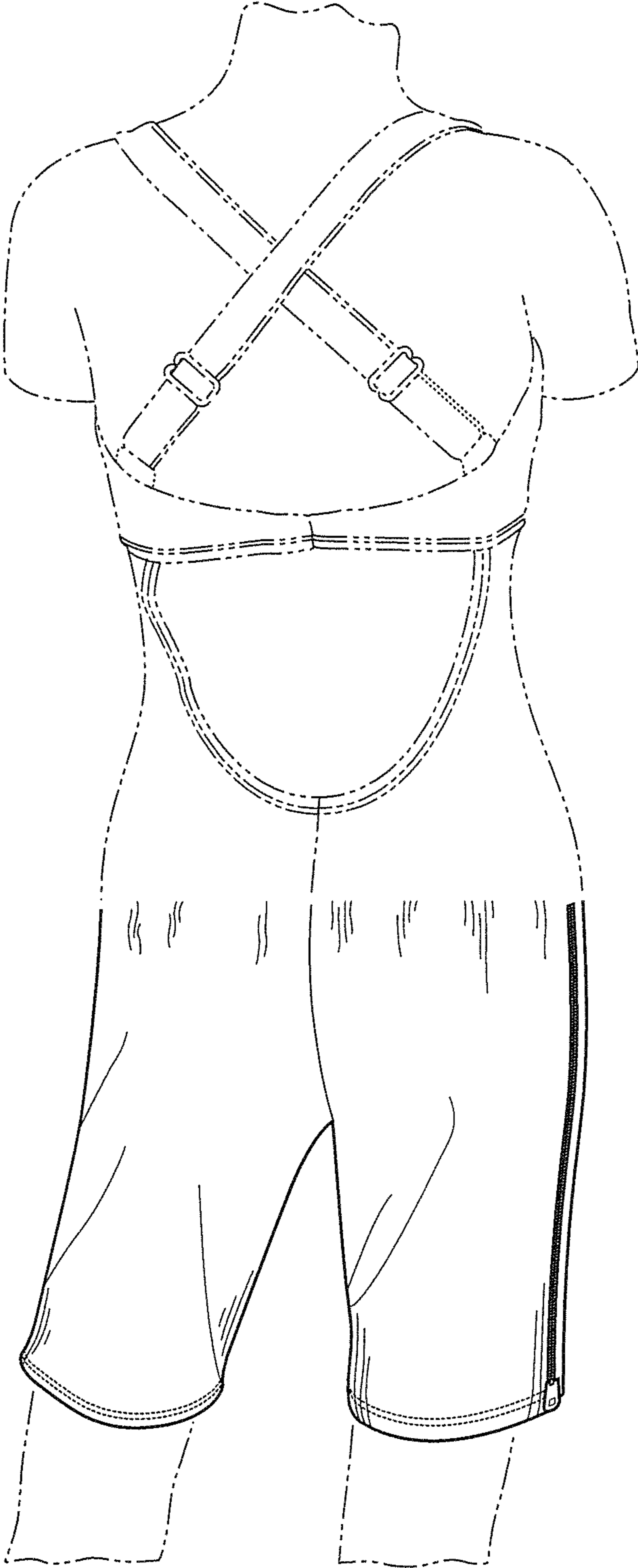
Broken lines are used to show visible environmental struc-

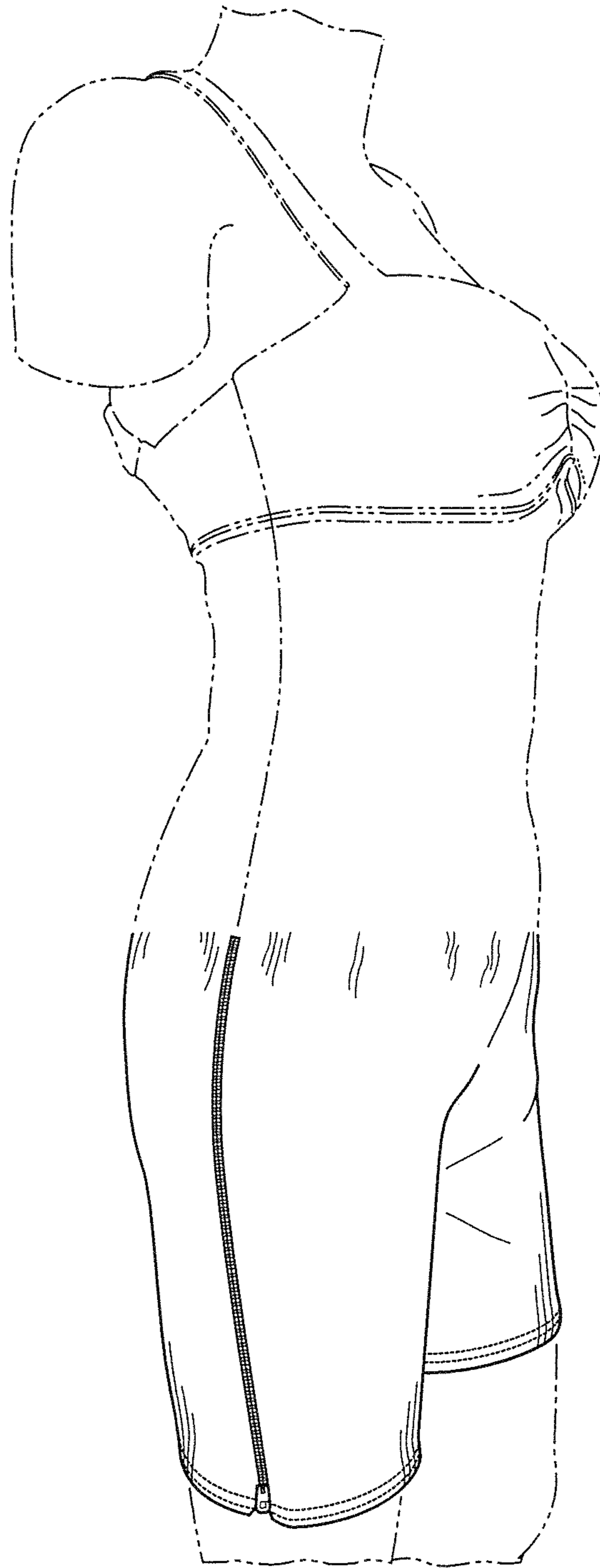

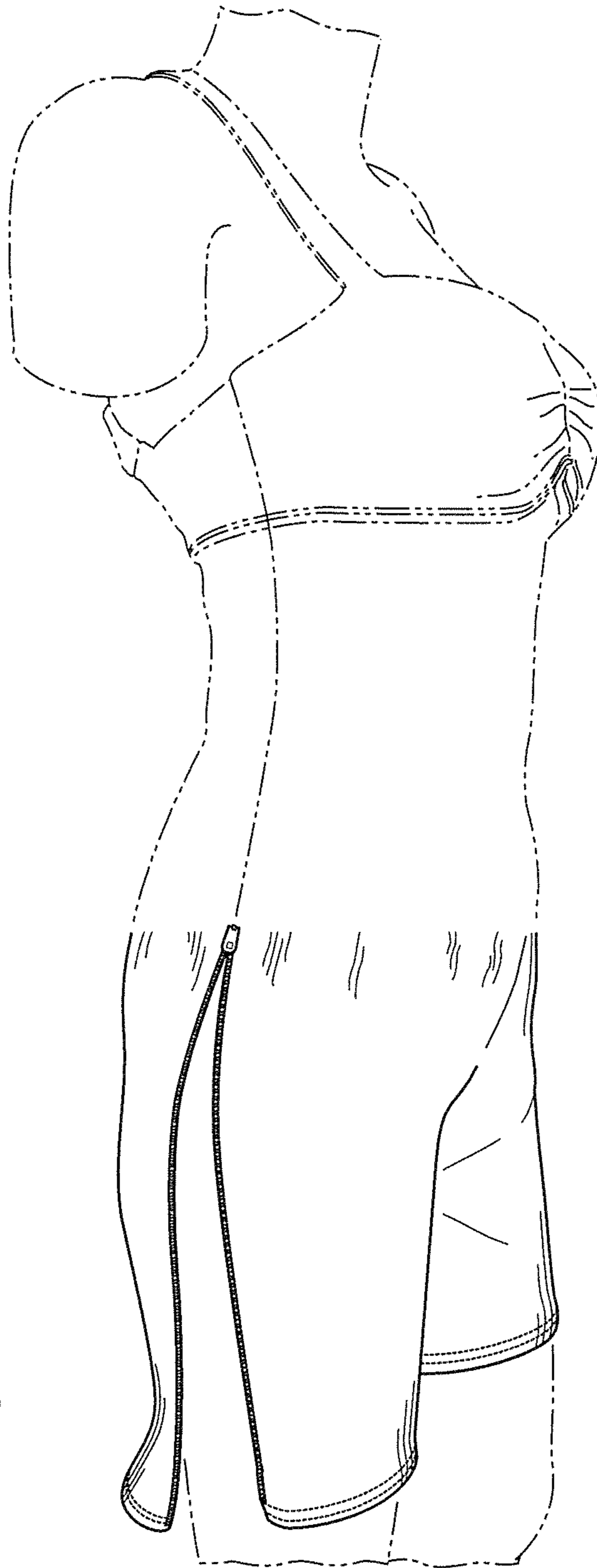

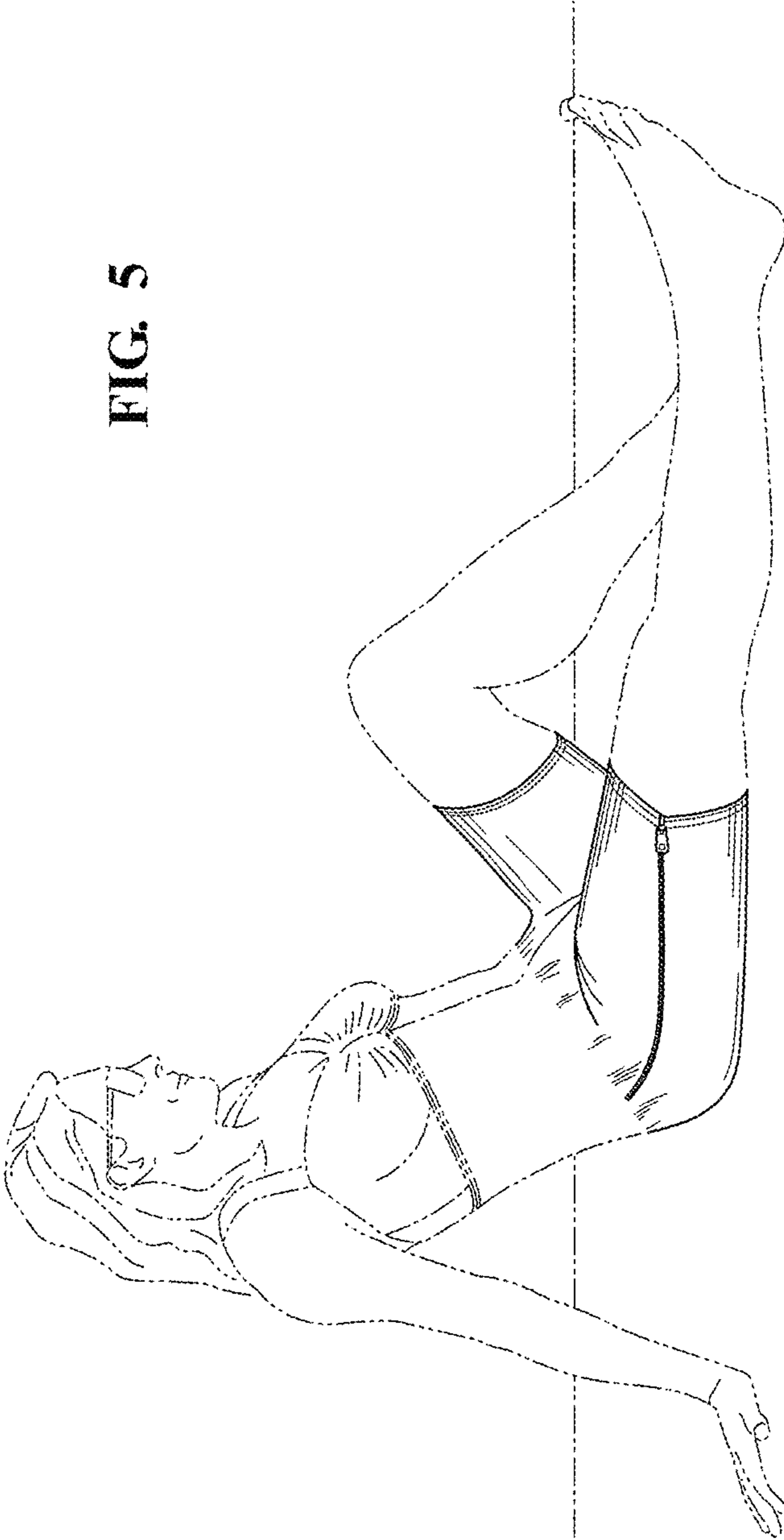

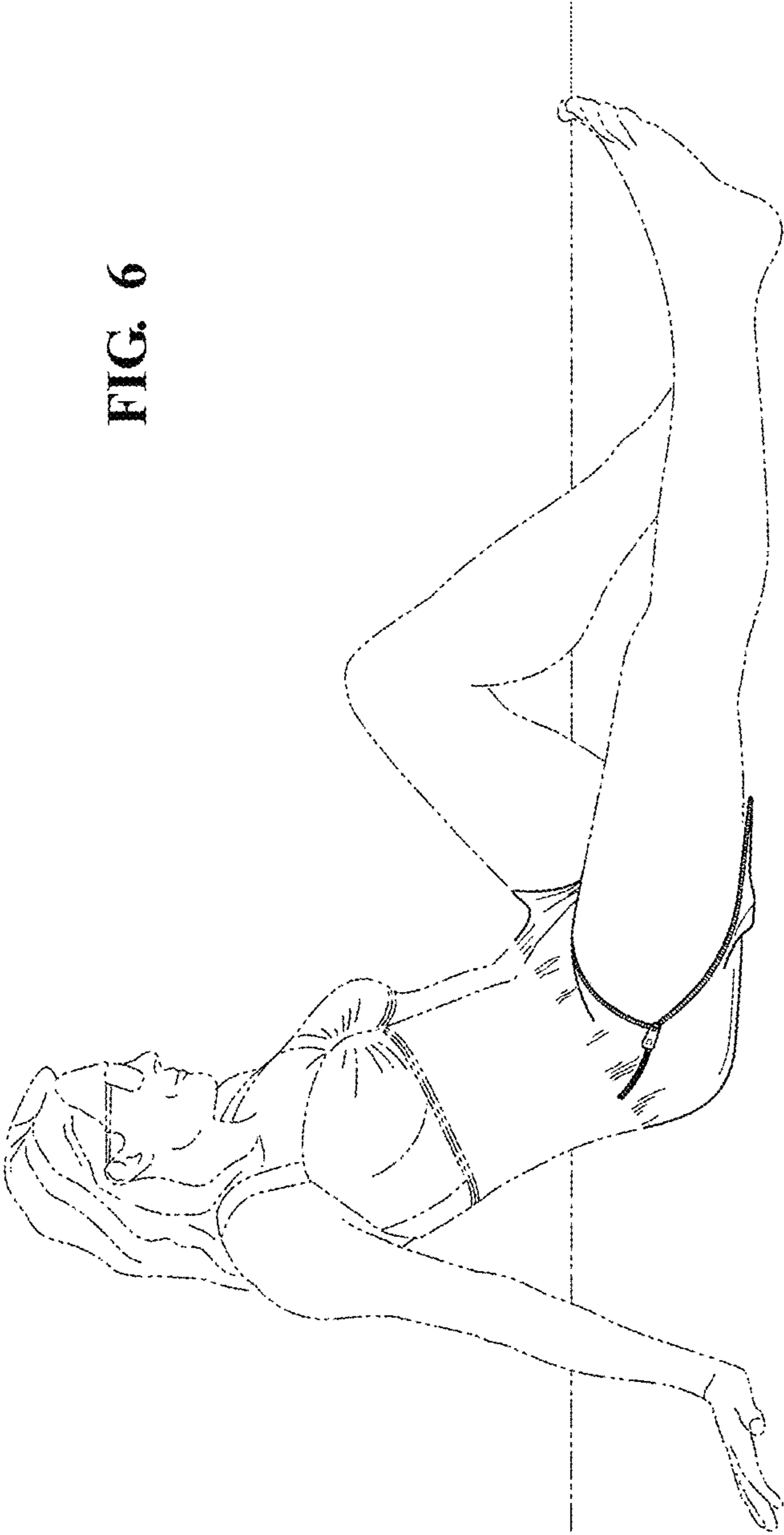
