FIG. 2 is a second side view thereof;

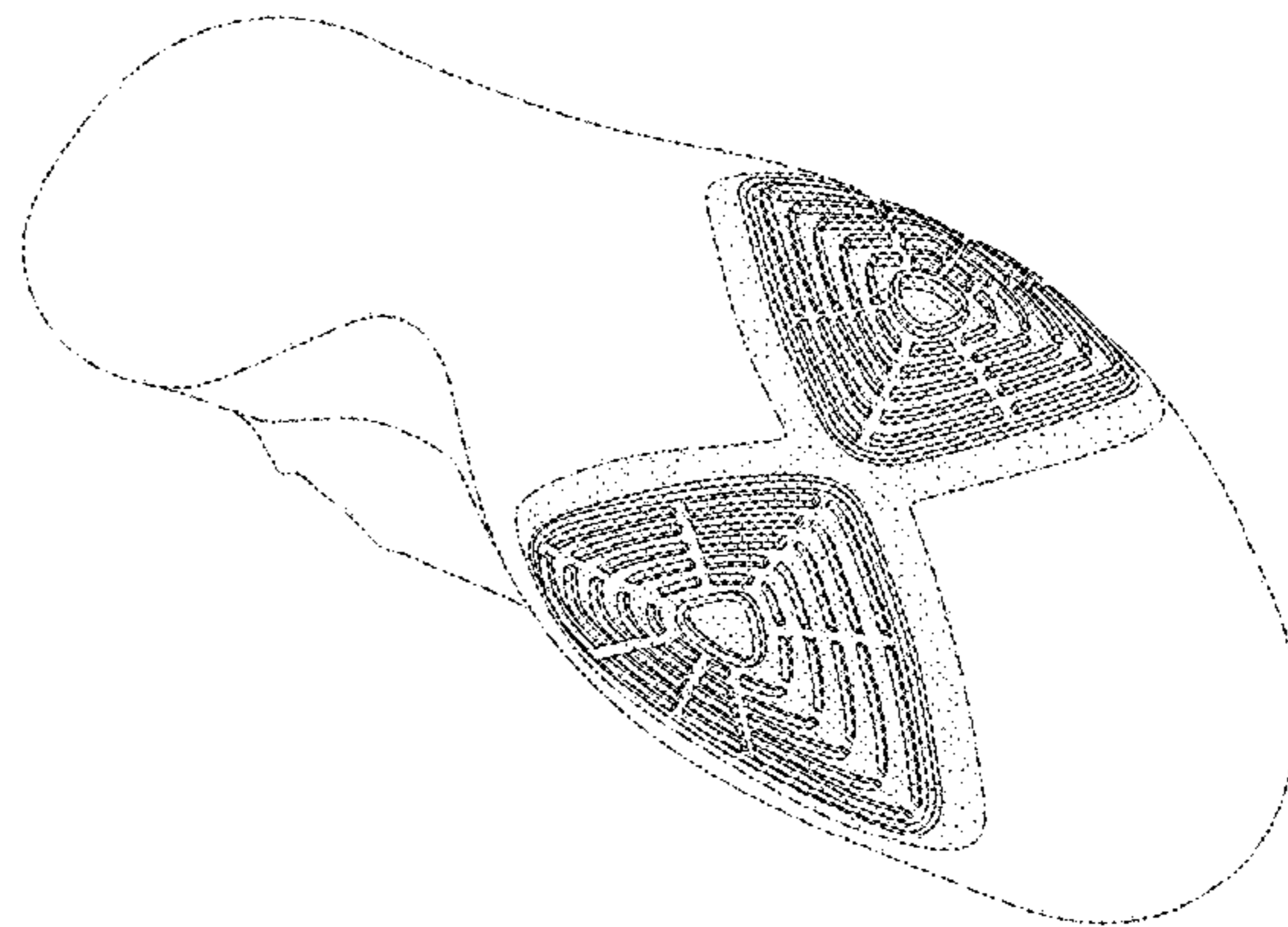
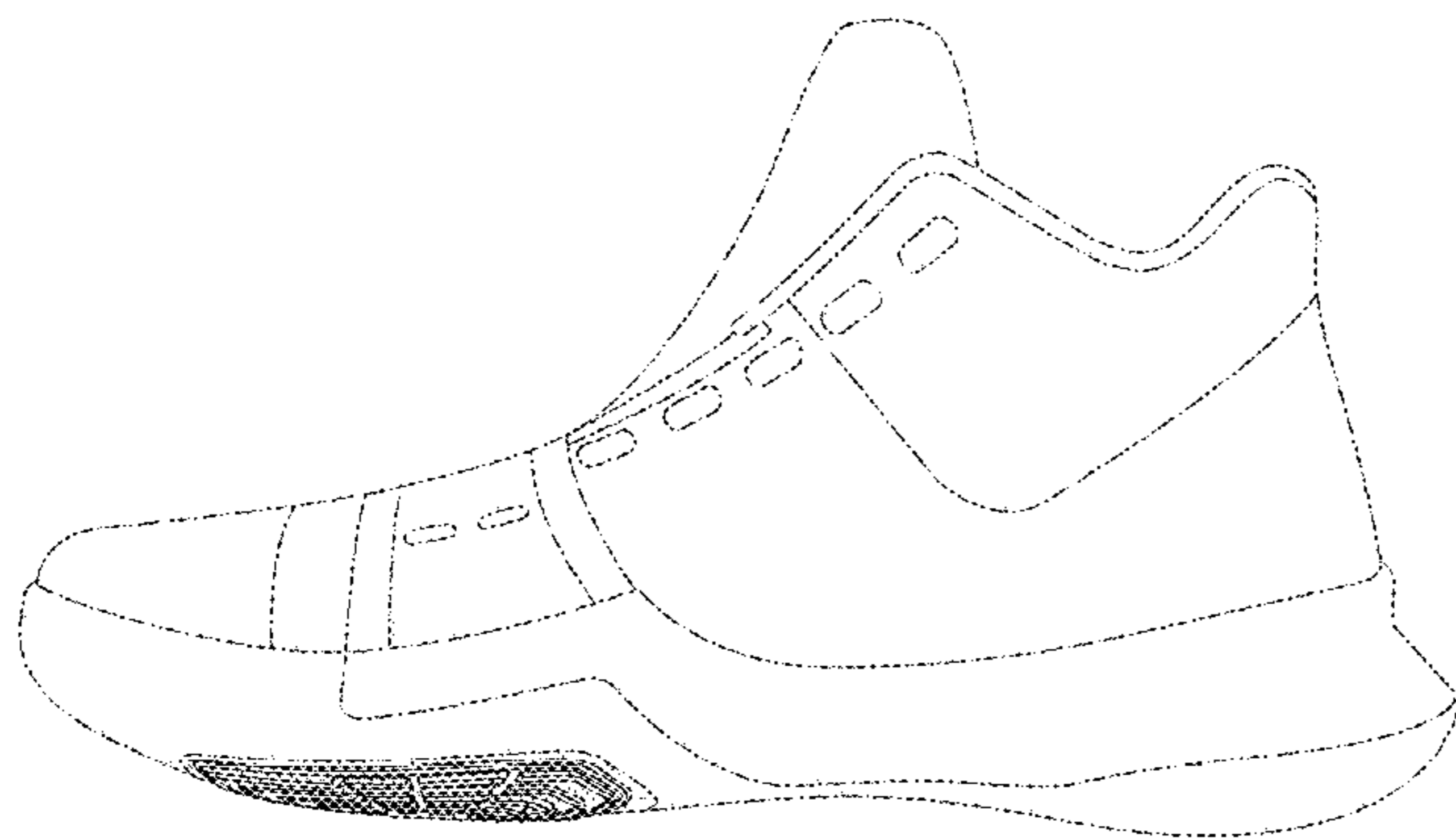
FIG. 3 is a front perspective view thereof;

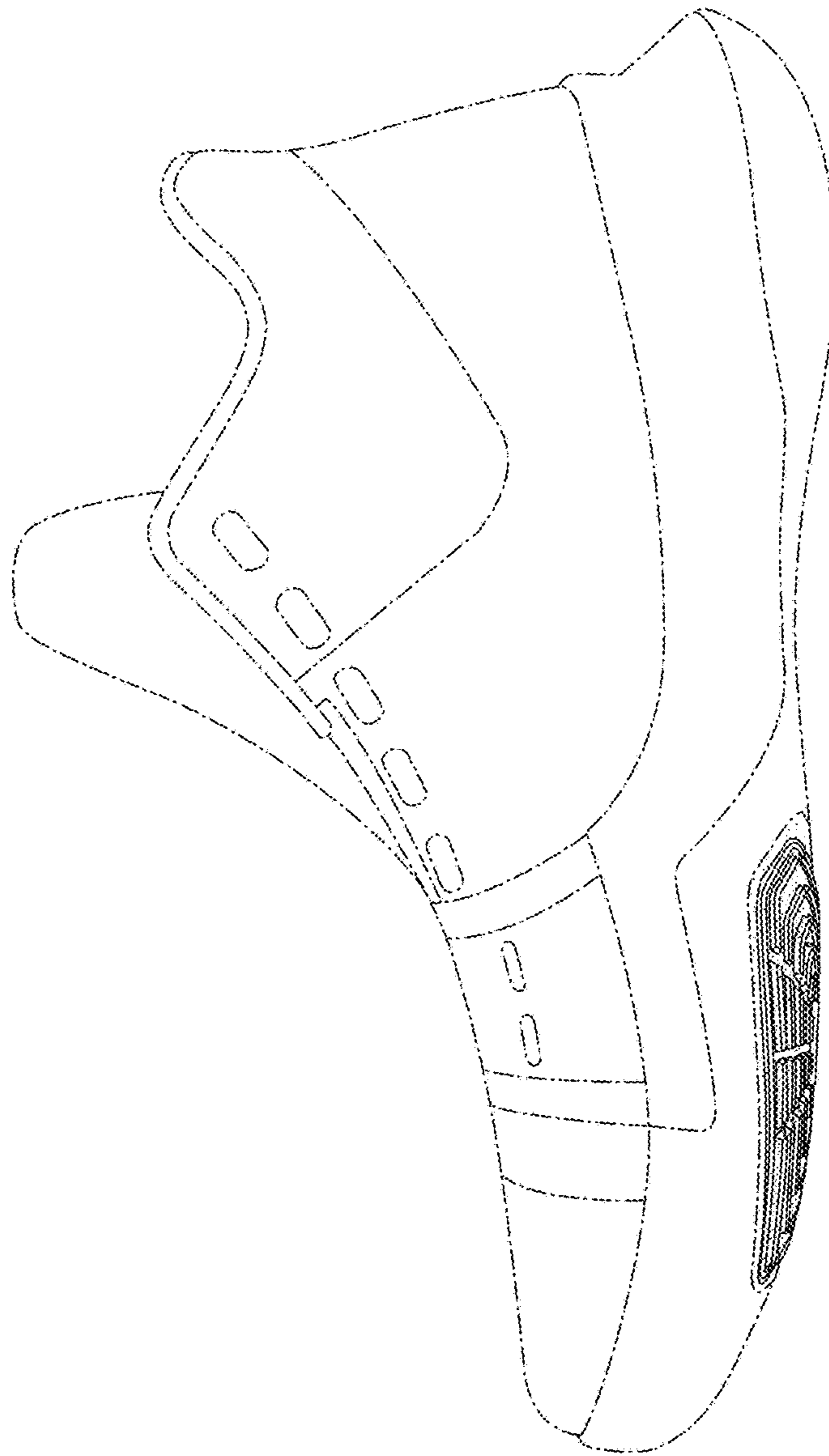

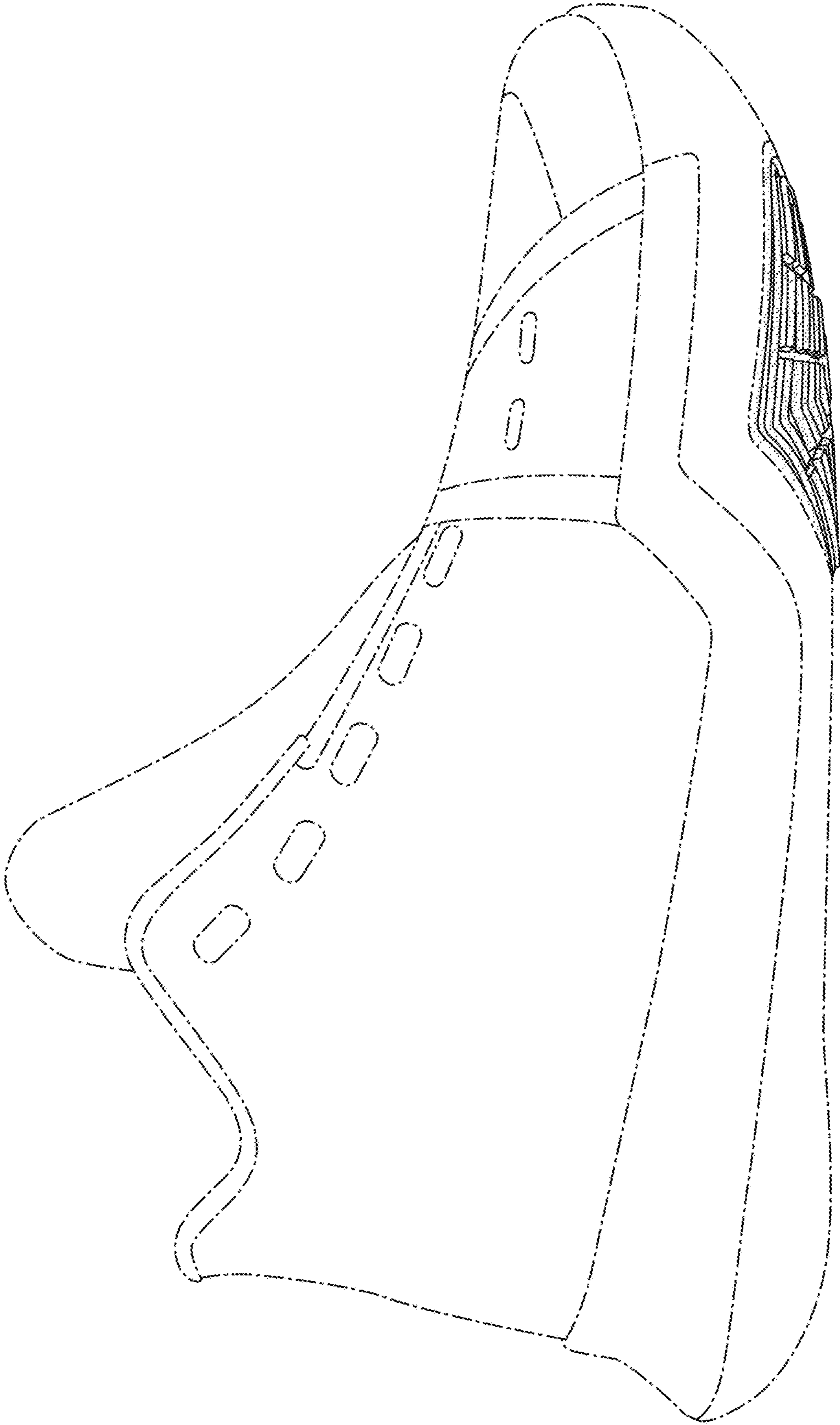

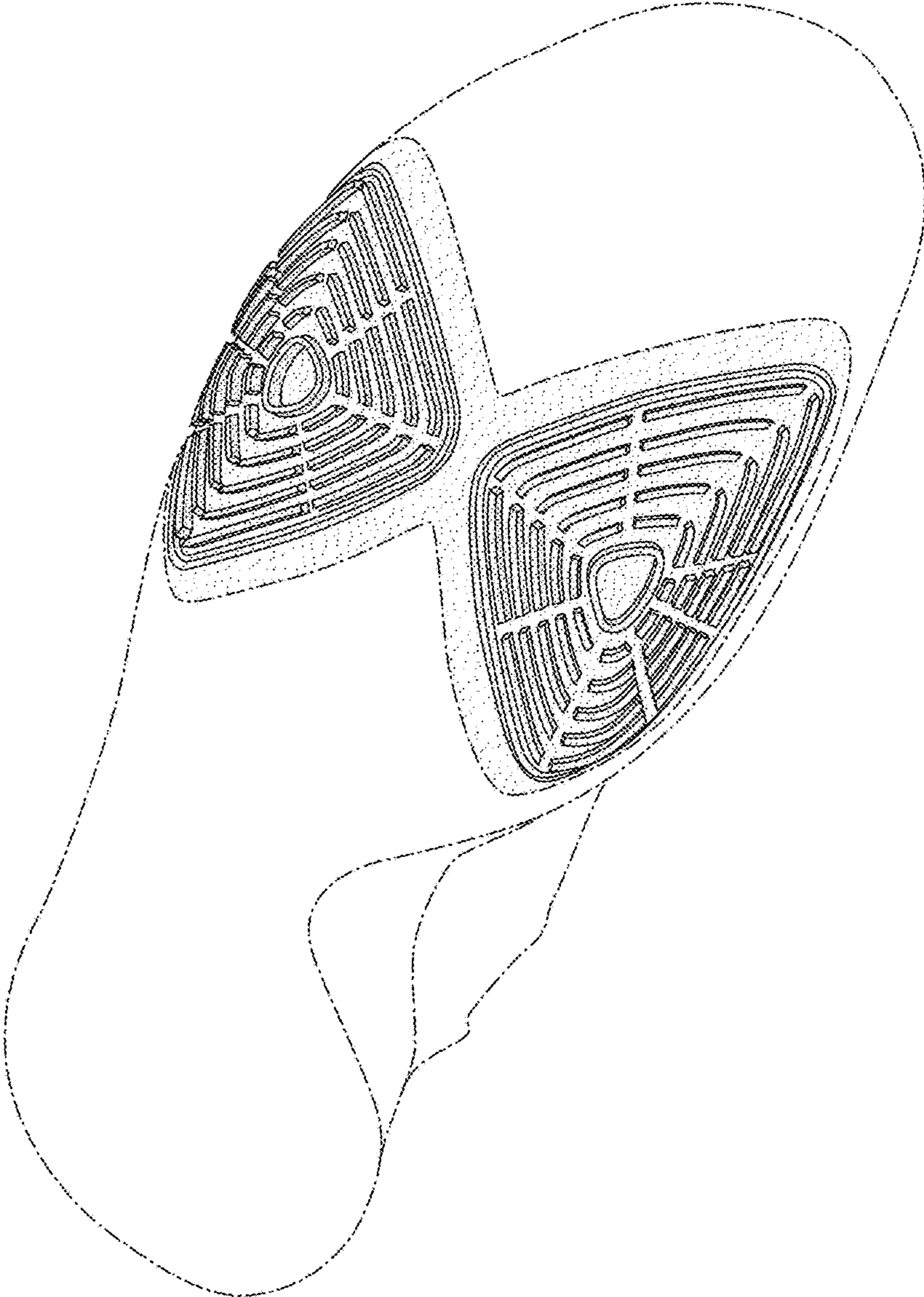

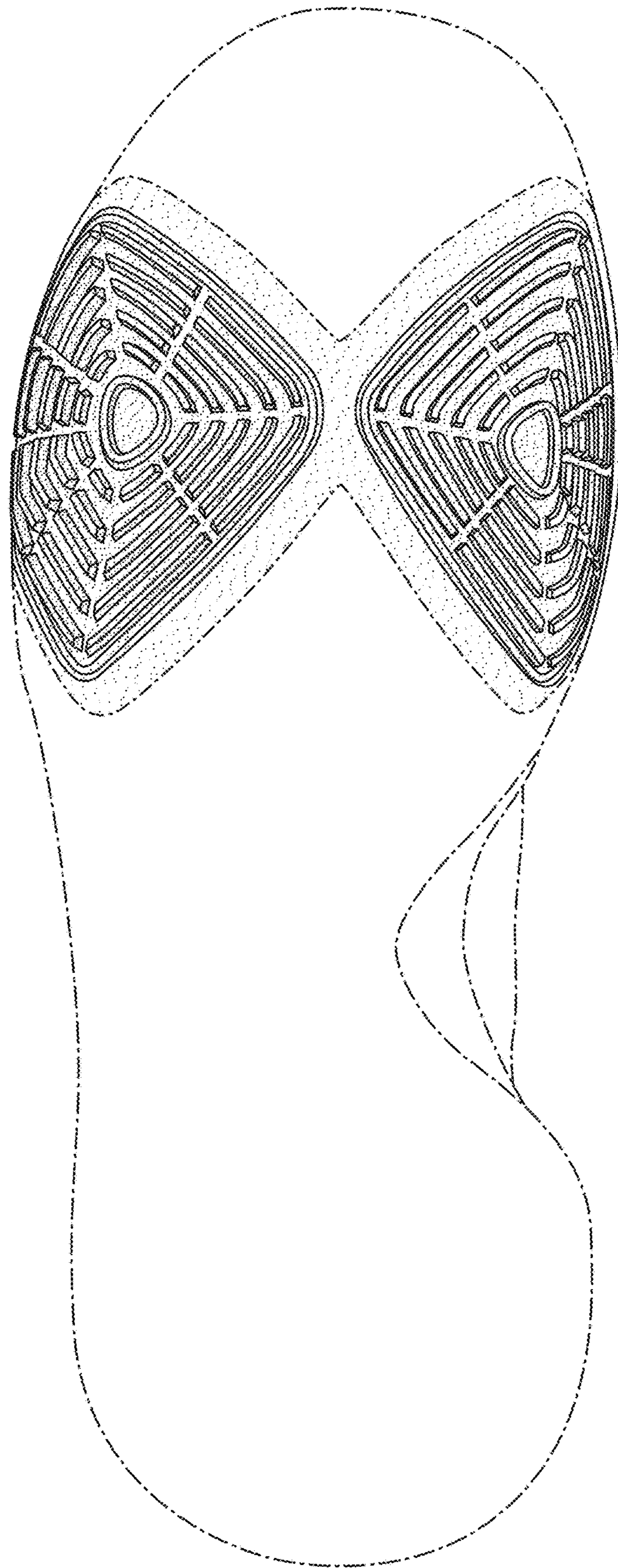

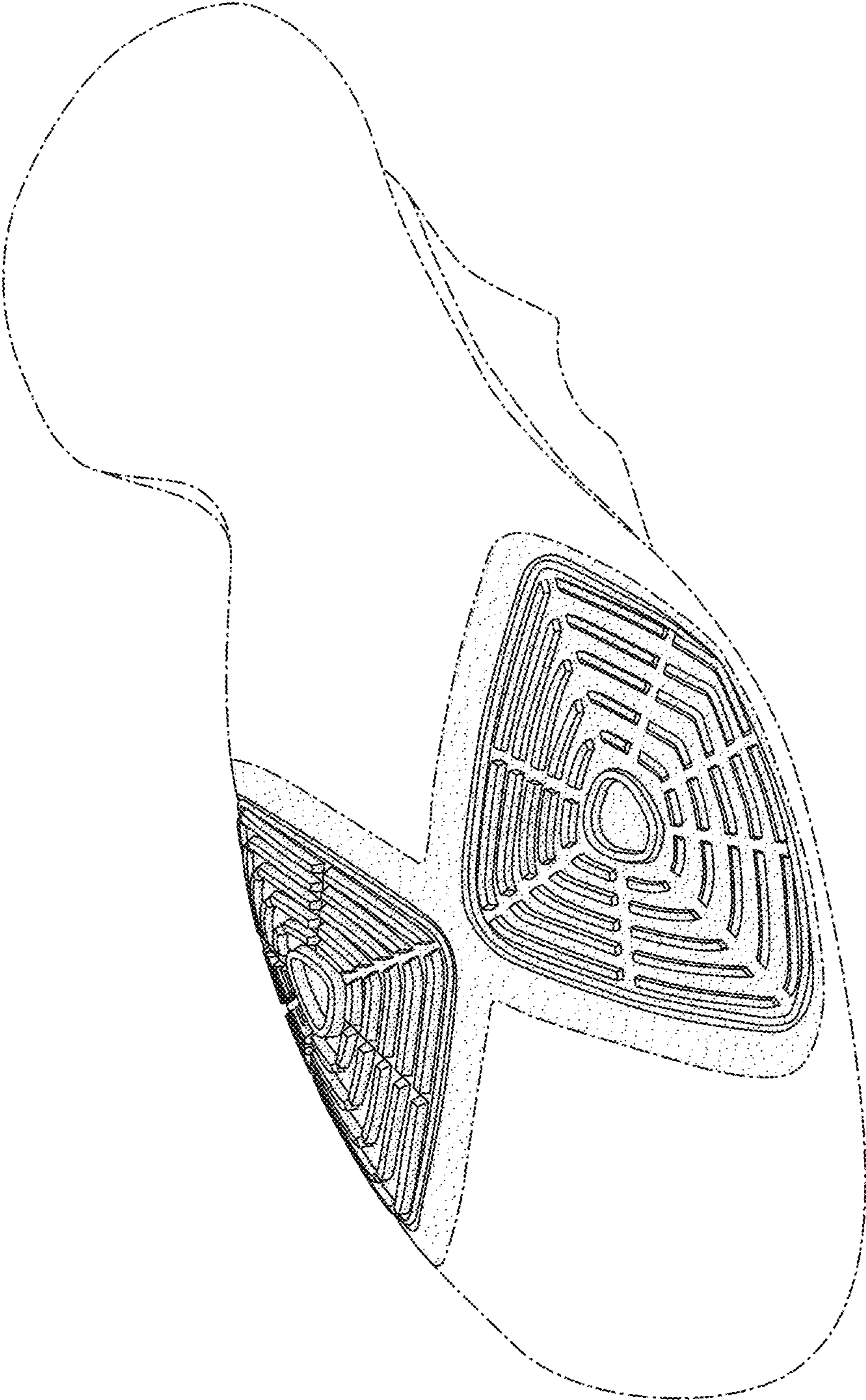
