(57) **CLAIM**

I claim the ornamental design for a bag for kendo gear, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bag for kendo gear in accordance with the present design, shown with a strap in a closed position;  
FIG. 2 is a front elevation view of the bag for kendo gear of FIG. 1;  
FIG. 3 is a rear elevation view of the bag for kendo gear of FIG. 1;  
FIG. 4 is a left side elevation view of the bag for kendo gear of FIG. 1;  
FIG. 5 is a right side elevation view of the bag for kendo gear of FIG. 1;  
FIG. 6 is a top plan view of the bag for kendo gear of FIG. 1;  
FIG. 7 is a bottom plan view of the bag for kendo gear of FIG. 1;  
FIG. 8 is a partial rear perspective view of the bag for kendo gear of FIG. 1; and,  
FIG. 9 is another partial rear perspective view of the bag for kendo gear, shown with the strap in an extended position.
