(57) **CLAIM**

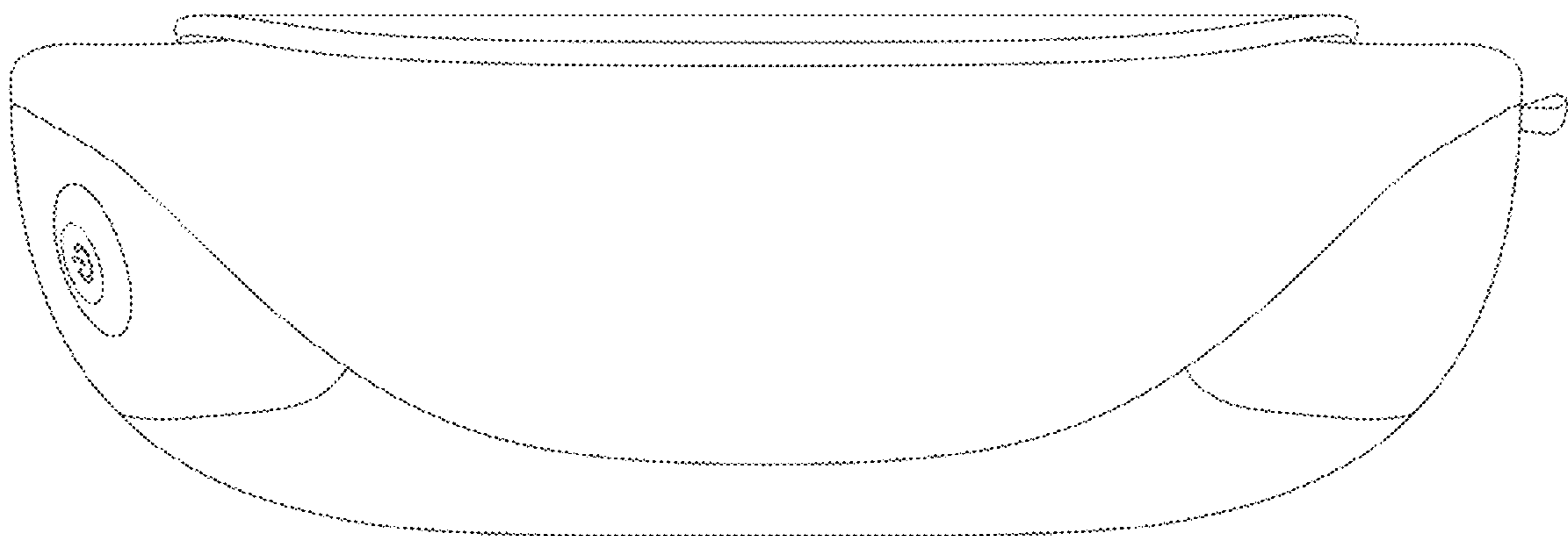
We claim the ornamental design for a massage pillow, as shown and described.

DESCRIPTION

FIG. 1 is a bottom side elevation view of the massage pillow. FIG. 2 is a top side elevation view of the massage pillow. FIG. 3 is a front side elevation view of the massage pillow. FIG. 4 is a rear side elevation view of the massage pillow. FIG. 5 is a left side elevation view of the massage pillow. FIG. 6 is a right side elevation view of the massage pillow. FIG. 7 is a perspective view showing the front and left elevation of the massage pillow; and, FIG. 8 is a perspective view showing the top, front, and left flat elevation of the massage pillow.

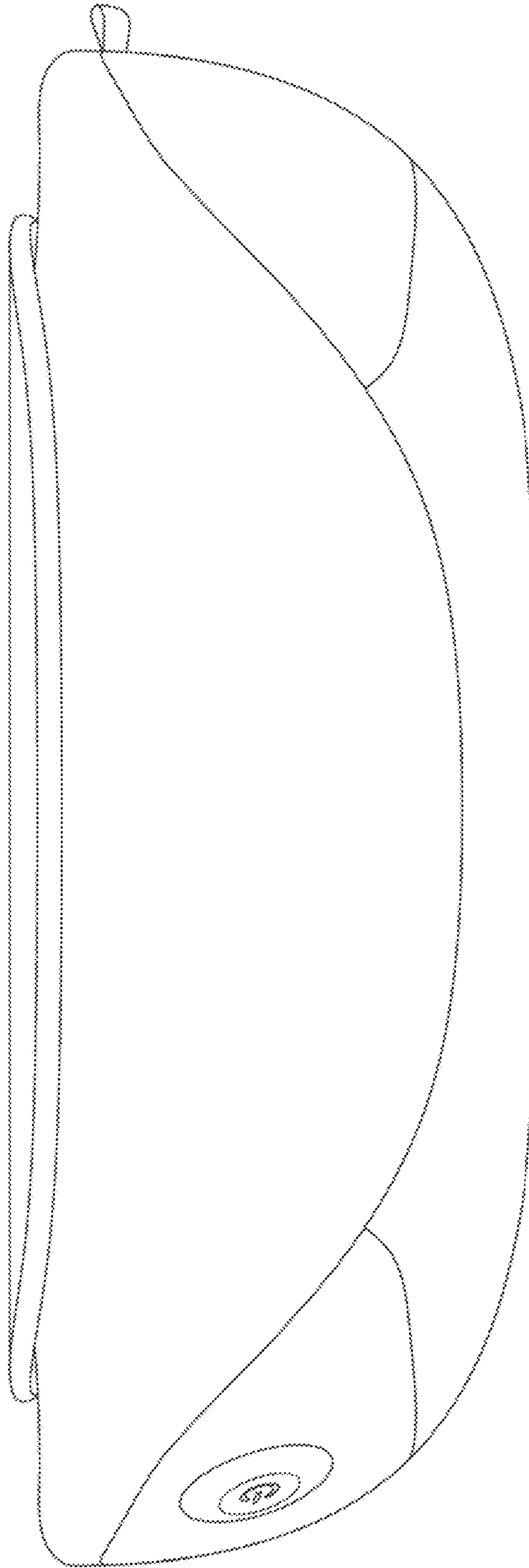

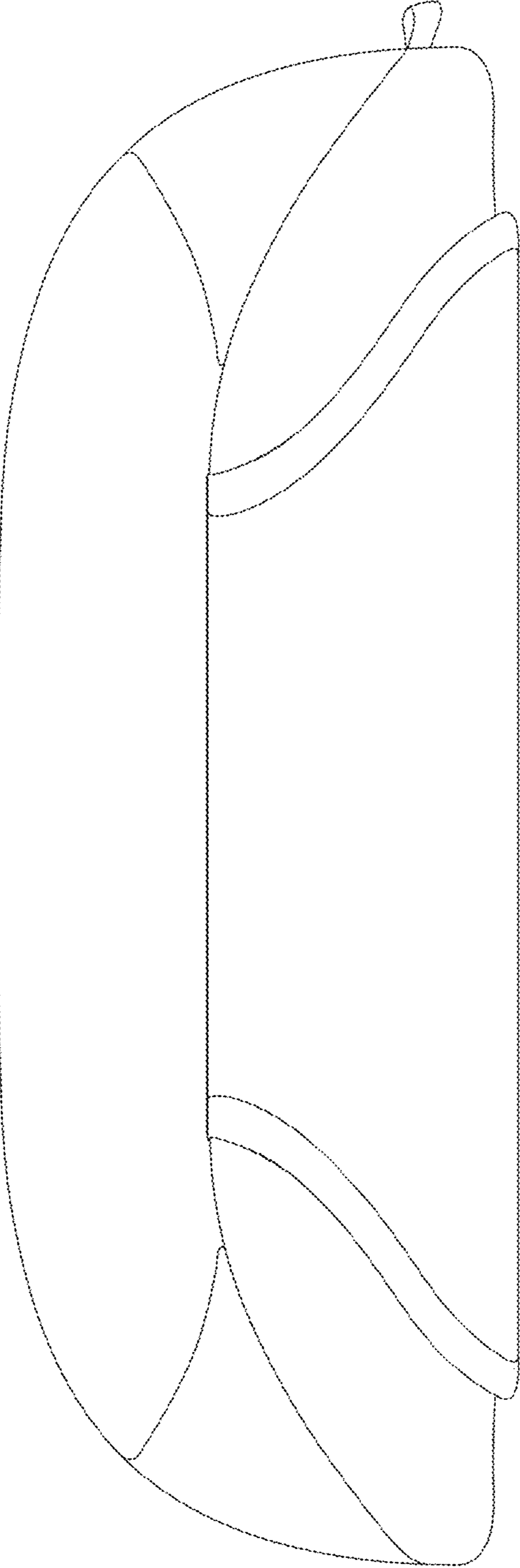

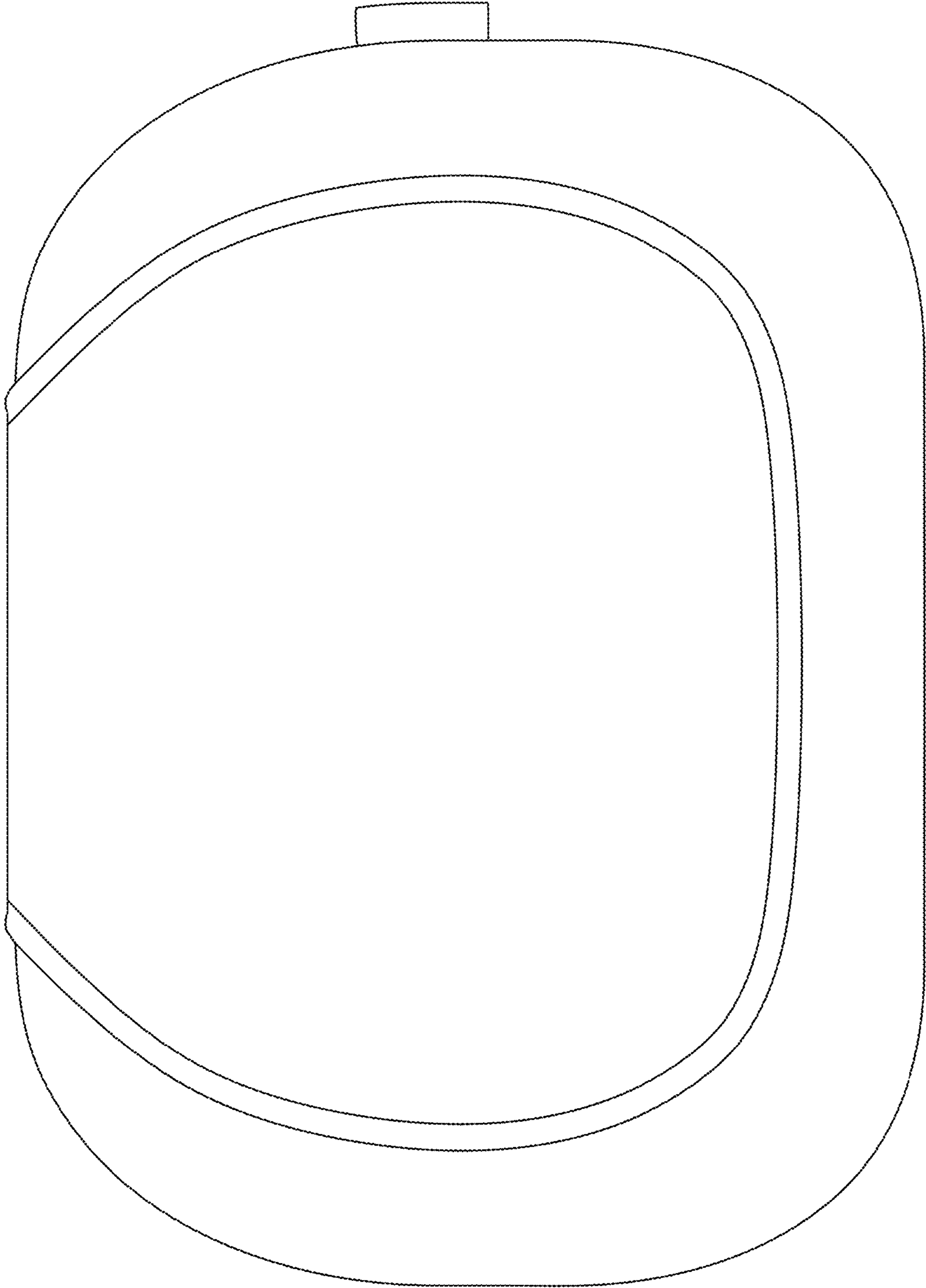

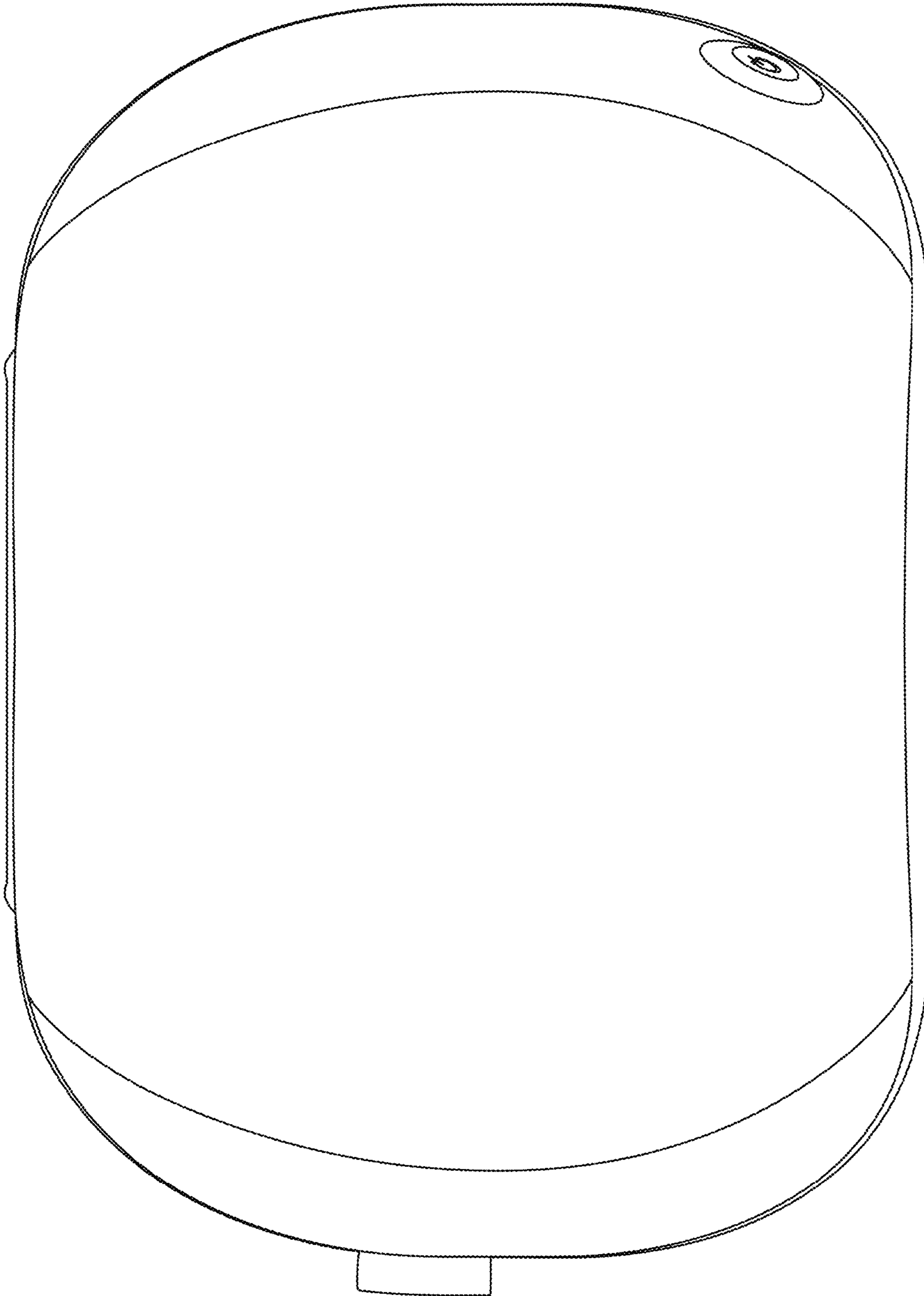

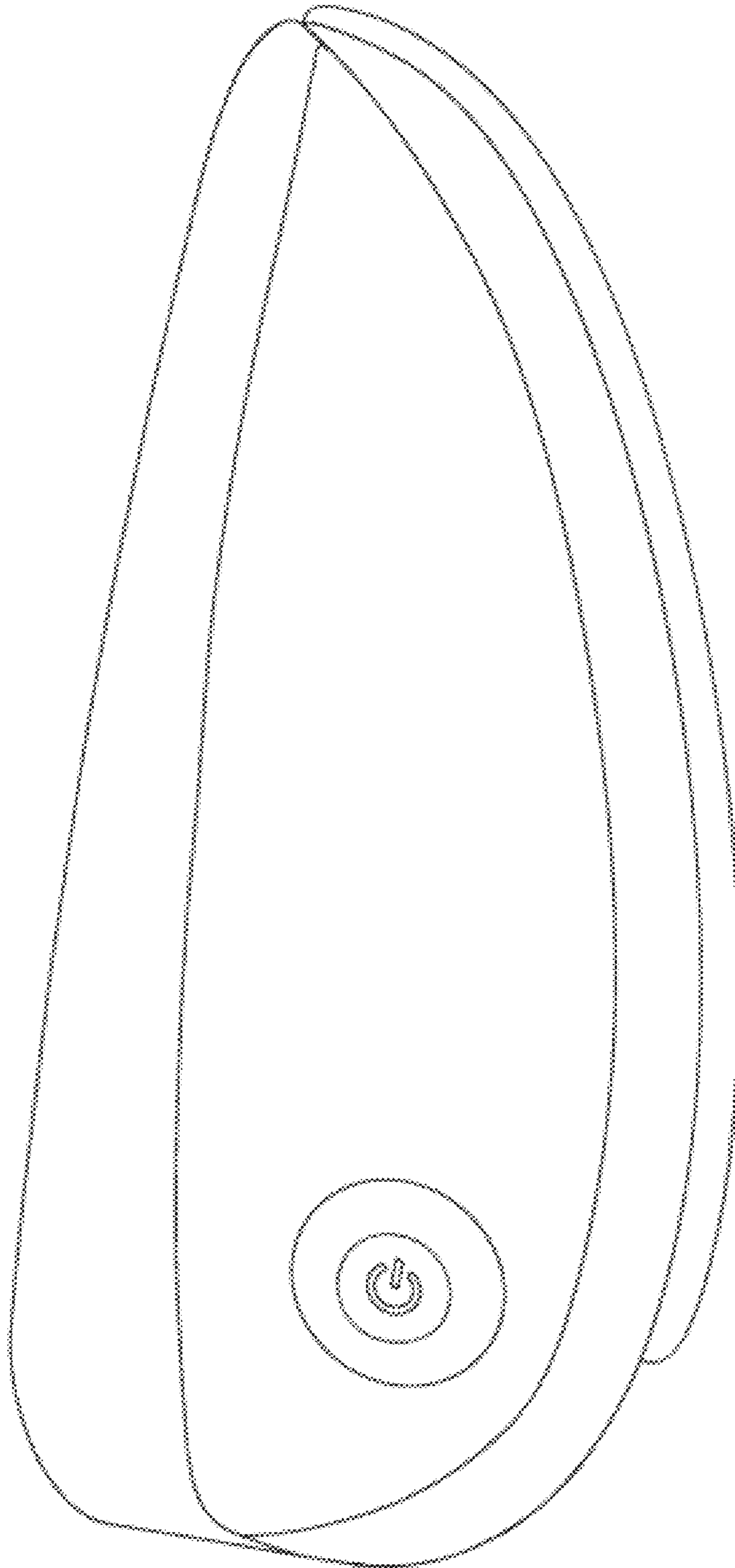

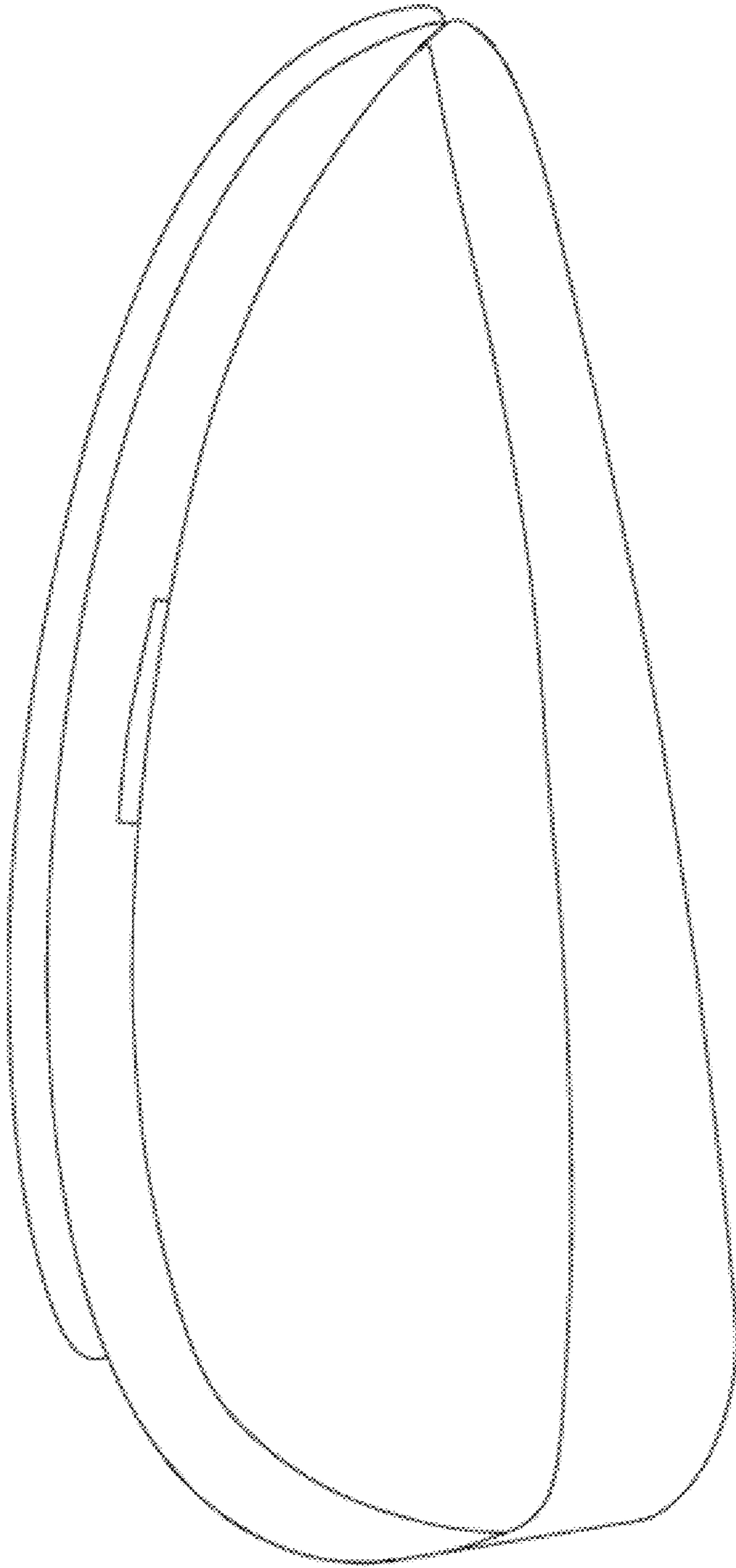

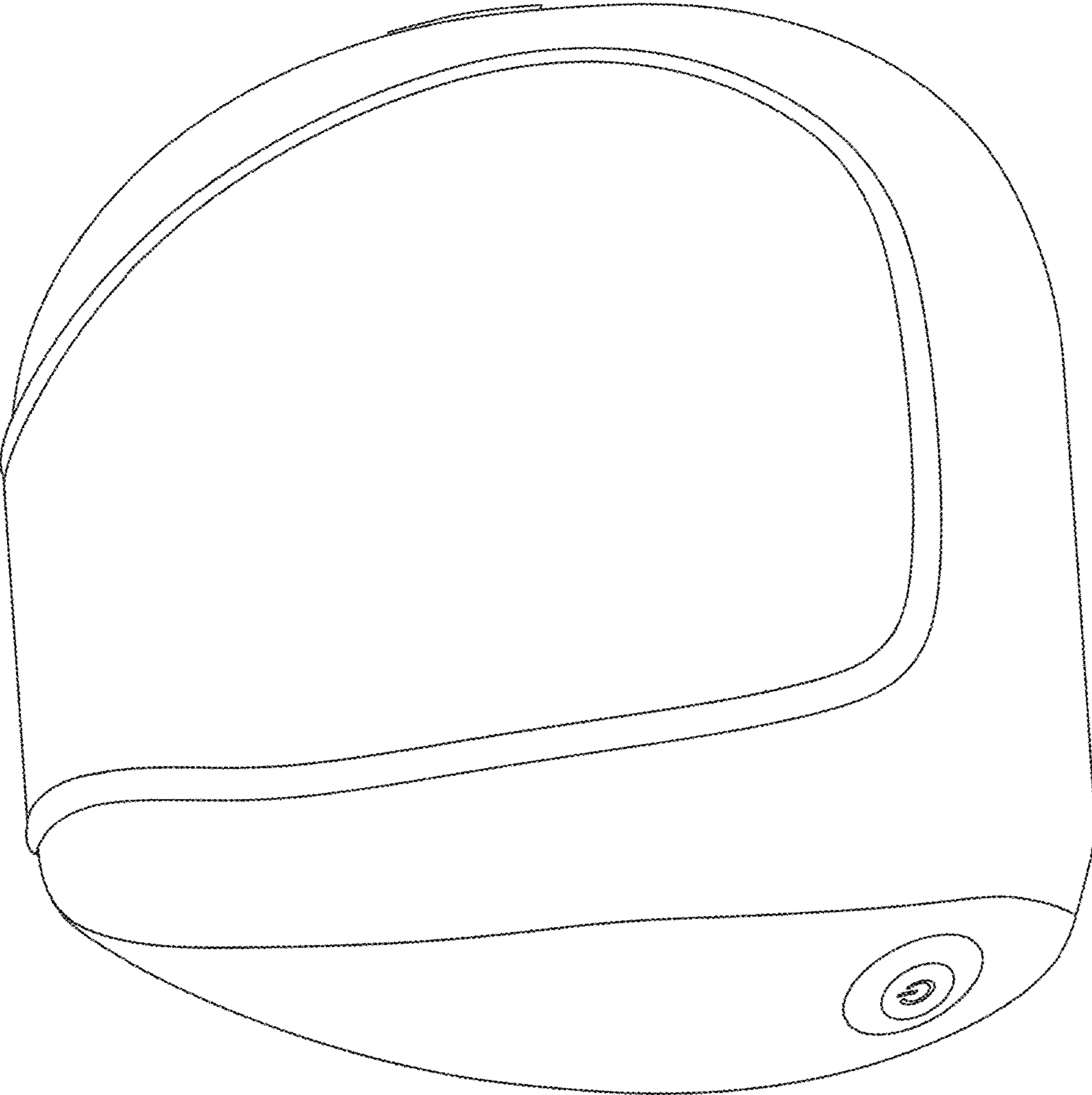

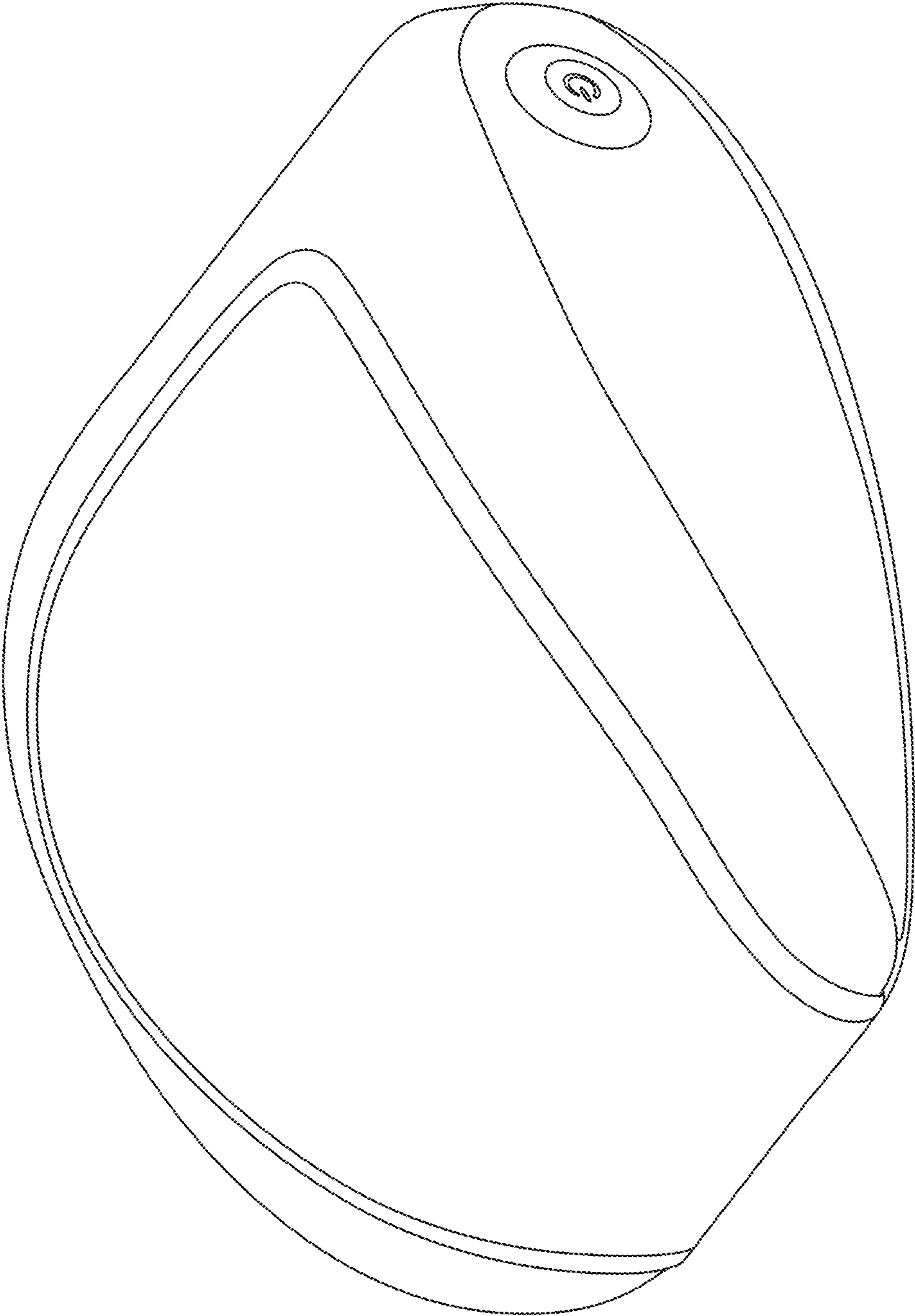
