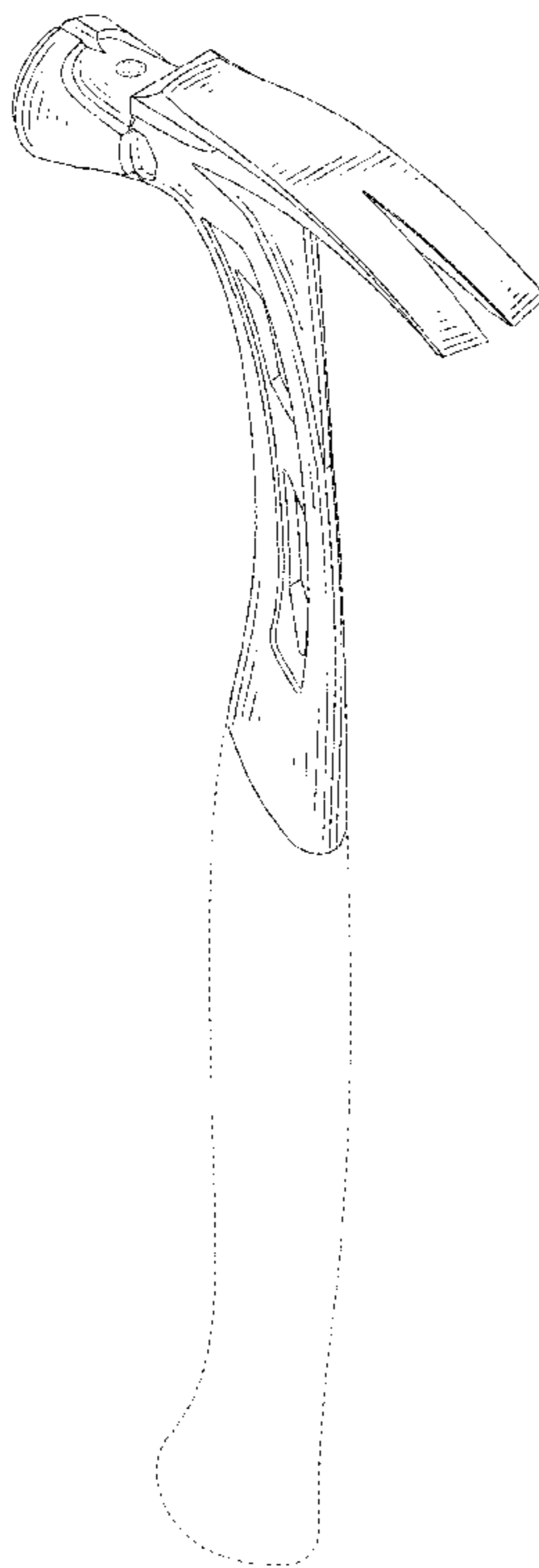
The ornamental design for a hammer, as shown and described.

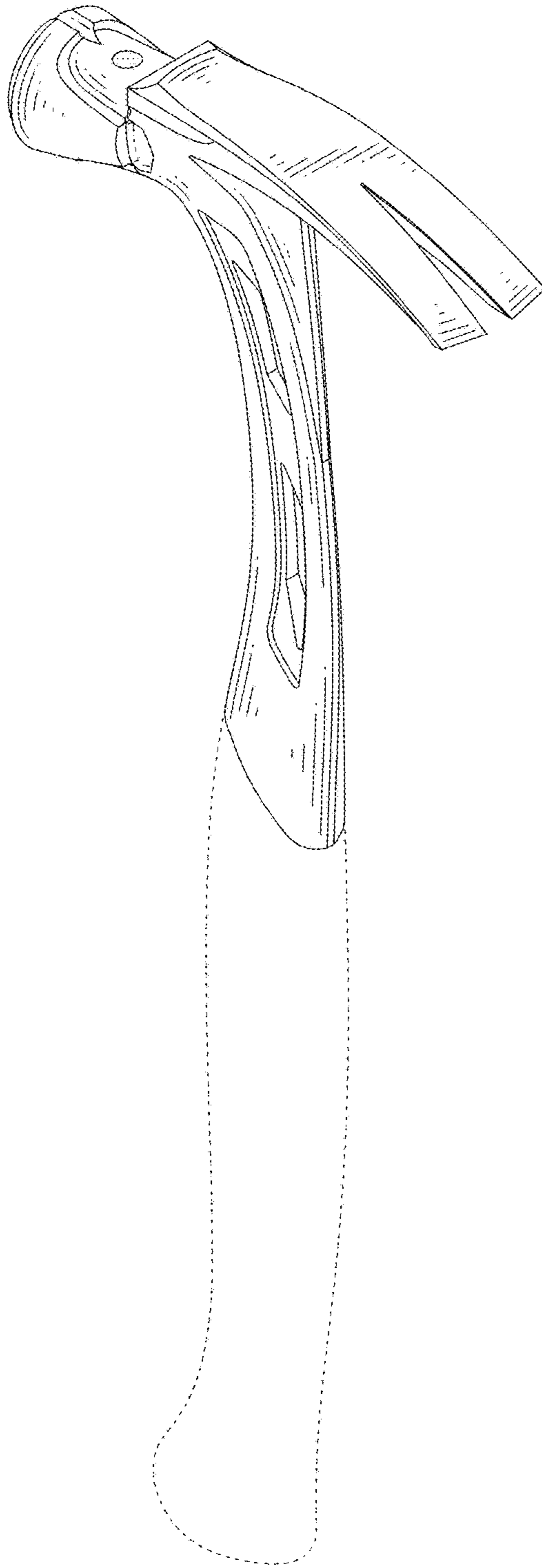

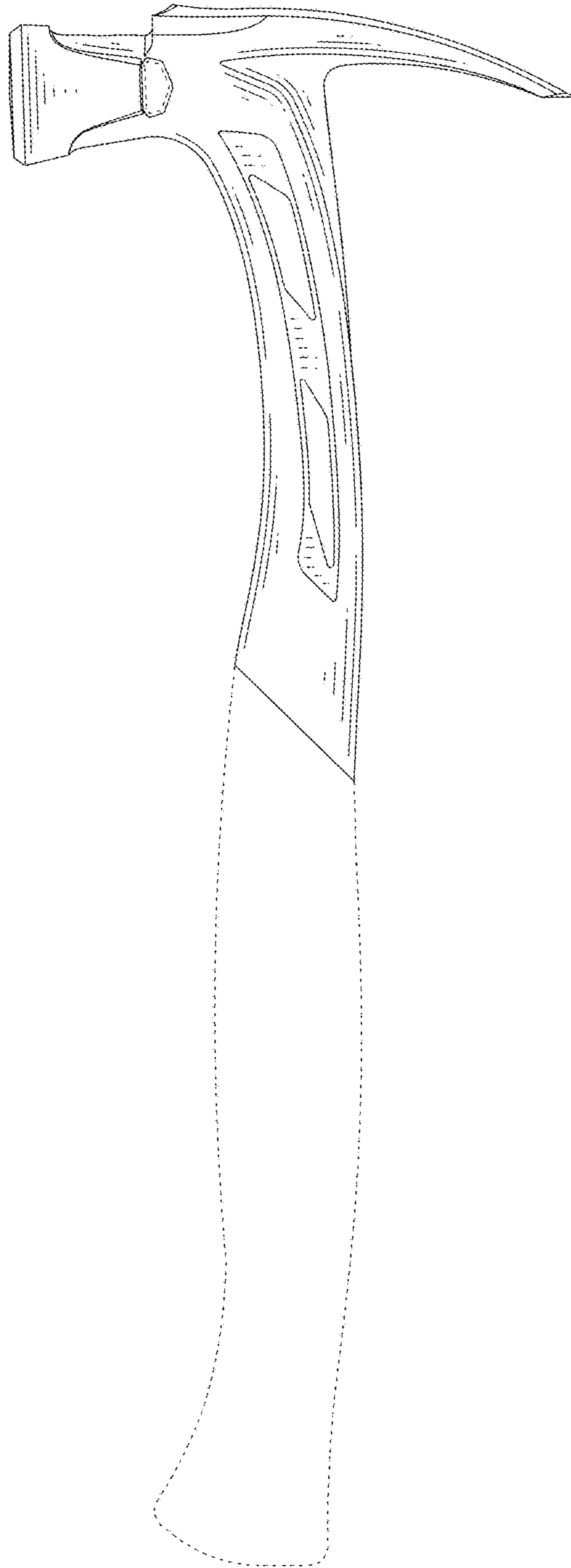

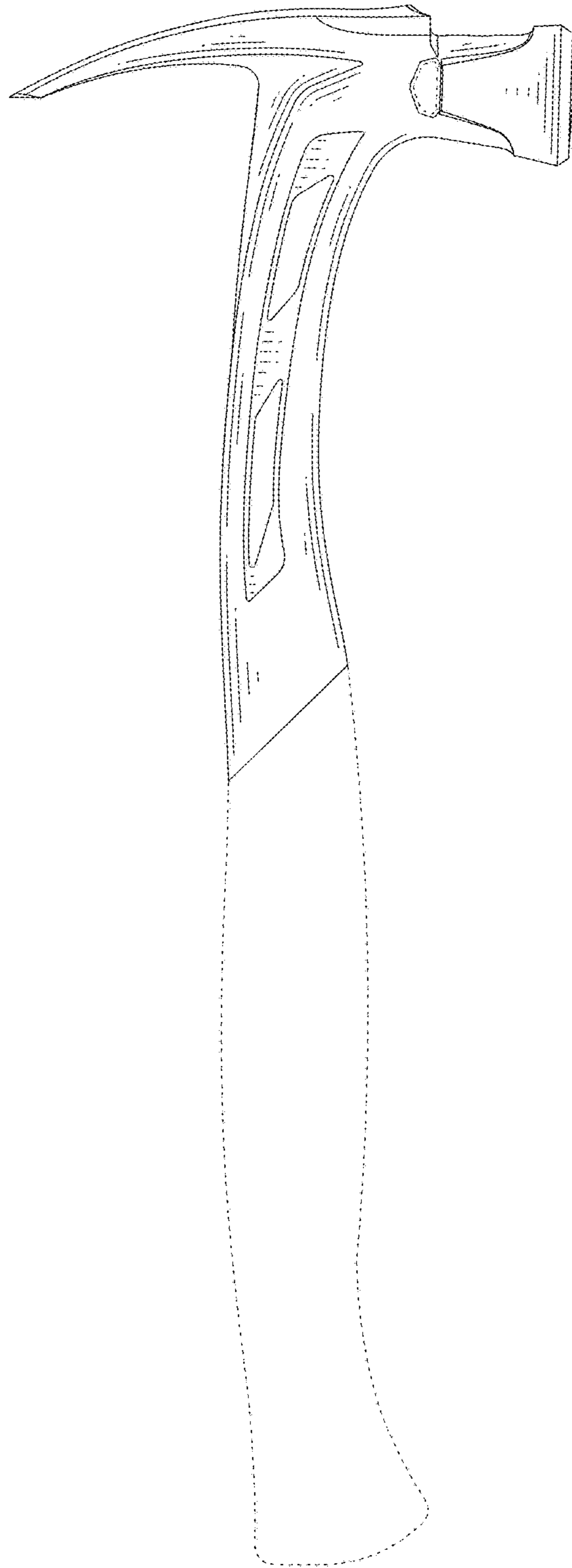

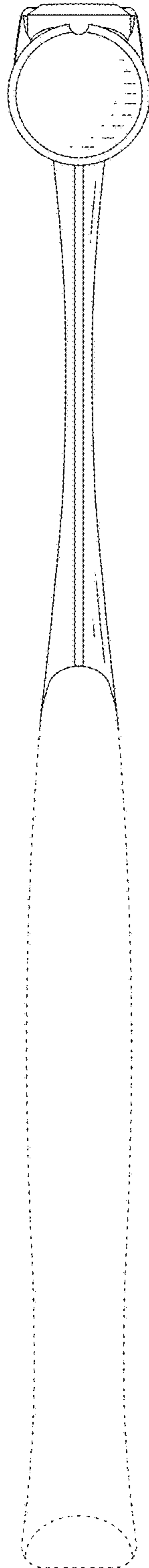

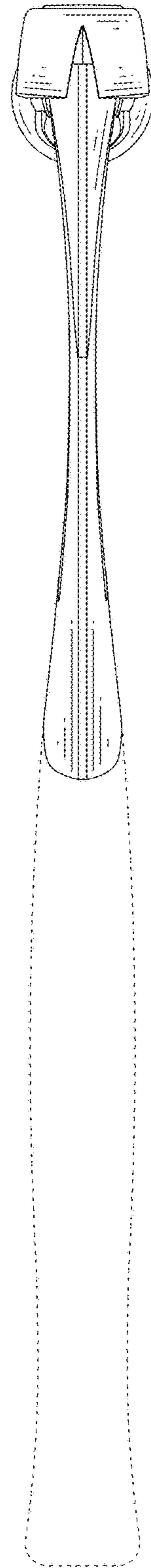

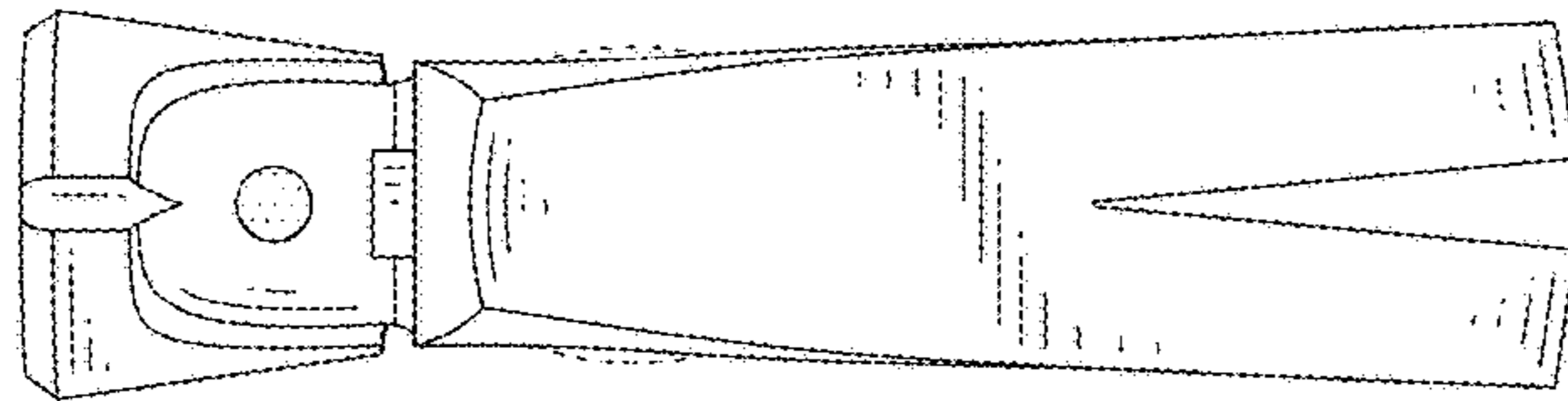

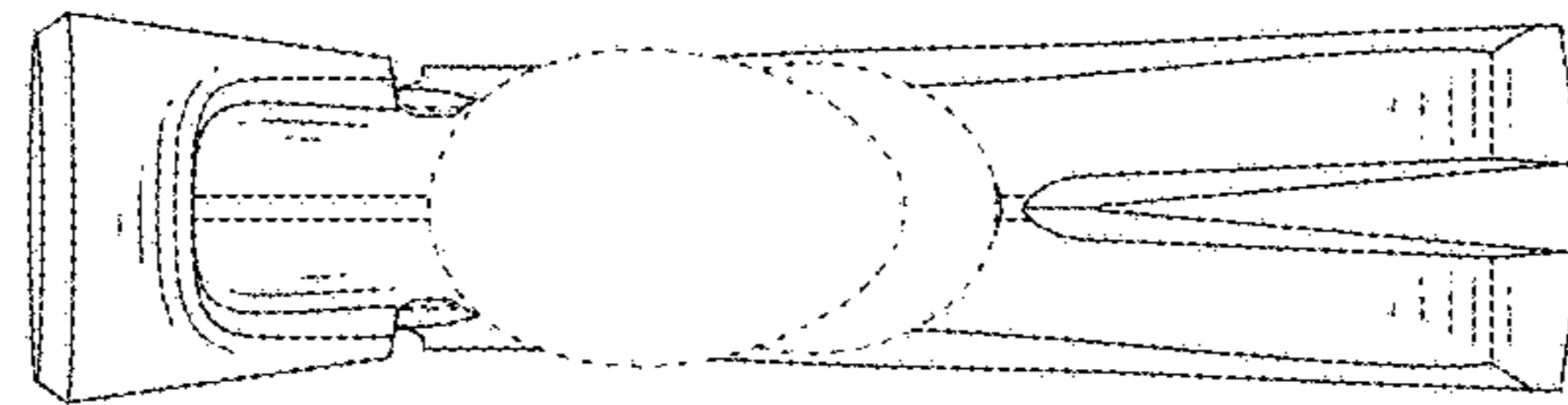
