(57) **CLAIM**

I claim the ornamental design for a food and beverage carrier, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a food and beverage carrier, showing my new design in a flat, unassembled configuration;

FIG. 2 is a perspective view thereof, illustrated in an assembled and open configuration;

FIG. 3 is a top plan view of FIG. 2;

FIG. 4 is a perspective view thereof, illustrated in an assembled and closed configuration;

FIG. 5 is a front elevational view of FIG. 4;

FIG. 6 is a rear elevational view of FIG. 4;

FIG. 7 is a left-side elevational view of FIG. 4;

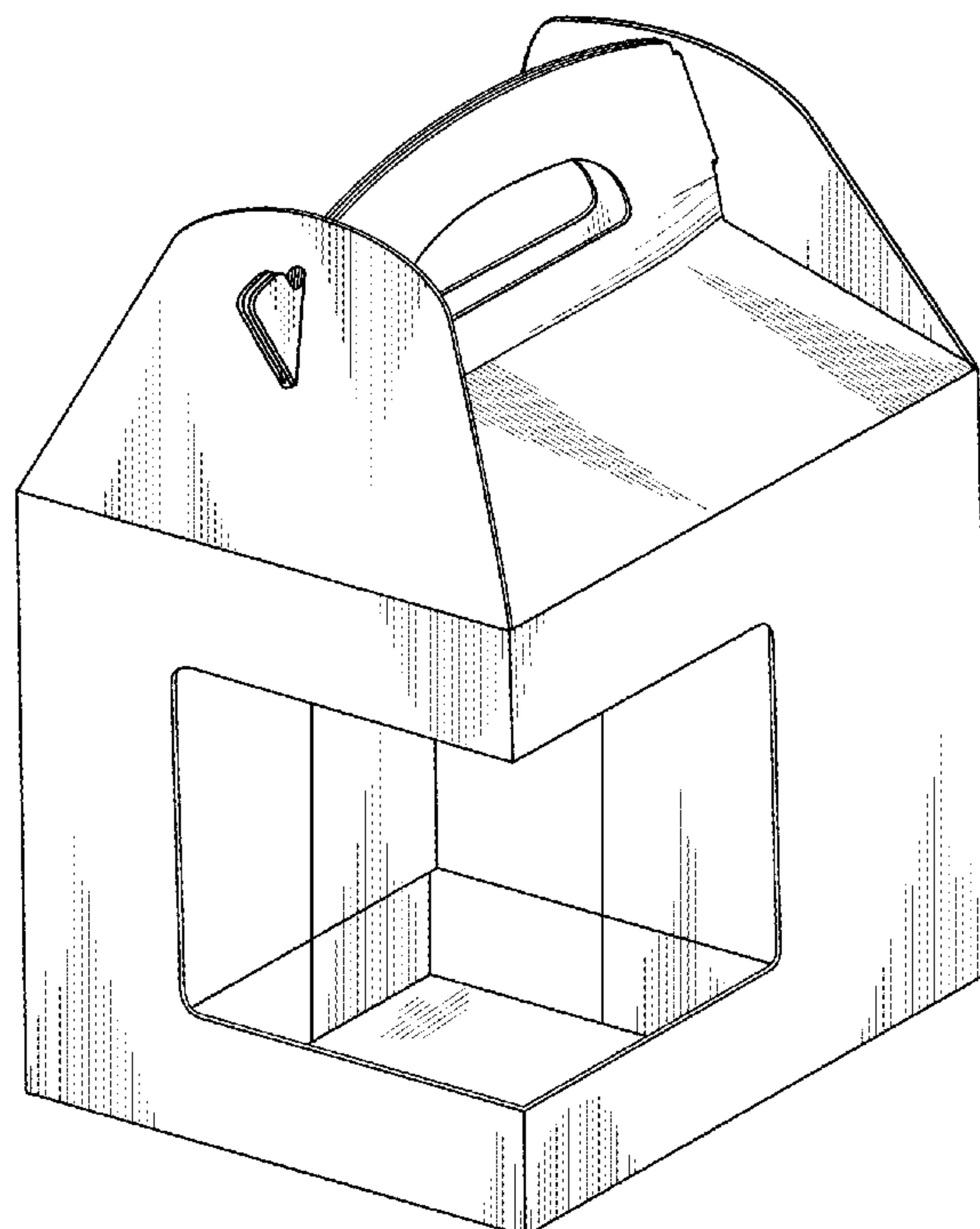
FIG. 8 is a right-side elevational view of FIG. 4;

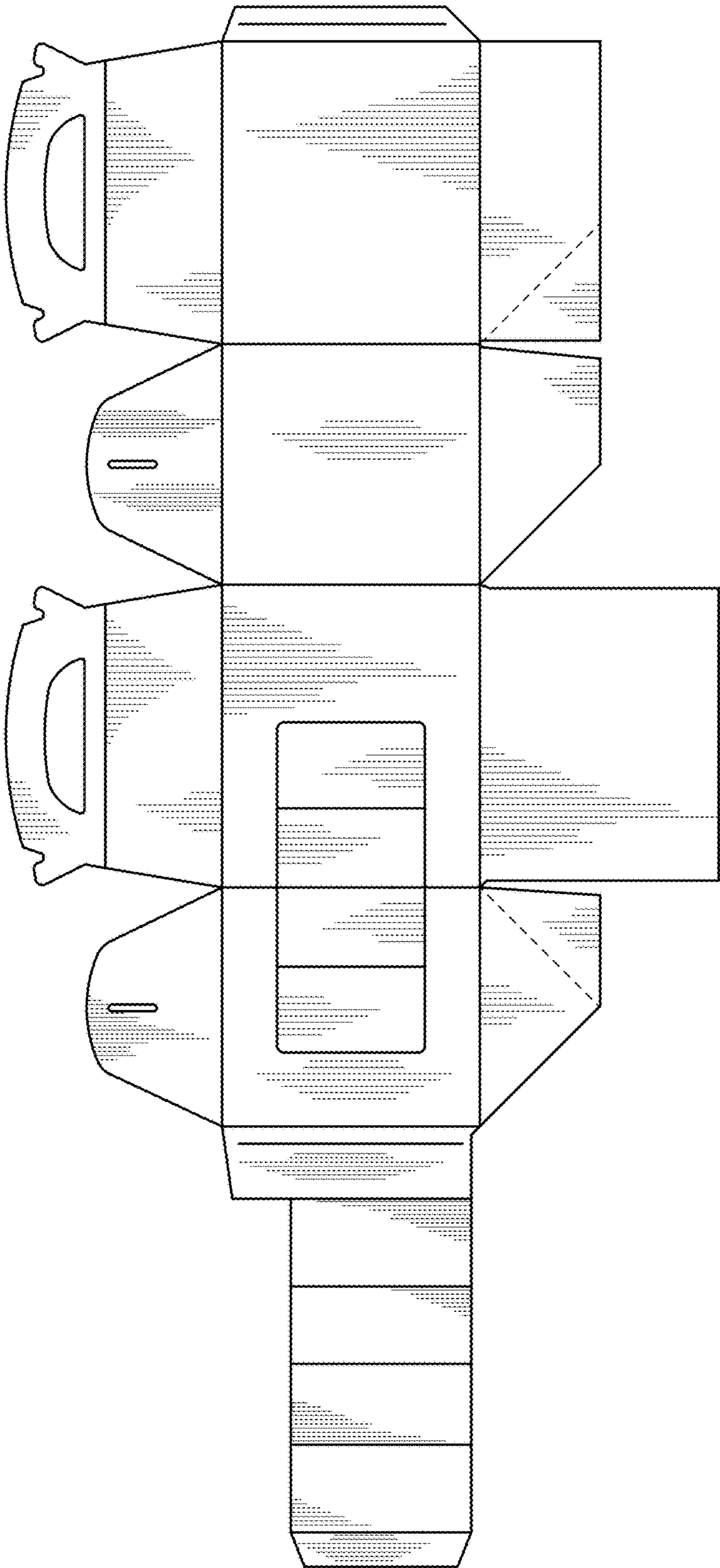

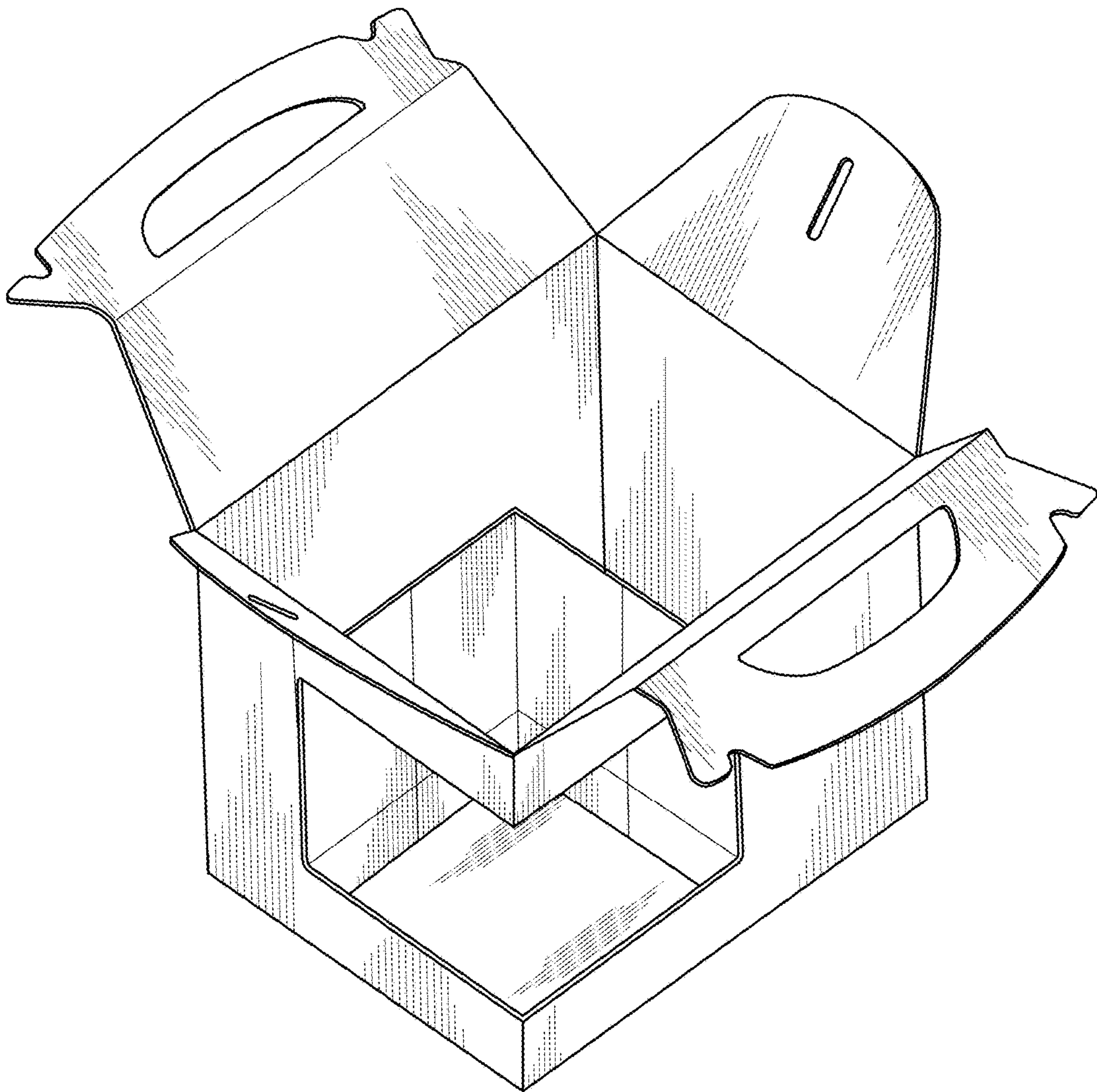

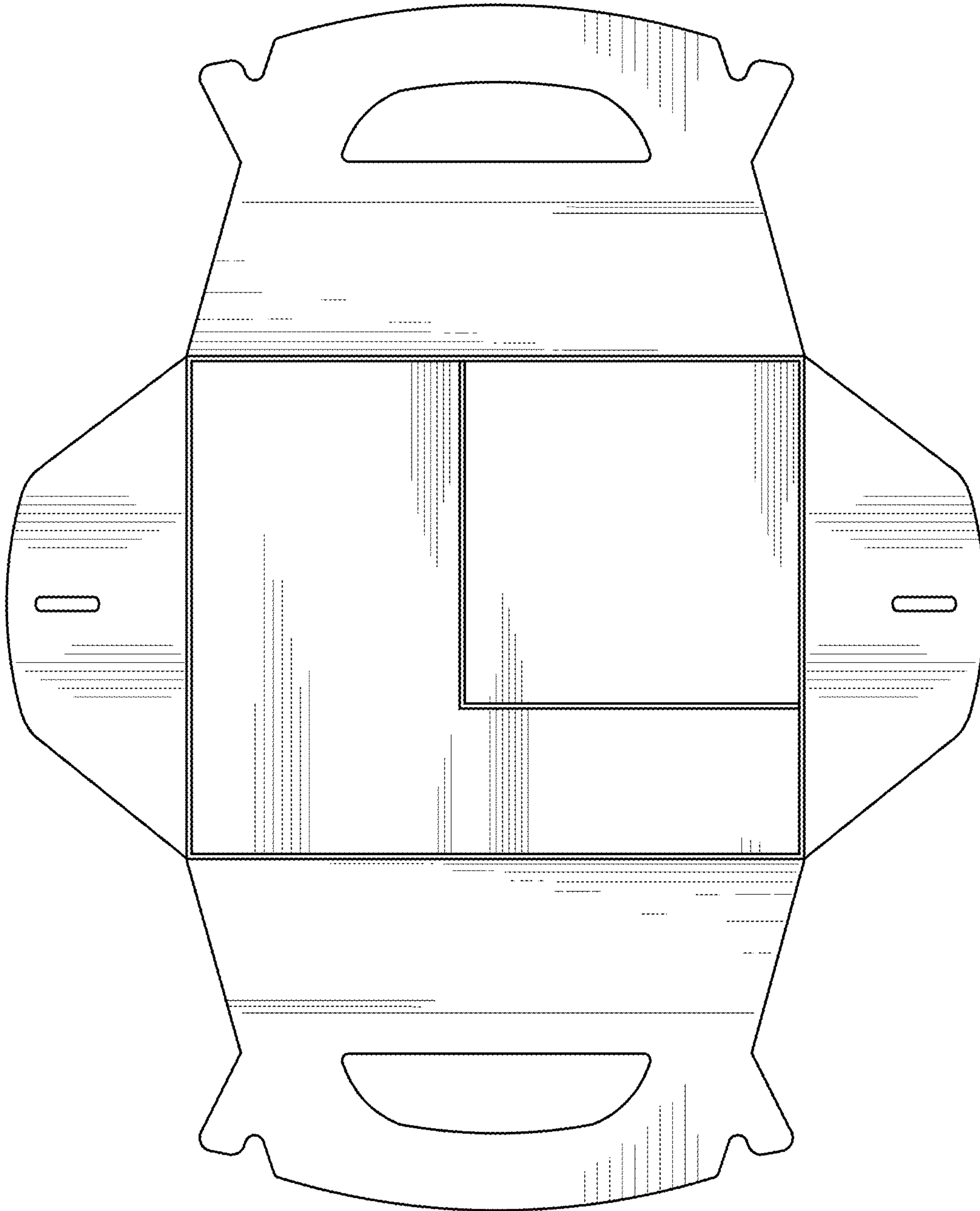

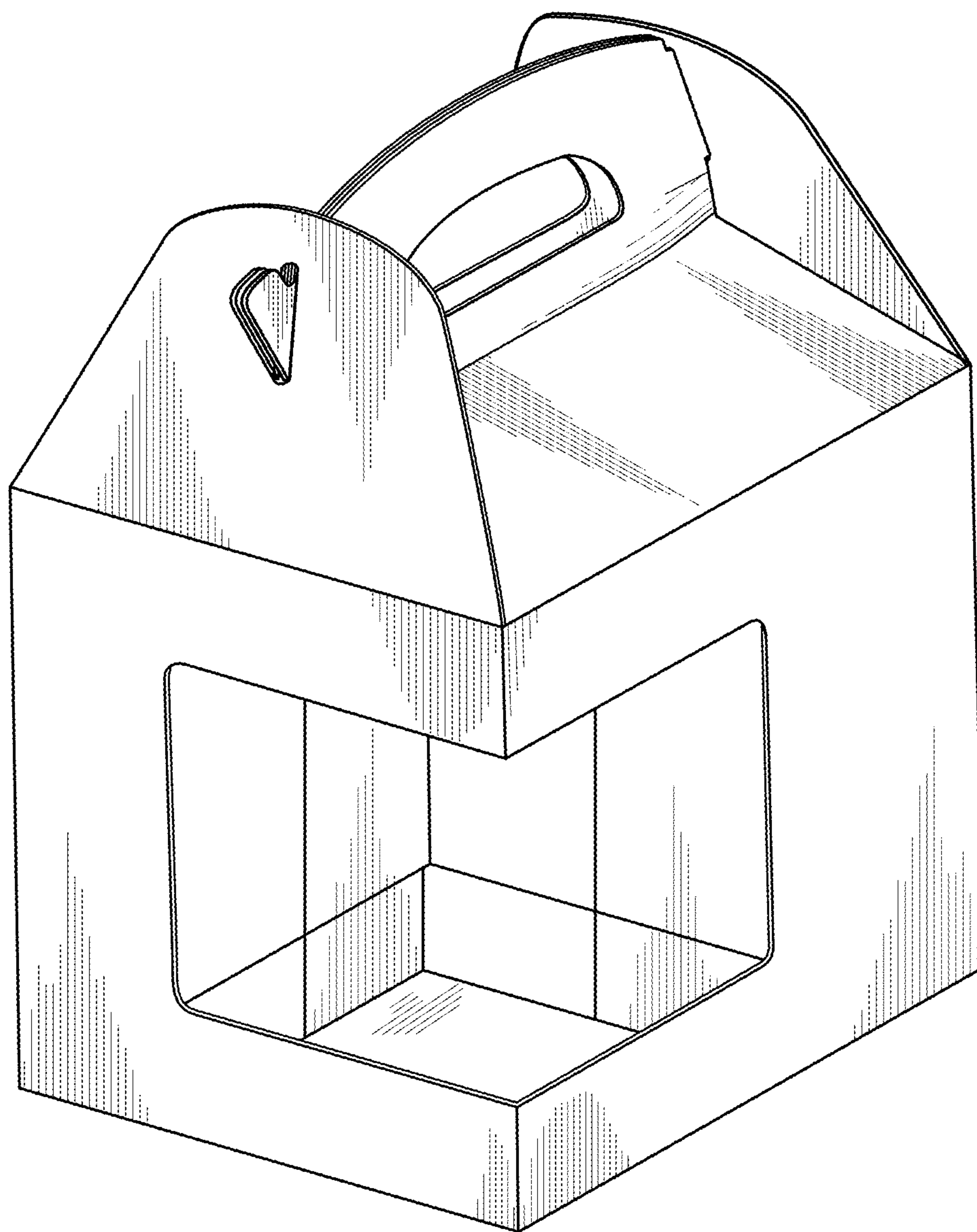

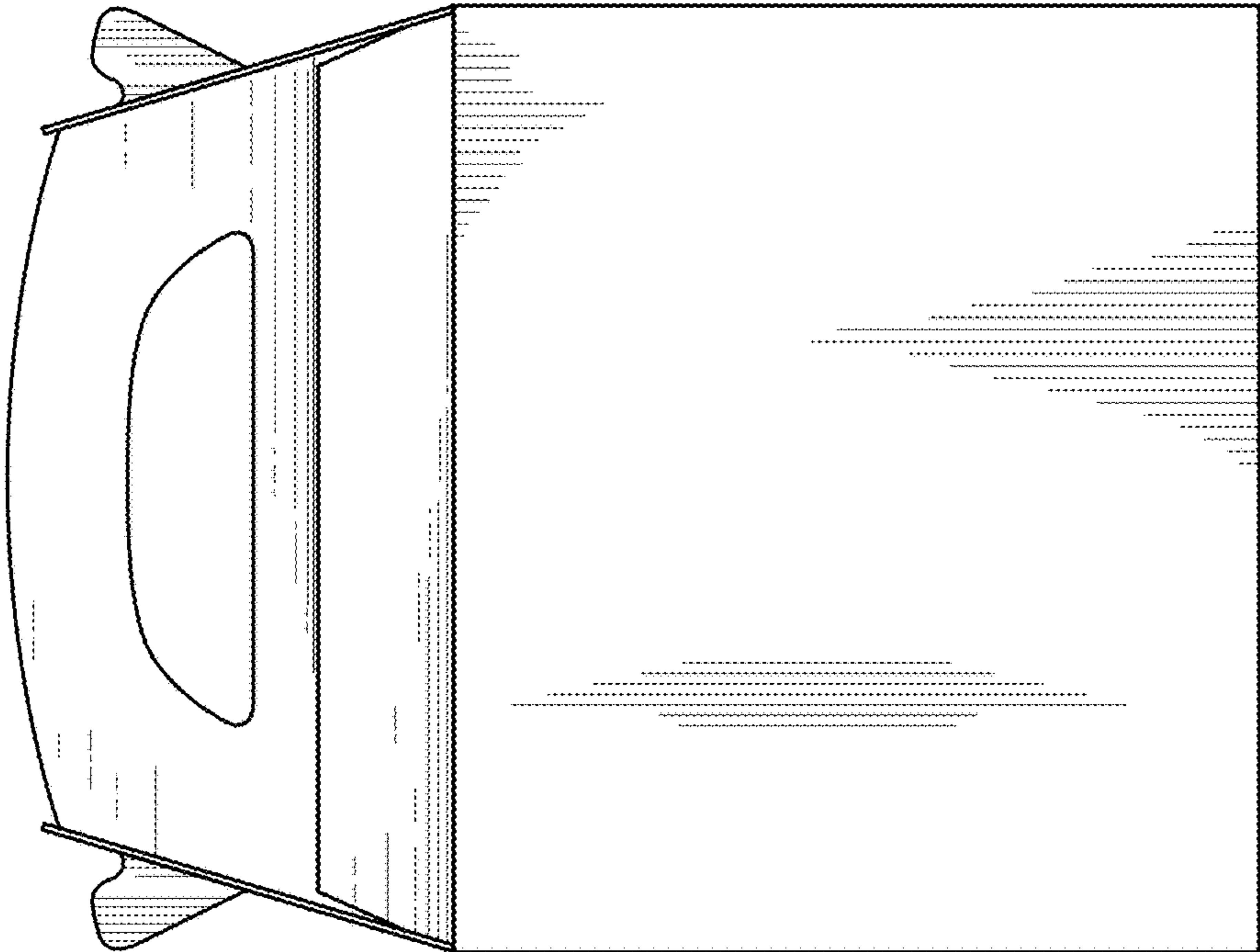

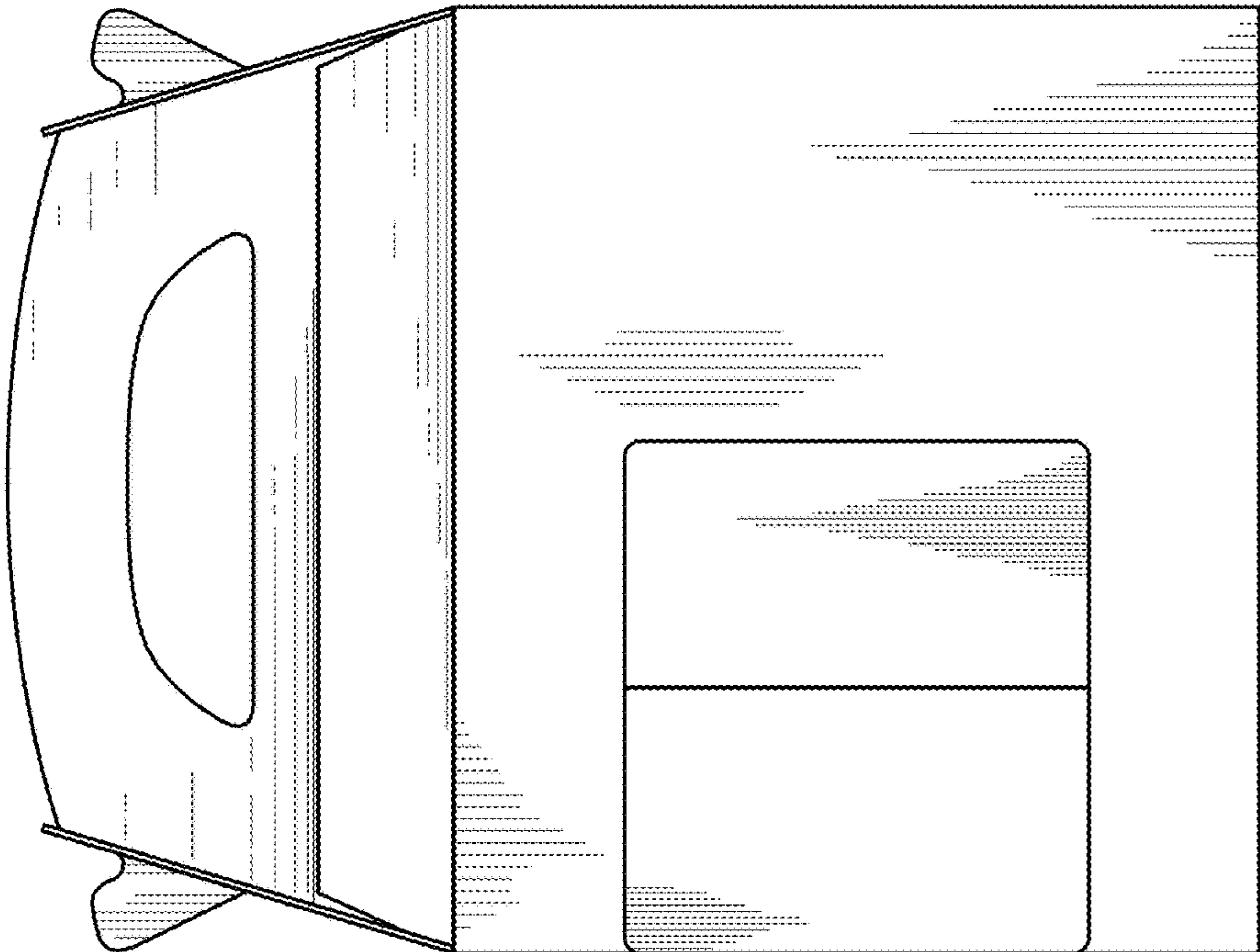

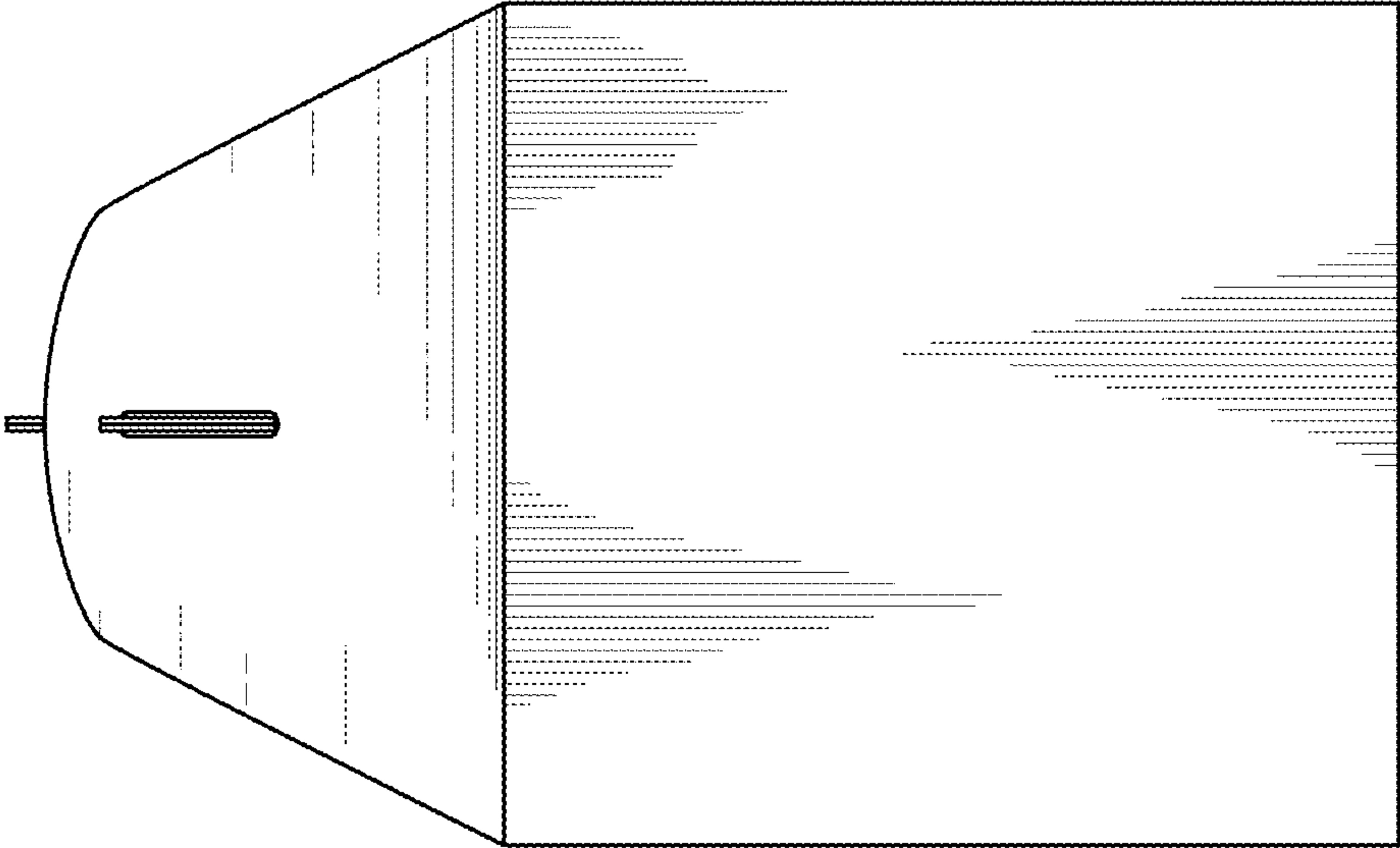

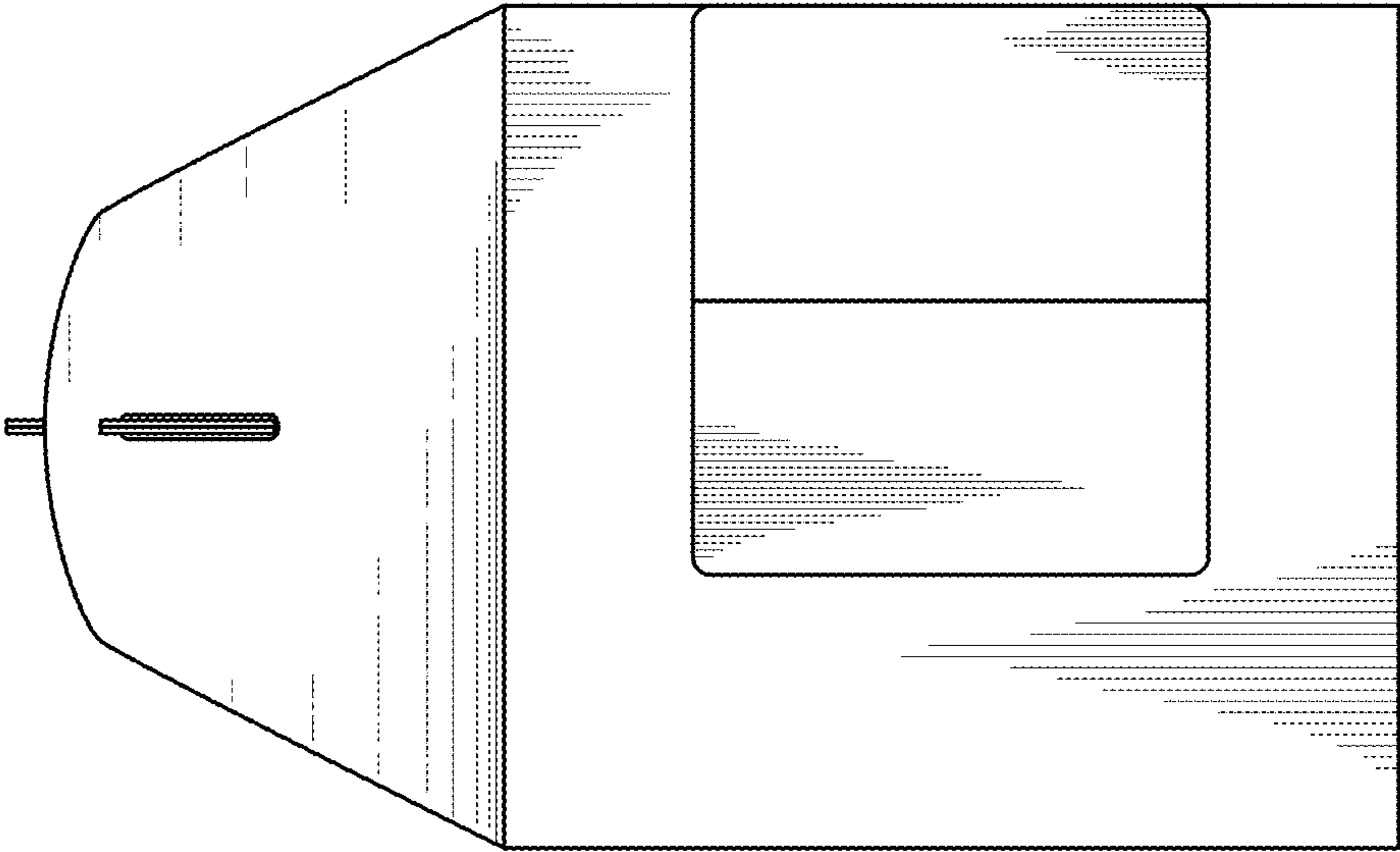

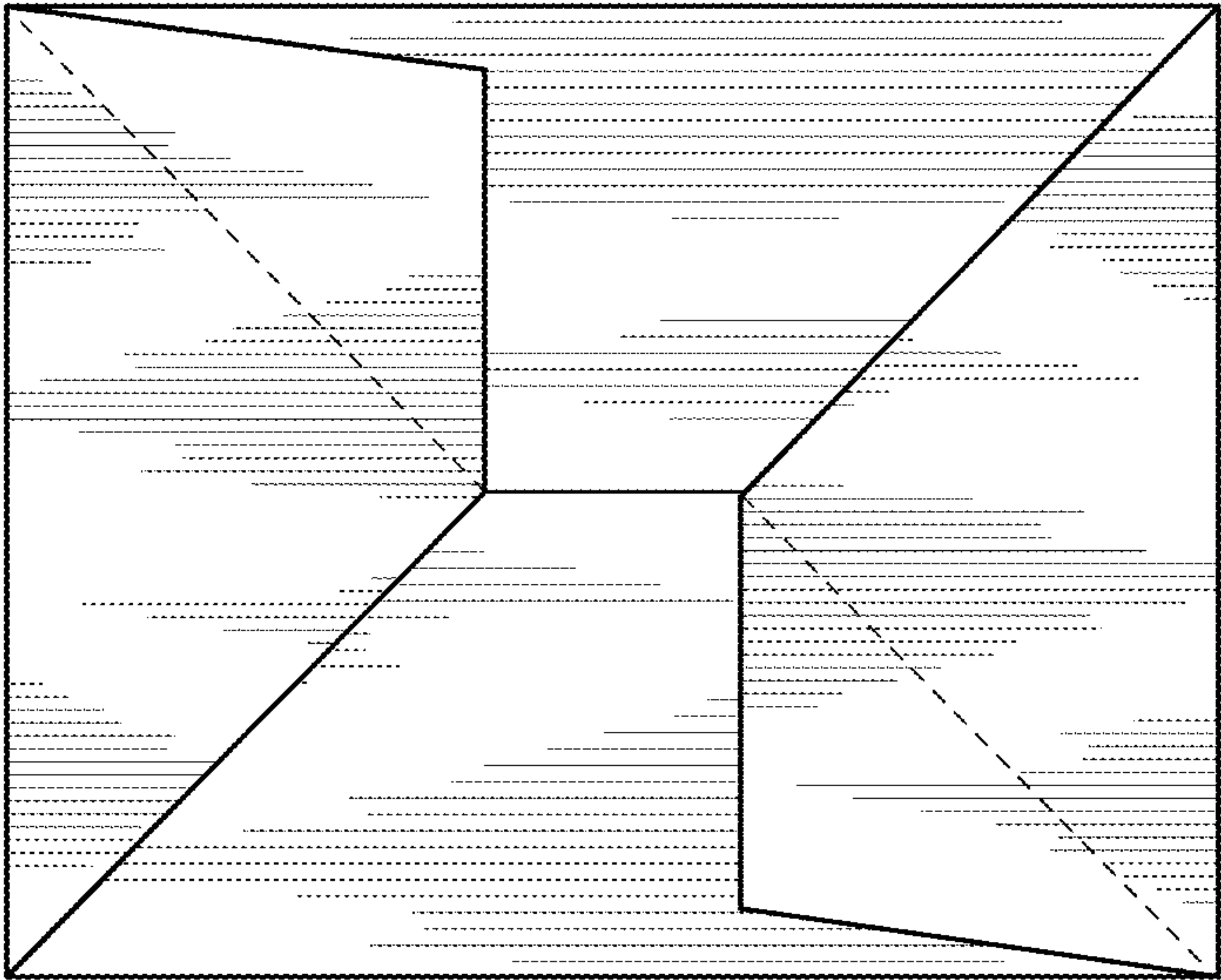

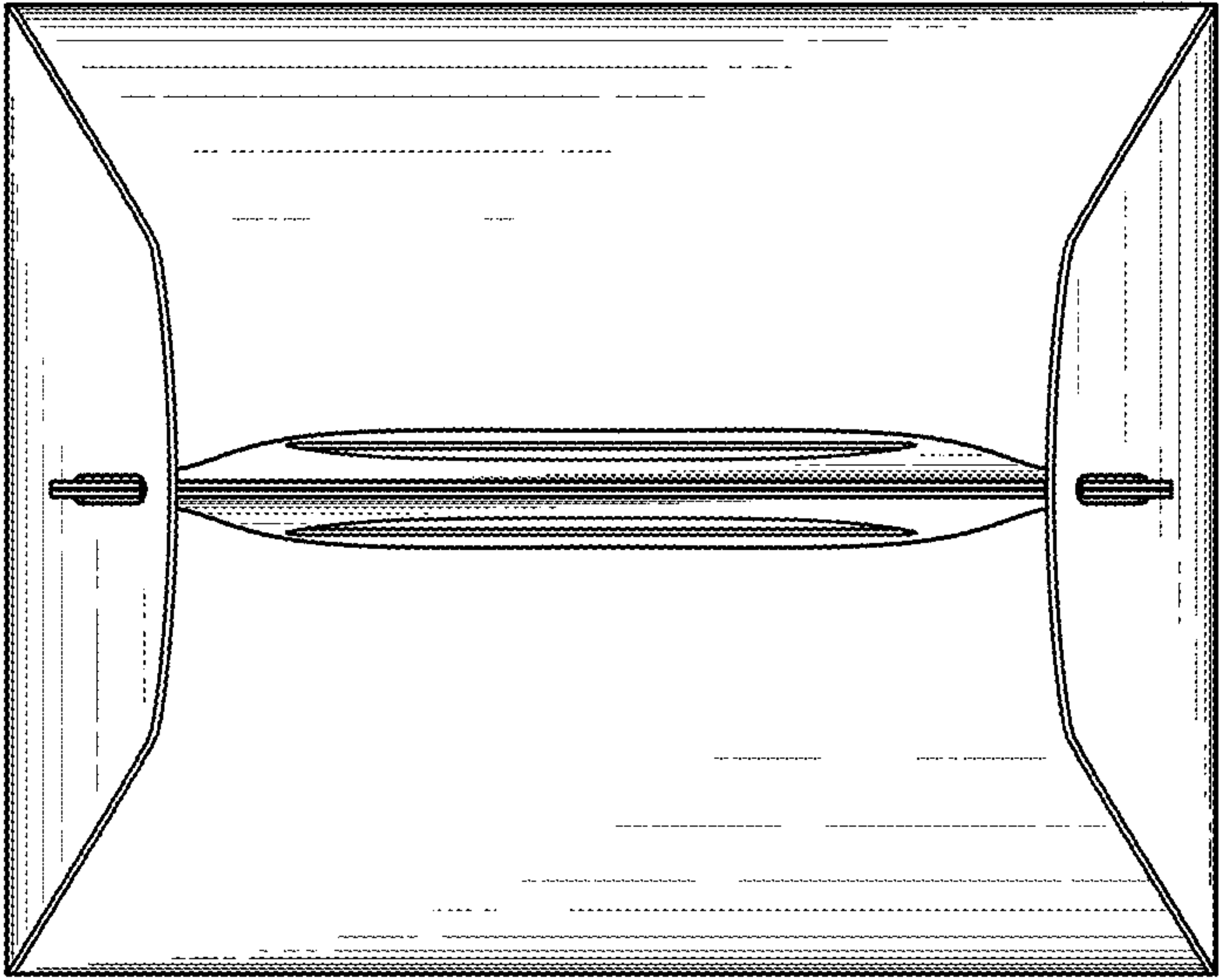
