(57) **CLAIM**

The ornamental design for a bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the bottle showing our new design, the rear elevational view being the mirror image thereof;

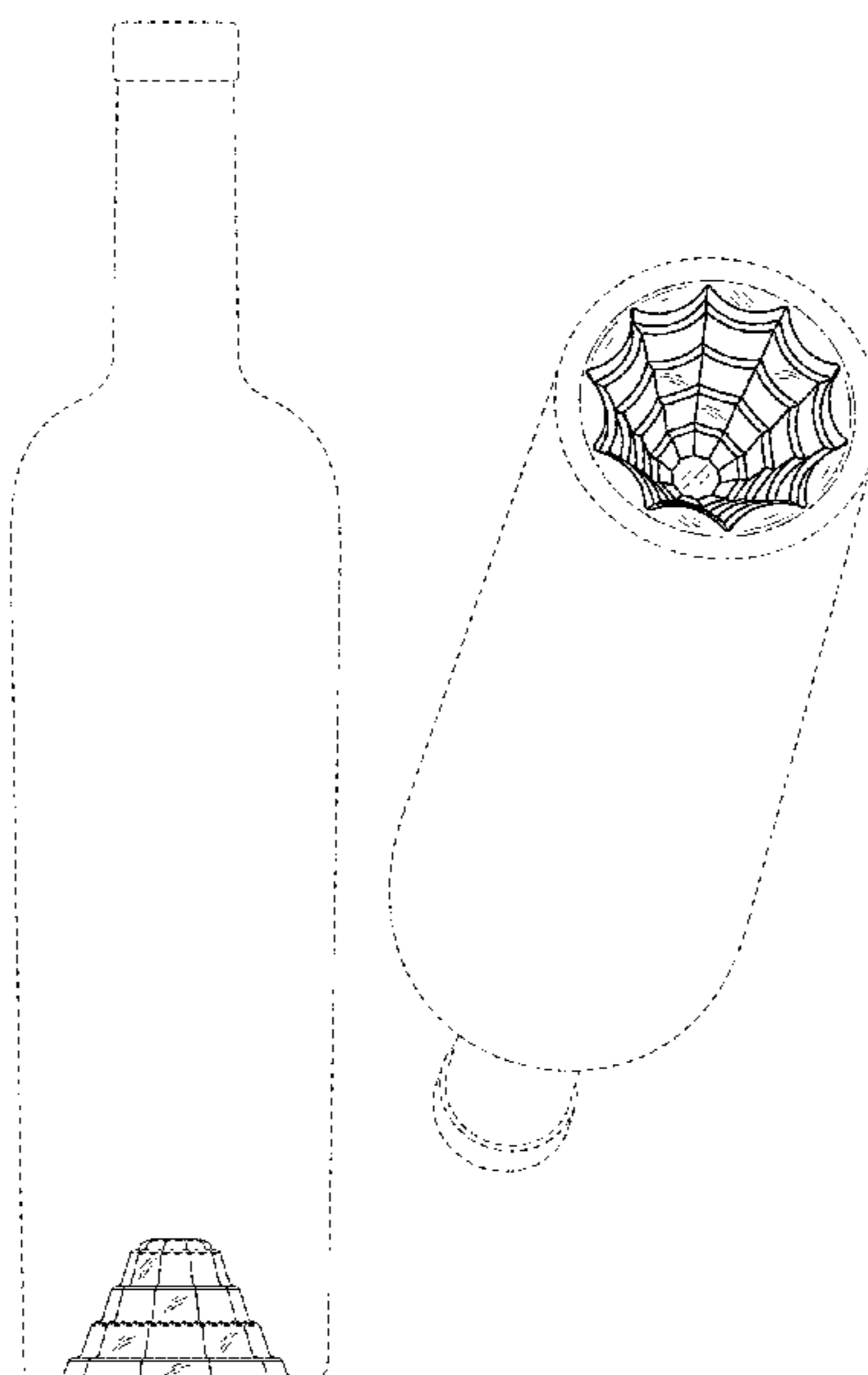
FIG. 2 is a right side elevational view thereof, the left side elevational view being the mirror image thereof;

FIG. 3 is a bottom plan view thereof; and,

FIG. 4 is a bottom perspective view thereof.

The evenly-dashed broken line showing of a bottle forms no part of the claimed design. The dot-dashed broken lines illustrate the boundary of the design and form no part of the claim.

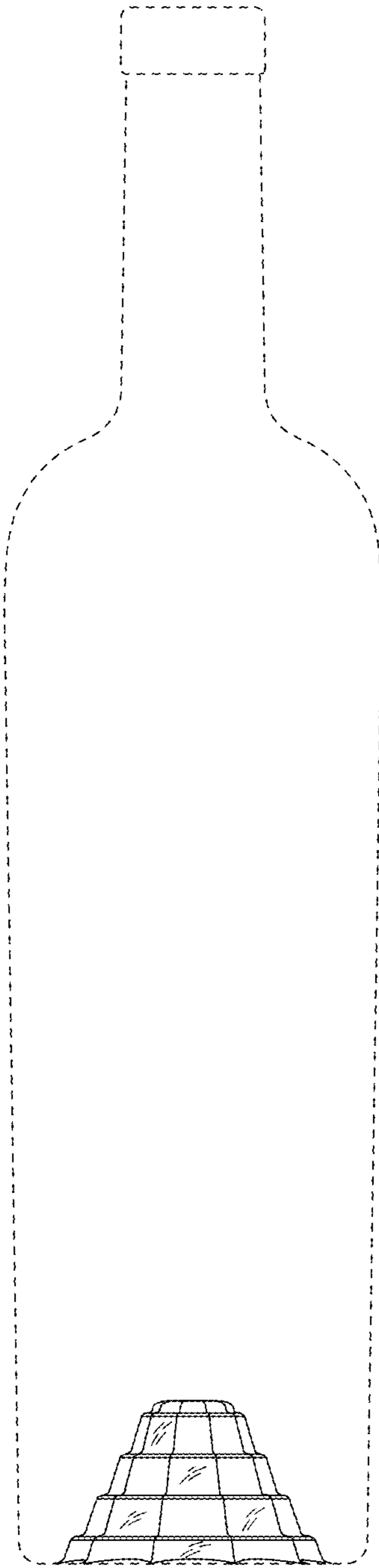

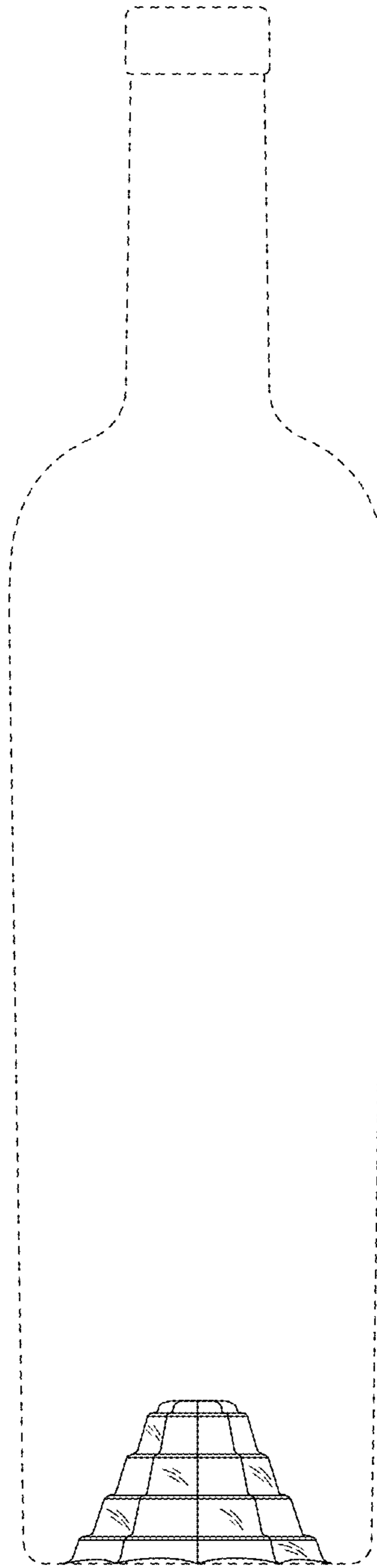

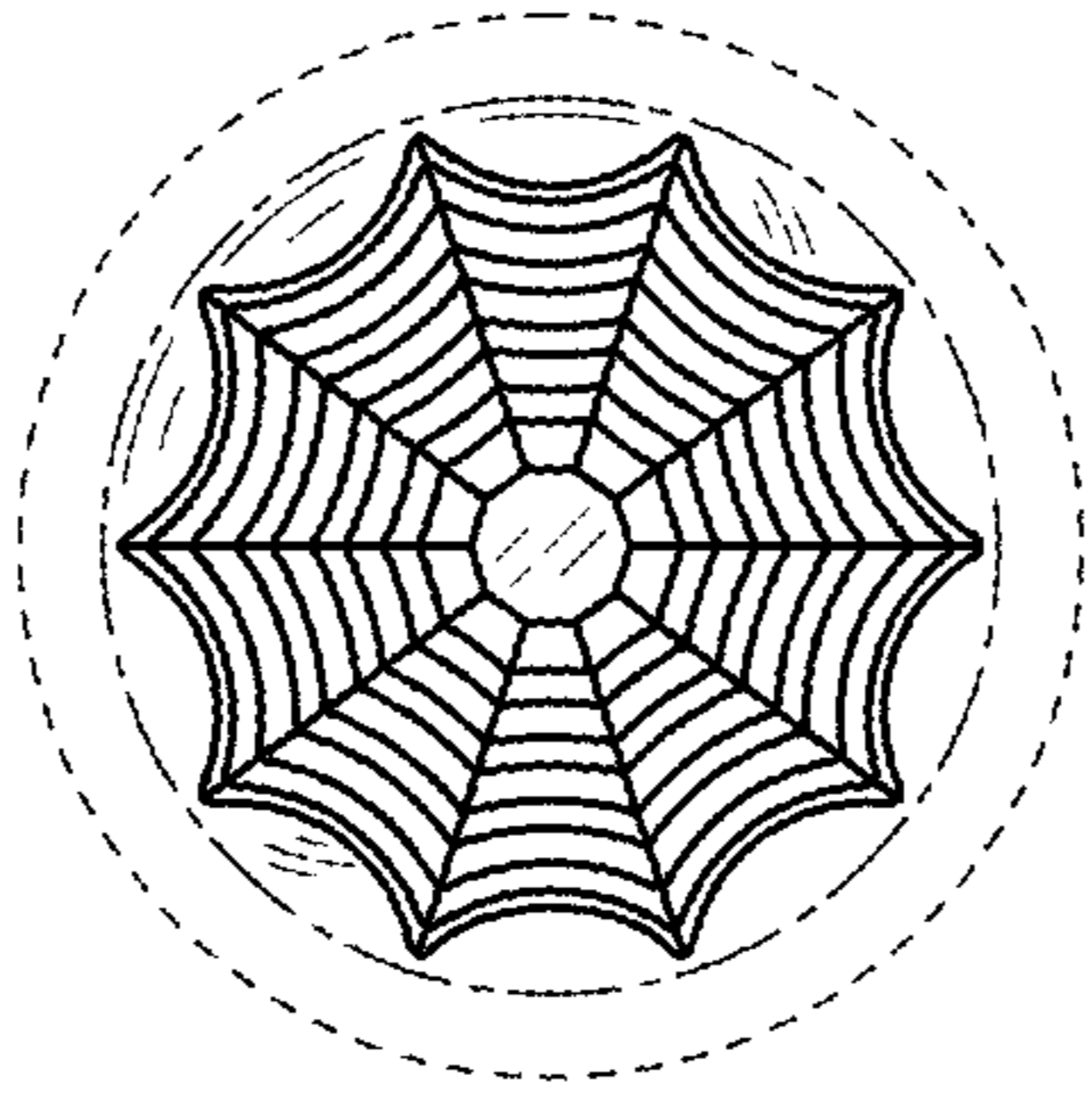

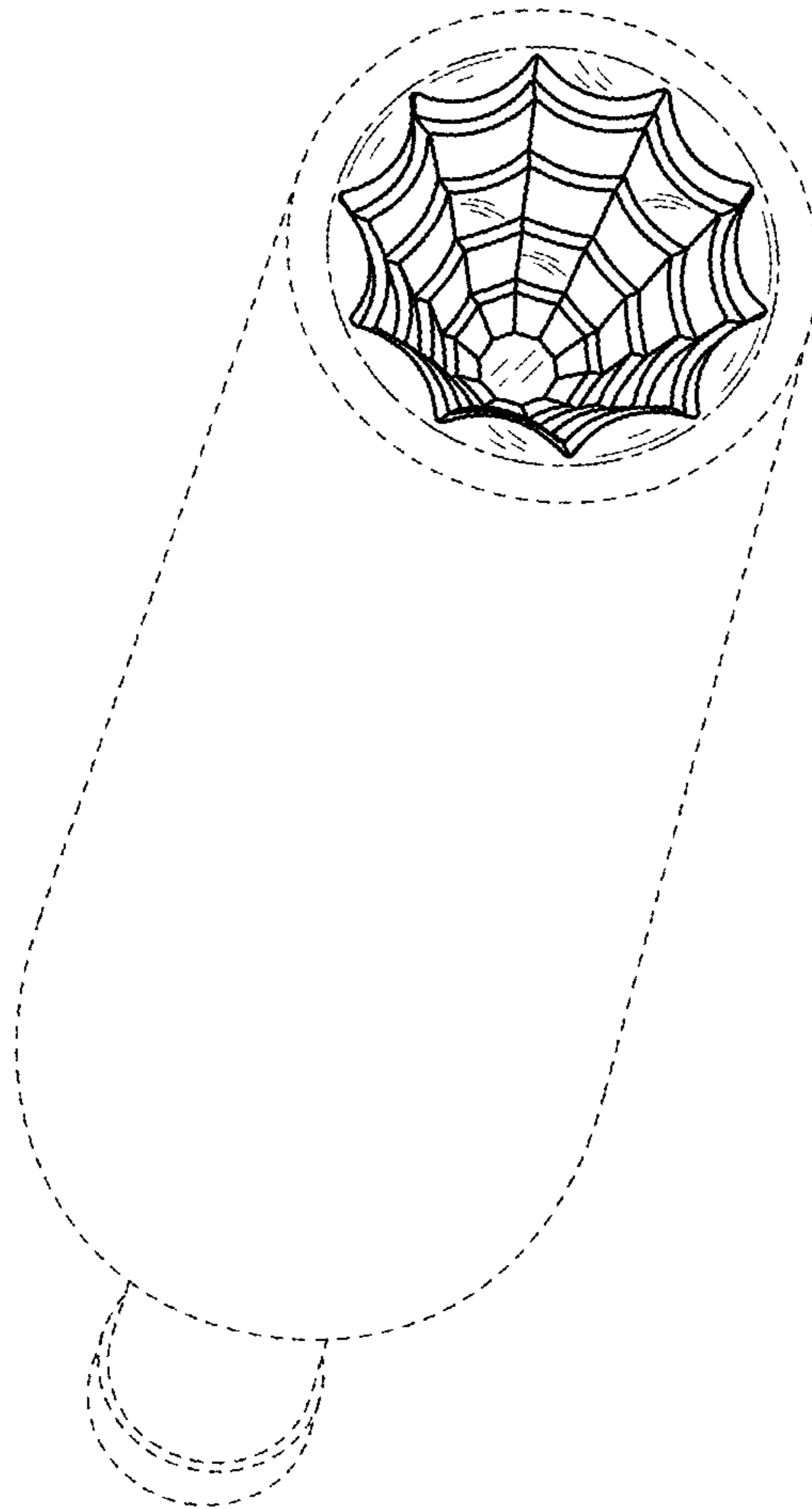
