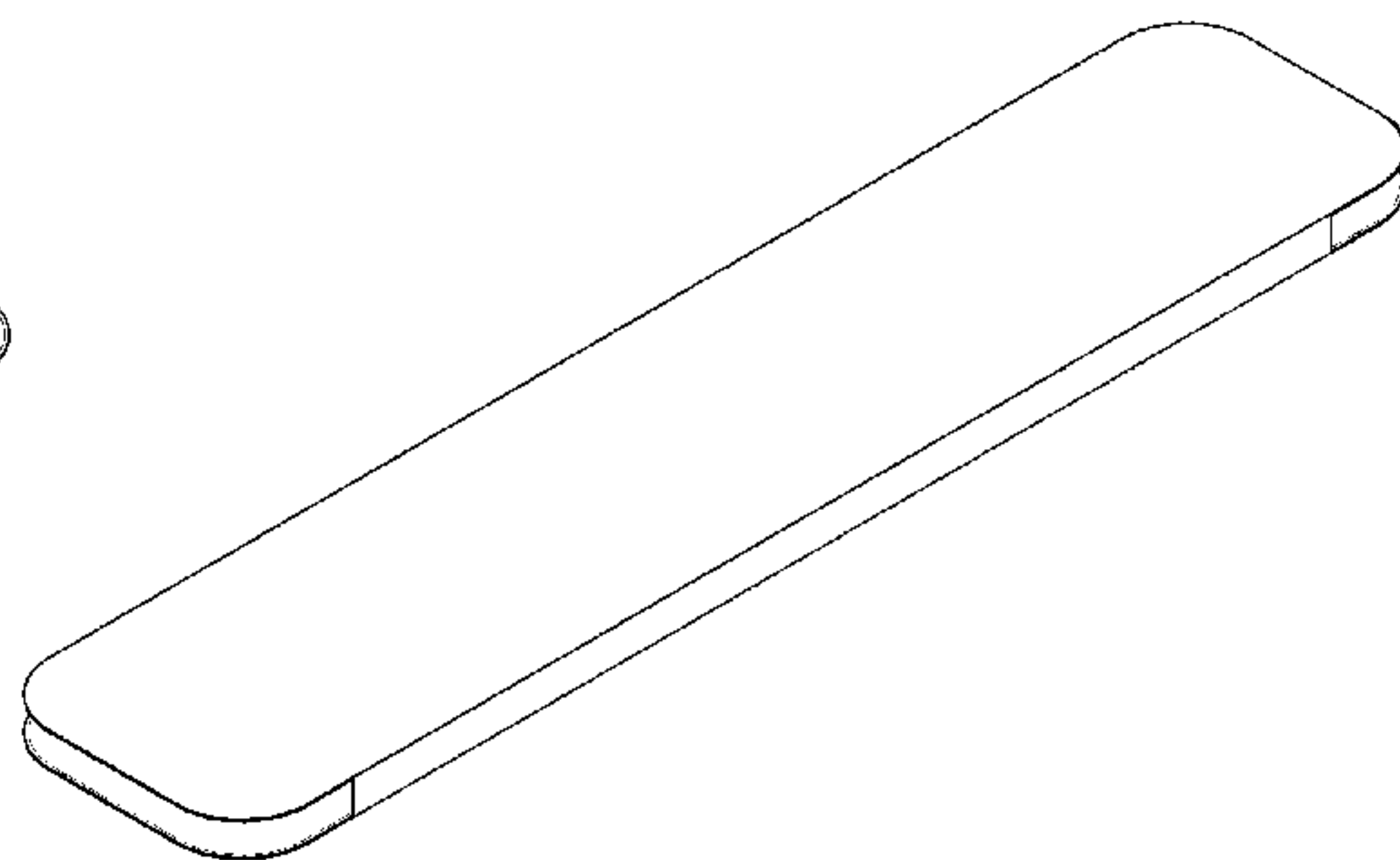
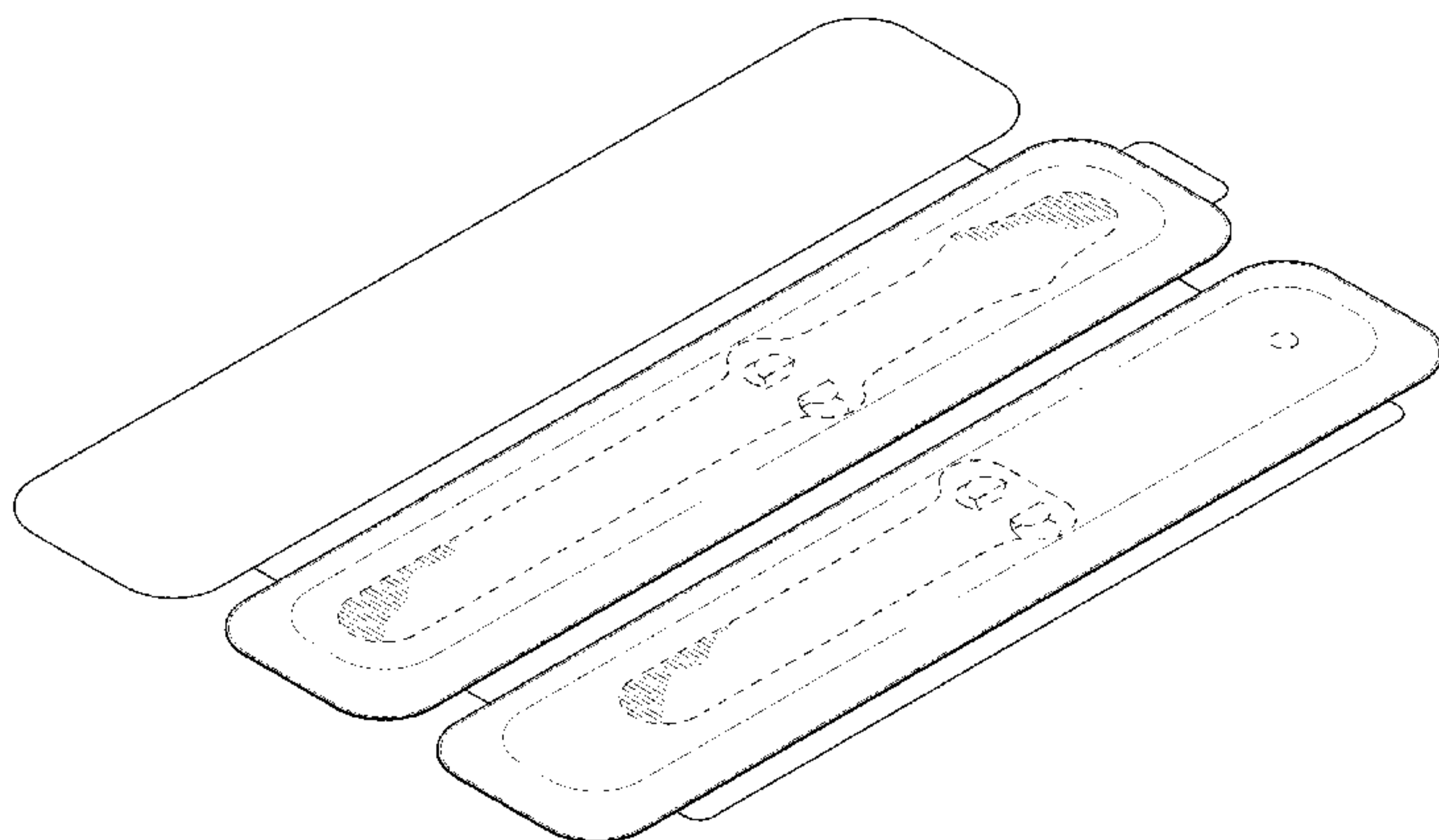
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of packaging showing the claimed design;
FIG. 2 is a bottom view thereof;

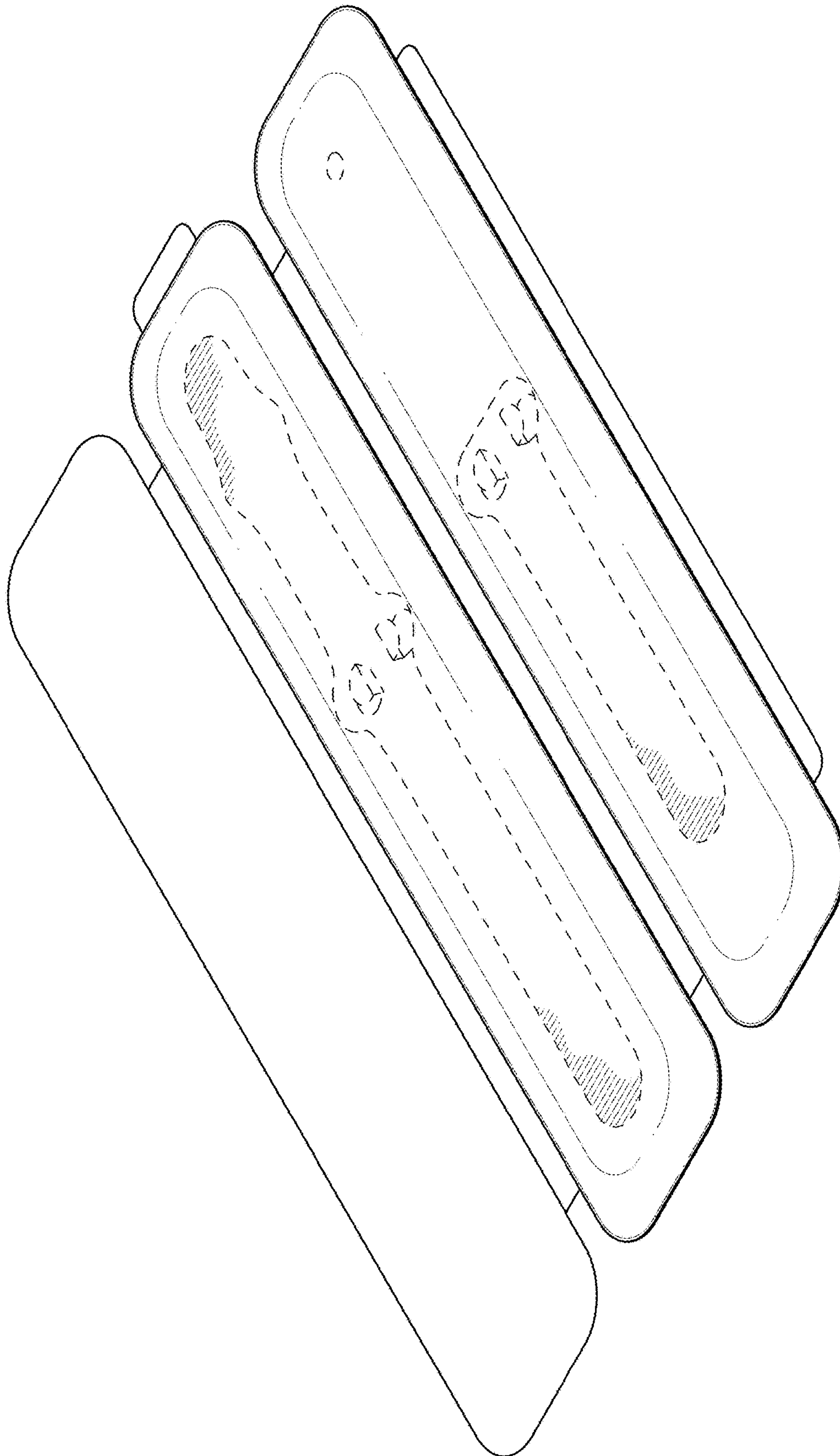

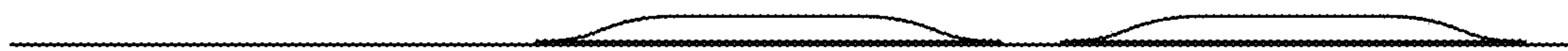

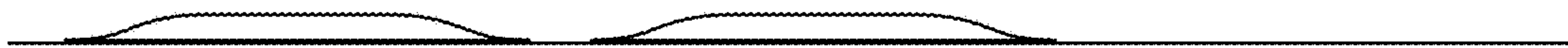

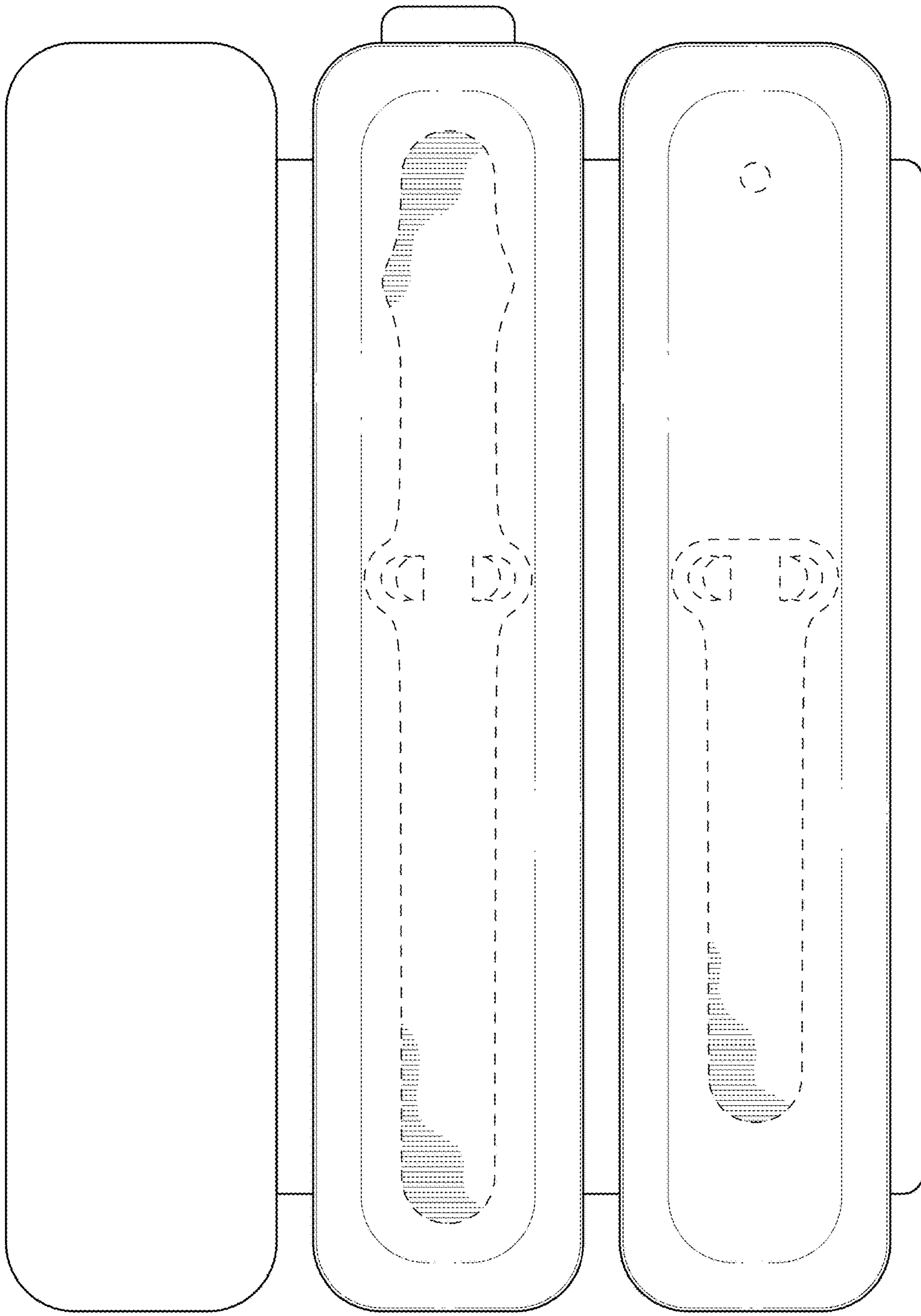

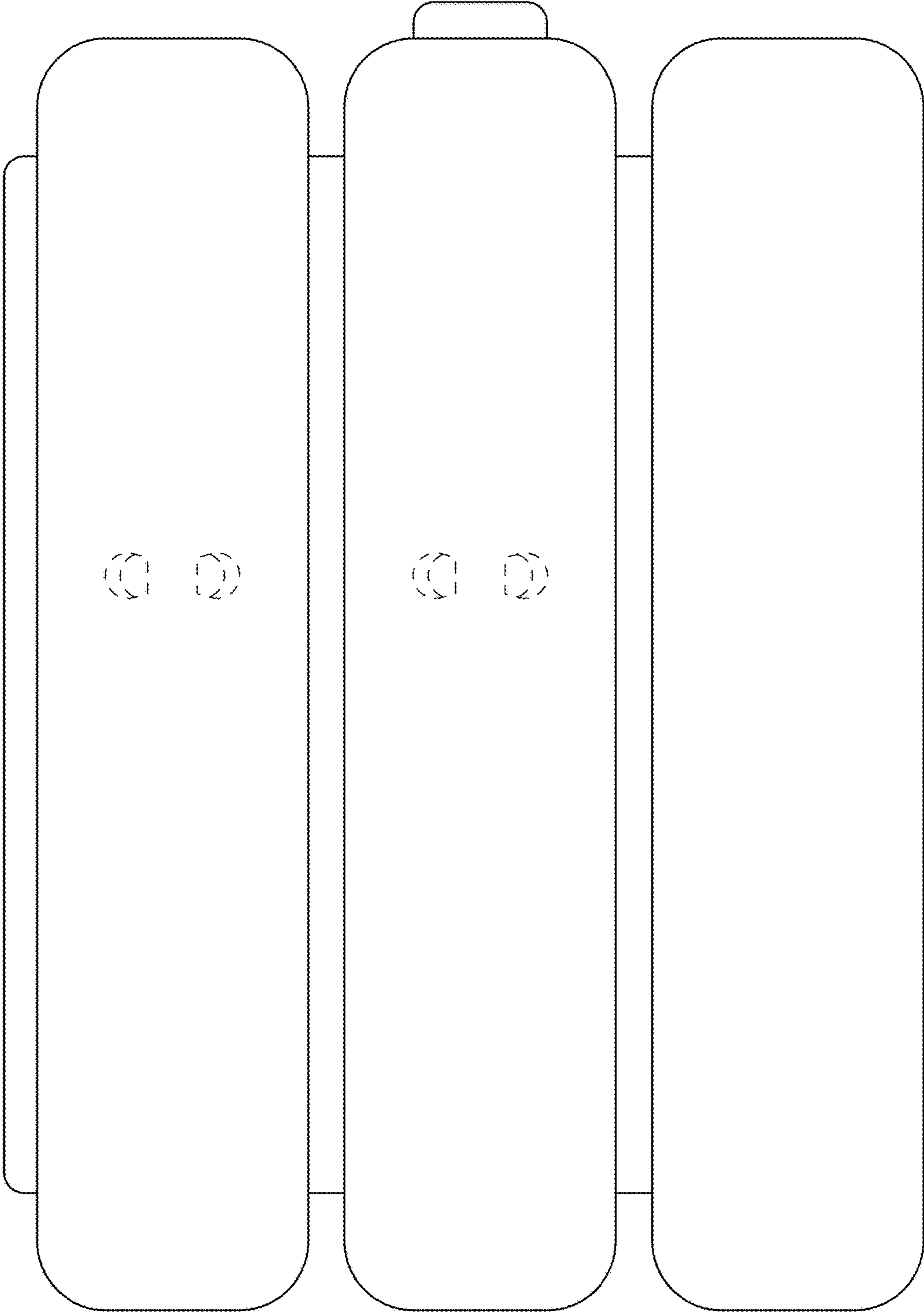

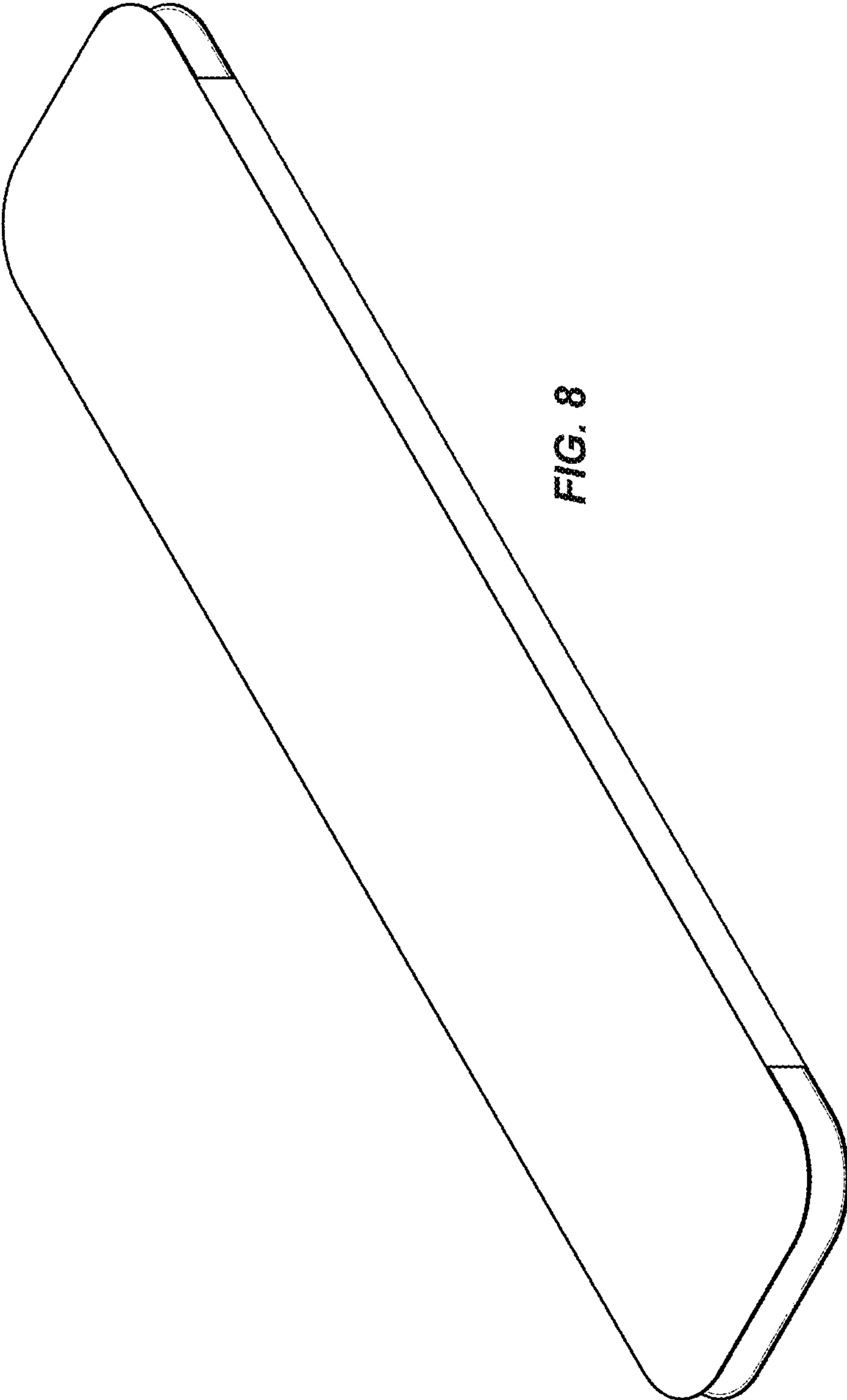

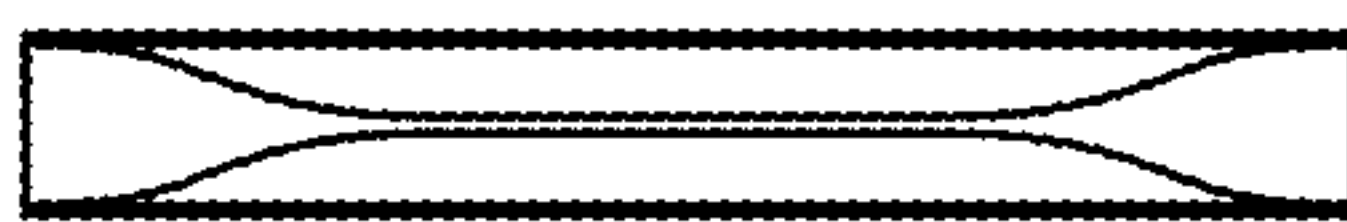

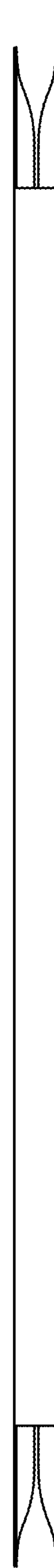

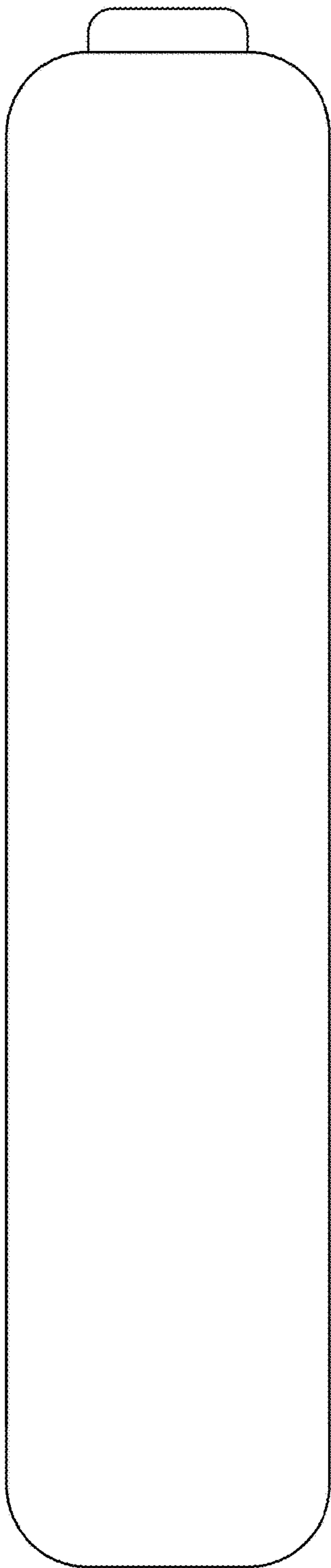

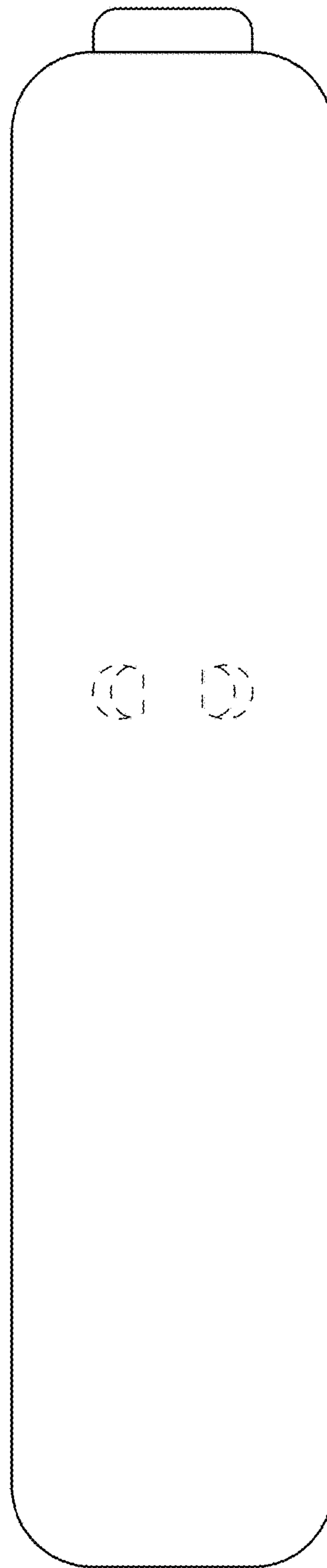
