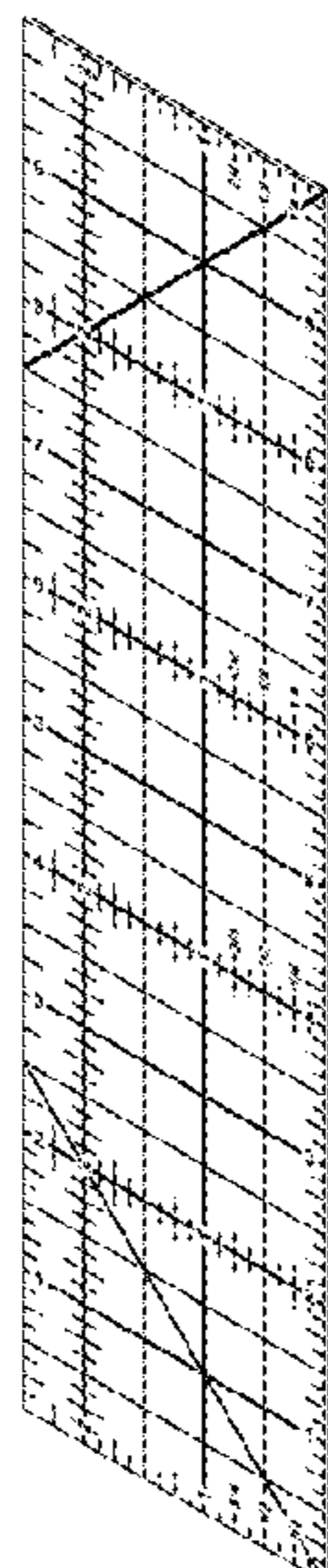
(57) **CLAIM**

We claim the ornamental design for an ironing template, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an ironing template according to my design;  
FIG. 2 is a front view of the same;

FIG. 4 is a left side view of the same which is identical to a right side view of the same; and,  
FIG. 5 is a plan view of the same which is identical to a bottom view of the same.

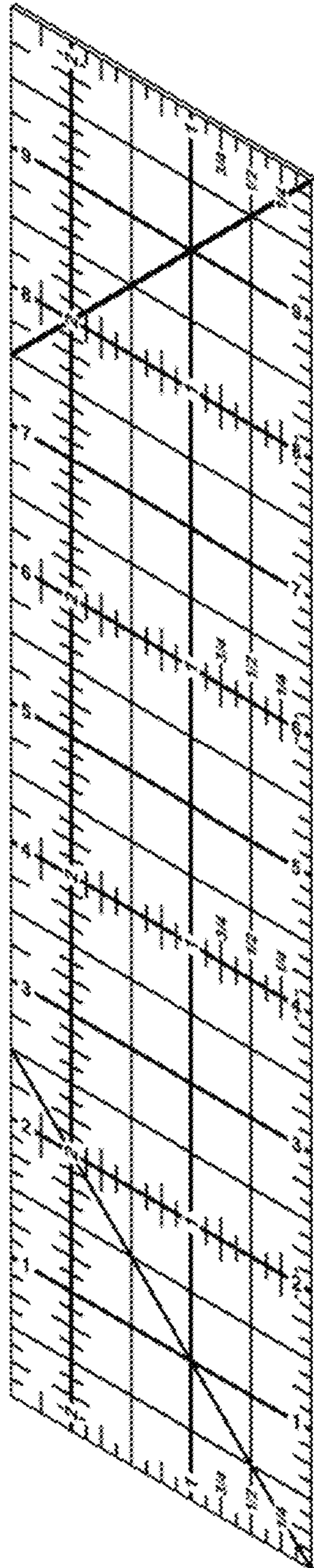

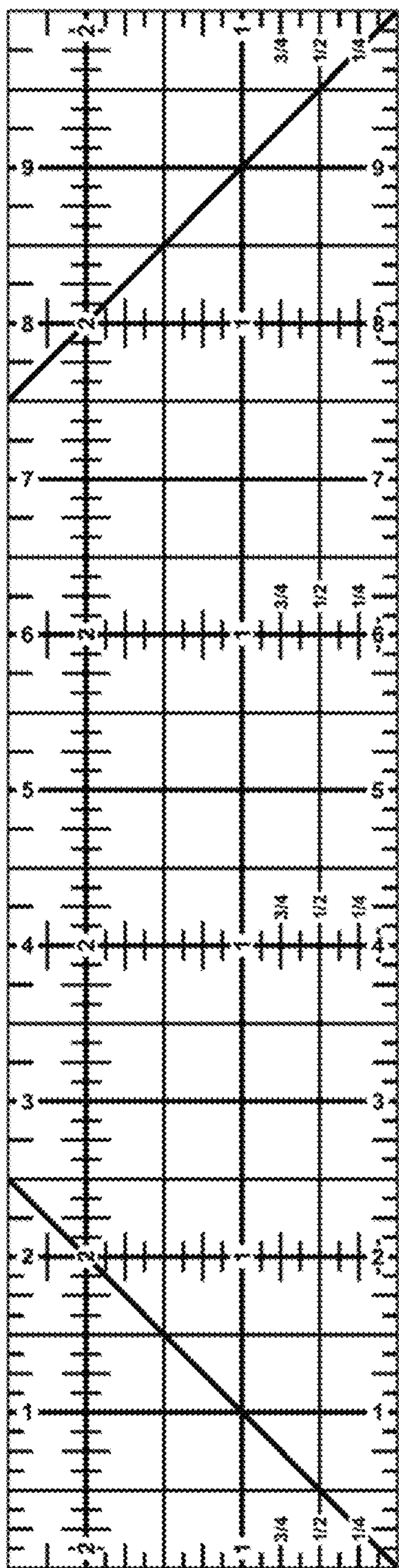

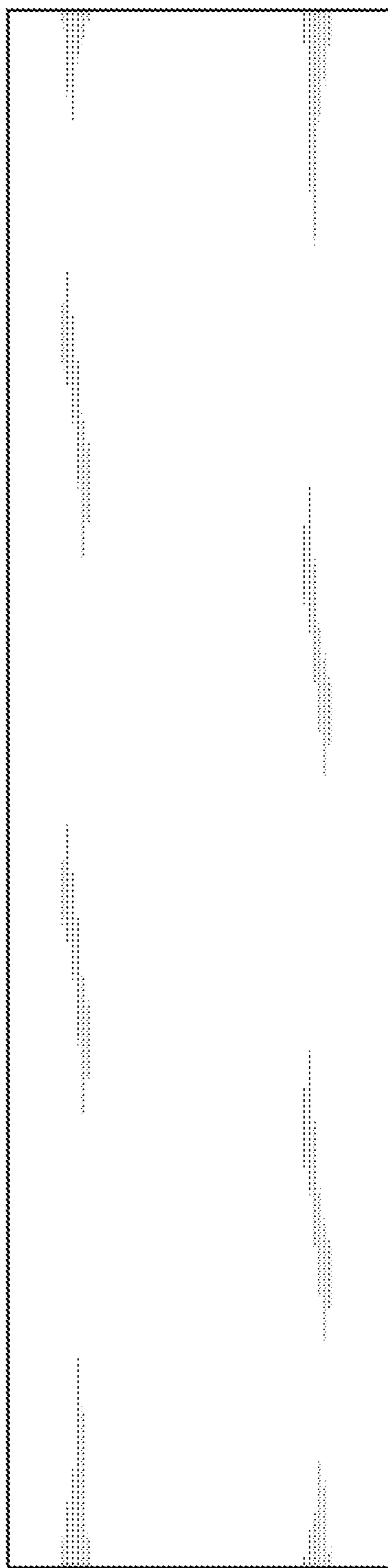
