DESCRIPTION

FIG. 1 is a front left perspective view of a charm, showing my new design;

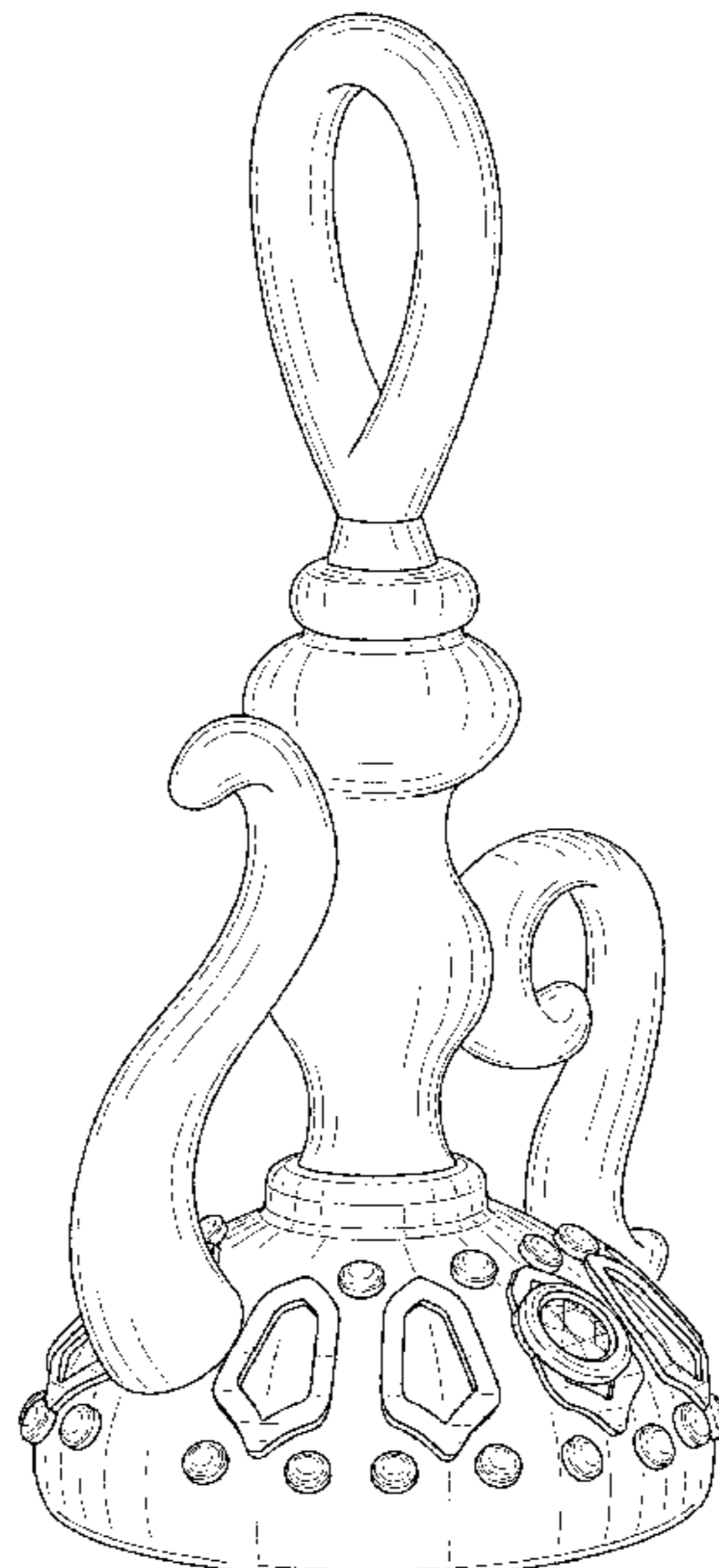

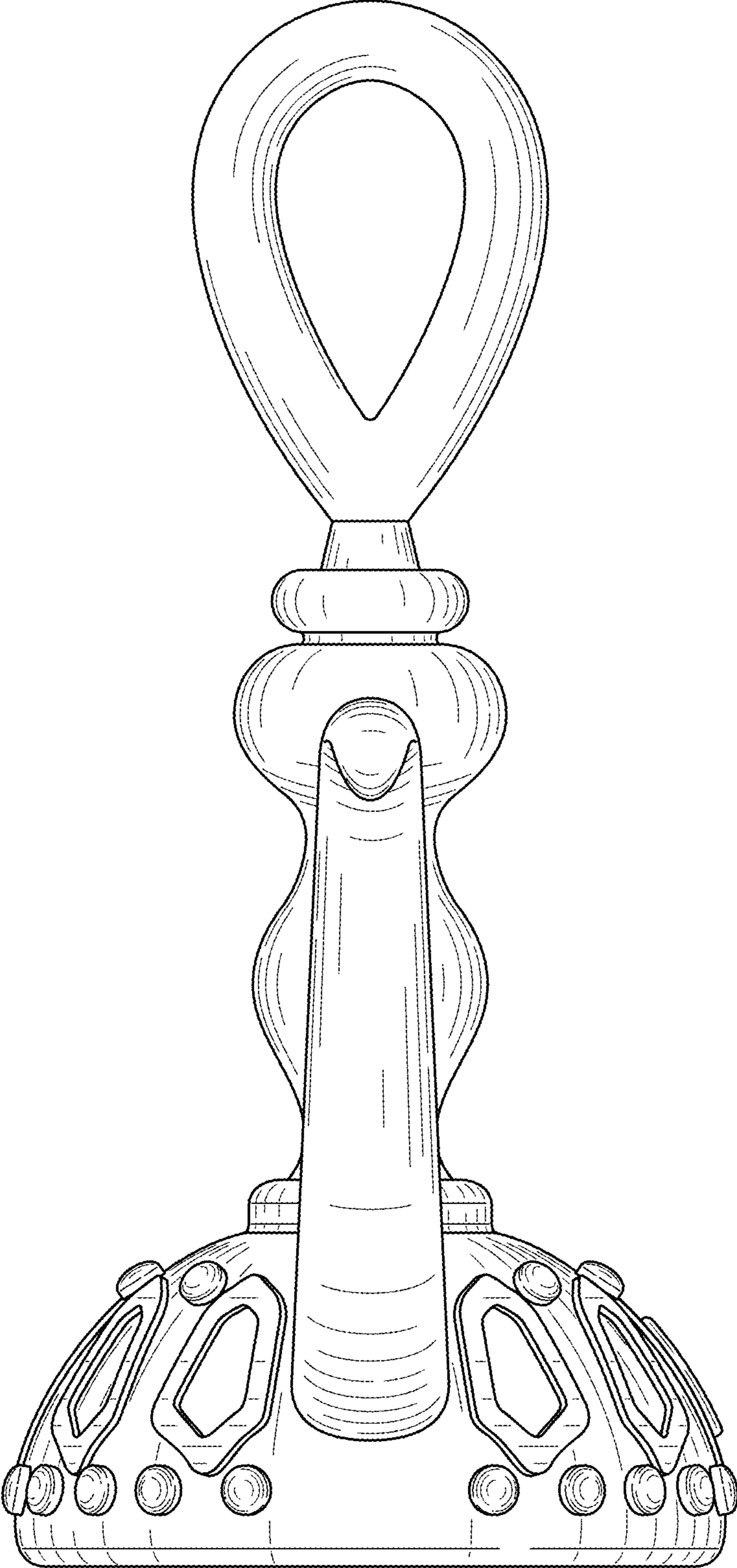

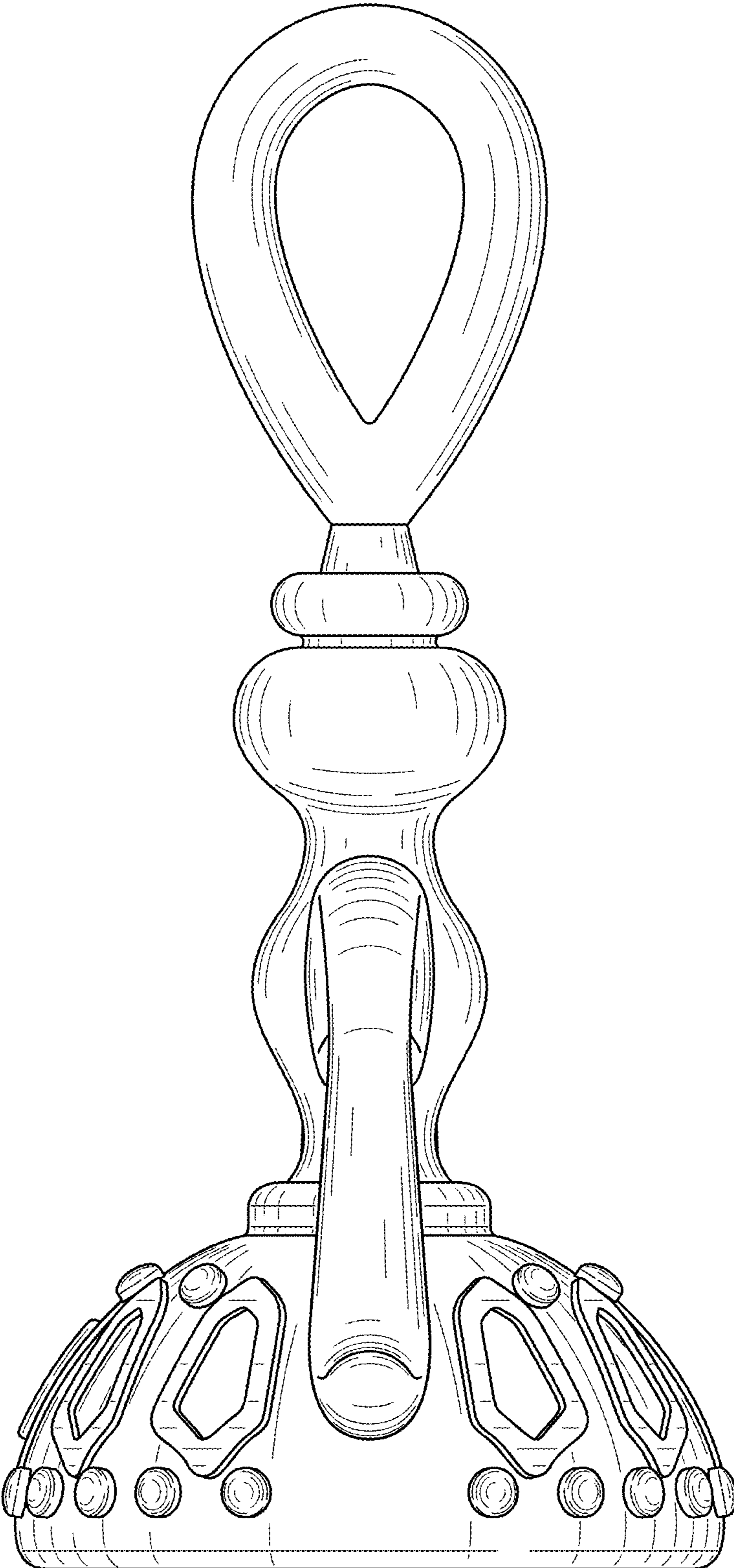

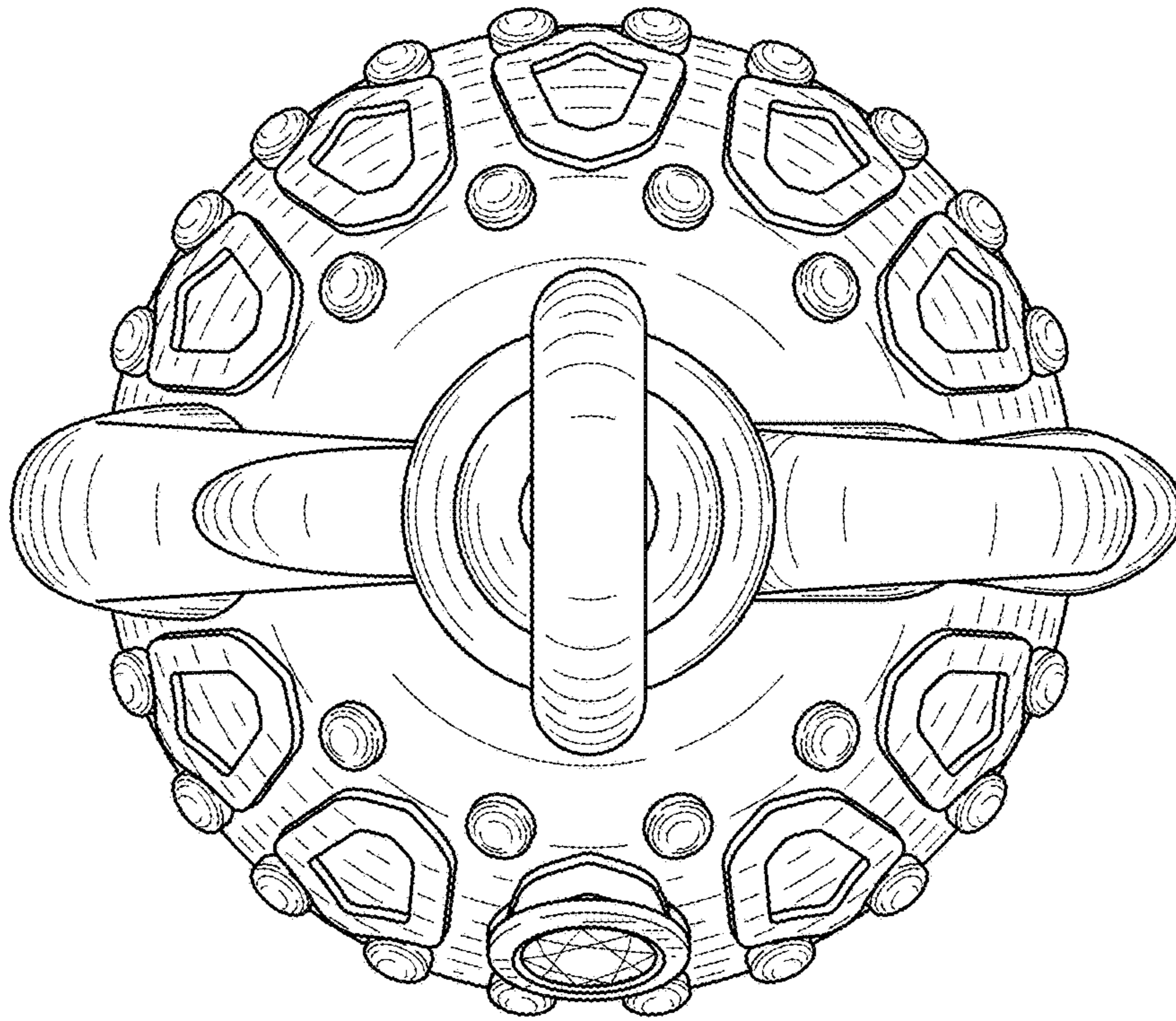

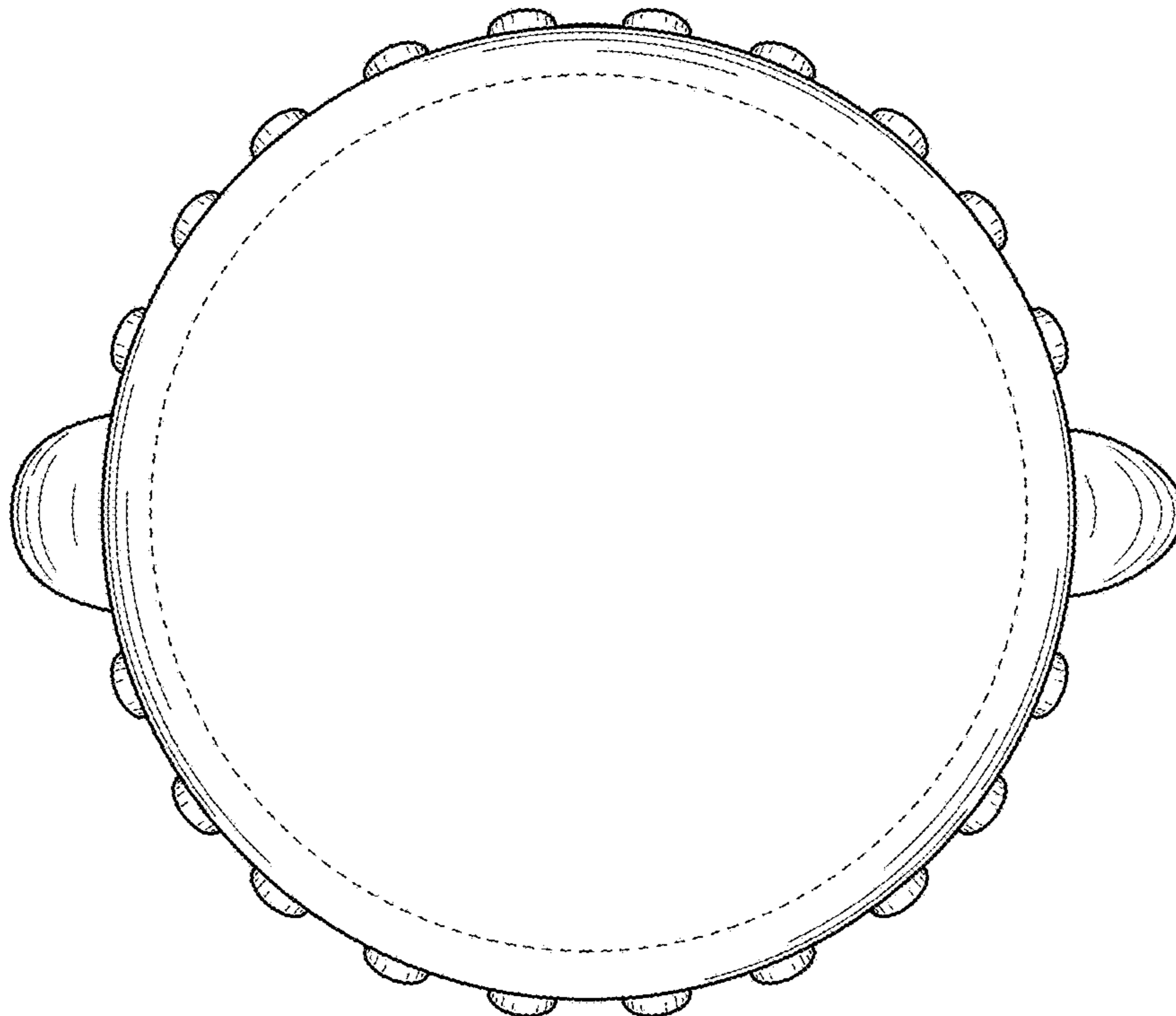
