FIG. 3 is a rear view of the portable electronic device stand of FIG. 1.

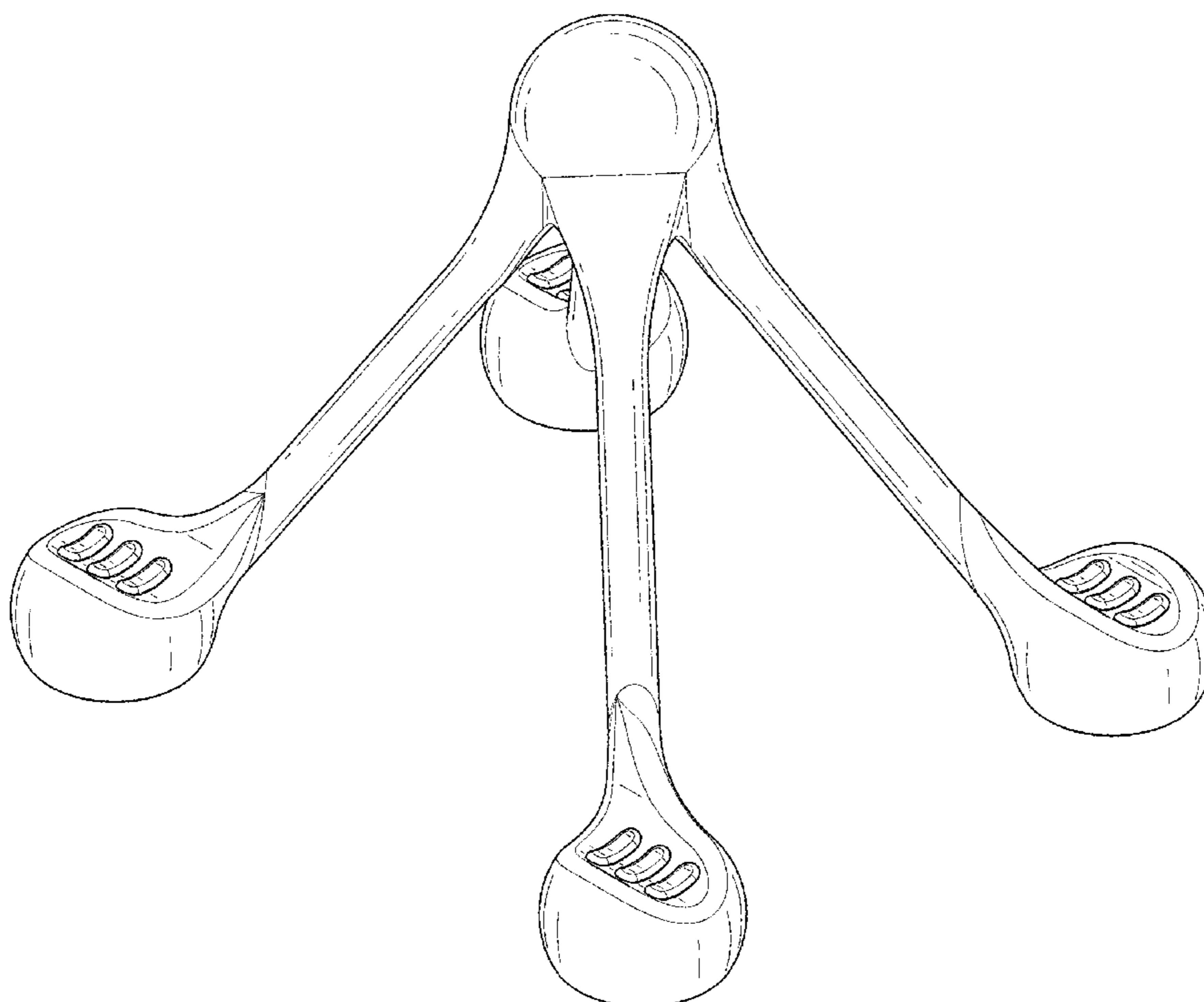
FIG. 4 is a right view of the portable electronic device stand of FIG. 1.

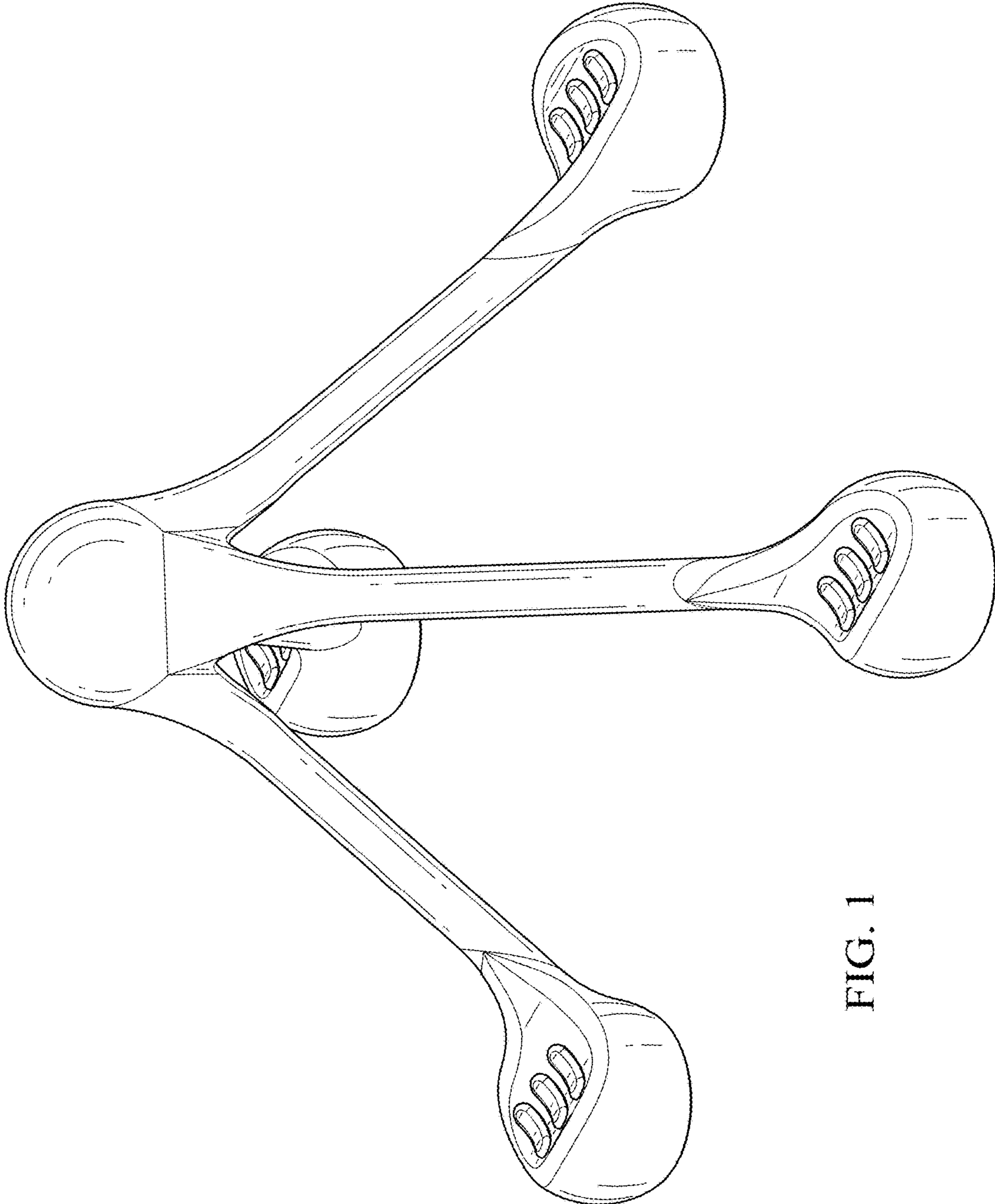

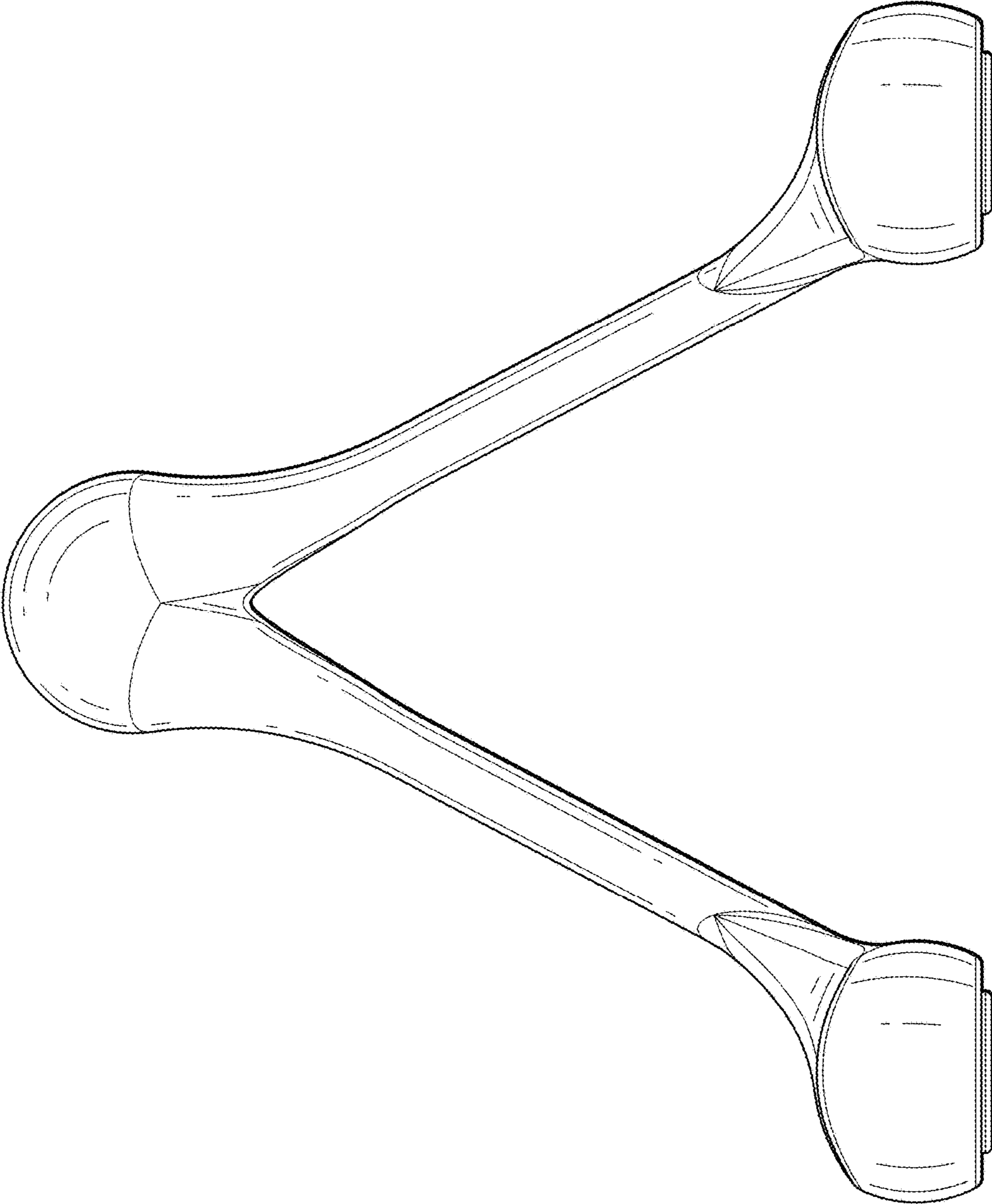

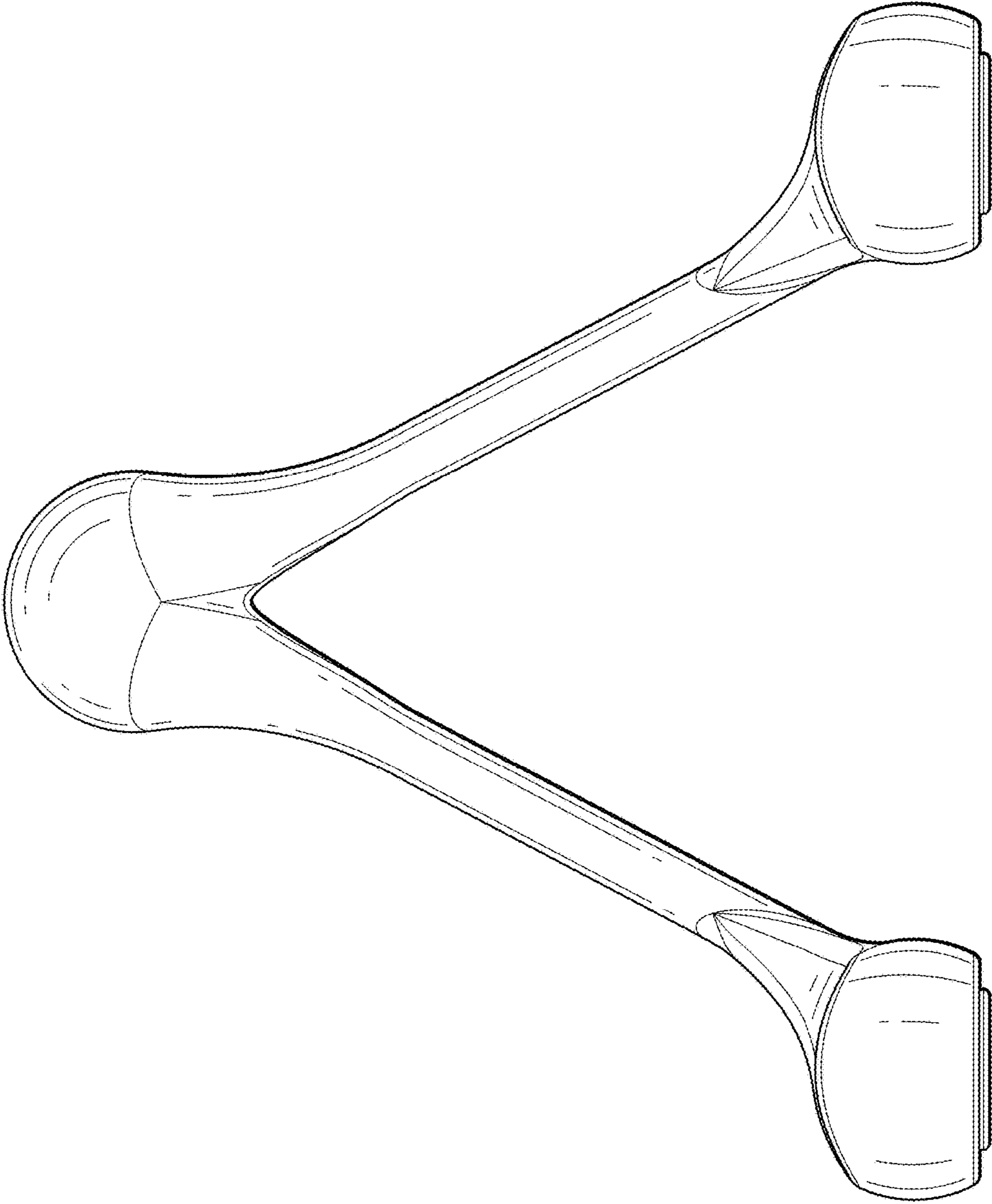

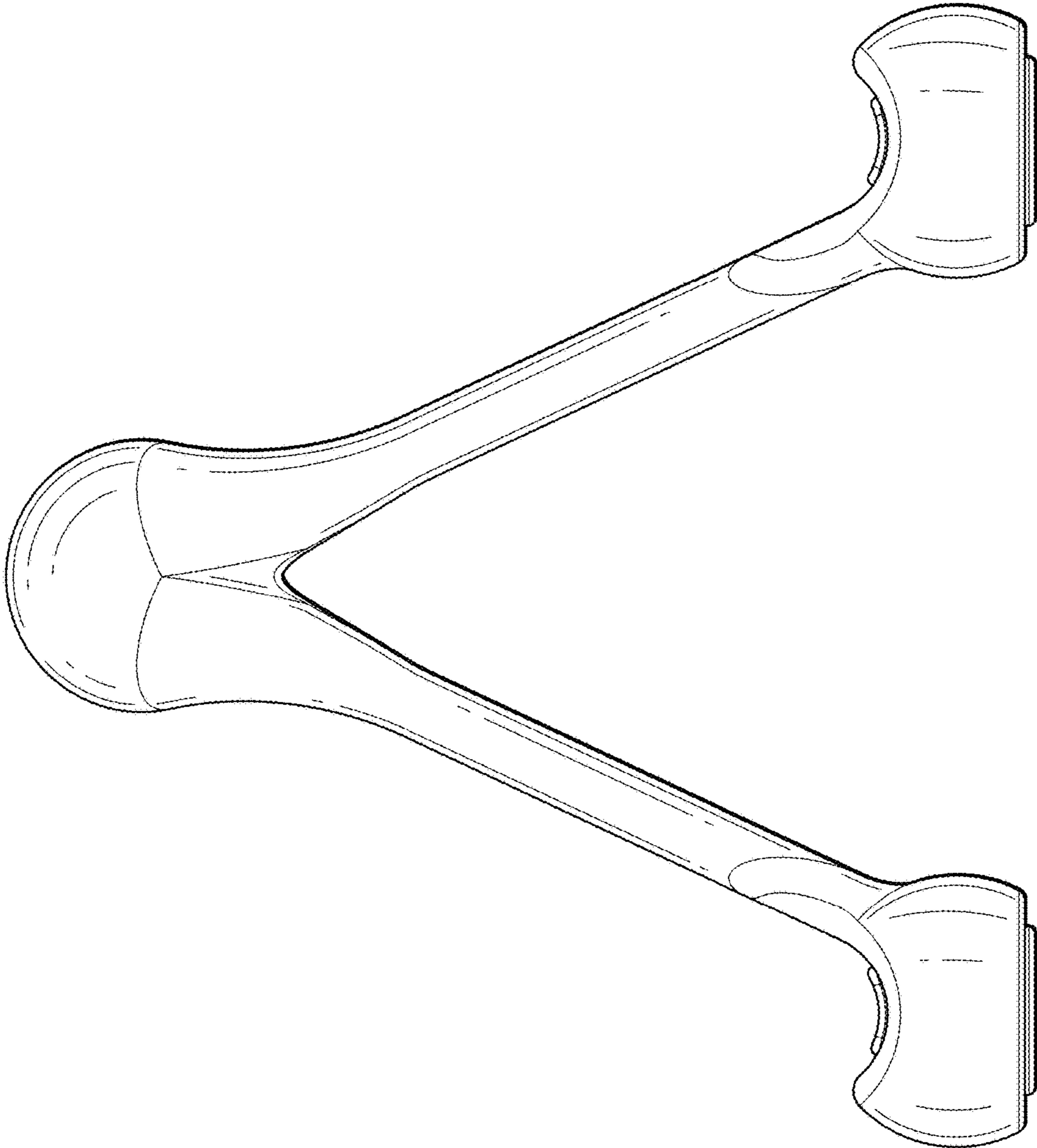

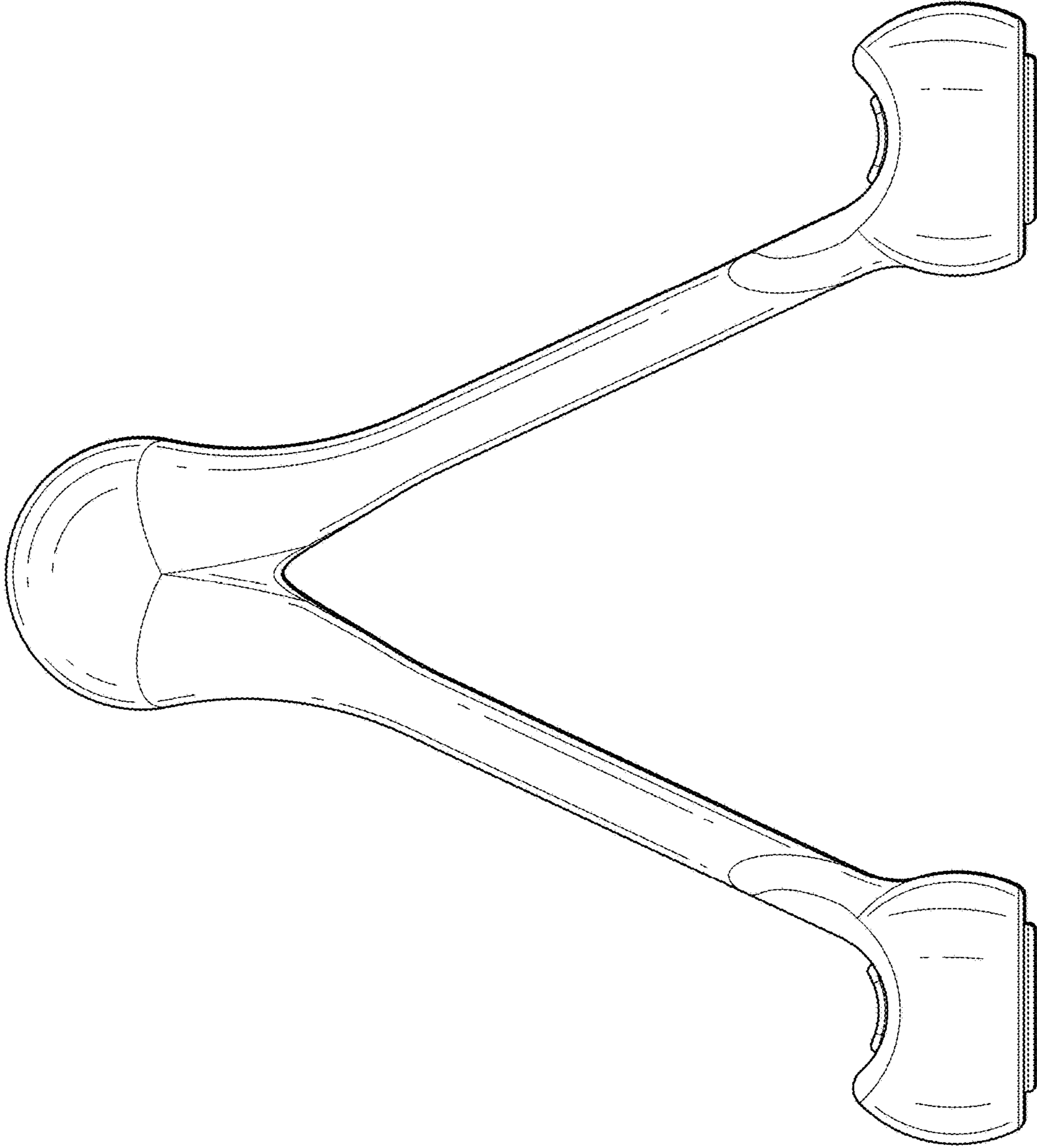

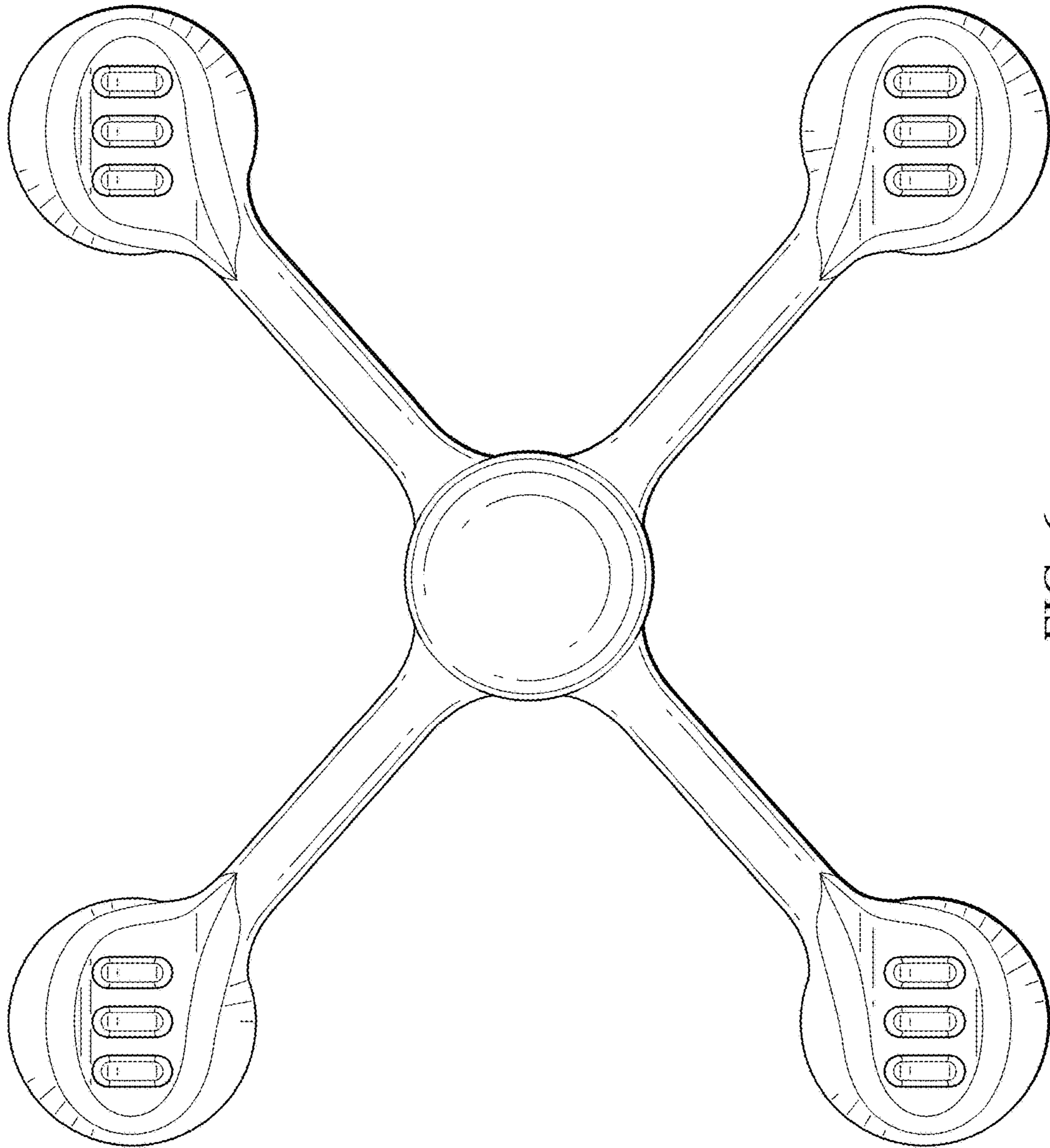

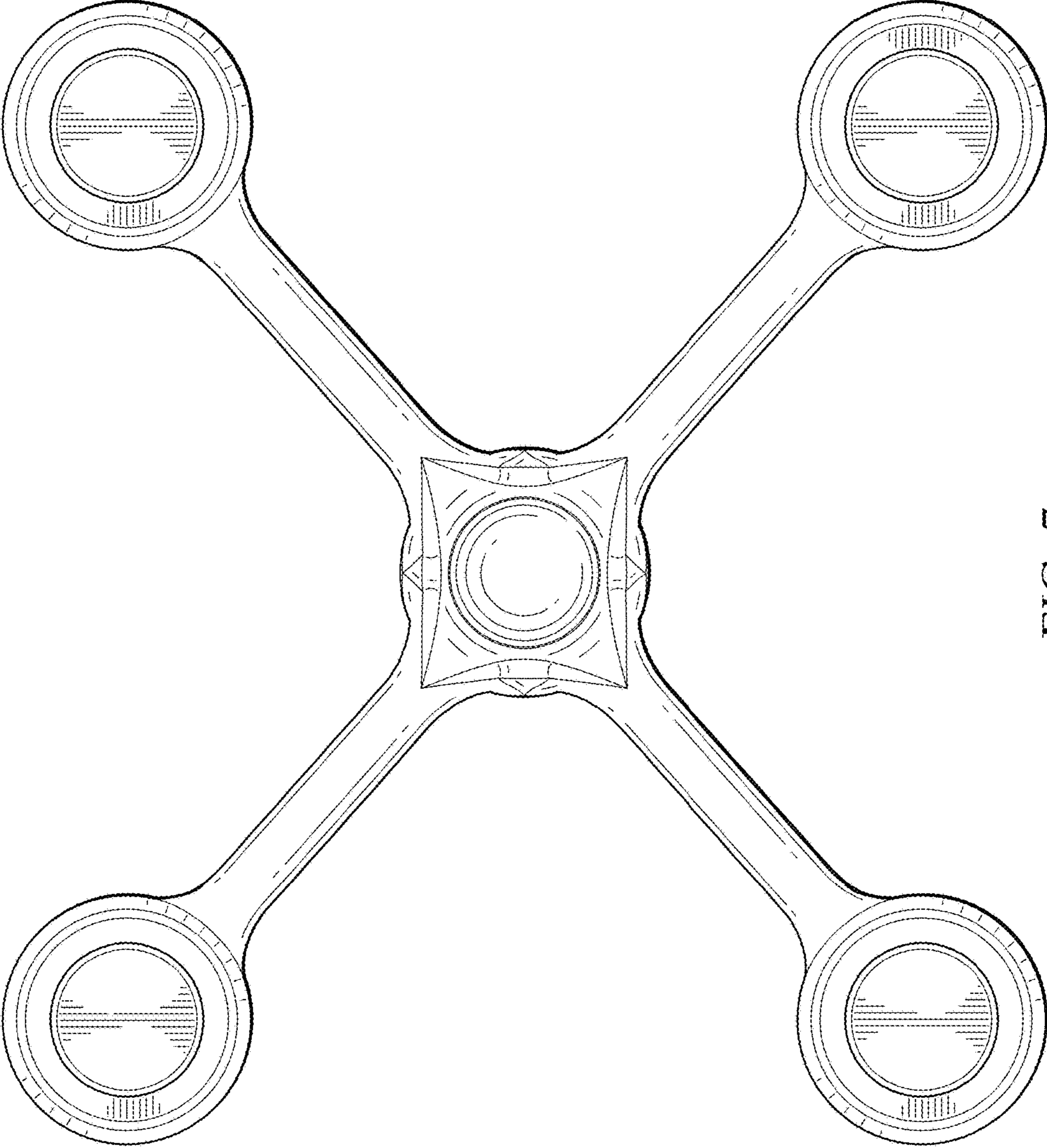
