The ornamental design for a portable printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable printer of the claimed design;

FIG. 2 is a front view of the portable printer shown in FIG. 1;

FIG. 3 is a rear view of the portable printer shown in FIG. 1;

FIG. 4 is a left side view of the portable printer shown in FIG. 1;

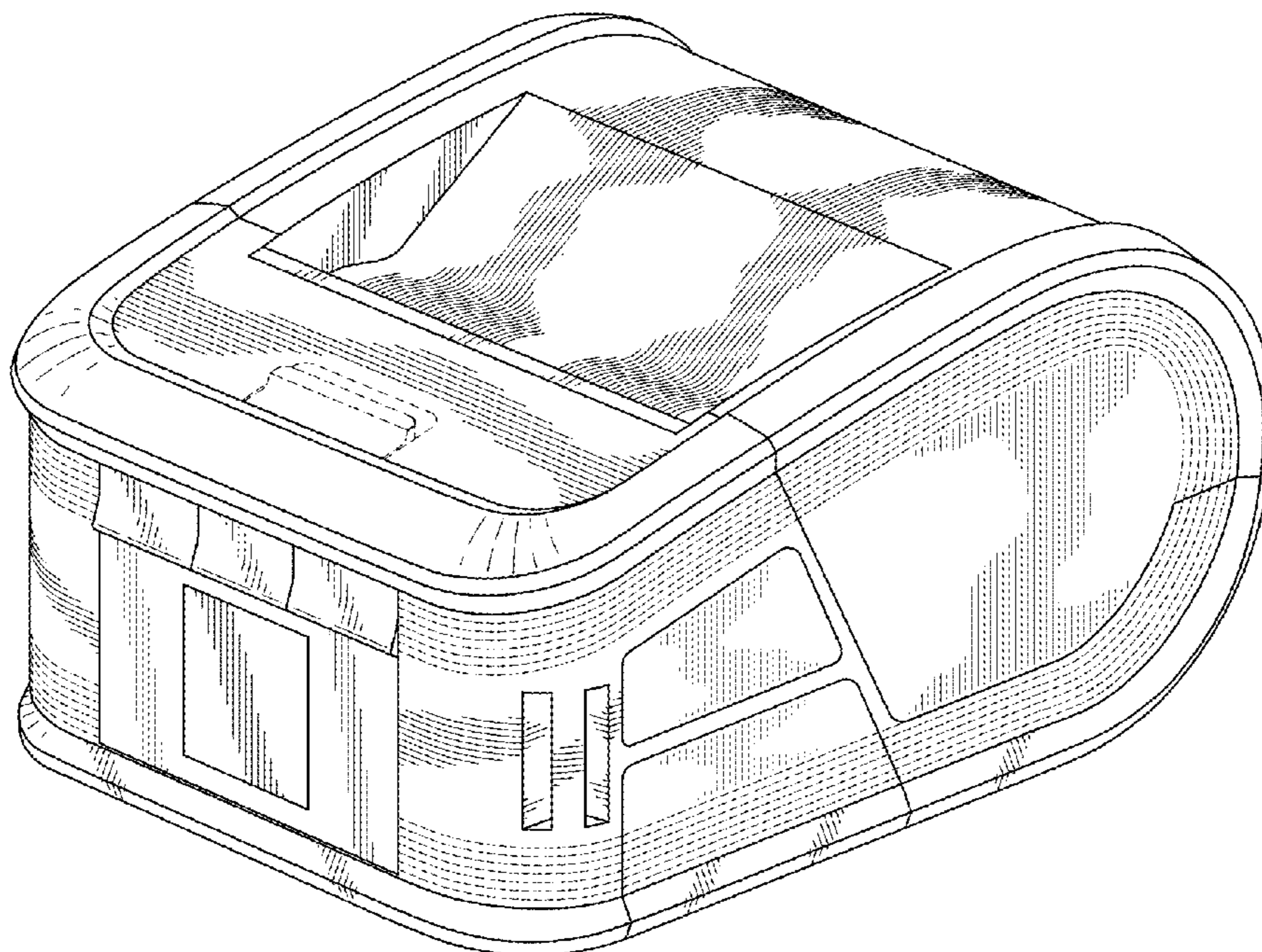

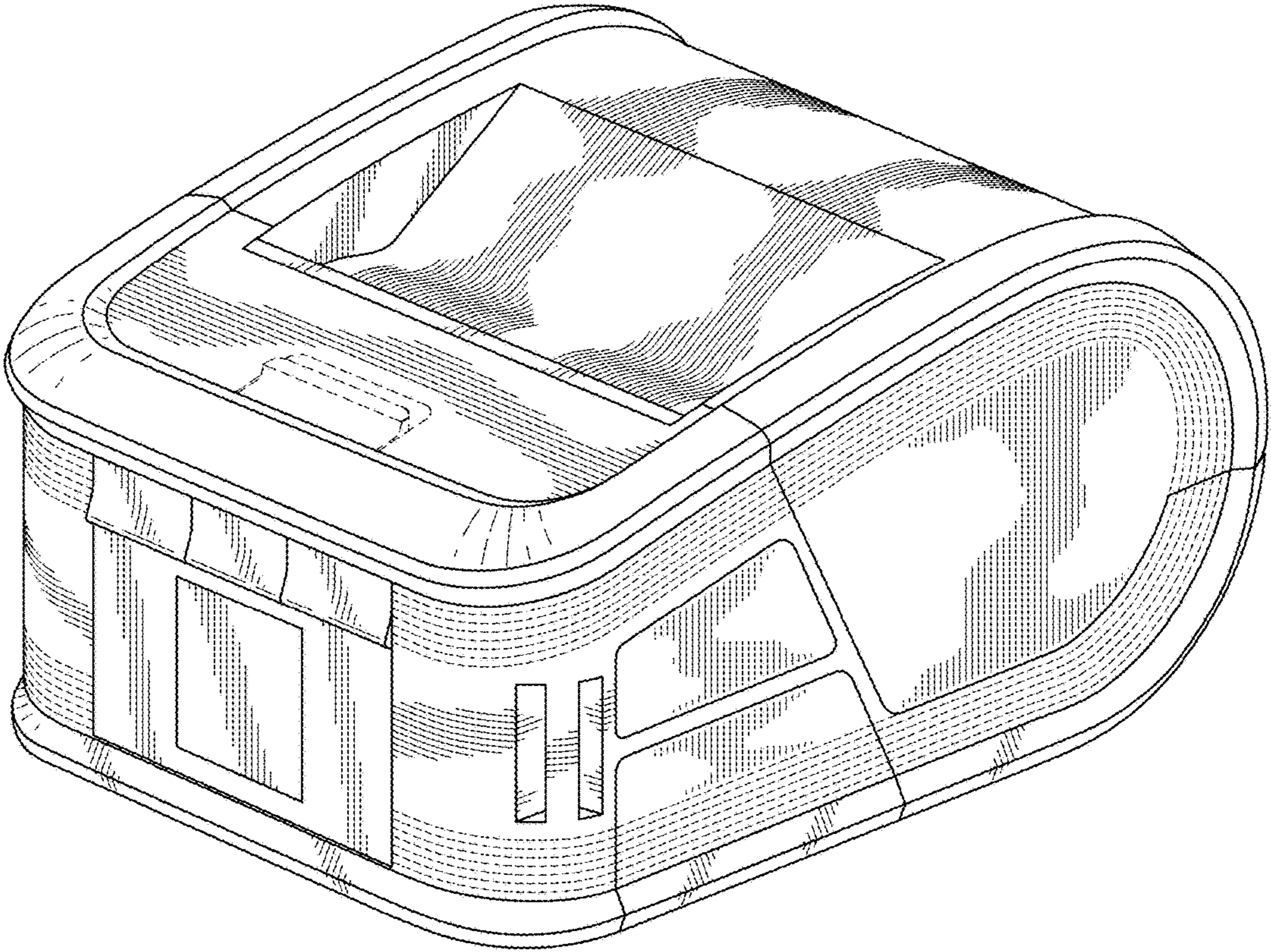

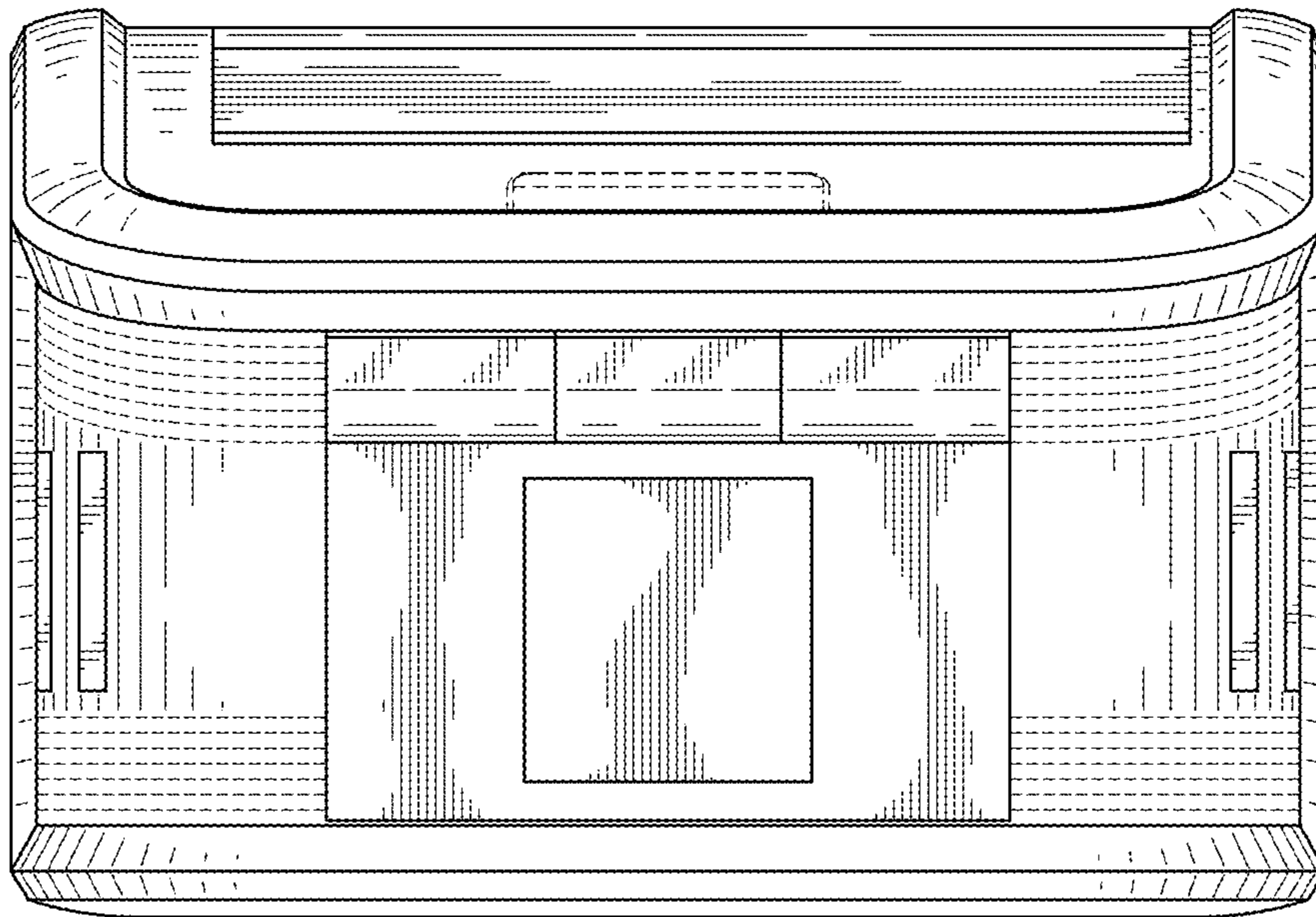

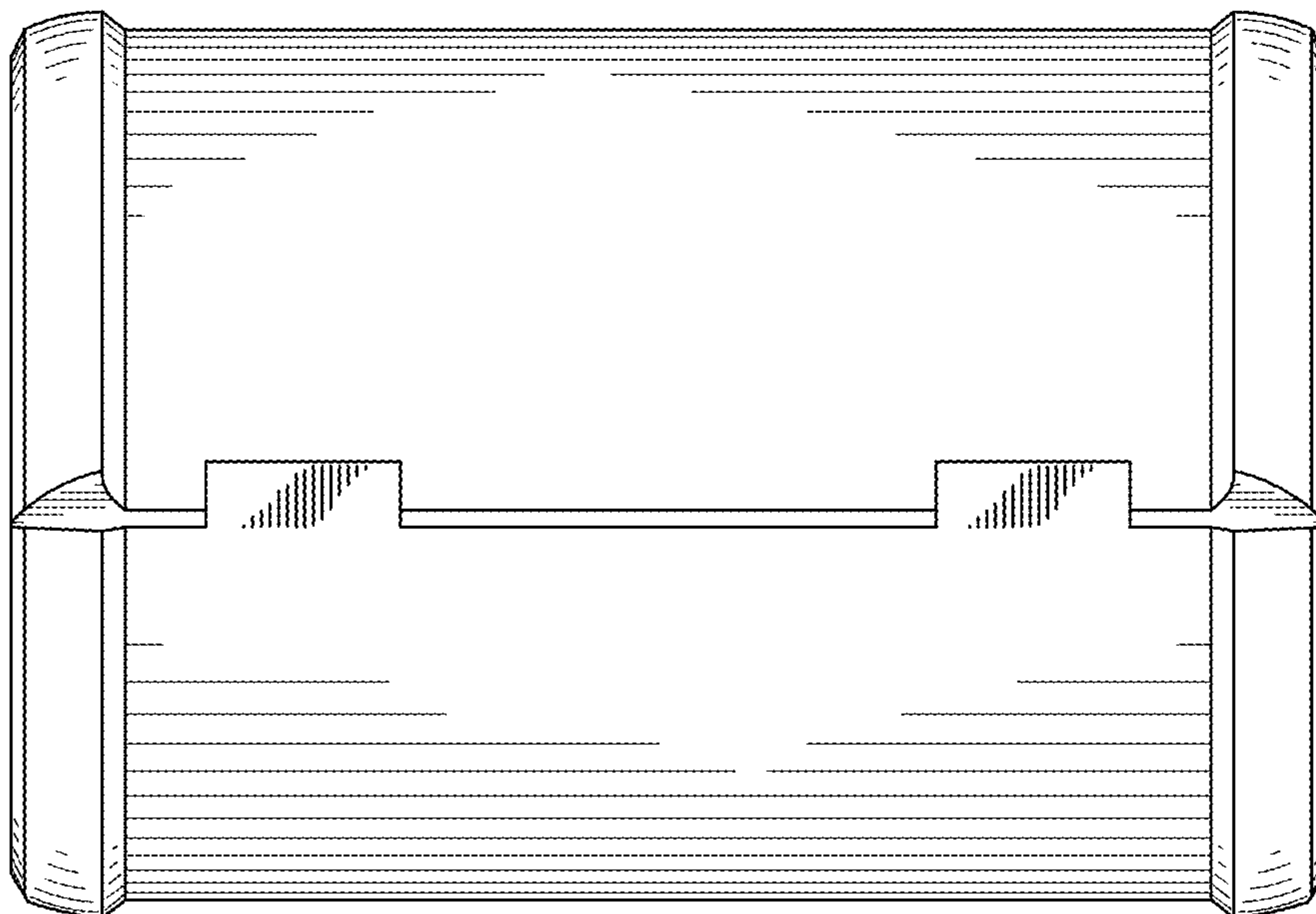

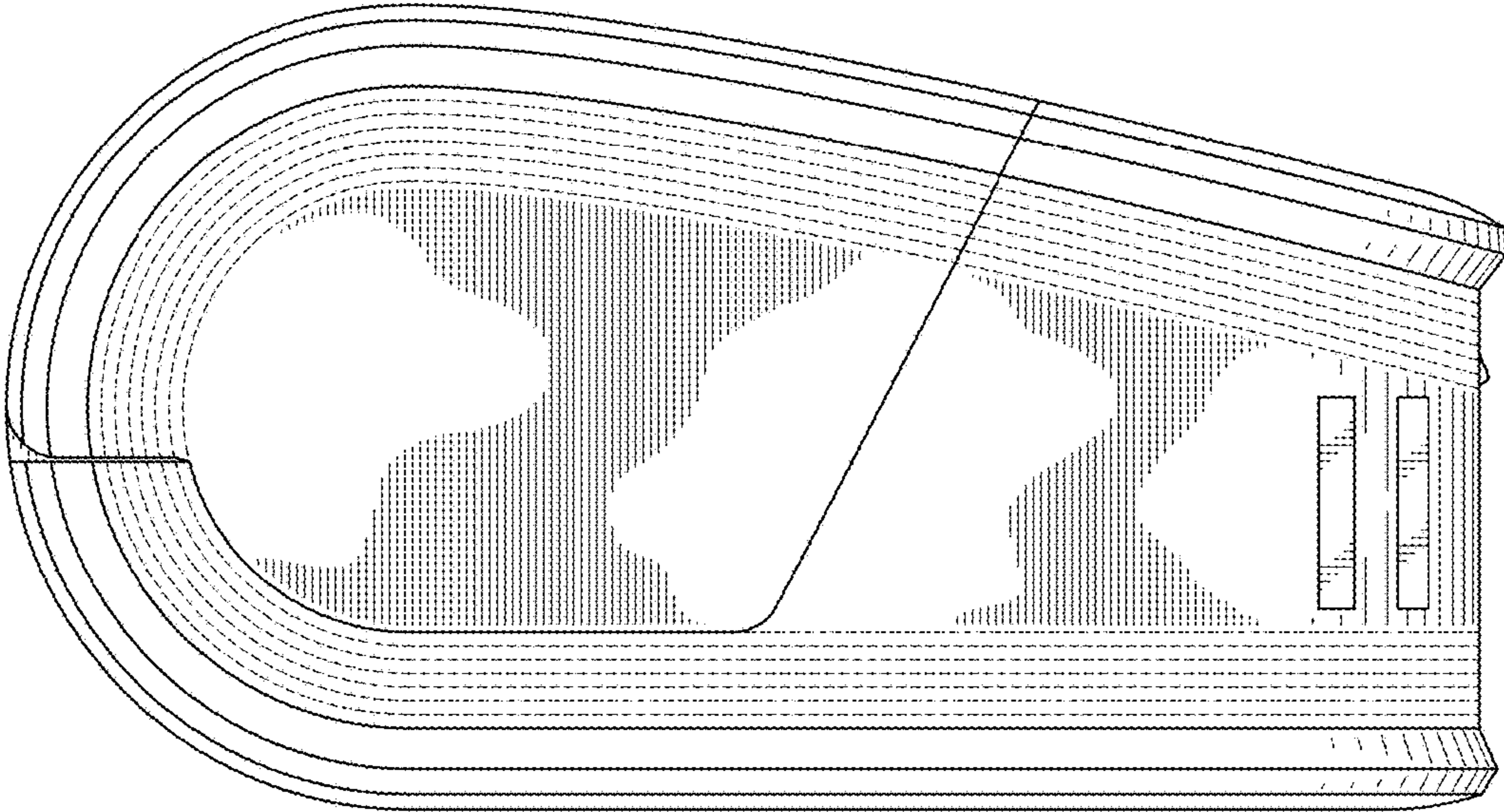

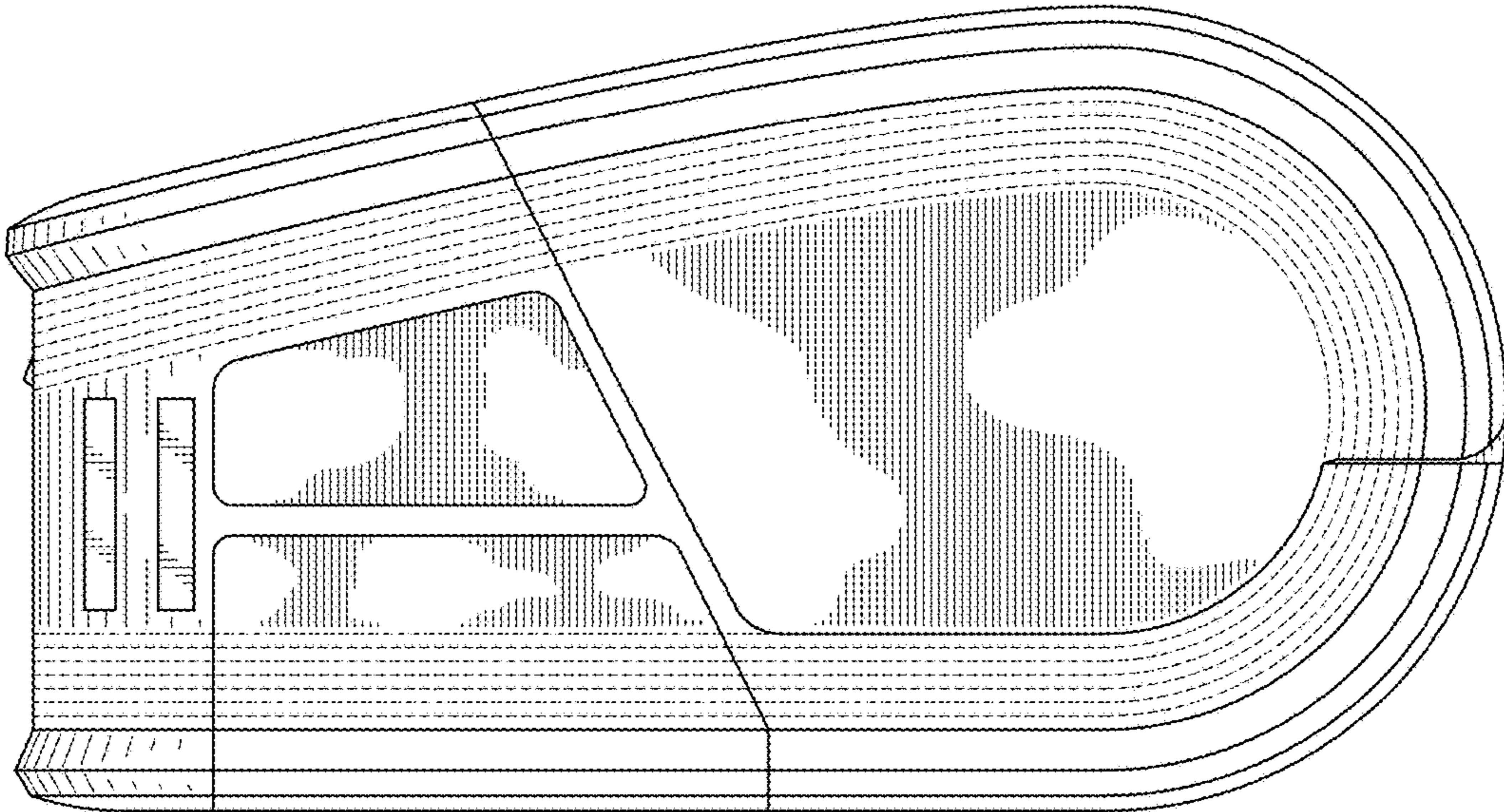

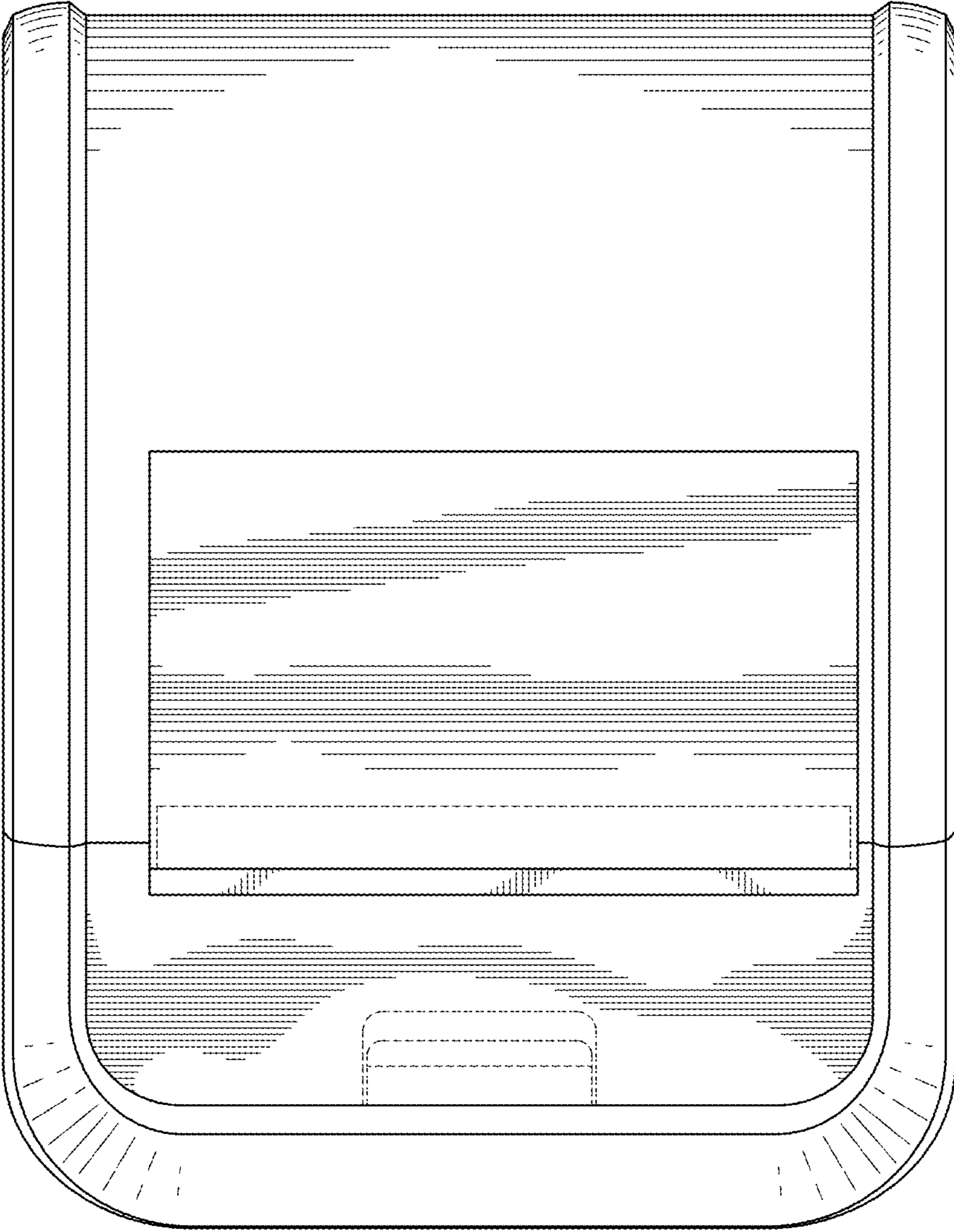
