(57) **CLAIM**

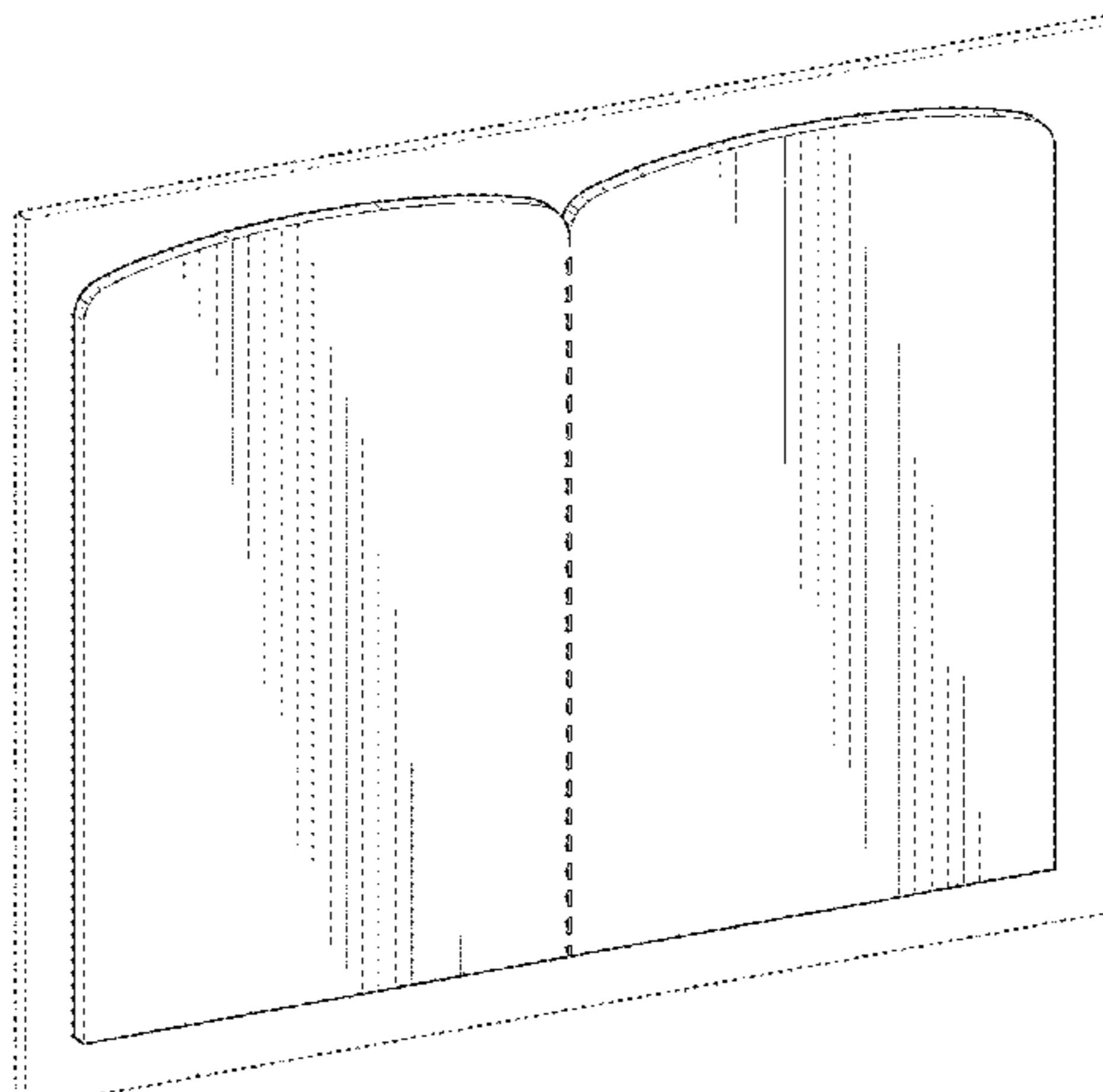
The ornamental design for a prescription label sheet, as shown and described.

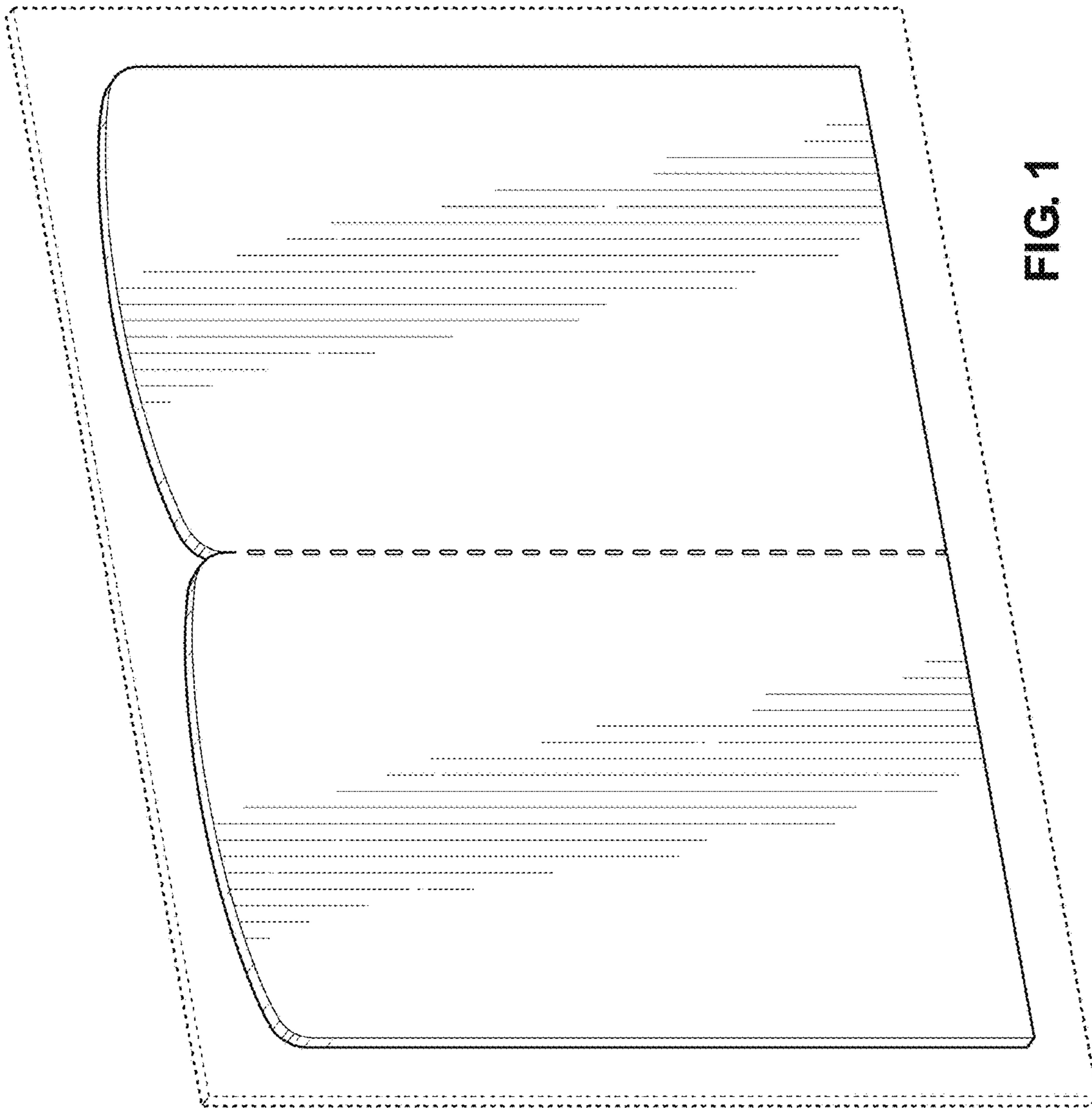

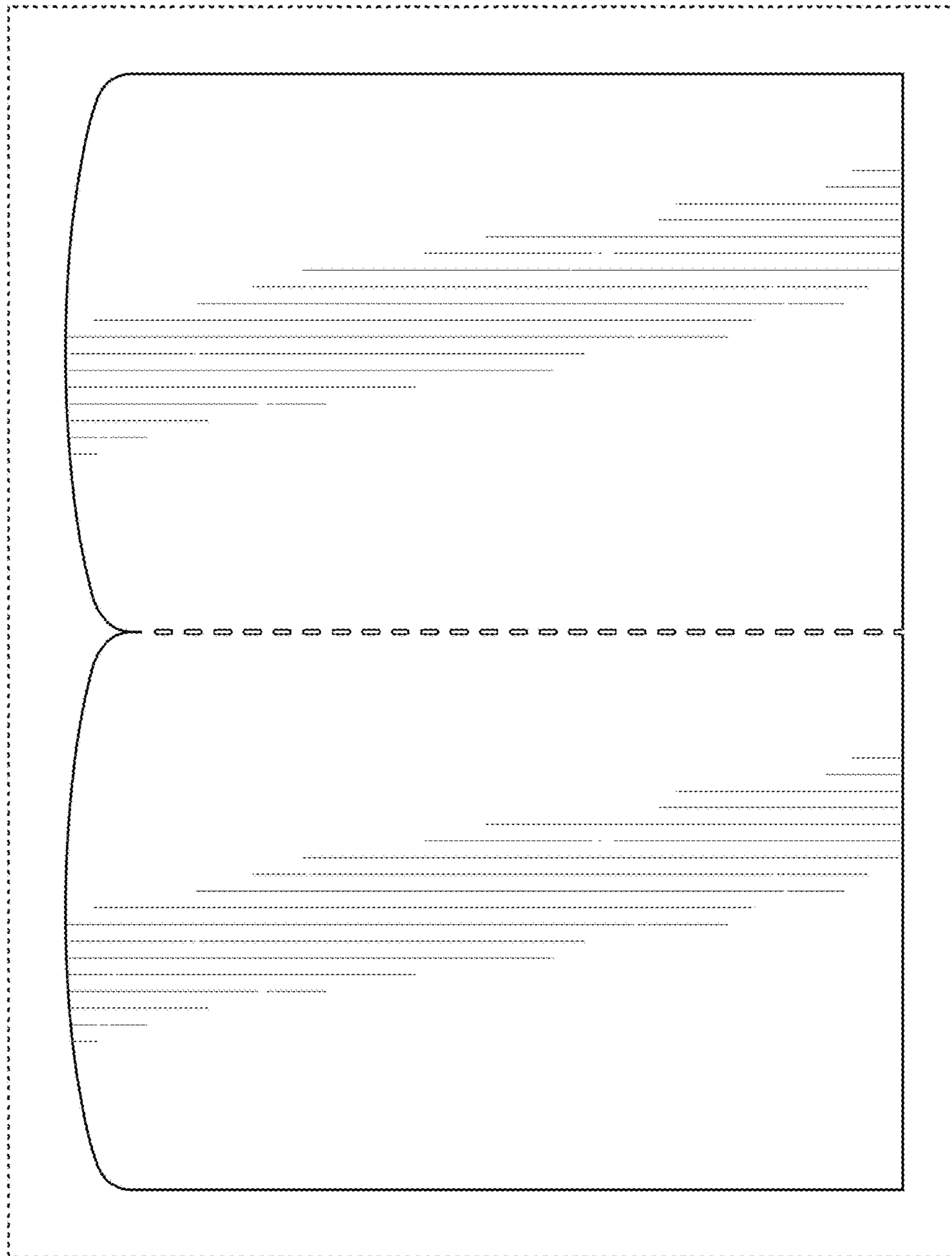
