The ornamental design for a wound dressing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a of a first embodiment of a wound dressing, showing our new design;

FIG. 13 is a front elevational view thereof;

FIG. 14 is a rear elevational view thereof;

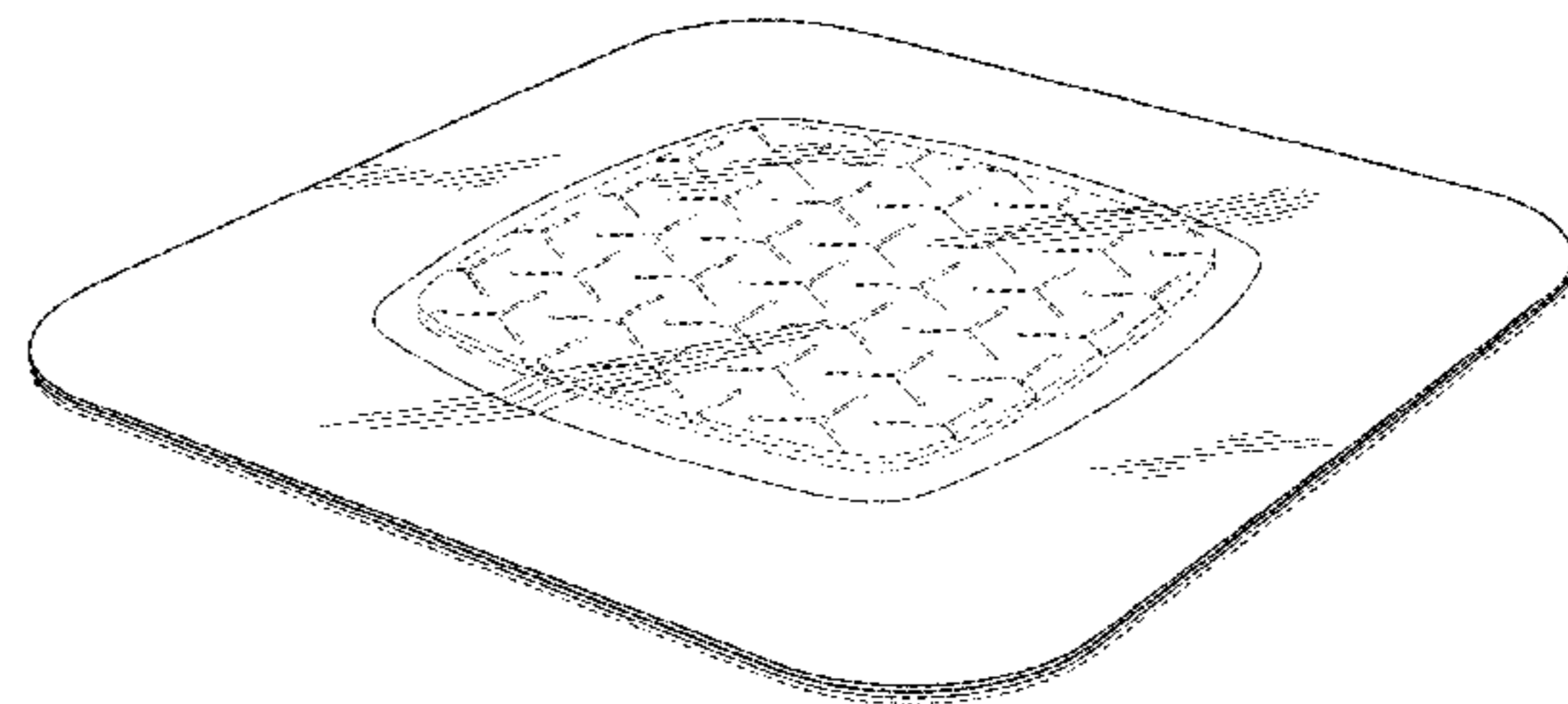
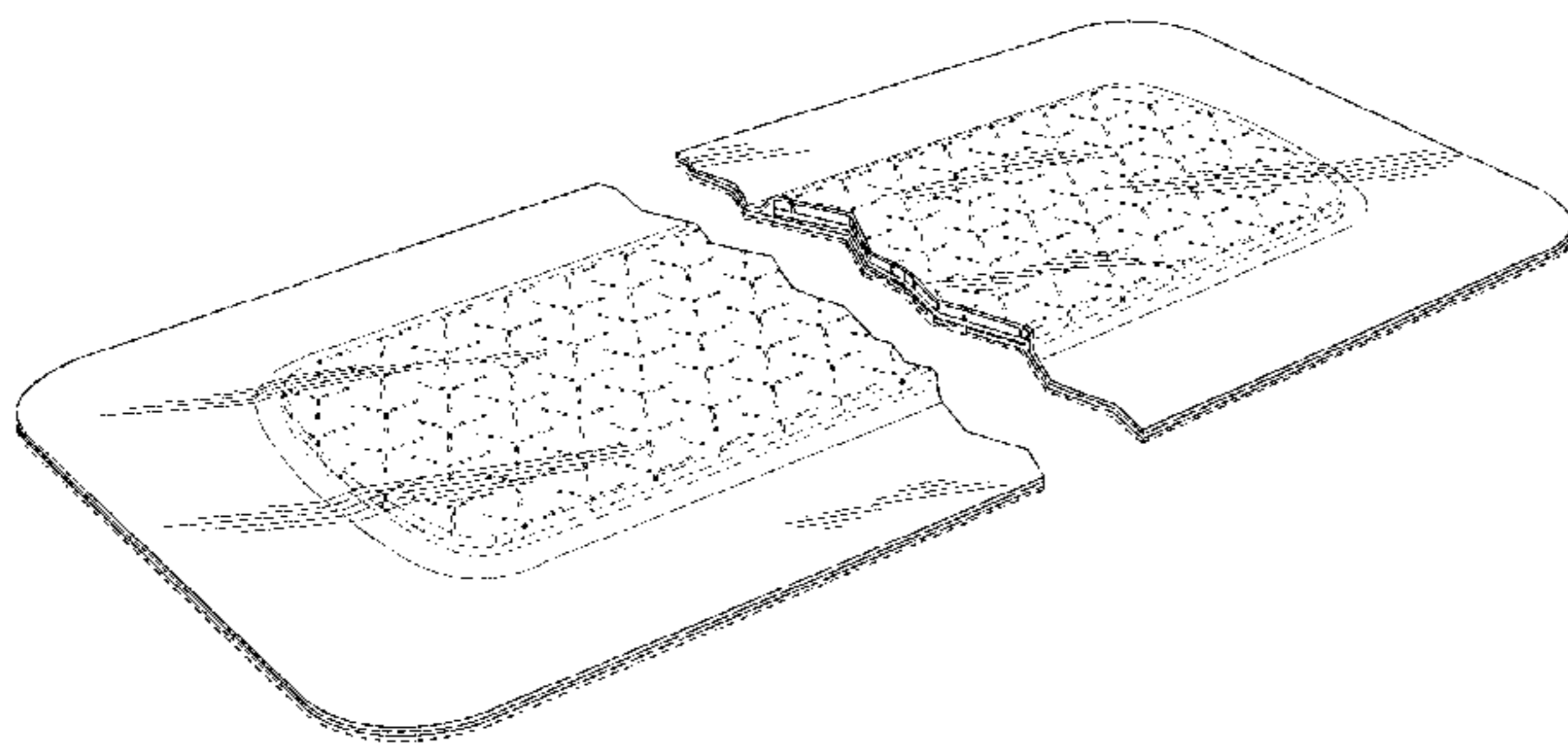
FIG. 15 is a top perspective exploded view of the first embodiment of a part of a wound dressing, showing our new design; and,

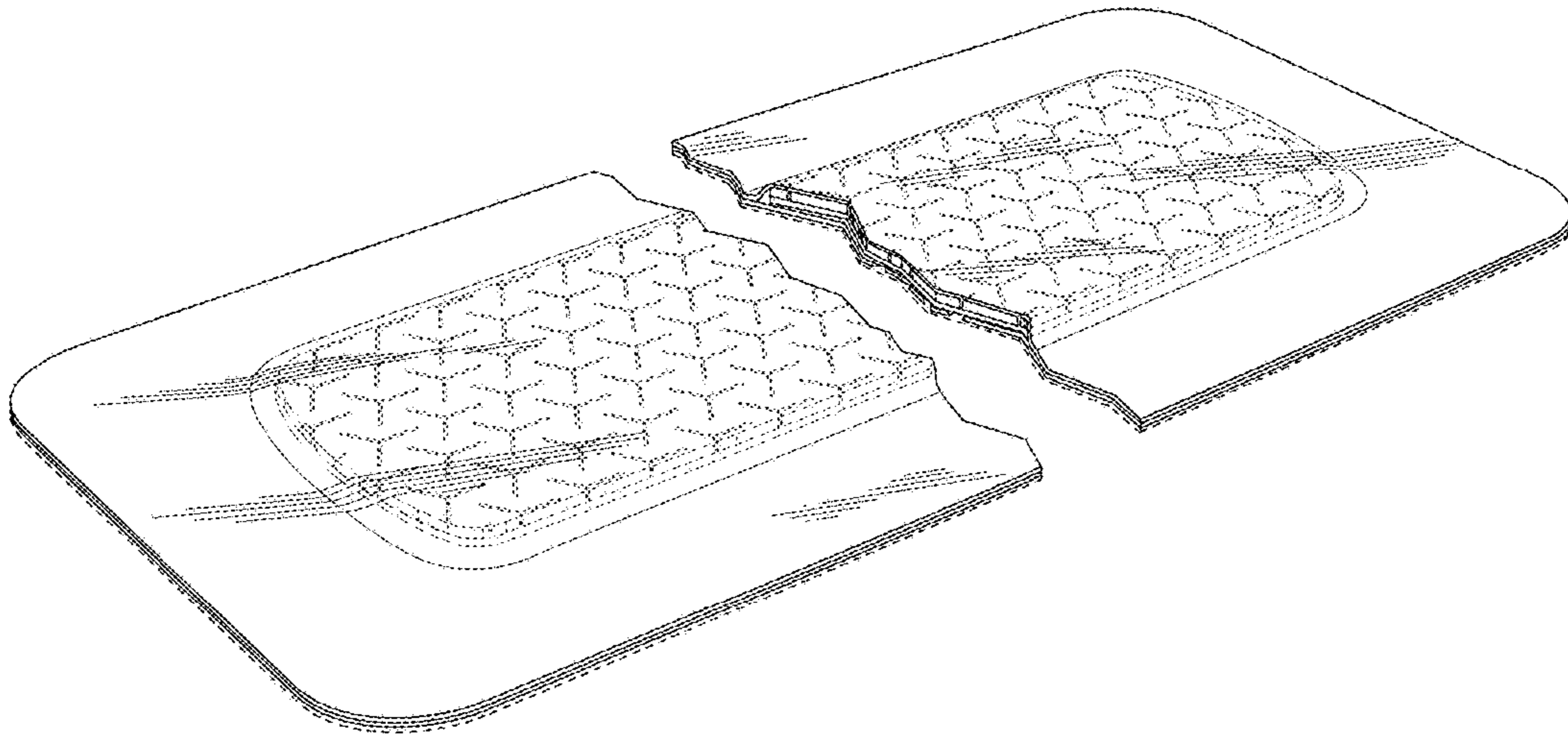

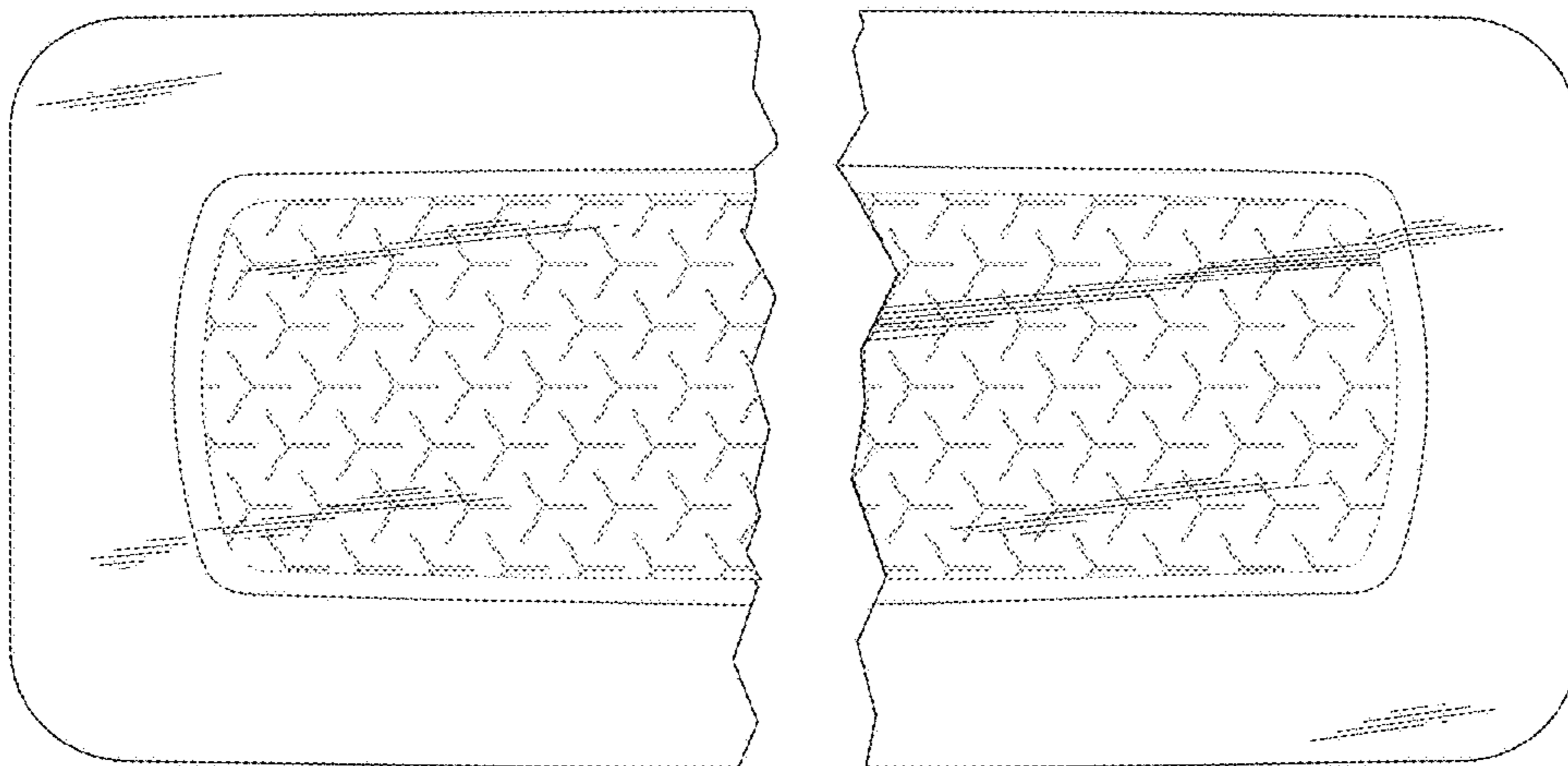

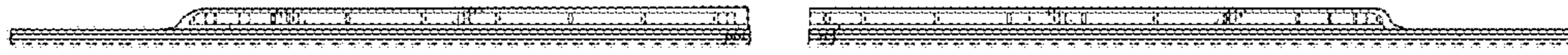

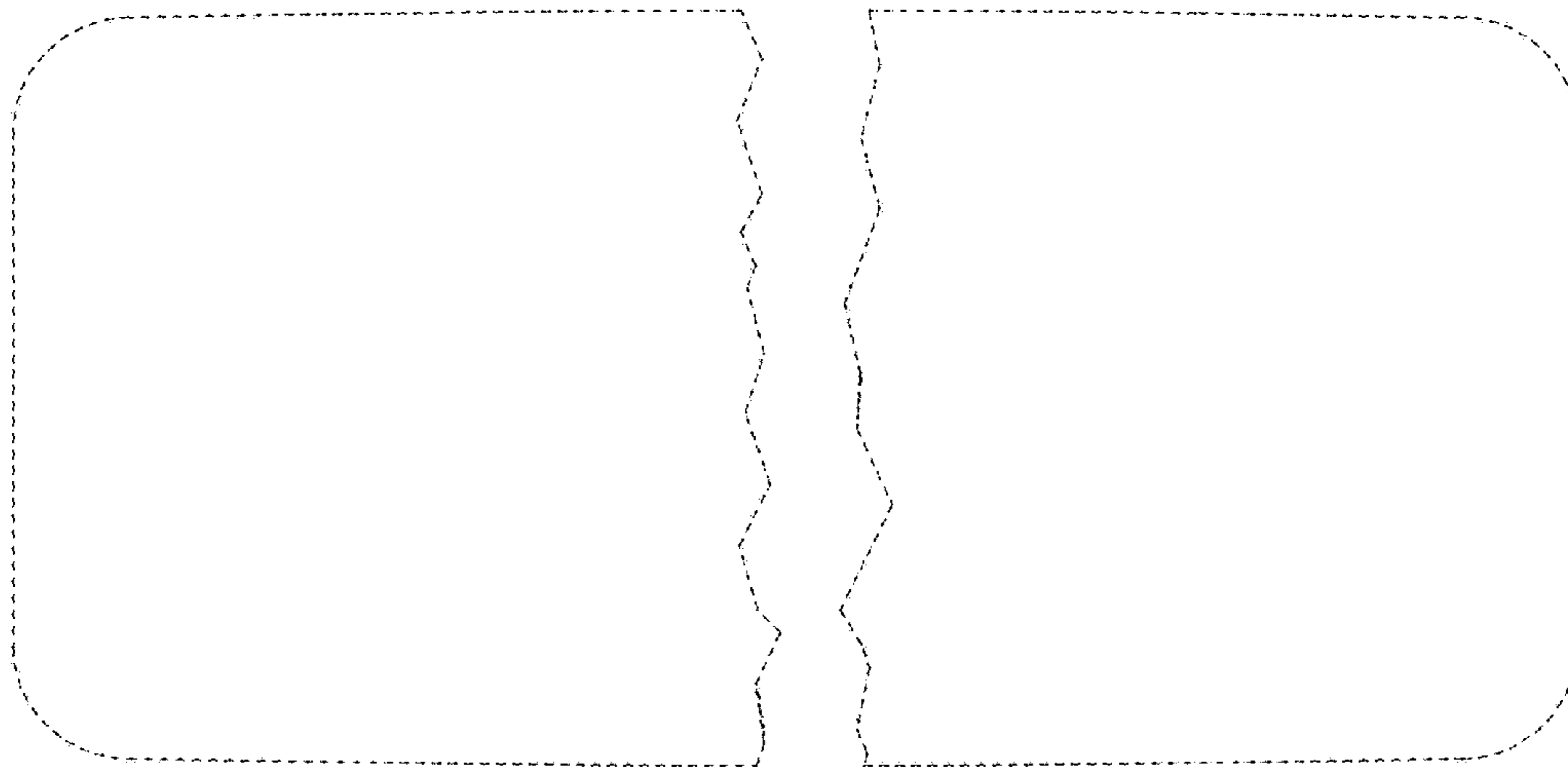

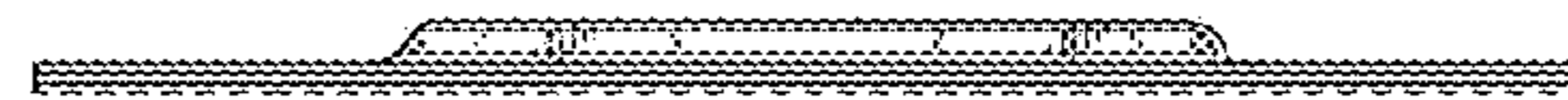

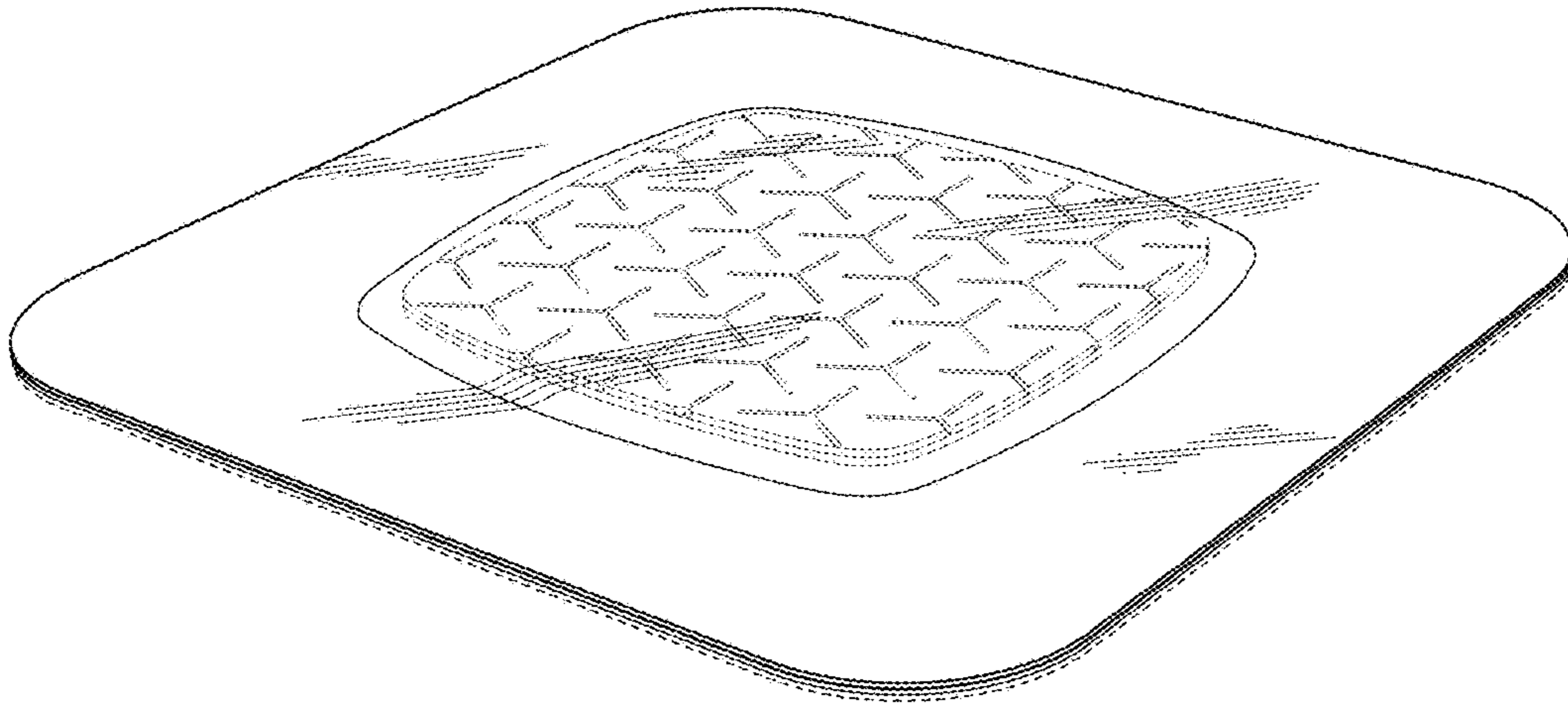

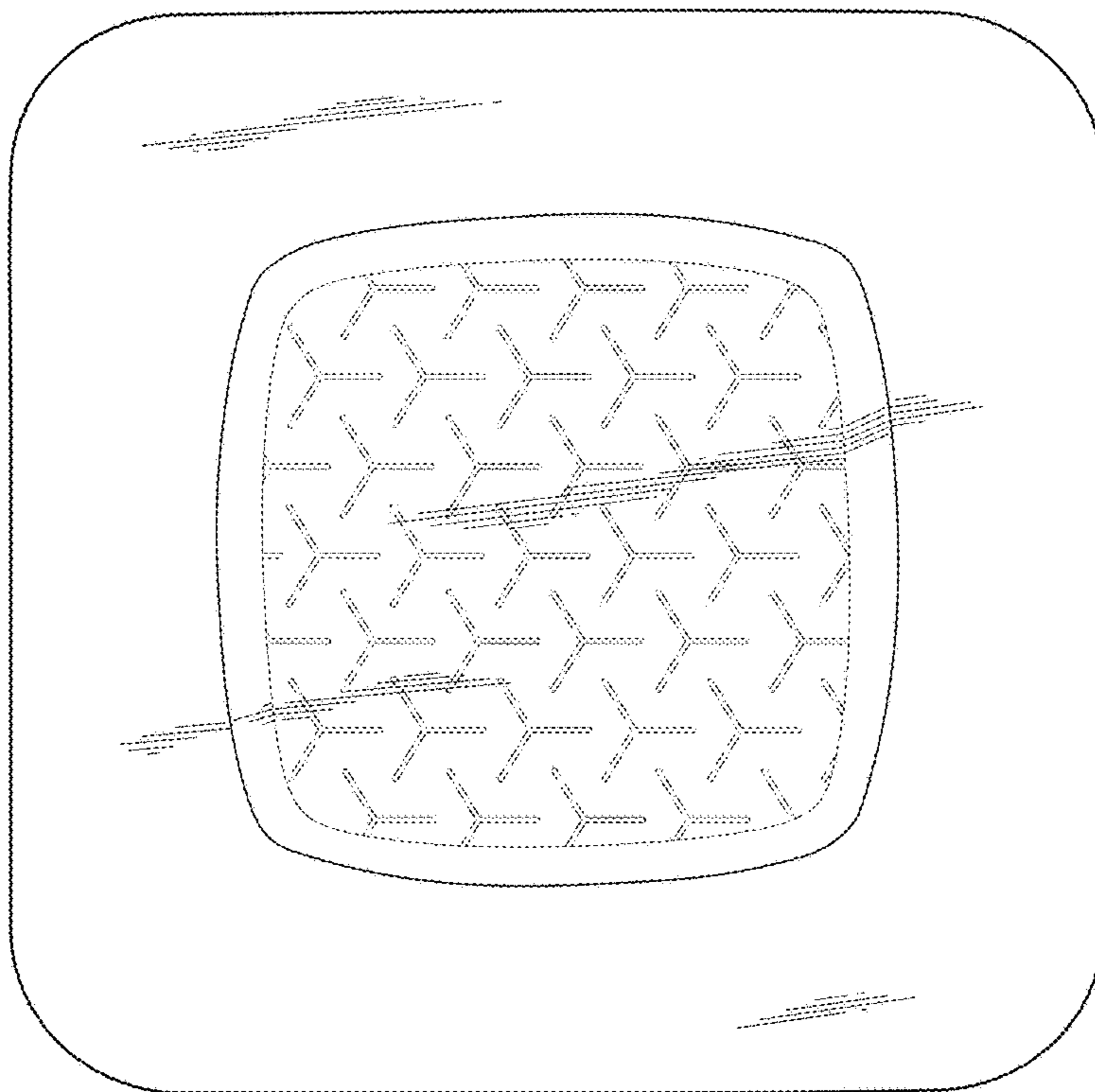

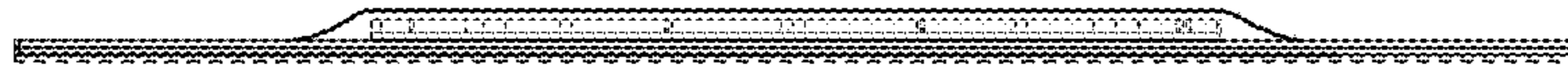

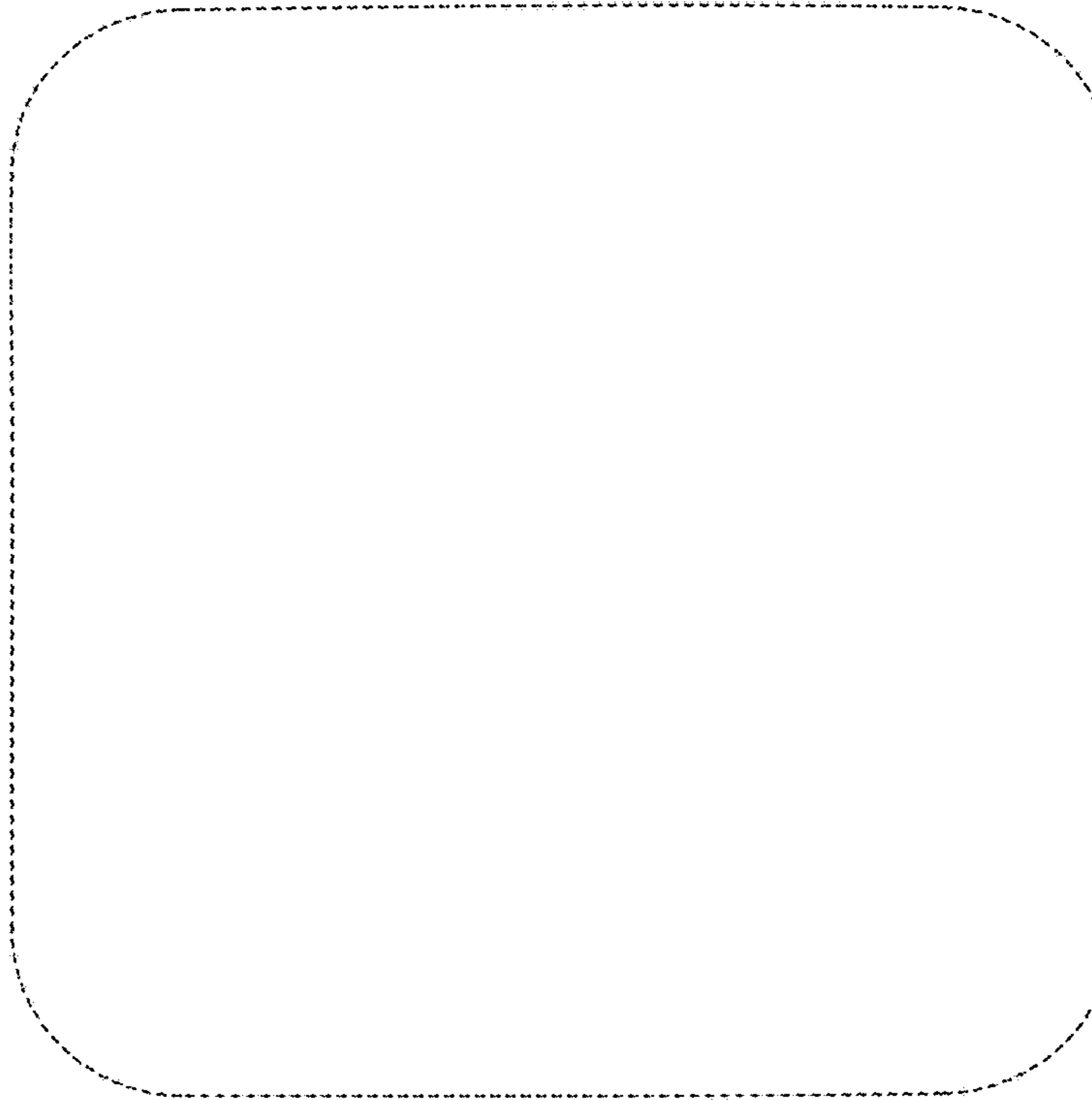

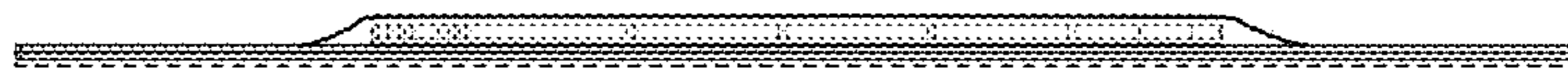

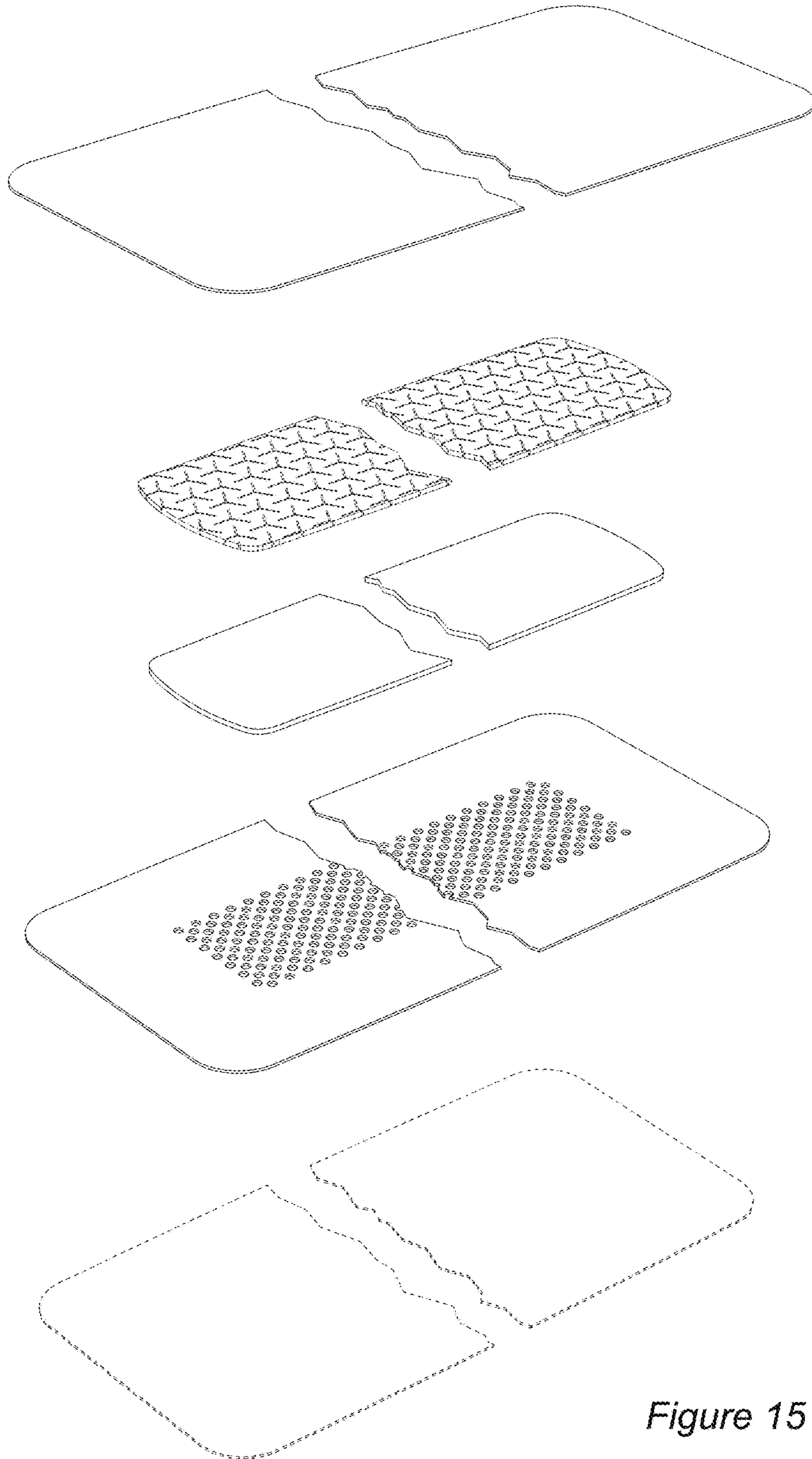

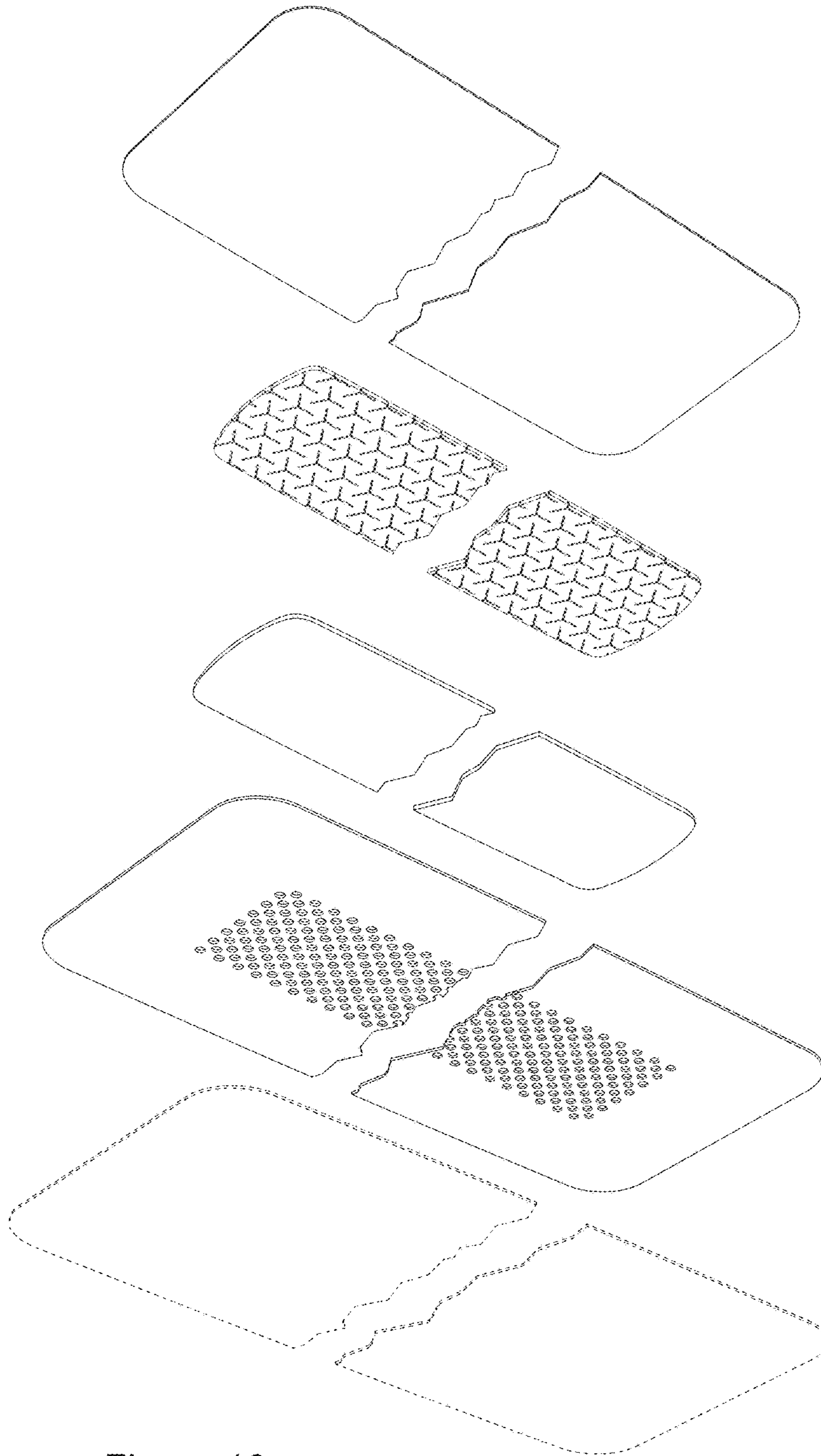
