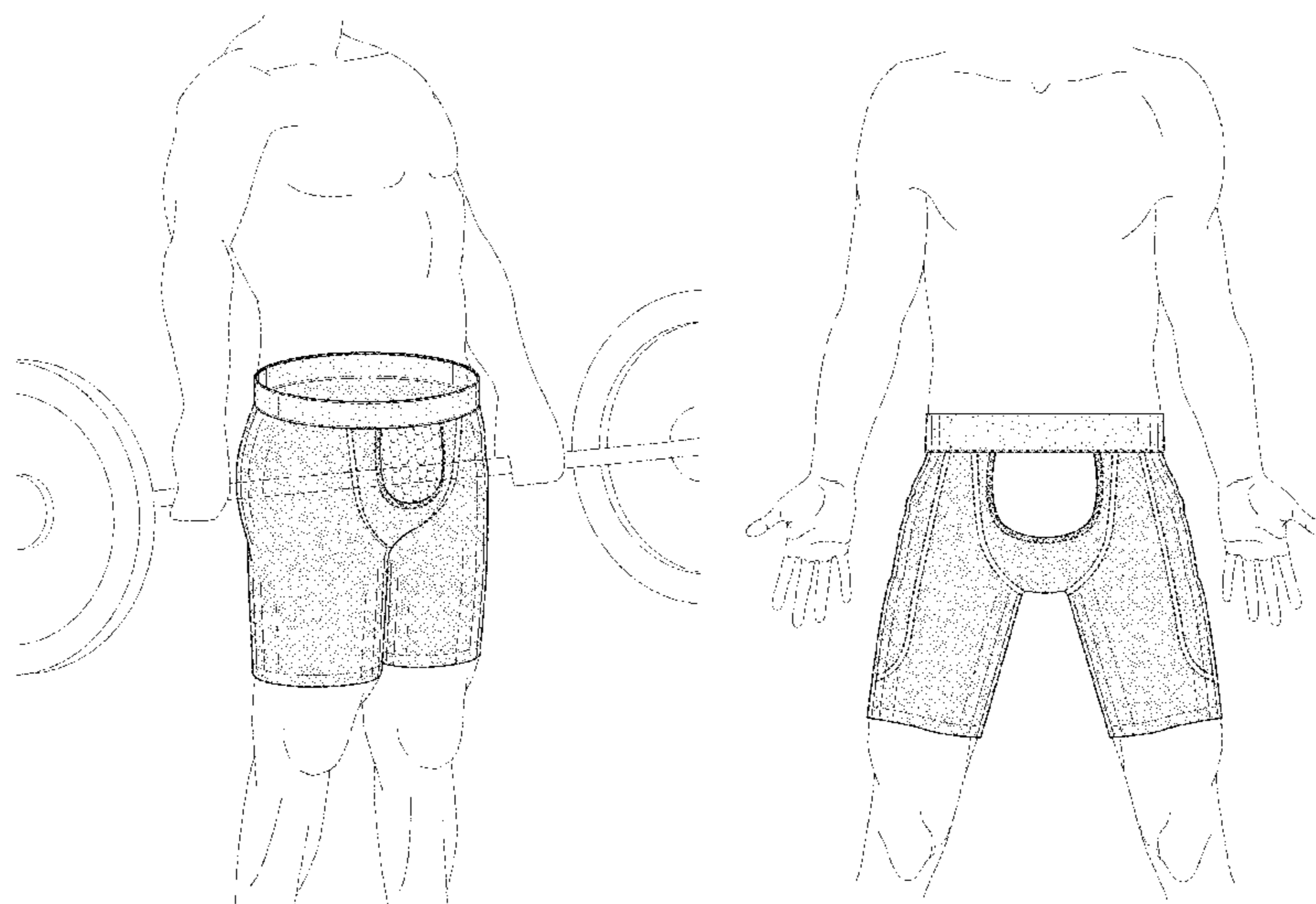
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front isometric view of a padded weight lifting short in accordance with the new design;

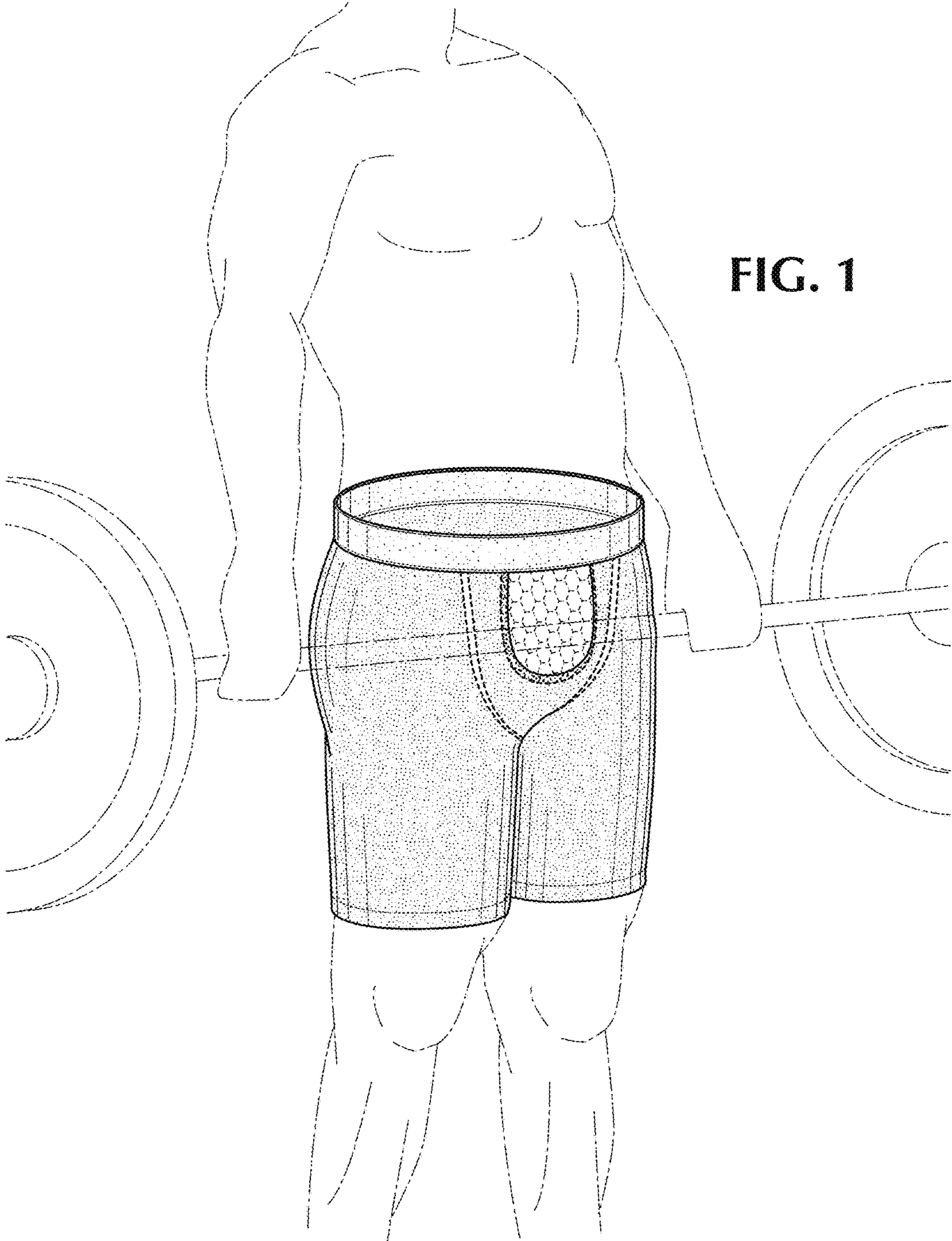

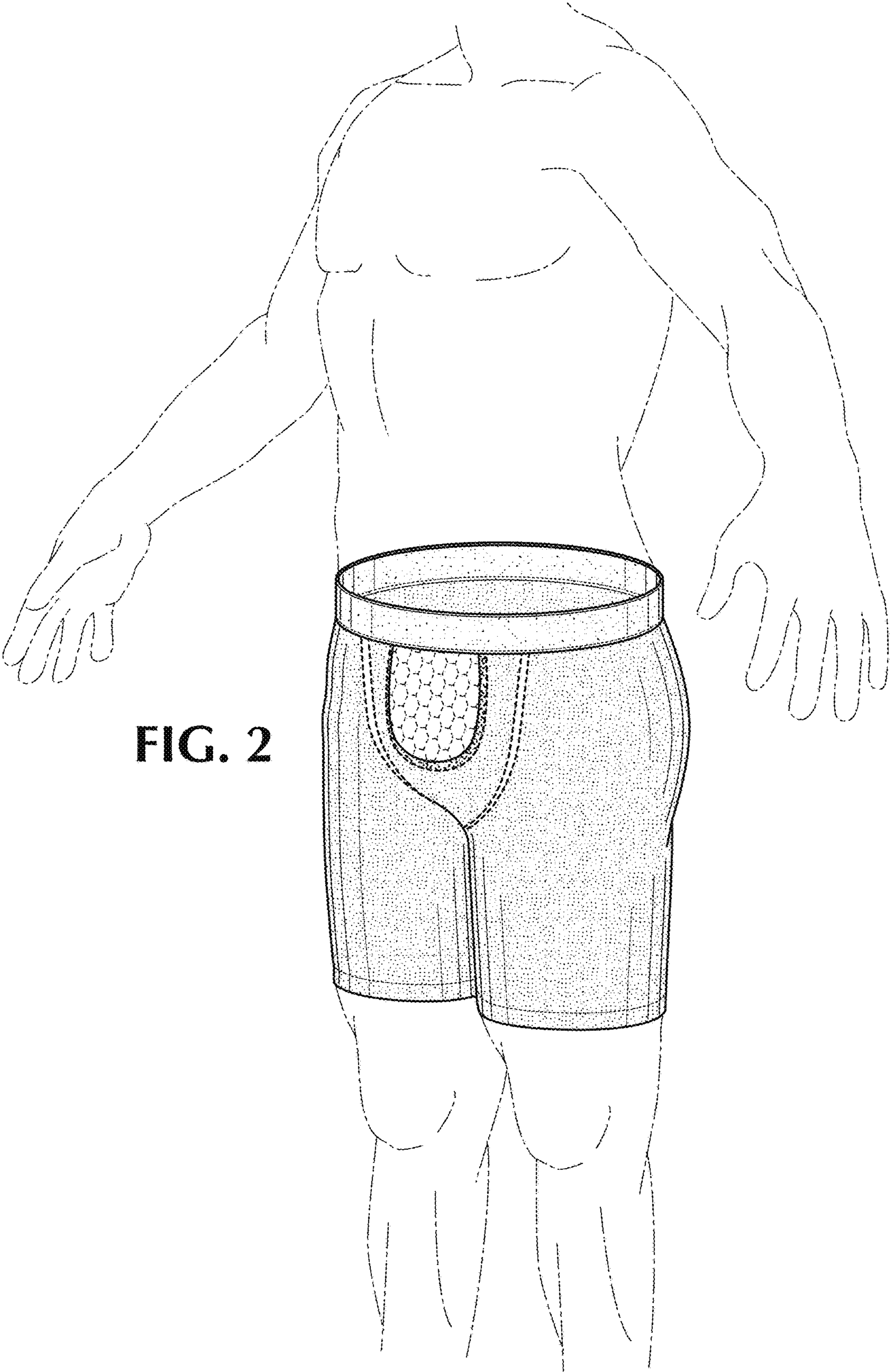

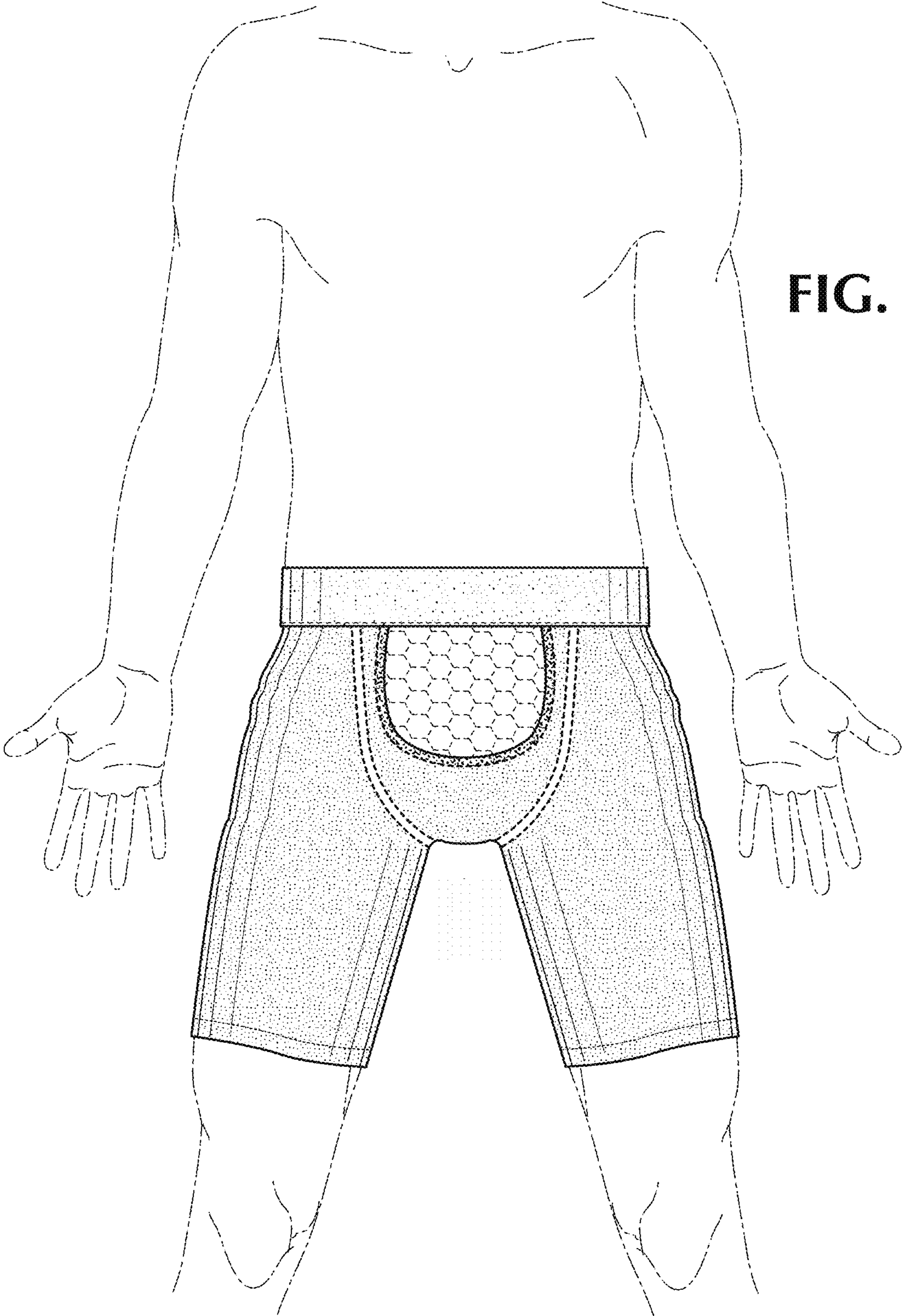

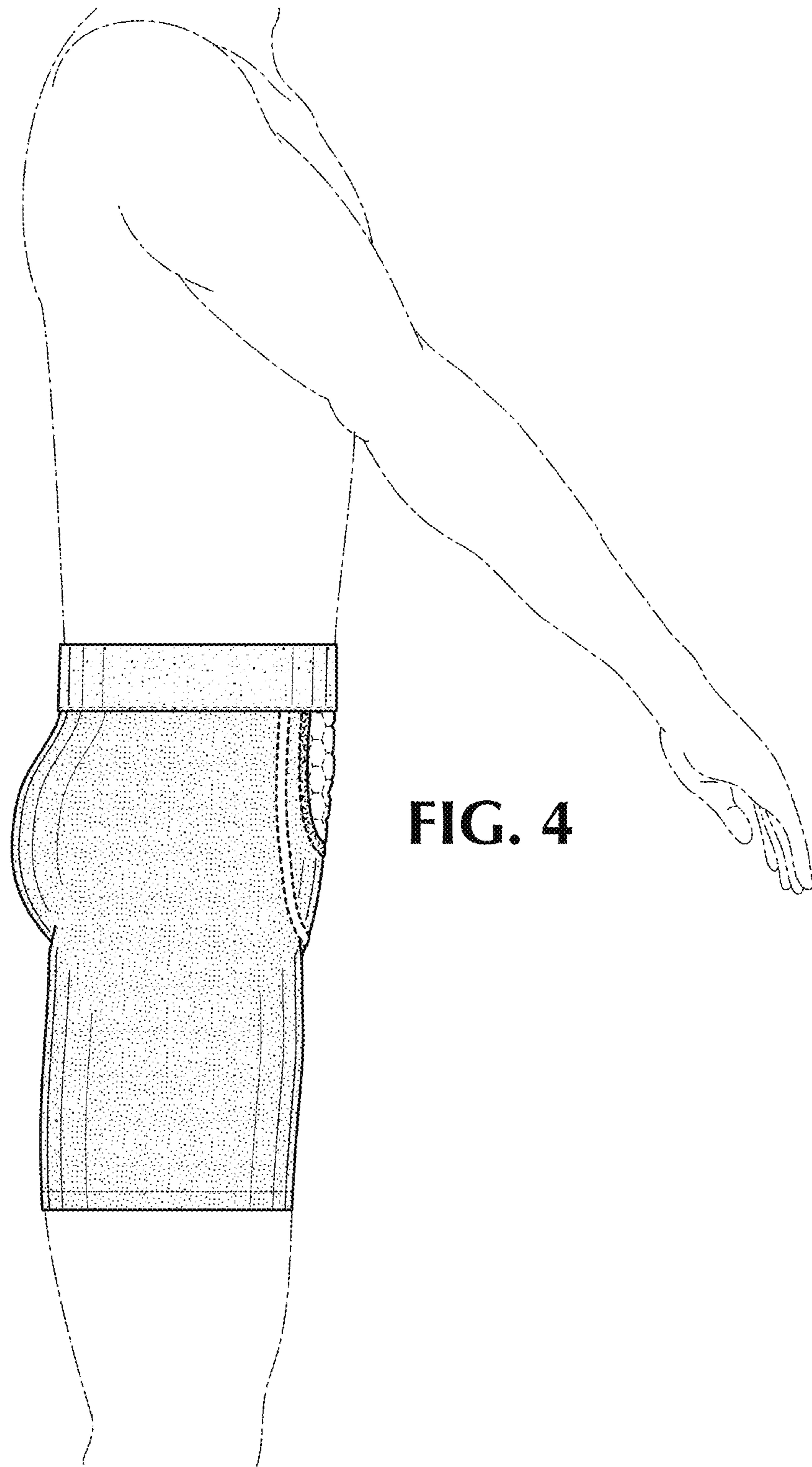

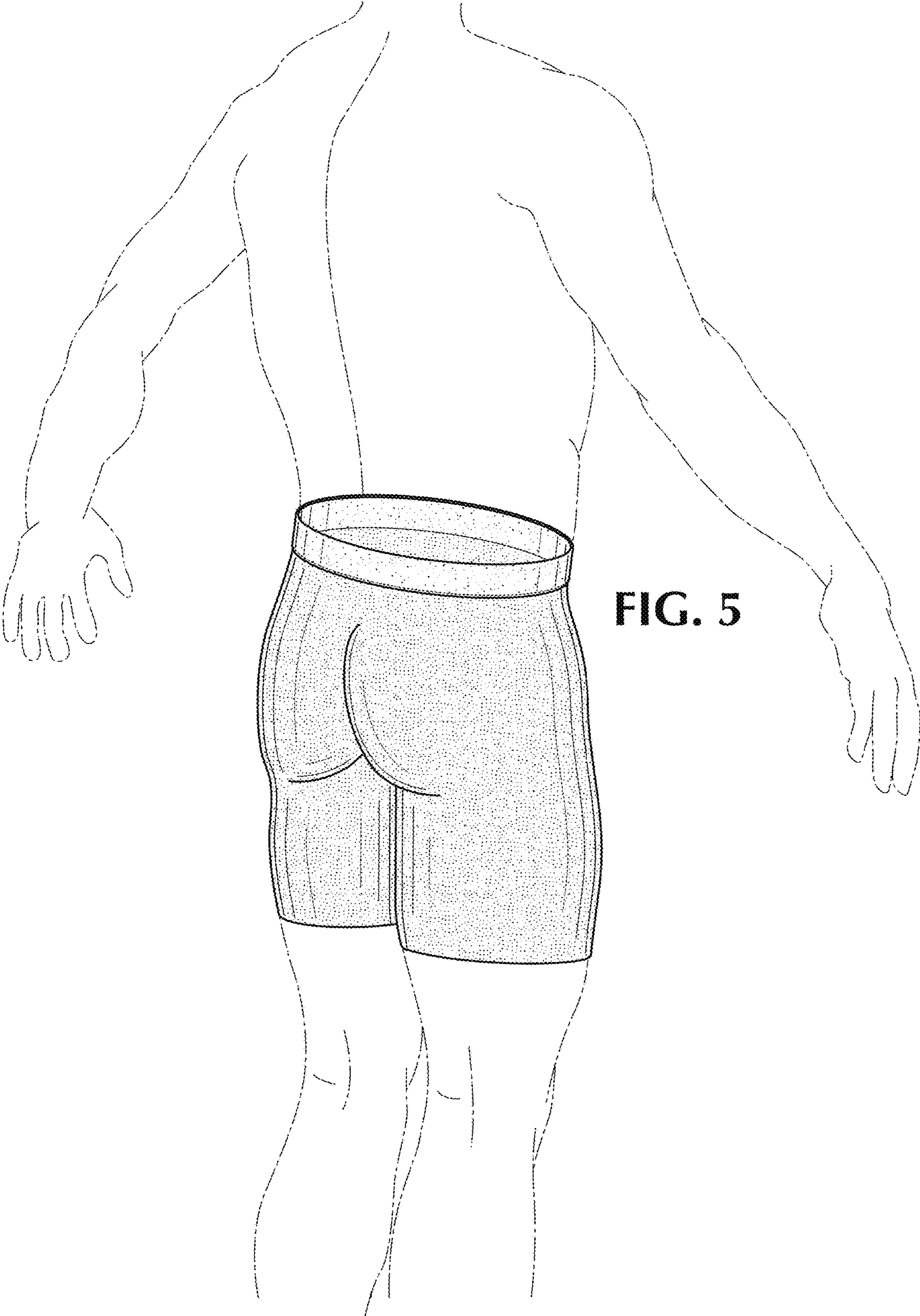

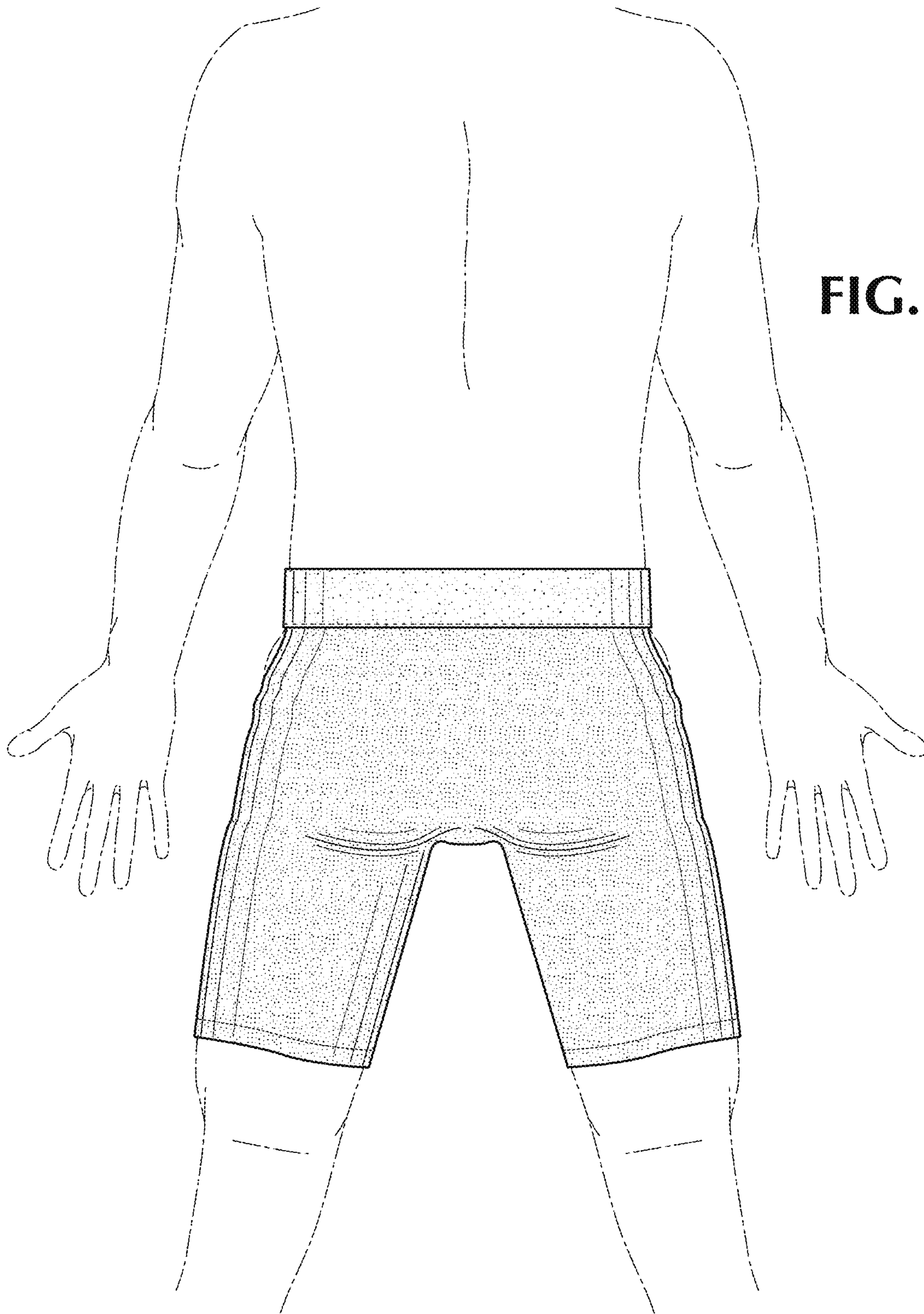

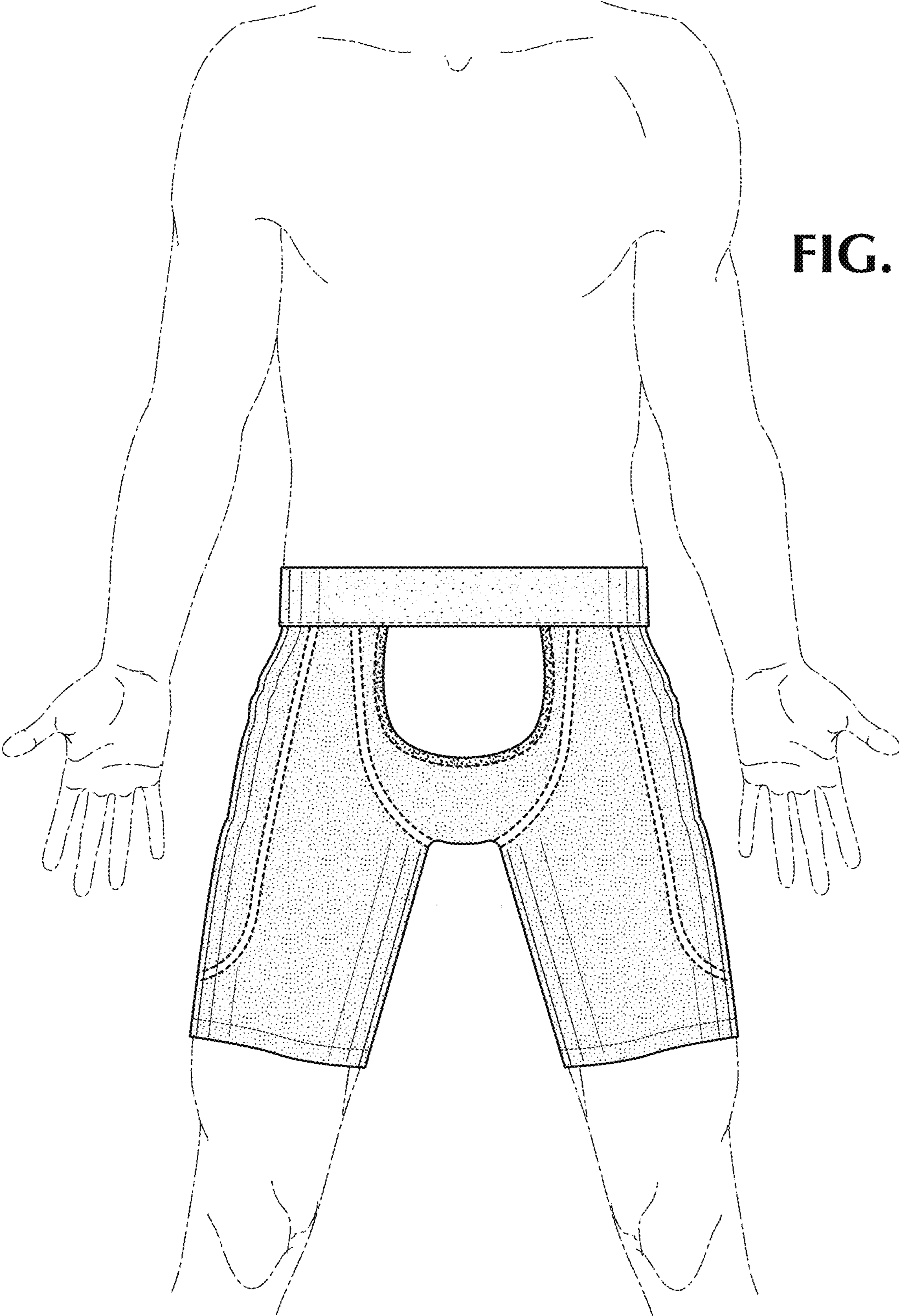

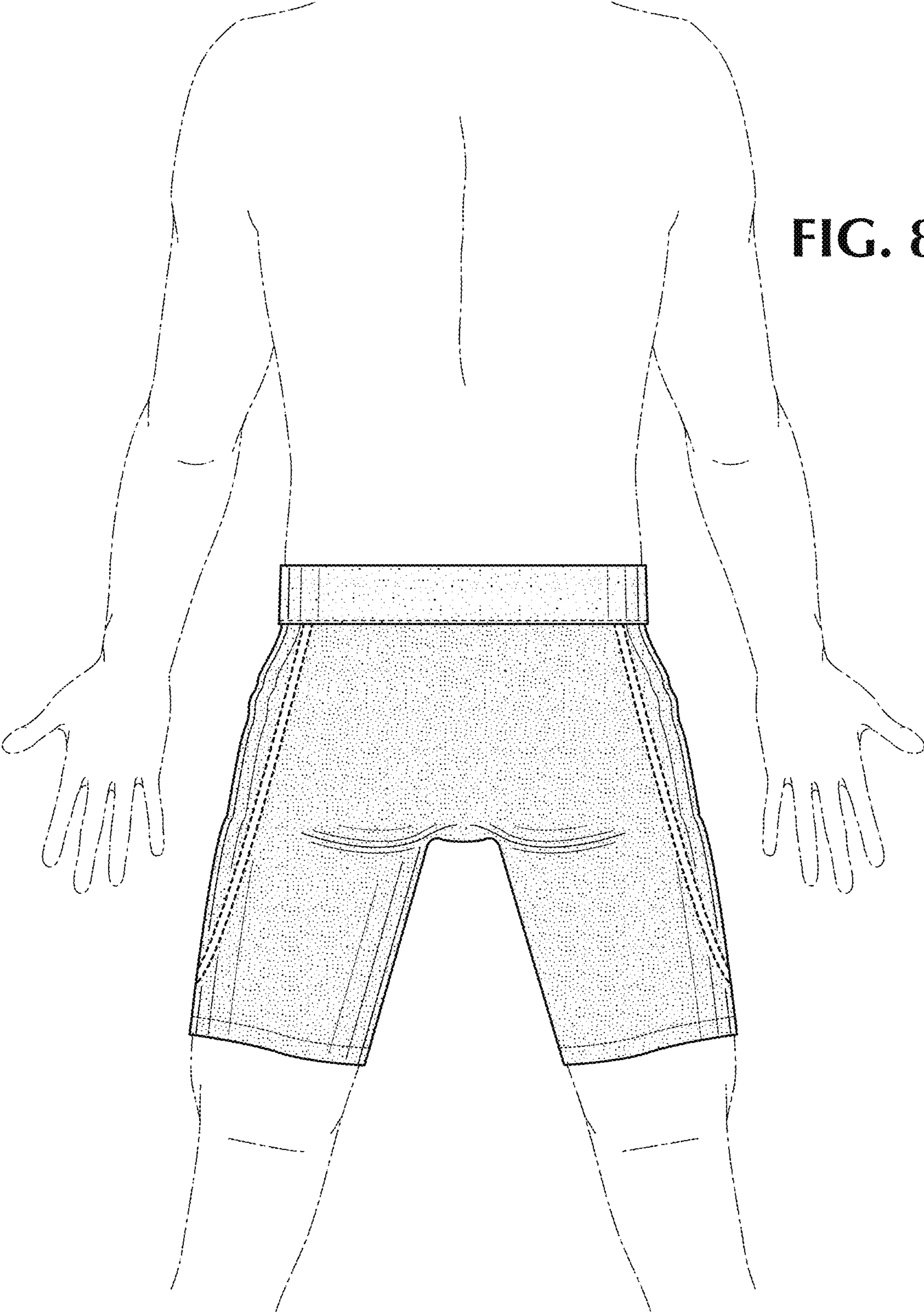
