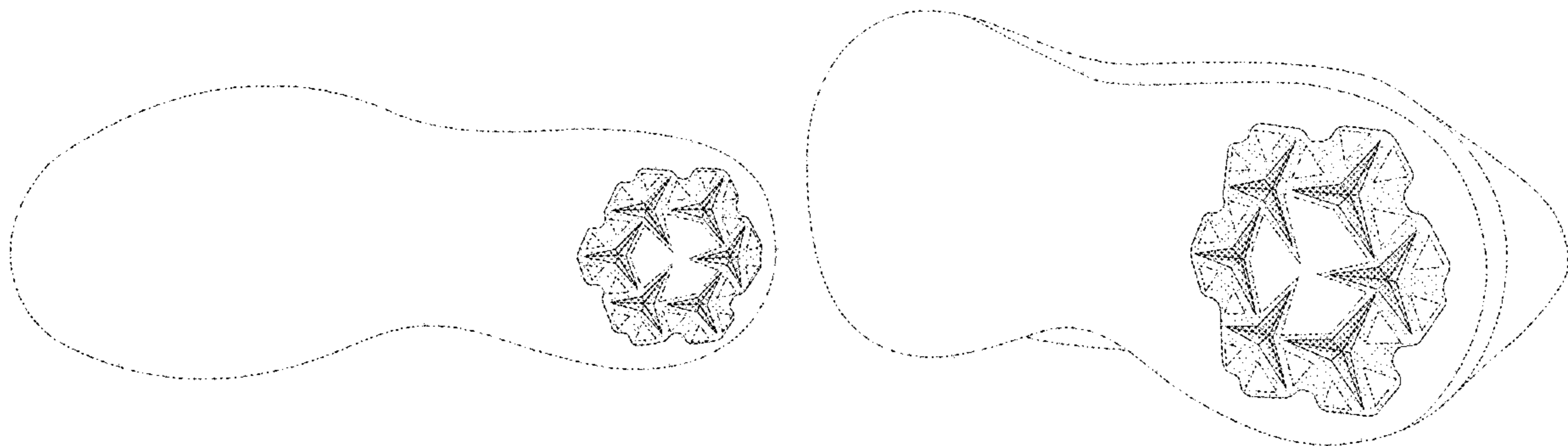
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a rear perspective view thereof;
 FIG. 4 is an enlarged rear perspective view with unclaimed subject matter omitted; and,
 FIG. 5 is an additional enlarged rear perspective view with unclaimed subject matter omitted.
 The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The nineteen unshaded regions within the shaded area that are demarcated by broken lines form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

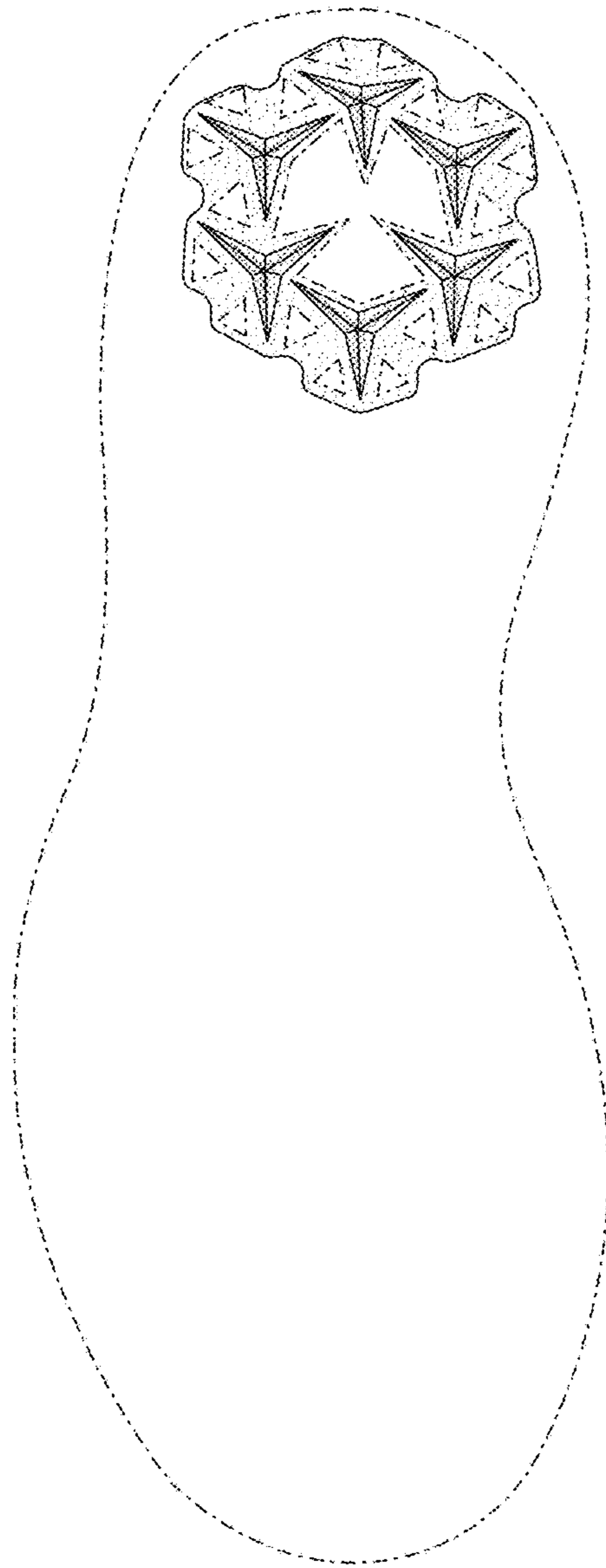

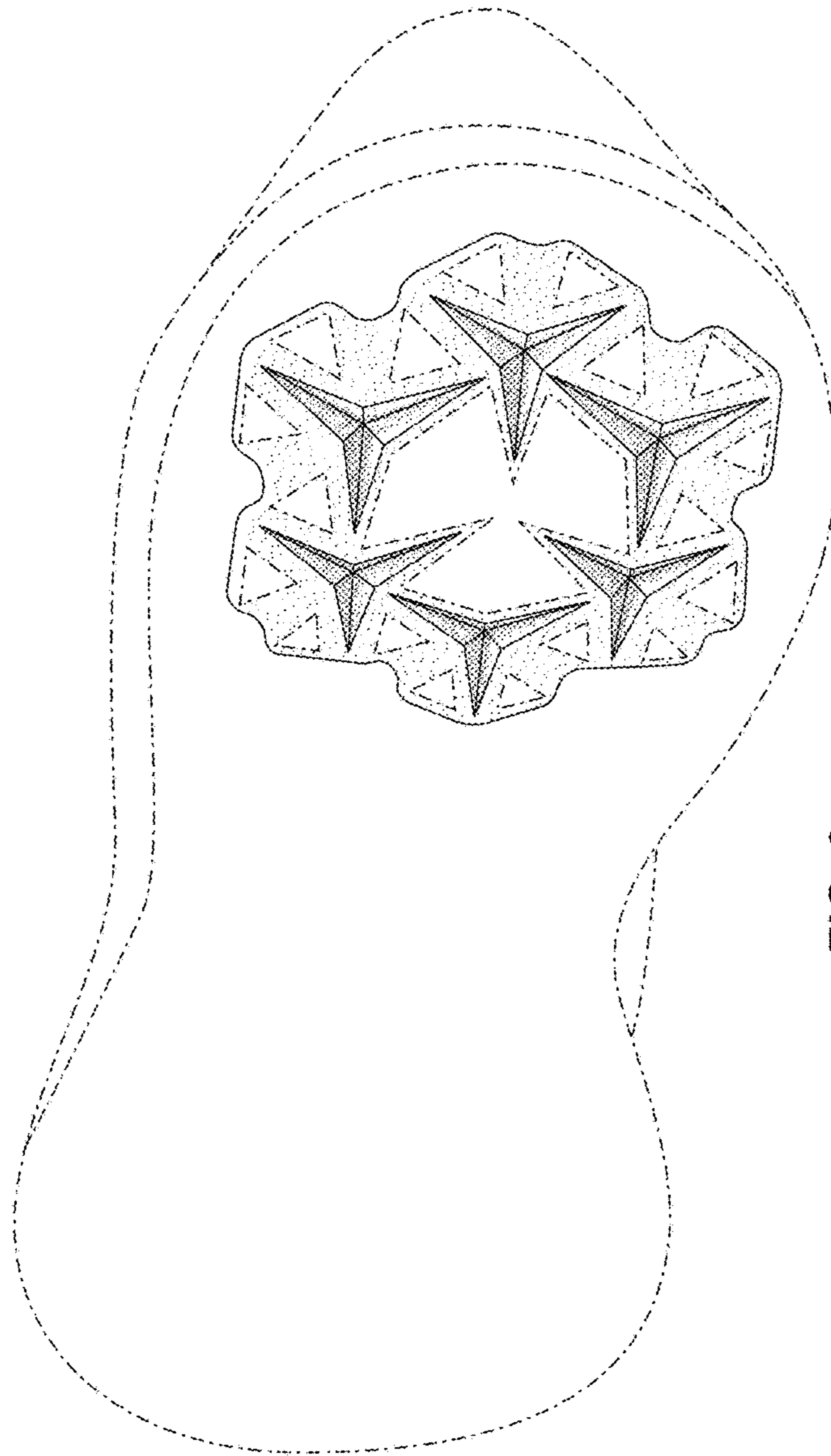

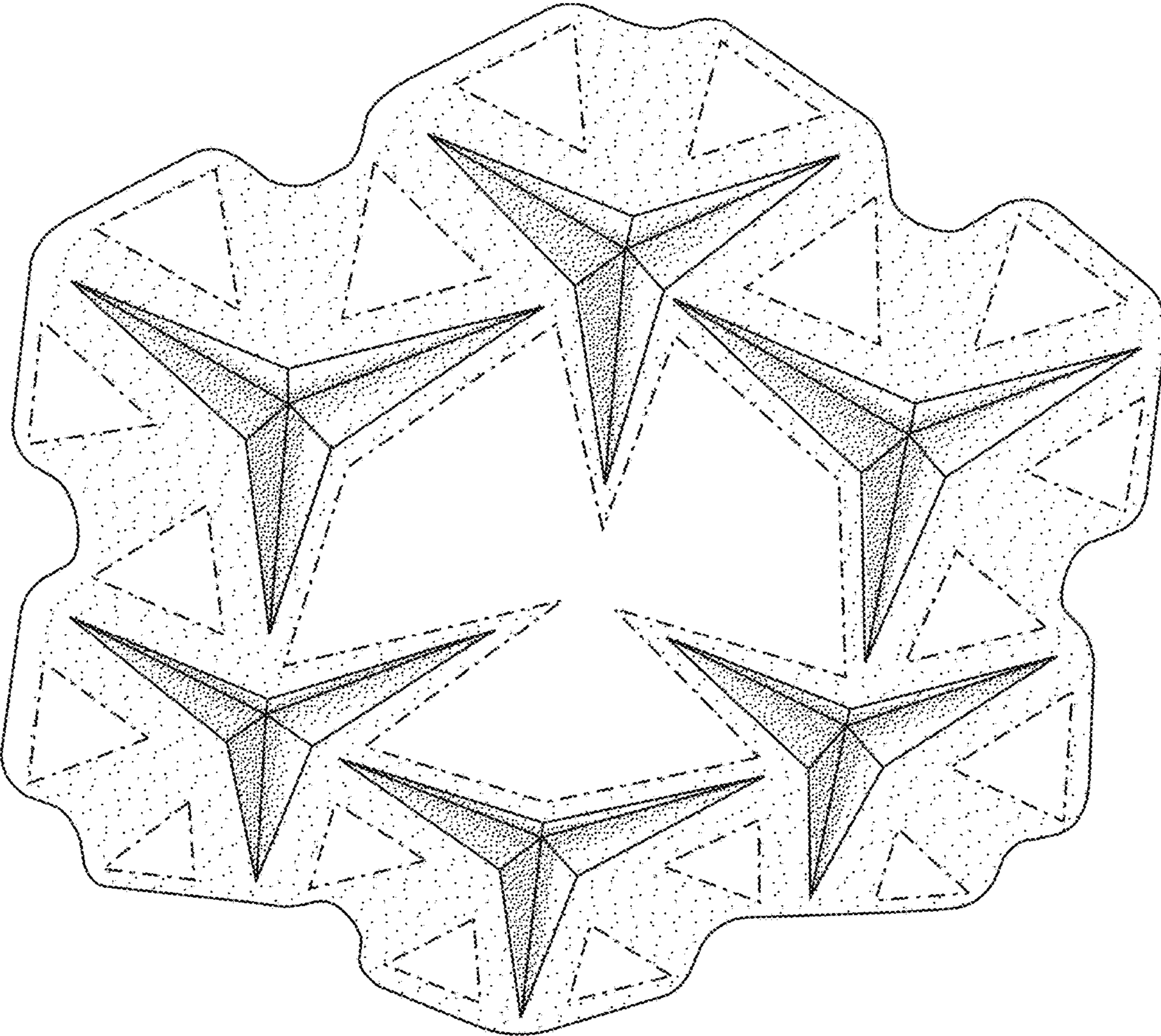

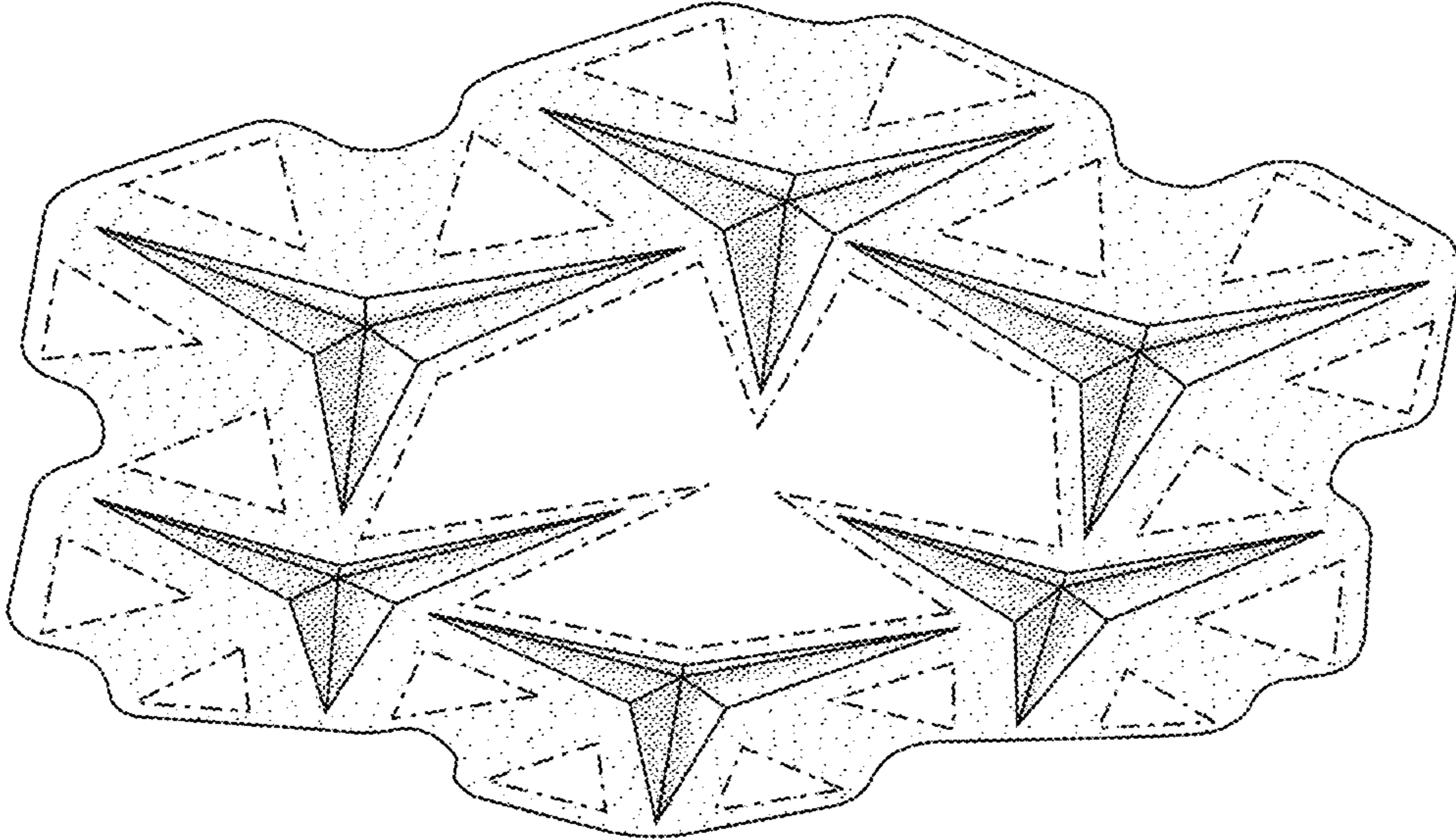
