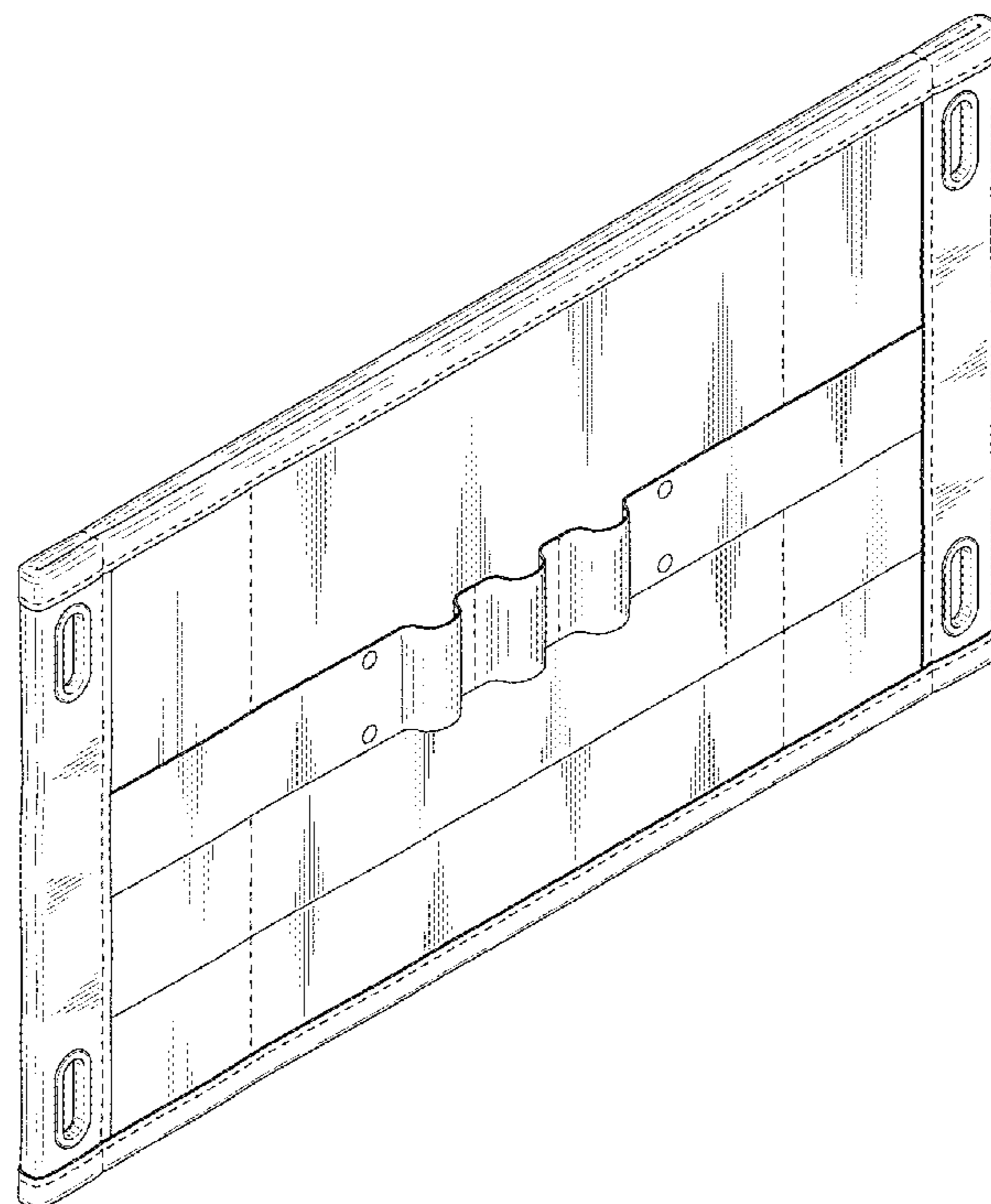
(57) **CLAIM**

The ornamental design for a toiletry bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the toiletry bag; FIG. 2 is a front side view of the toiletry bag; FIG. 3 is a back side view of the toiletry bag; FIG. 4 is a left side view of the toiletry bag; FIG. 5 is a right side view of the toiletry bag; FIG. 6 is a top view of the toiletry bag; FIG. 7 is a bottom view of the toiletry bag; and, FIG. 8 is a second perspective view of the toiletry bag shown open. The broken lines on the toiletry bag represent unclaimed stitching.

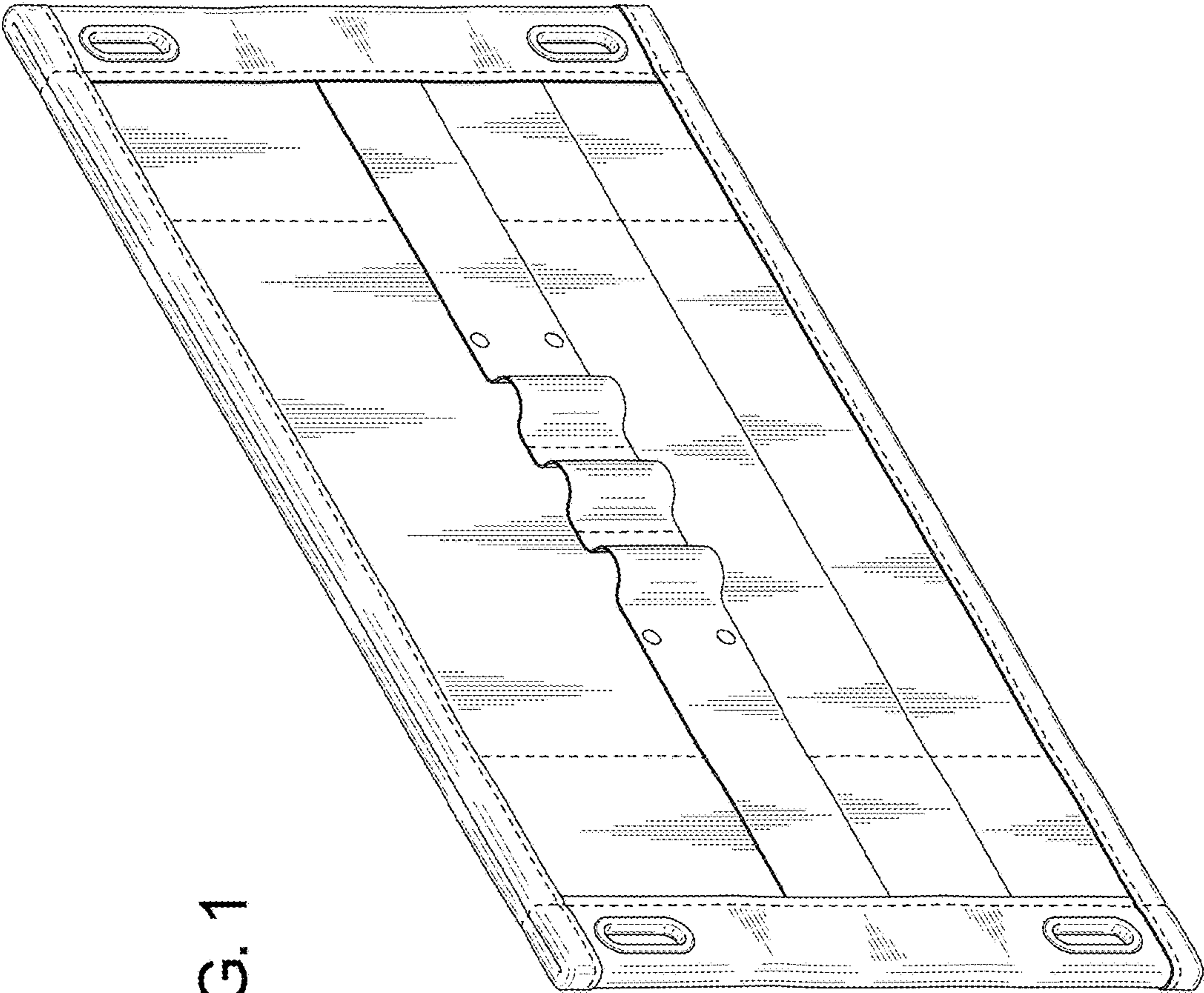

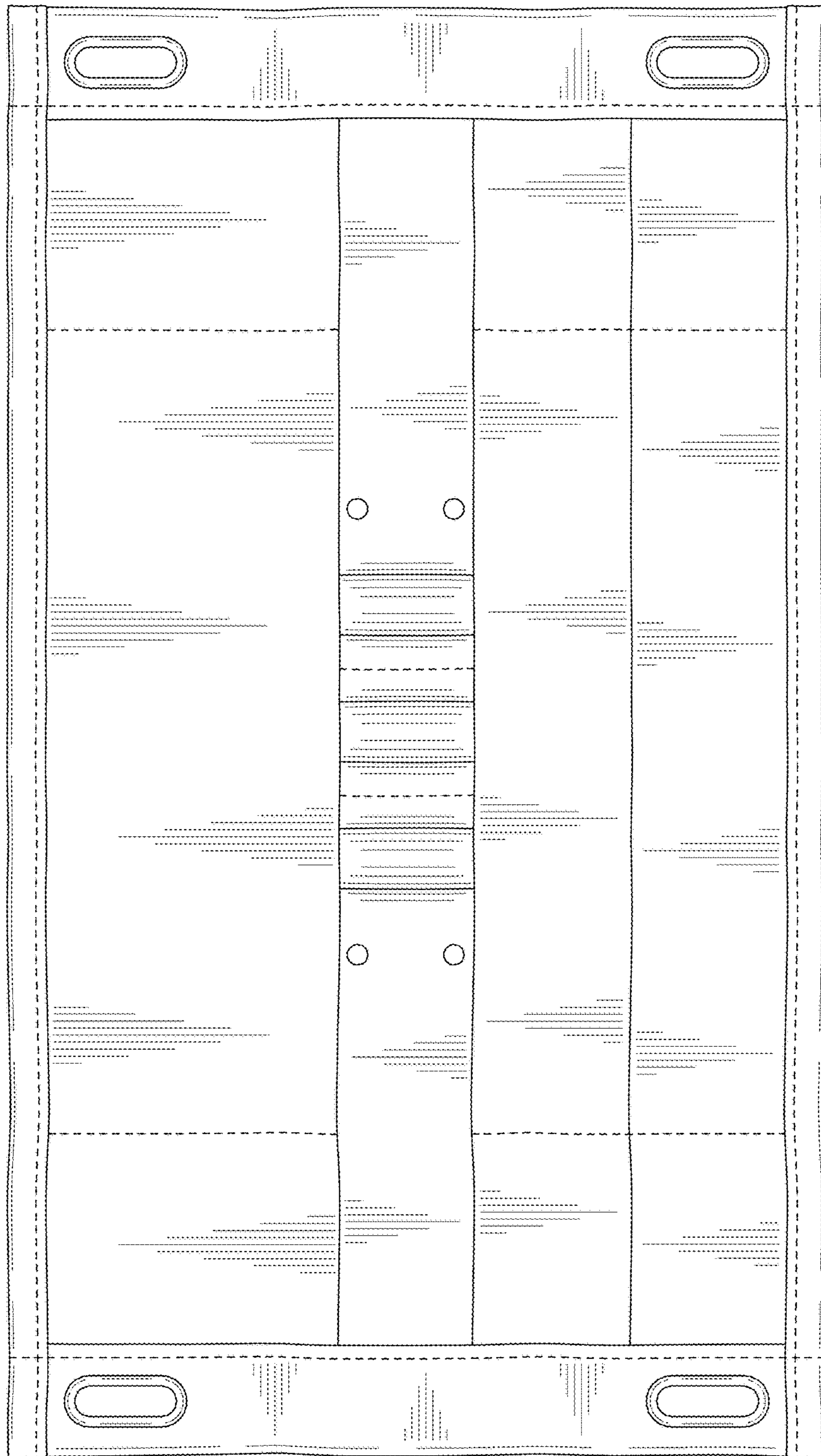
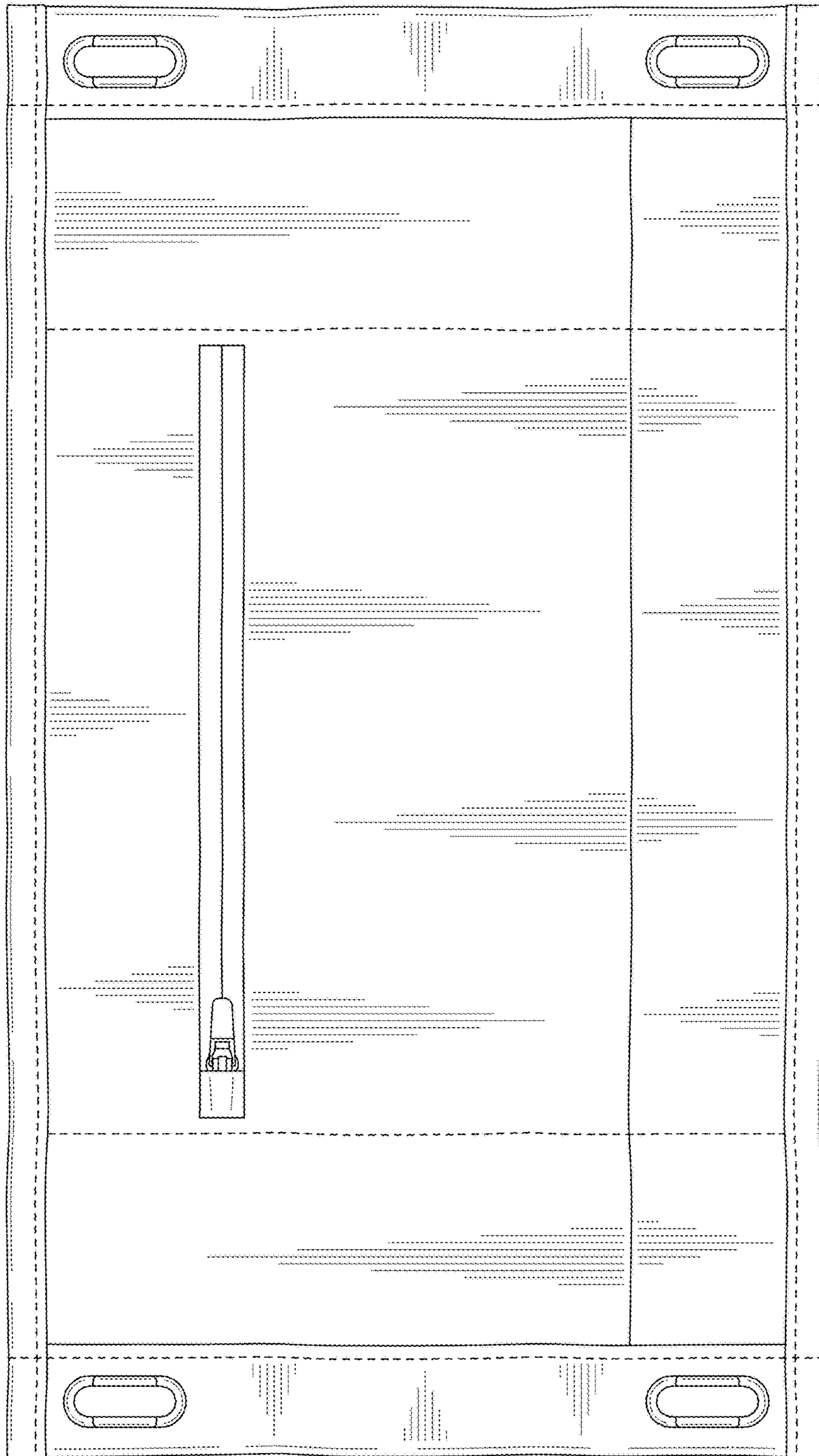

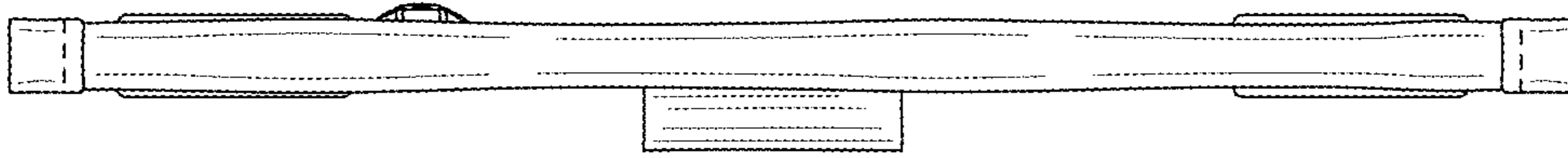

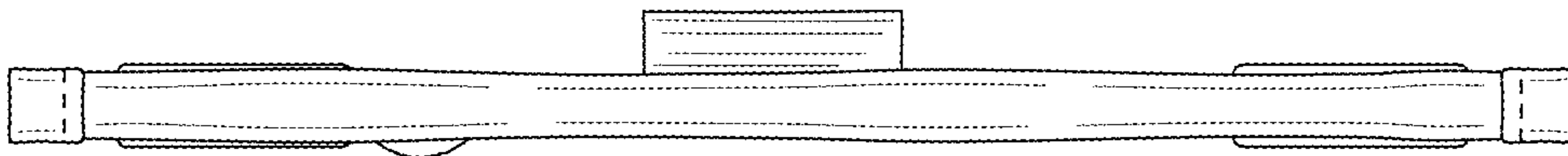

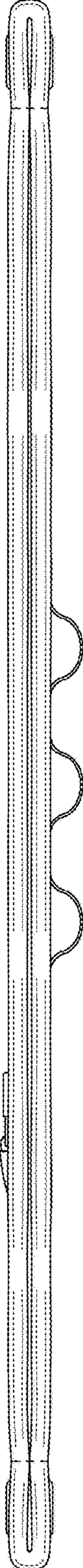
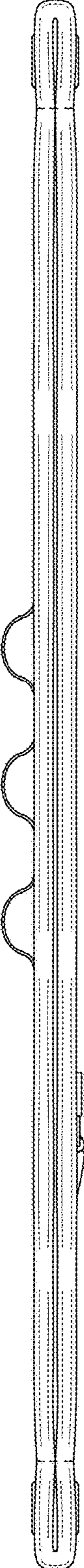

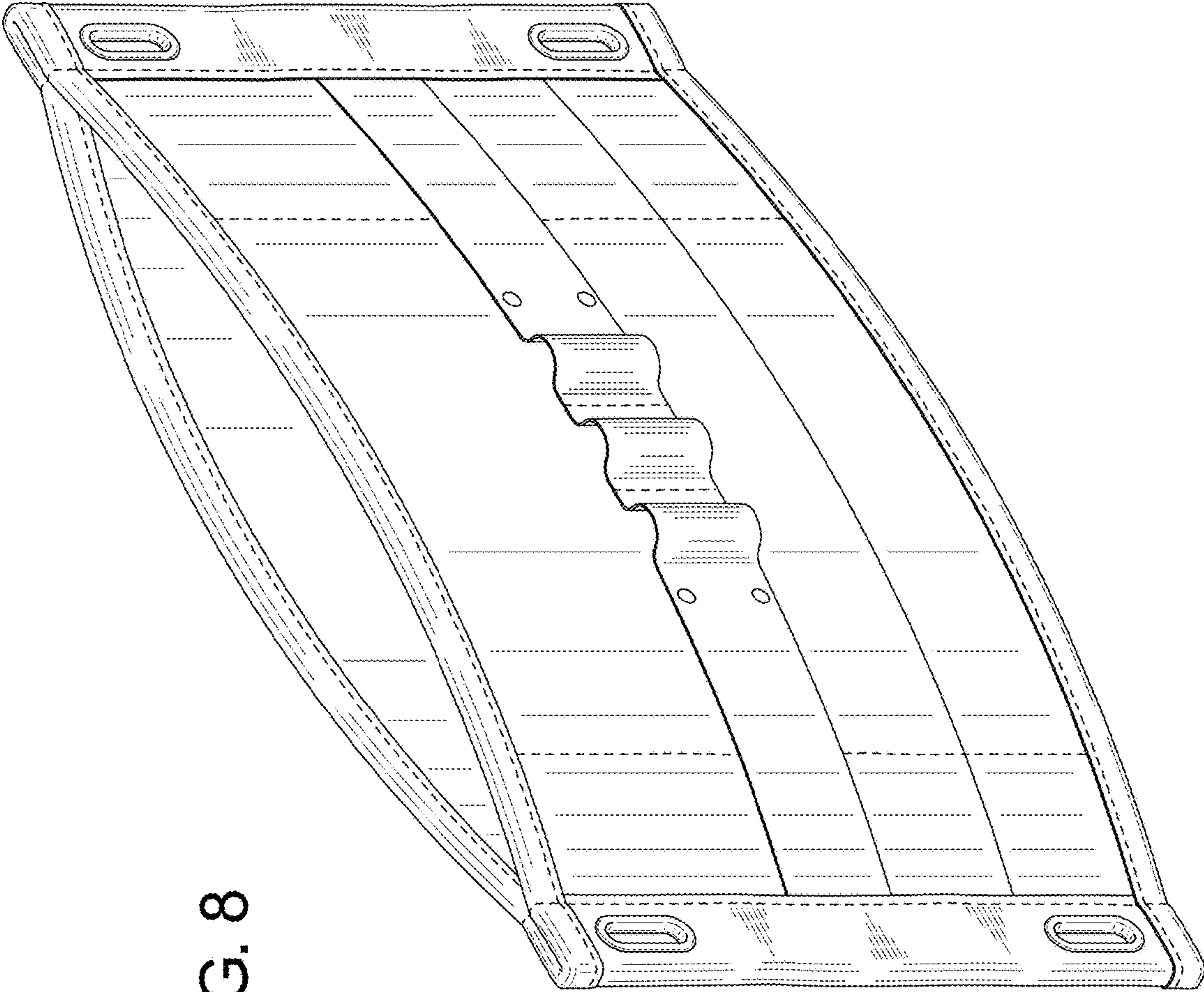
