The ornamental design for a wooden fly box, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a wooden fly box showing the new design;

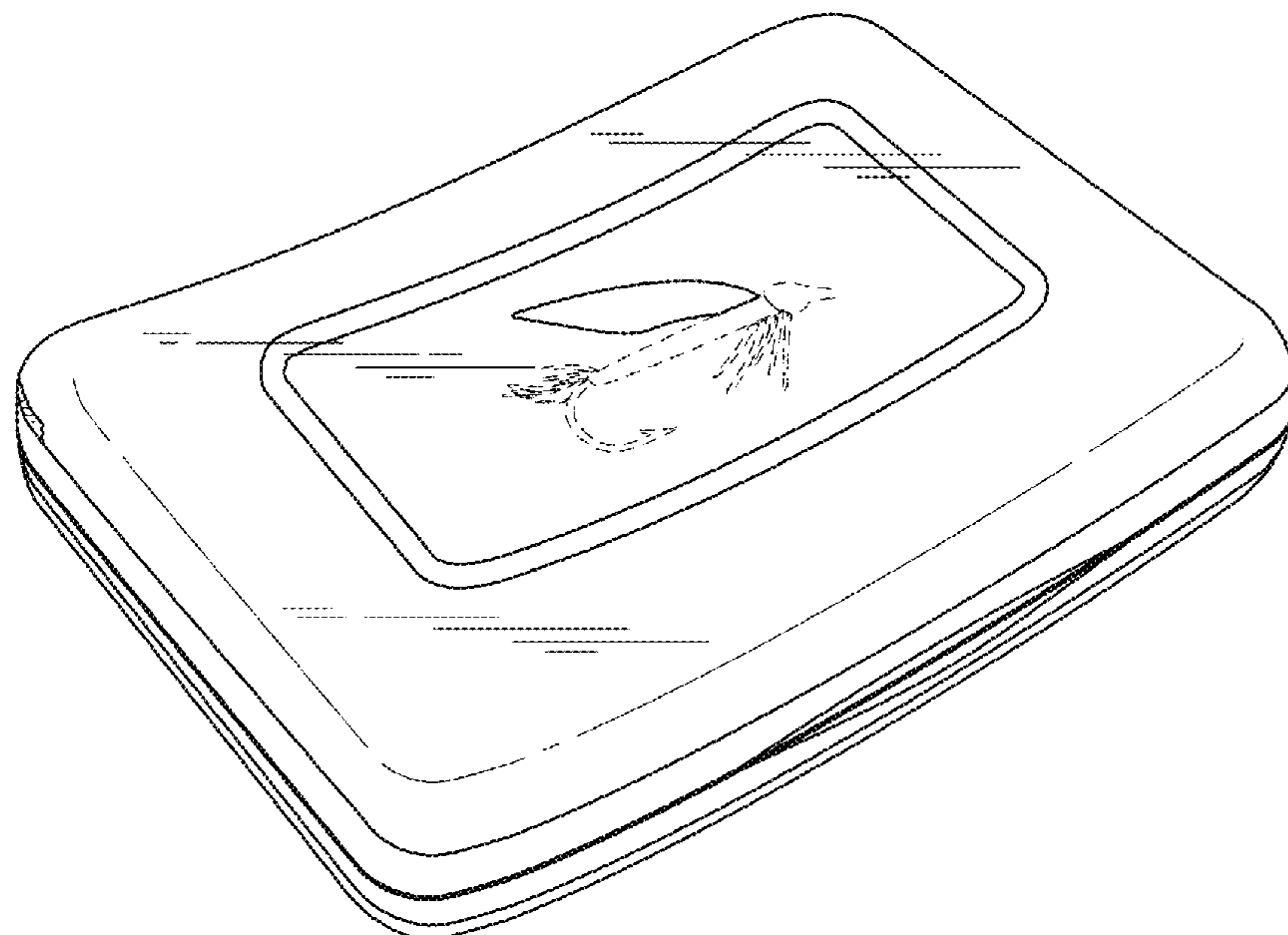

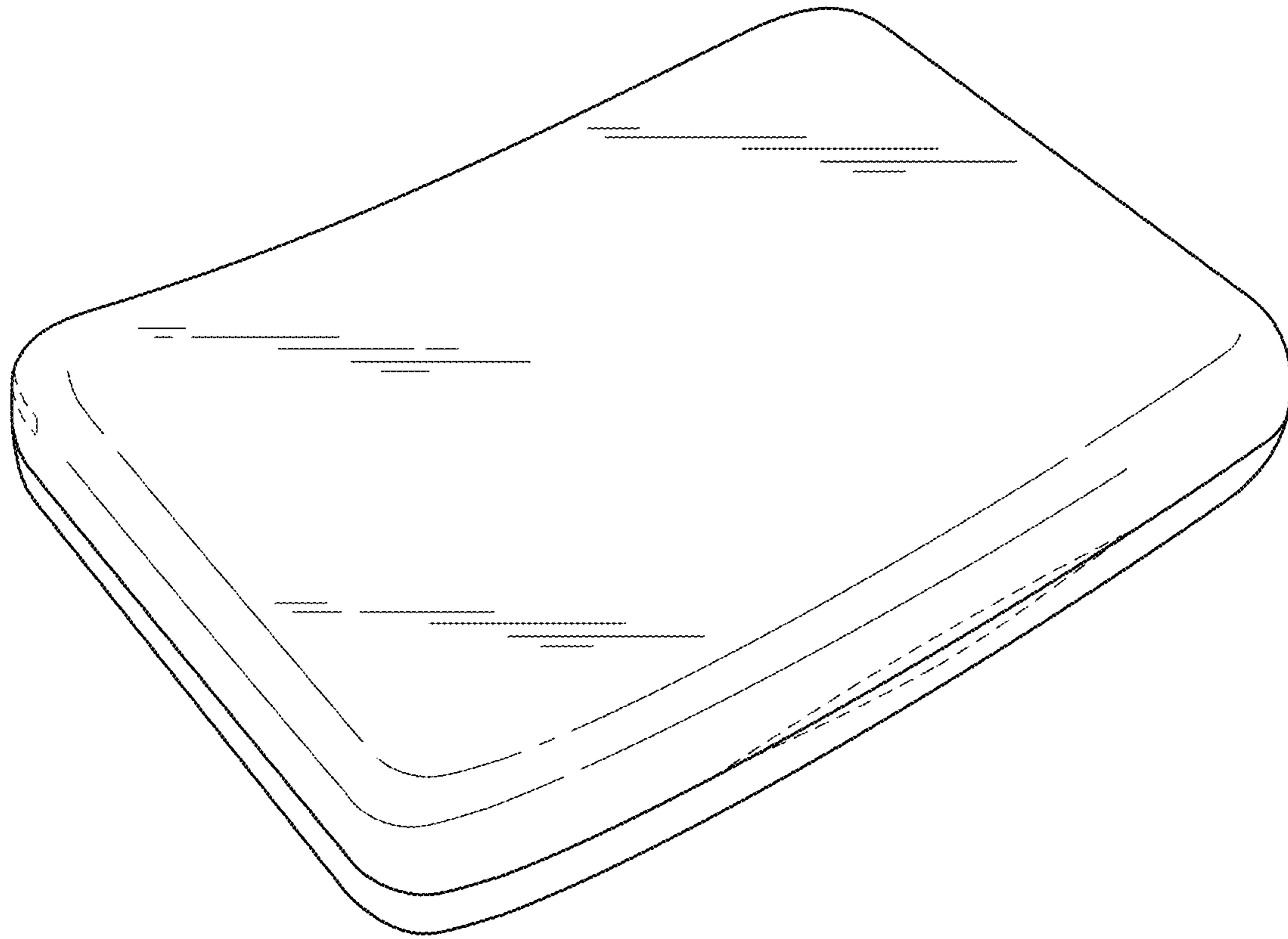

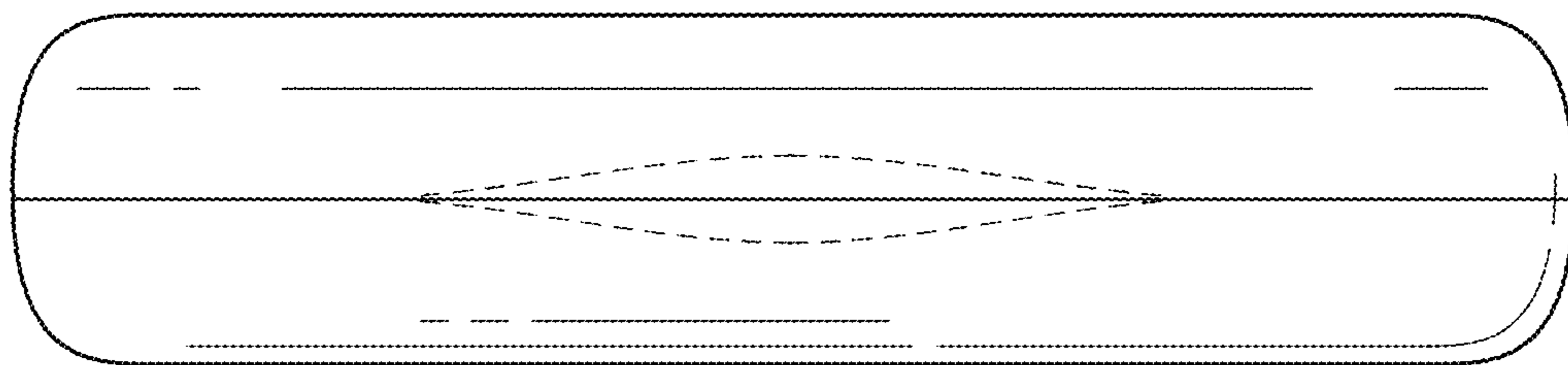

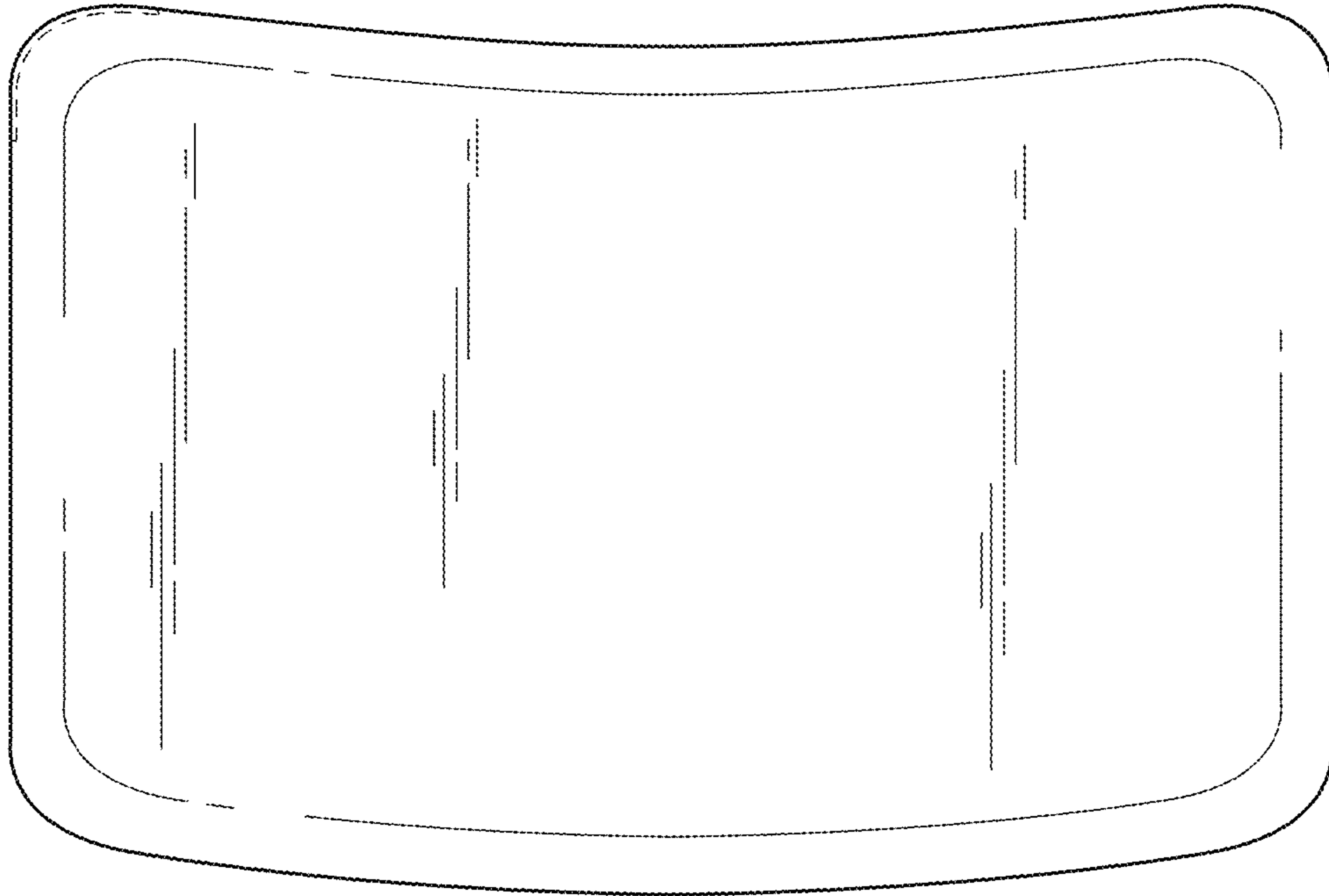

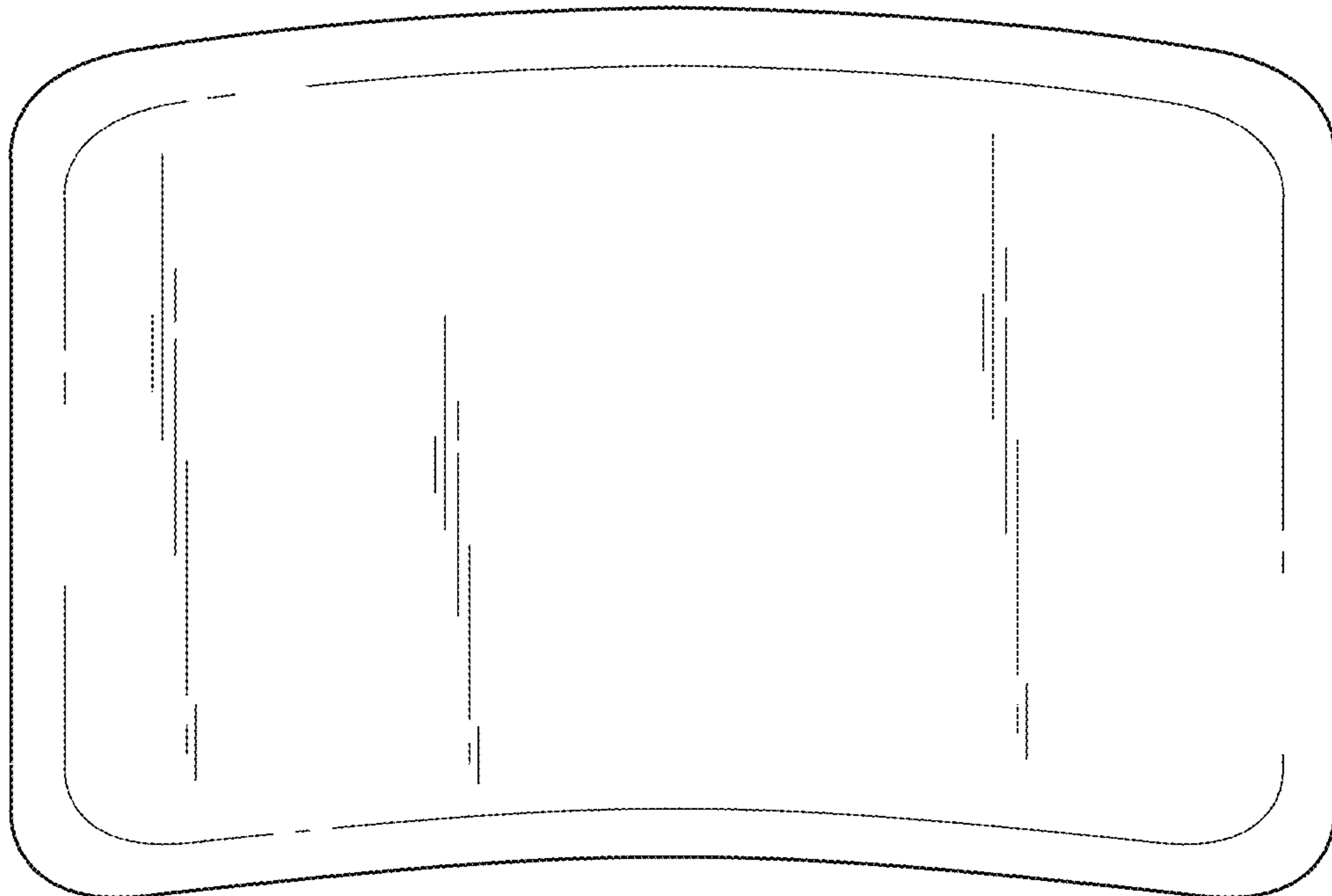

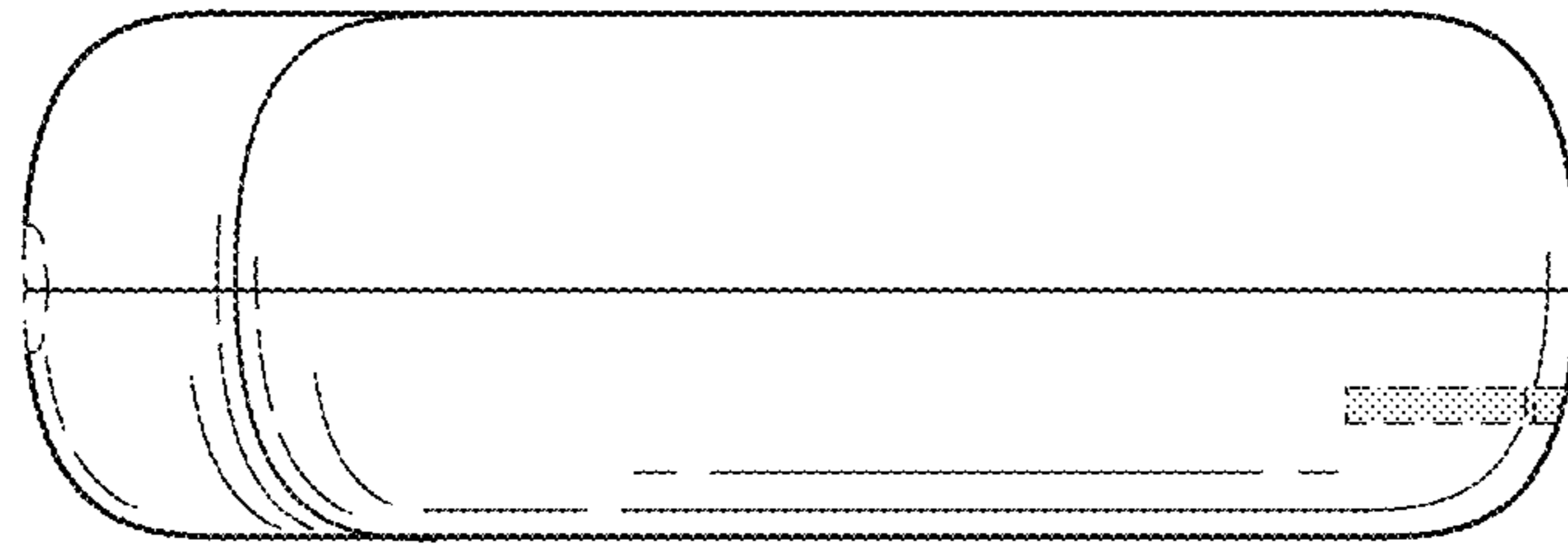

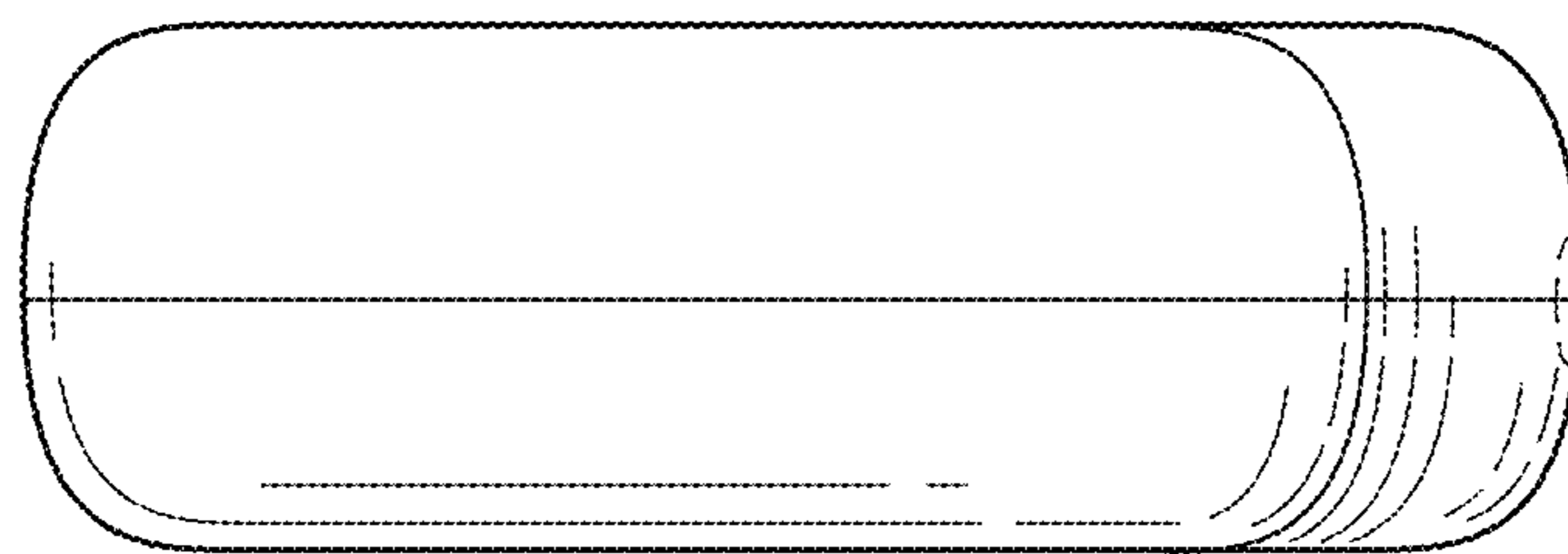

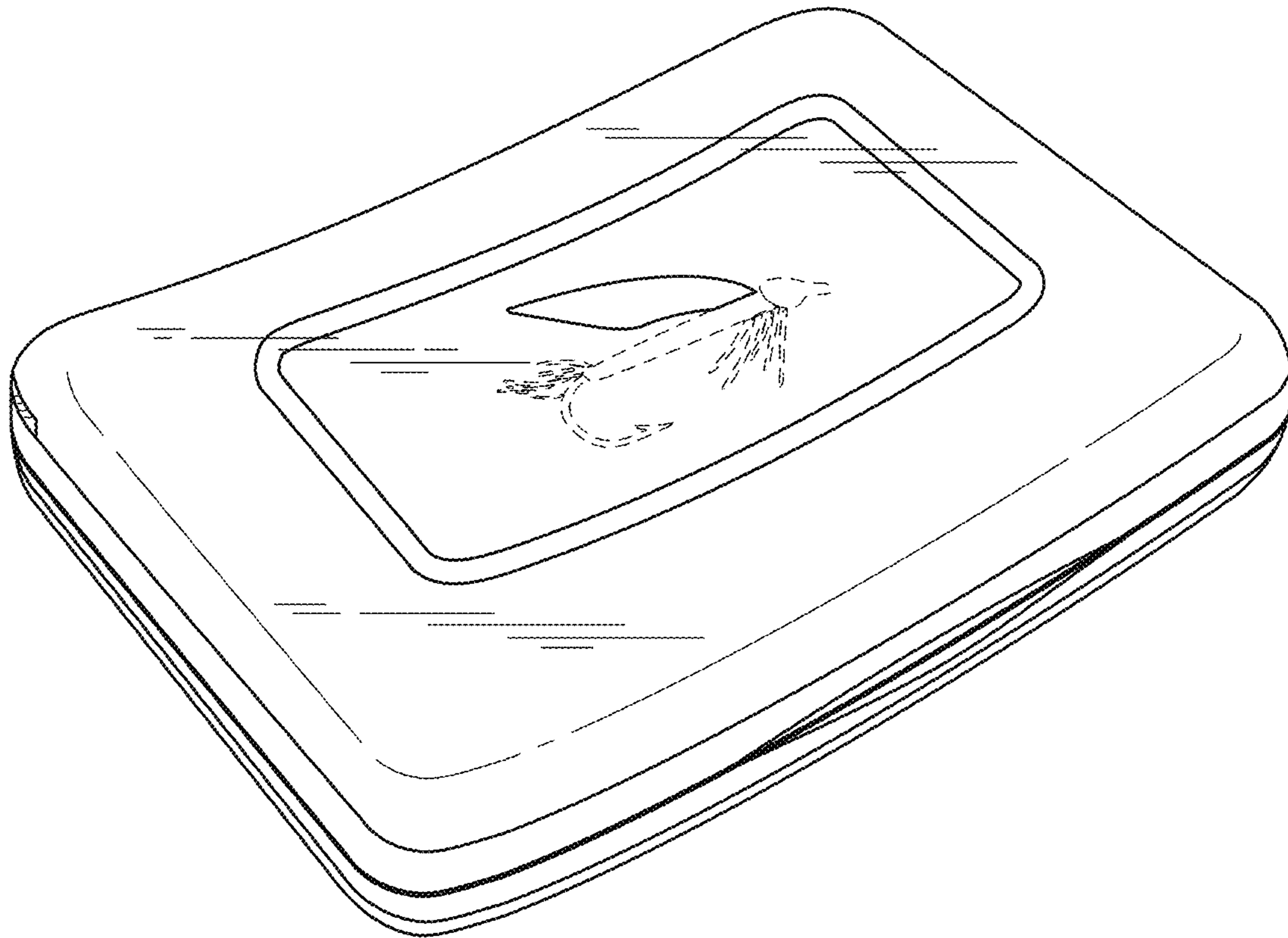

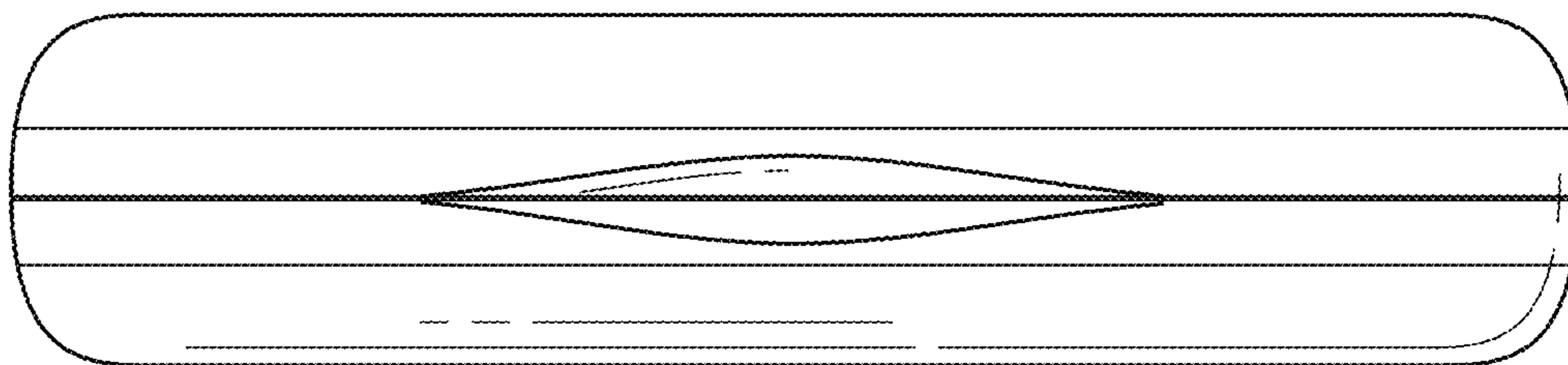

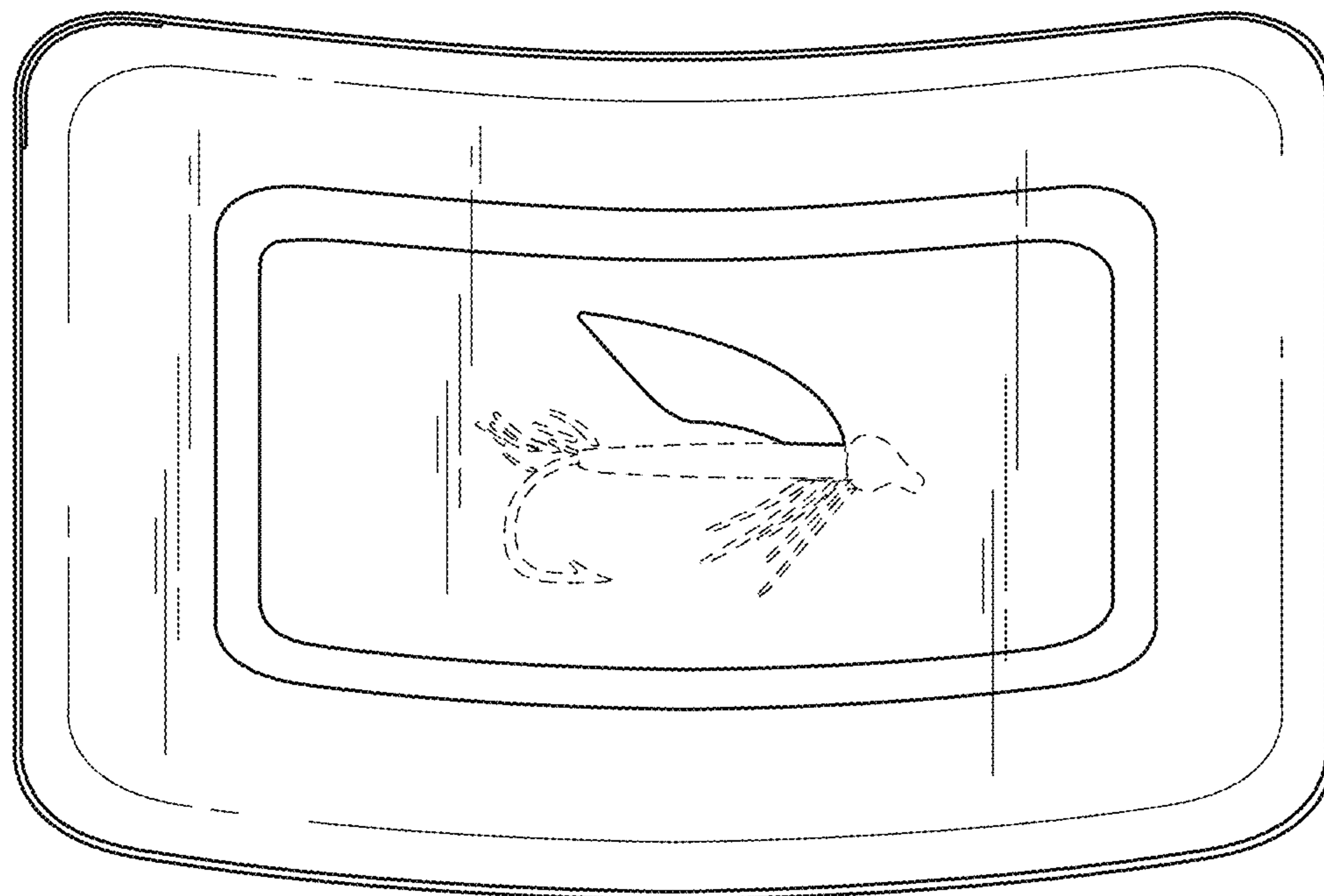

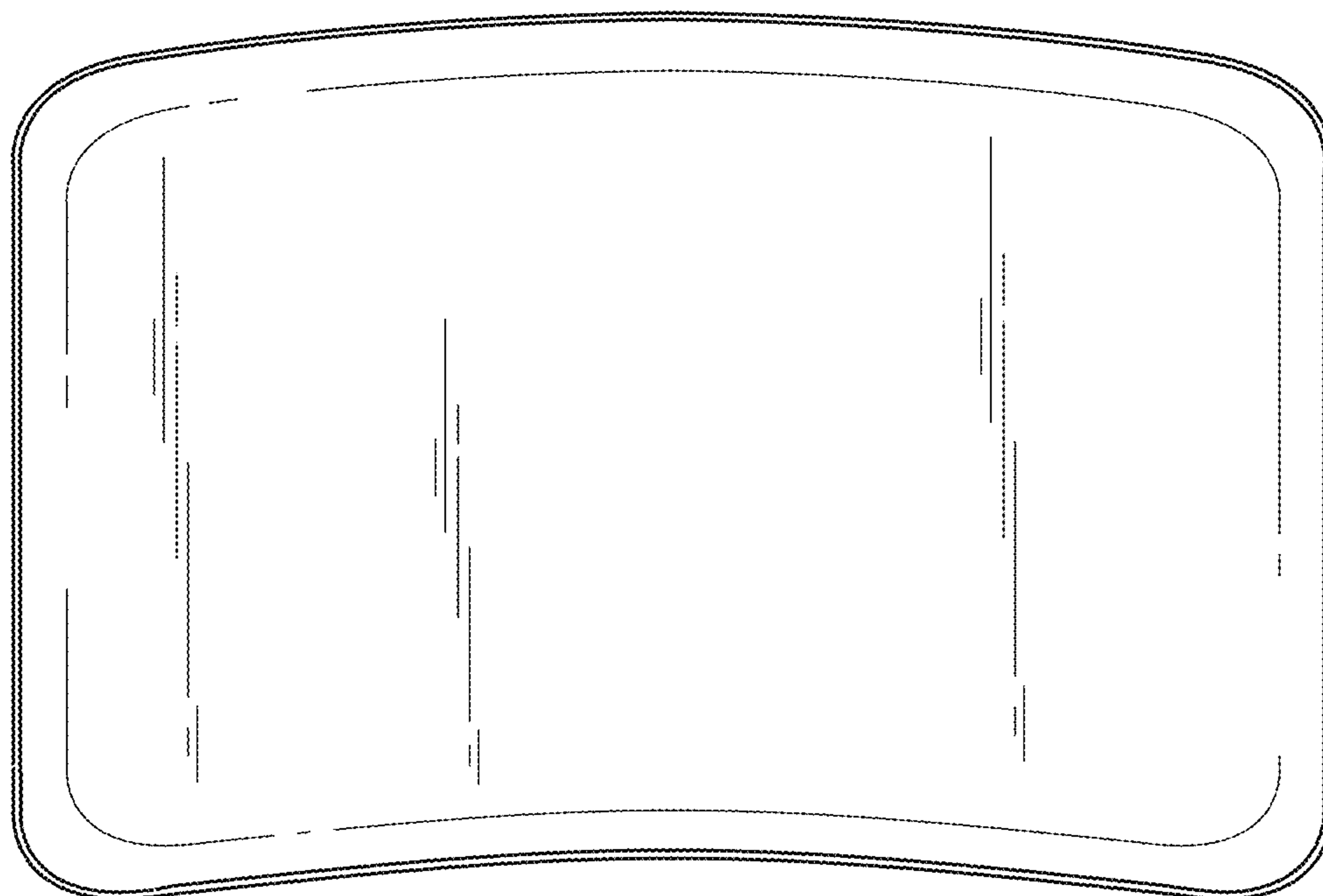

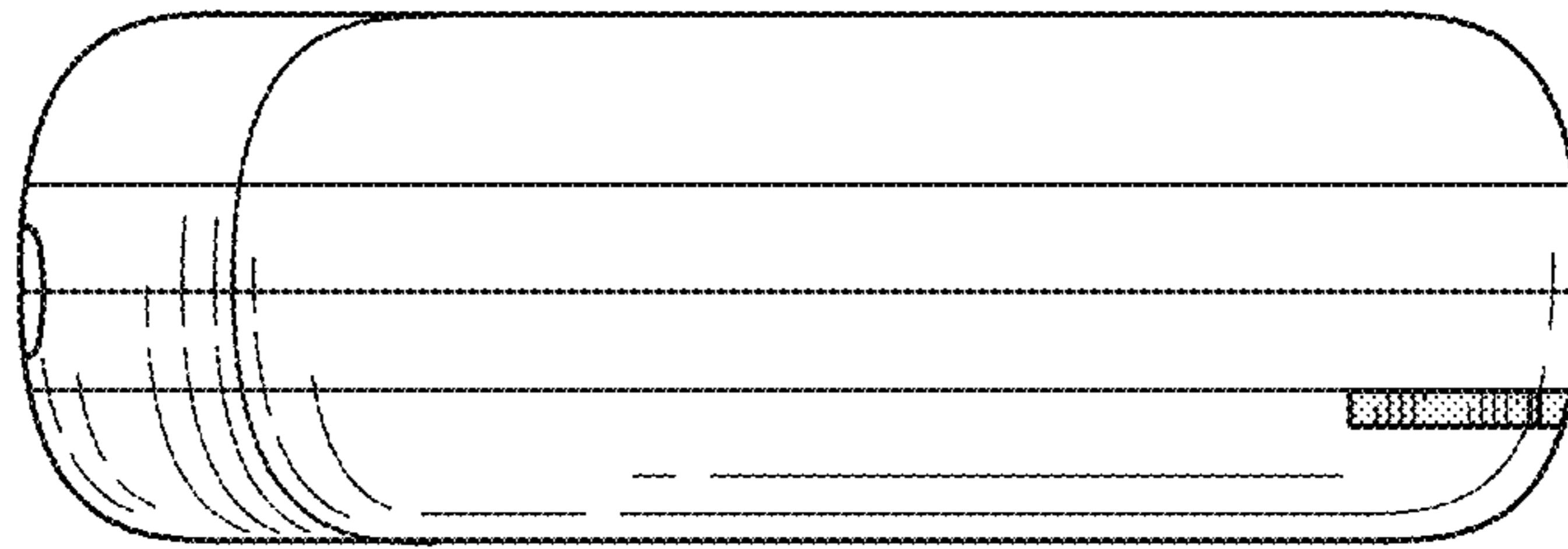
