FIG. 14 is a top plan view thereof; and,

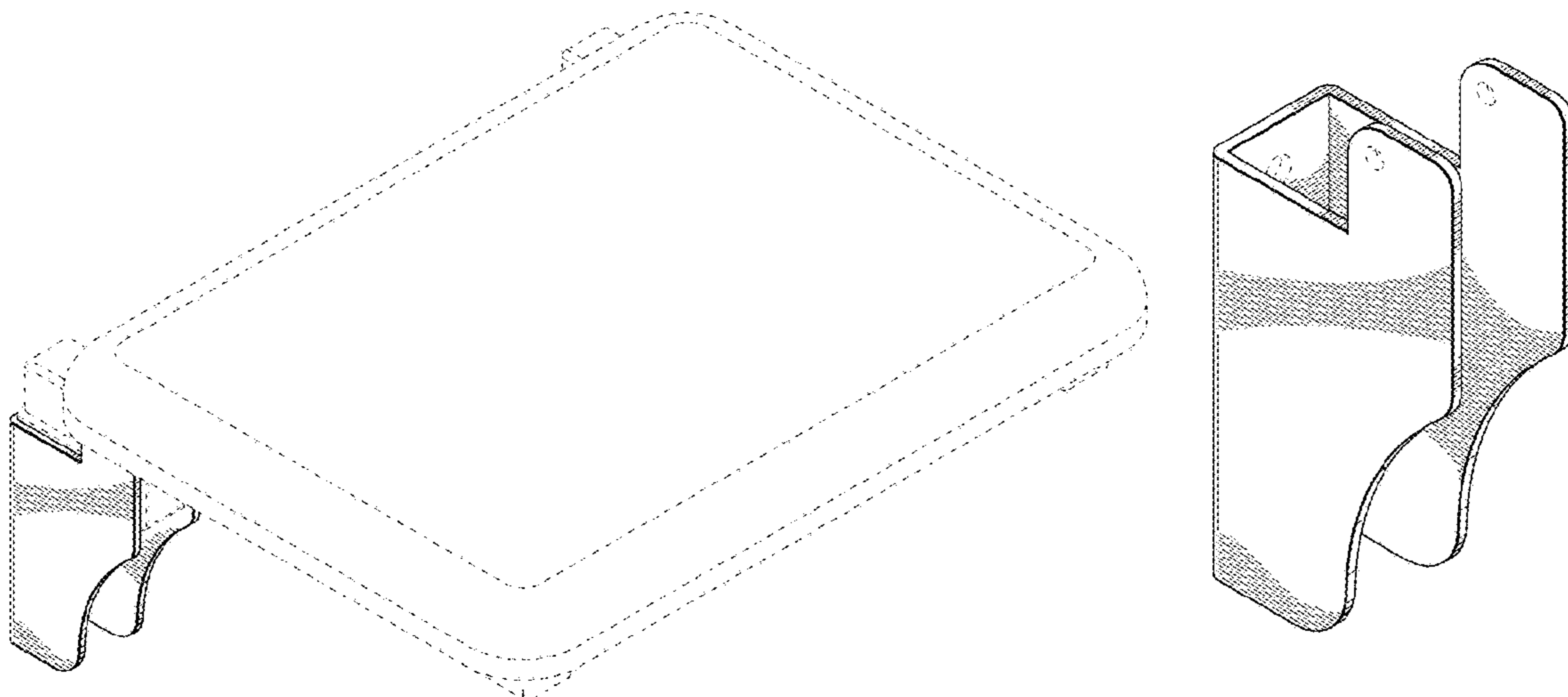
FIG. 15 is a bottom plan view thereof.

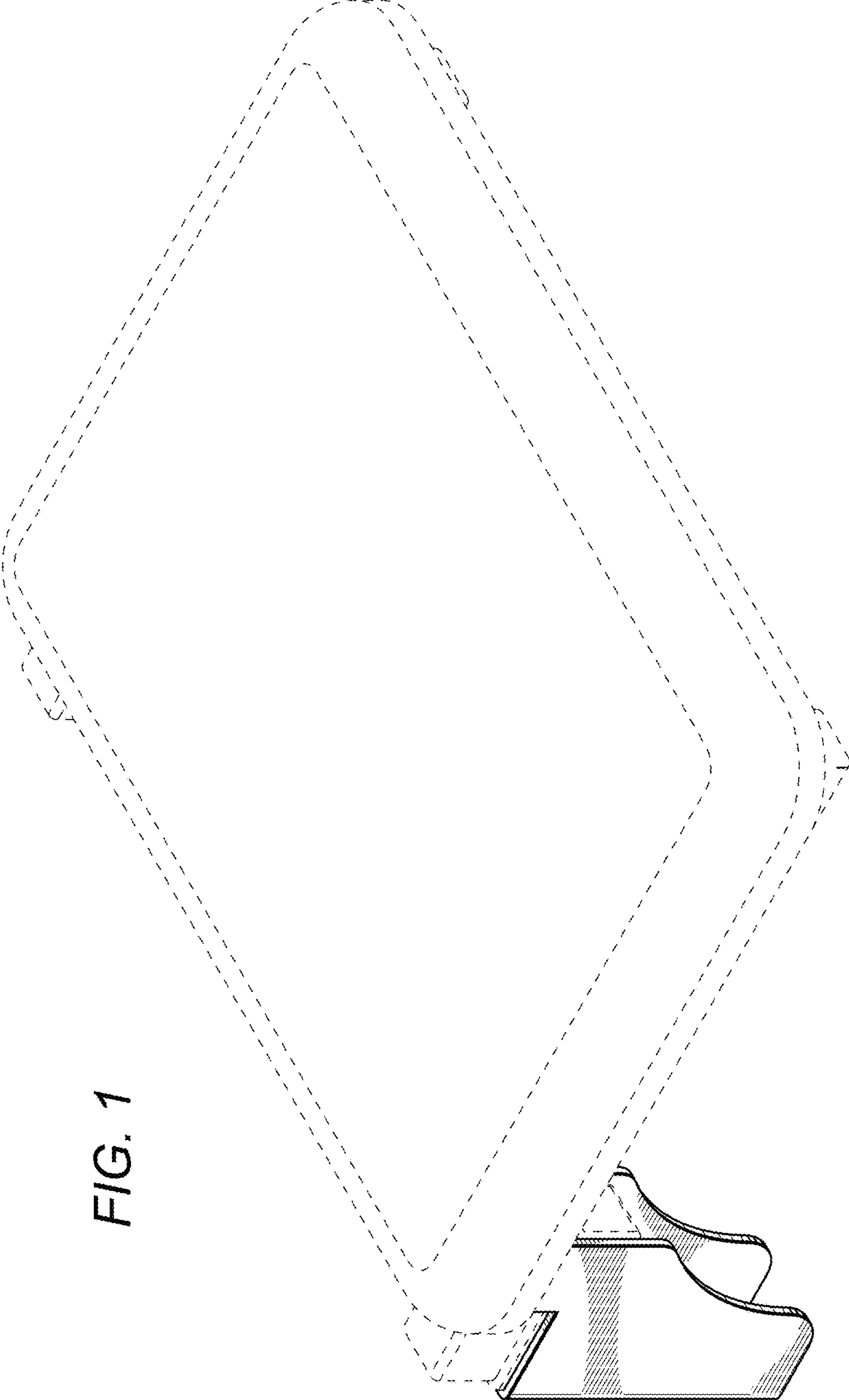

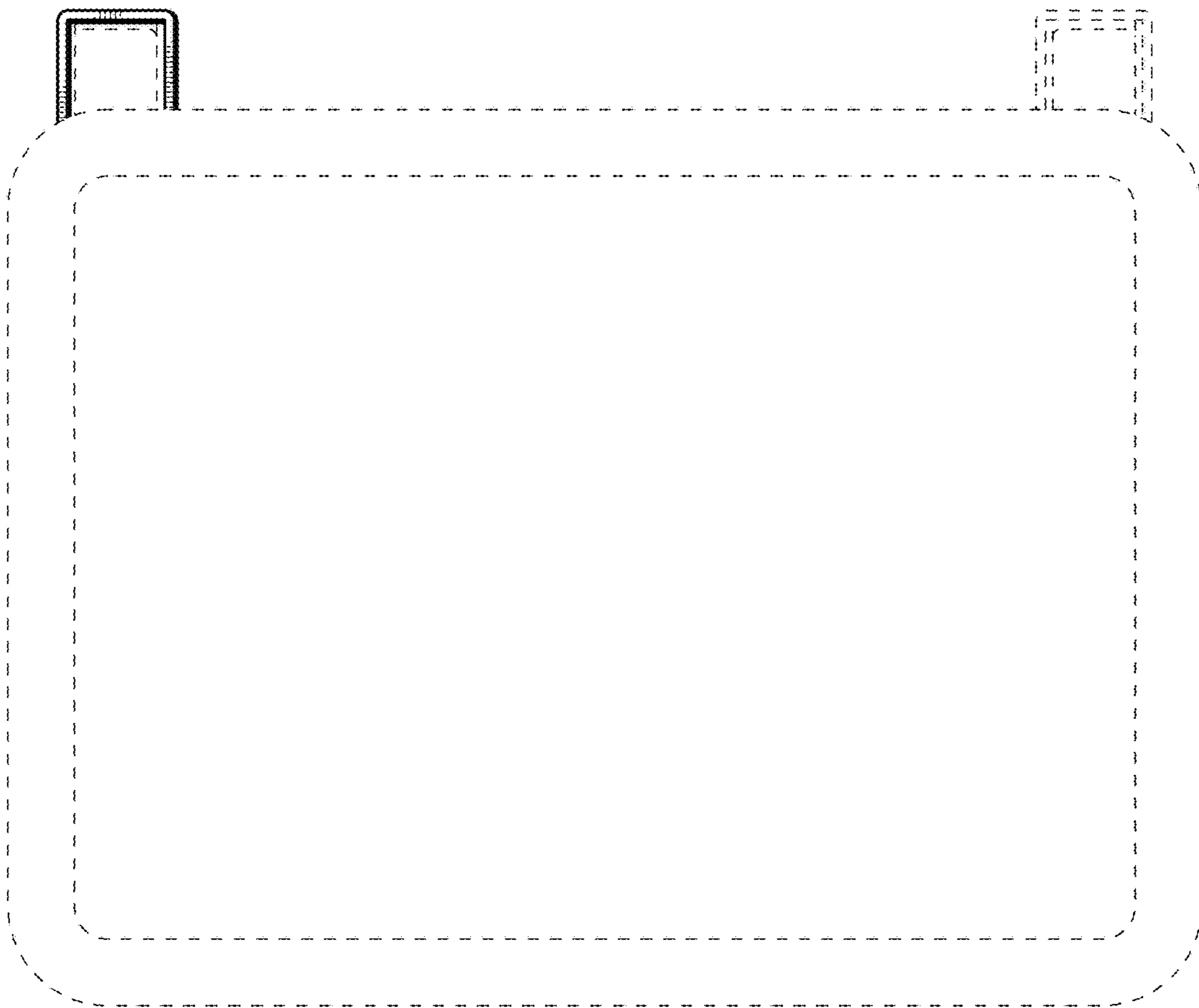
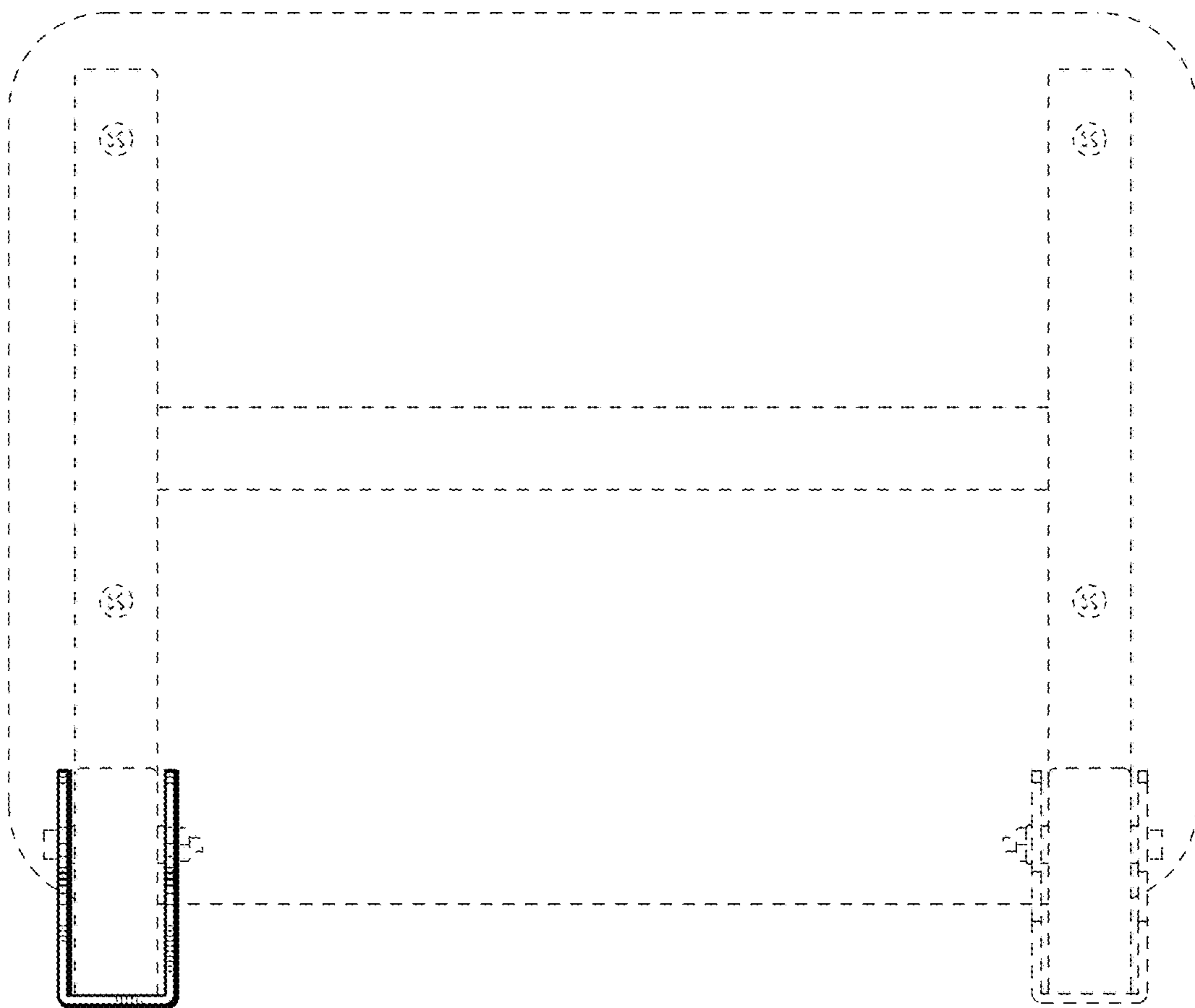
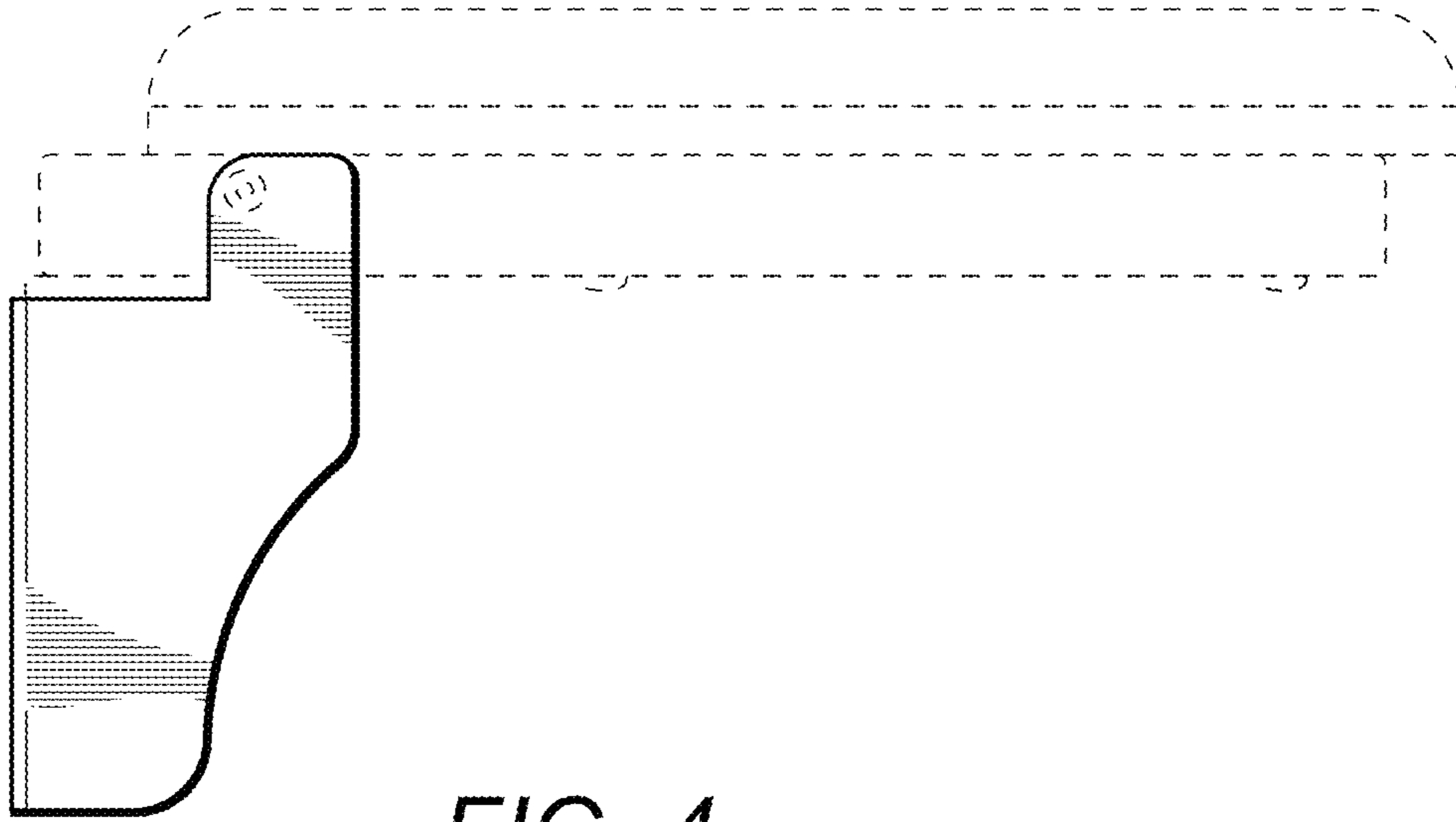

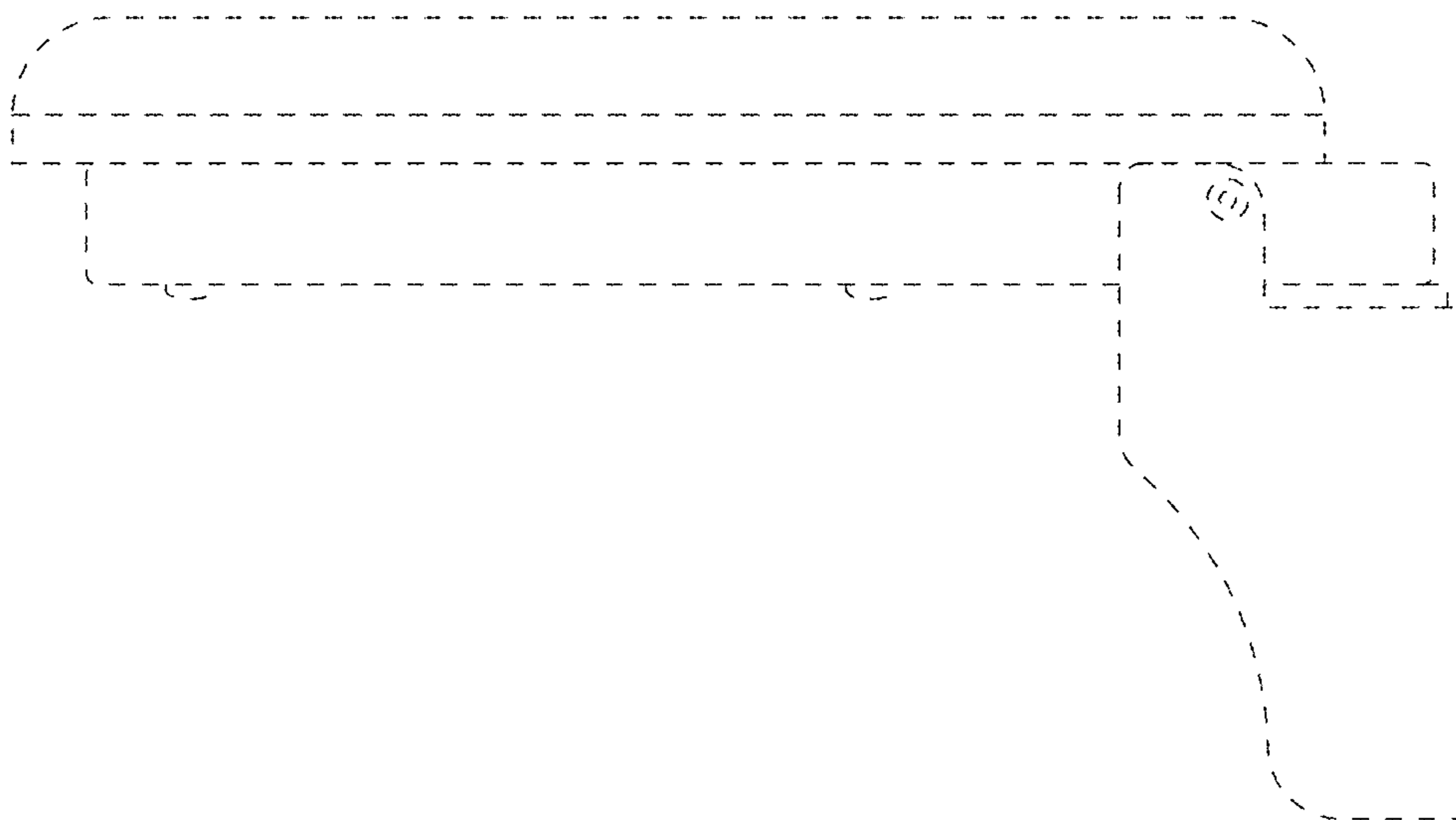

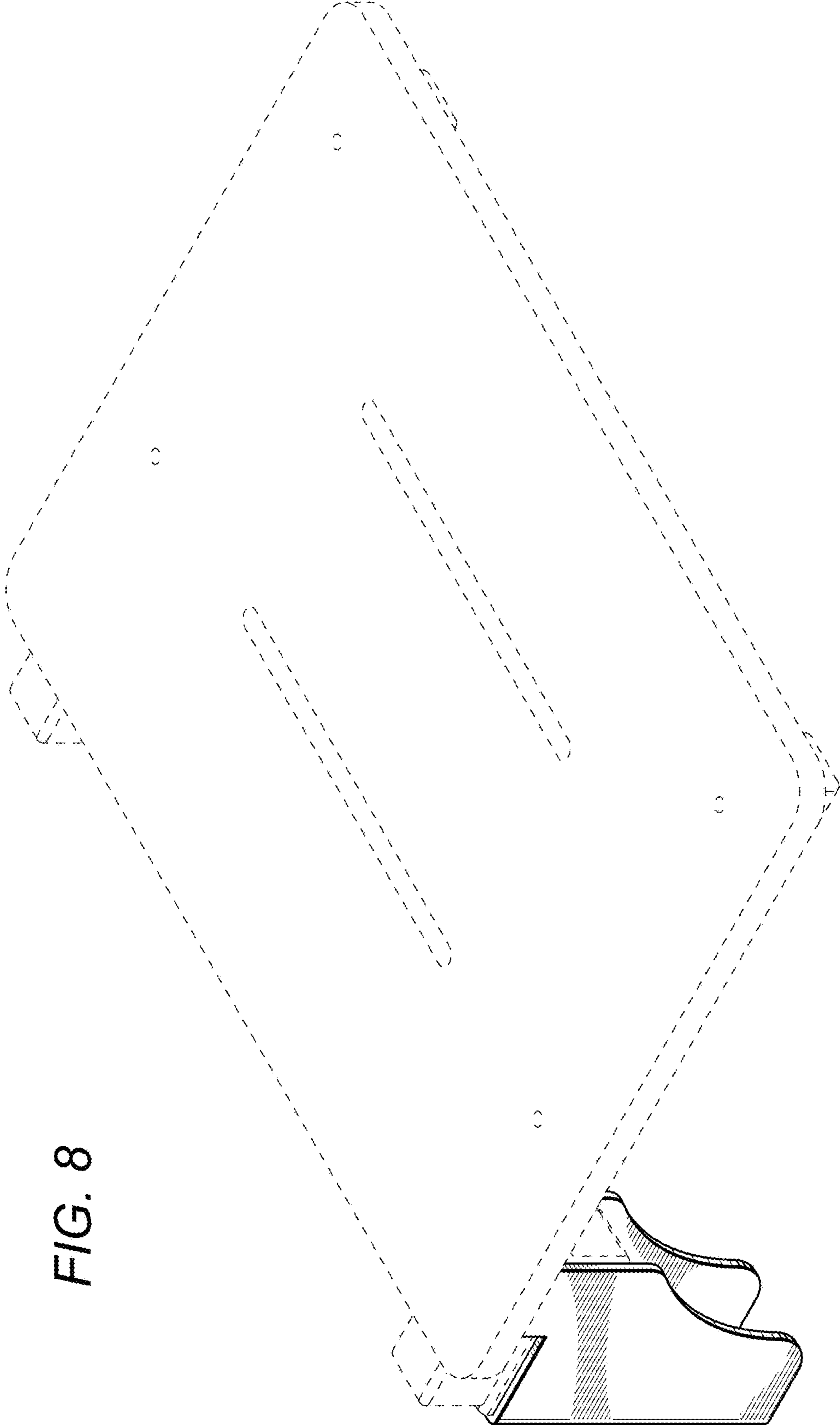

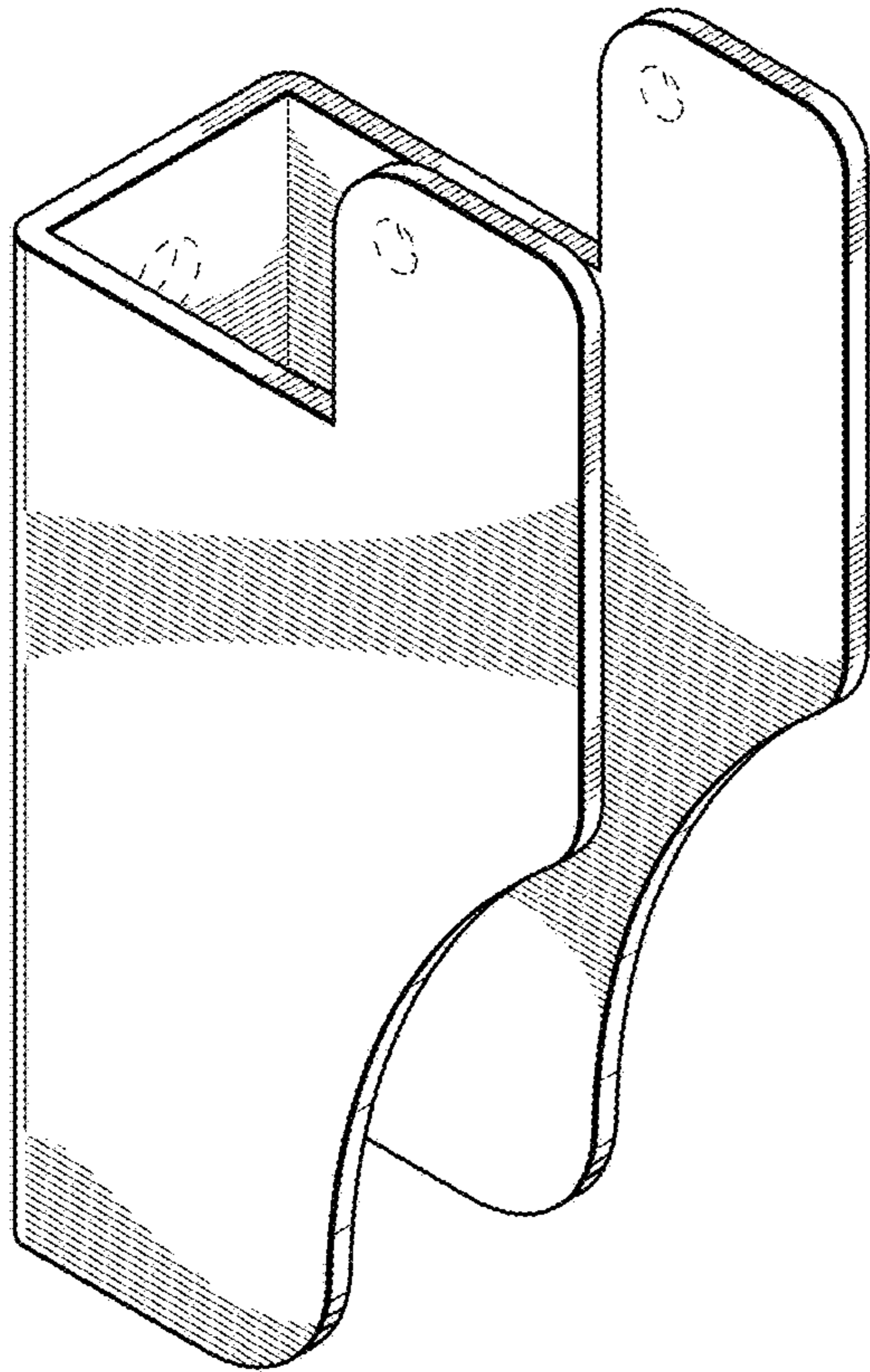

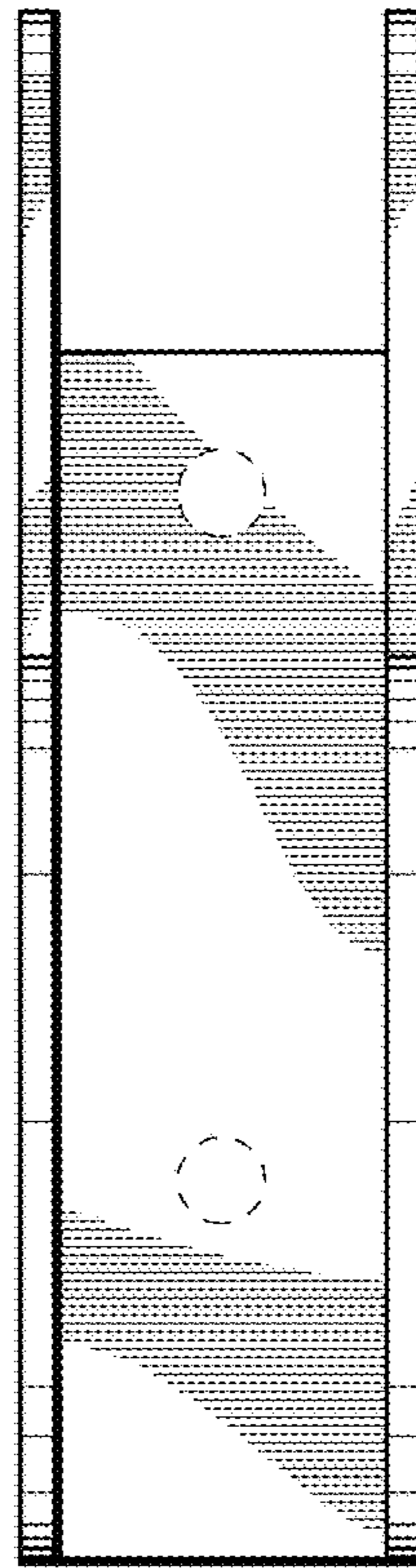

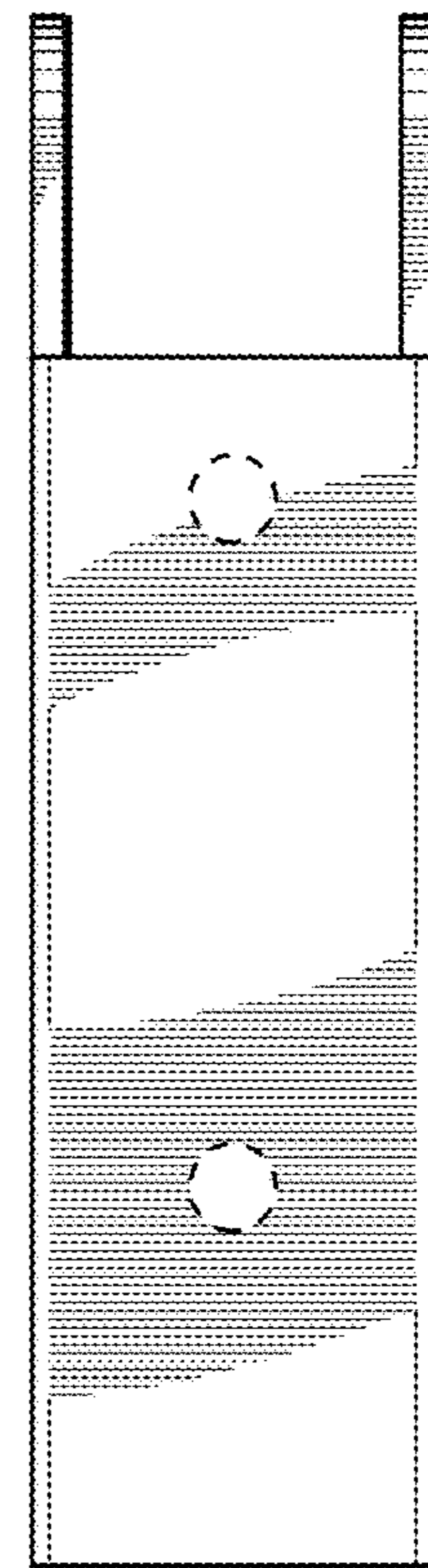

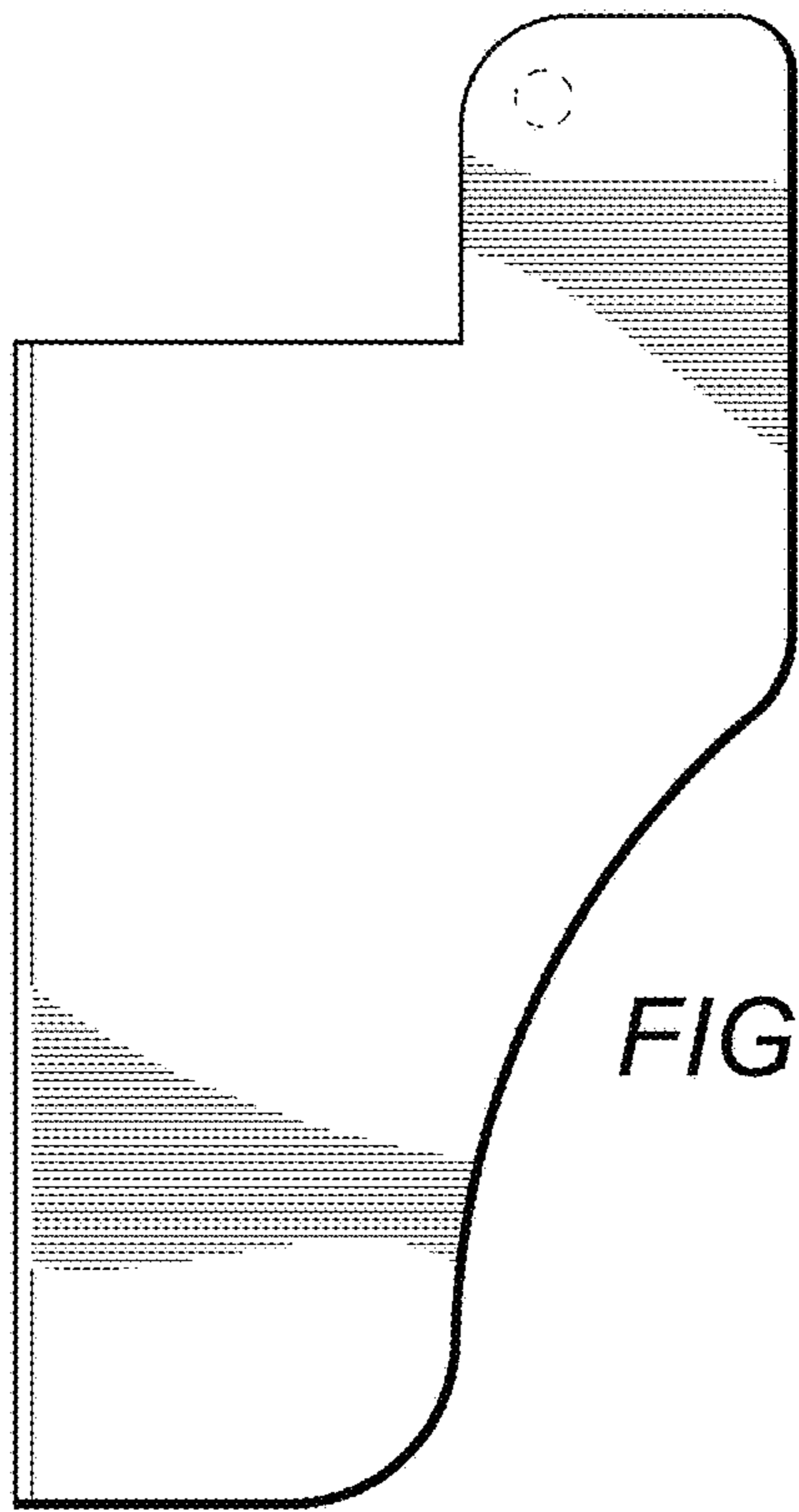

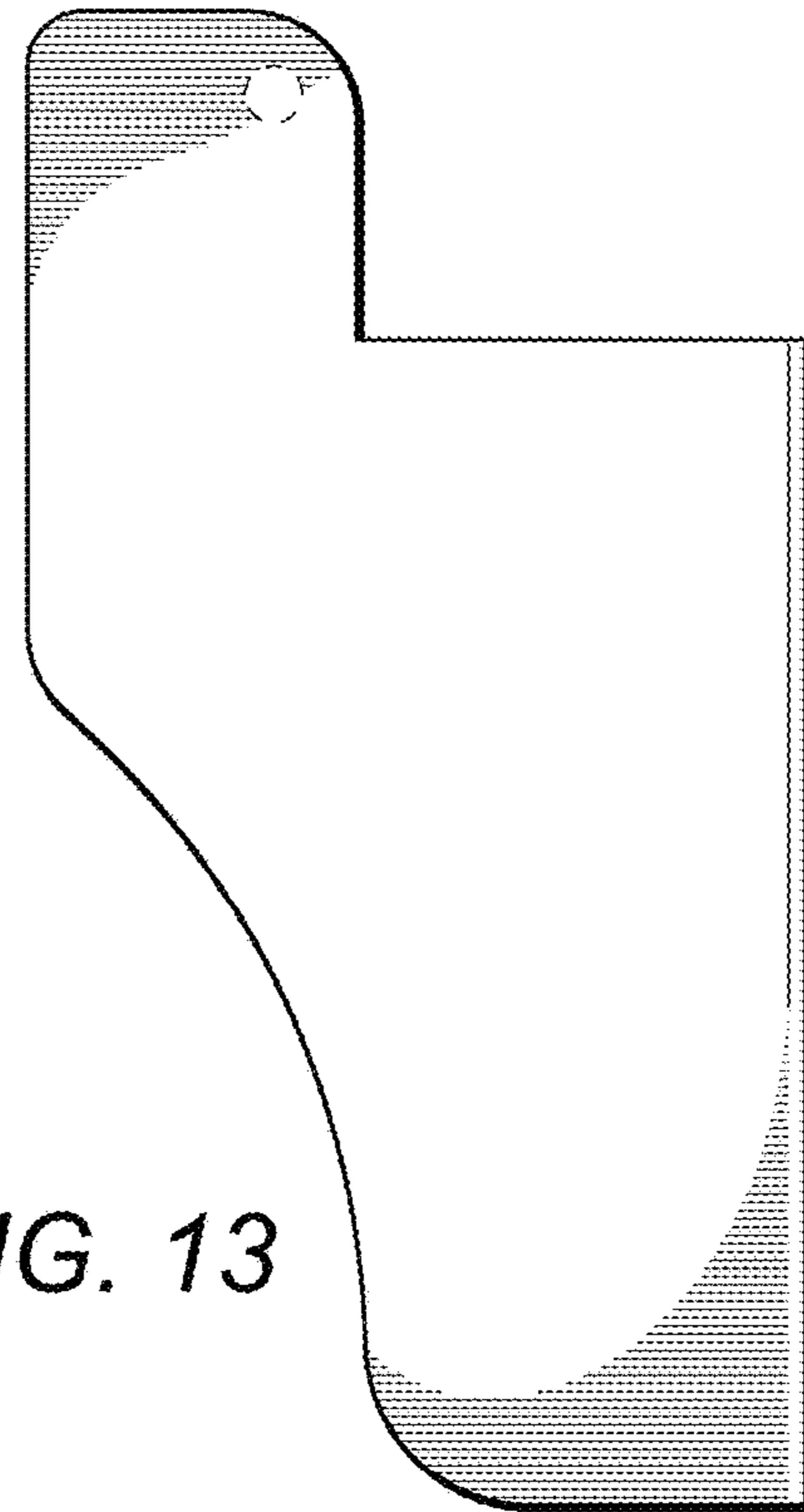

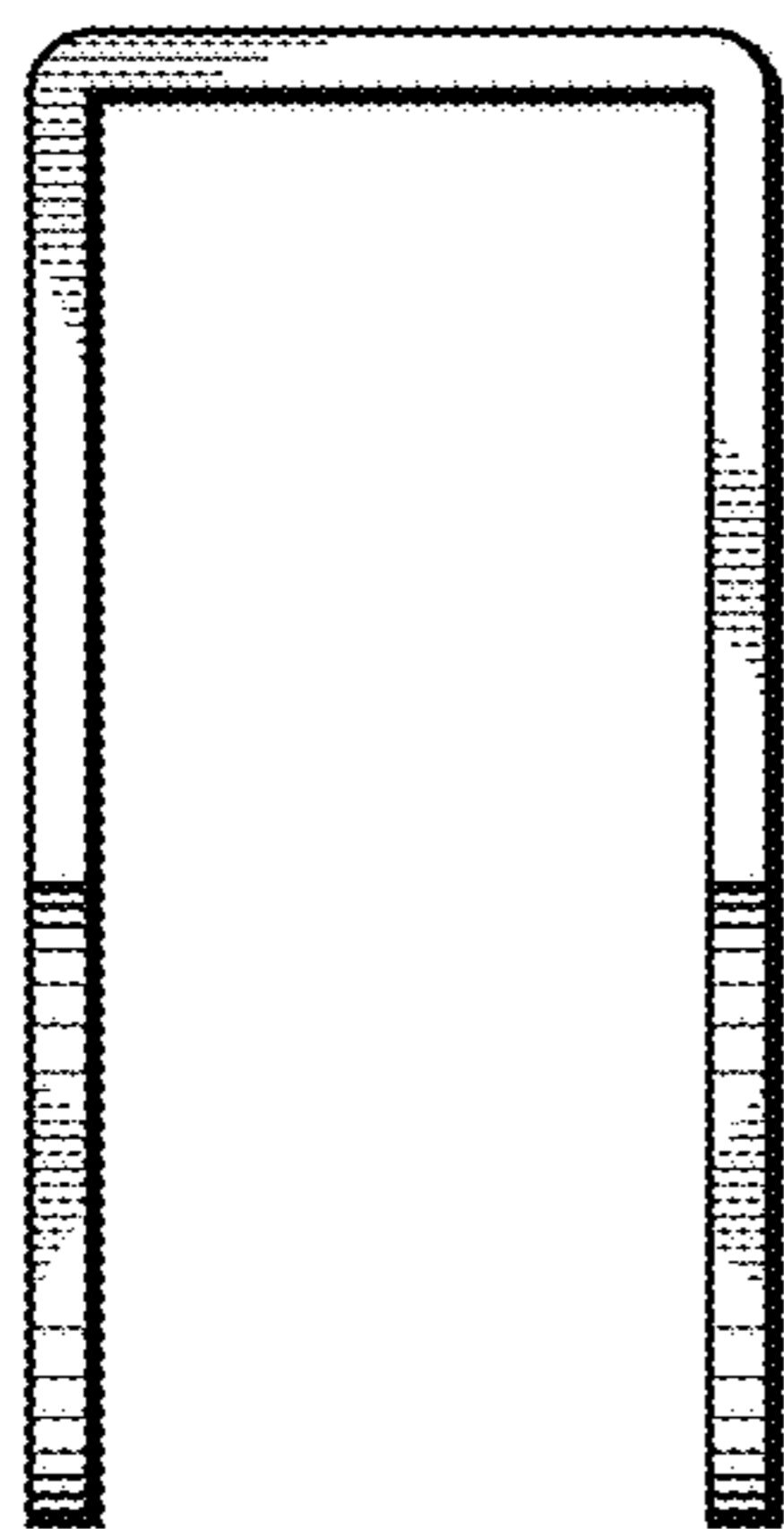

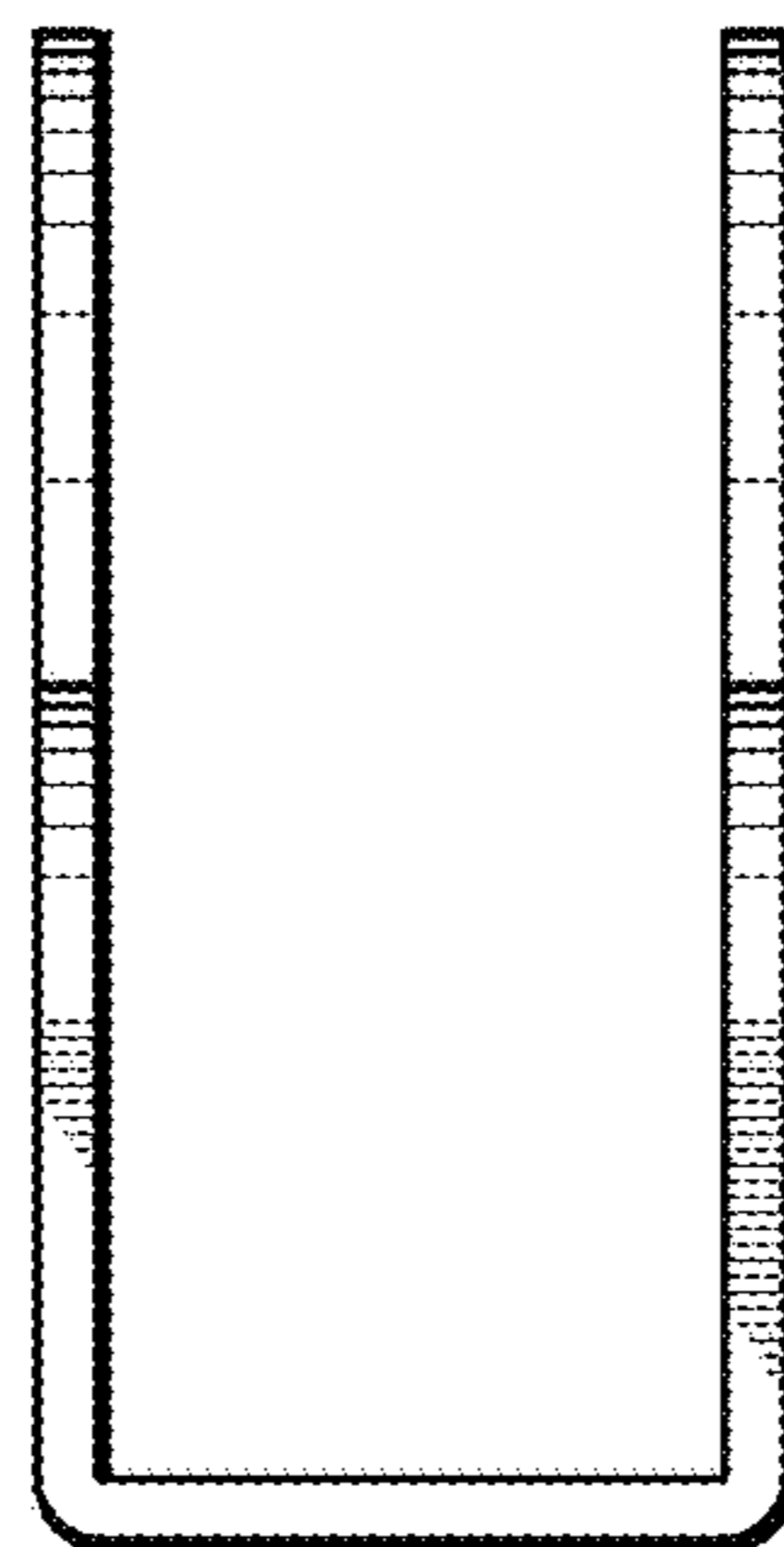
