(57) **CLAIM**

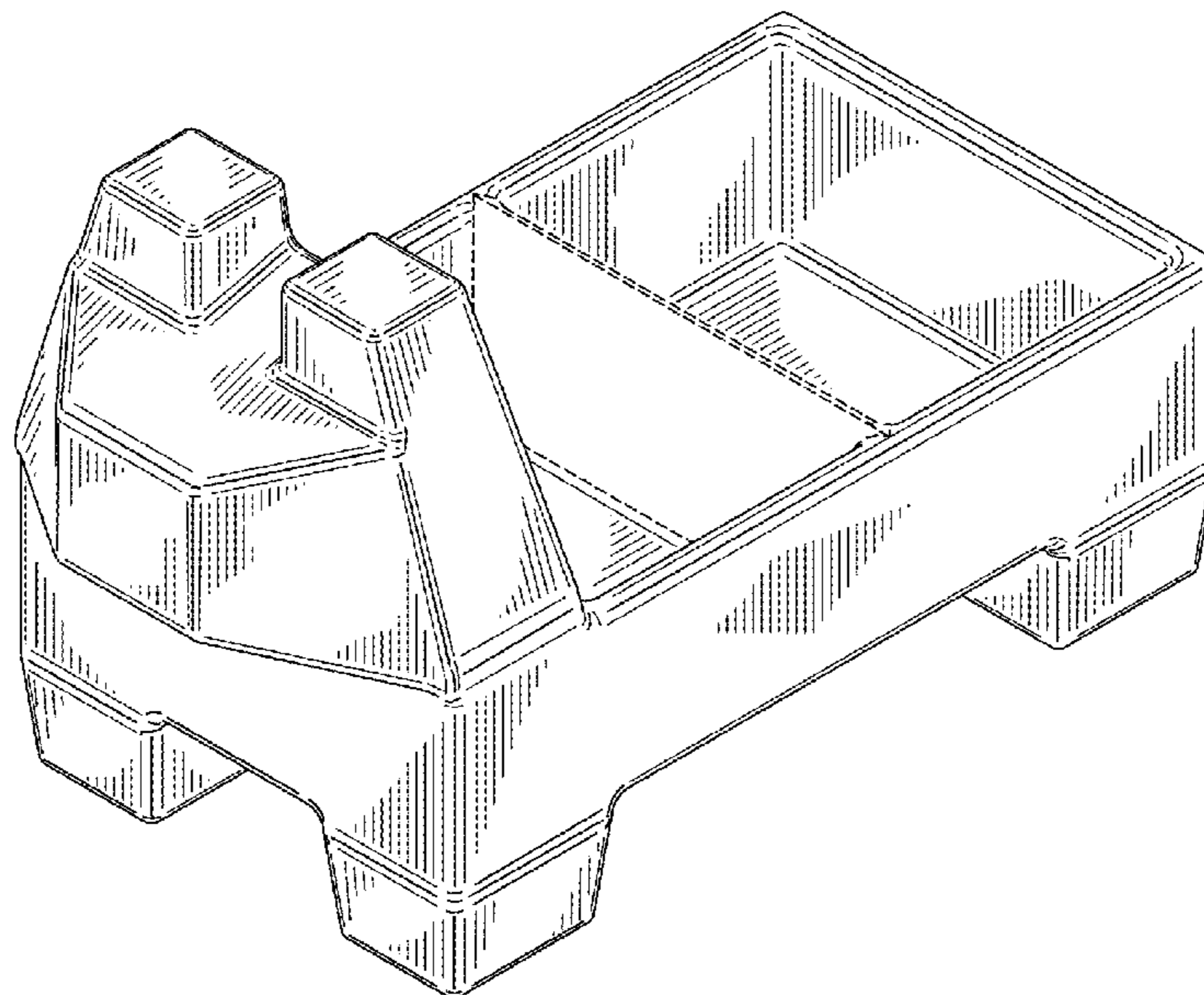
The ornamental design for a dip bowl, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dip bowl;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a right side view thereof, the left side being a mirror image;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

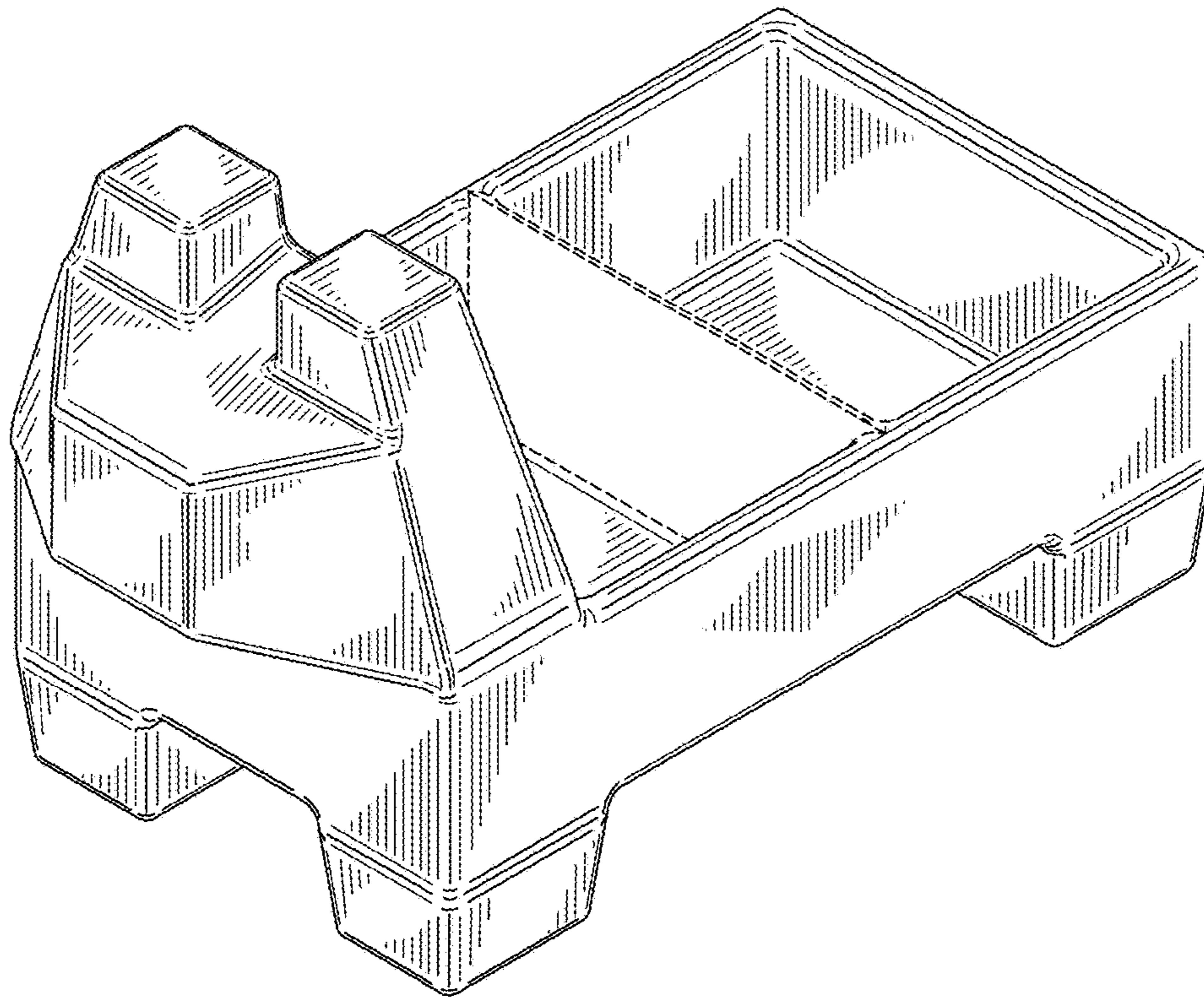

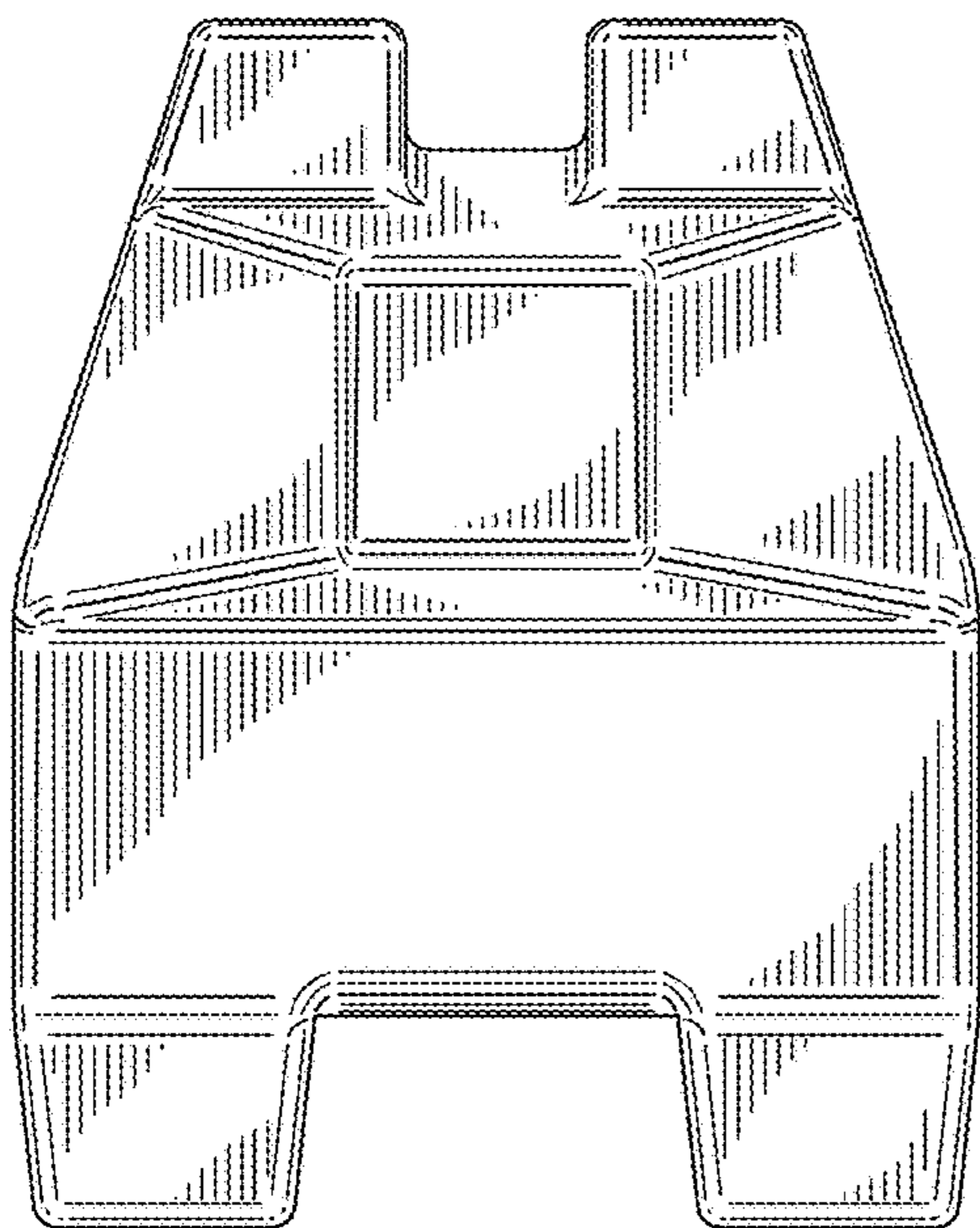

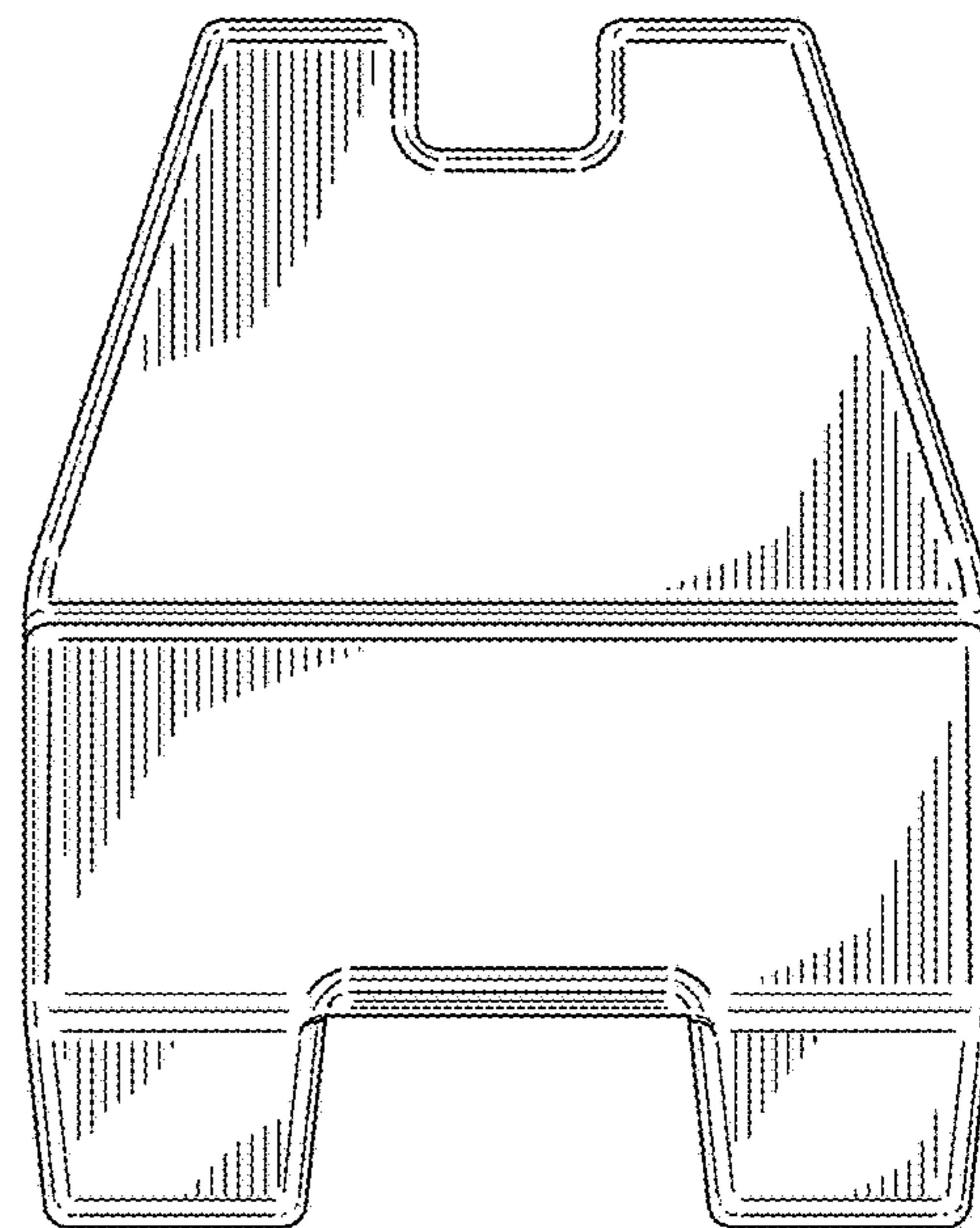

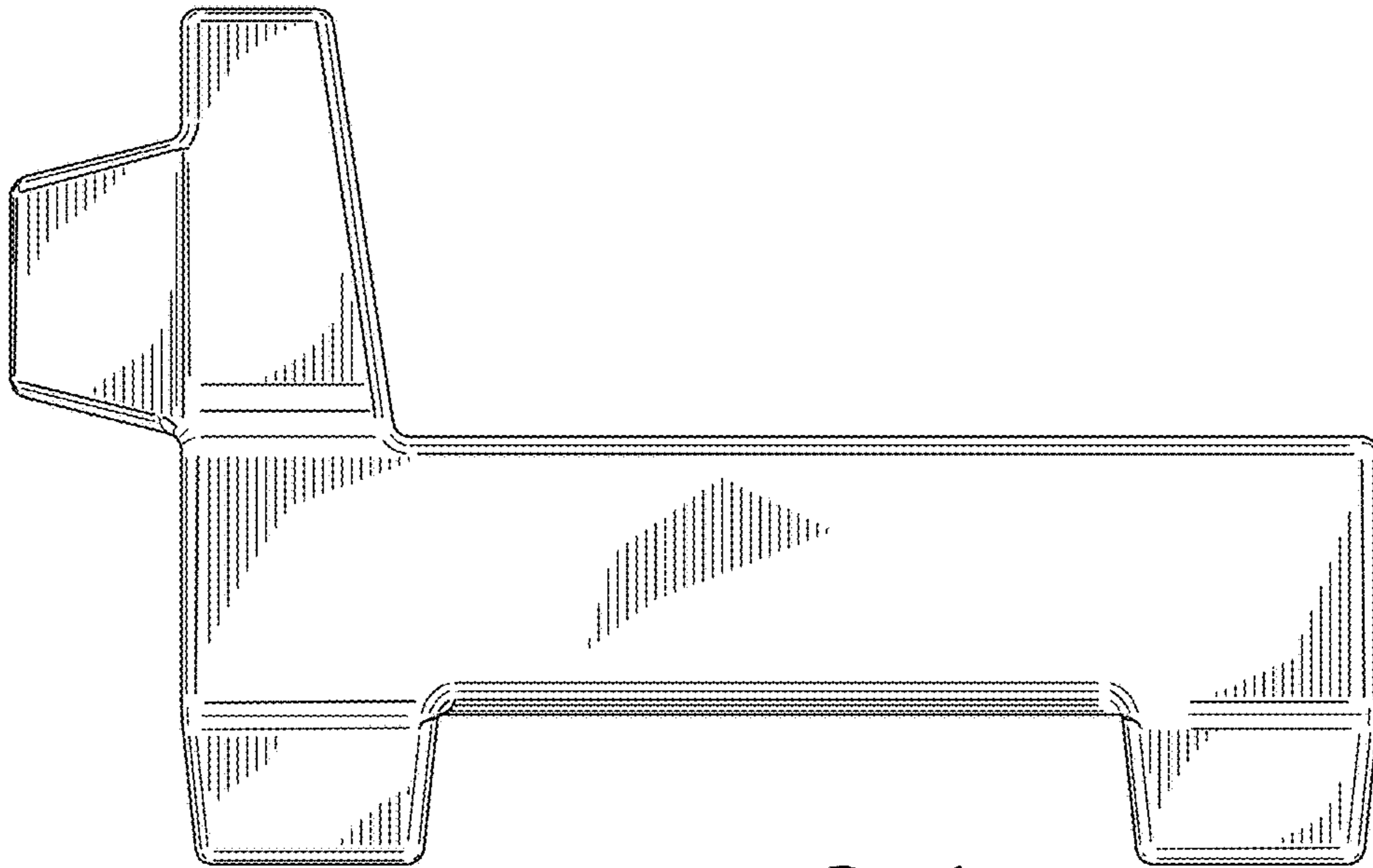

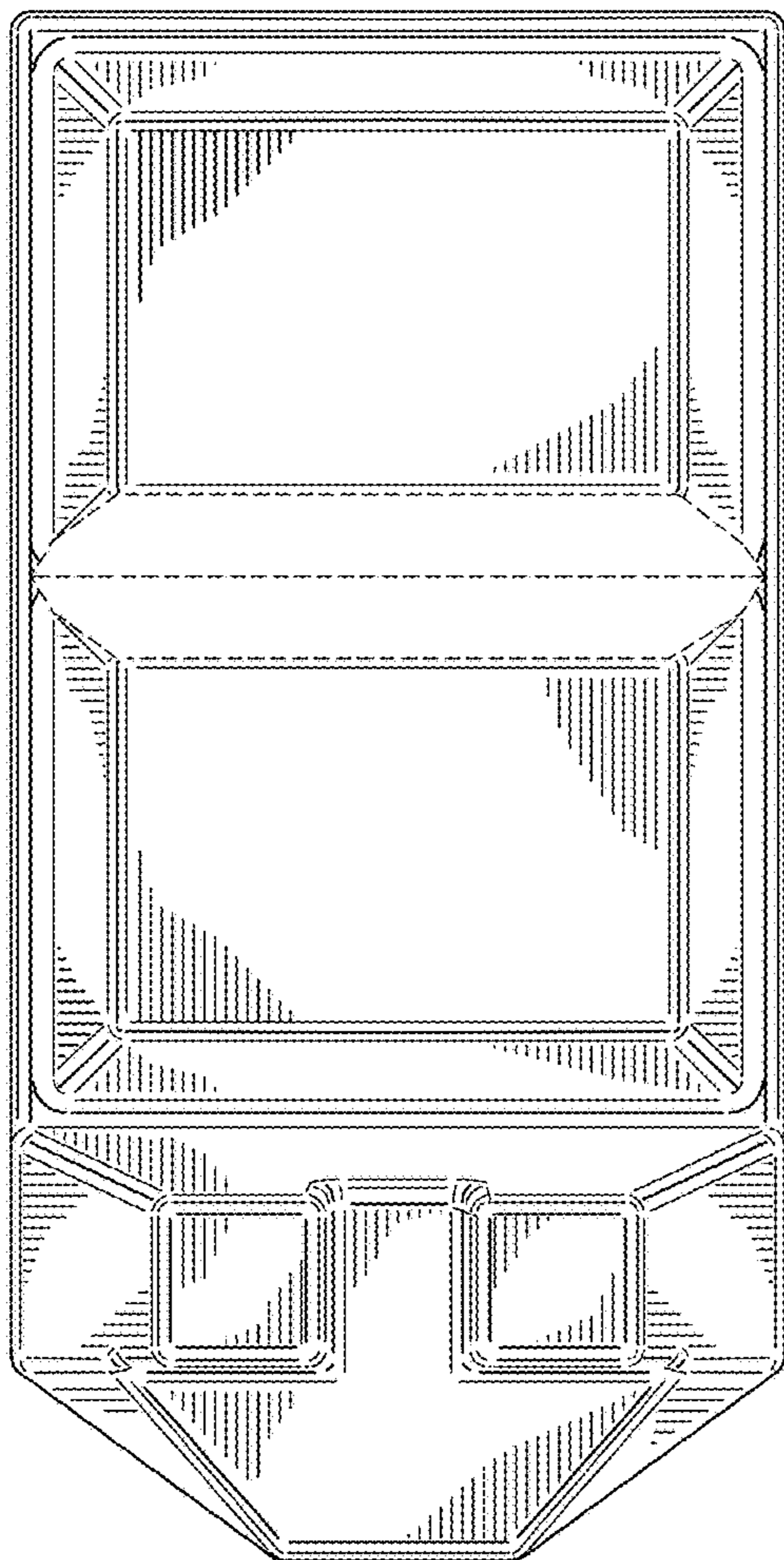

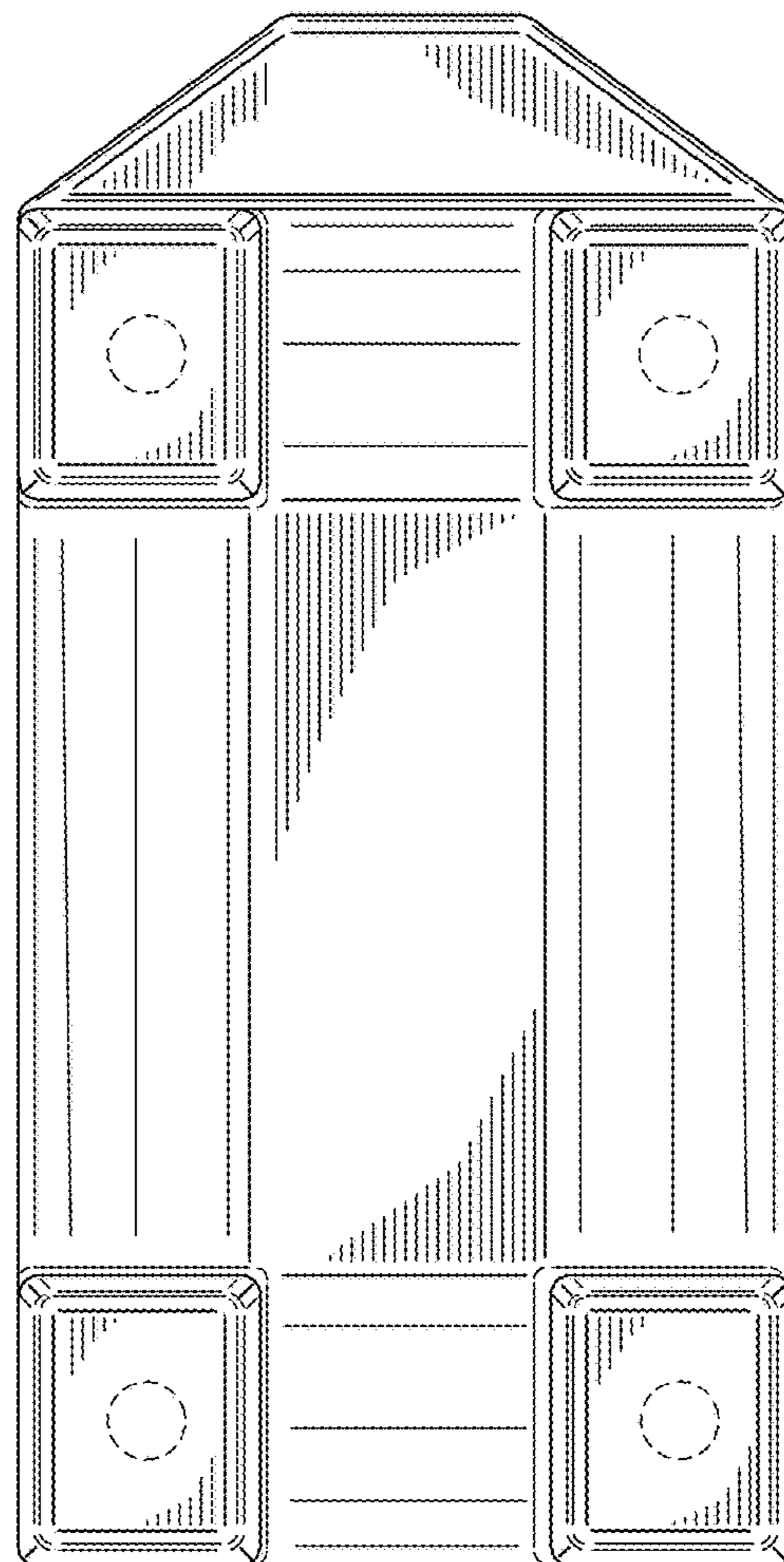
