FIG. 3 is a left side view of the bag holder of the present invention.

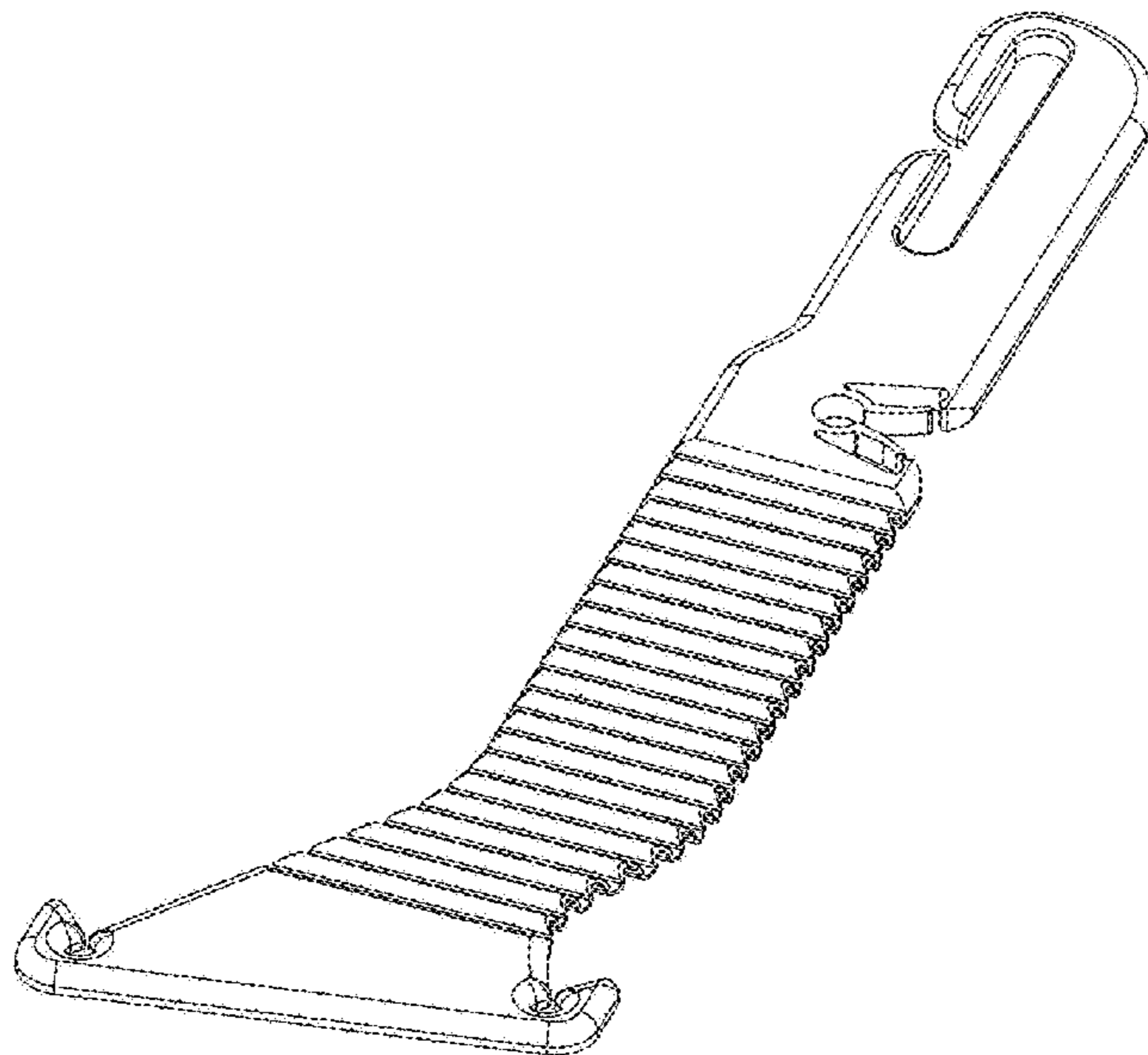
FIG. 4 is a right side view of the bag holder of the present invention.

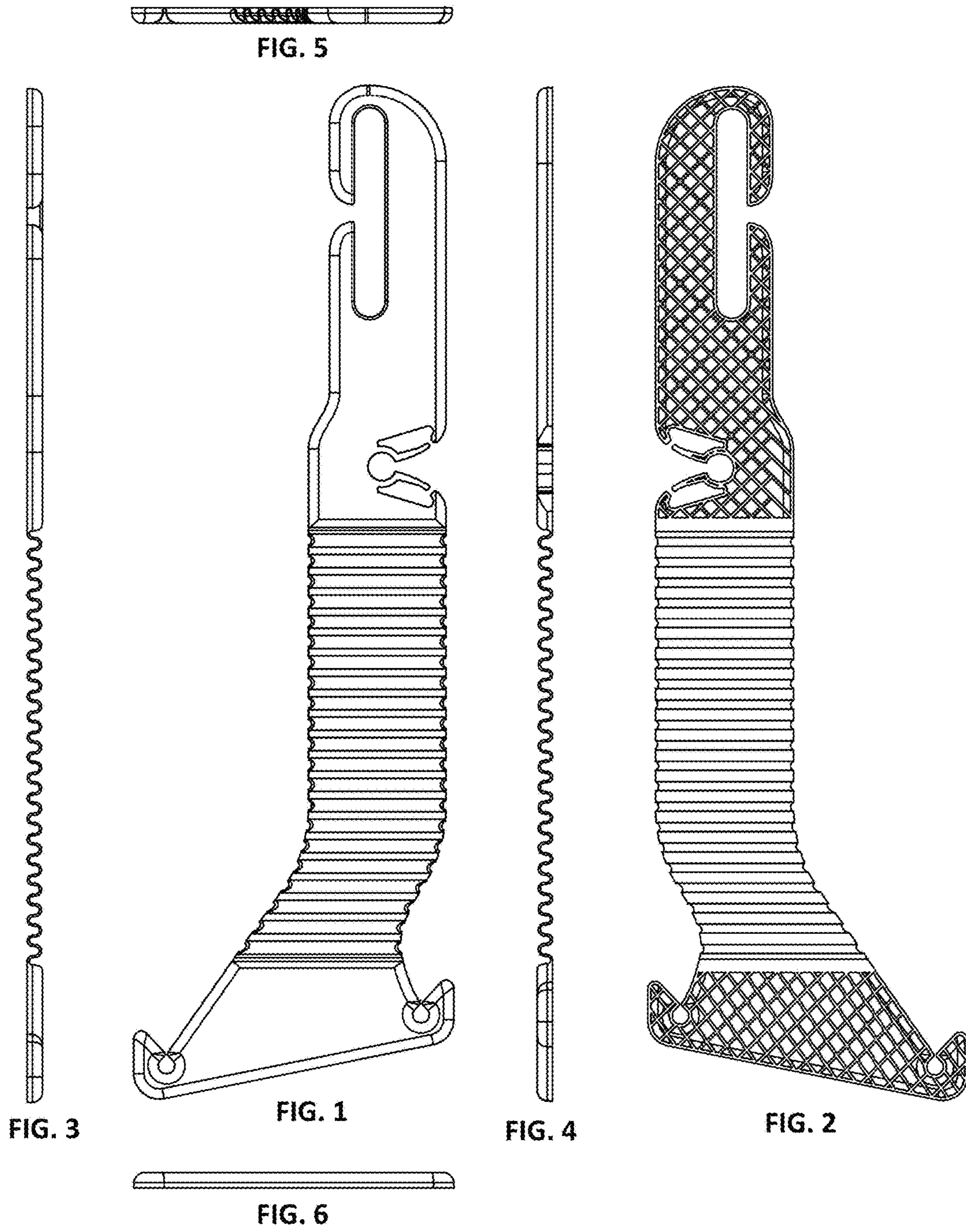
FIG. 5 is a top view of the bag holder of the present invention.

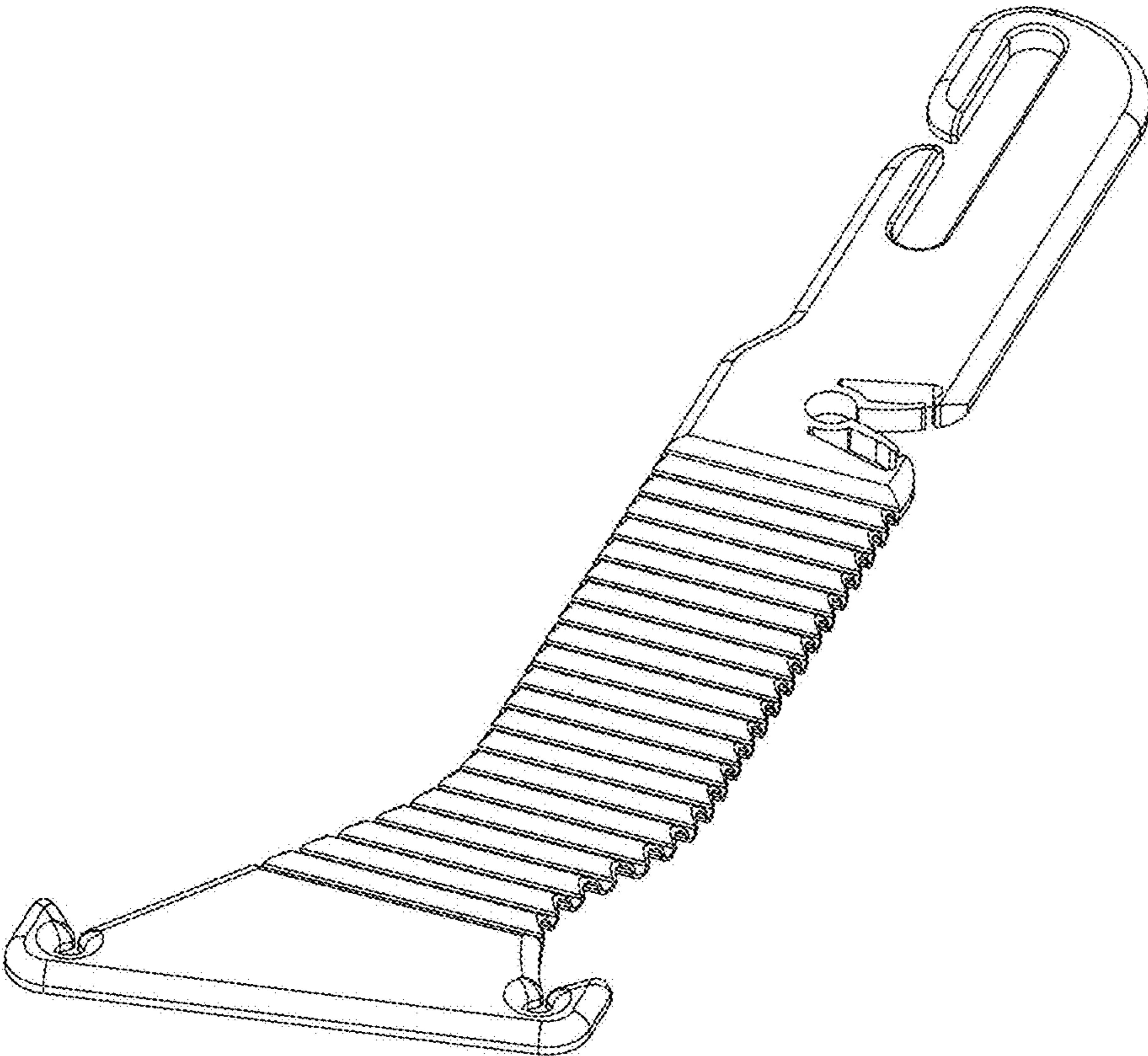


FIG. 7
