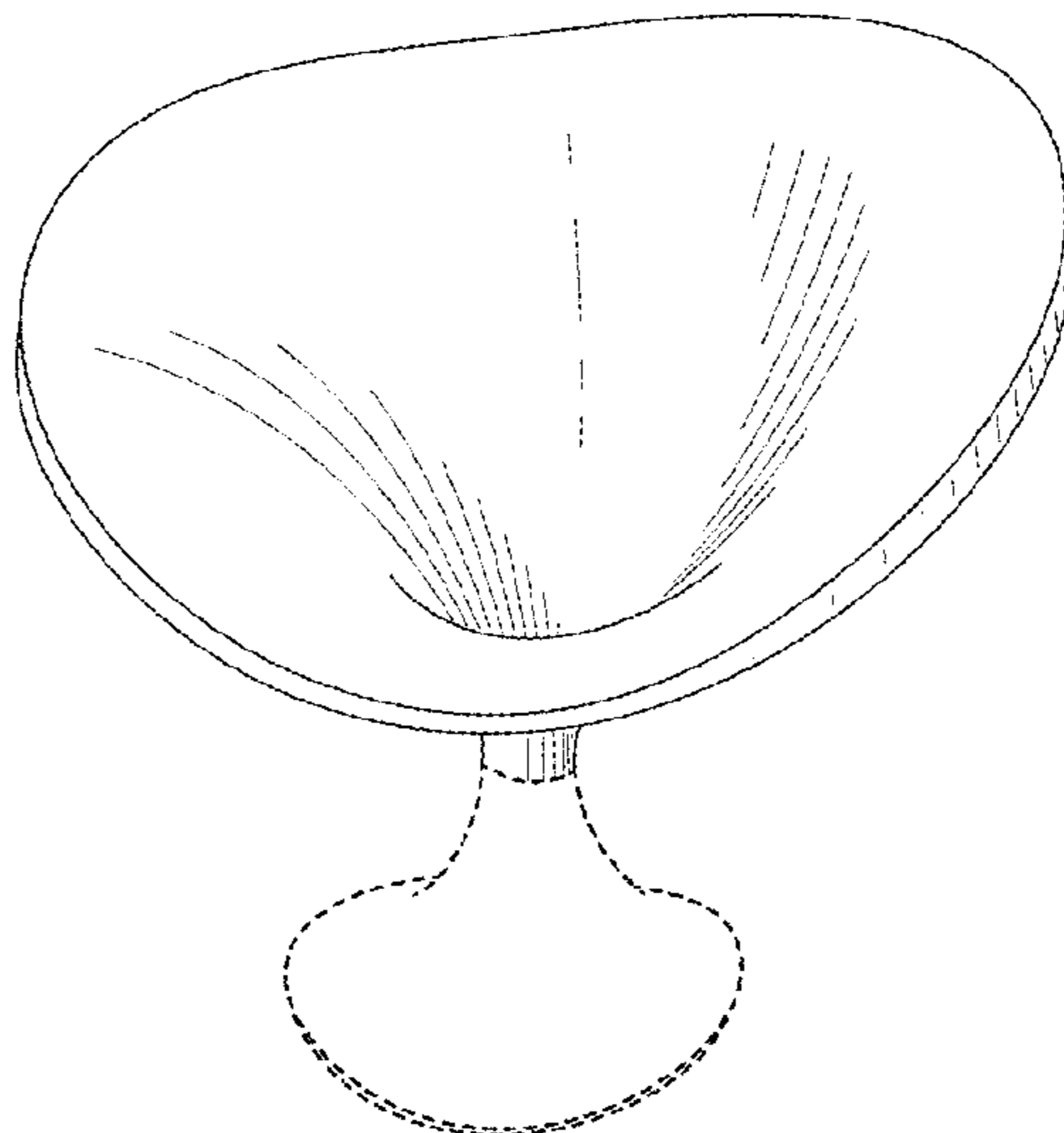
(57) **CLAIM**

The ornamental design for a ring, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a ring showing my new design;  
FIG. 2 is a bottom, rear perspective view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a front side elevational view thereof;  
FIG. 6 is a rear side elevation view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken lines shown in FIGS. 1-6 and 8 represent portions of the ring which form no part of the claimed design.

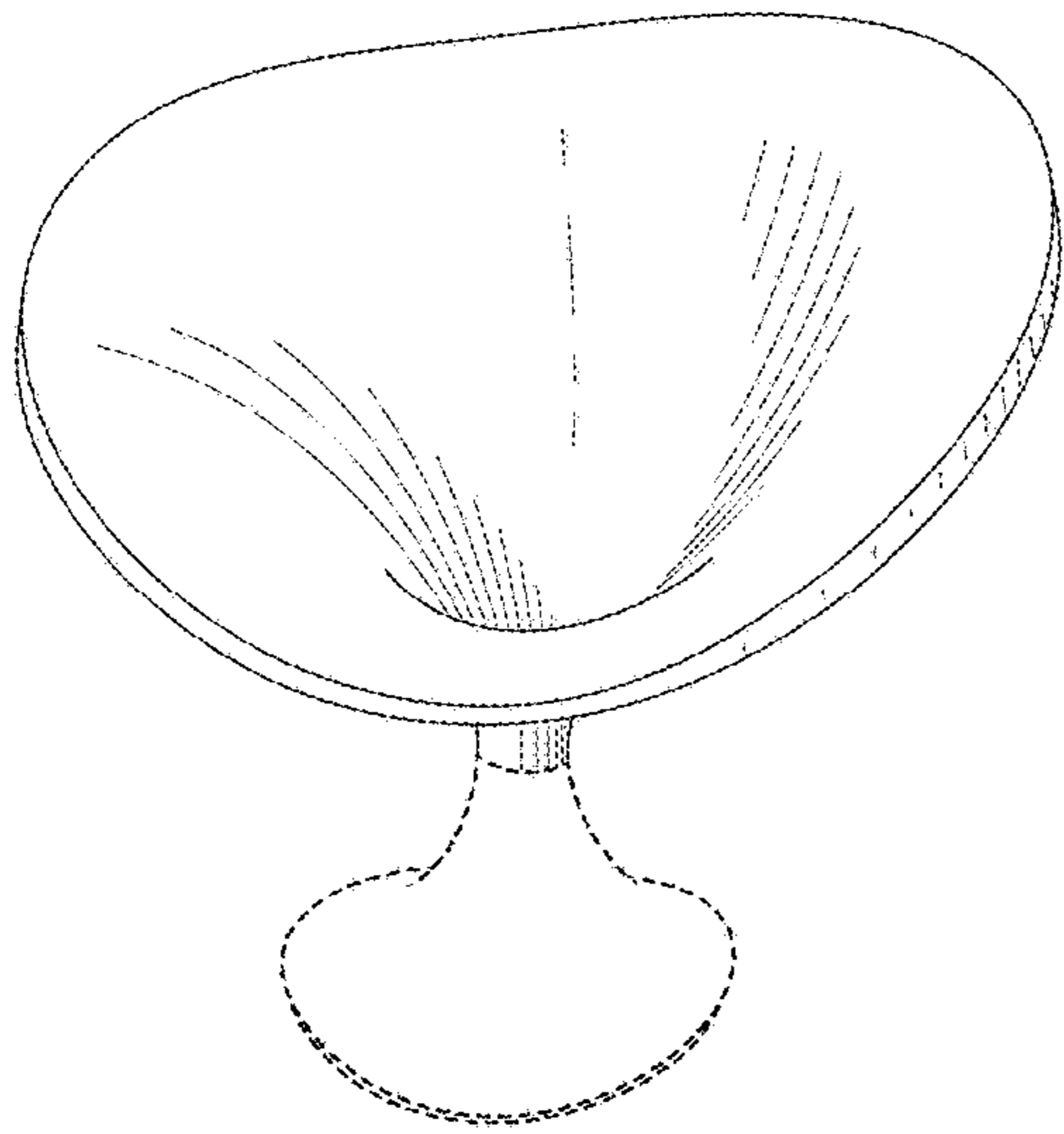

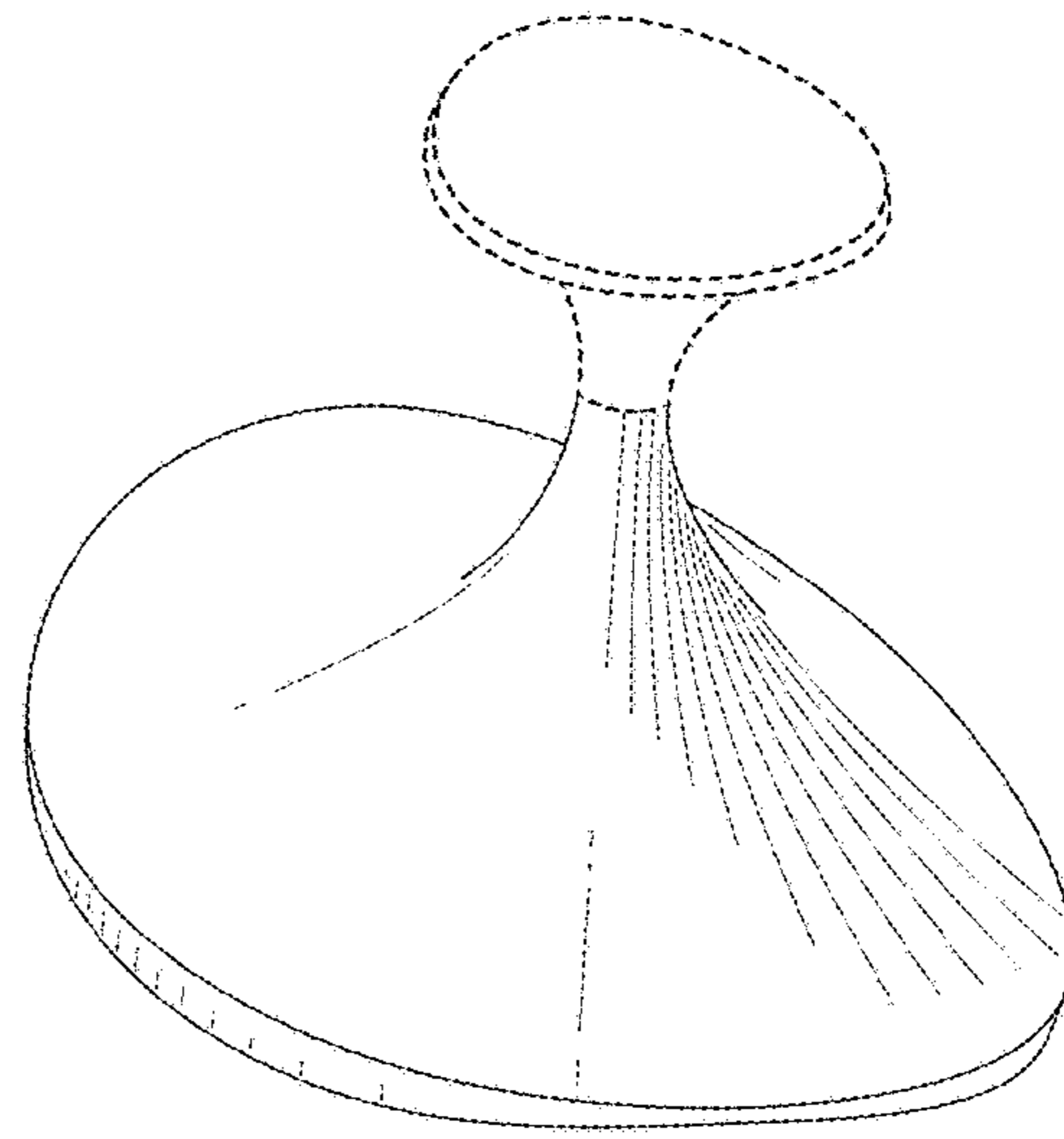

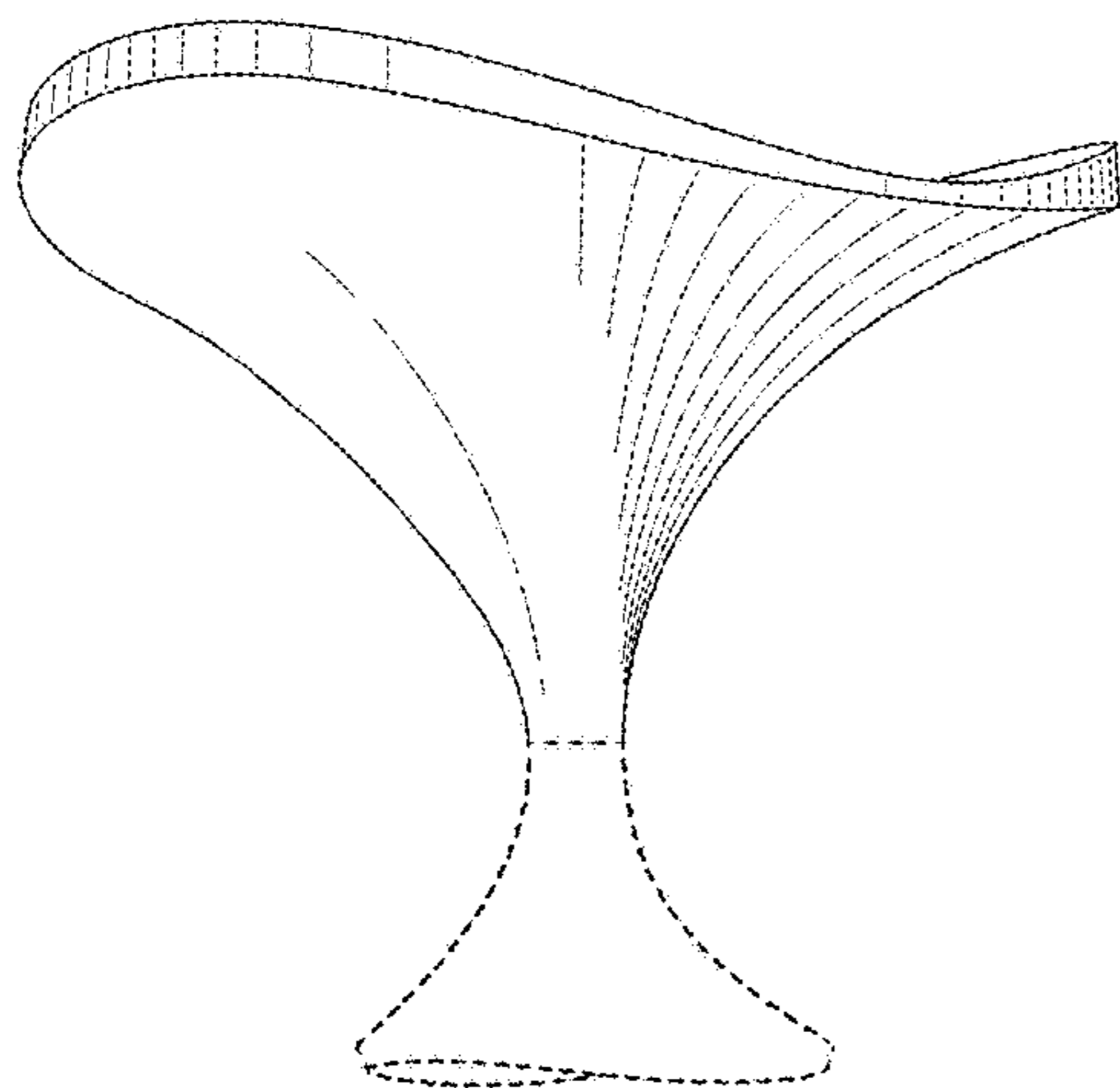

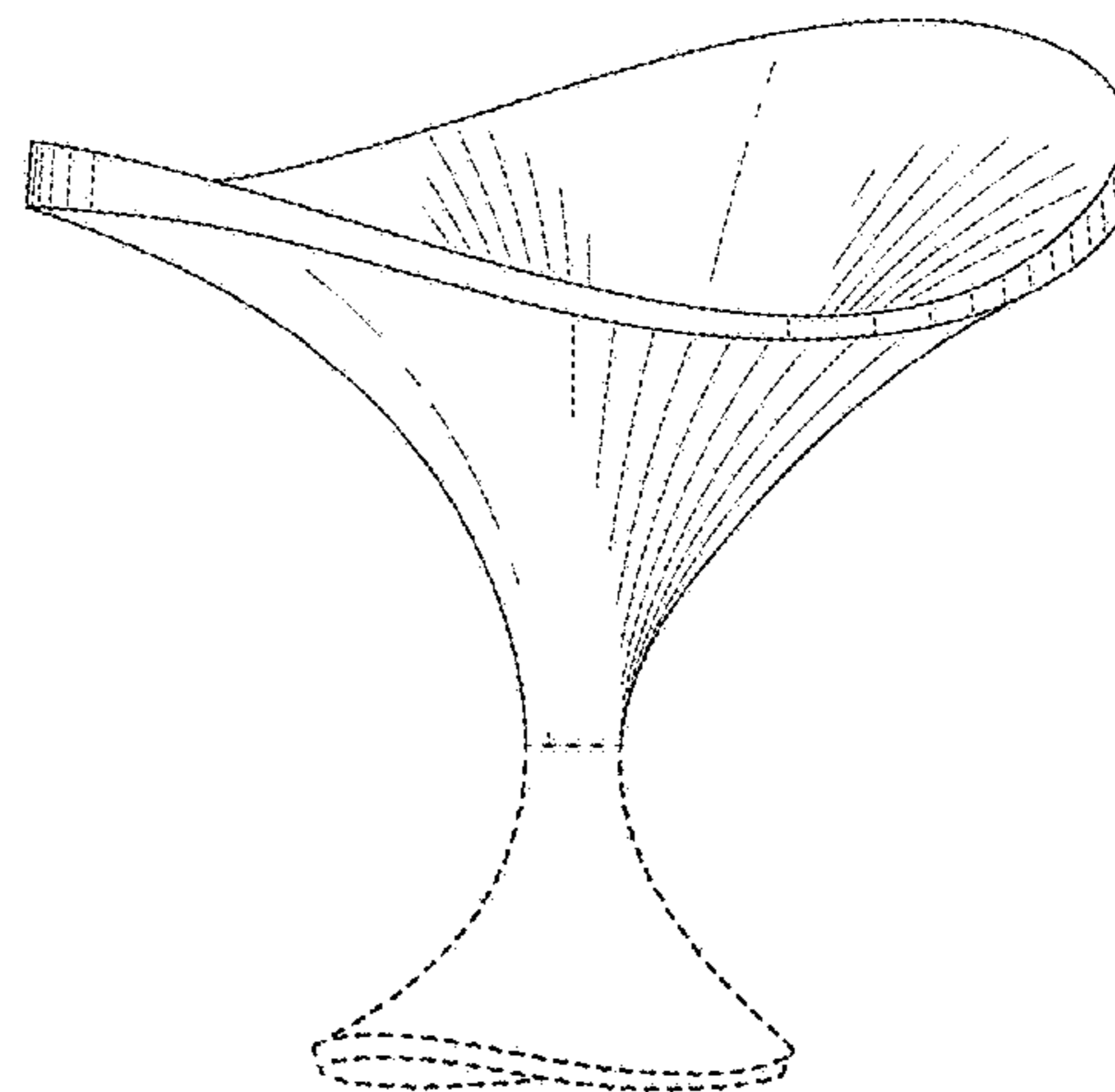

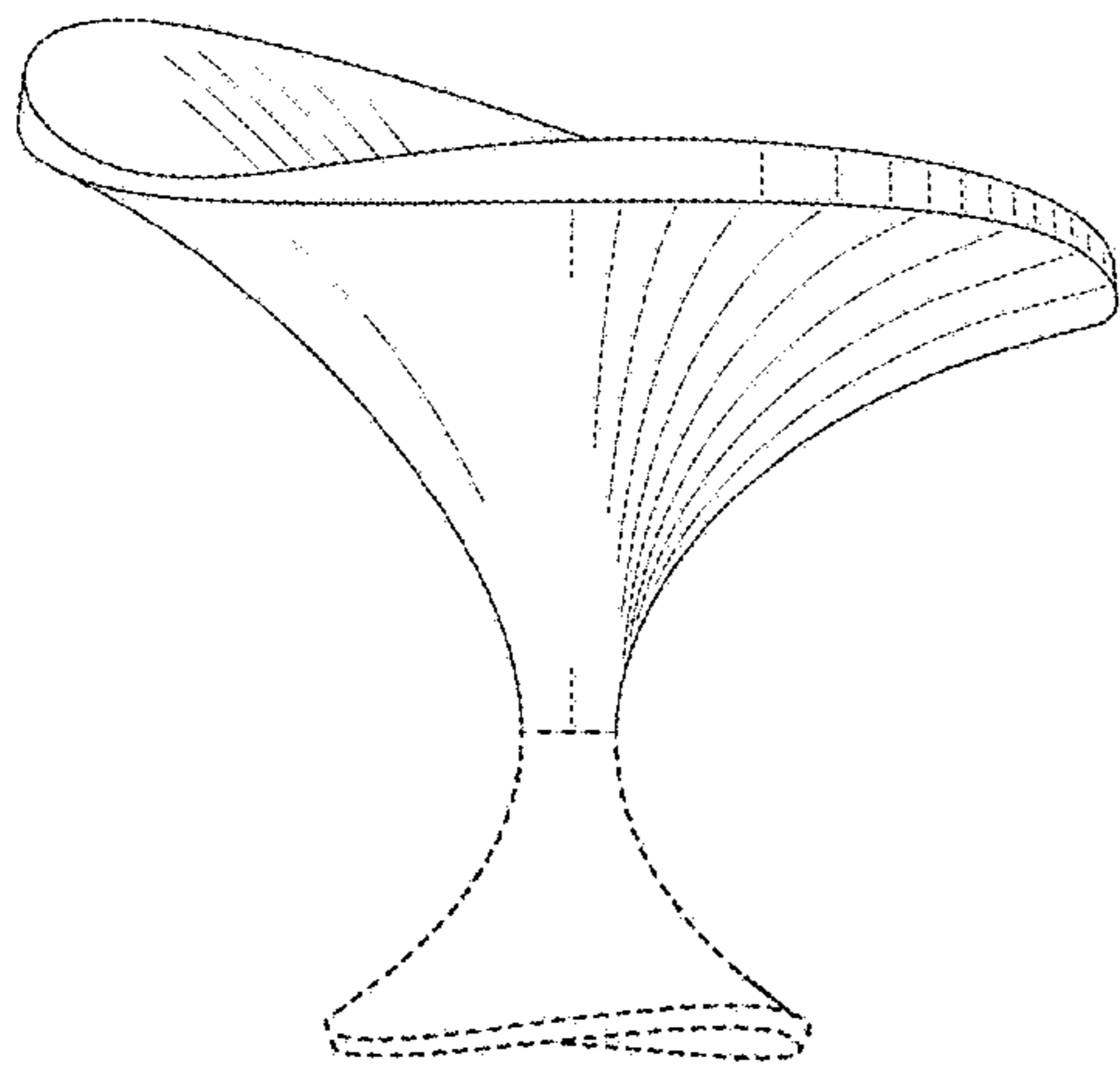

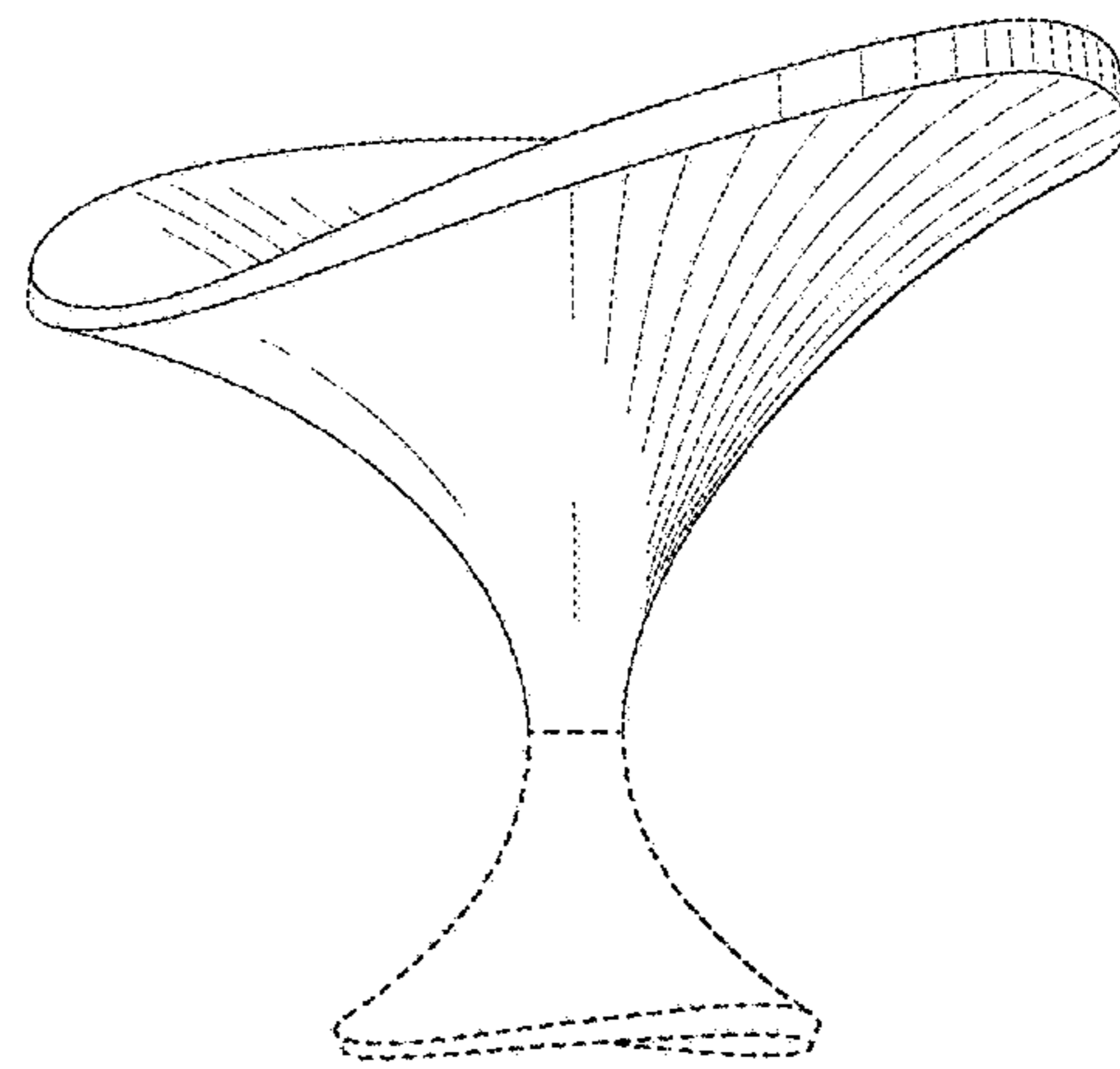

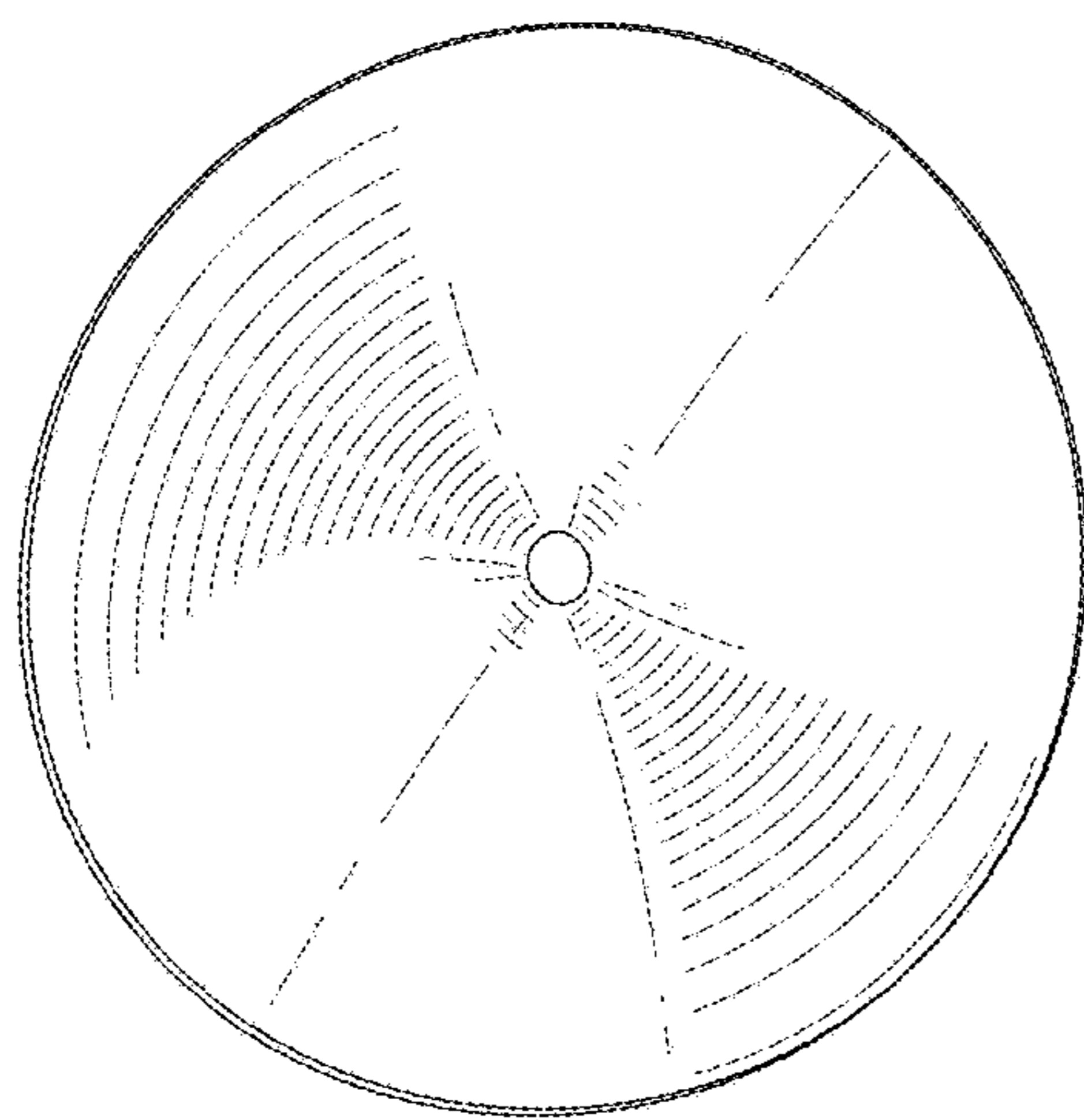

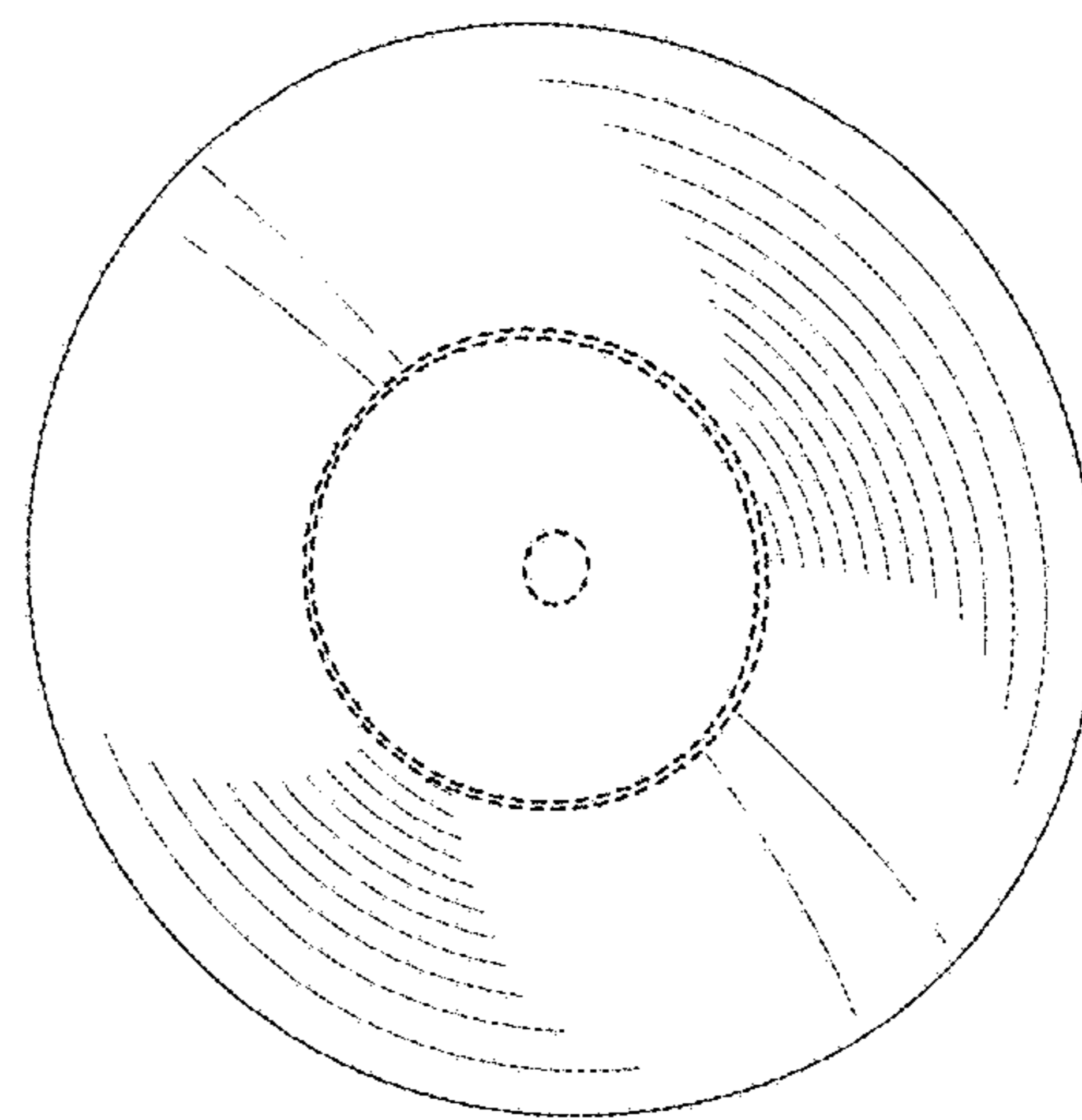
