DESCRIPTION

FIG. 10 is a front view of FIG. 8;

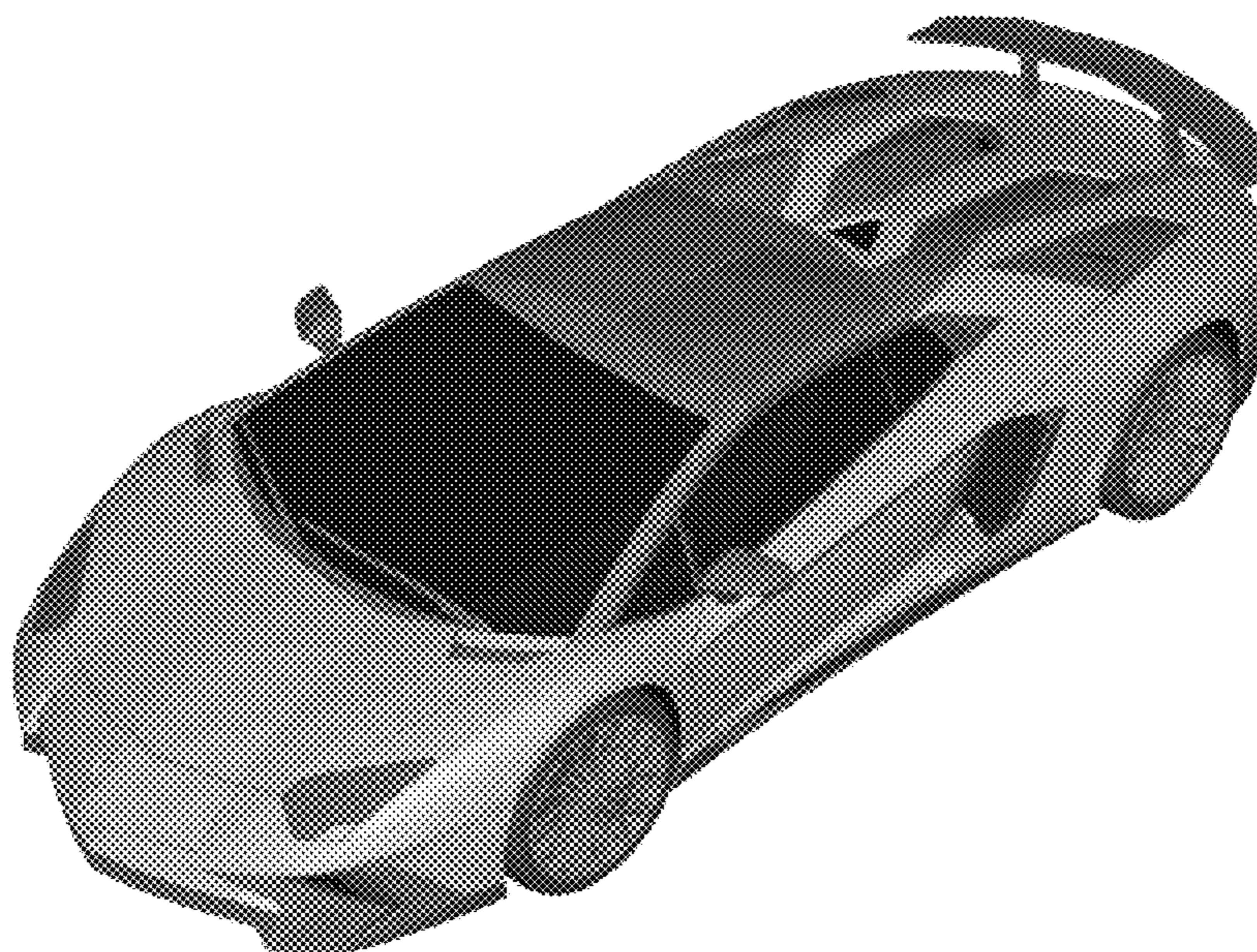
FIG. 11 is a rear view of FIG. 8;

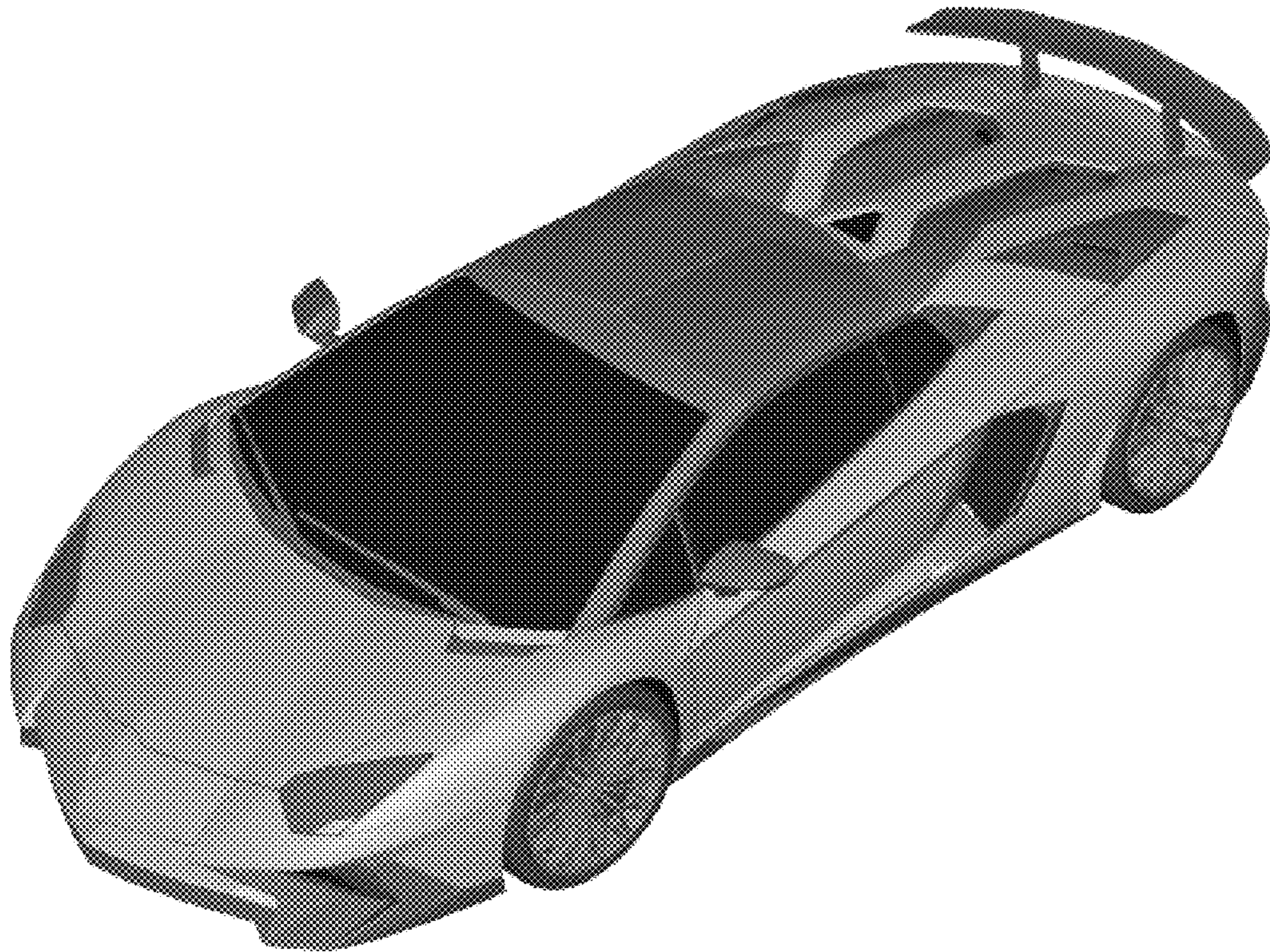

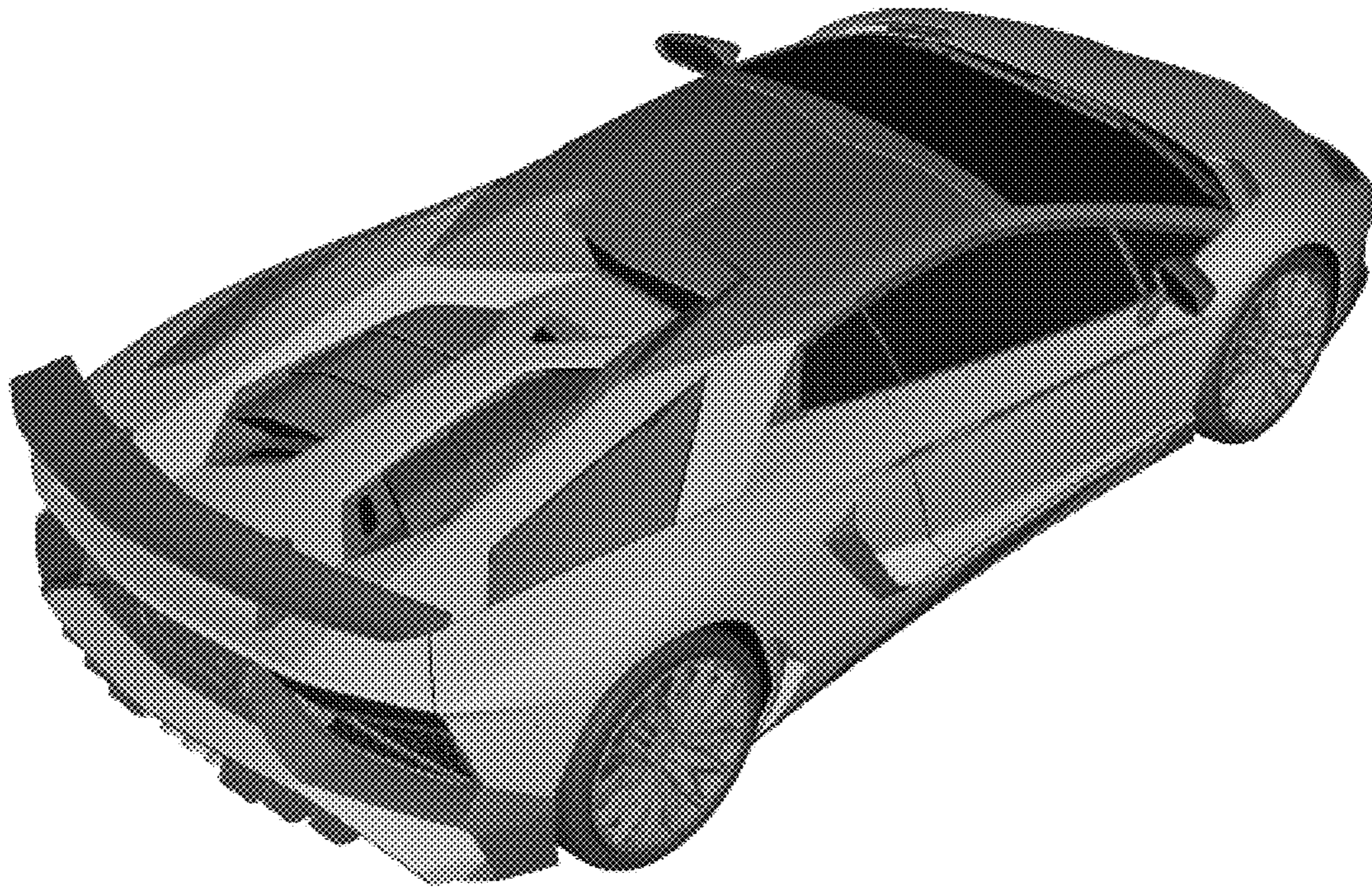

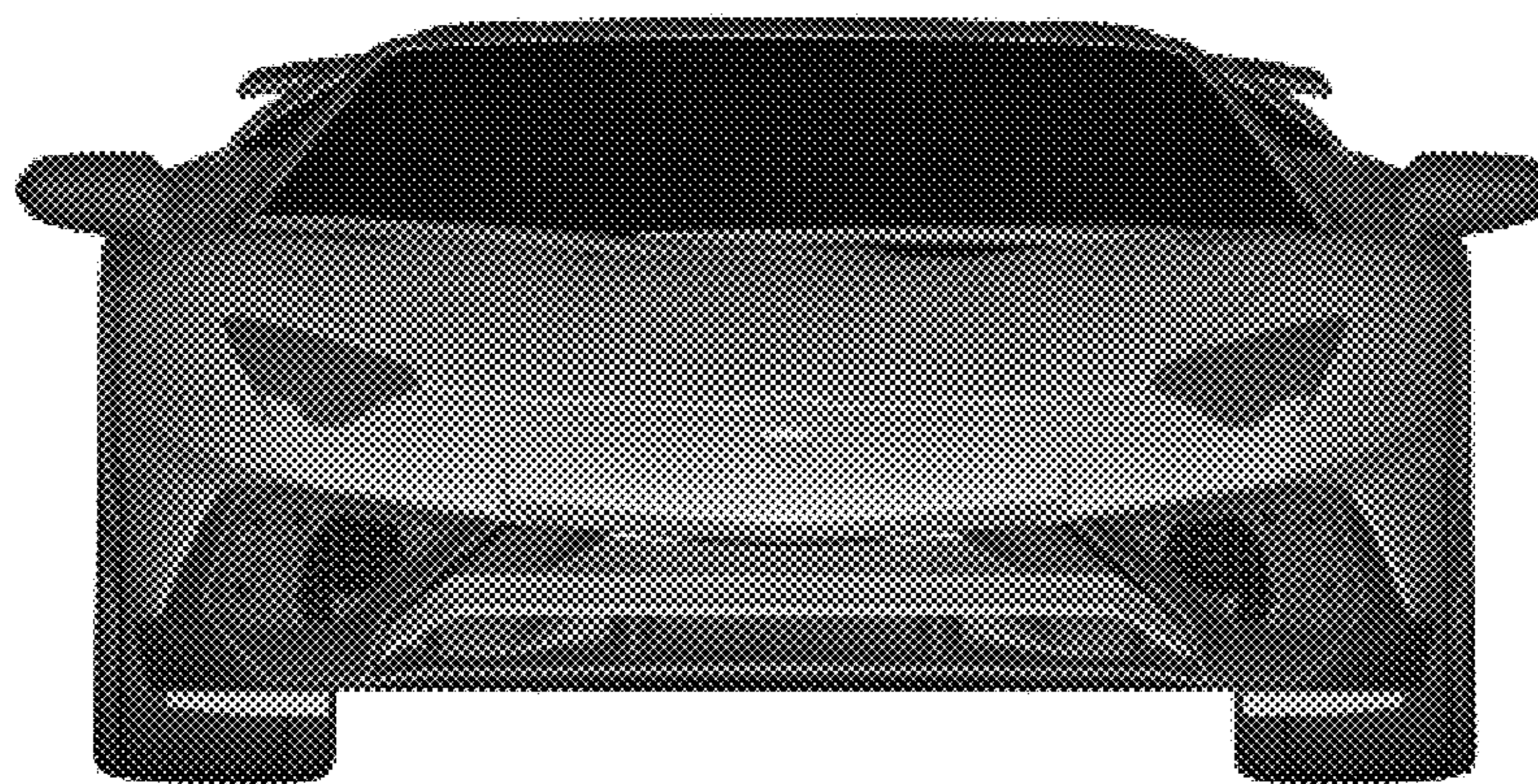

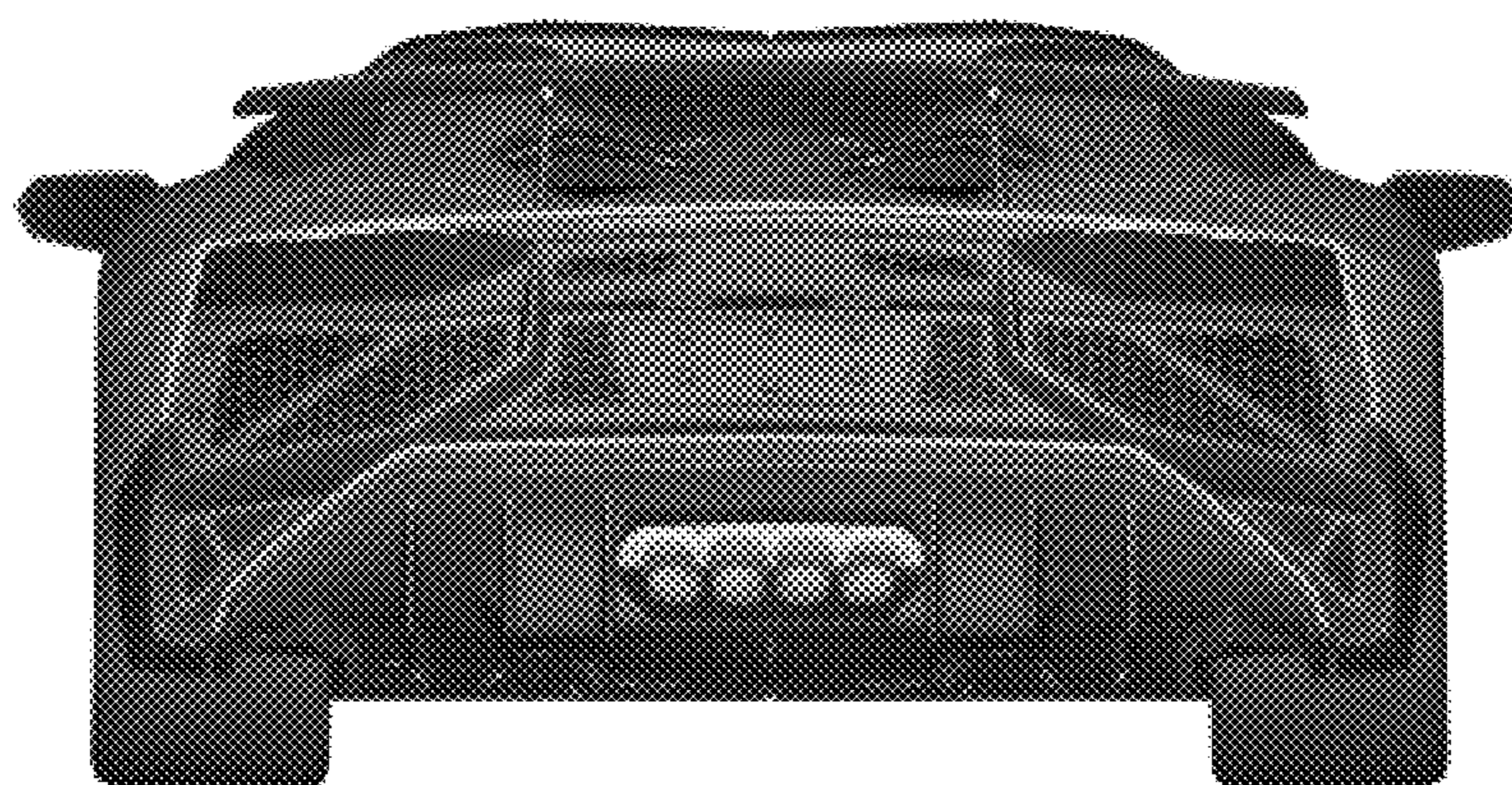

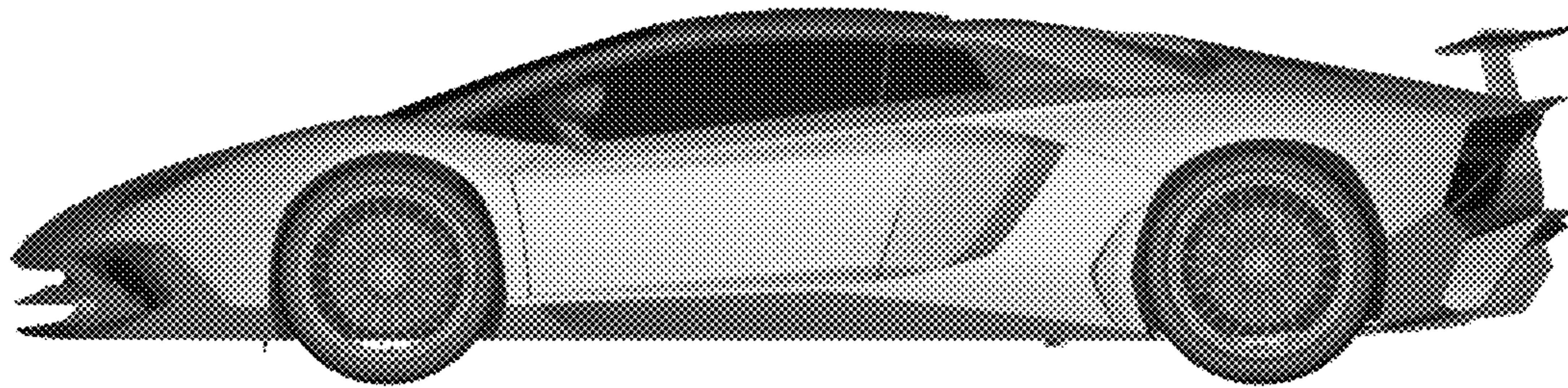

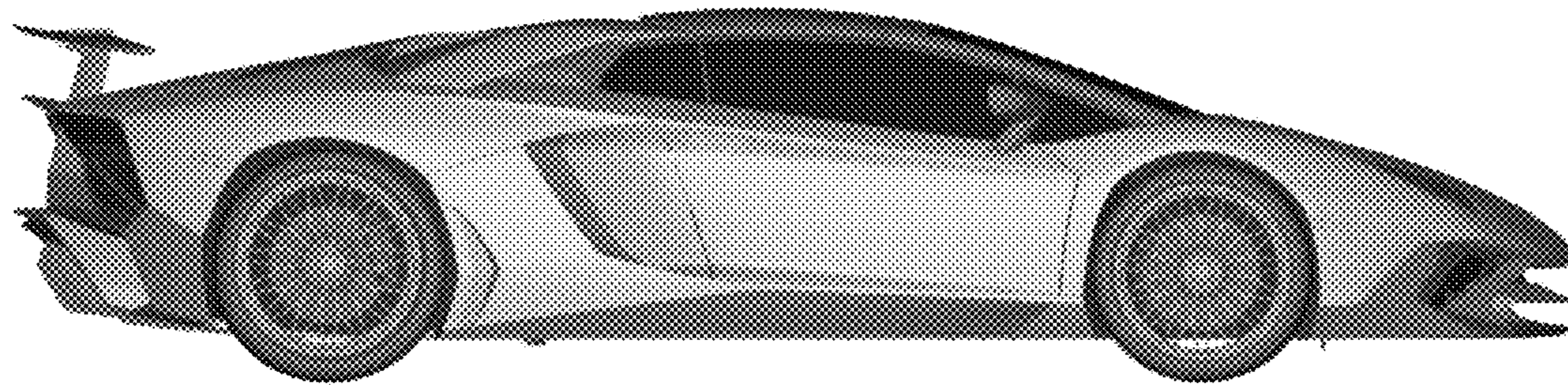

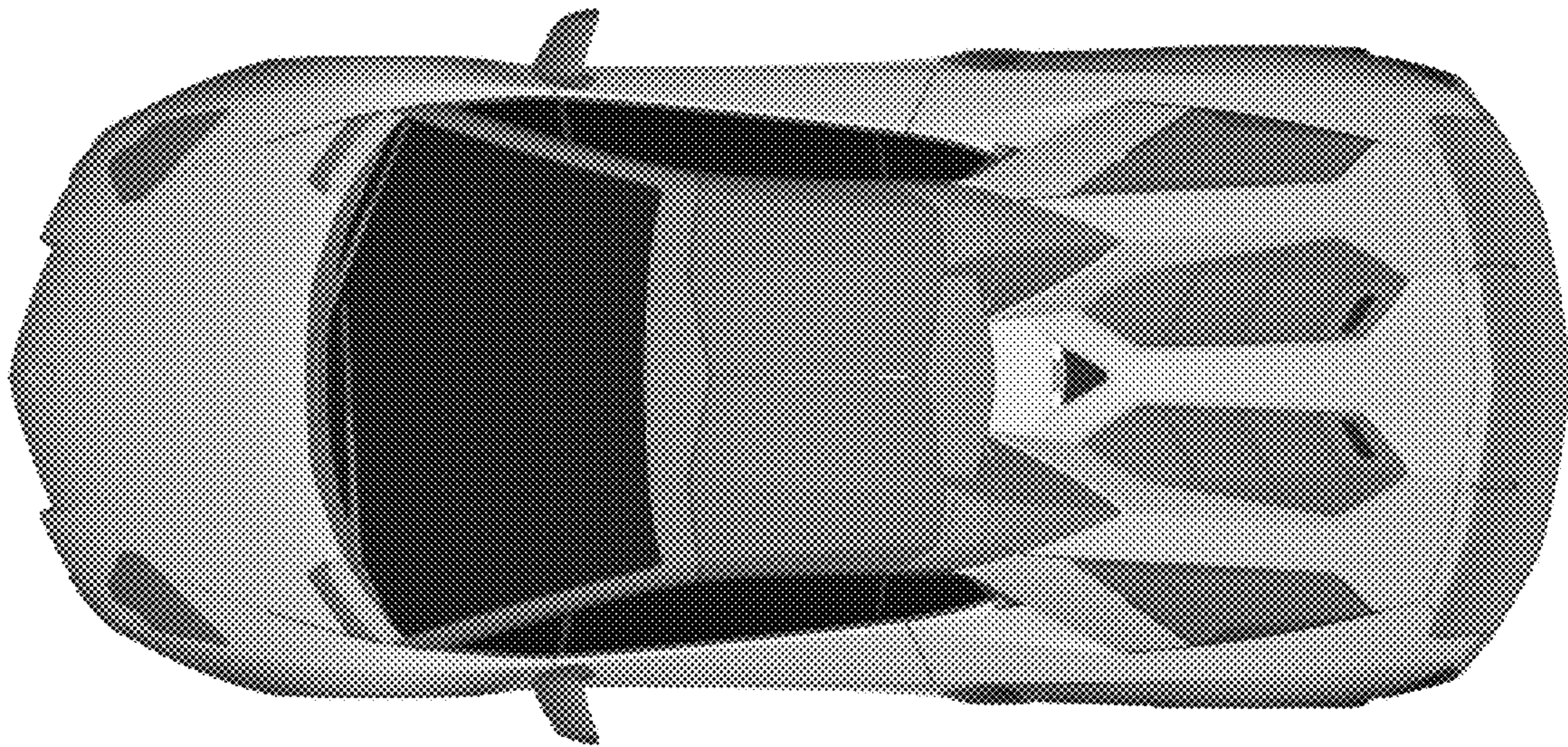

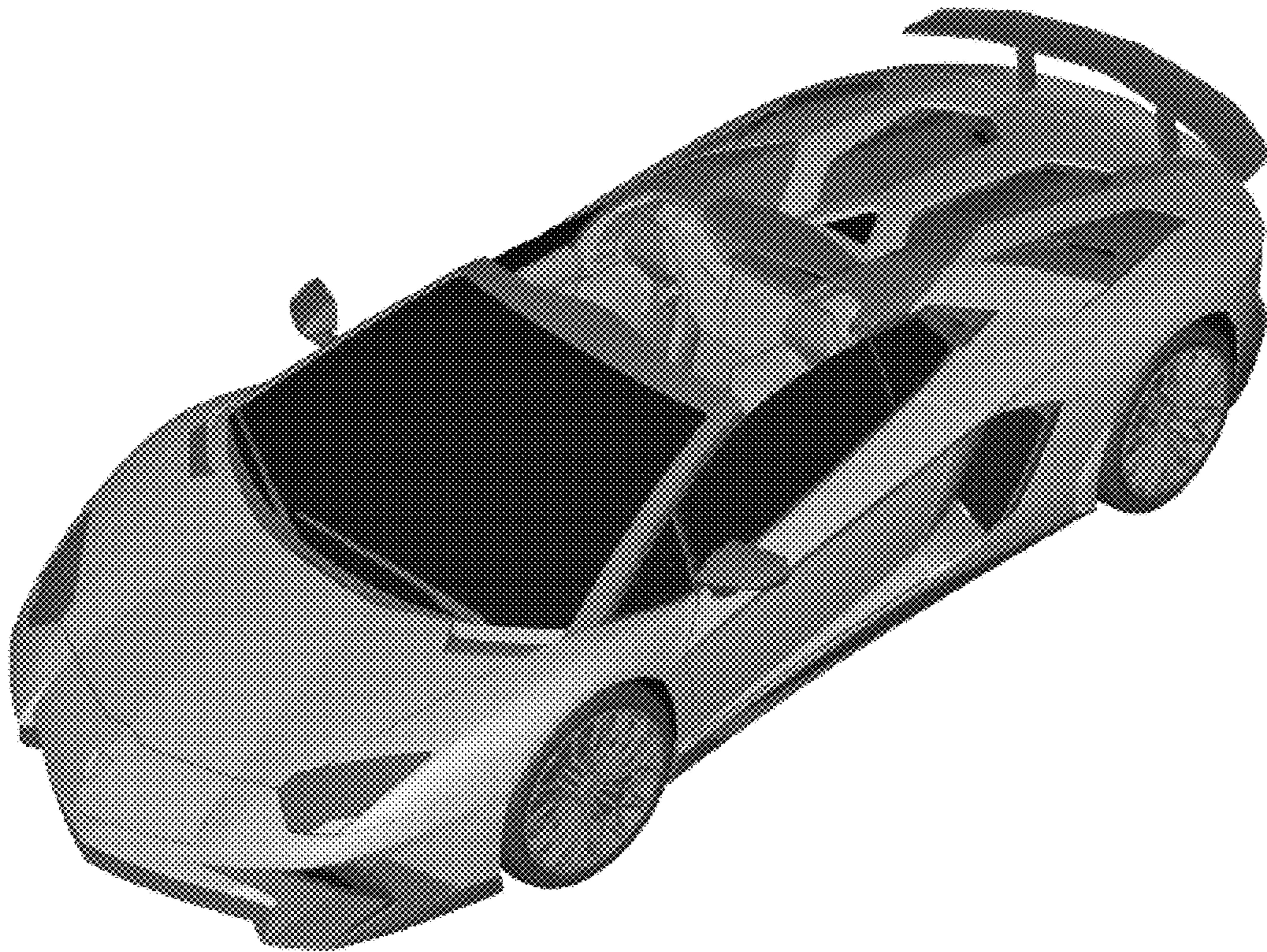

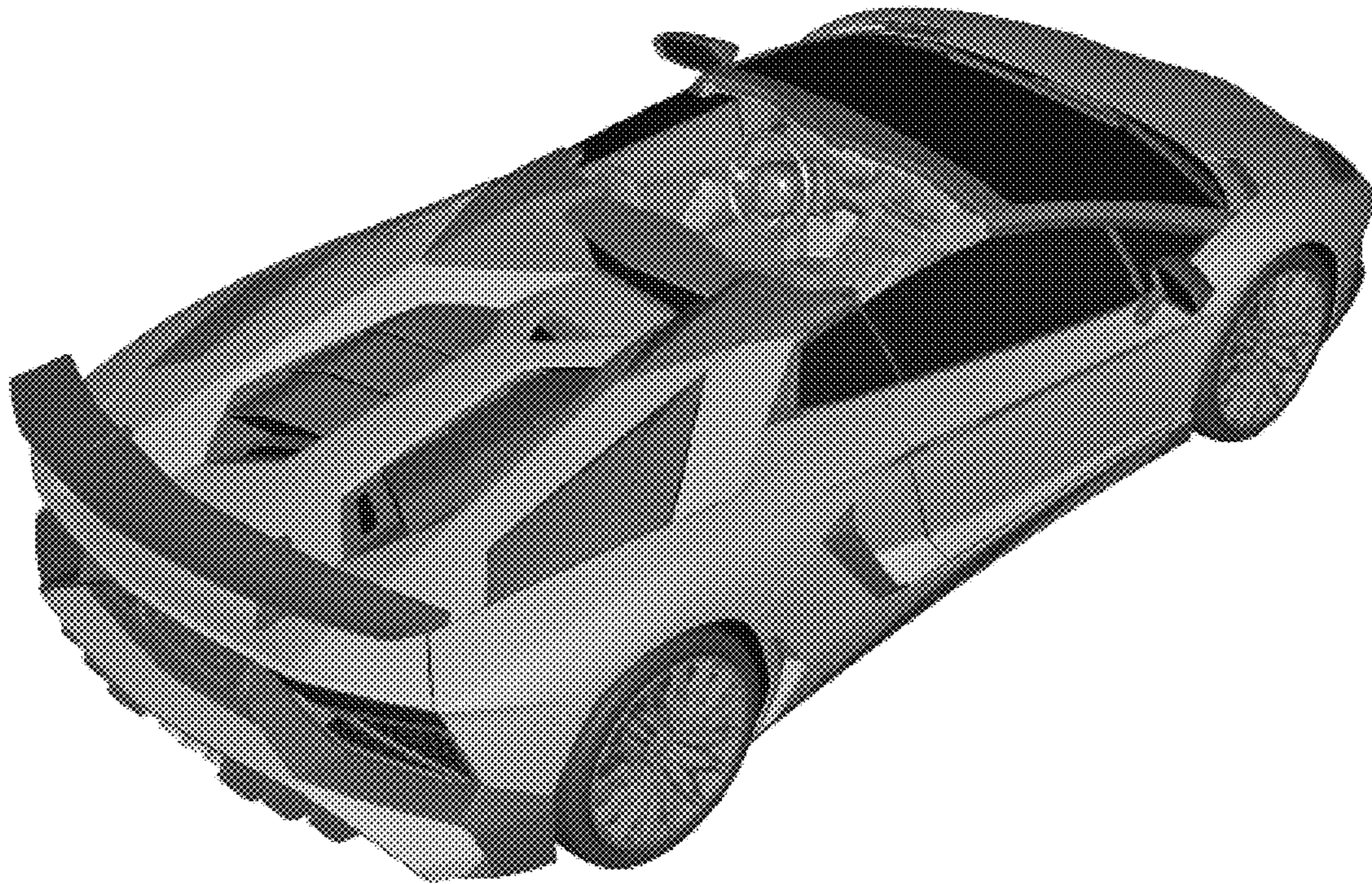

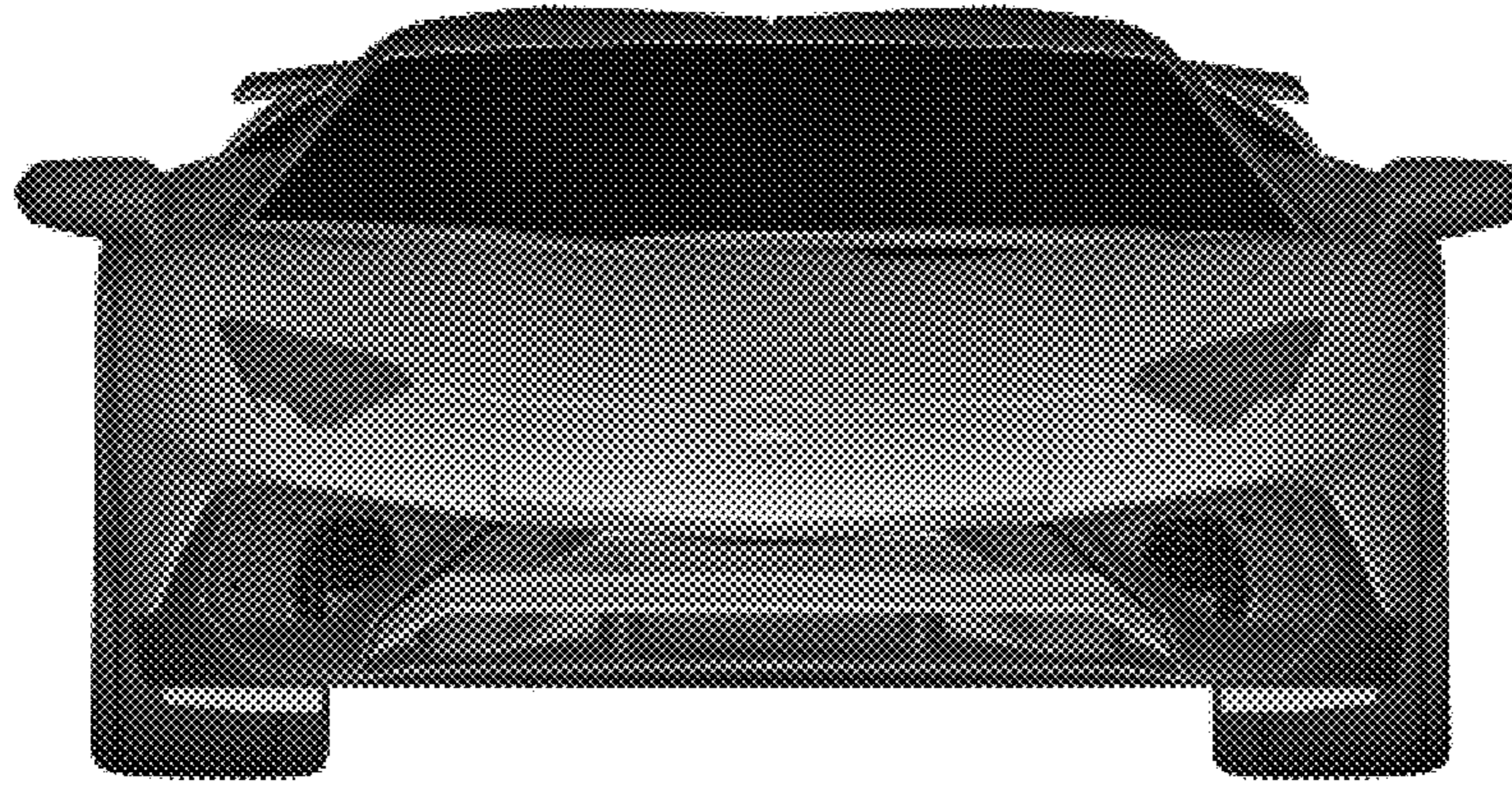

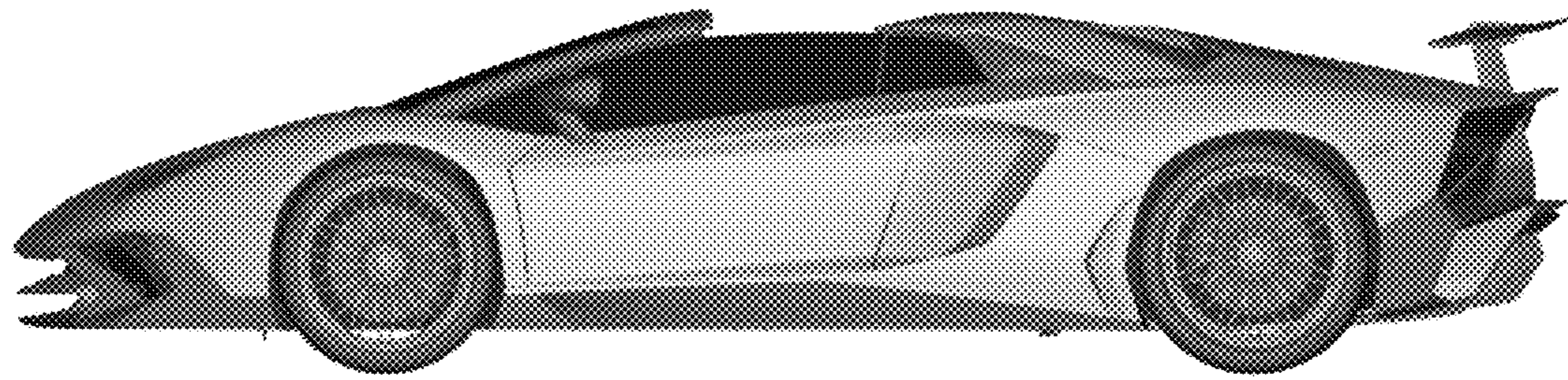

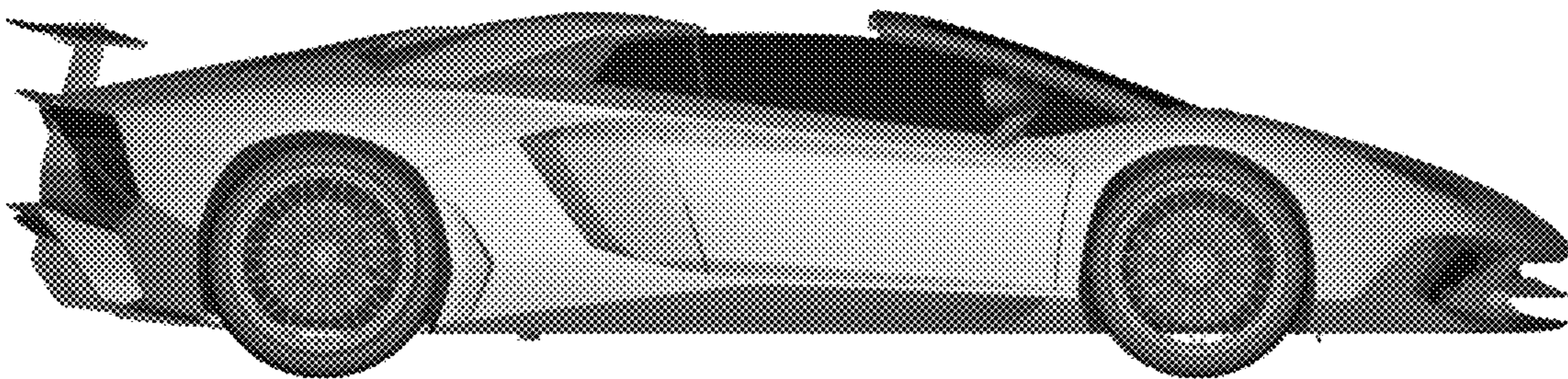

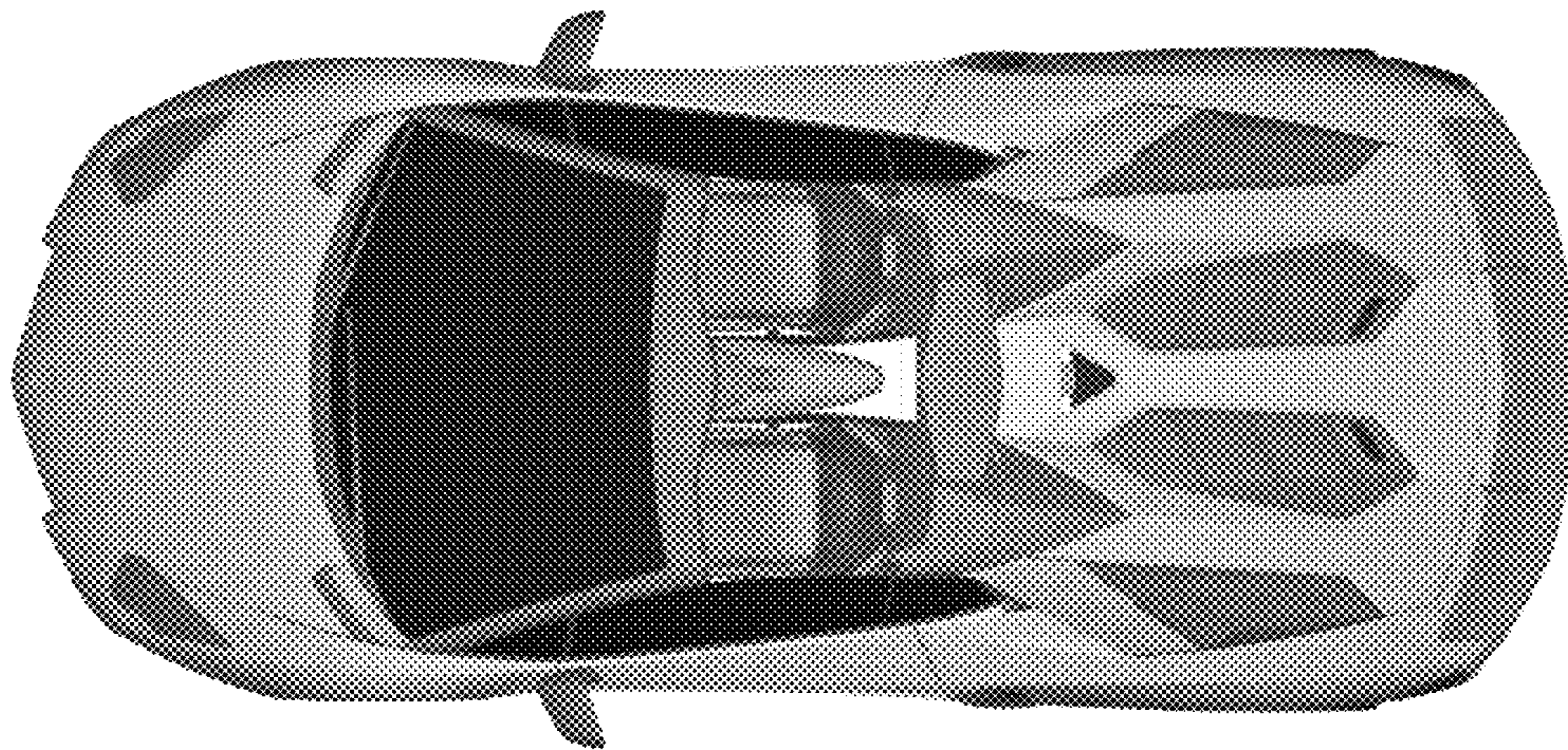
