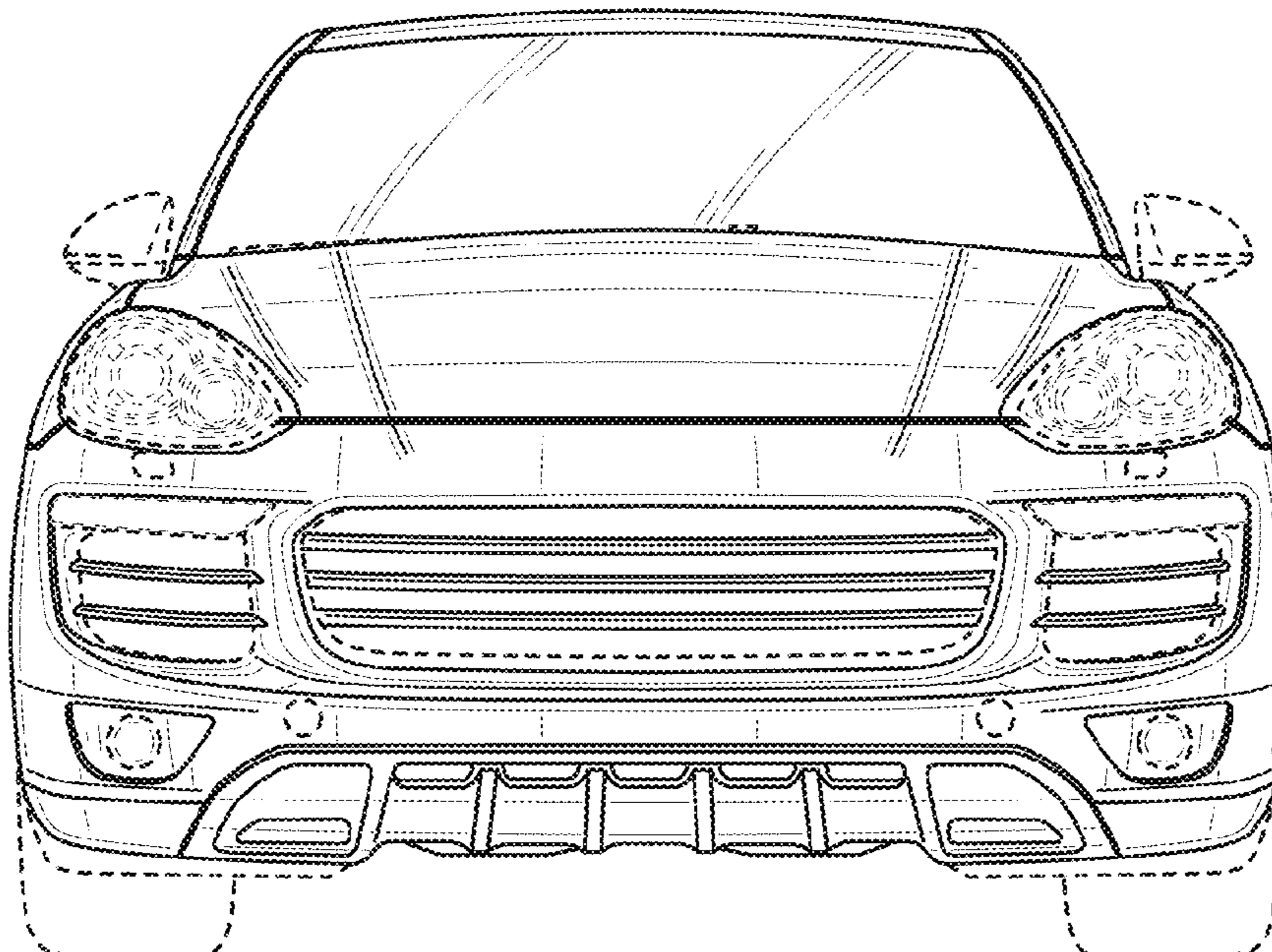
(57) **CLAIM**

The ornamental design for a motor vehicle, toy and/or replica, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevation view of a motor vehicle, toy and/or replica, the left side elevation view being a substantial mirror image thereof;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevation view thereof; and,  
FIG. 4 is a rear elevation view thereof.  
The broken line showing of the motor vehicle, toy and/or replica is for the purpose of illustrating portions of the motor vehicle, toy and/or replica and forms no part of the claimed design.

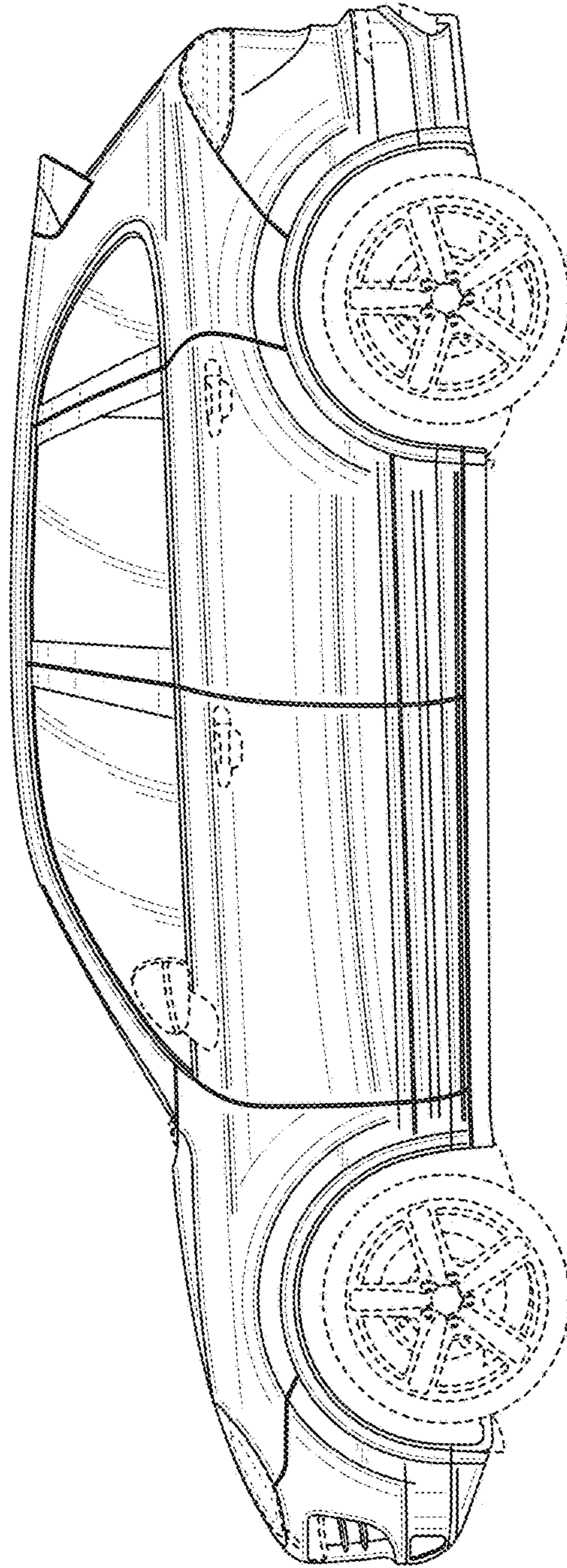

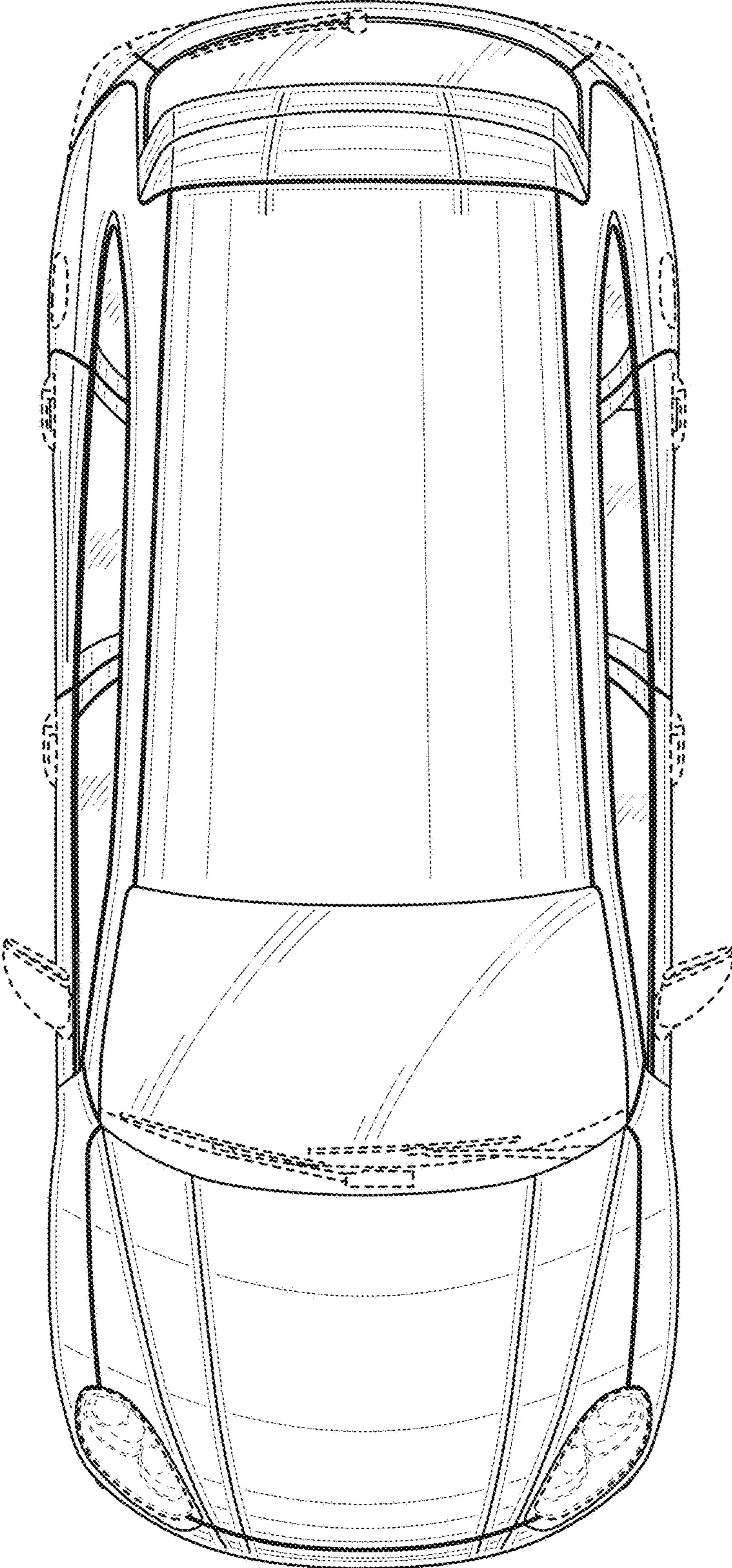

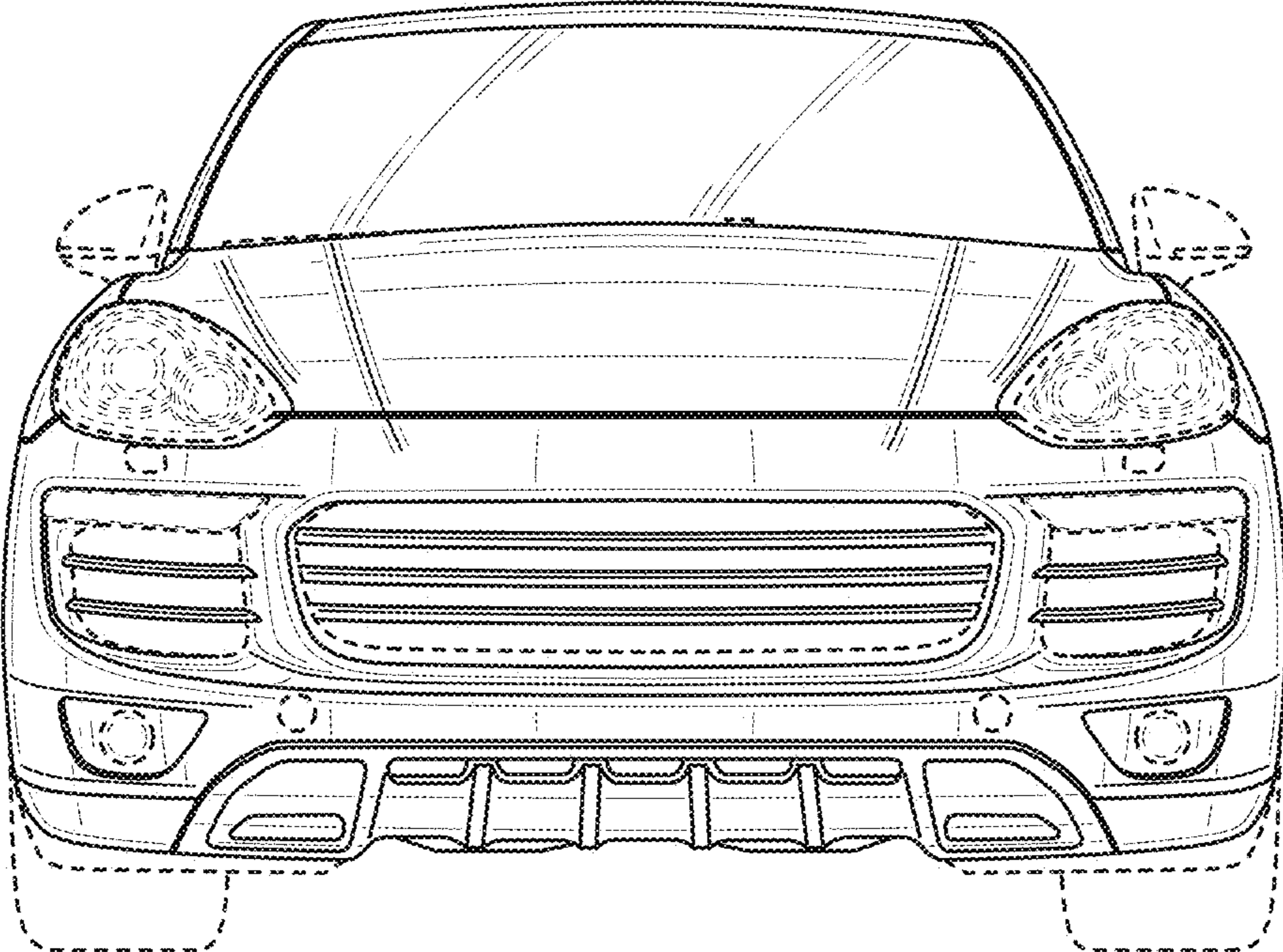

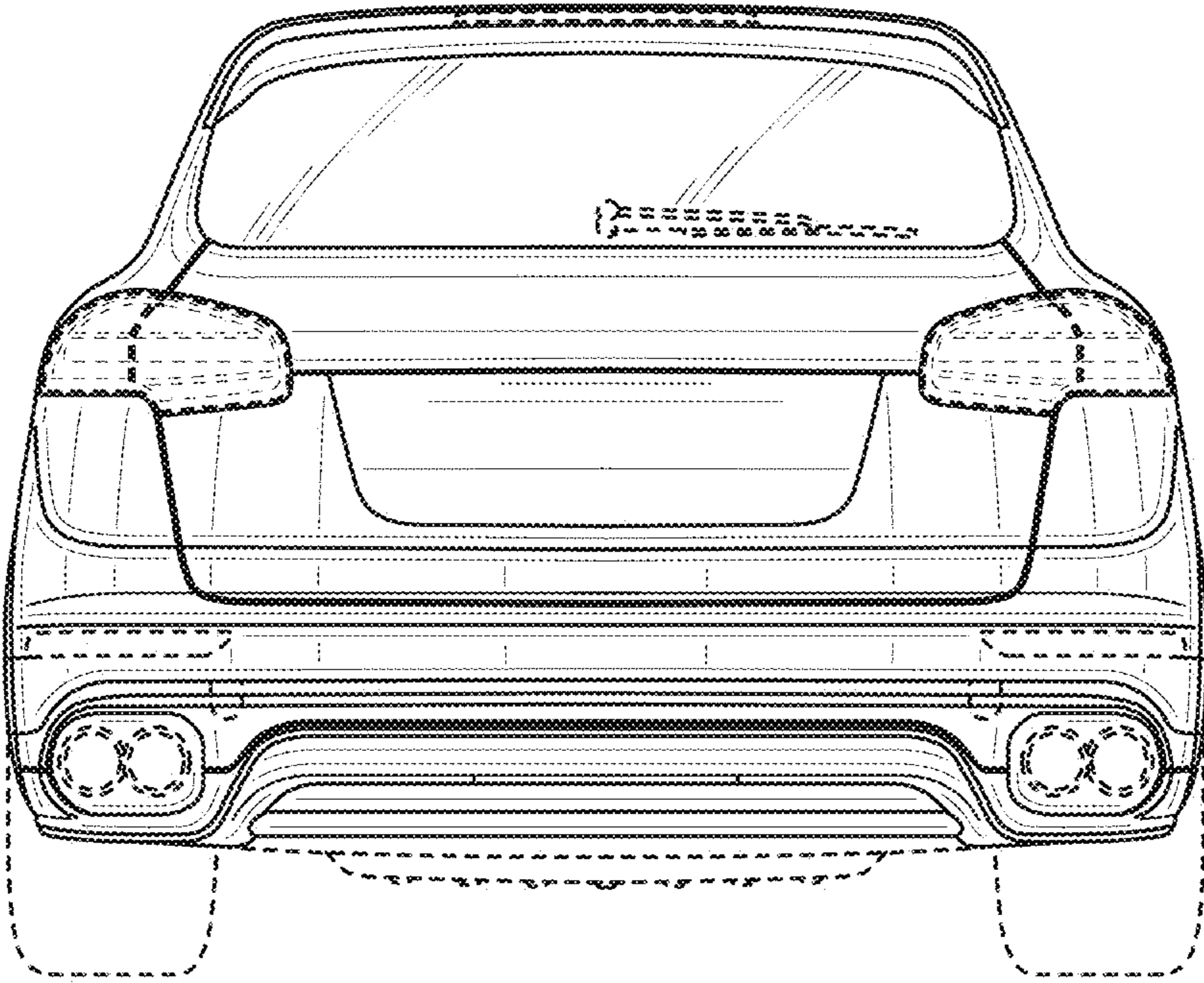
