(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire tread showing our design;

FIG. 2 is a front view thereof;

FIG. 7 is a section view taken along line 7-7 in FIG. 6;

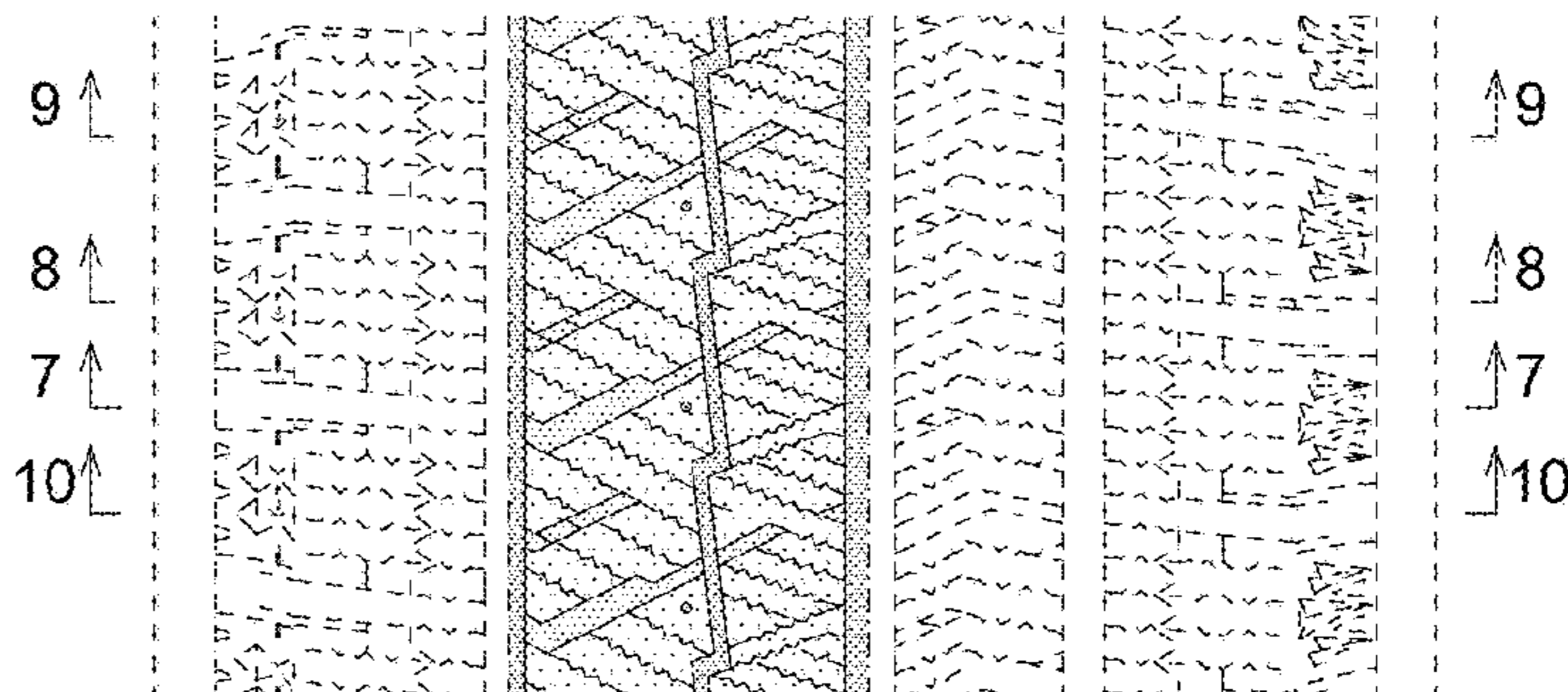
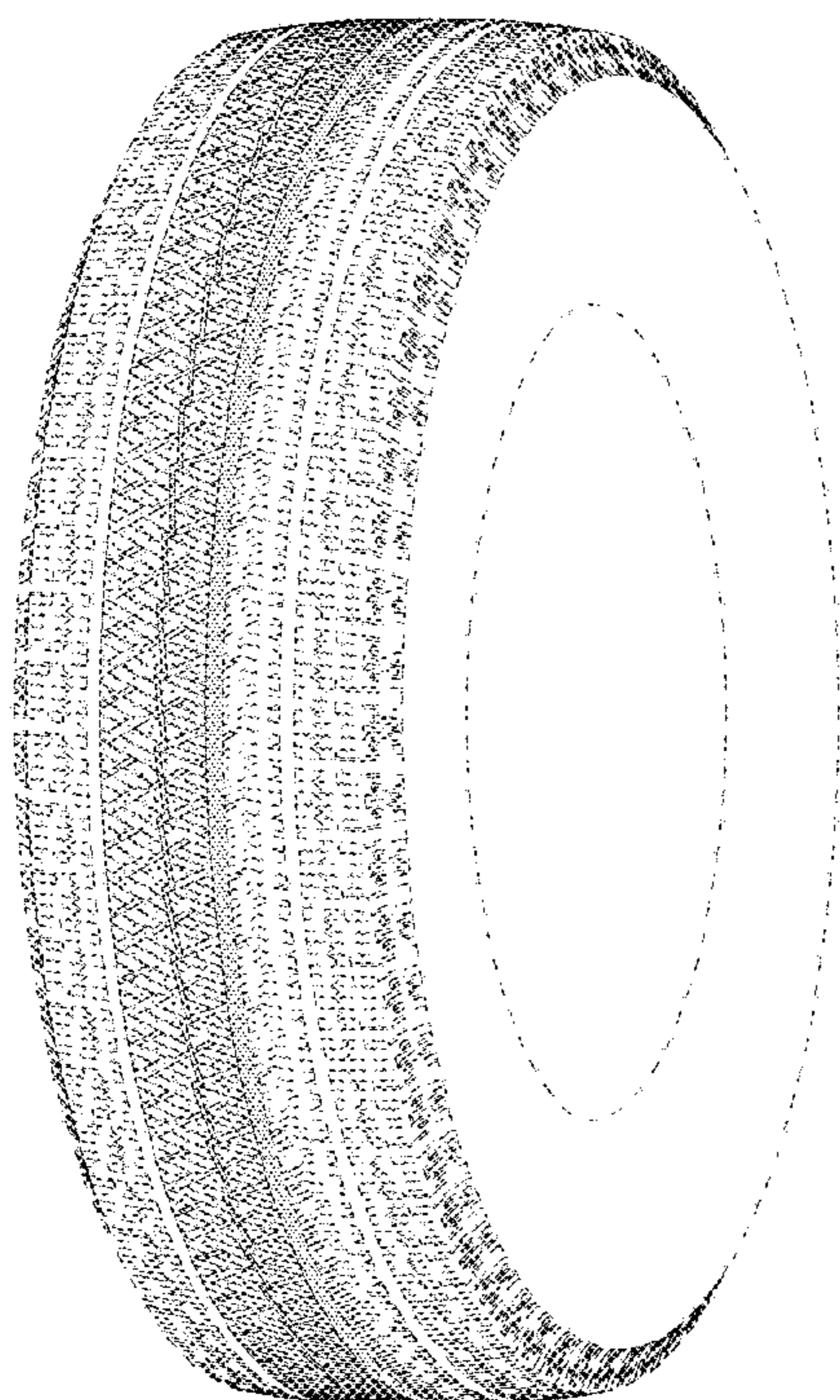
FIG. 8 is a section view taken along line 8-8 in FIG. 6;

FIG. 9 is a section view taken along line 9-9 in FIG. 6; and,

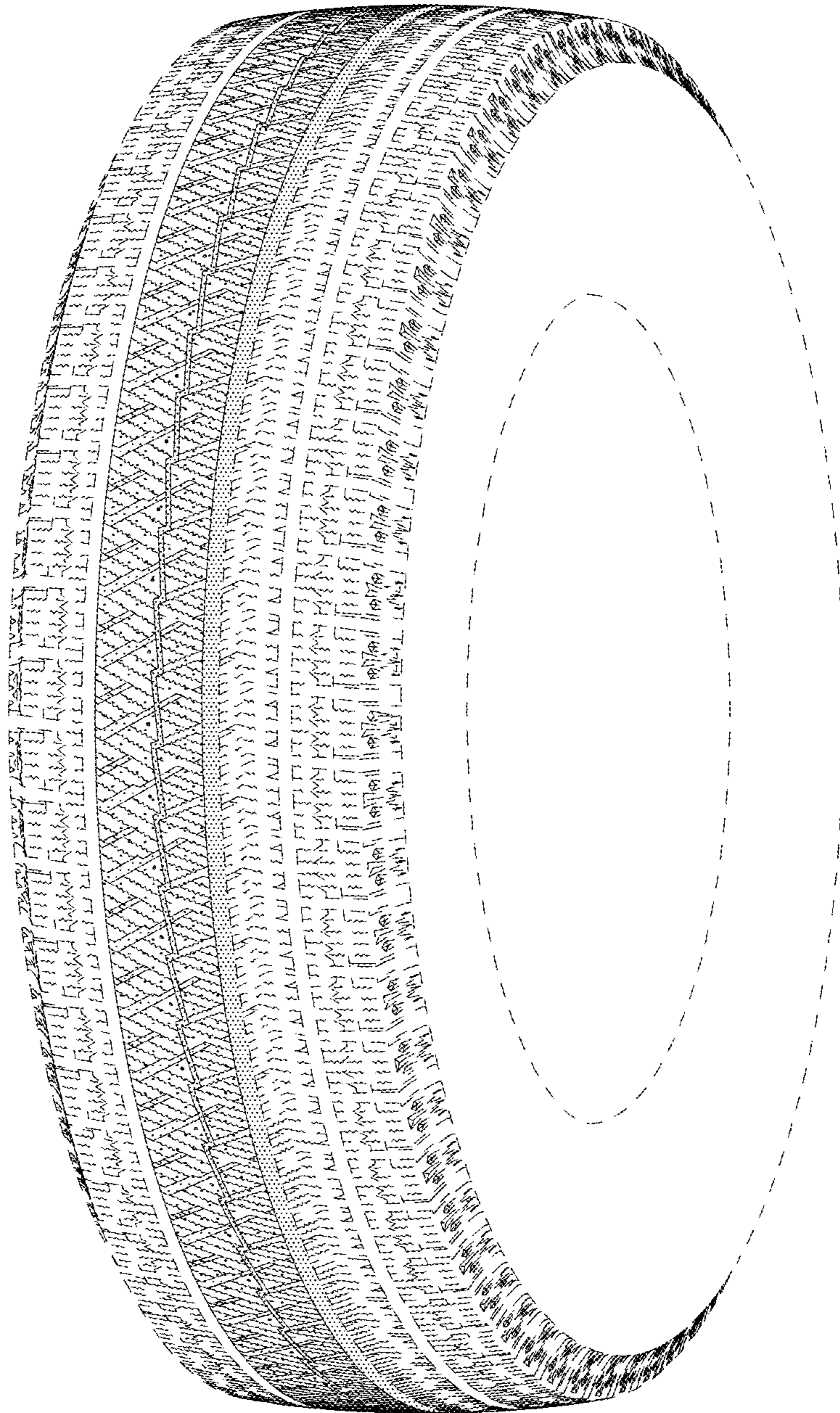
FIG. 10 is a section view taken along line 10-10 in FIG. 6.

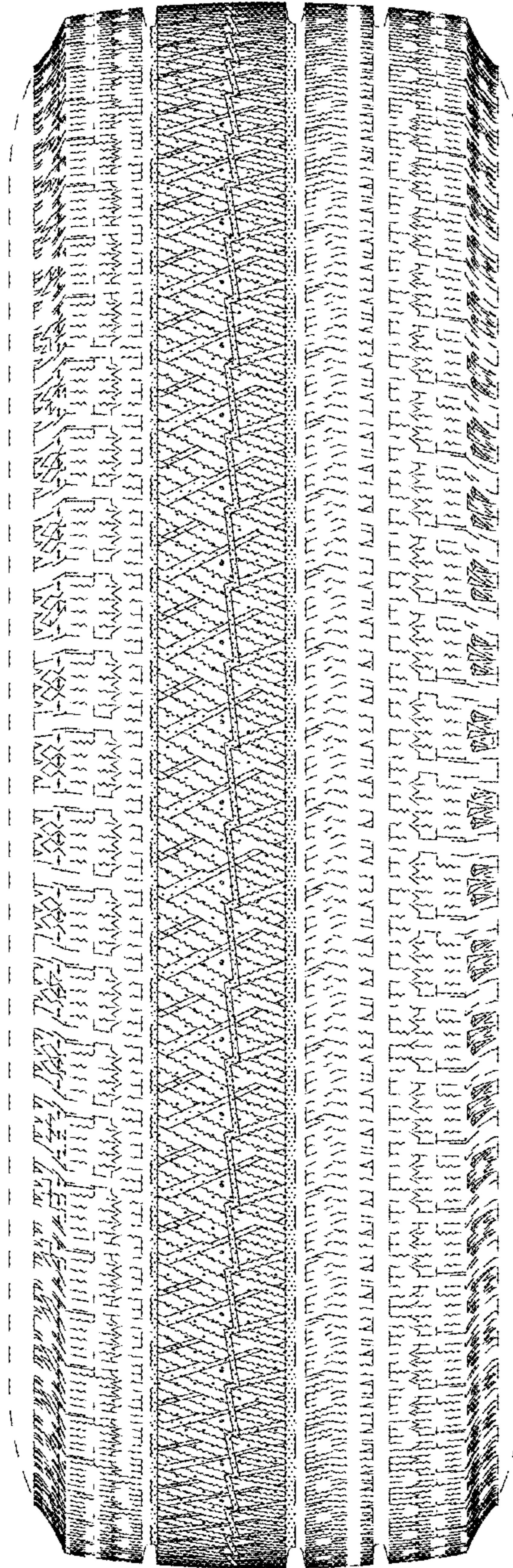

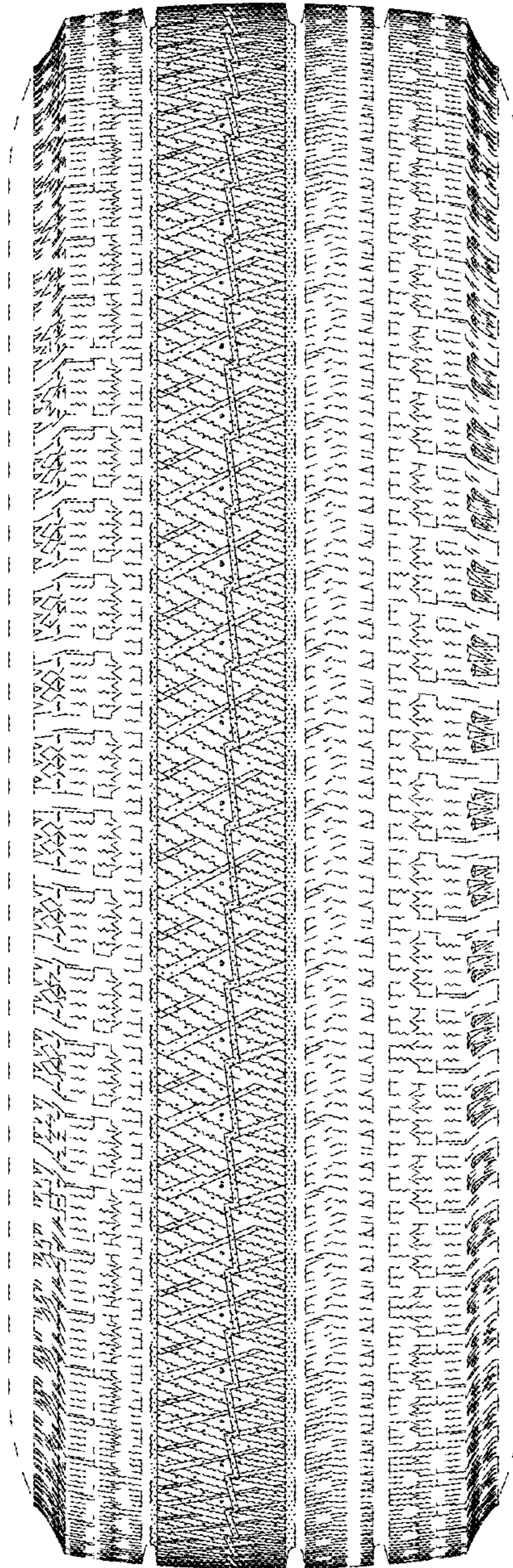

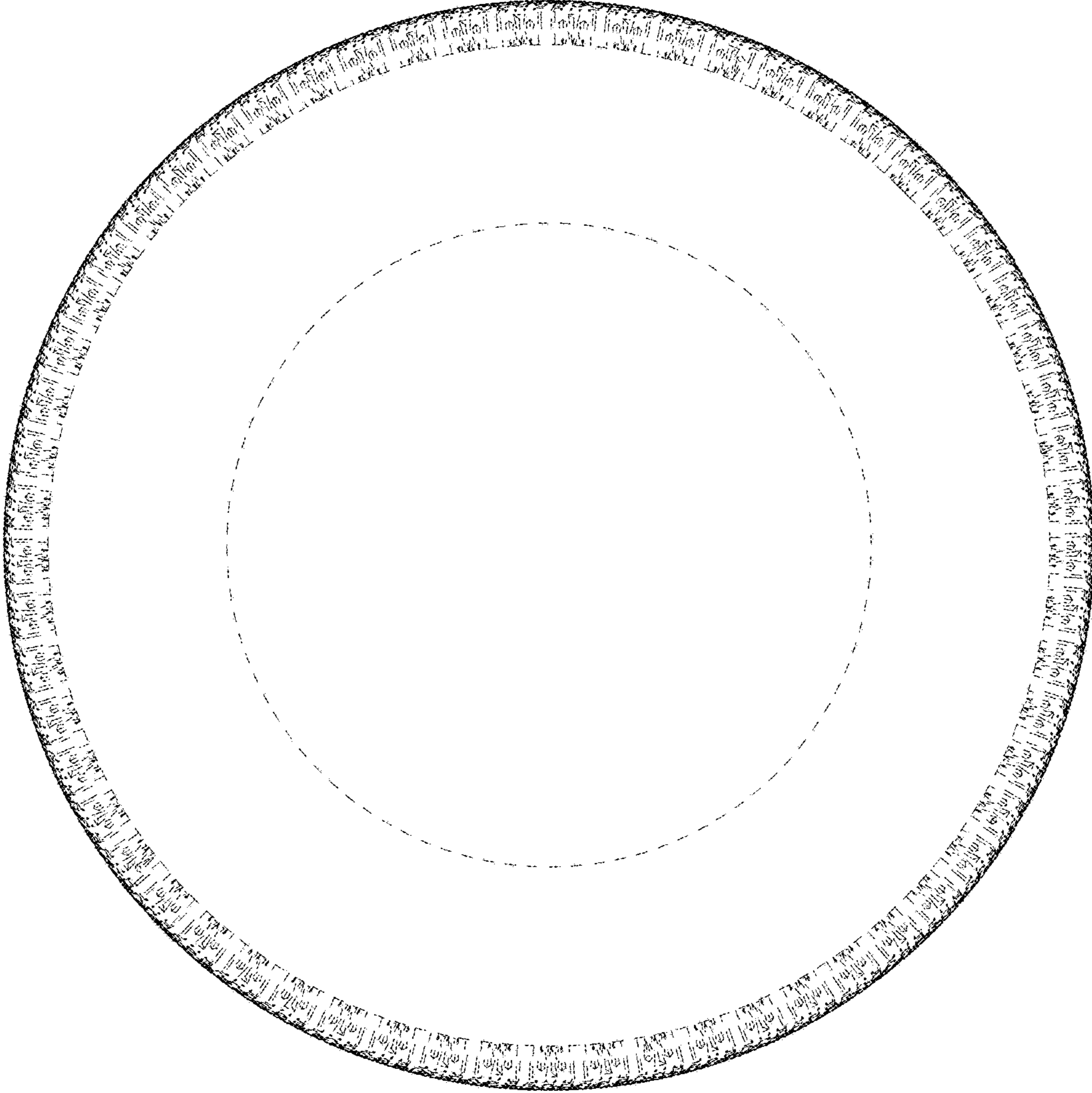

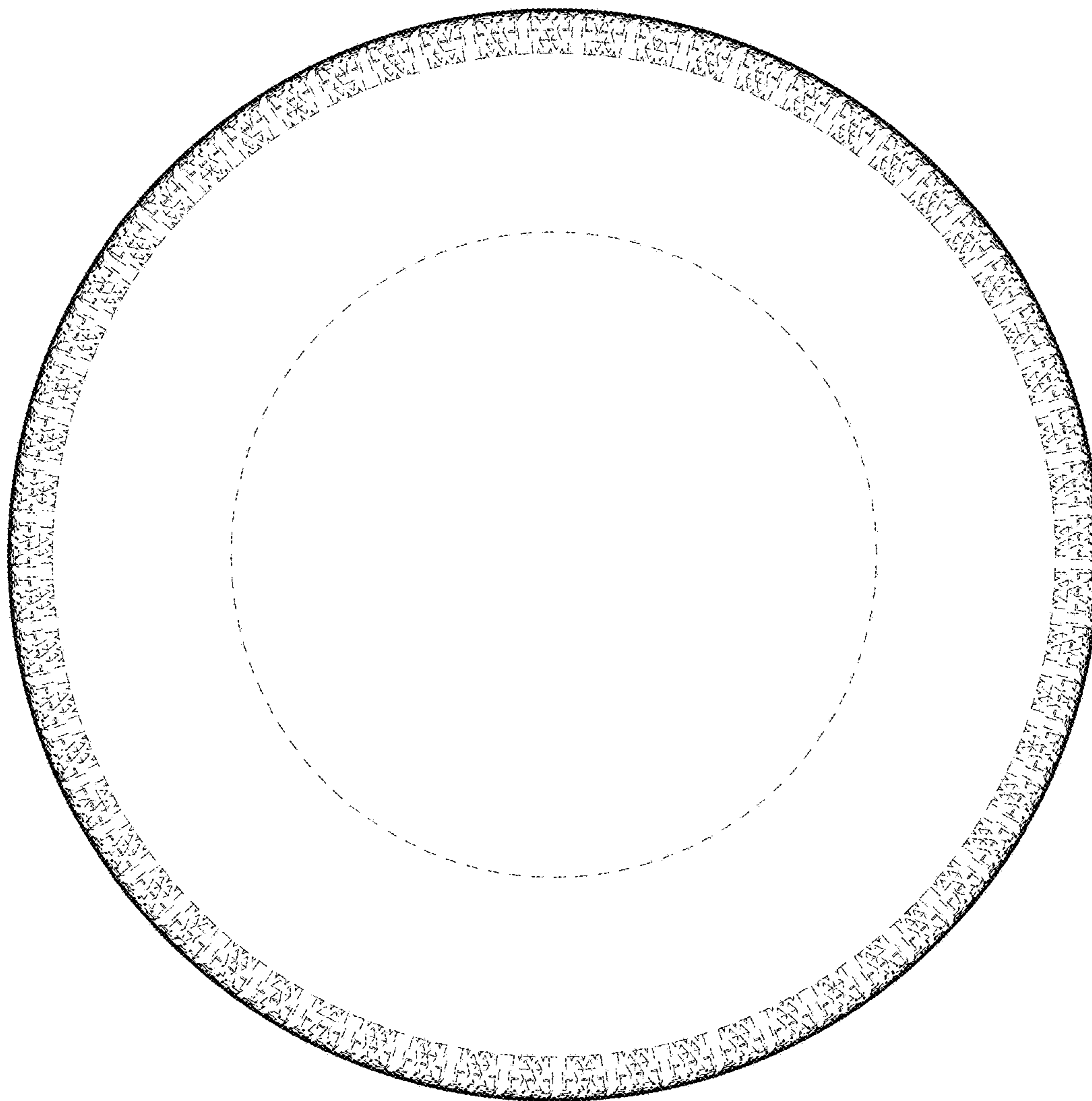
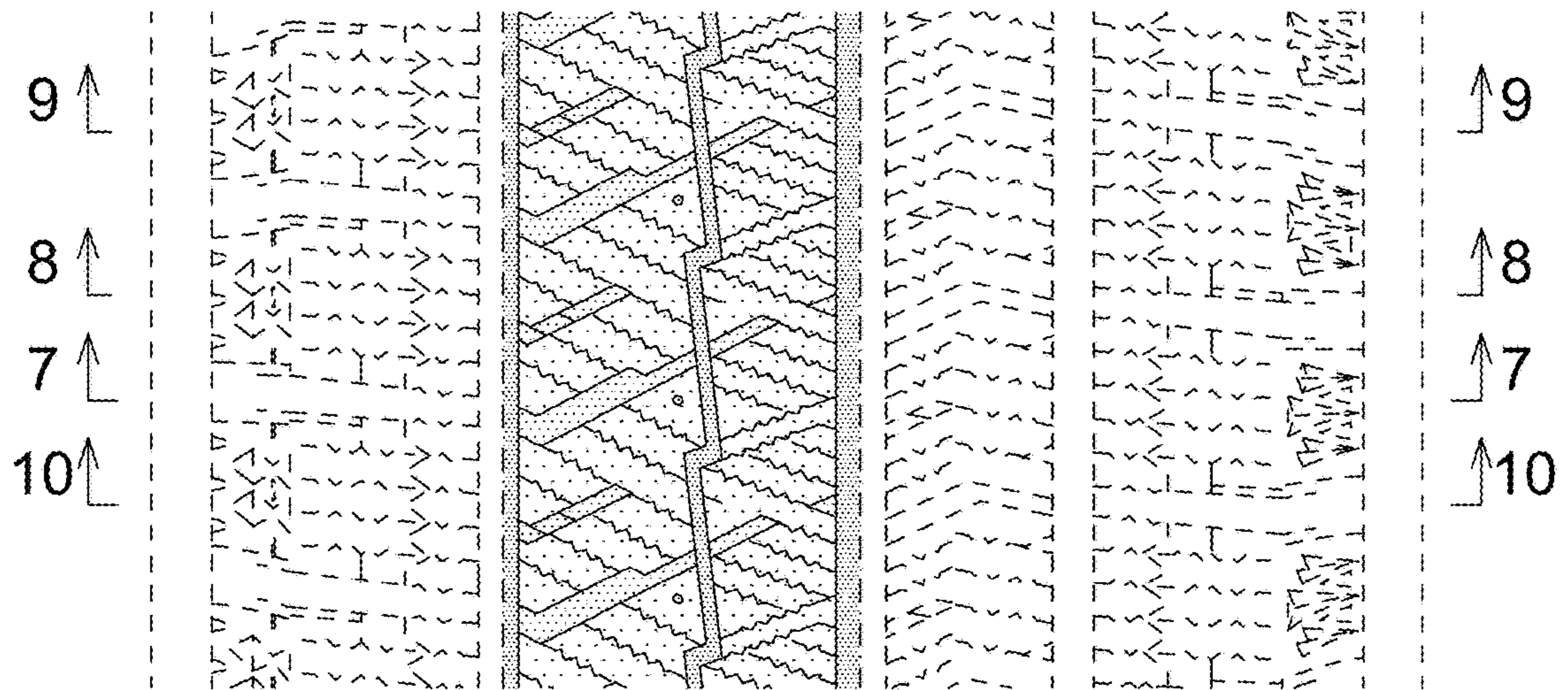
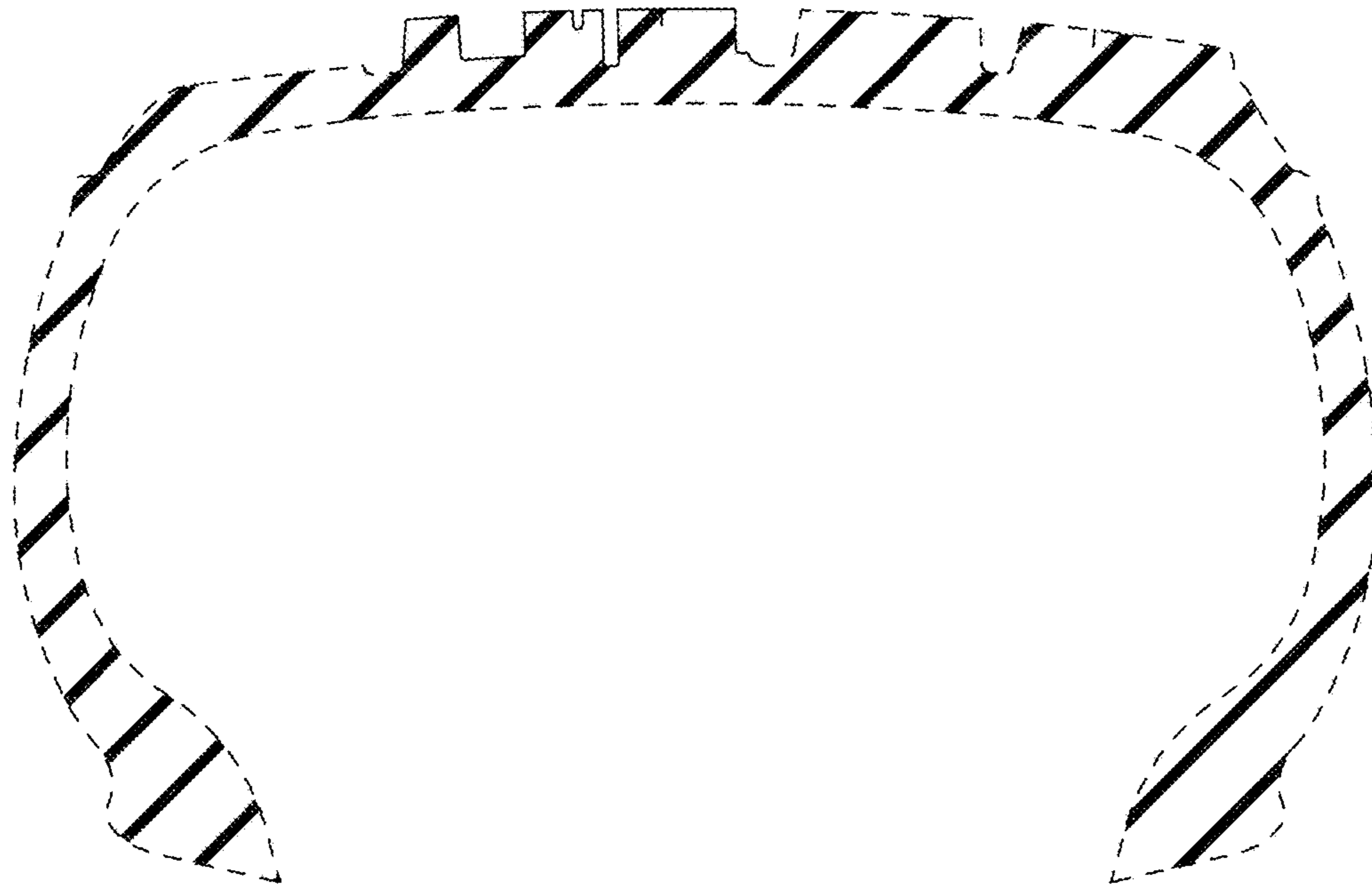

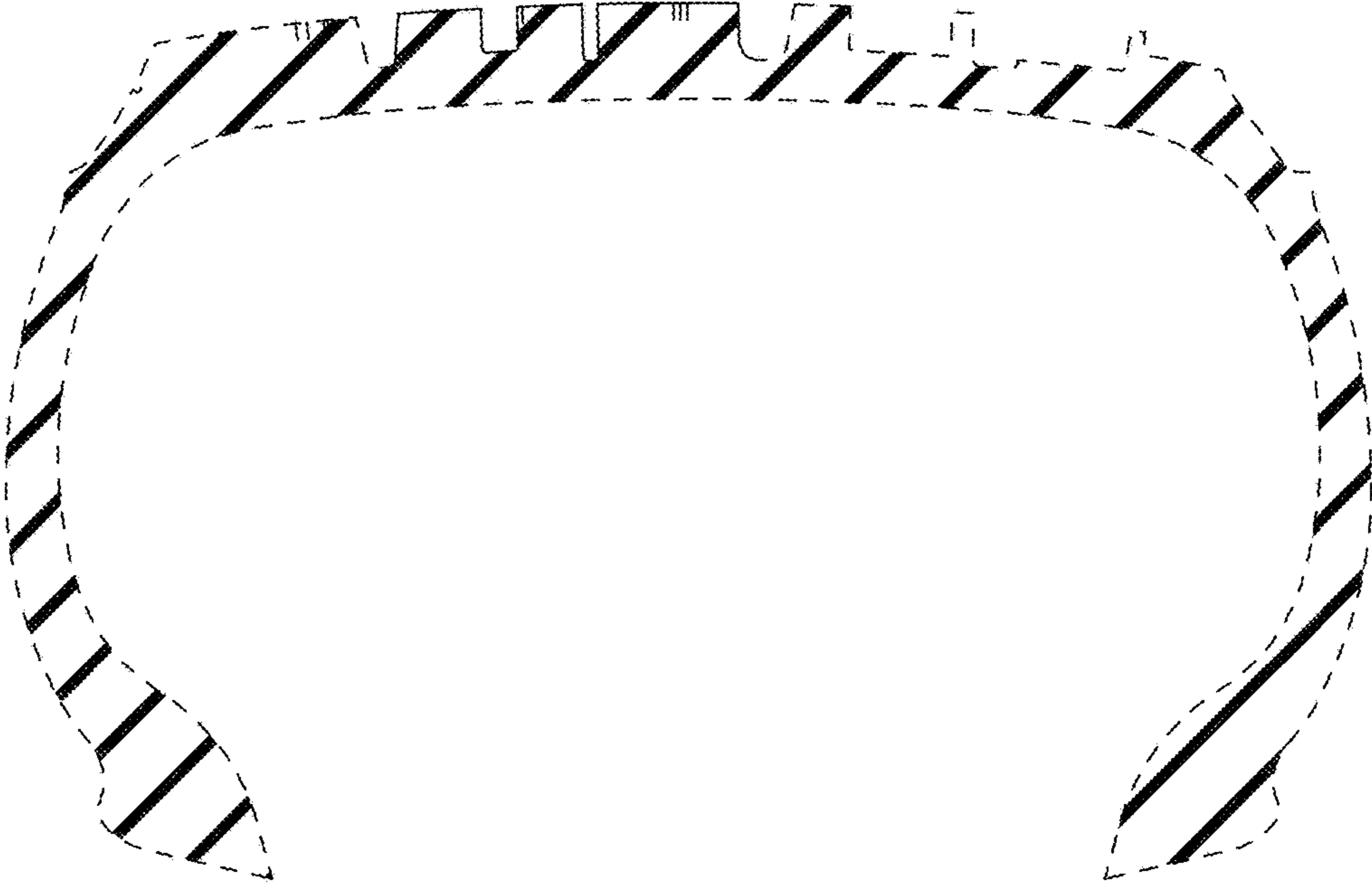

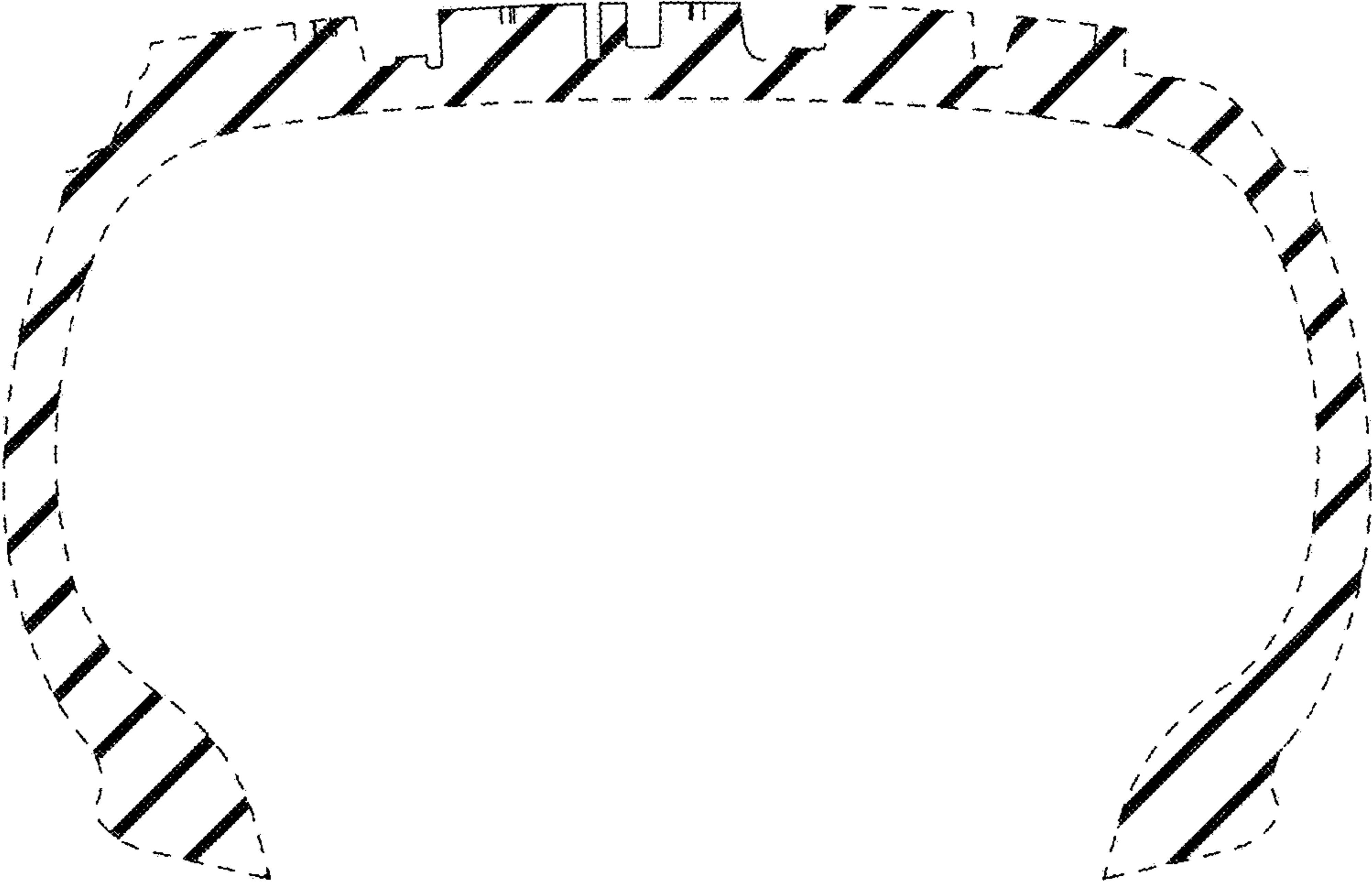
