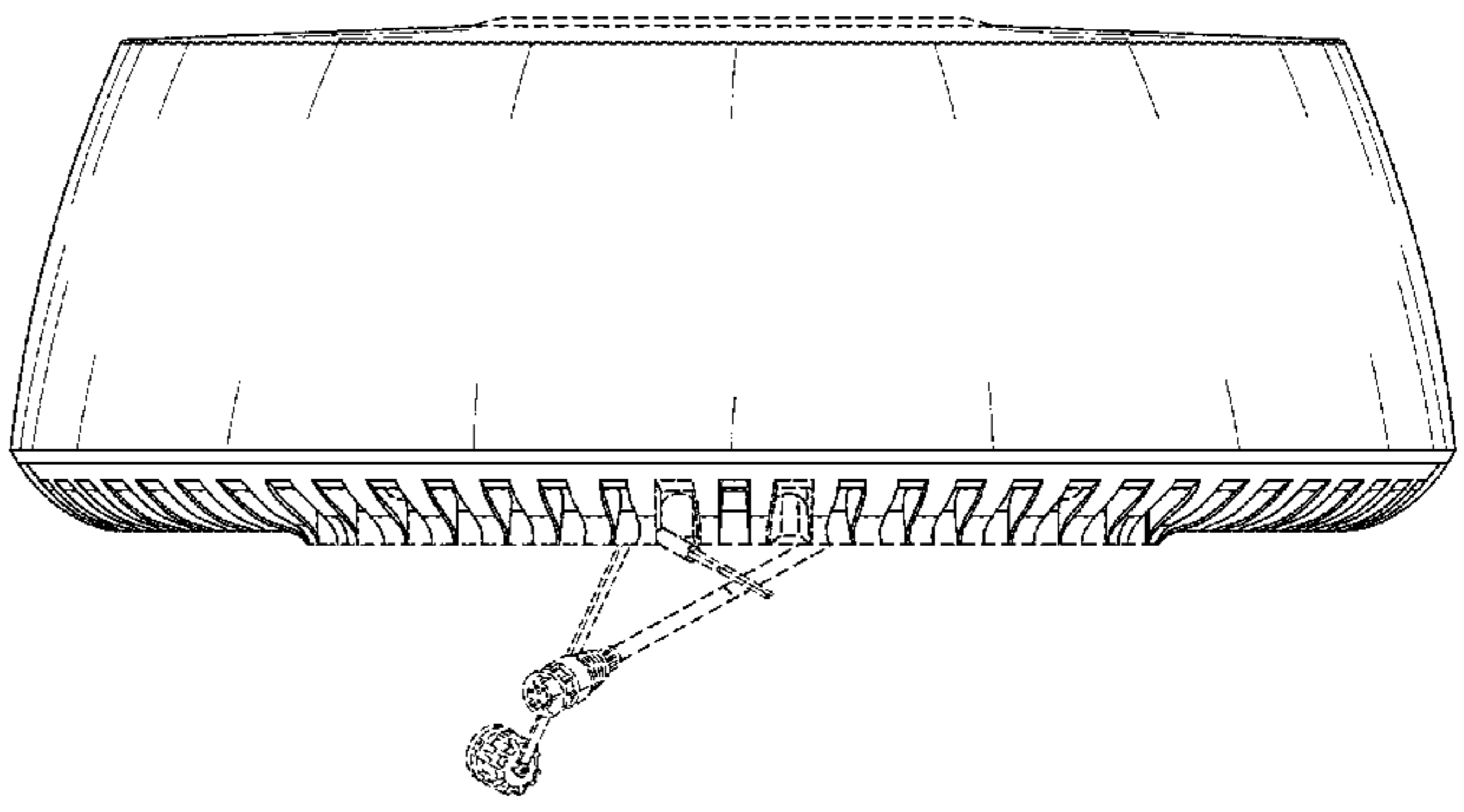
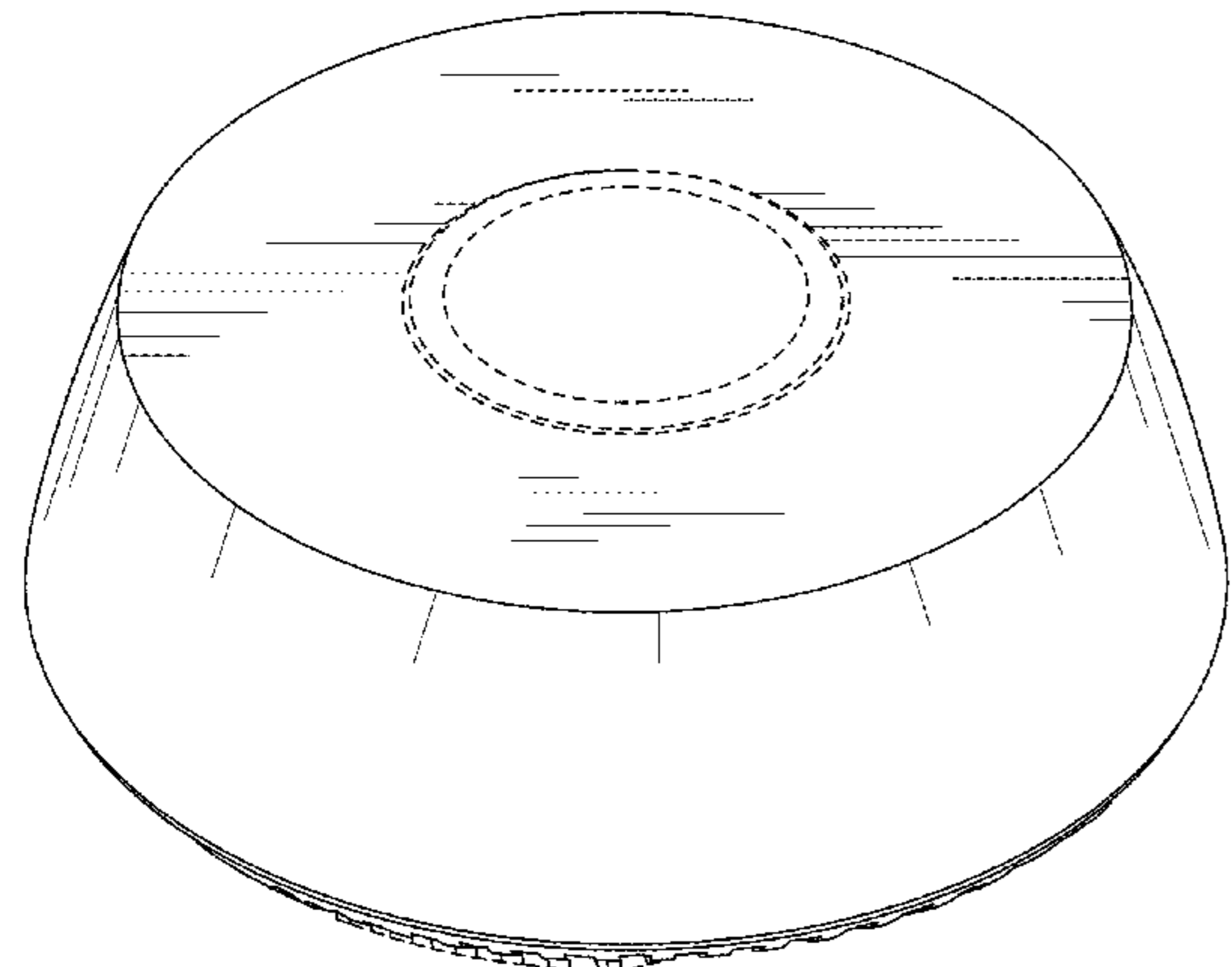
(57) **CLAIM**

The ornamental design for a marine radar housing, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-right perspective view of a marine radar housing embodying the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a left side elevational view thereof. The broken lines depict portions of a marine radar housing in which the design is embodied that form no part of the claimed design.

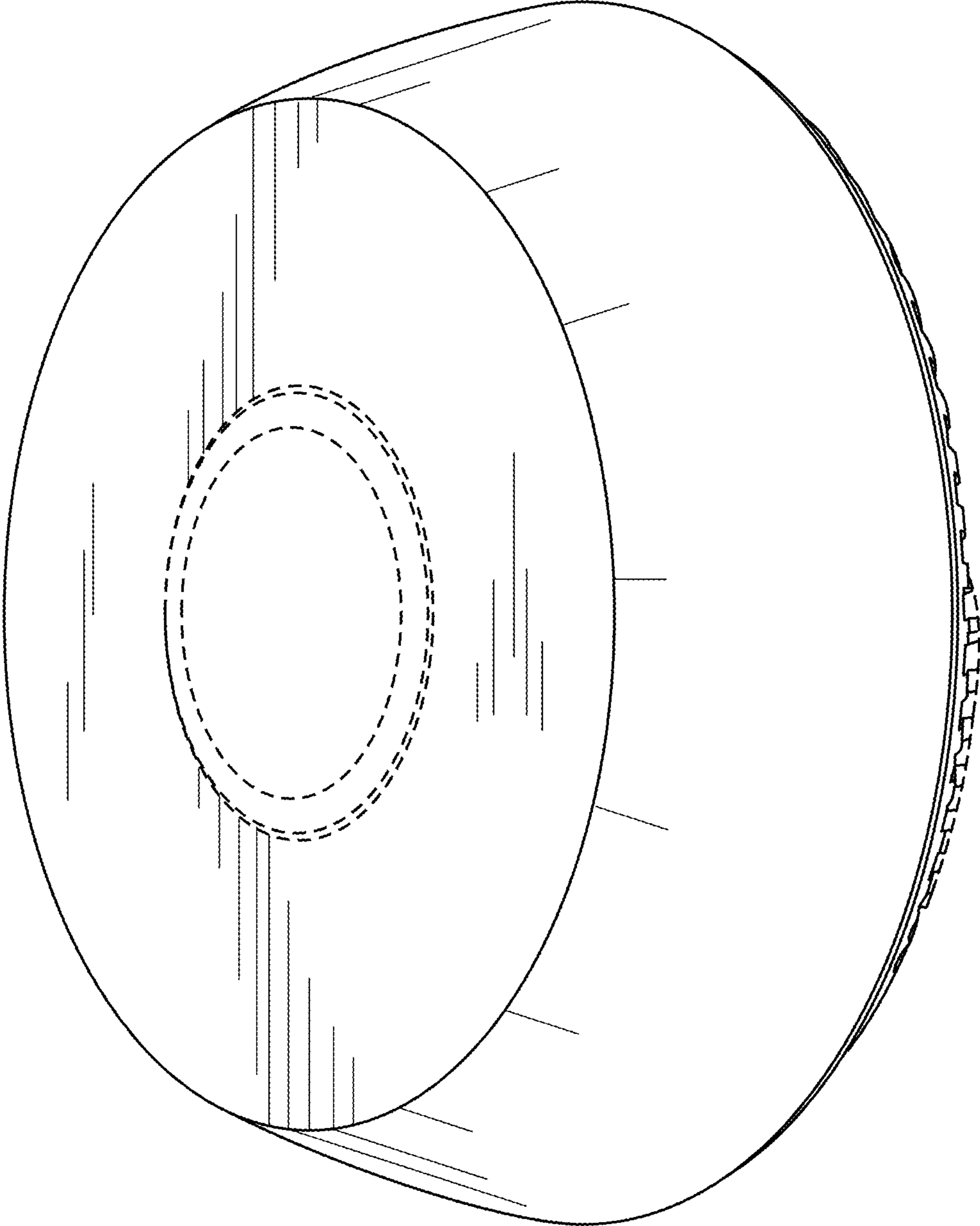

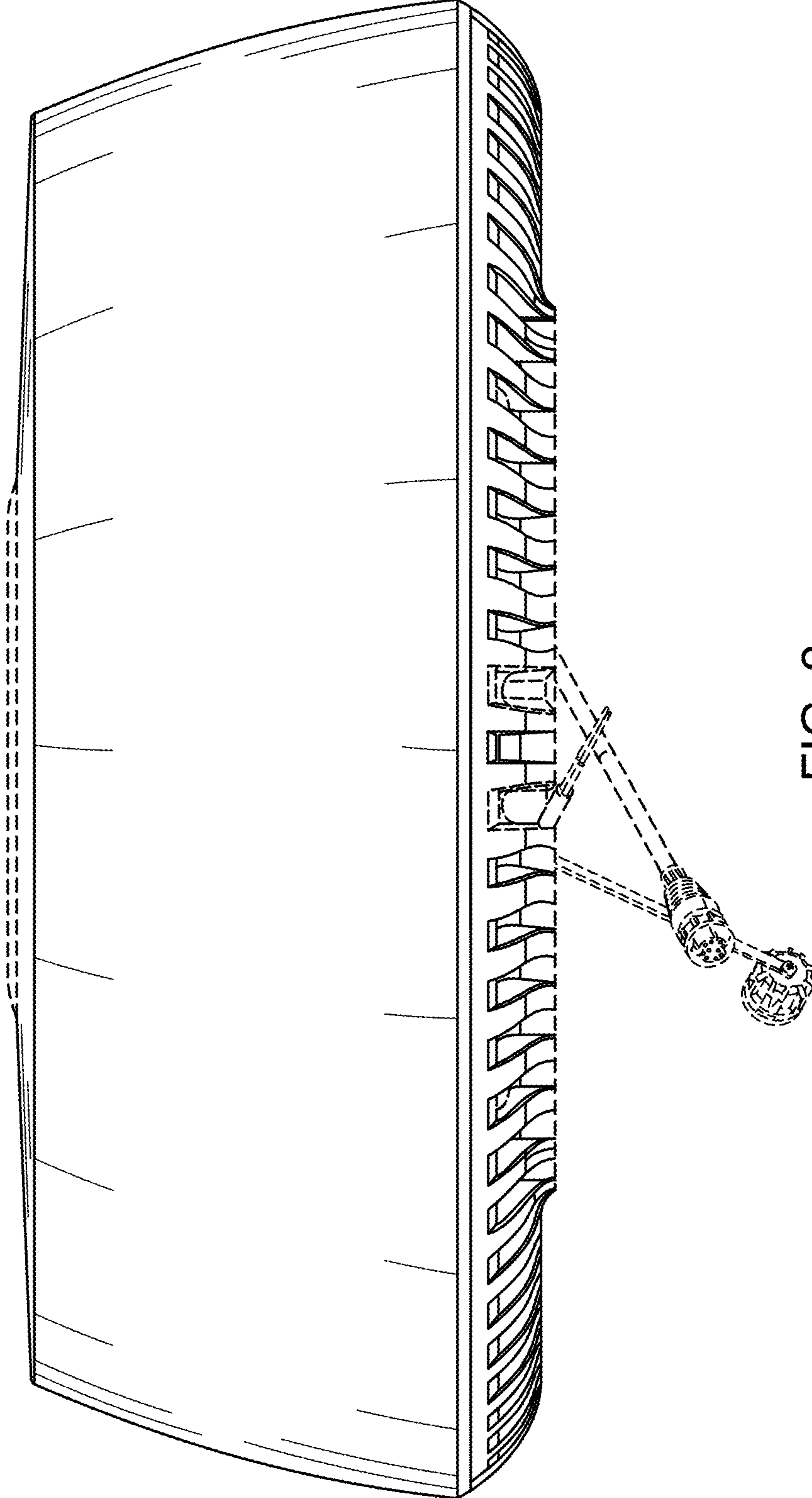

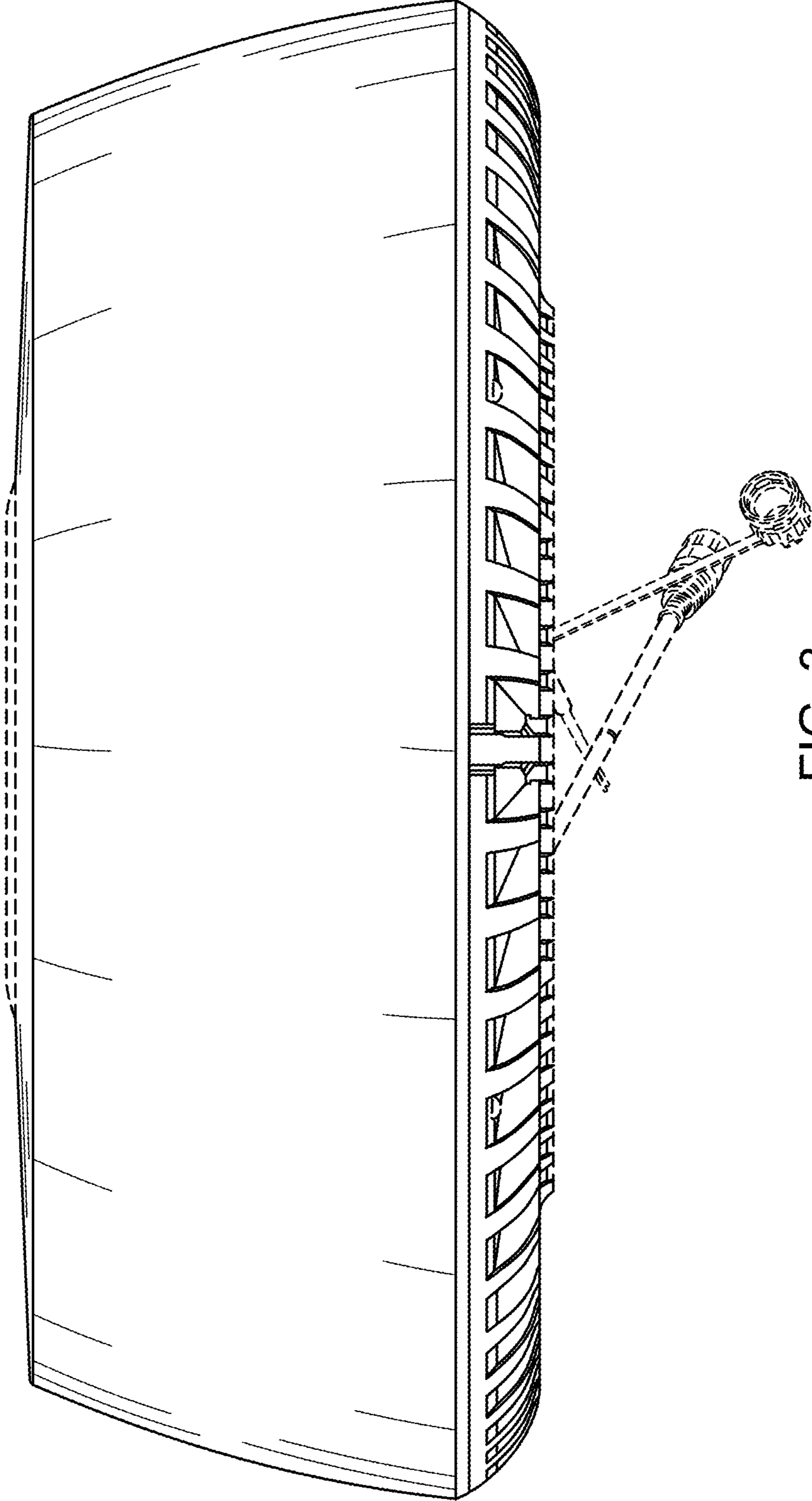

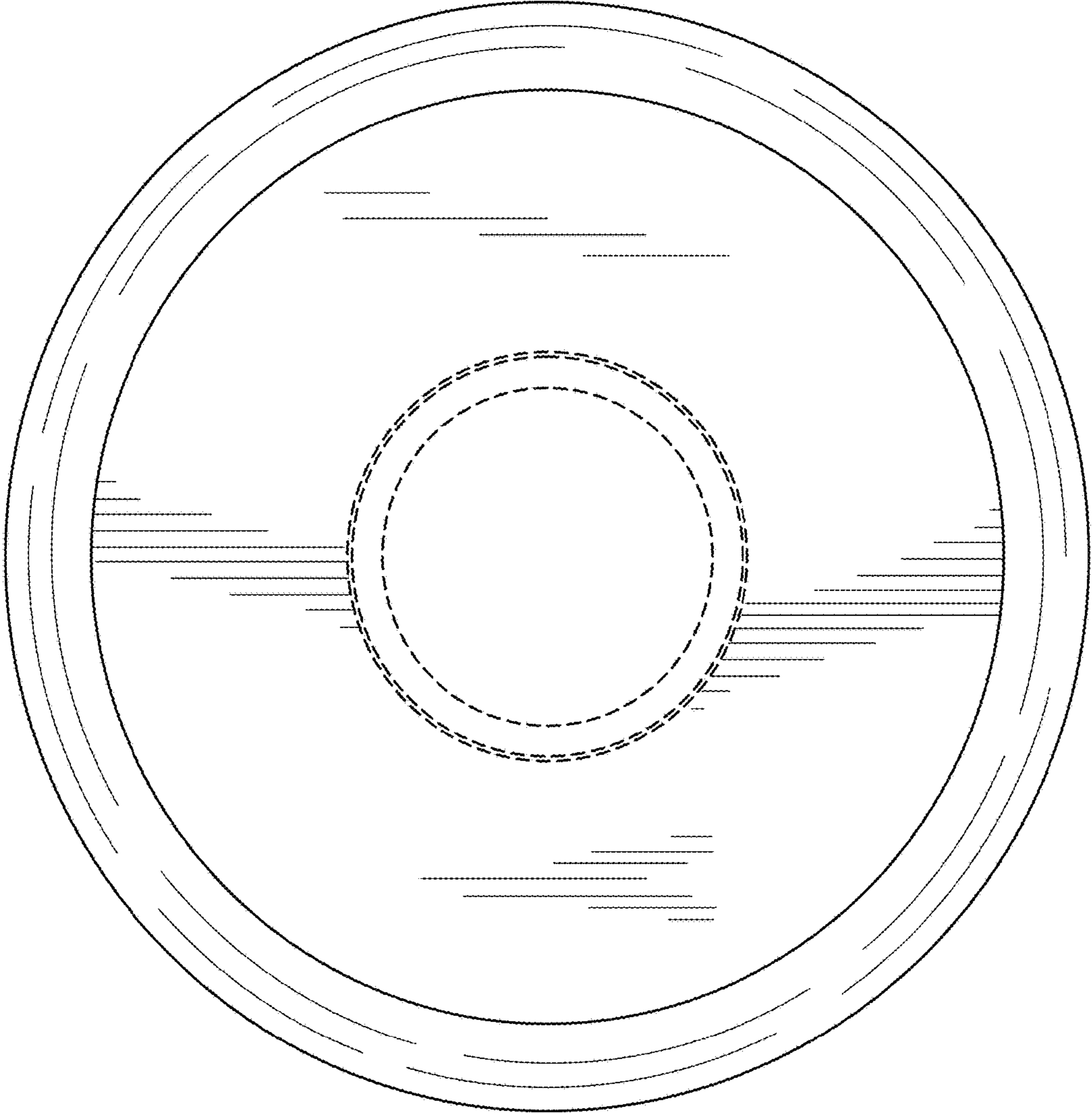

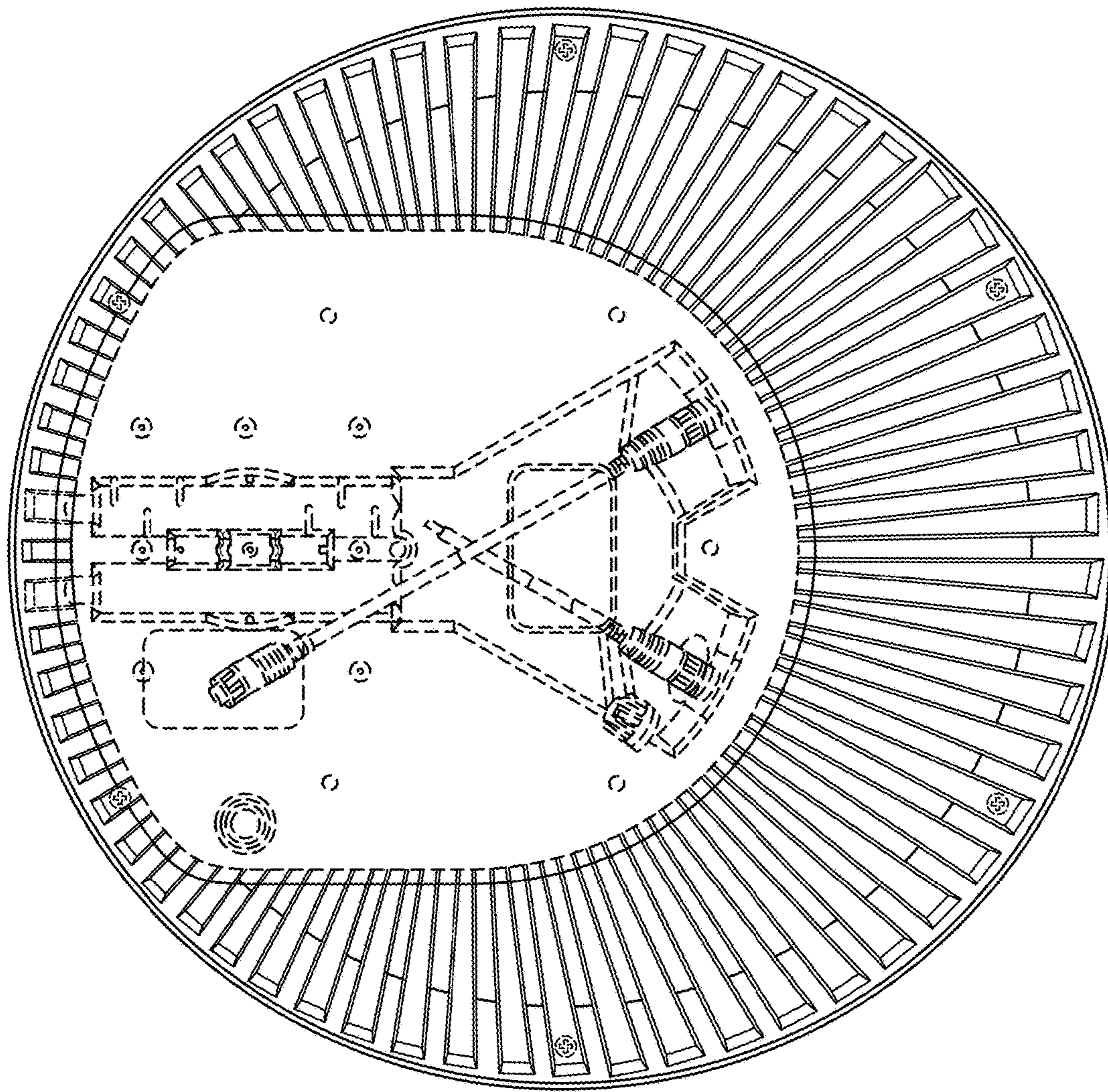

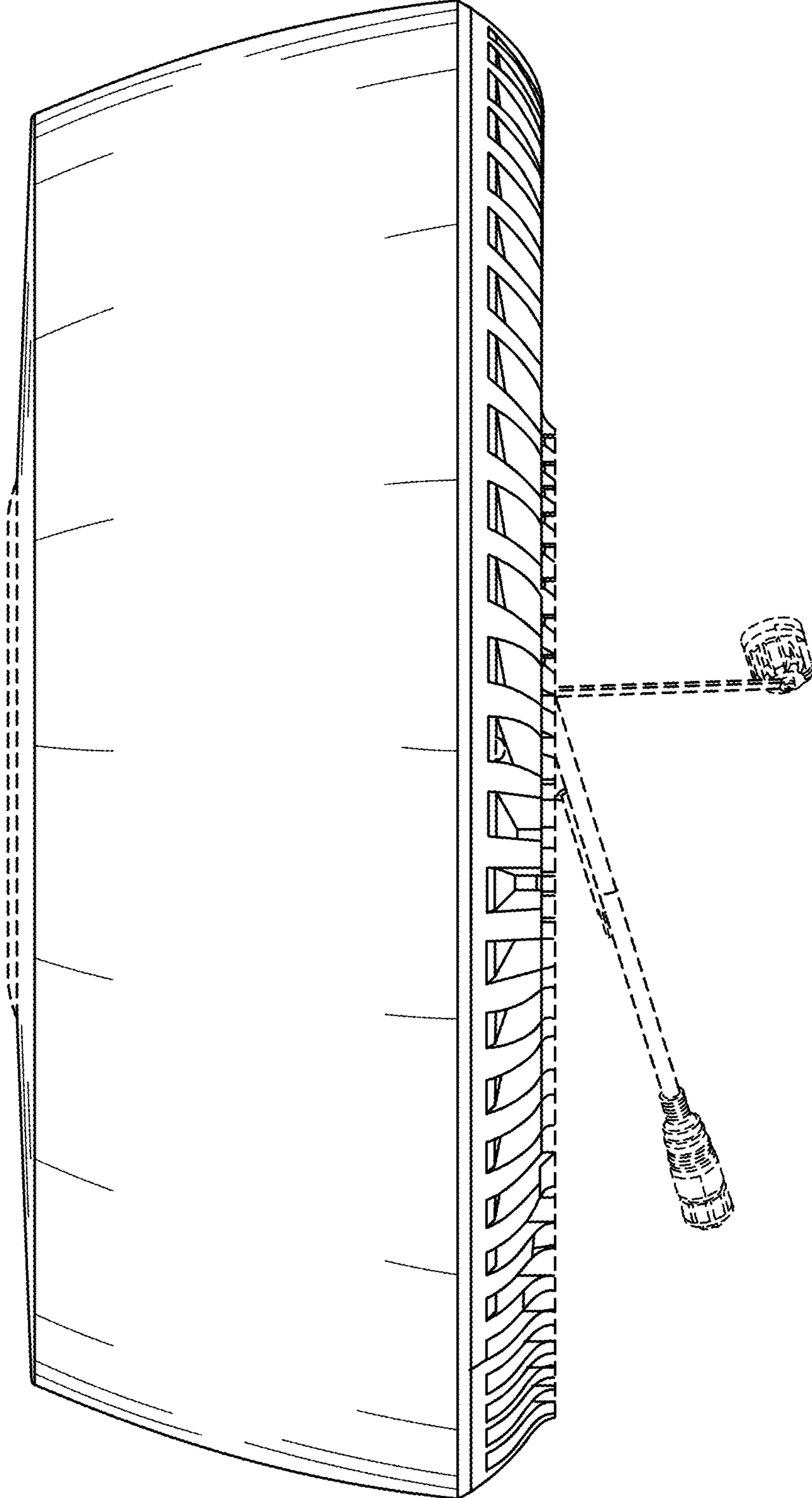

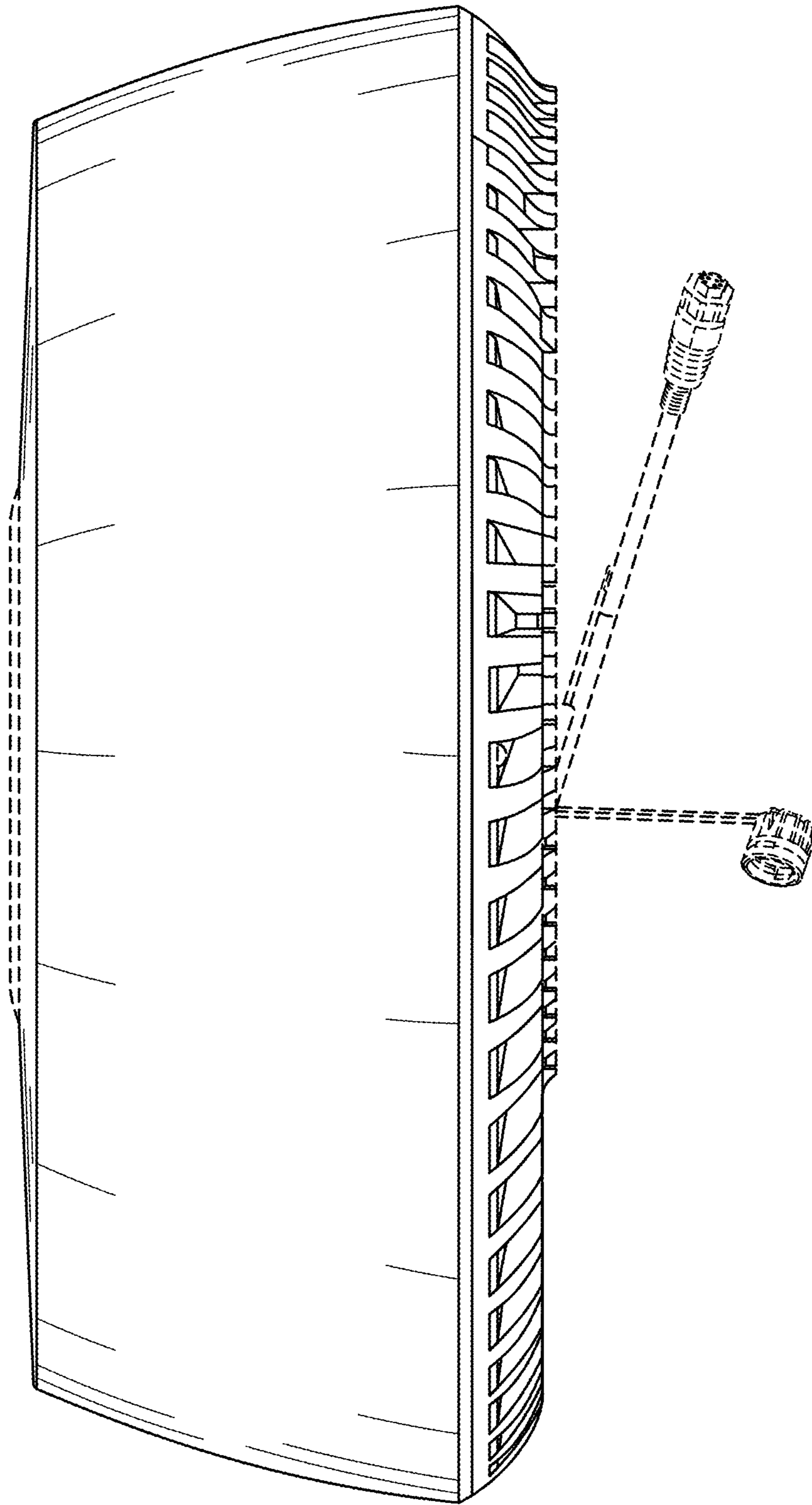
