(57) **CLAIM**

The ornamental design for a display screen with a payment graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a display screen with a payment graphical user interface showing a first embodiment of the new design;

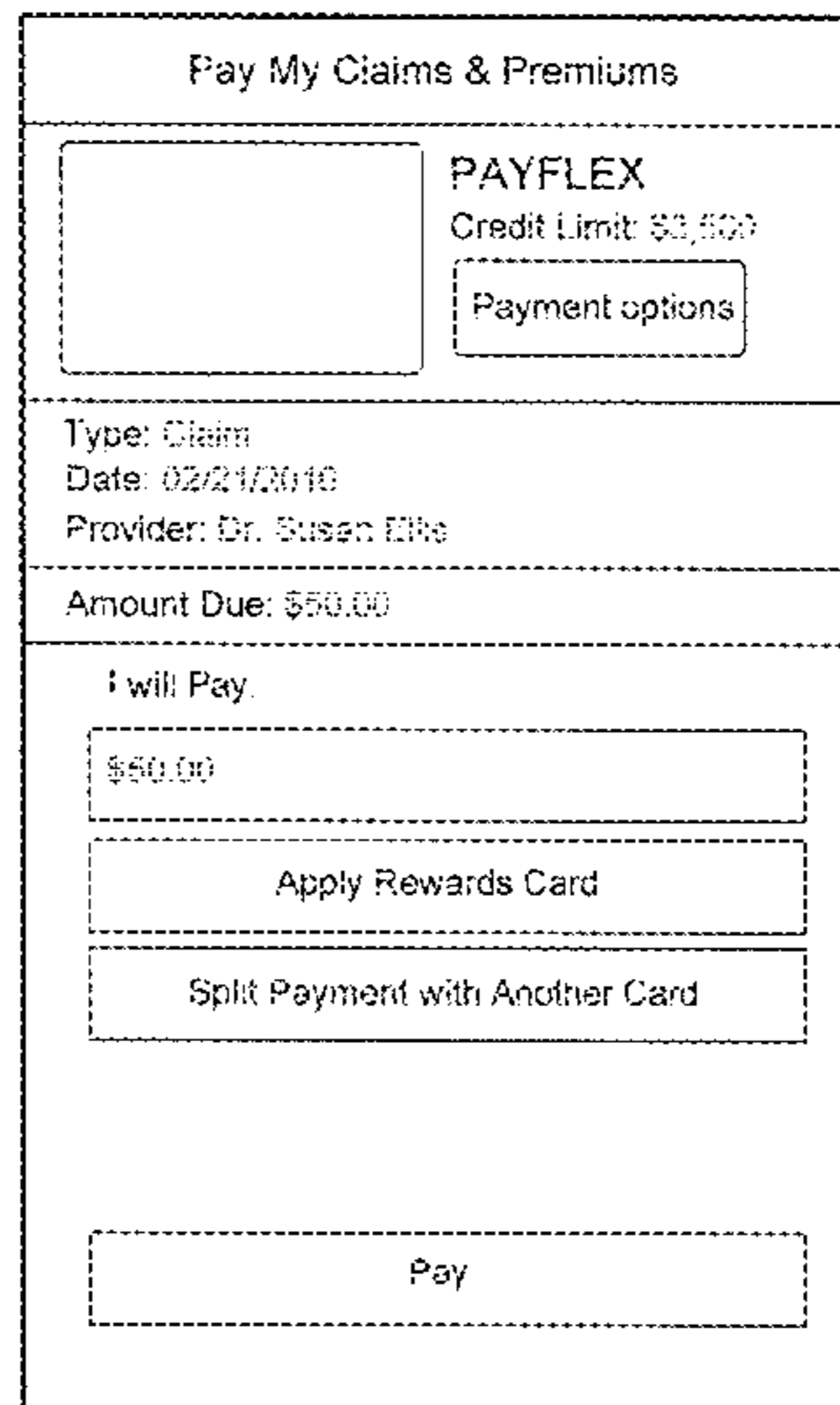
FIG. 2 is a front elevation view of a display screen with a payment graphical user interface showing a second embodiment of the new design; and,




