(57) **CLAIM**

I claim the ornamental design for a tabbed index card, as  
shown and described.

**DESCRIPTION**

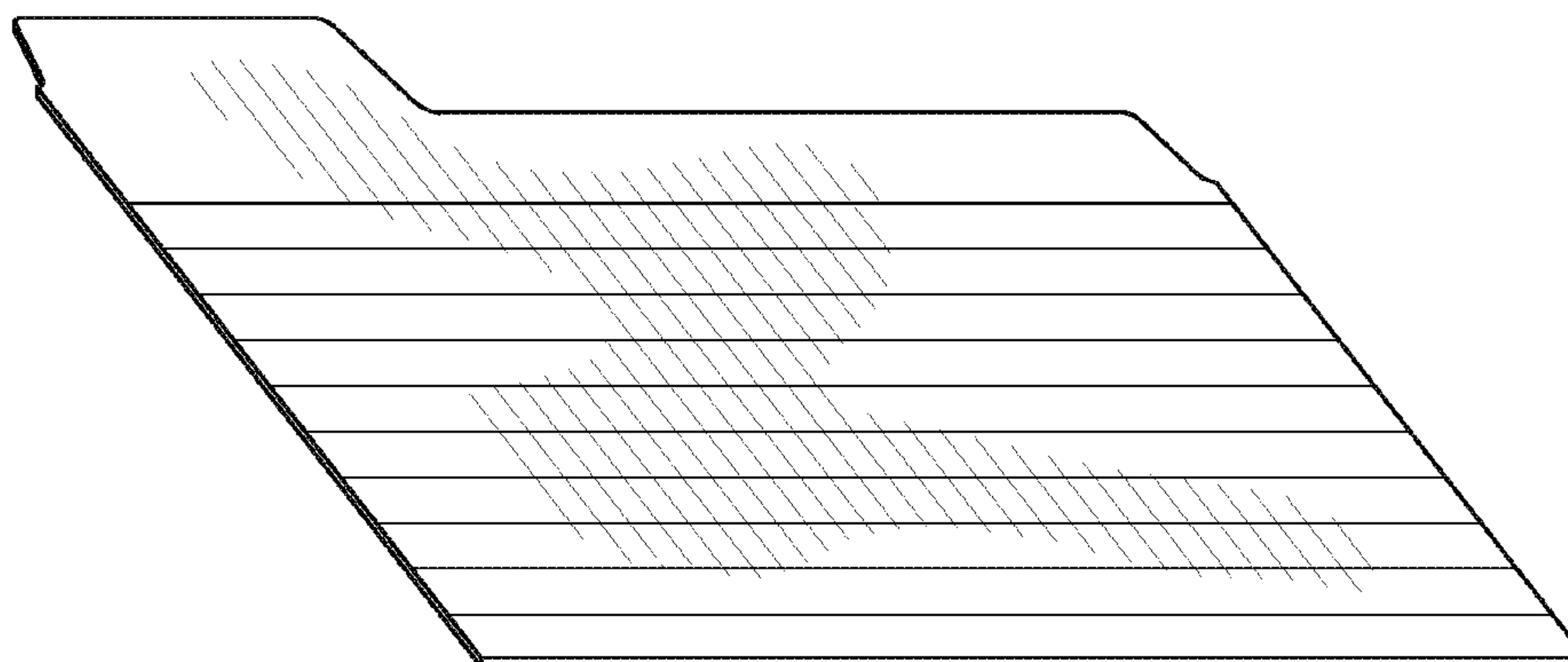


FIG. 21 is a right side elevational view thereof;

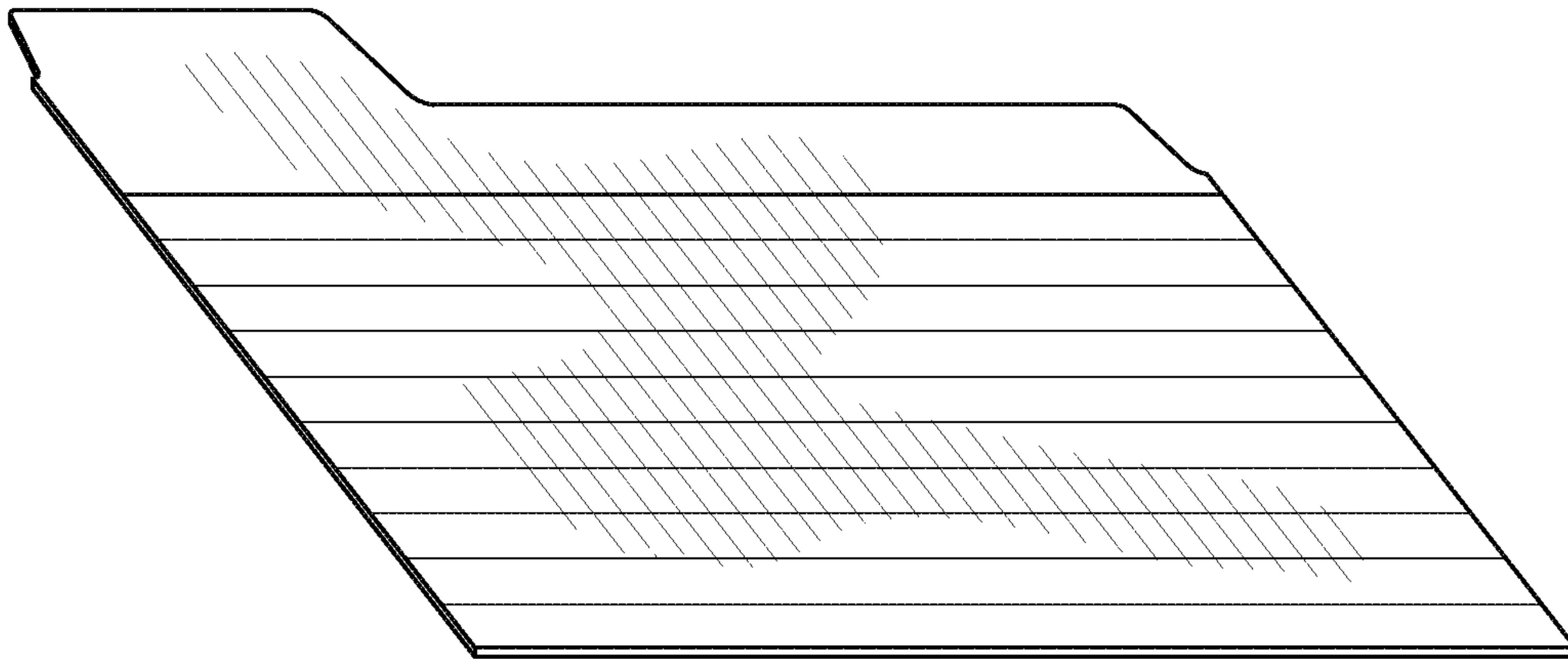

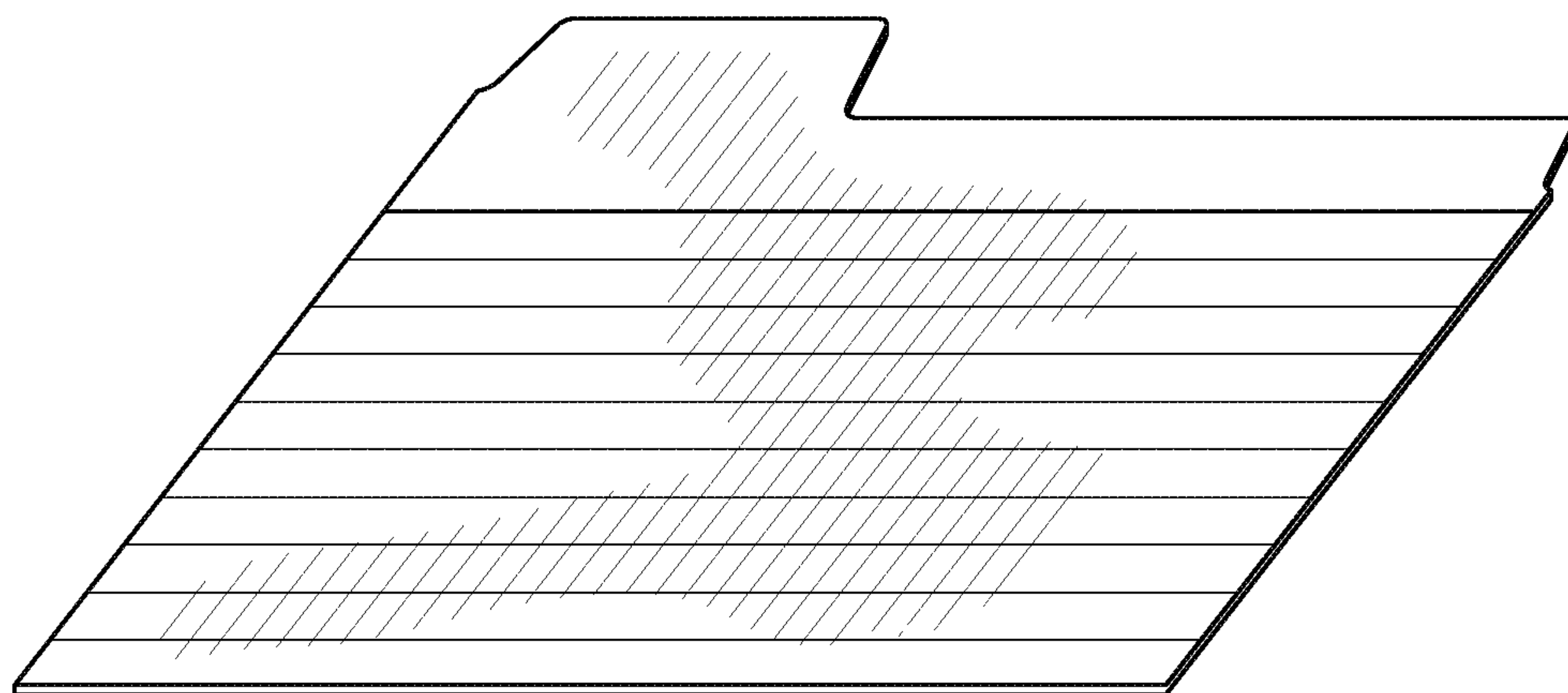

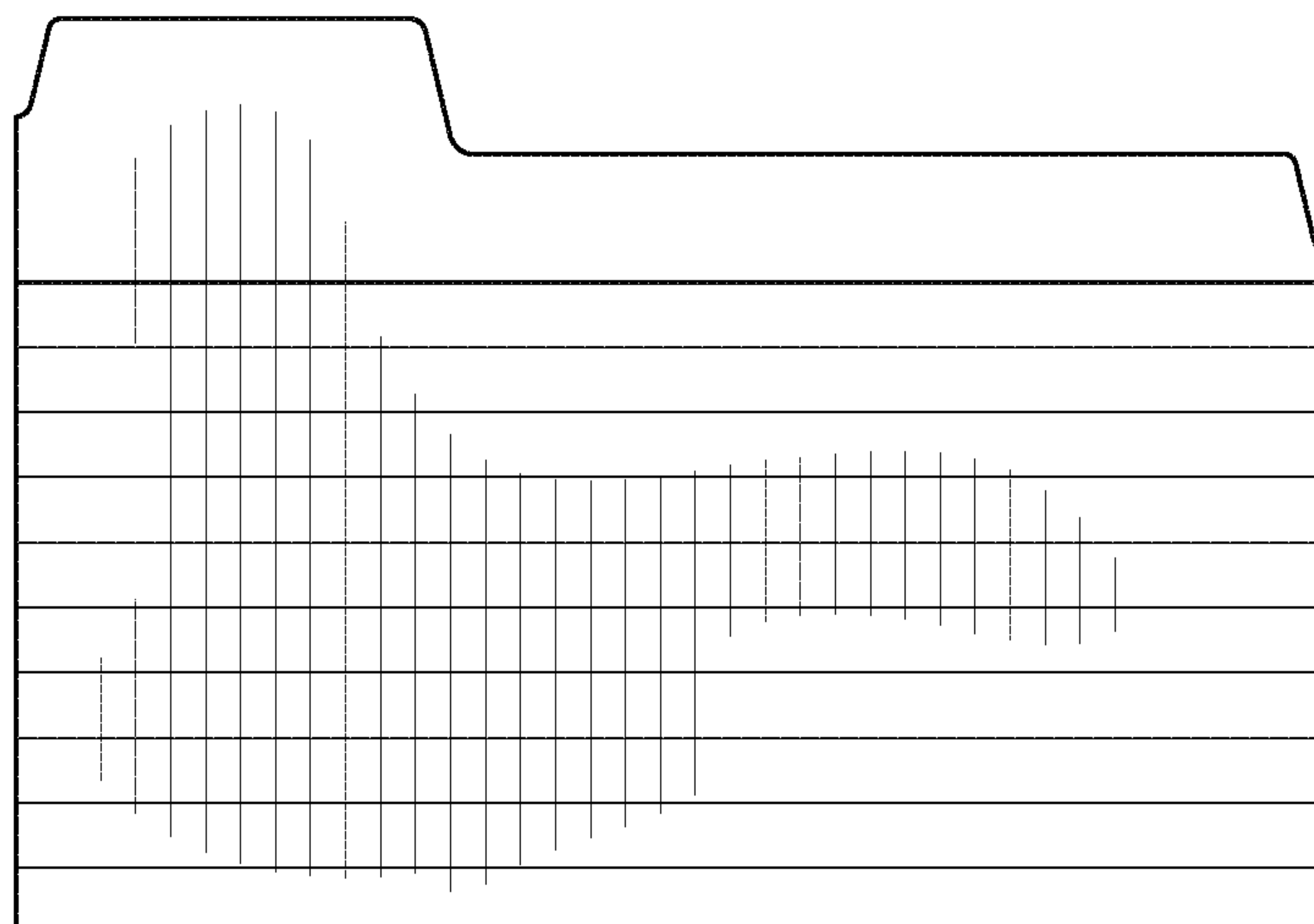

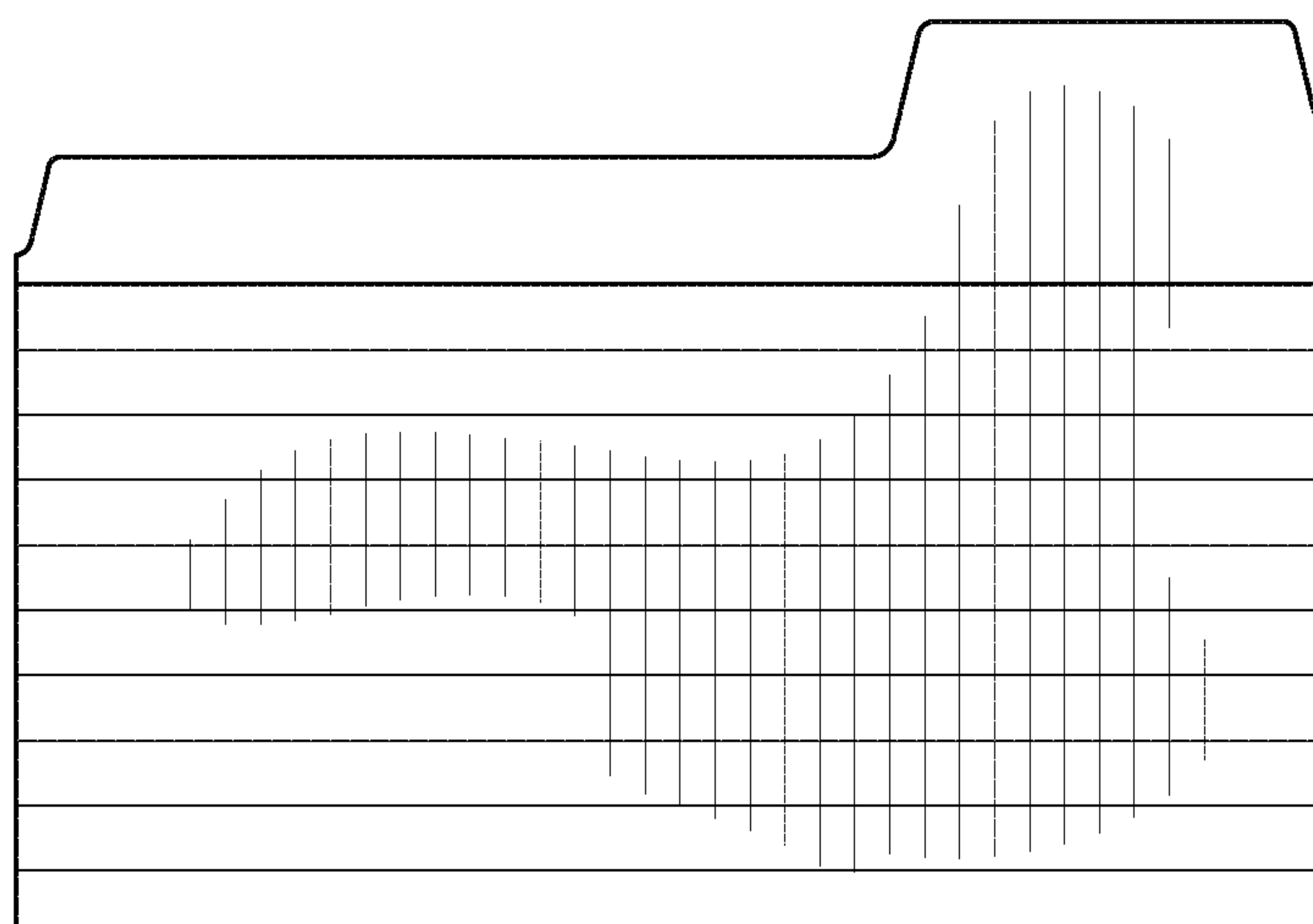

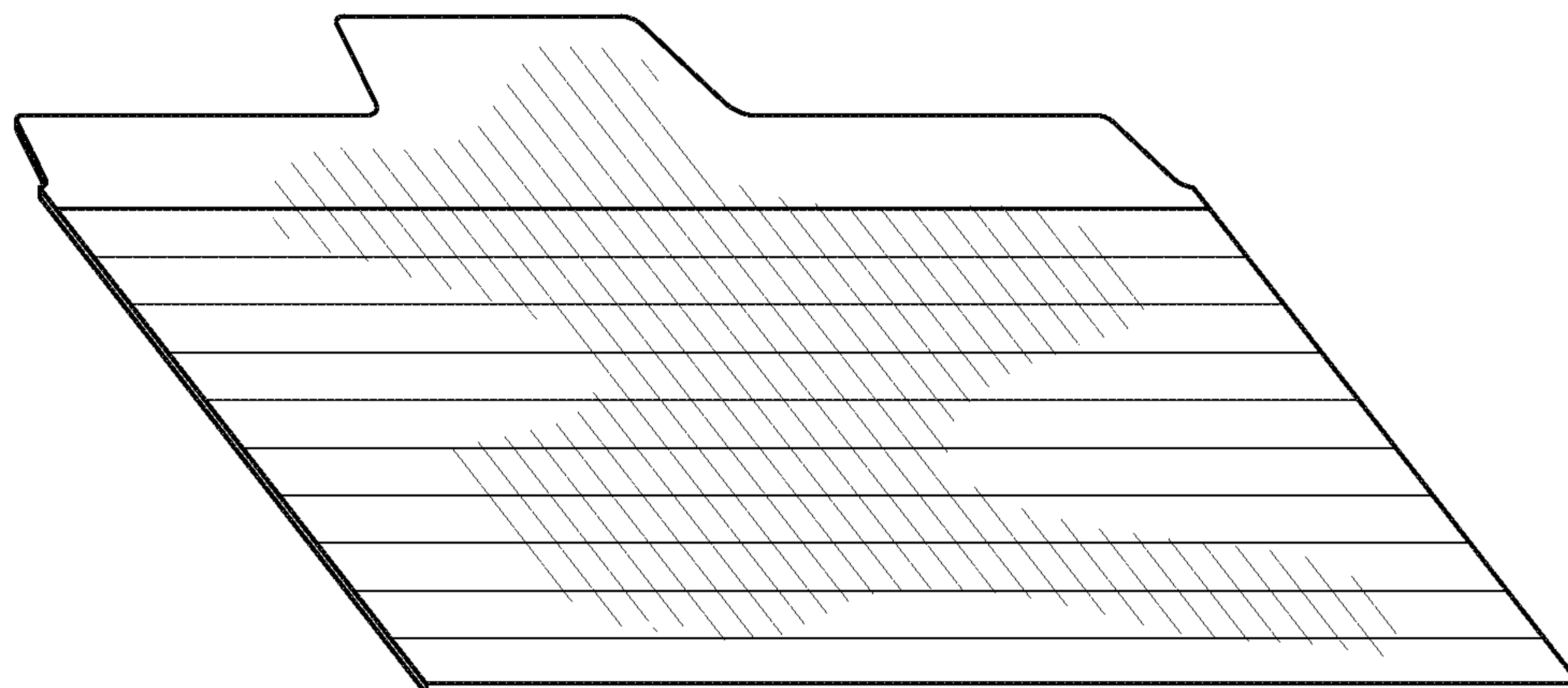

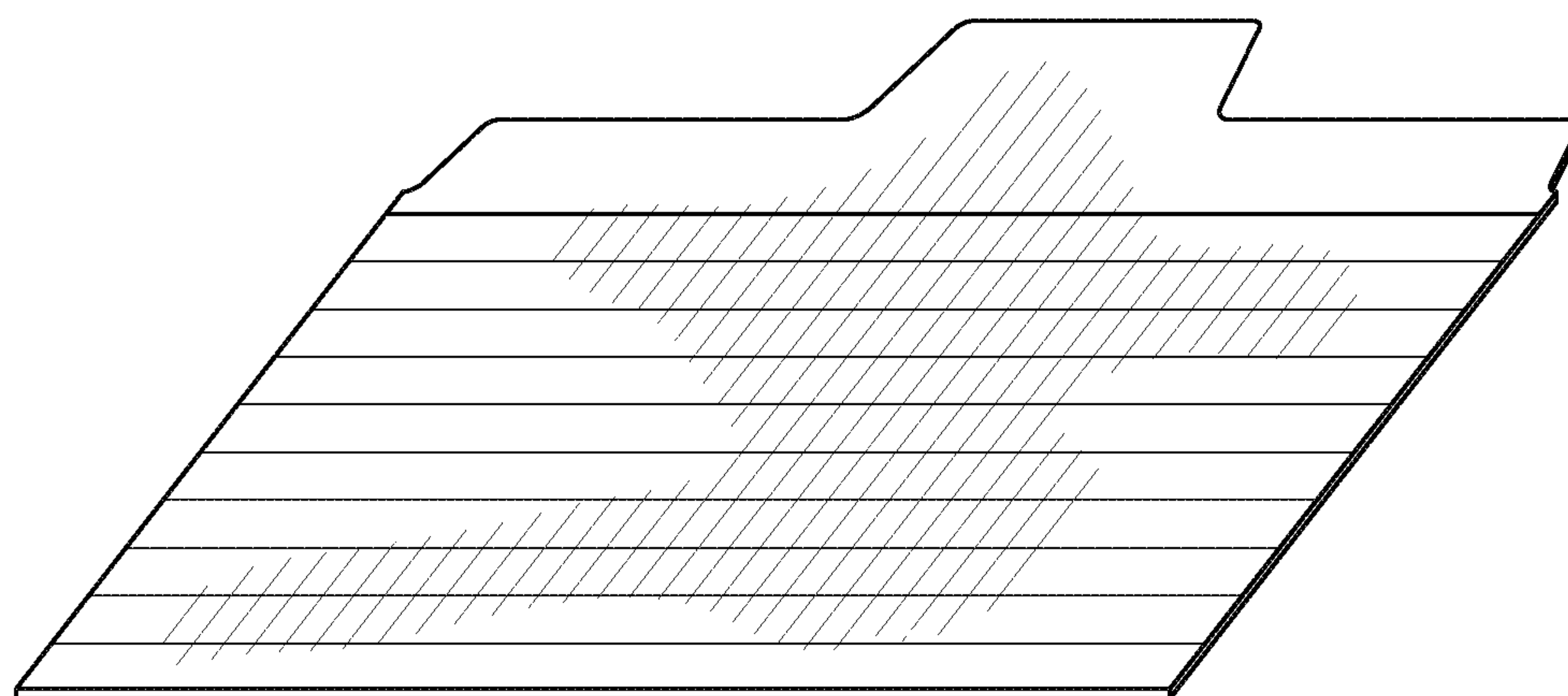

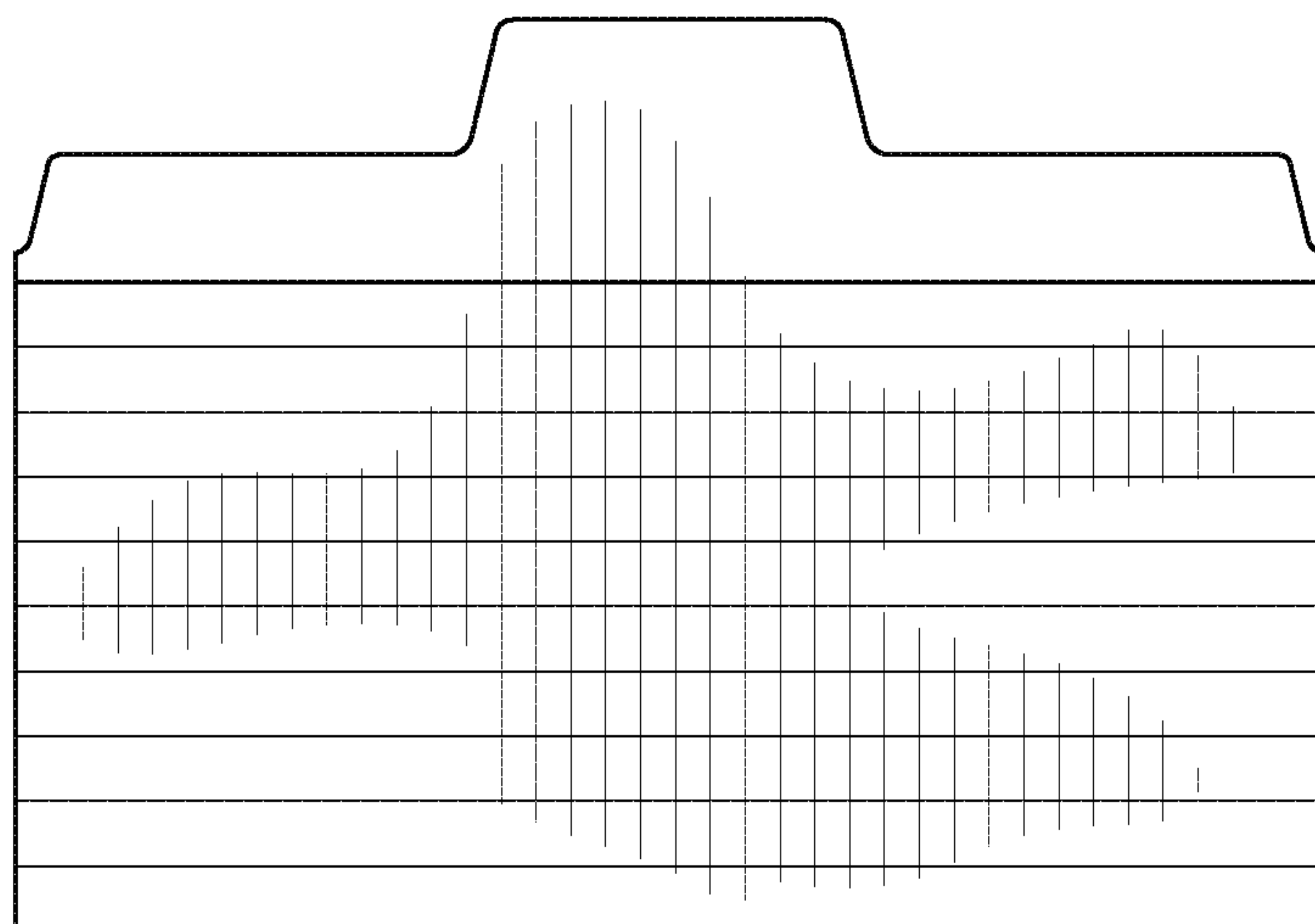

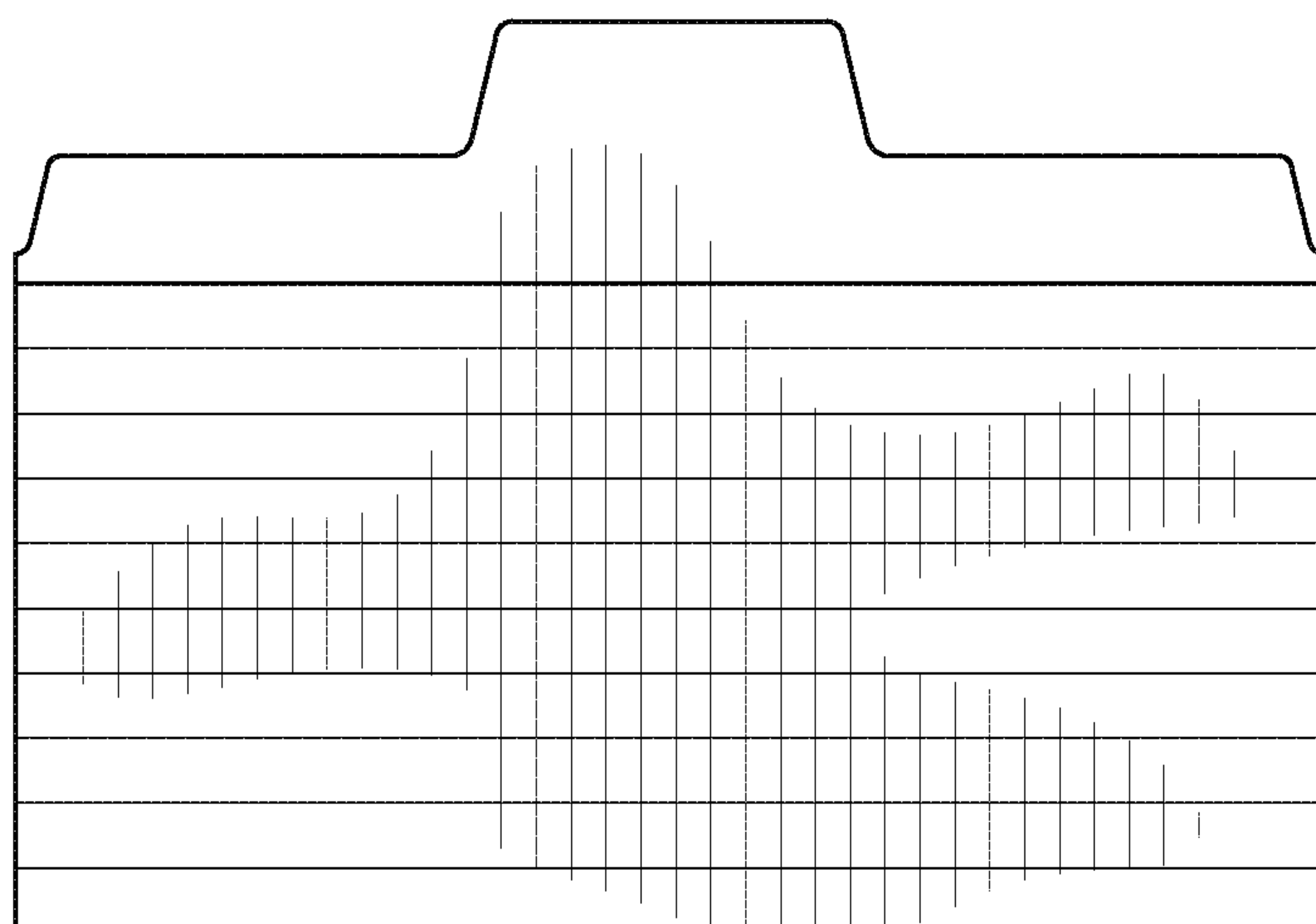

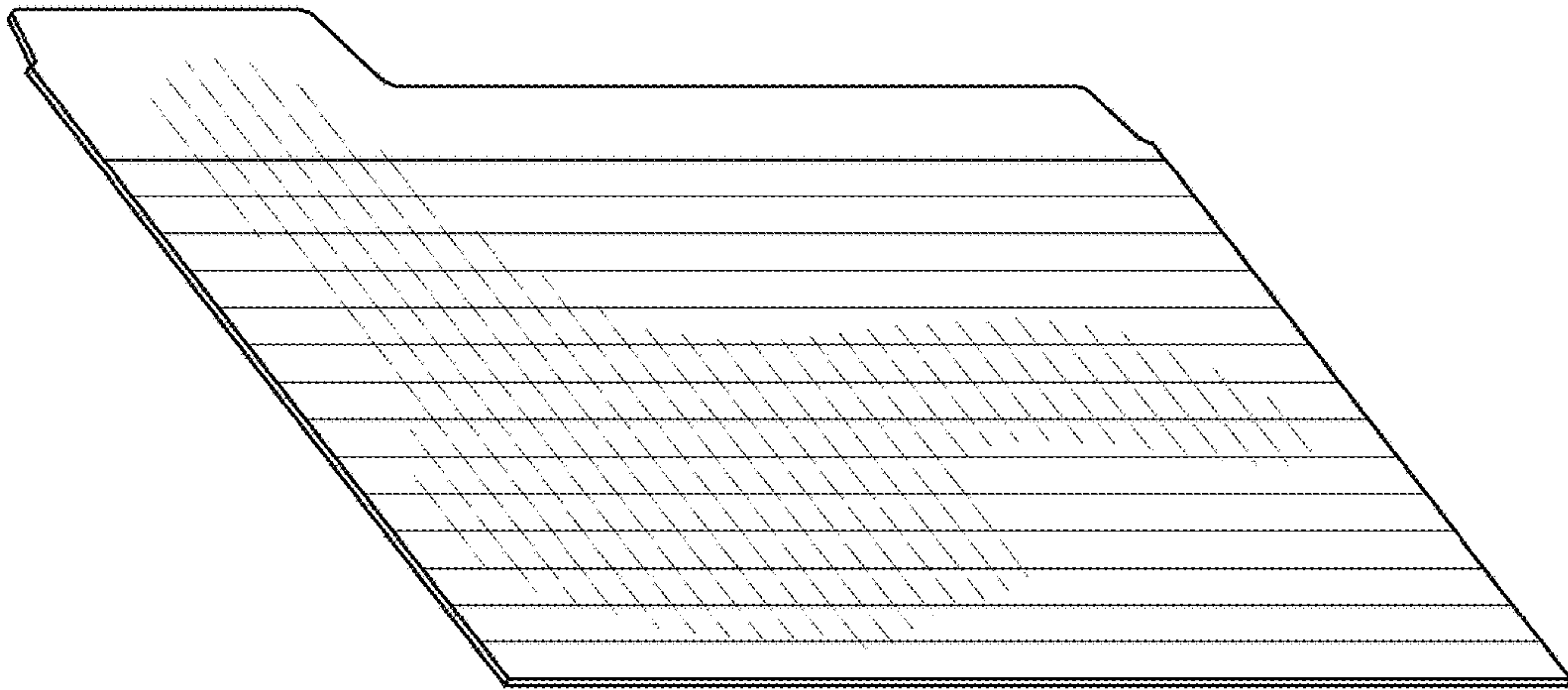

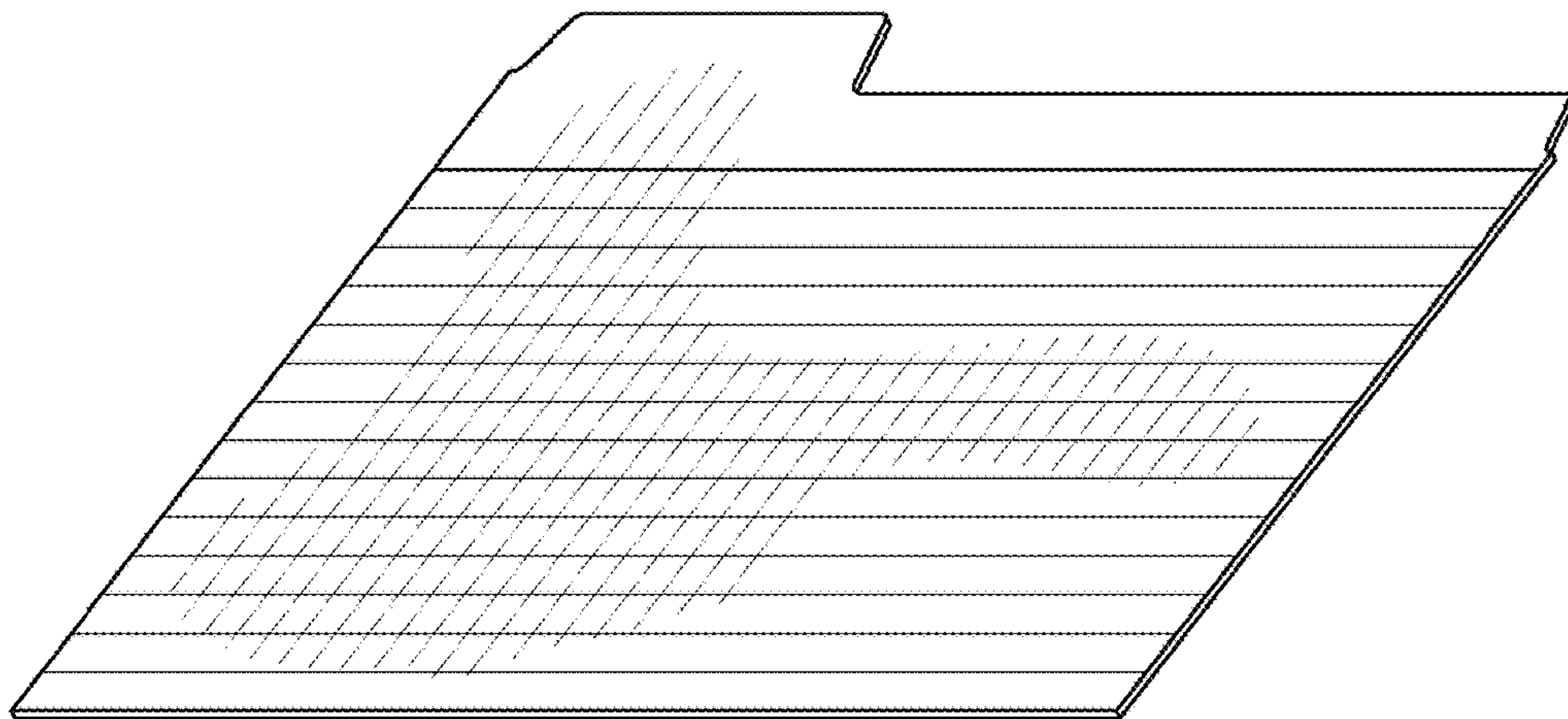

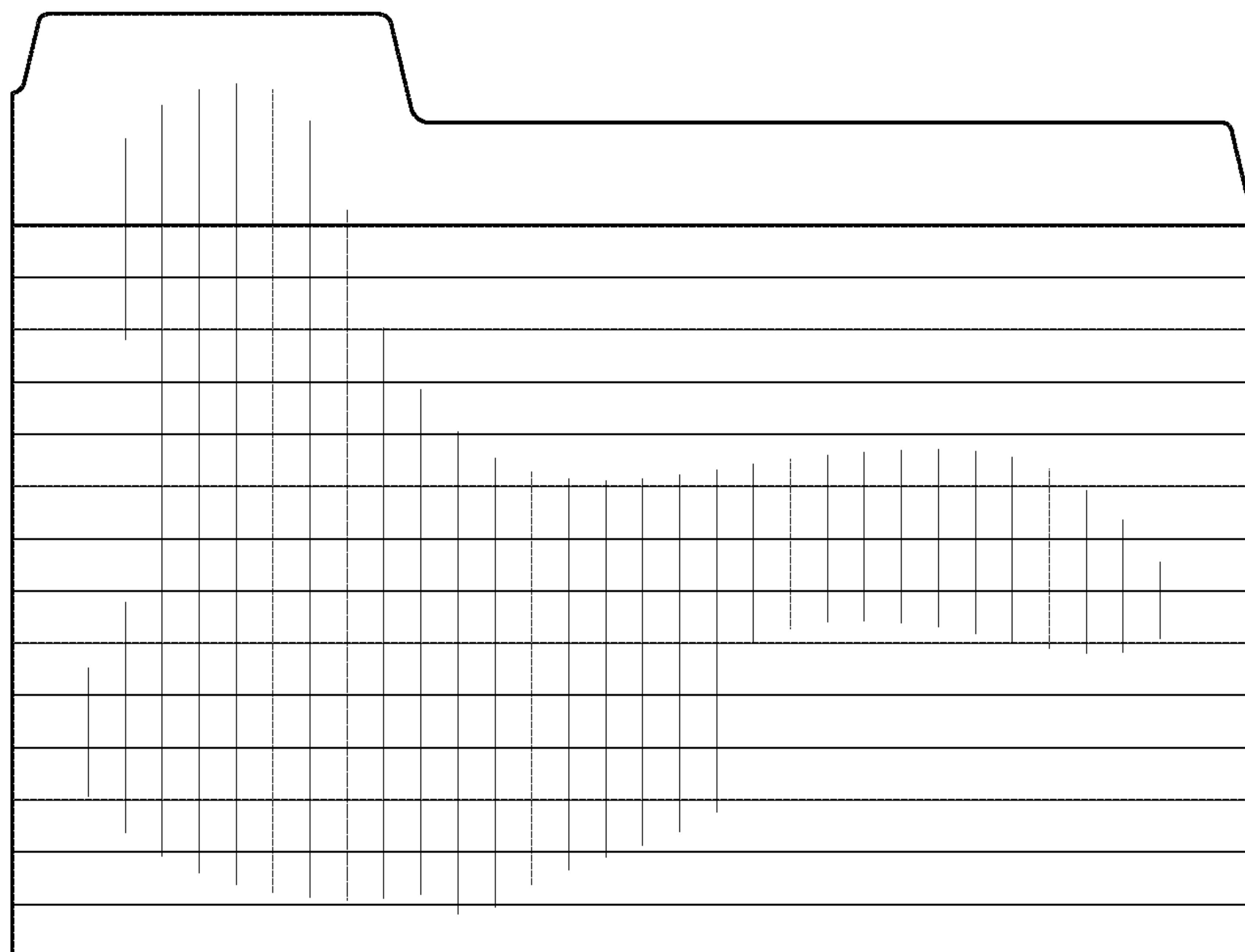

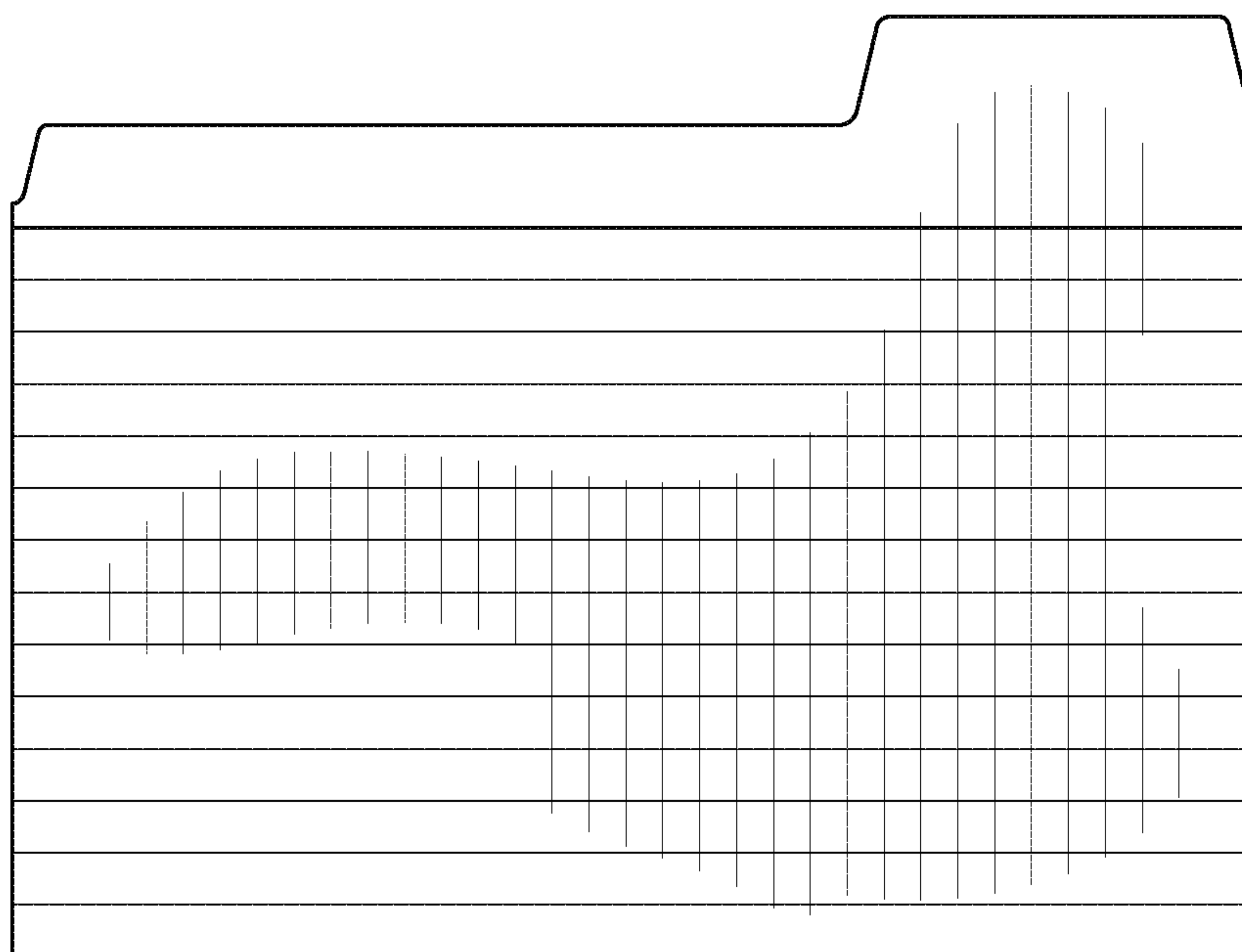

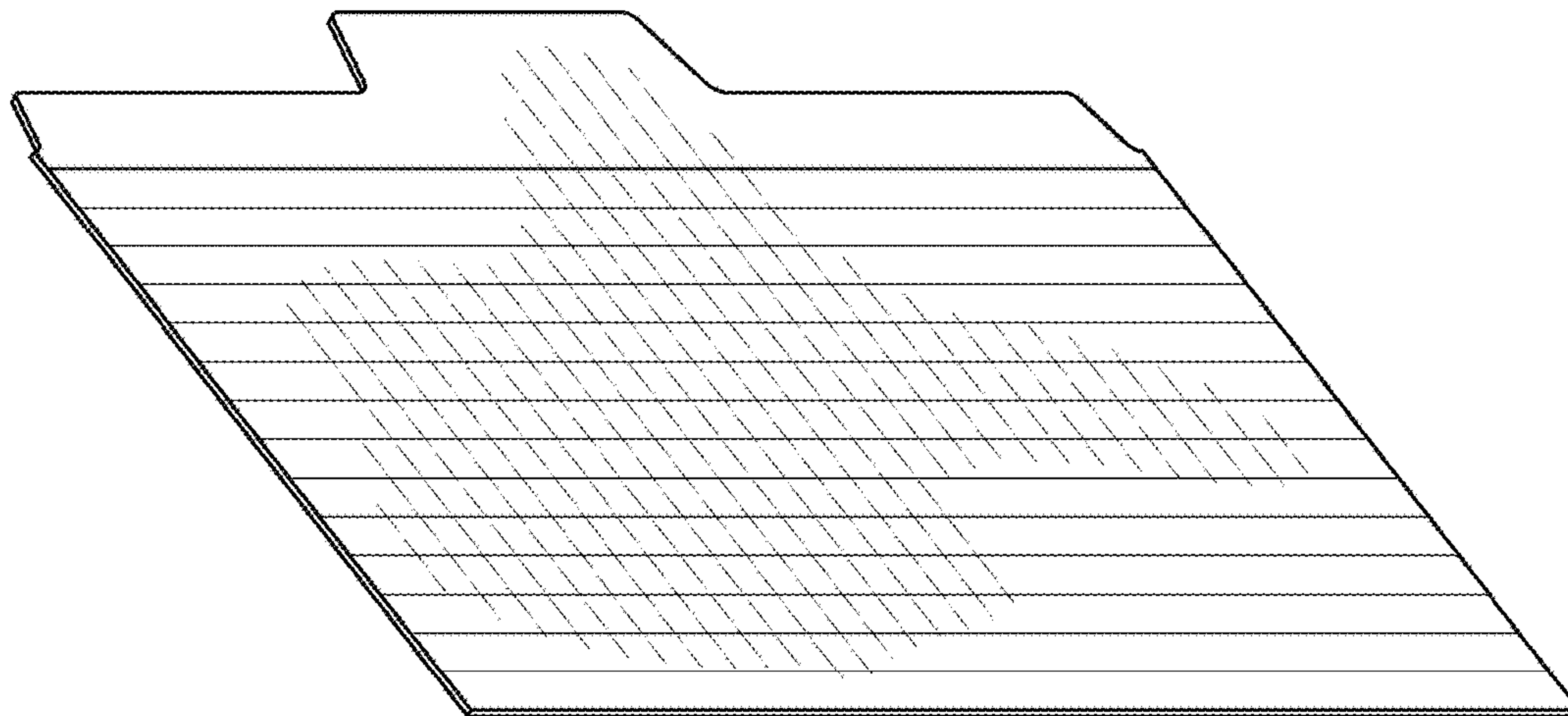

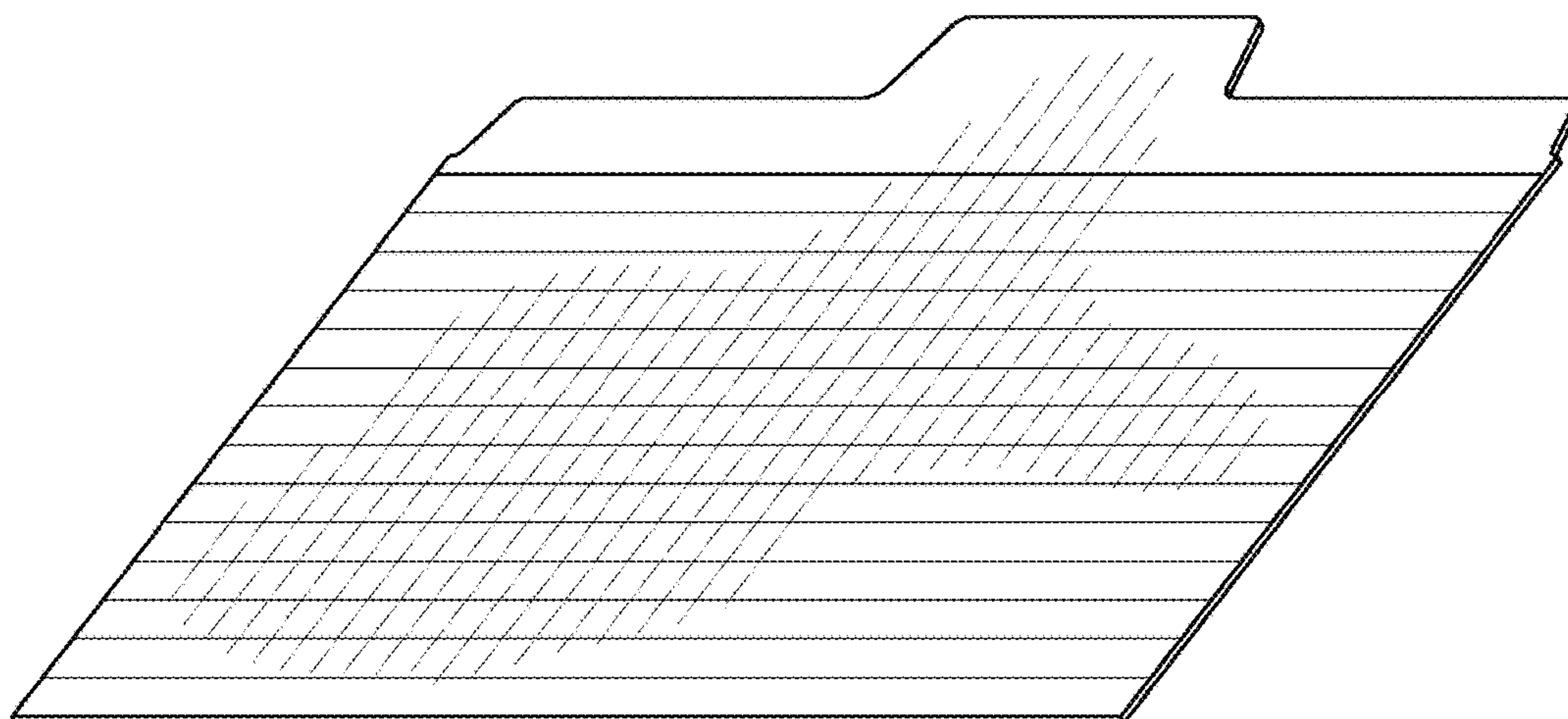

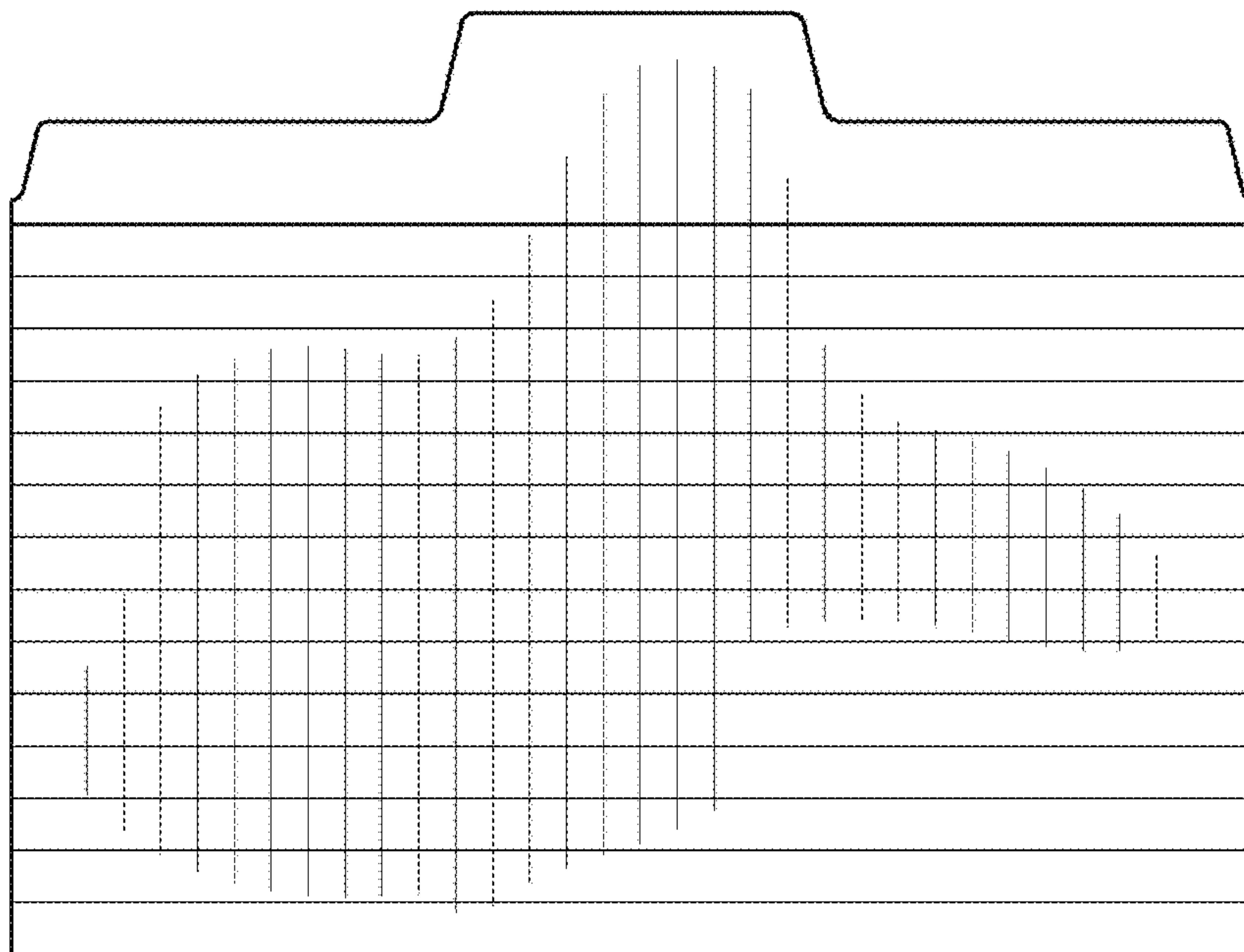

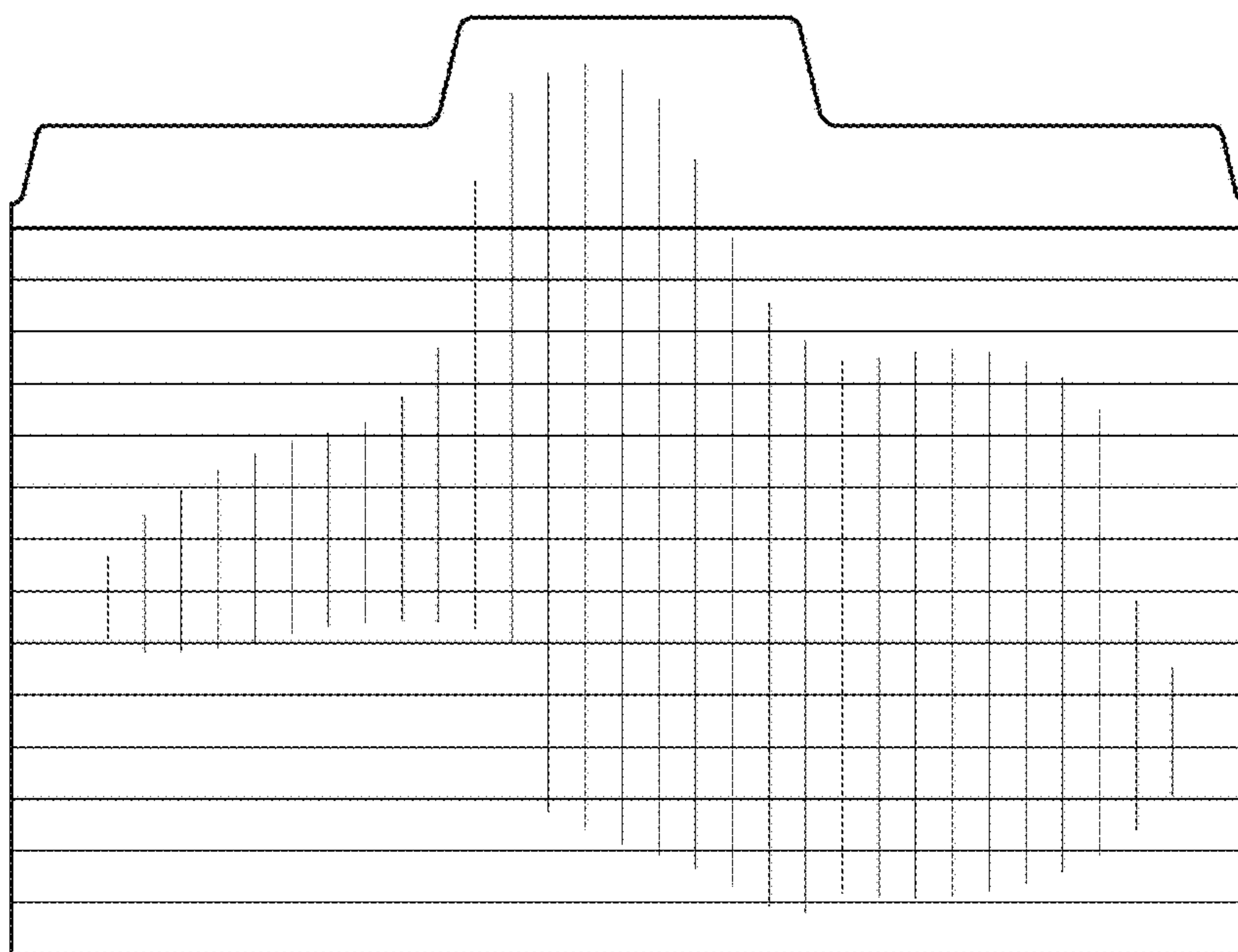

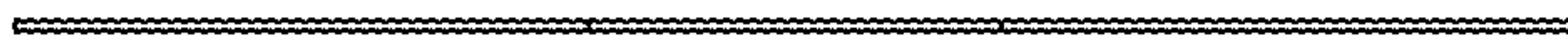
